DESCRIPTION

FIG. 2 is a first side elevation view of FIG. 1.

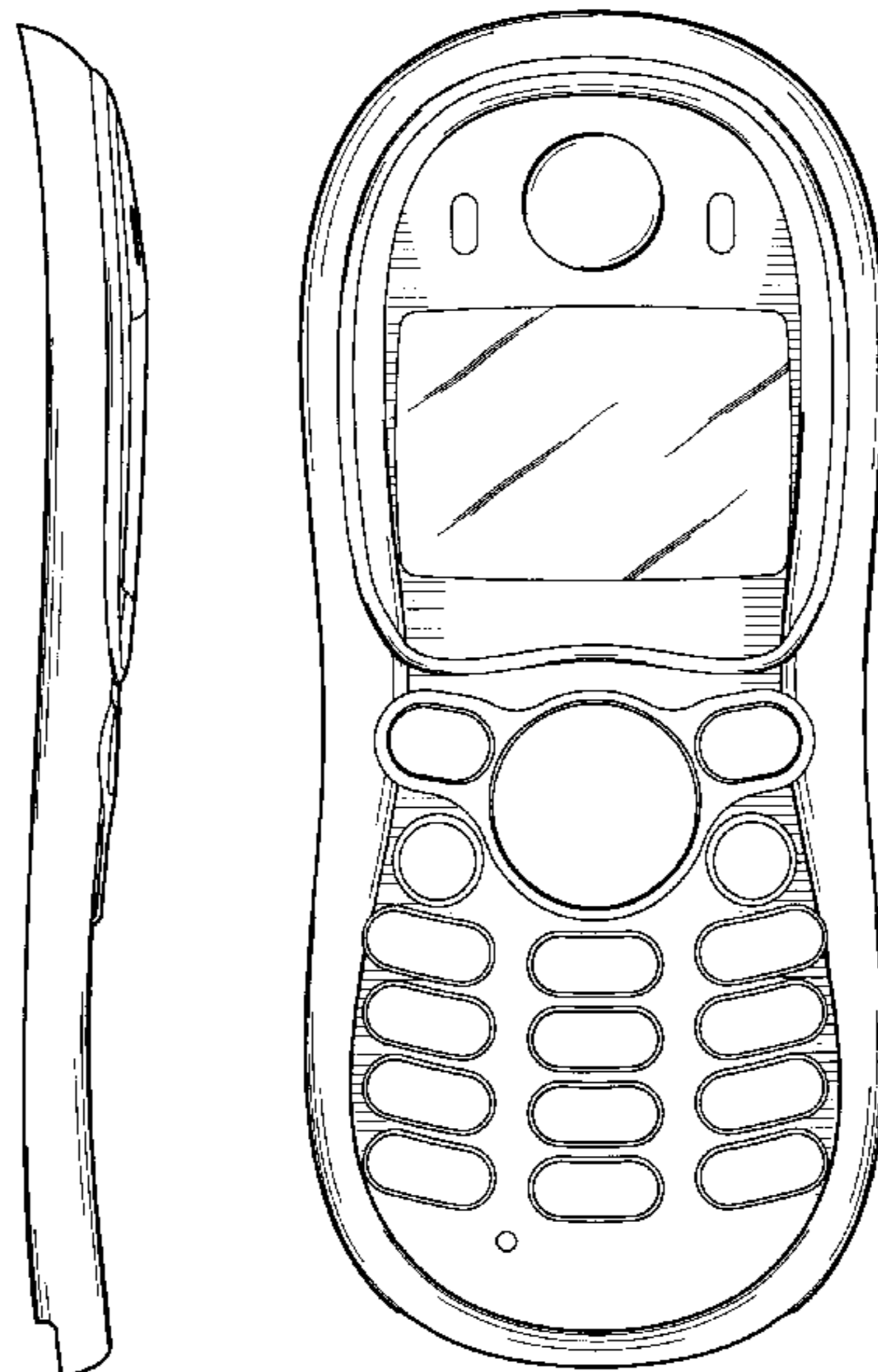
FIG. 3 is a front elevation view of FIG. 1.

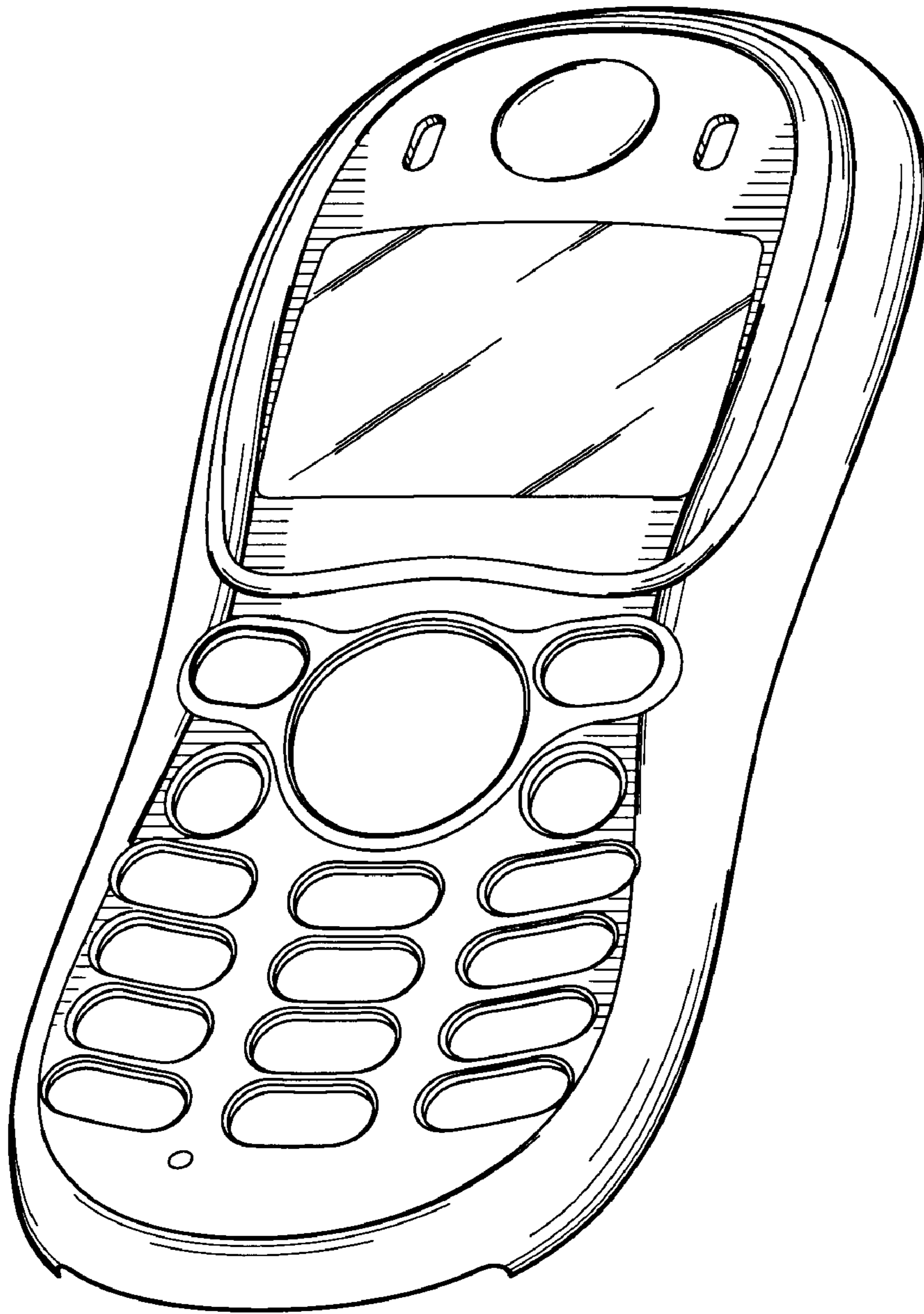

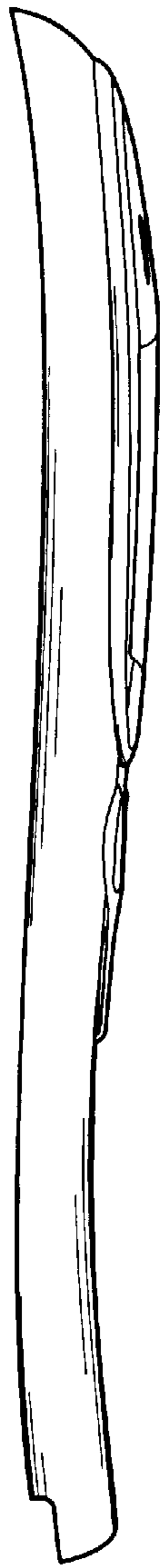

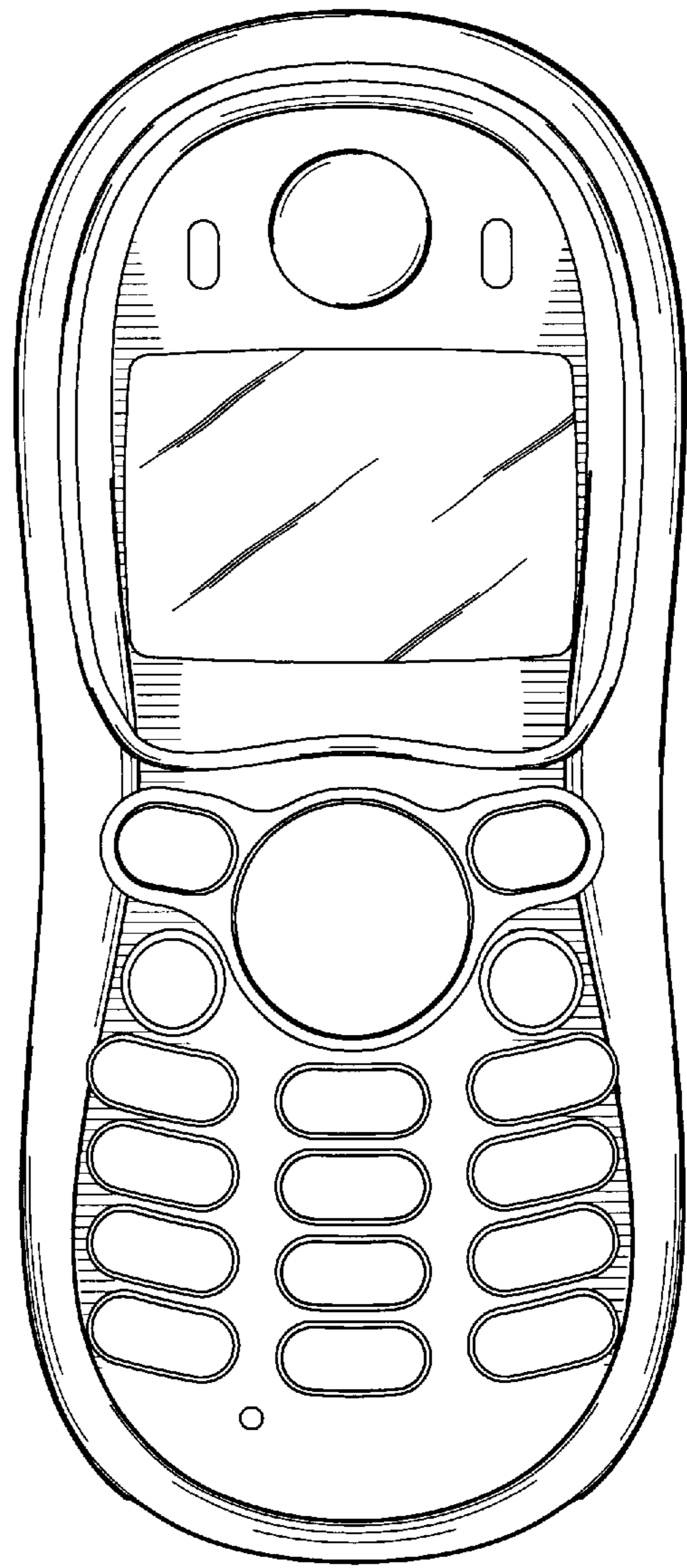

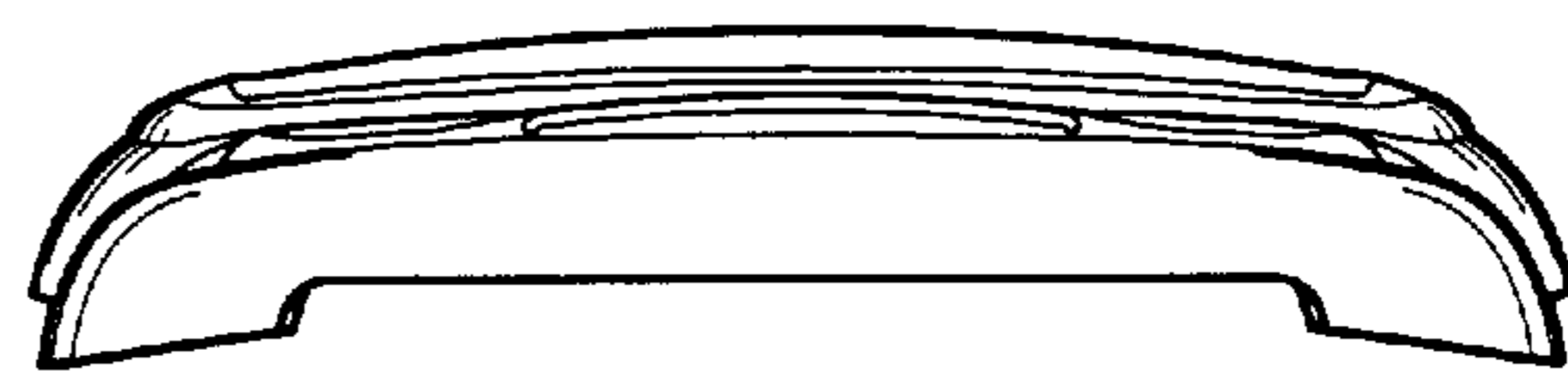

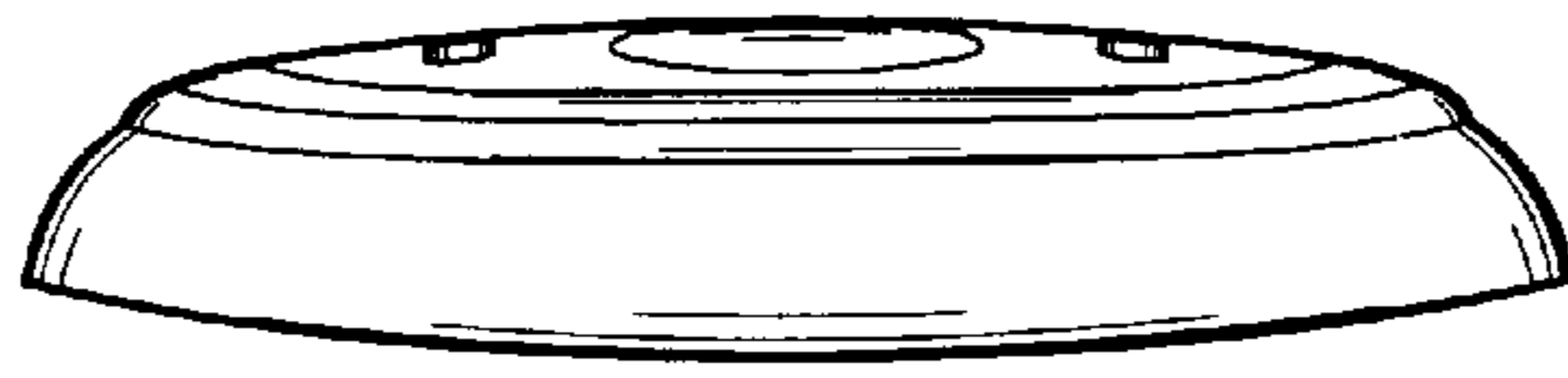
