DESCRIPTION

FIG. 1 is a front view of a first embodiment of a condensing lens system according to the present invention;
 FIG. 2 is a back view of the embodiment of FIG. 1;
 FIG. 3 is a right-side view of the embodiment of FIG. 1;
 FIG. 4 is a left-side view of the embodiment of FIG. 1;

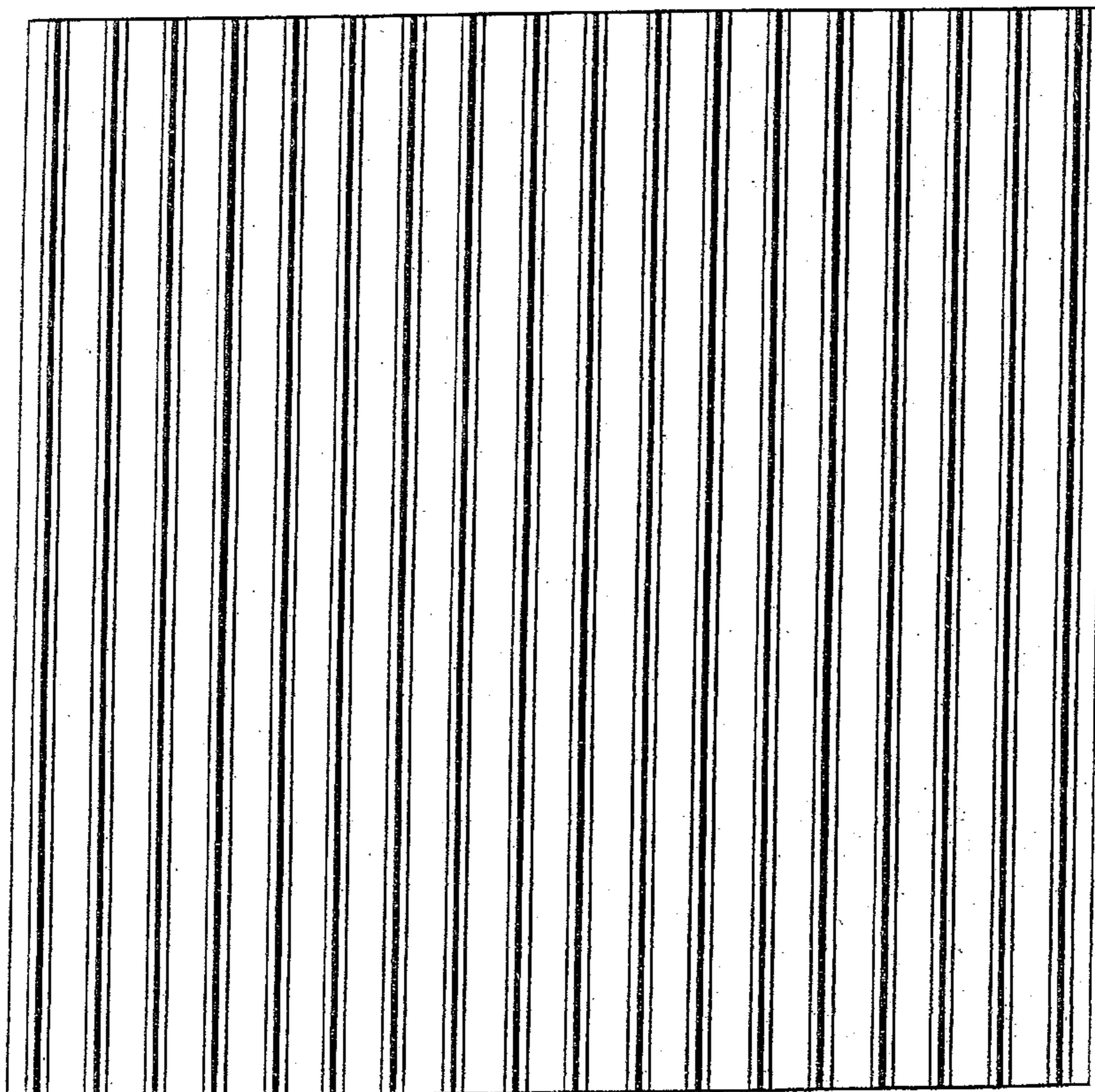

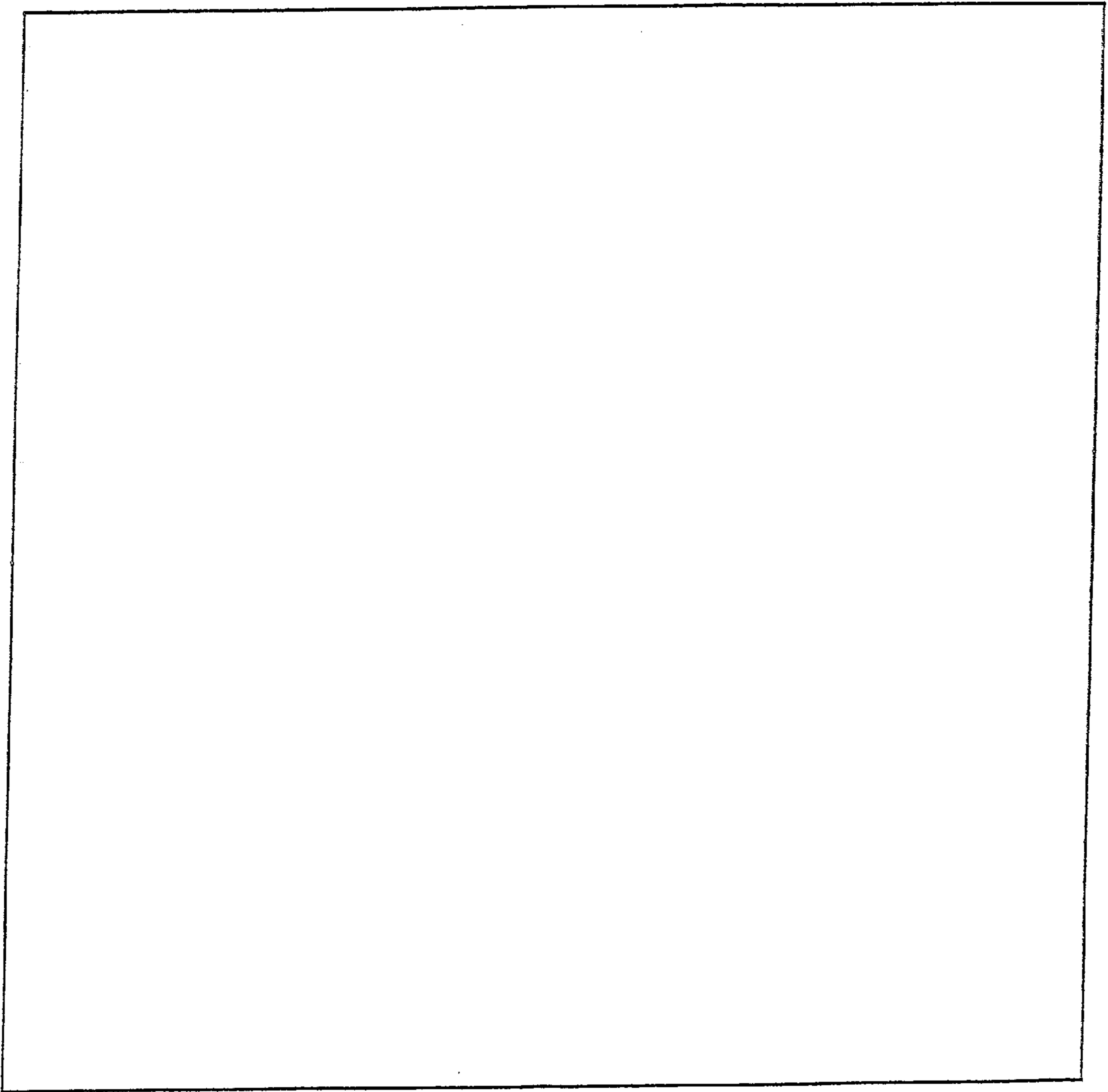

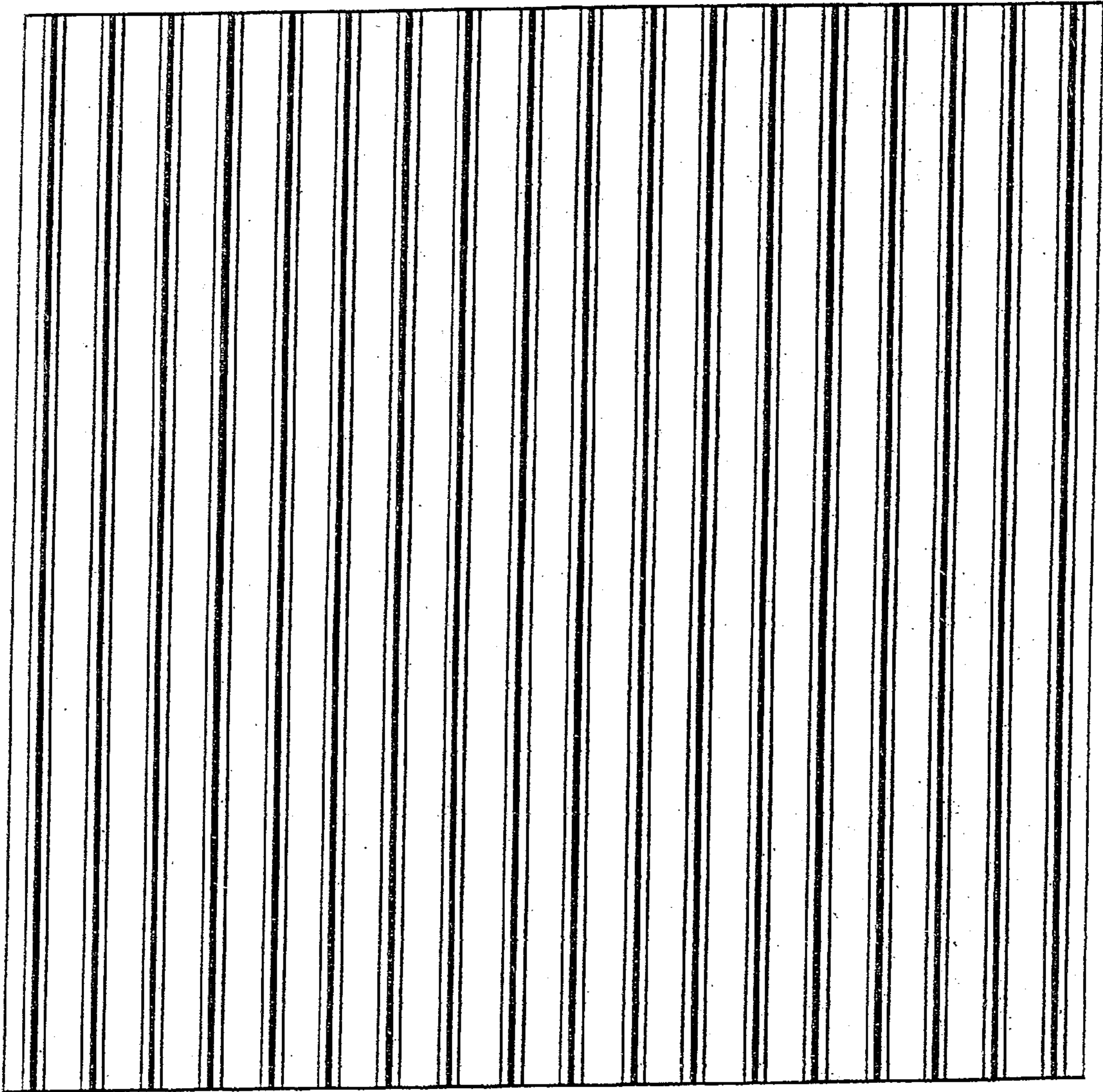

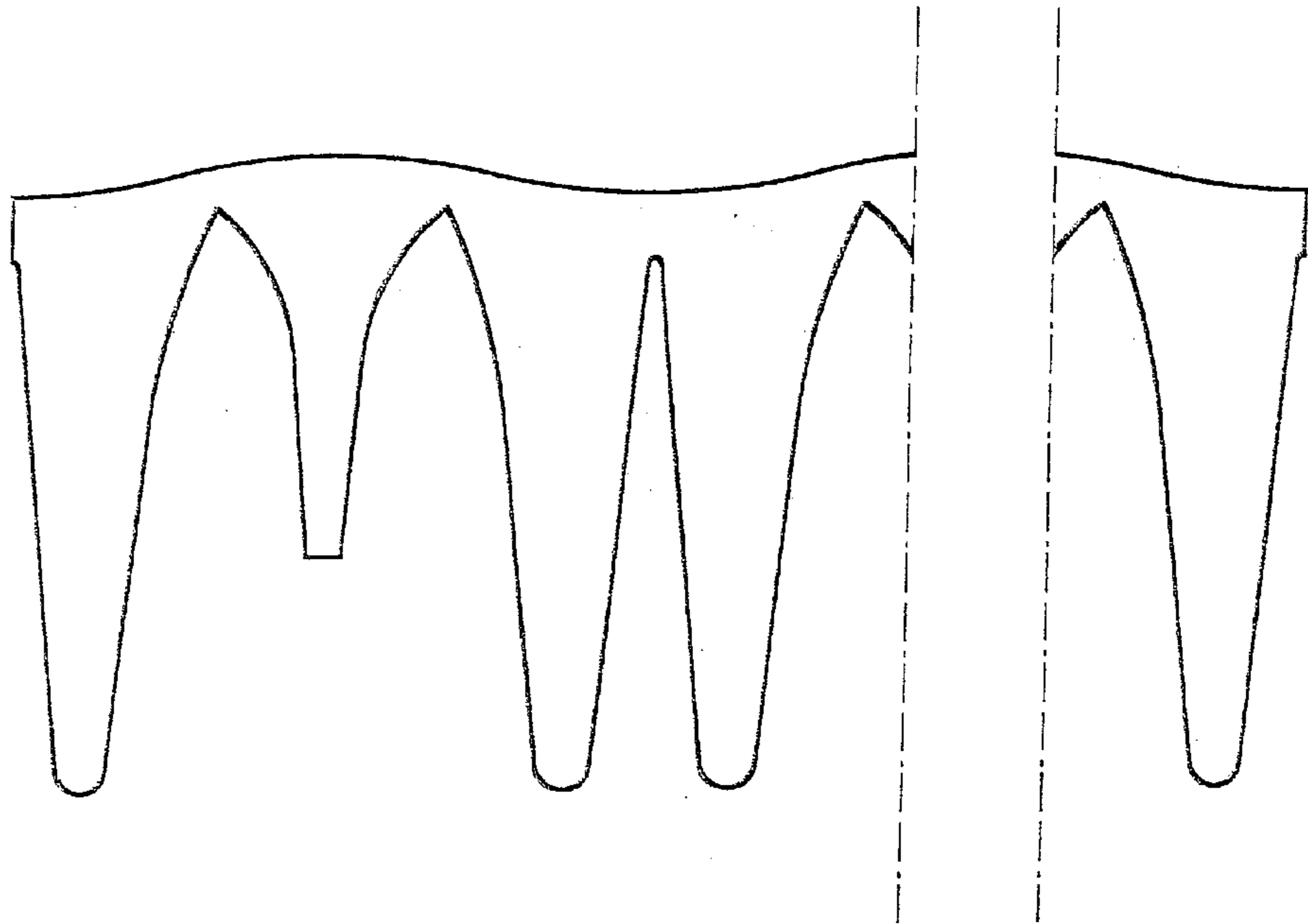
