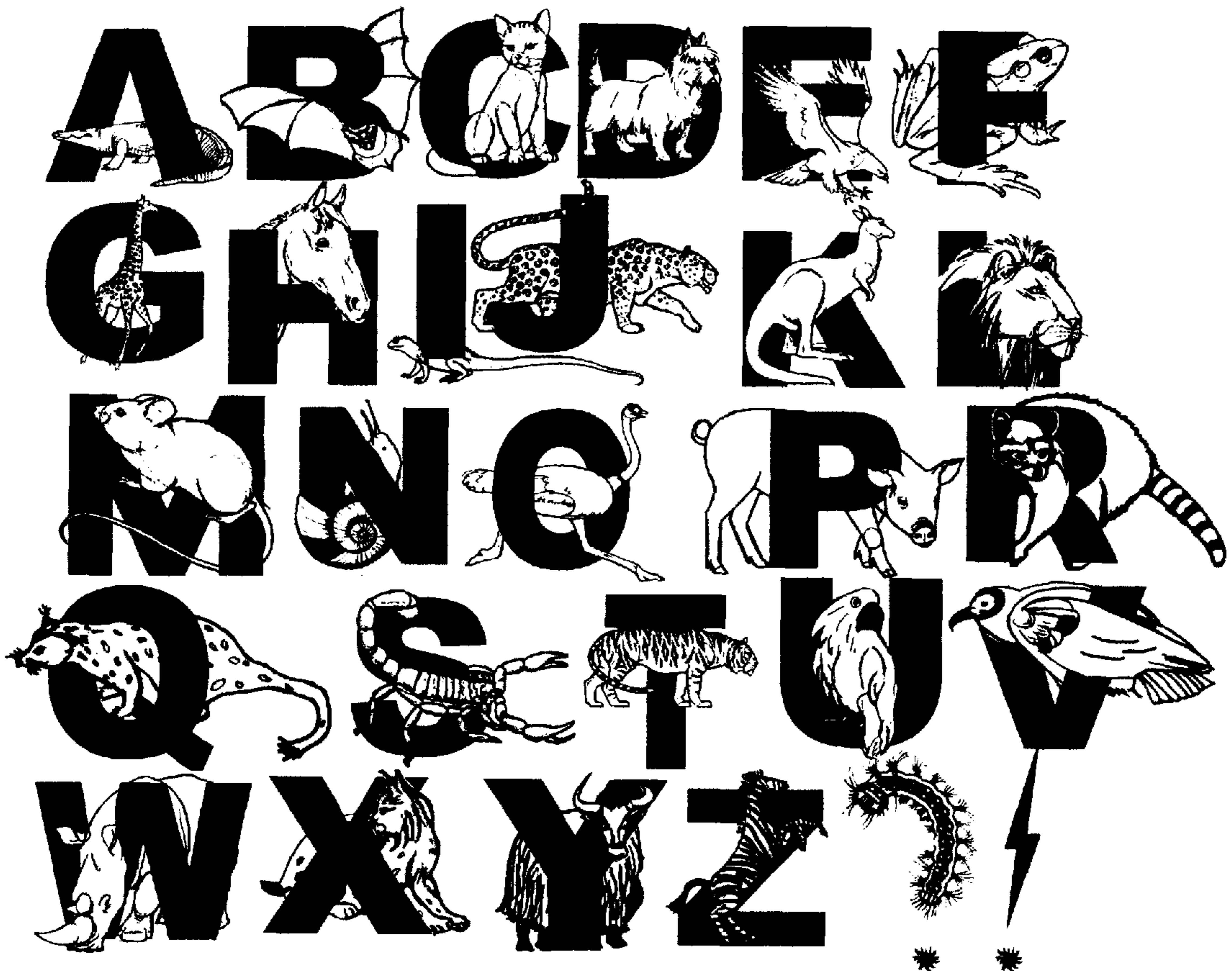
The ornamental design for a decorative font funny animals, as shown and described.

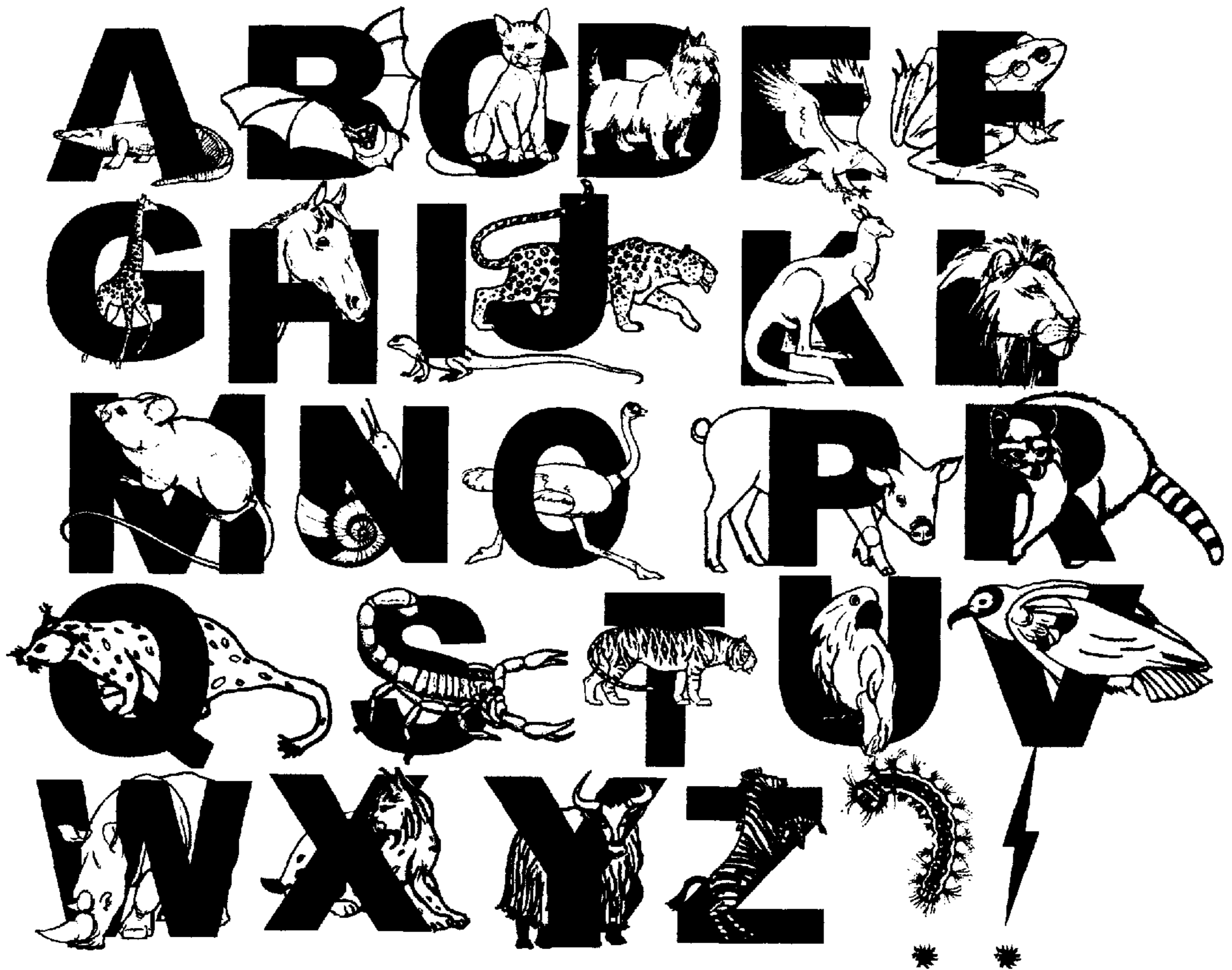

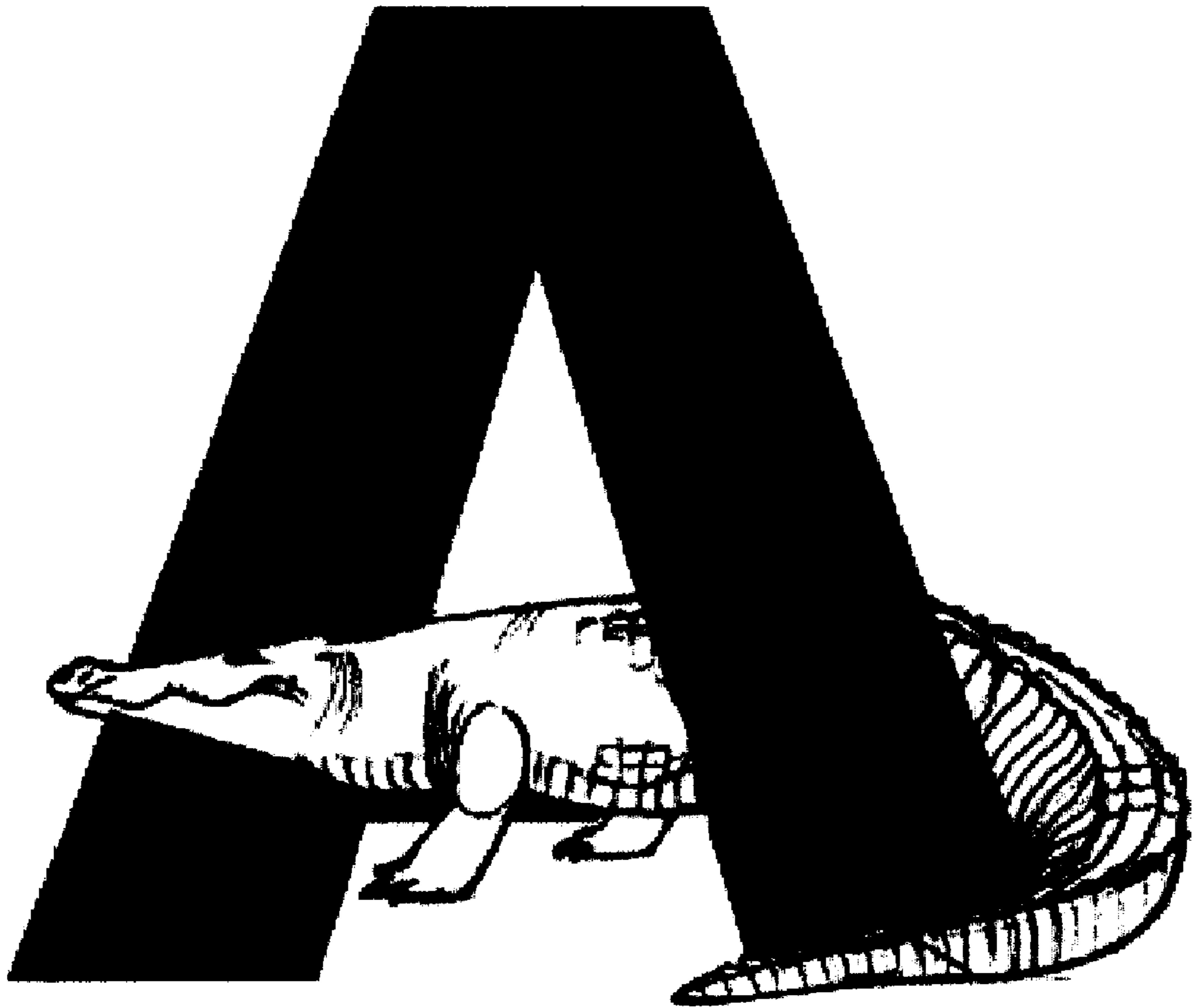

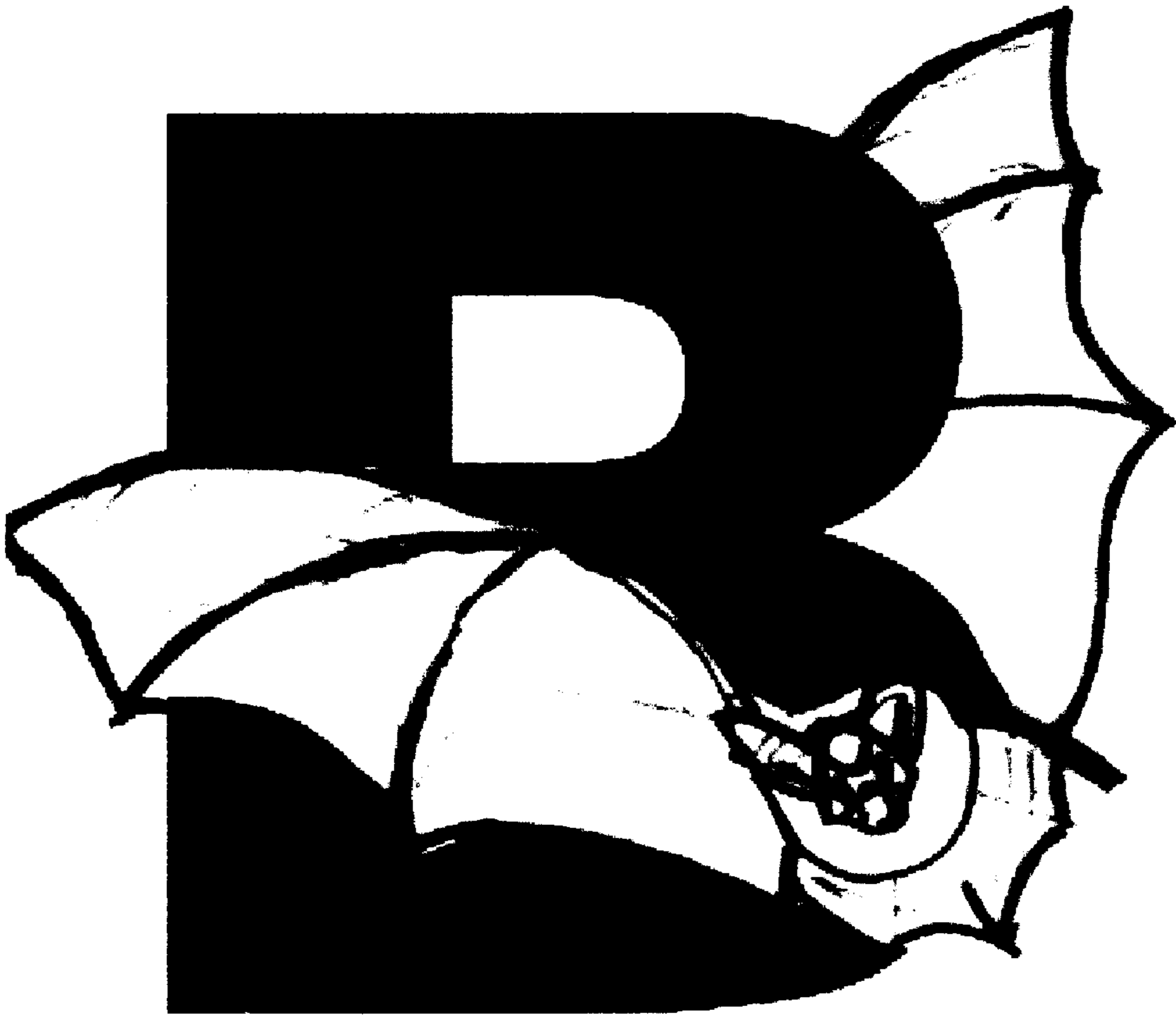

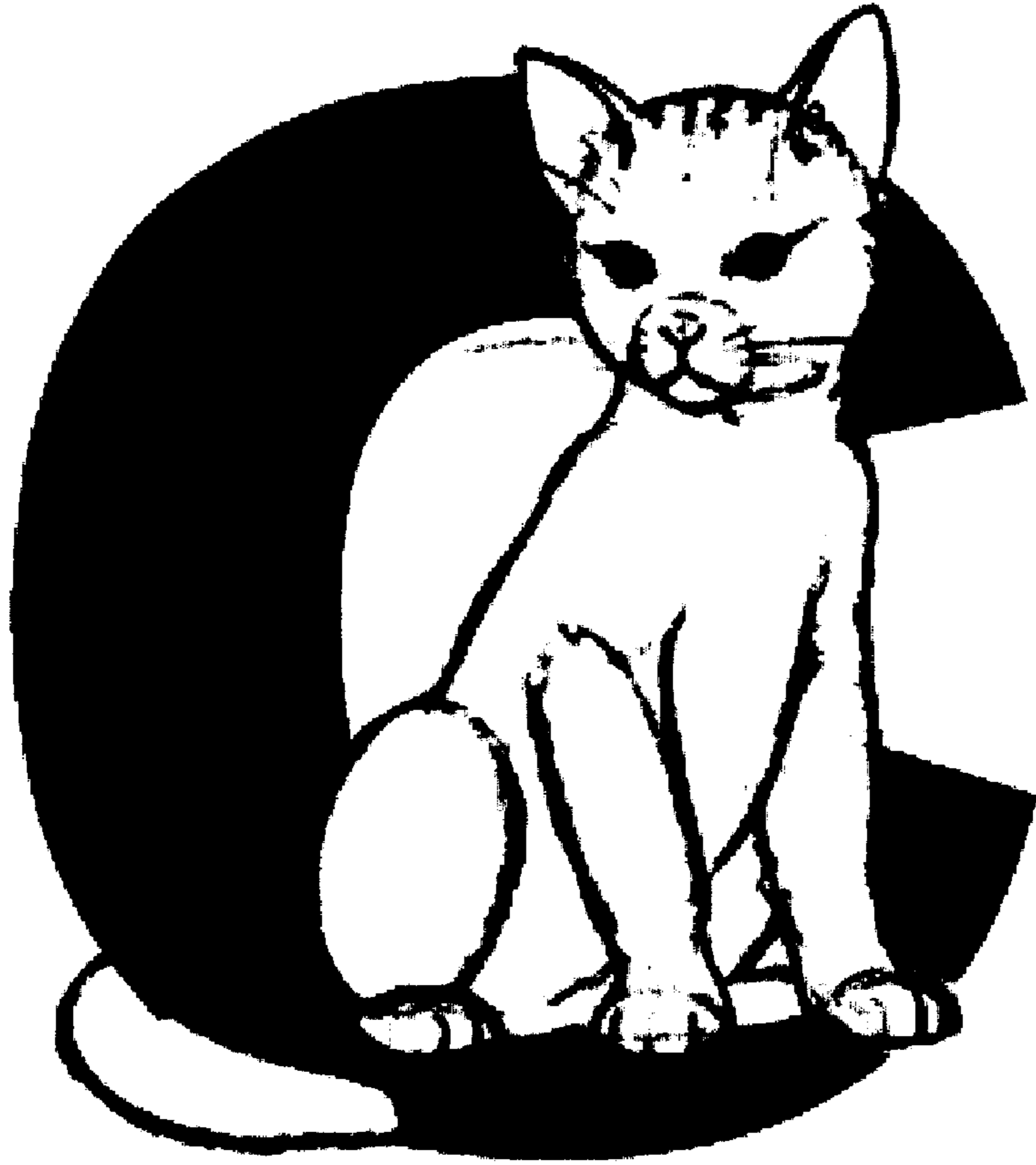

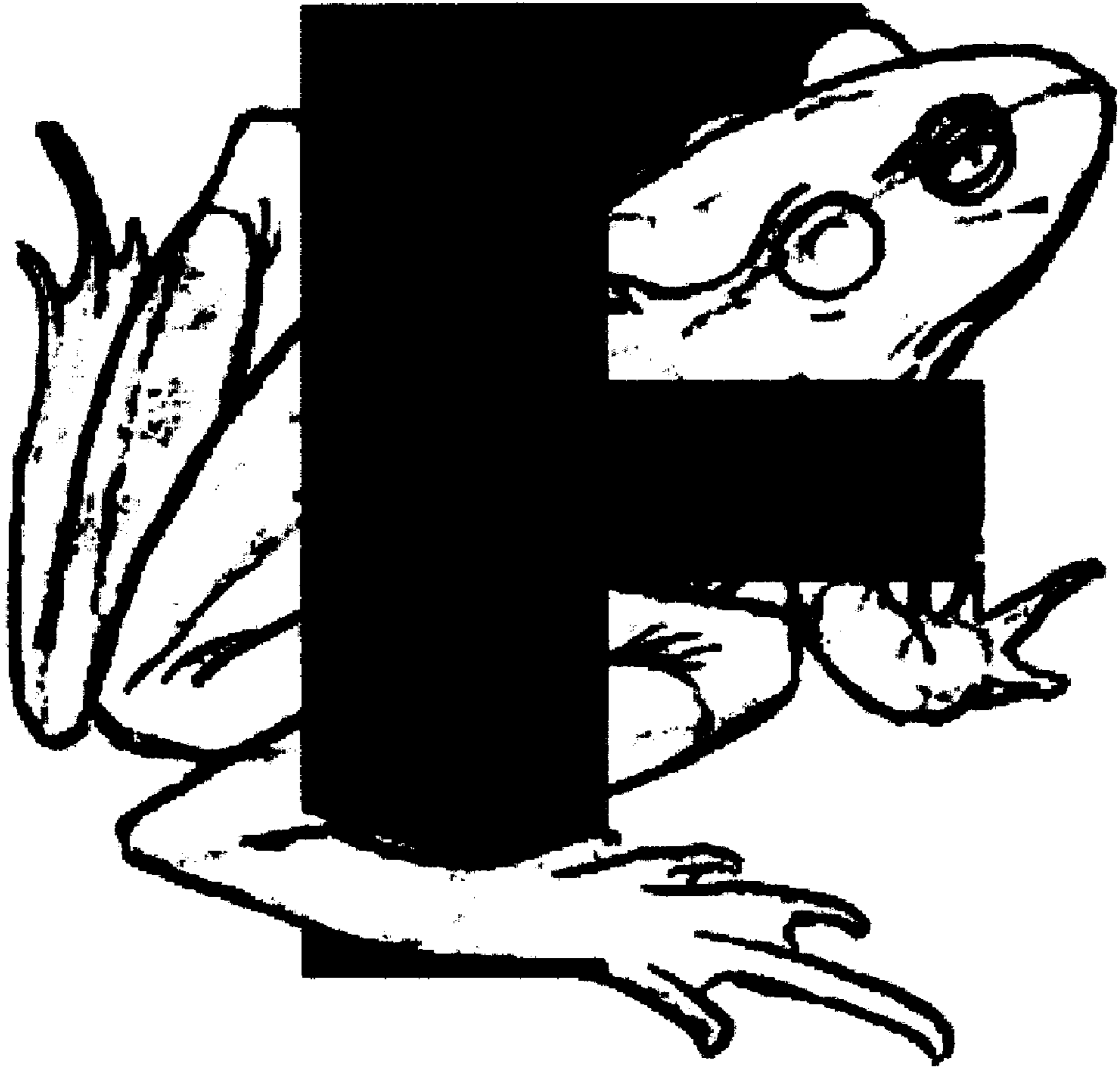

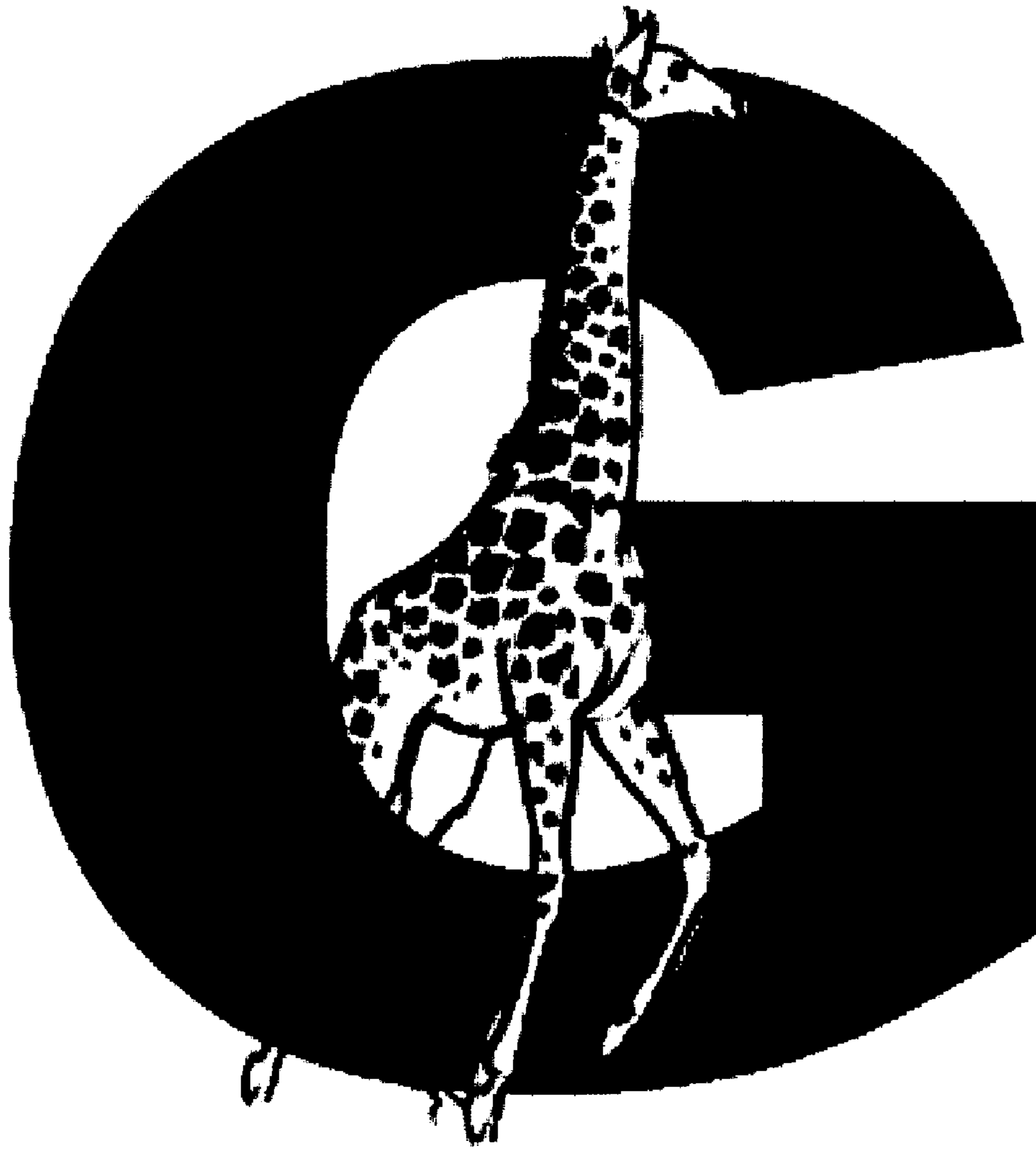

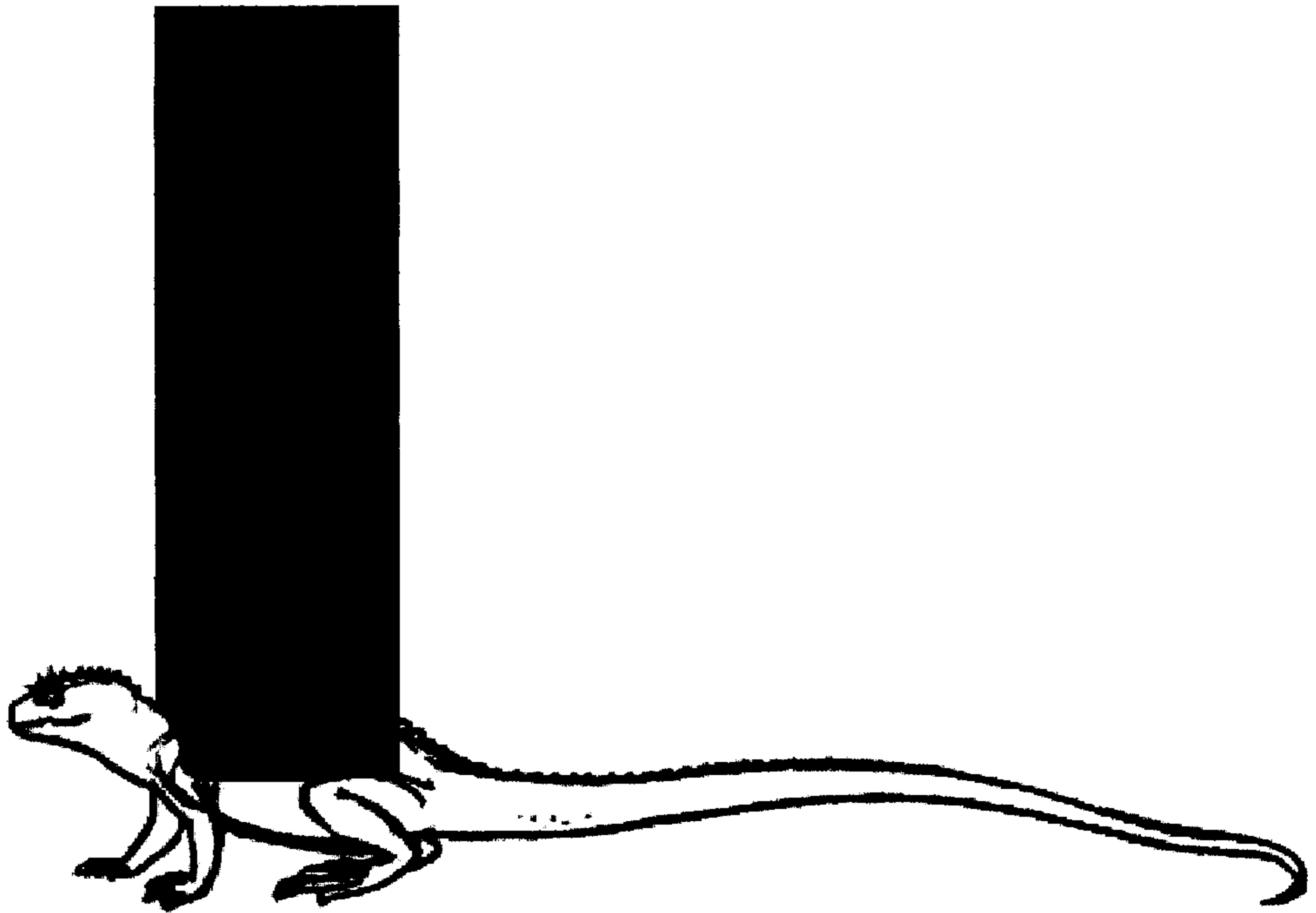

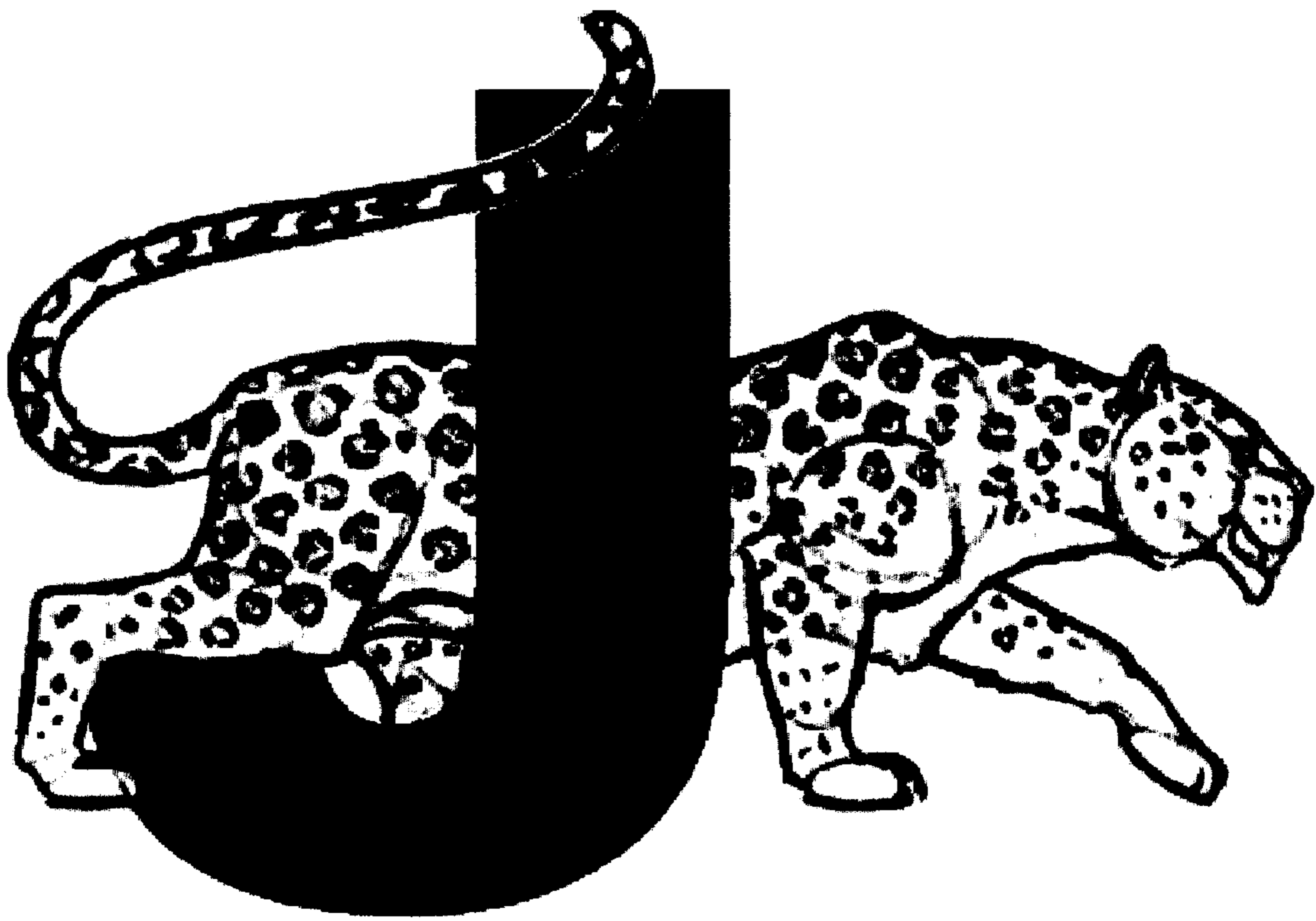

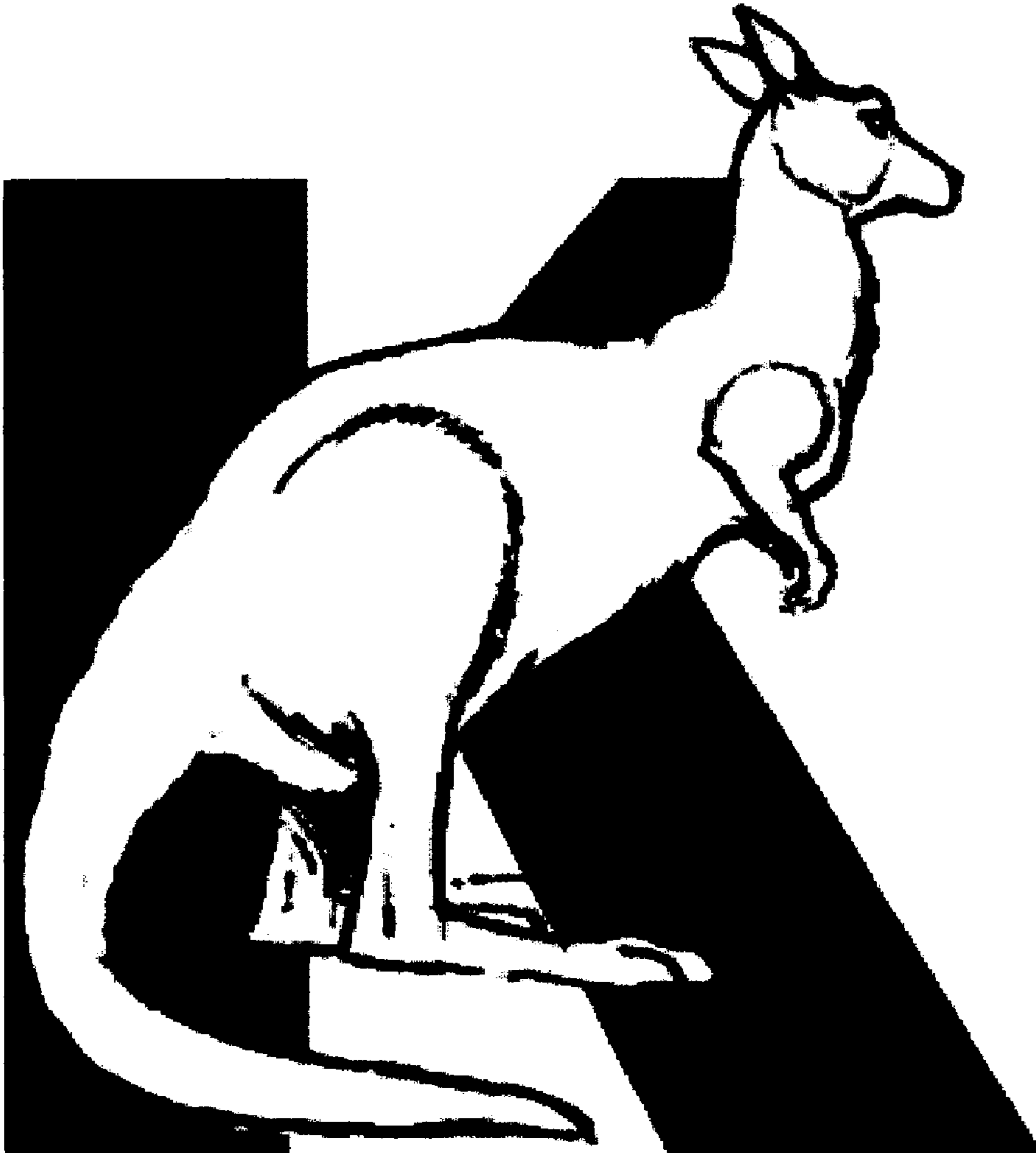

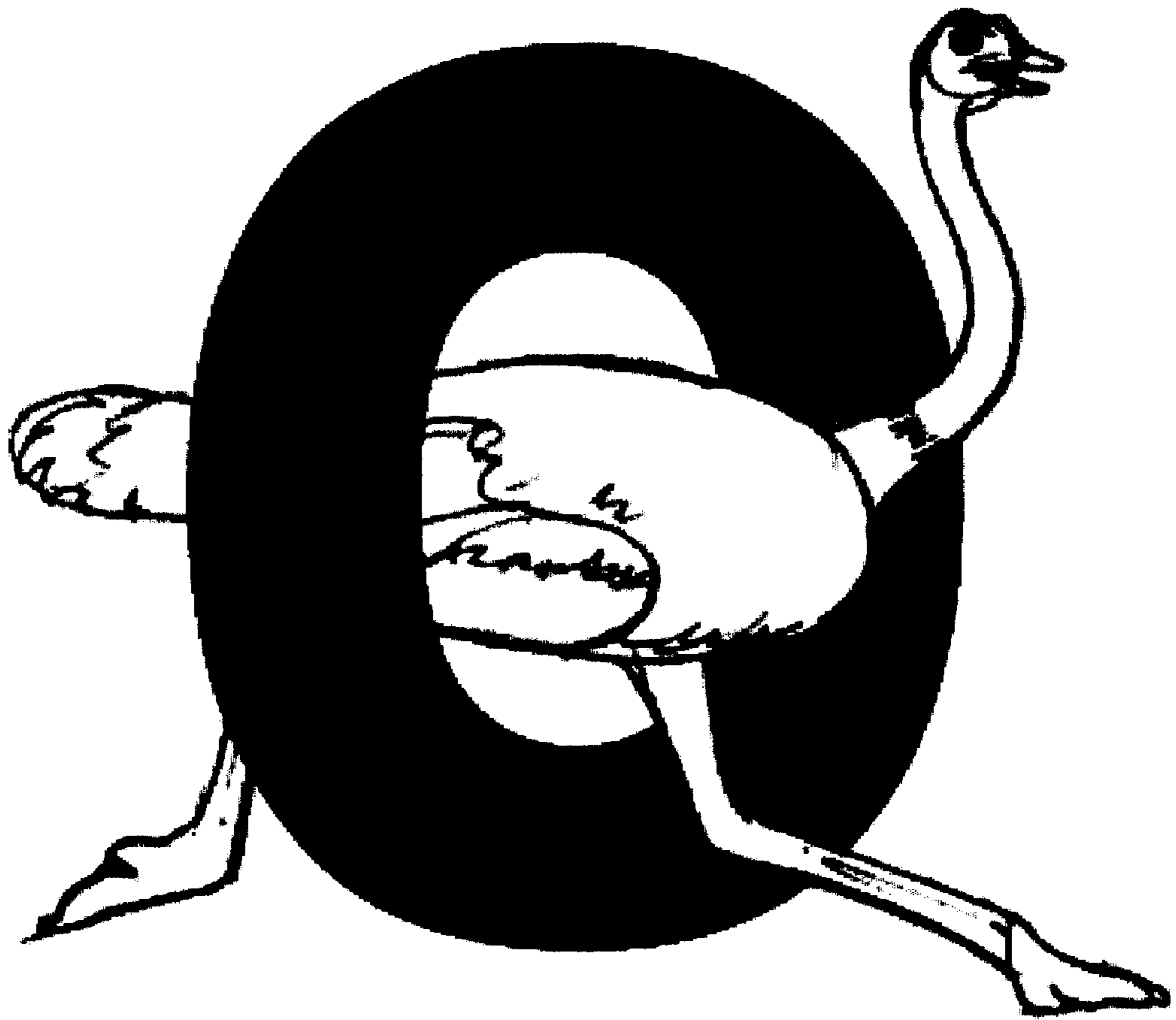

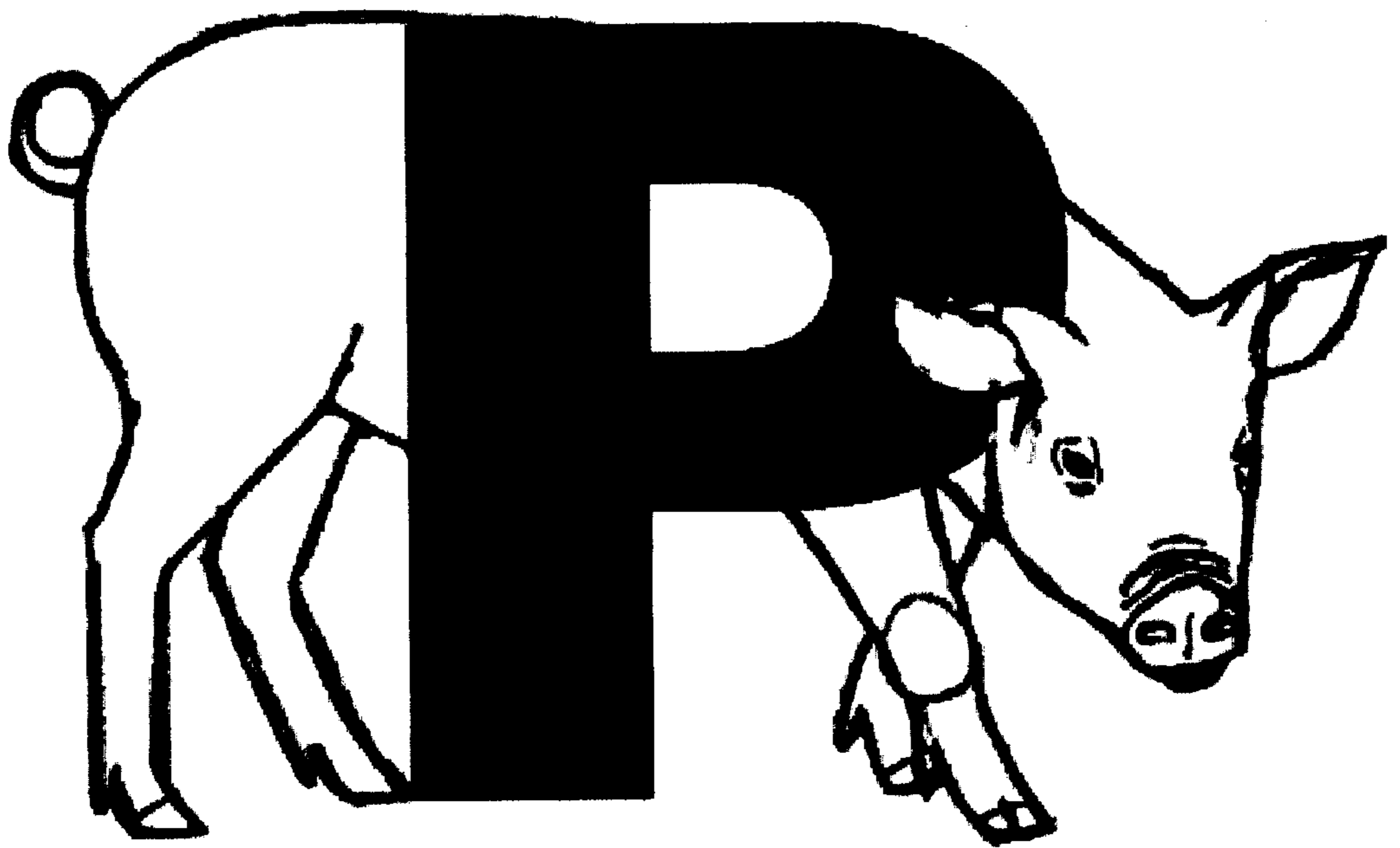

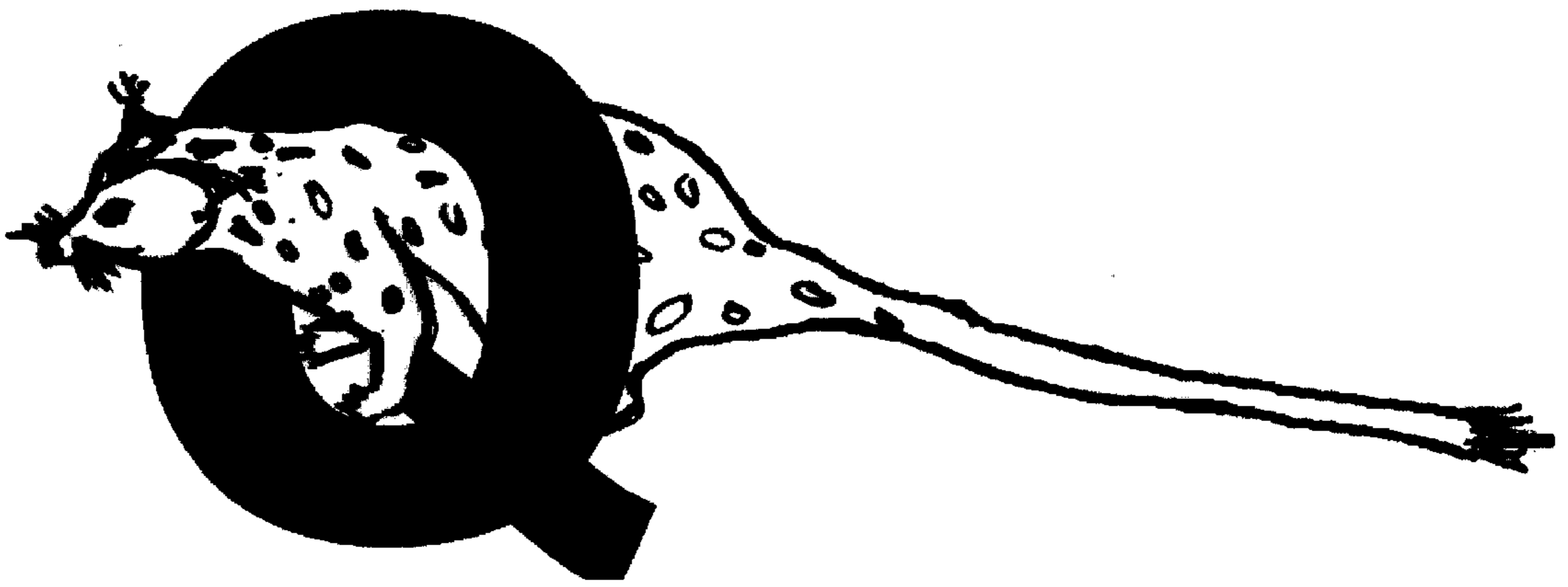

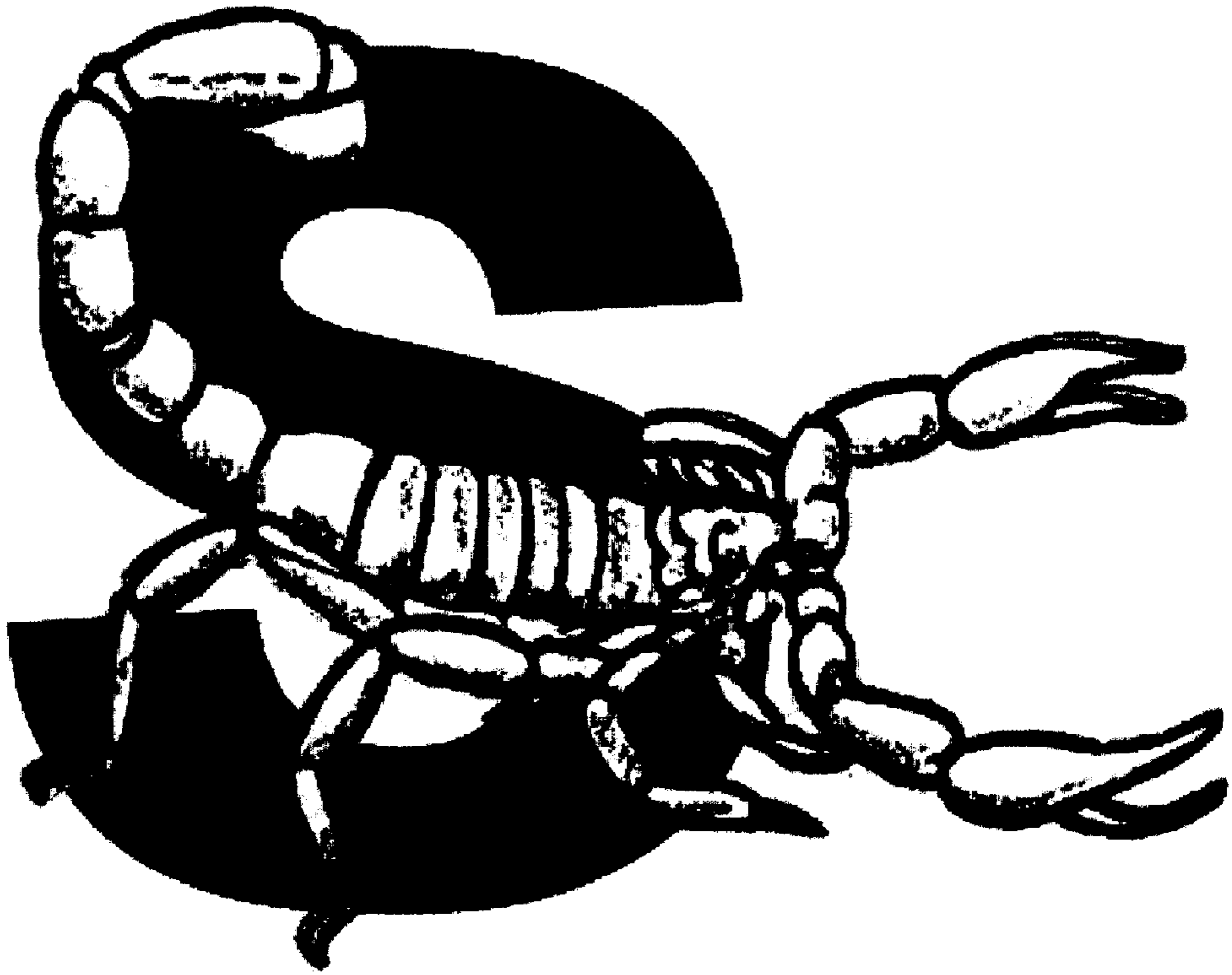

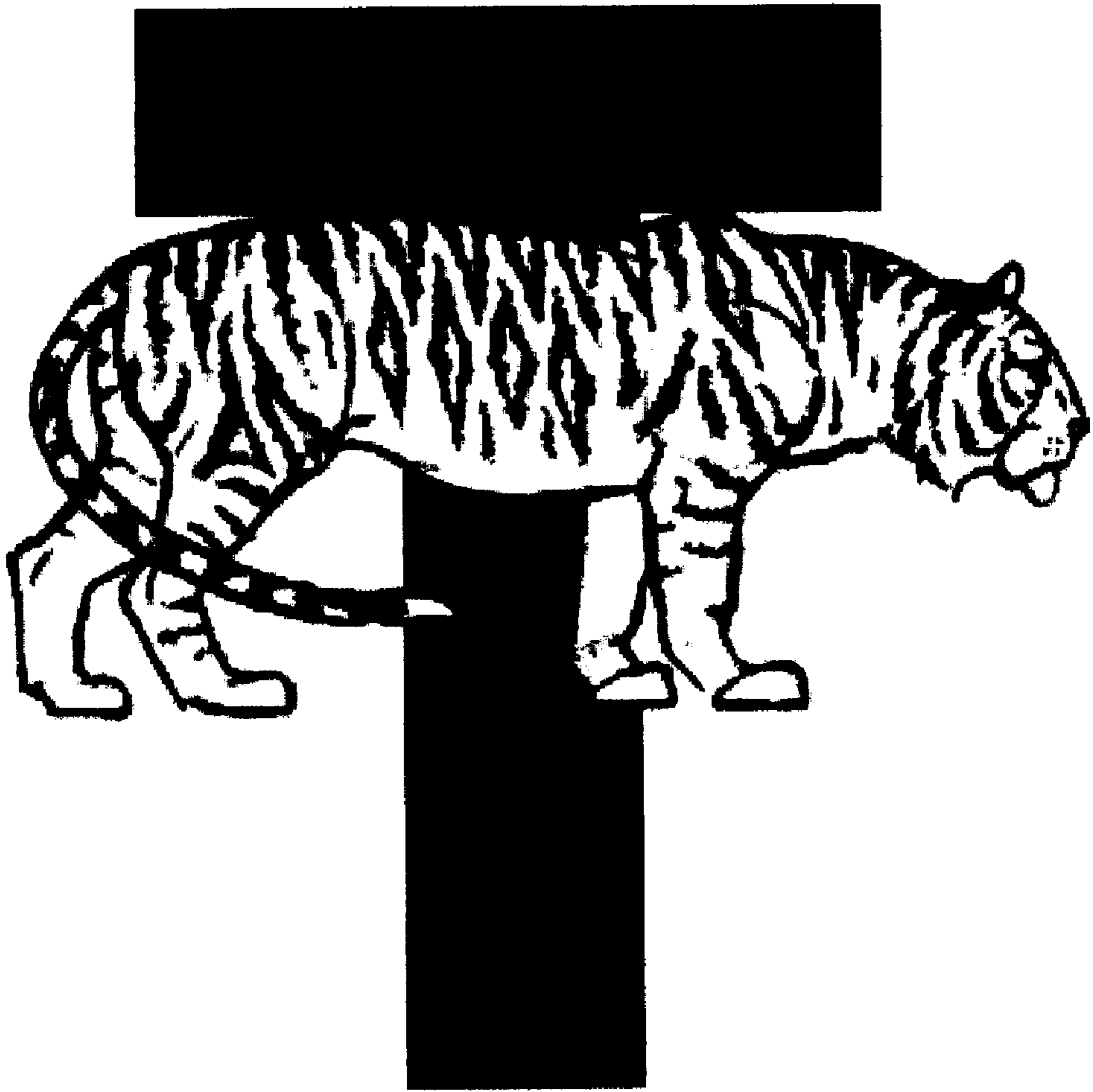

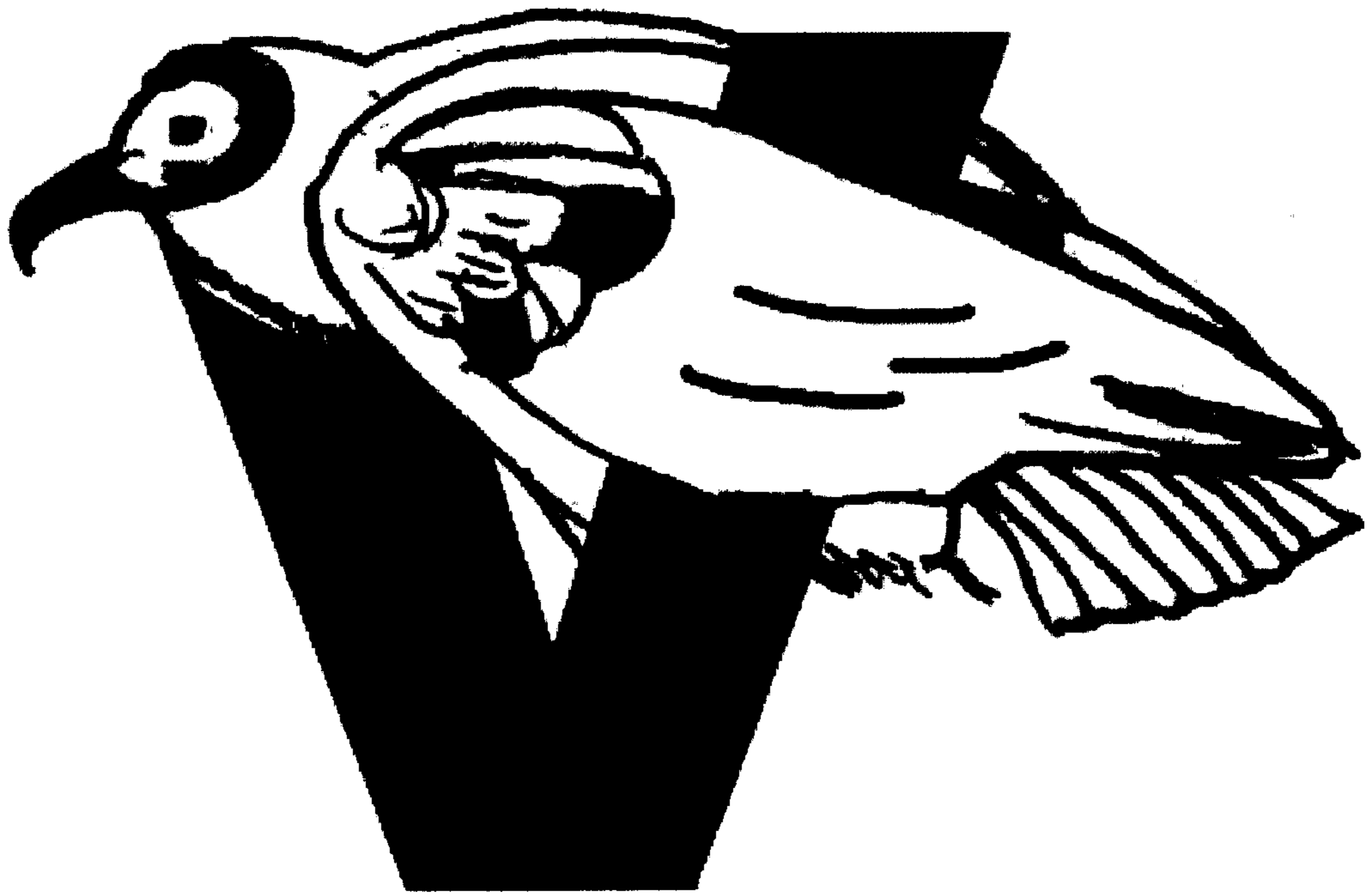
