(57) **CLAIM**

The ornamental design for a neck strap and chin cushion for neck stabilization during sit-ups, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevated view of a neck strap and chin cushion for neck stabilization during sit-ups showing my new design;

FIG. 2 is a rear elevated view of the neck strap and chin cushion for neck stabilization during sit-ups;

FIG. 3 is a right side elevated view of the neck strap and chin cushion for neck stabilization during sit-ups;

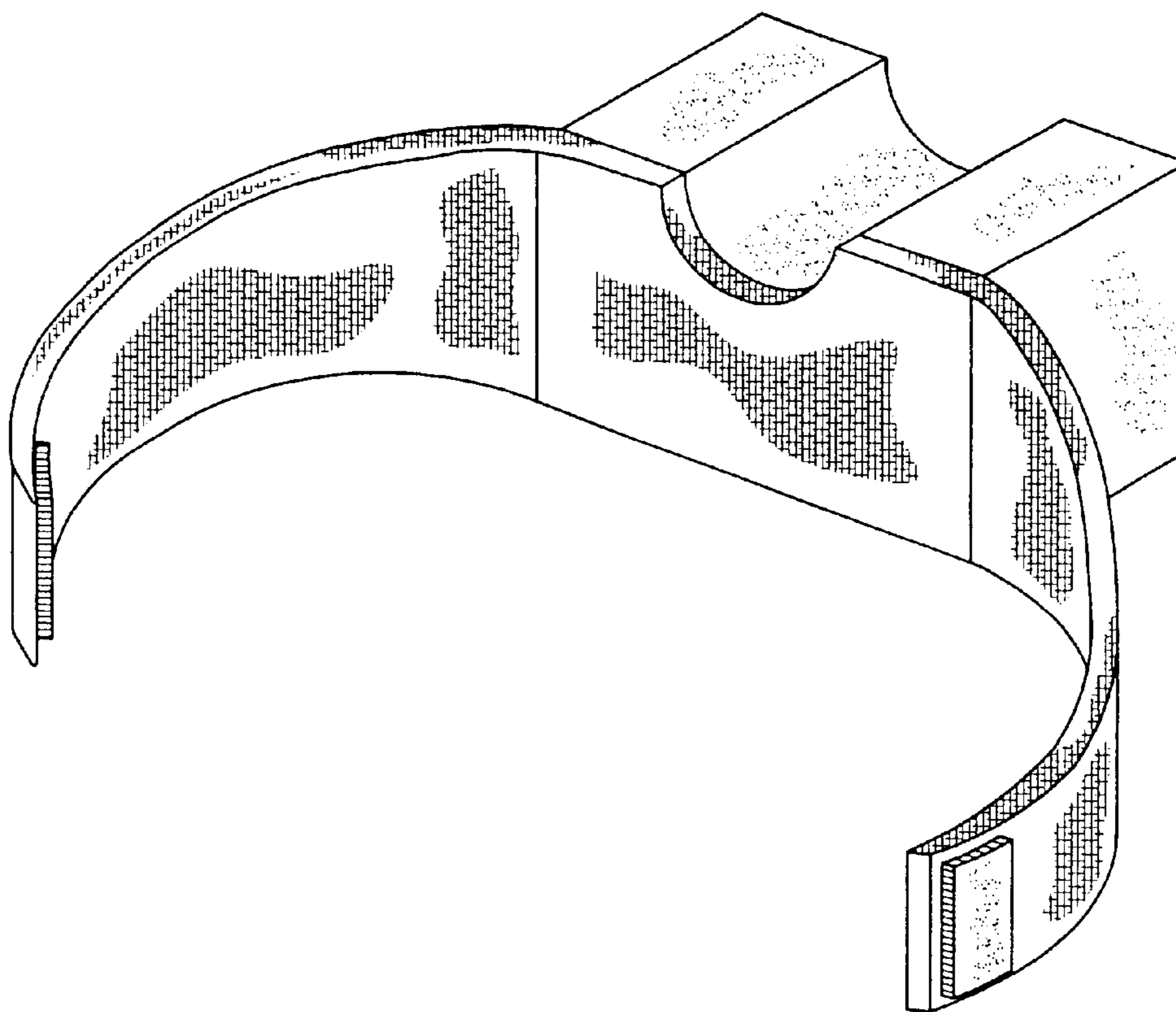
FIG. 4 is a left side elevated view of the neck strap and chin cushion for neck stabilization during sit-ups;

FIG. 5 is a top plan view of the neck strap and chin cushion for neck stabilization during sit-ups;

FIG. 6 is a bottom plan view of the neck strap and chin cushion for neck stabilization during sit-ups; and,

FIG. 7 is a perspective view of the neck strap and chin cushion showing the arms of the neck strap extending toward each other.

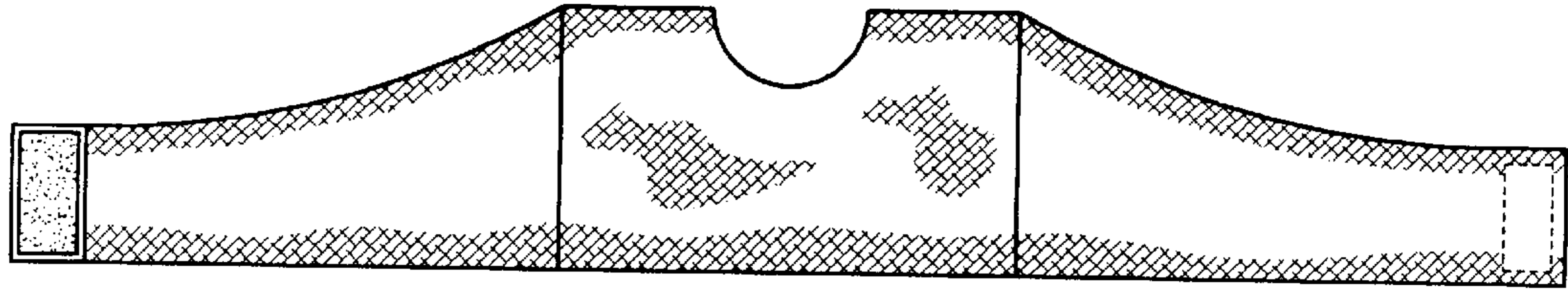

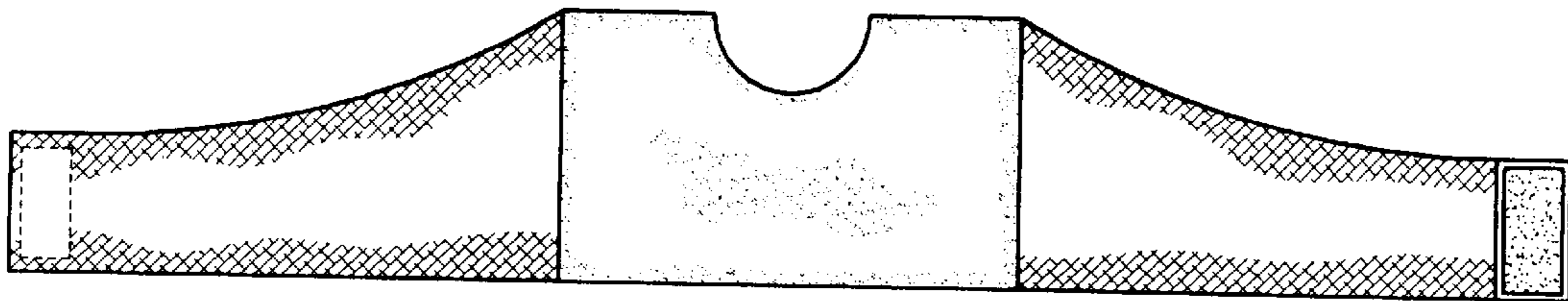

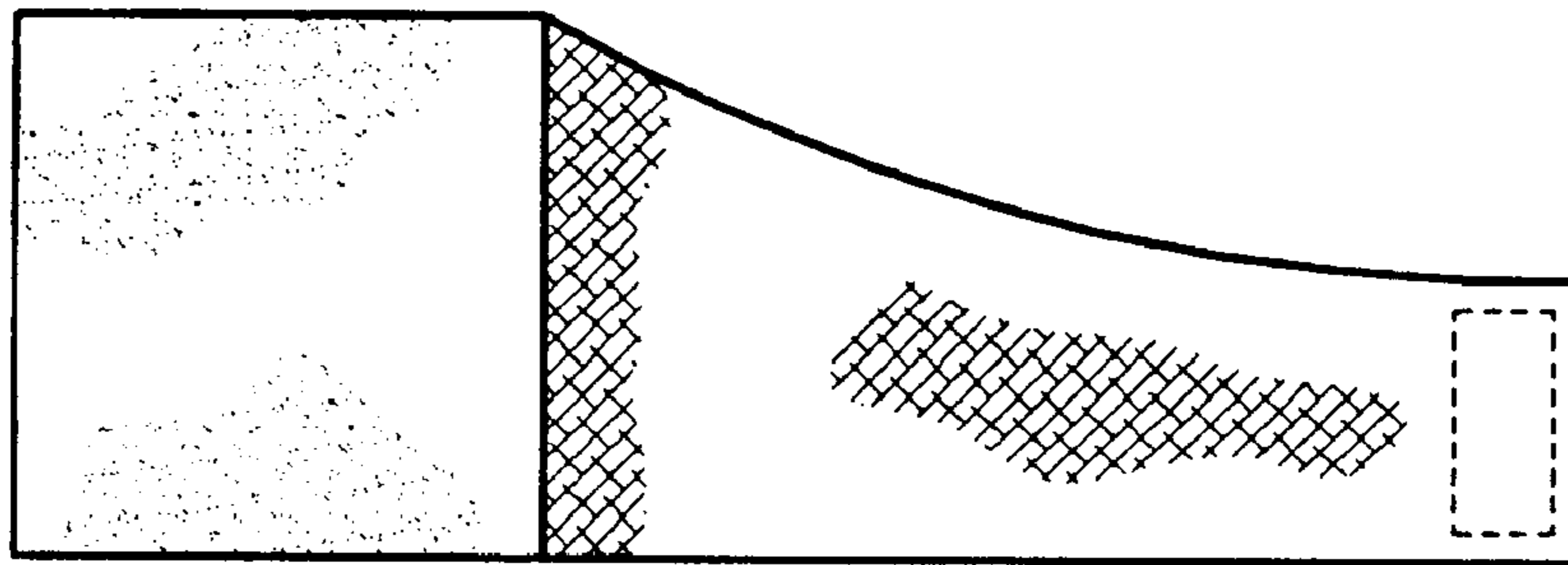

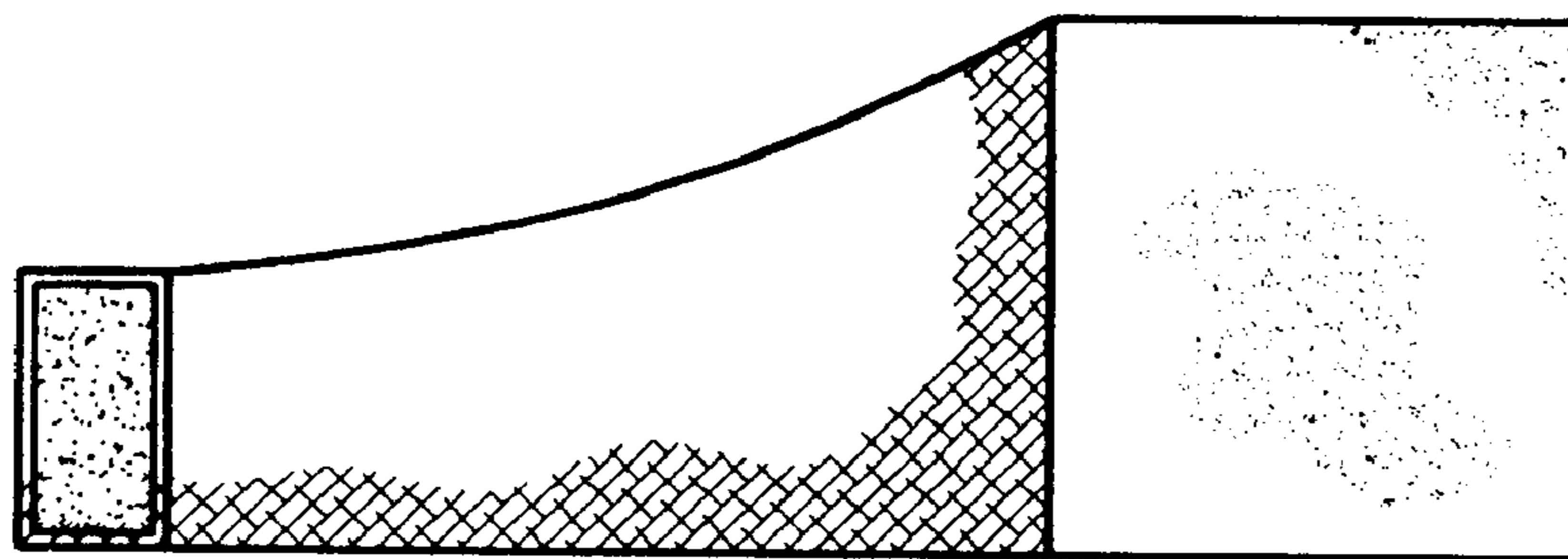

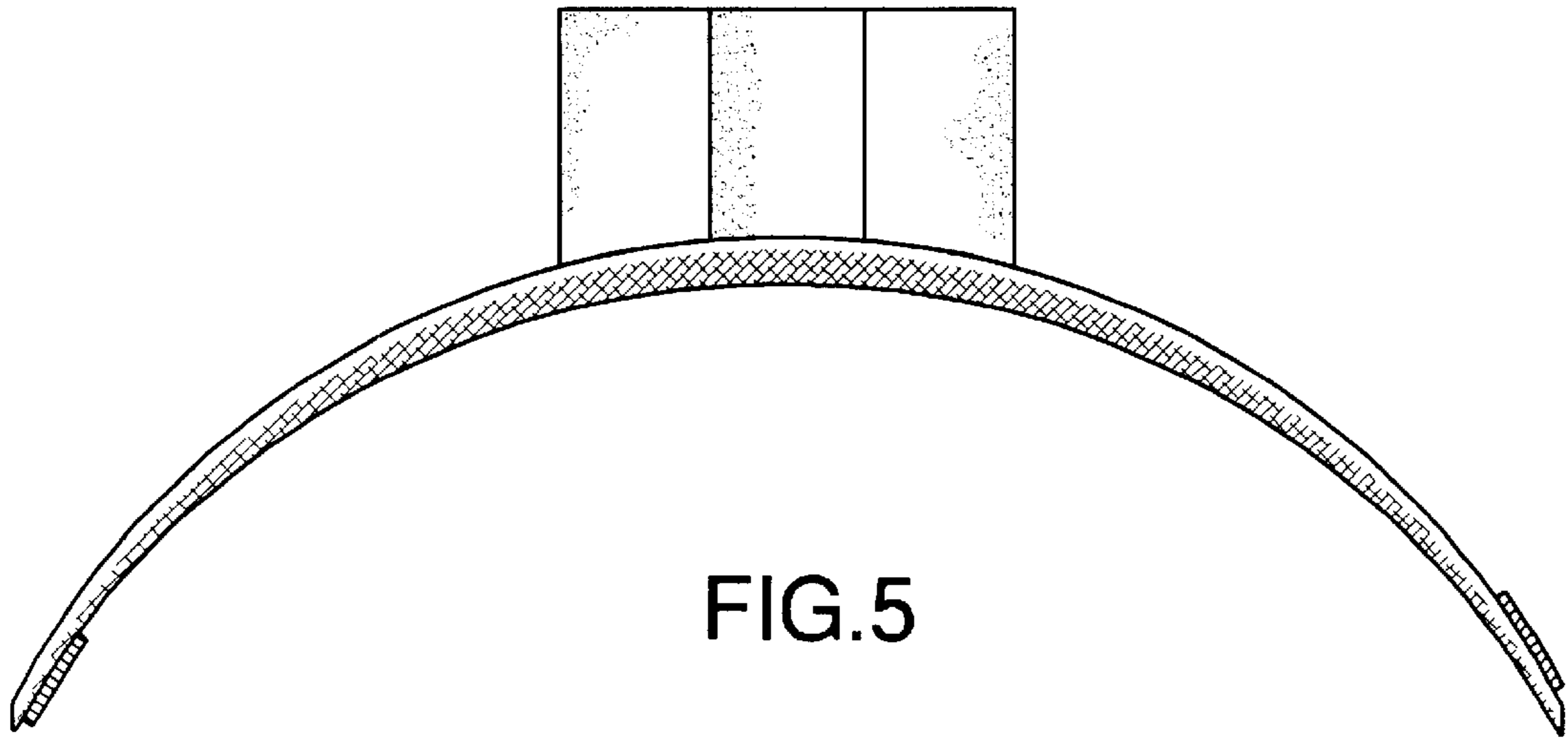

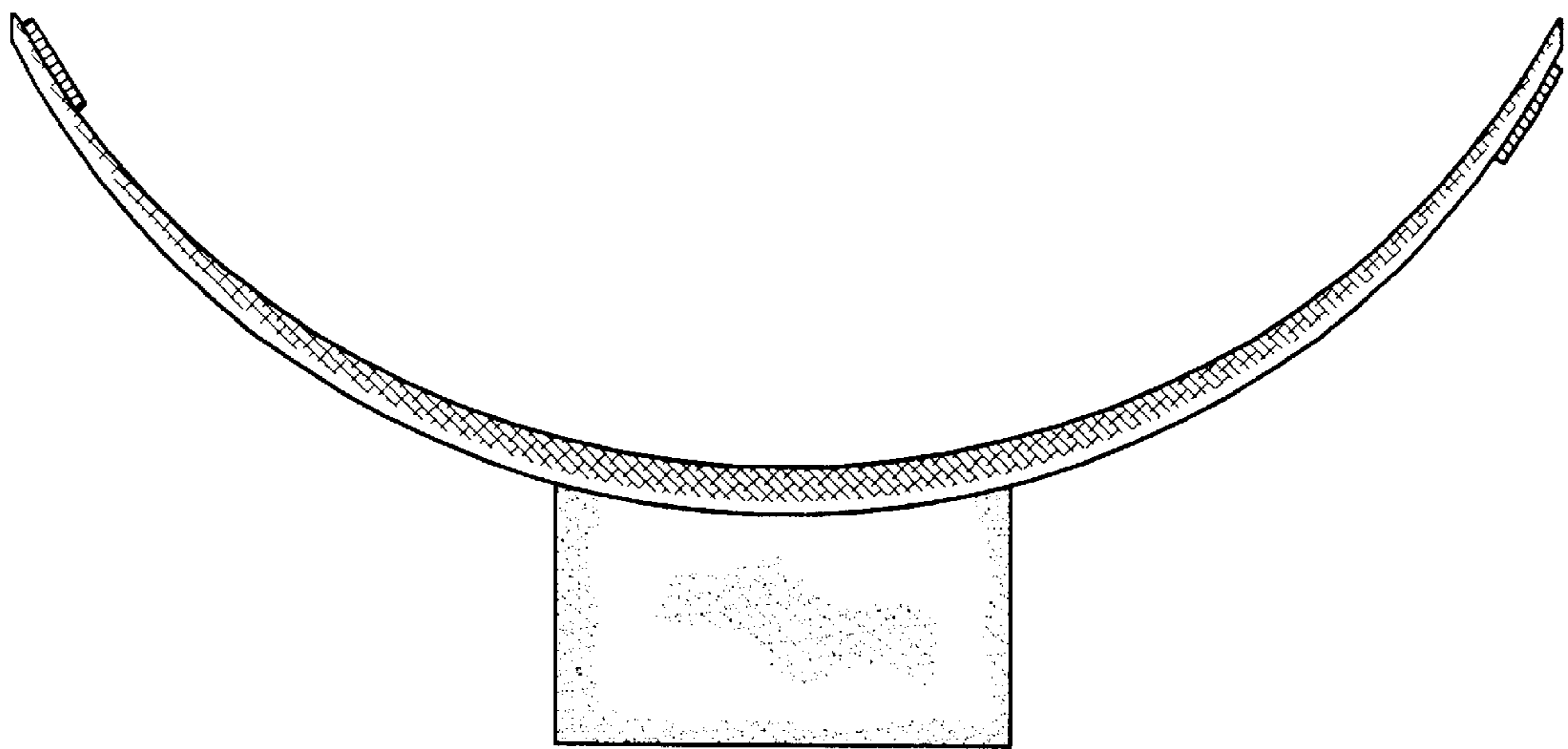

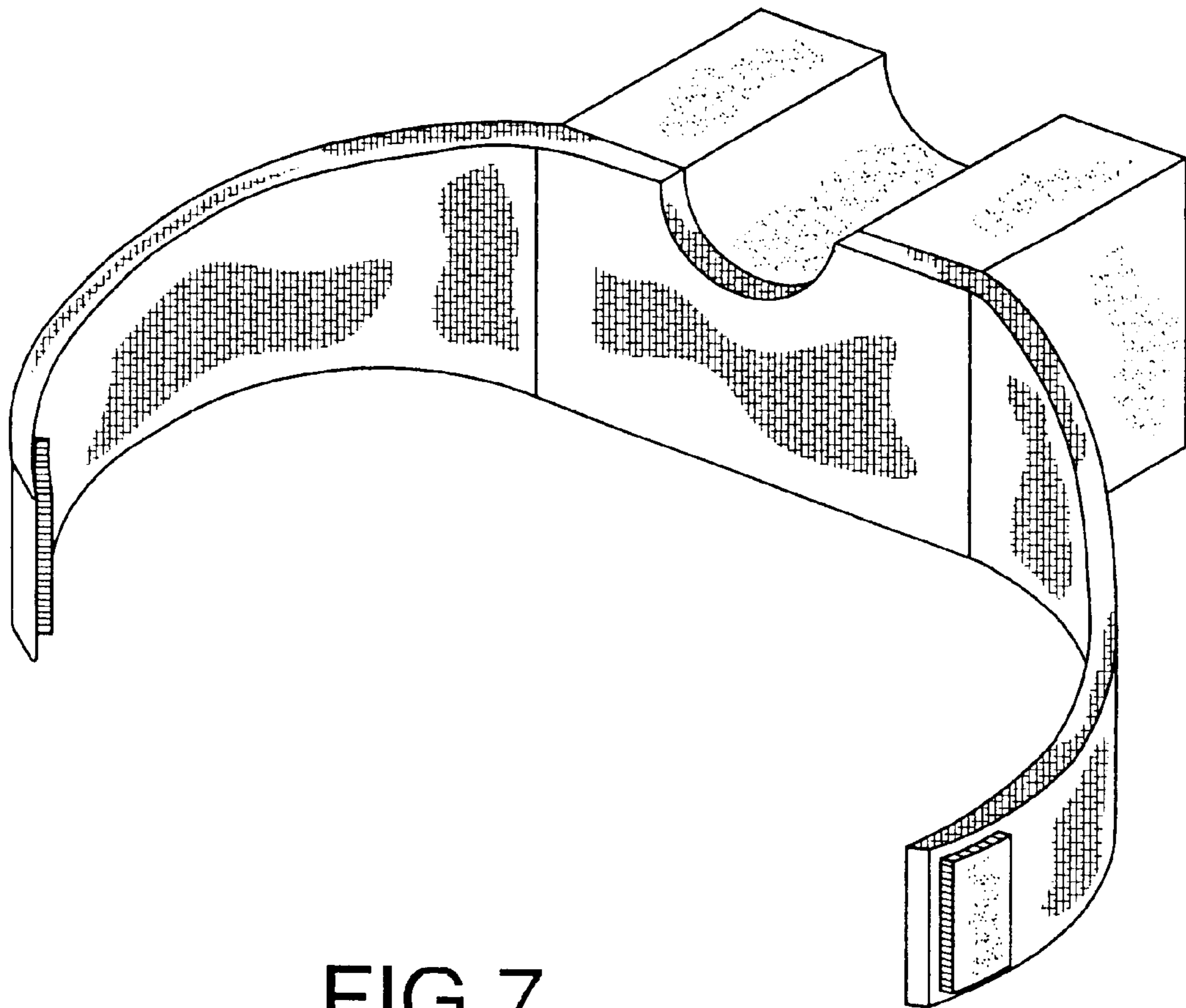
