(57) **CLAIM**

The ornamental design for a lavatory unit of aircraft, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the lavatory unit of aircraft.

FIG. 2 is a rear elevational view thereof.

FIG. 3 is a right side elevational view thereof.

FIG. 4 is a left side elevational view thereof.

FIG. 5 is a top view thereof.

FIG. 6 is a bottom view thereof.

FIG. 7 is a cross-sectional view thereof along VII—VII with a pivotally movable step retracted (see on the lower right side).

FIG. 8 is a cross-sectional view thereof along VII—VII with a pivotally movable step extended.

FIG. 9 is a cross-sectional view thereof along IX—IX.

FIG. 10 is a cross-sectional view thereof along X—X with a pivotally movable diaper changing table retracted (see on the middle left side).

FIG. 11 is a cross-sectional view thereof along X—X with a pivotally movable diaper changing table extended.

FIG. 12 is a cross-sectional view thereof along XII—XII with a pivotally movable step retracted (see on the lower right side).

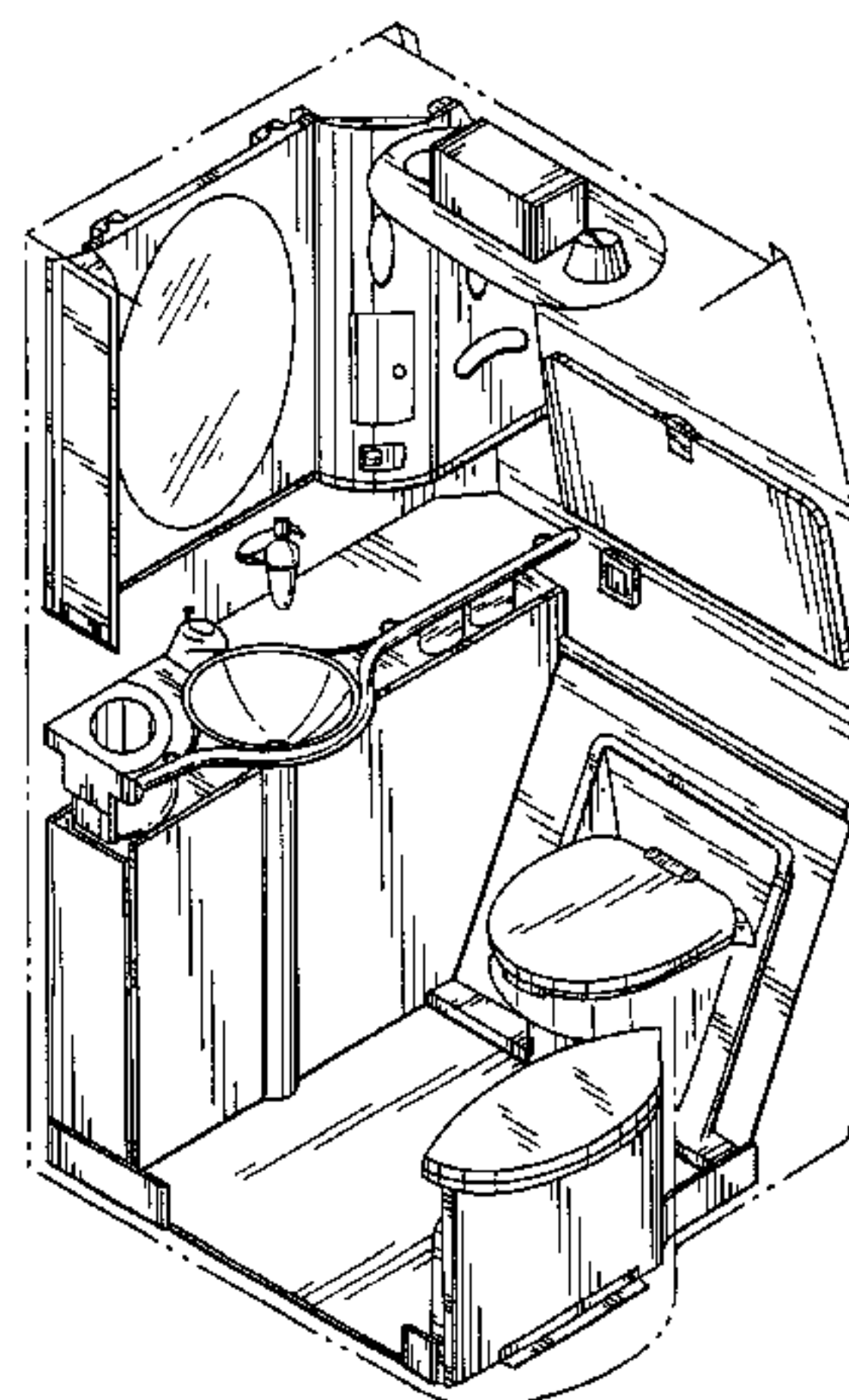
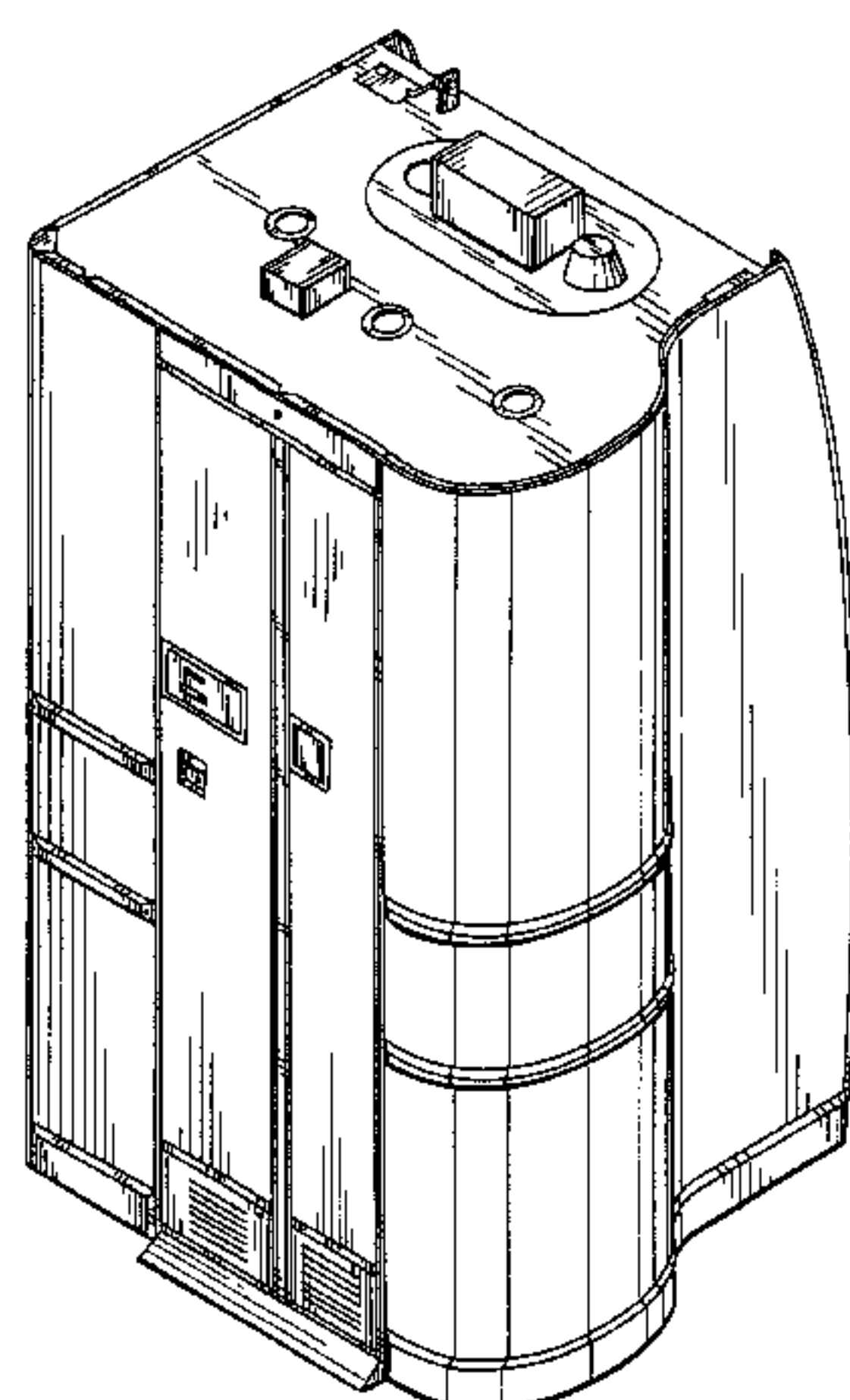
FIG. 13 is a cross-sectional view thereof along XII—XII with a pivotally movable step extended.

FIG. 15 is a right side perspective view thereof with the door open.

FIG. 17 is a top perspective view thereof with the roof removed.

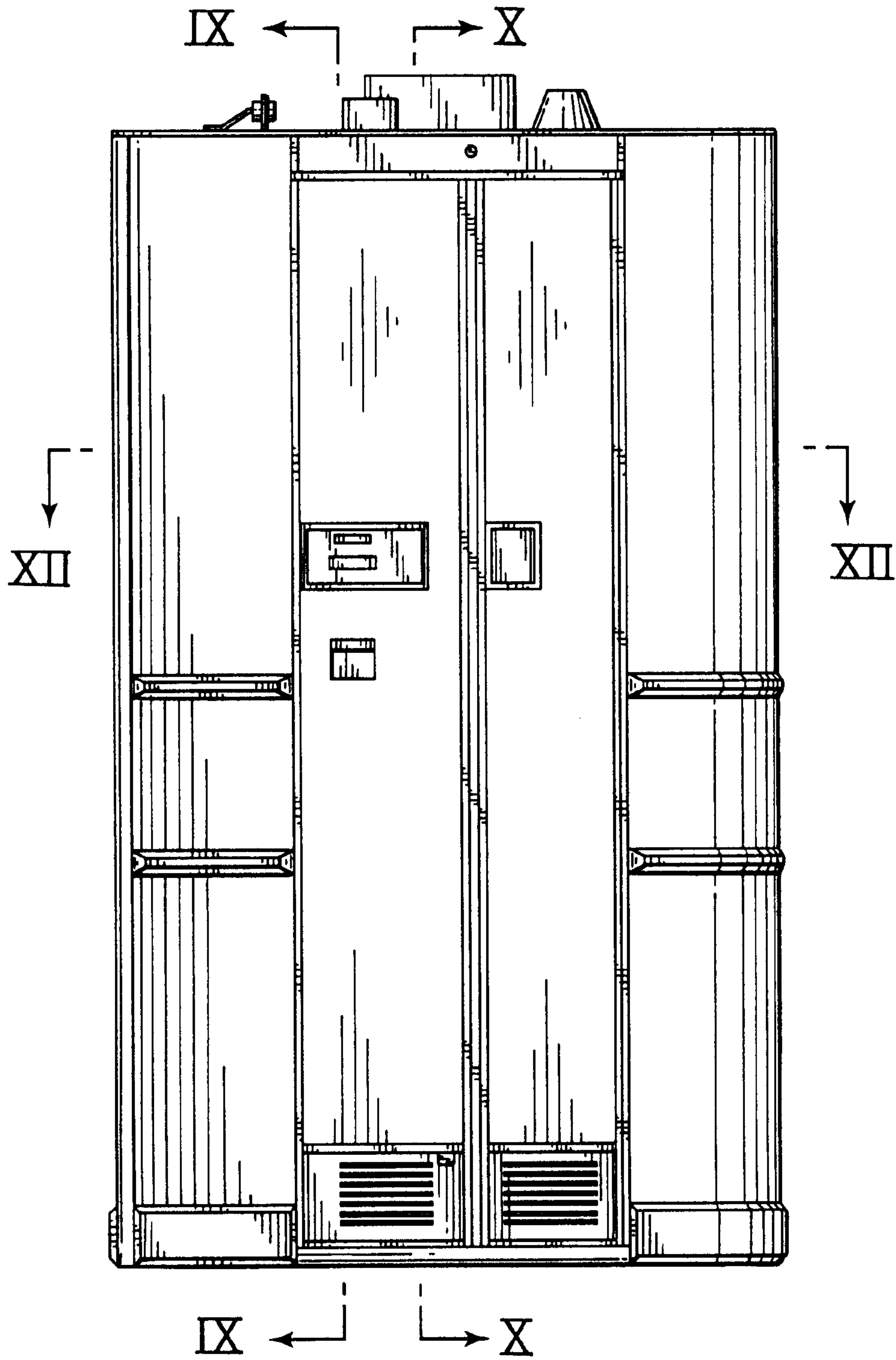

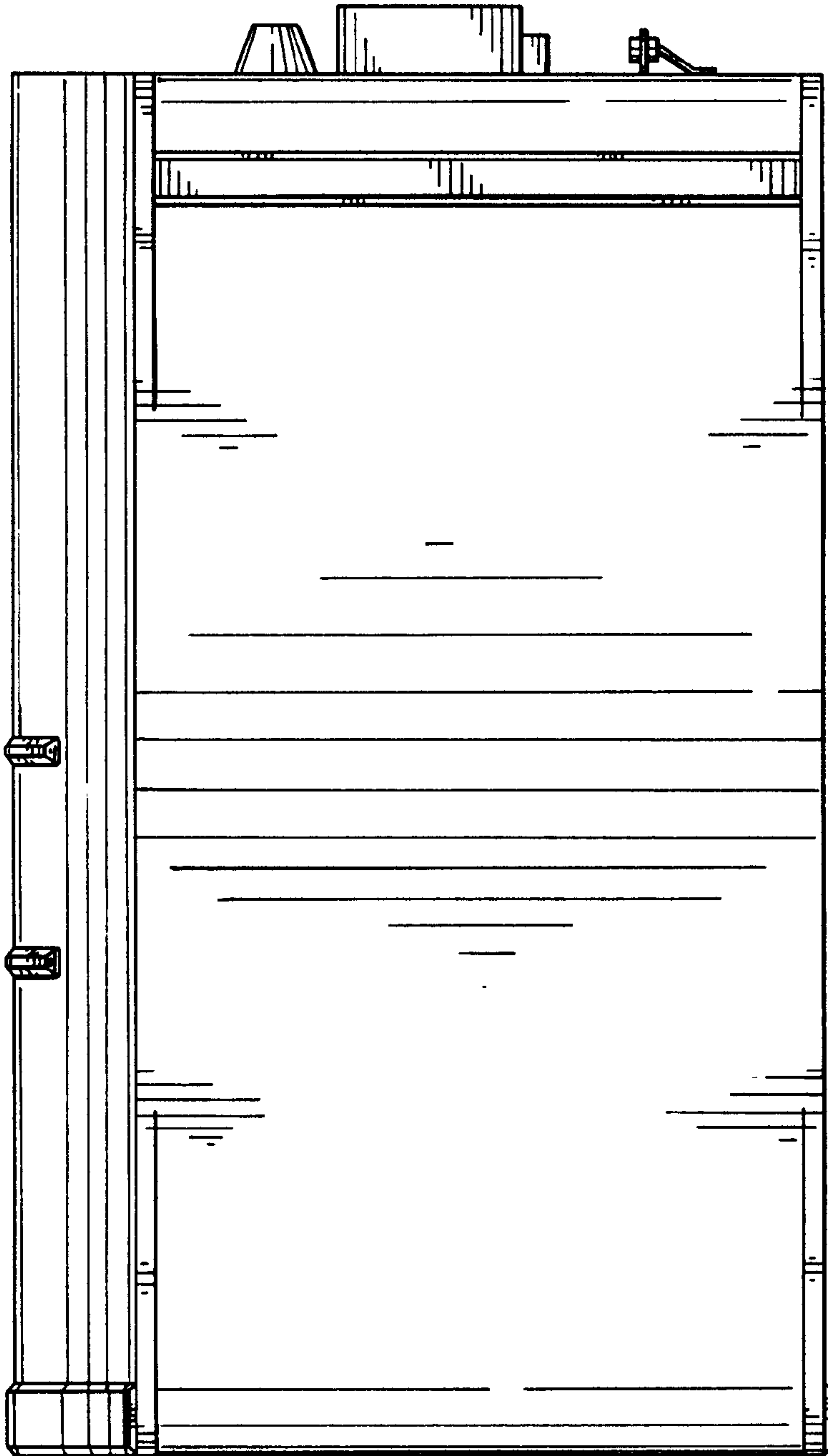

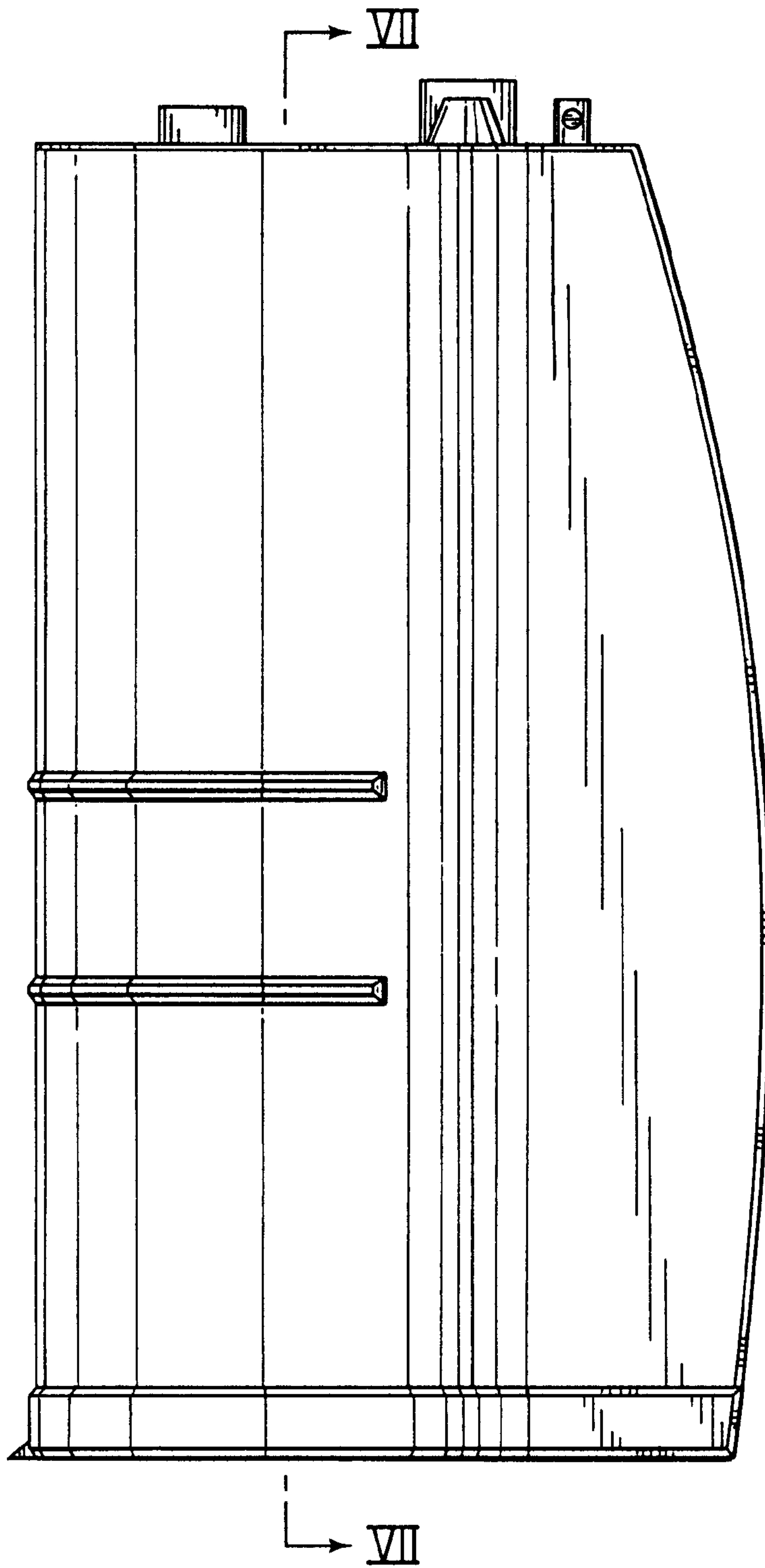

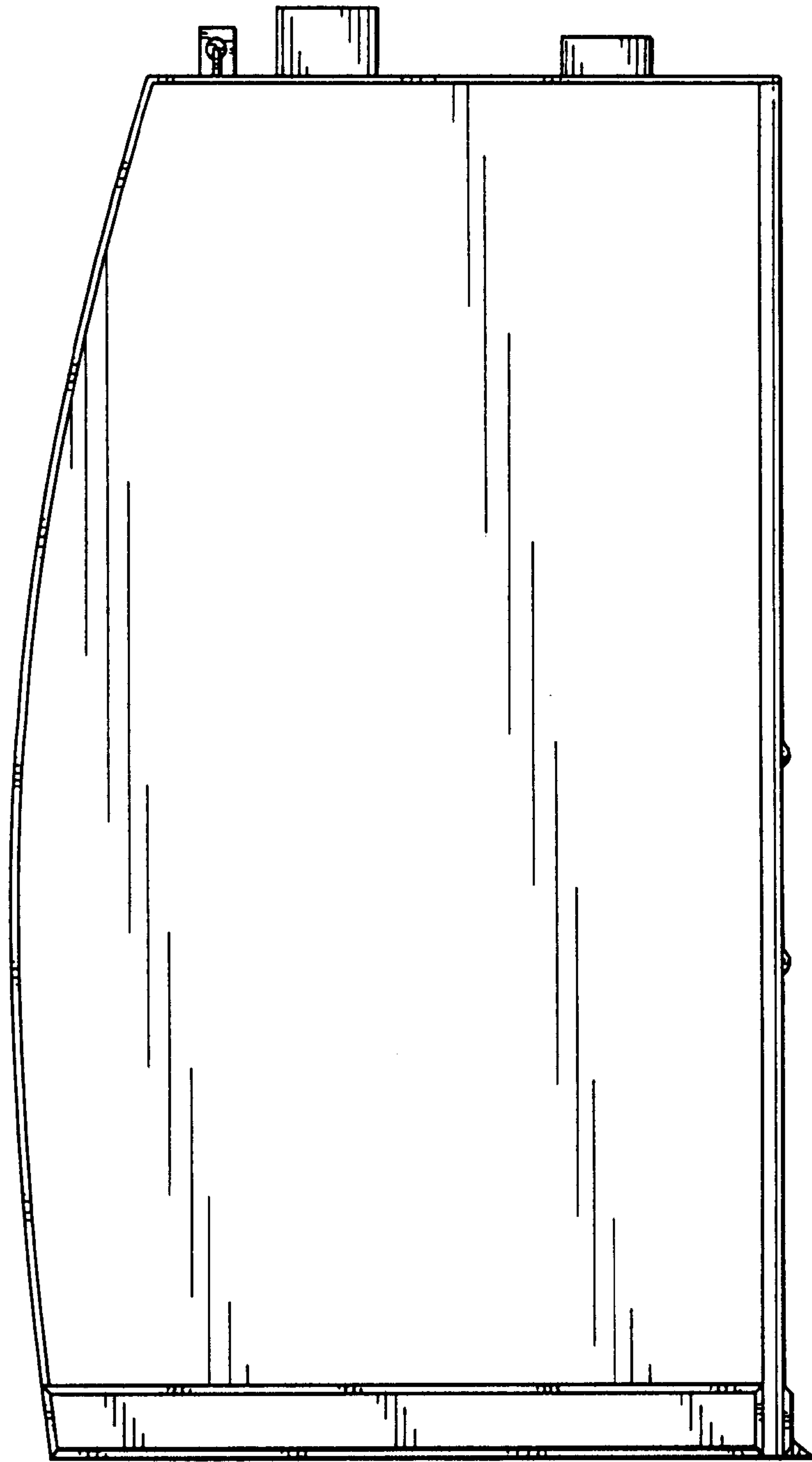

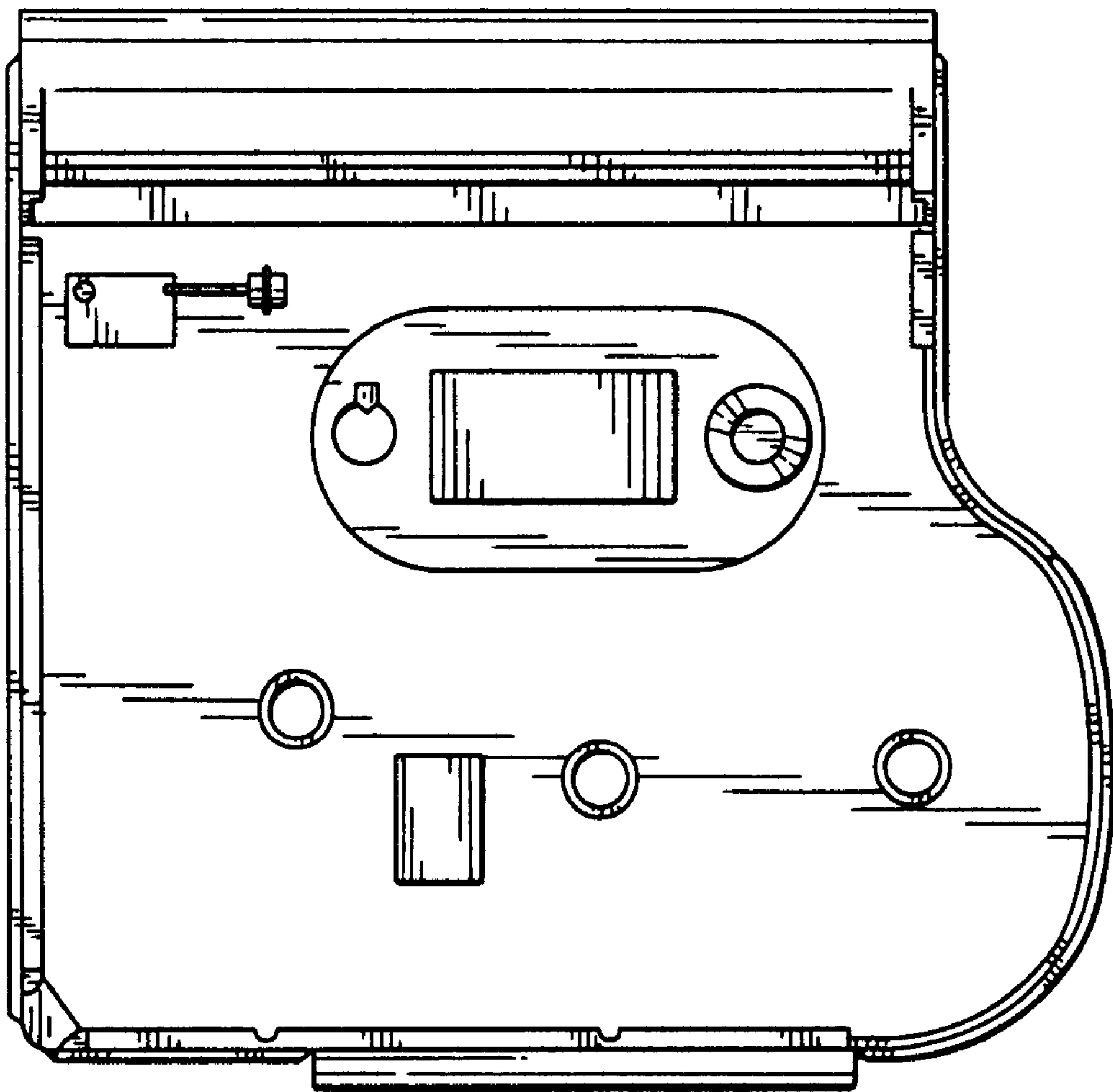

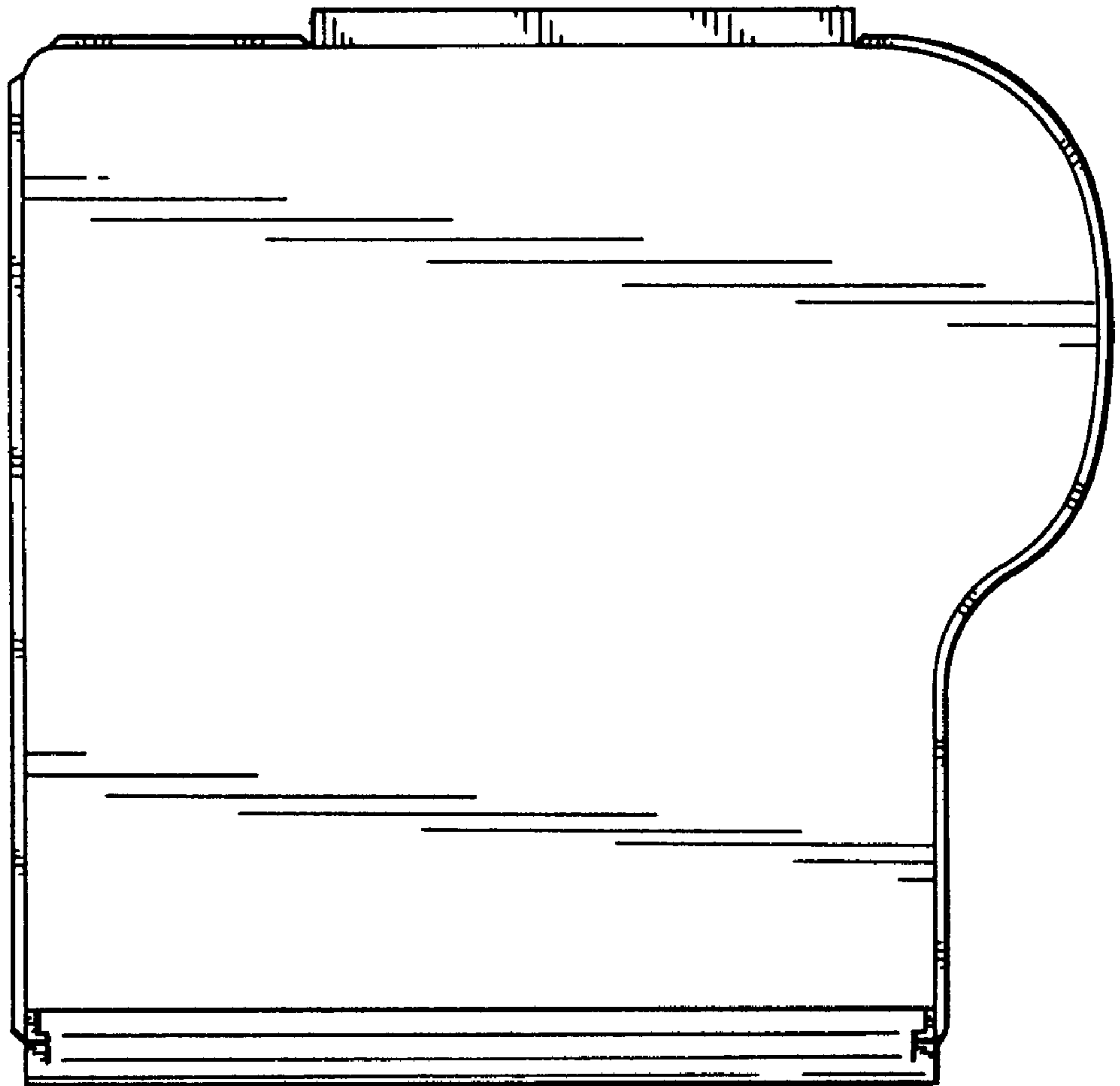

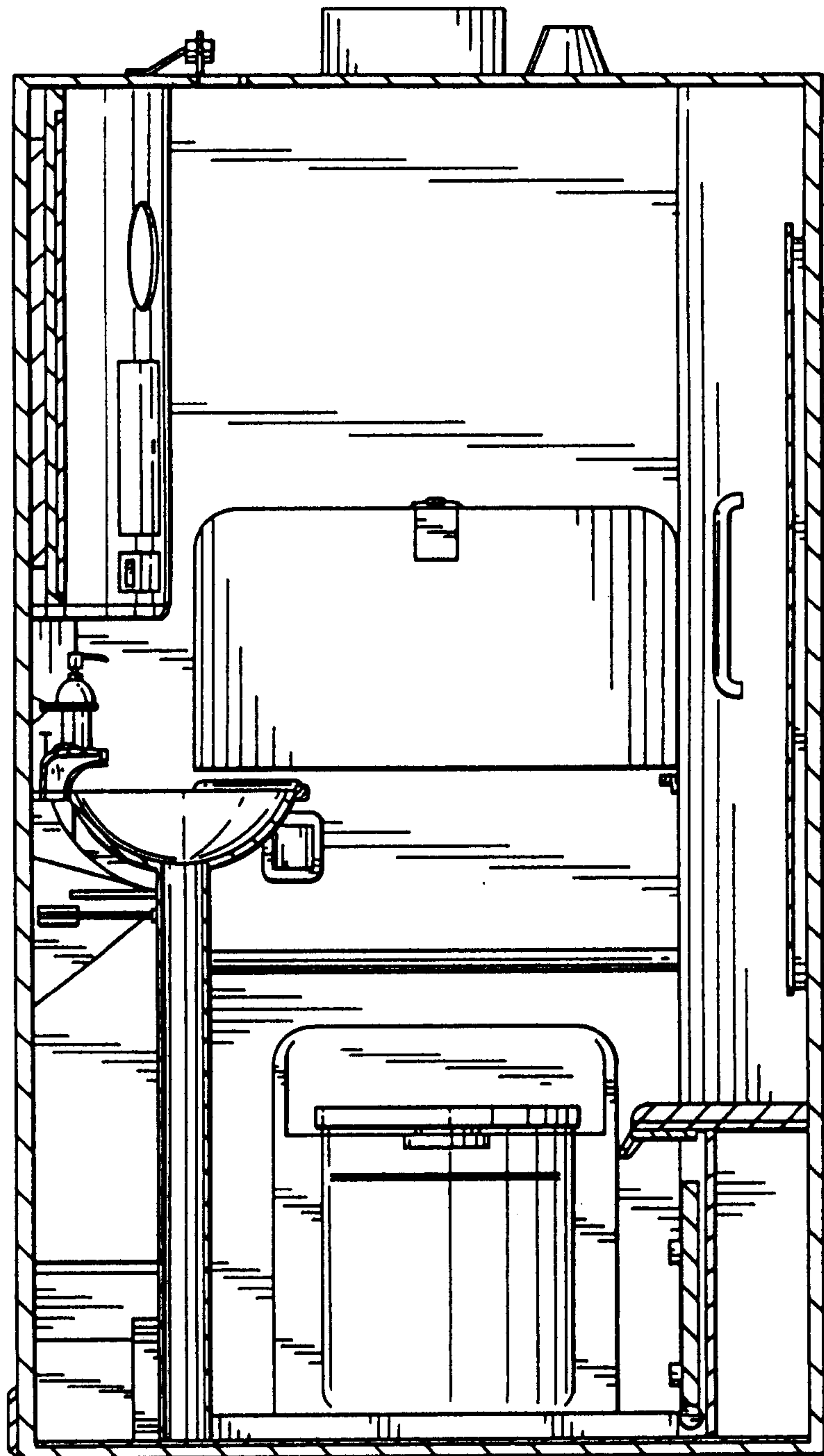

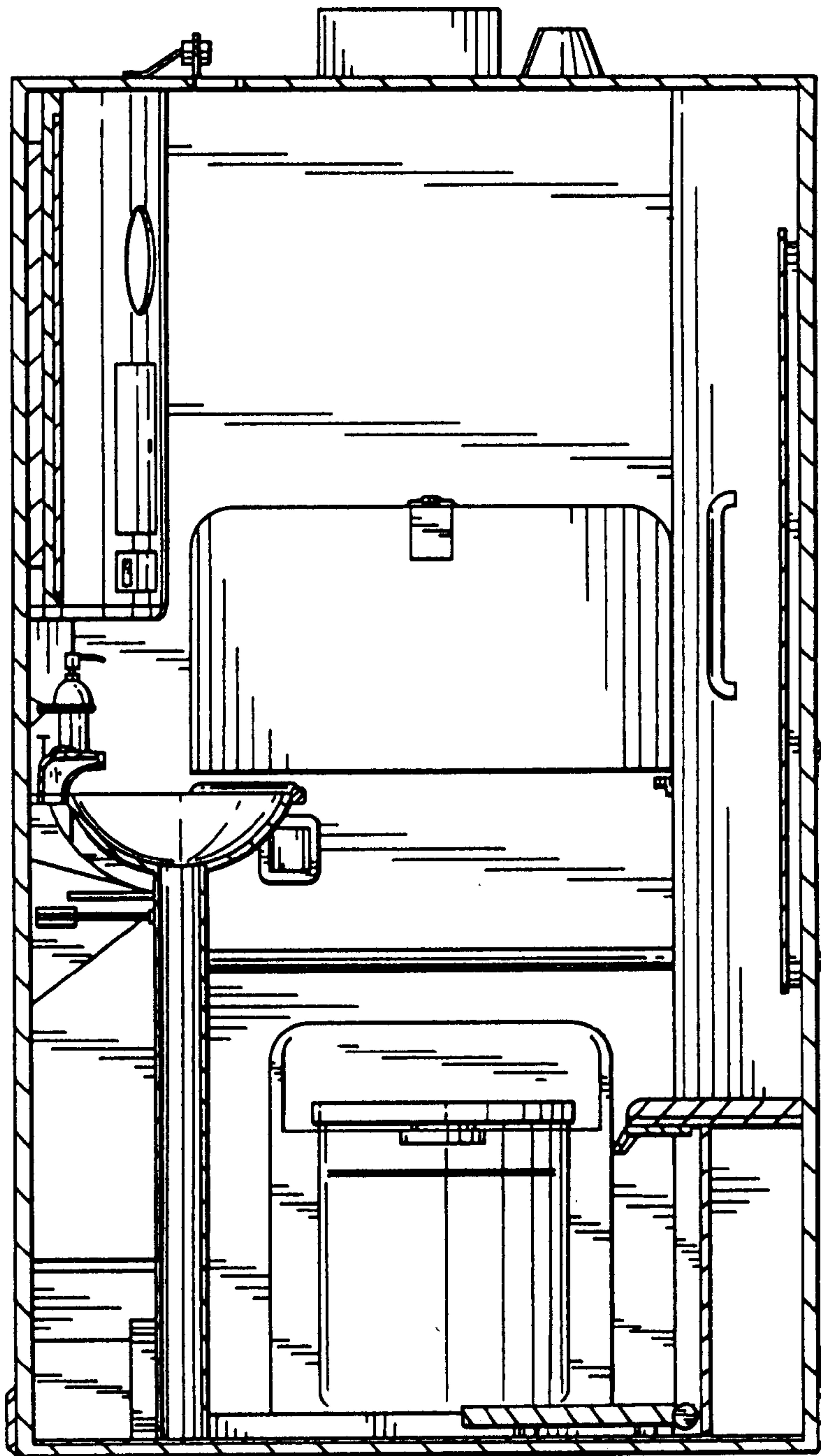

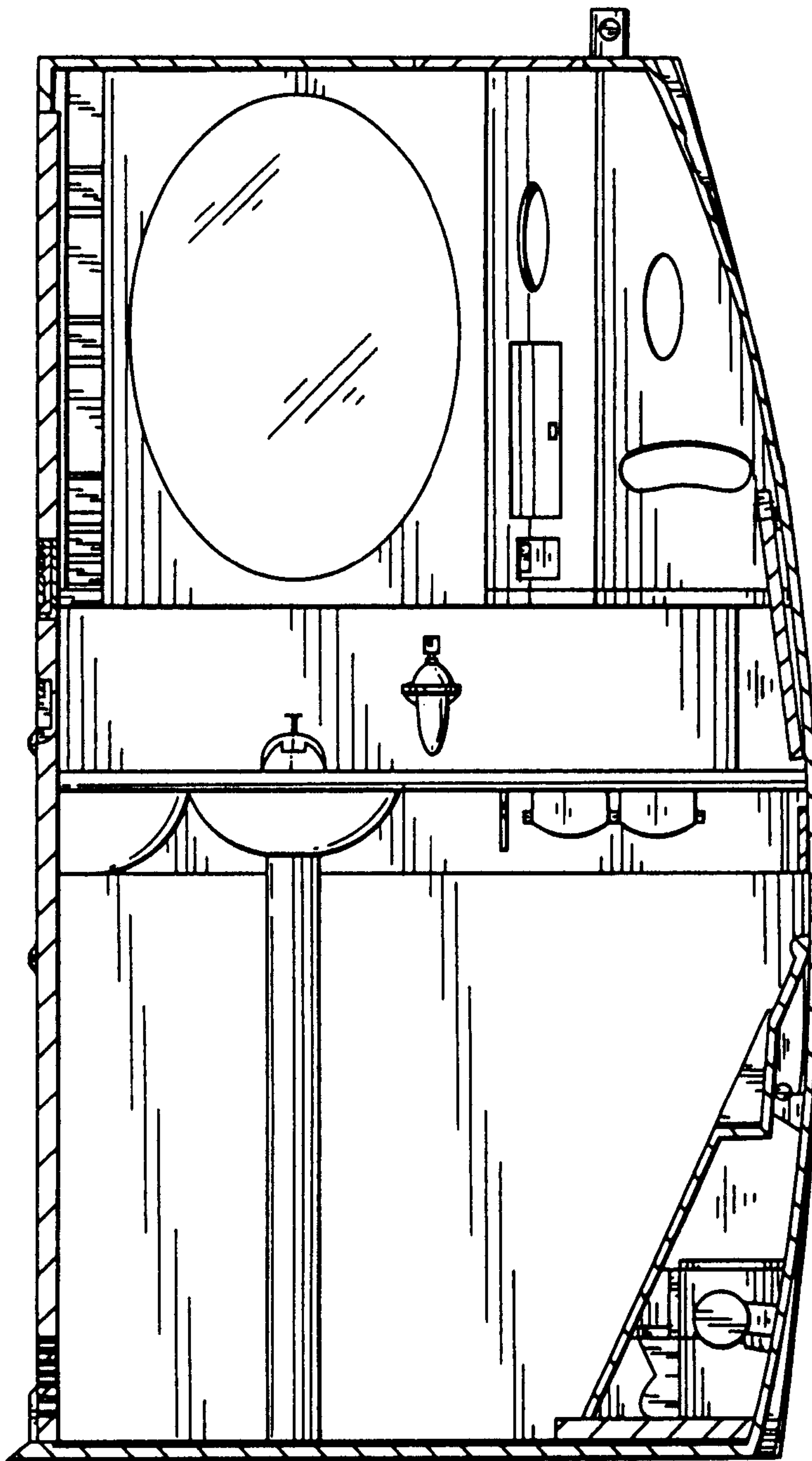

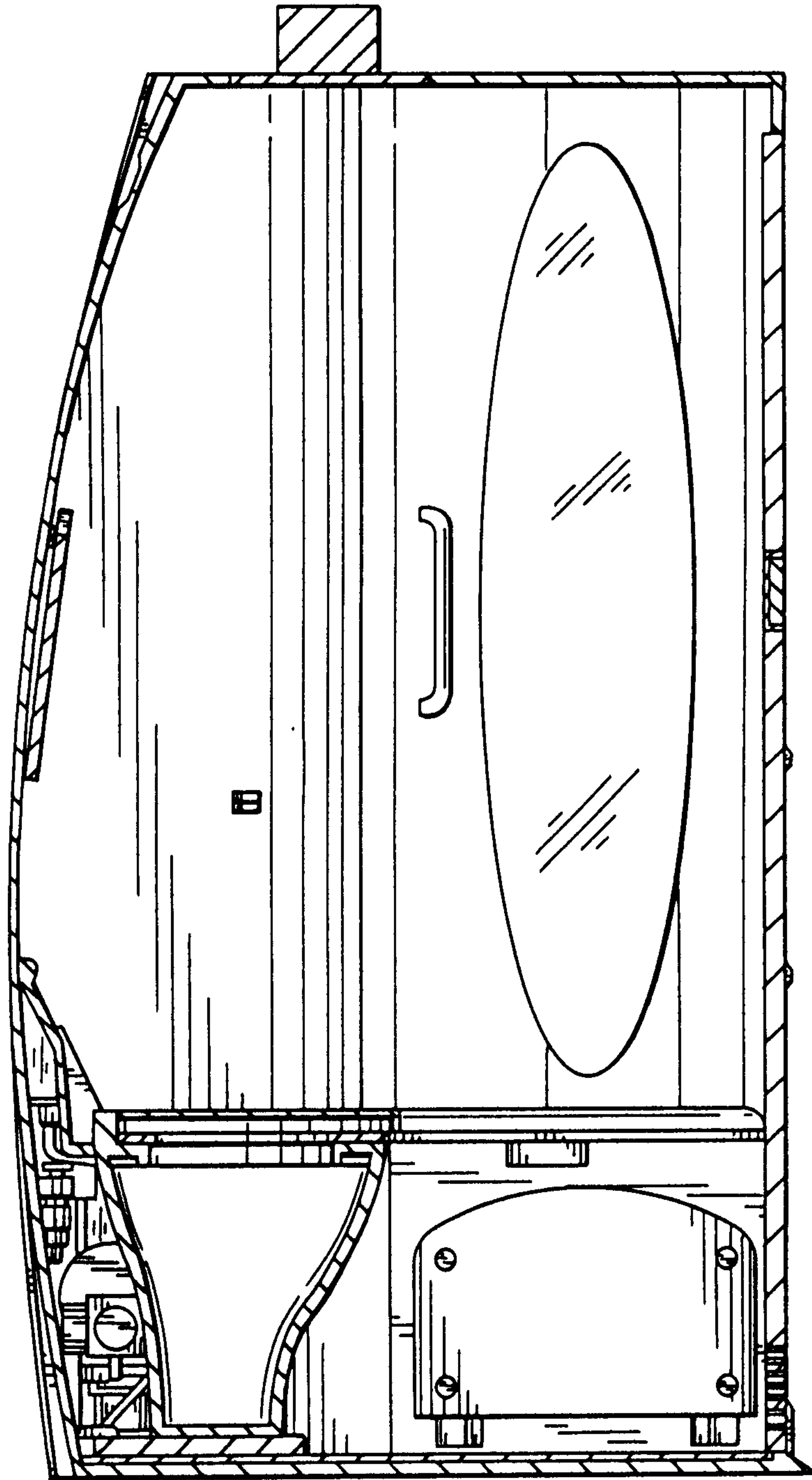

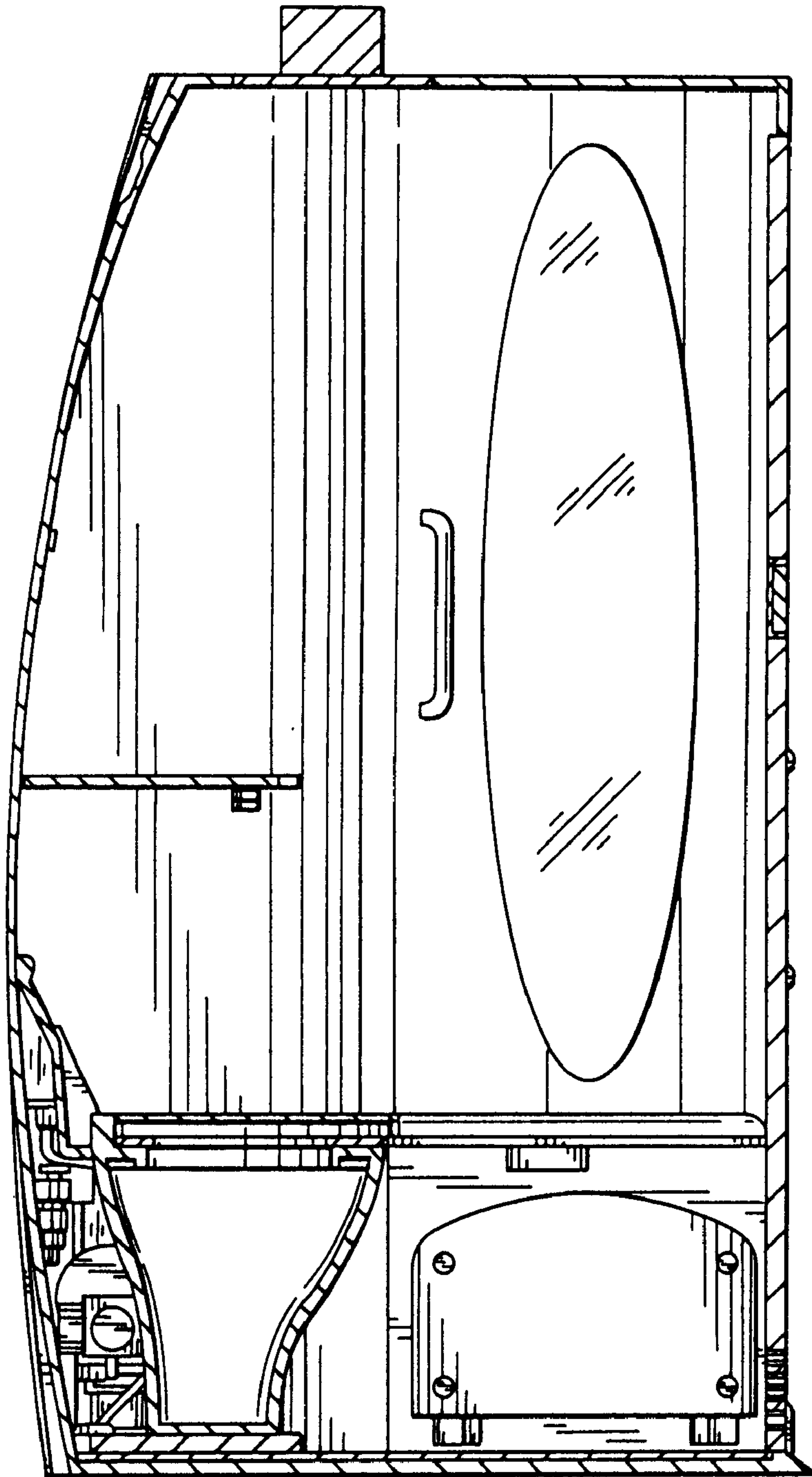

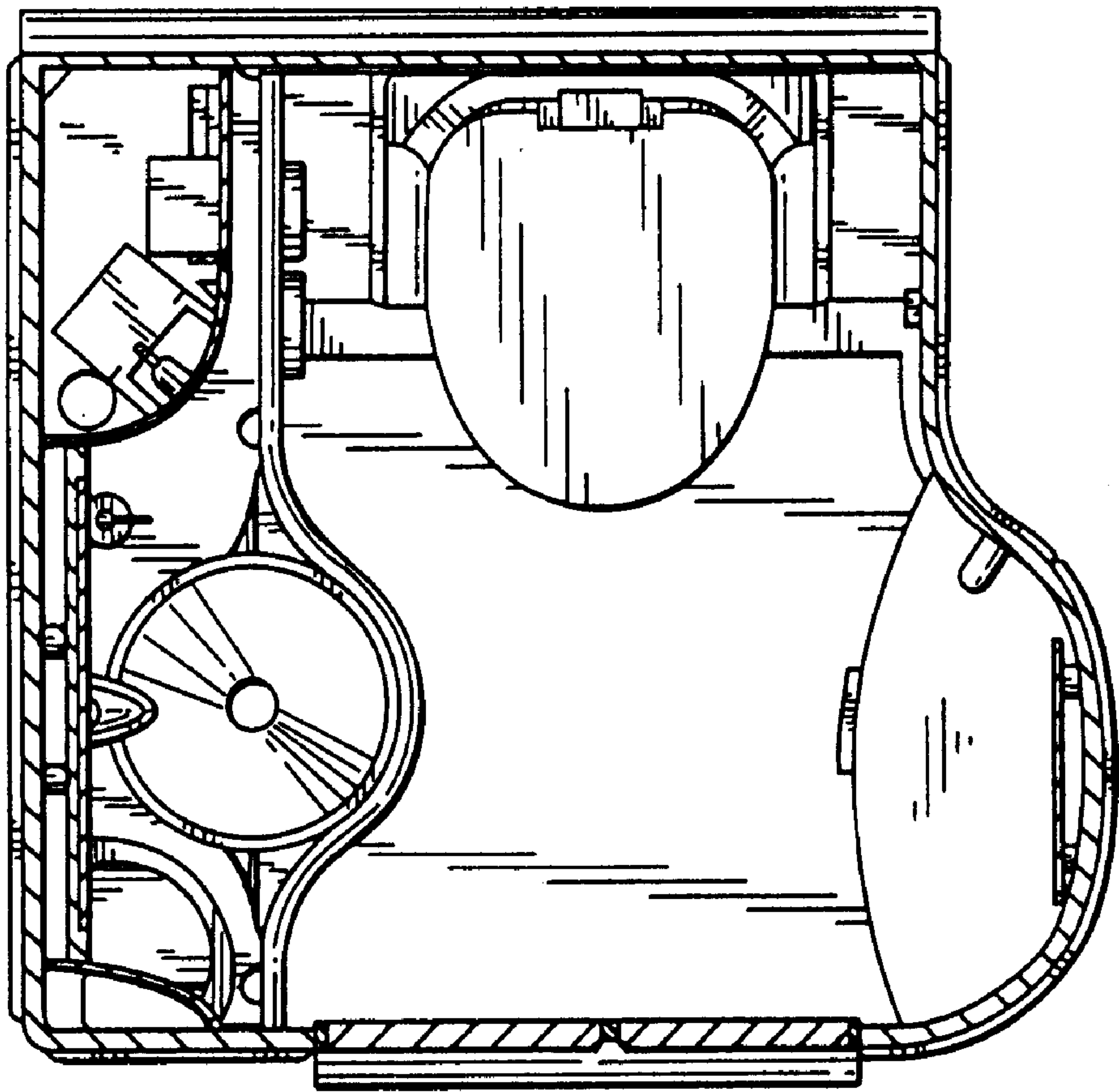

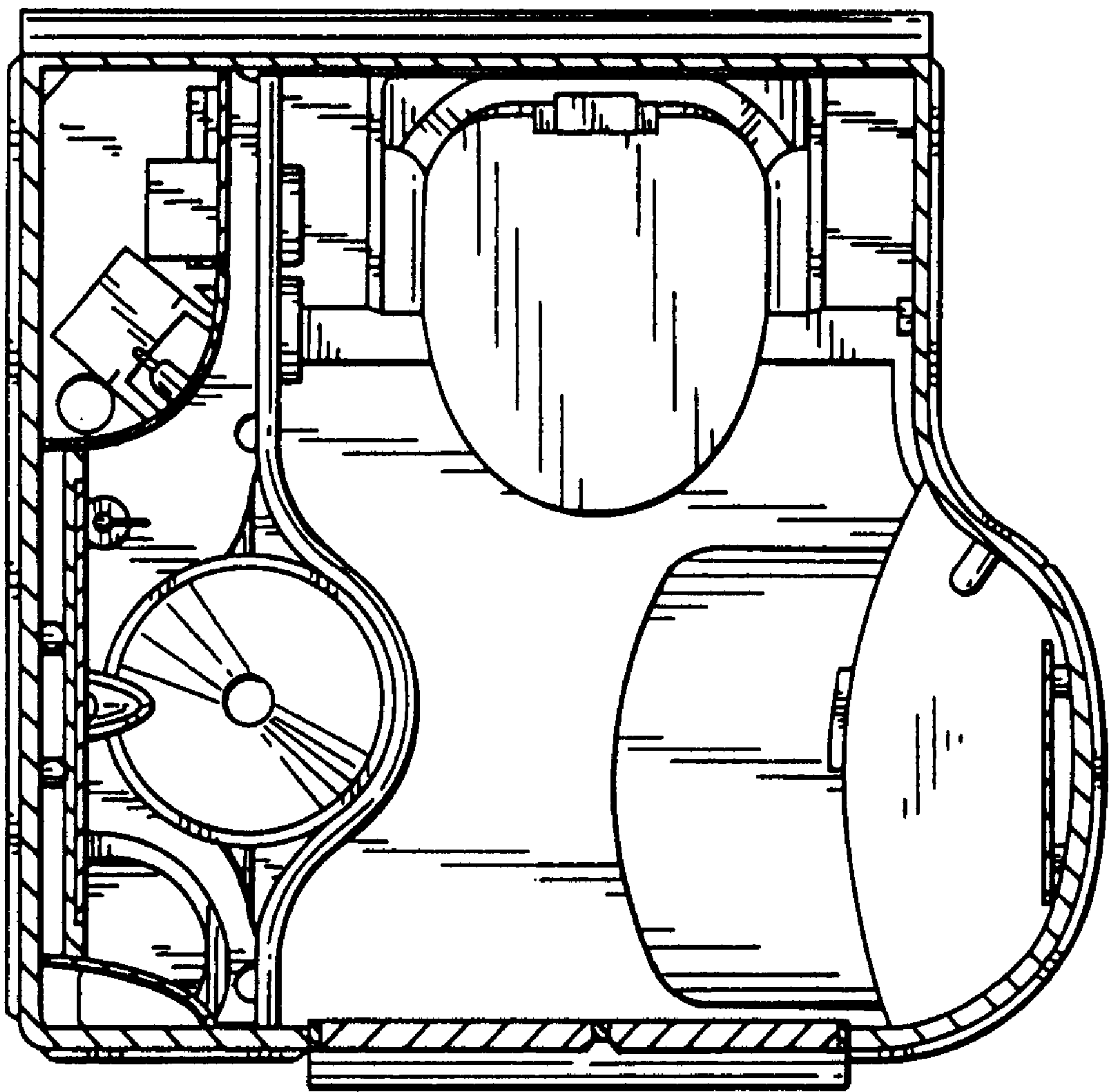

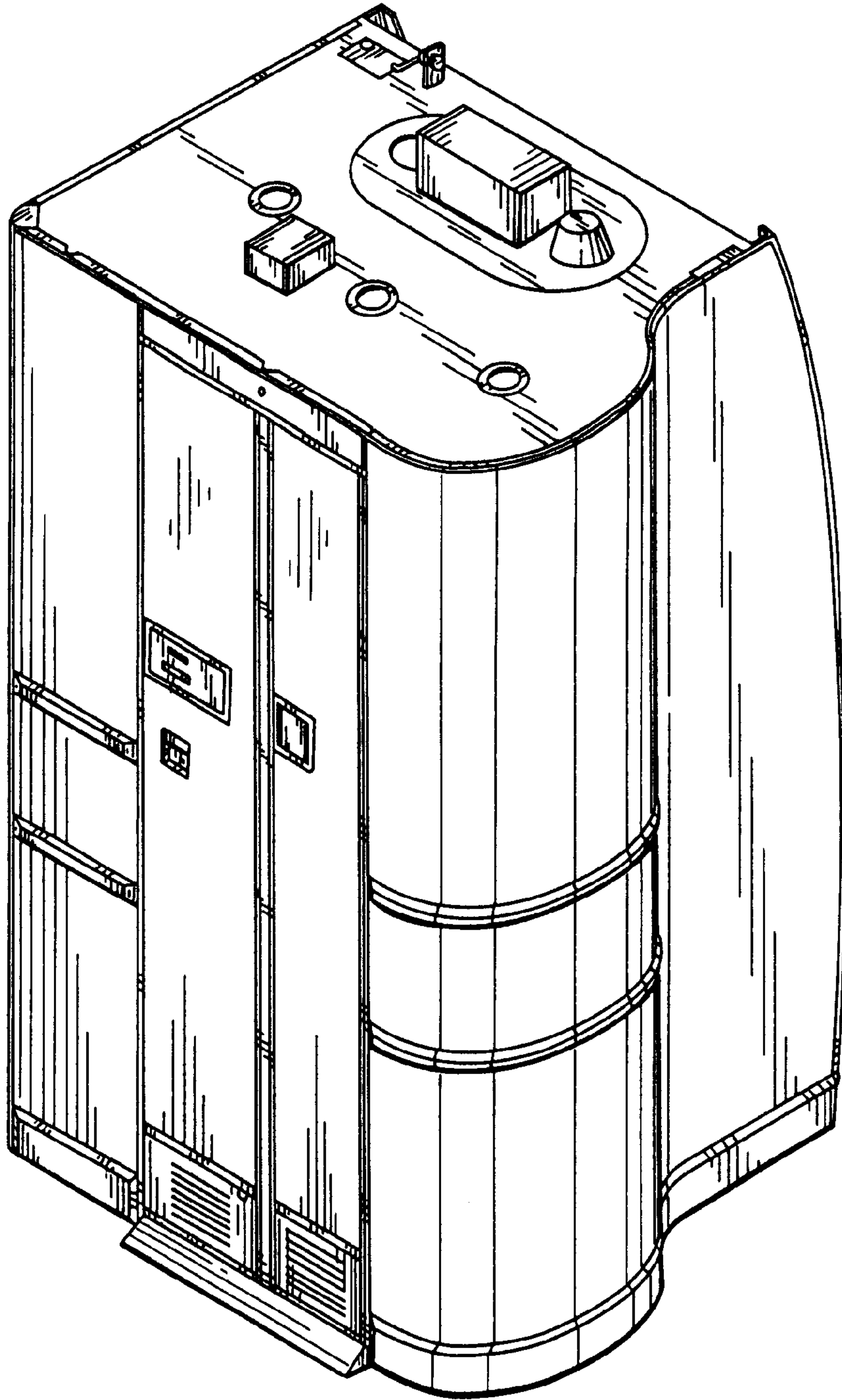

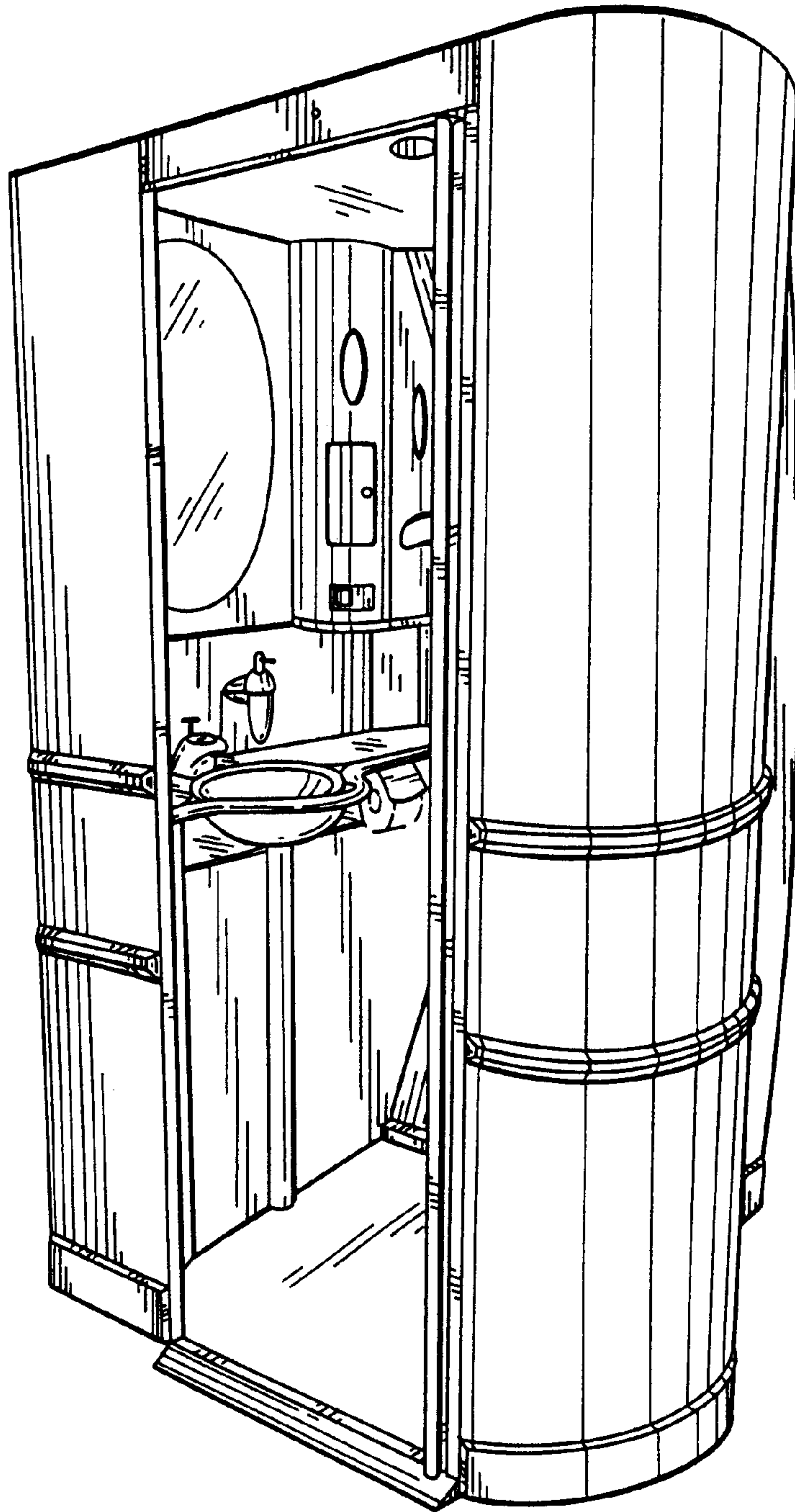

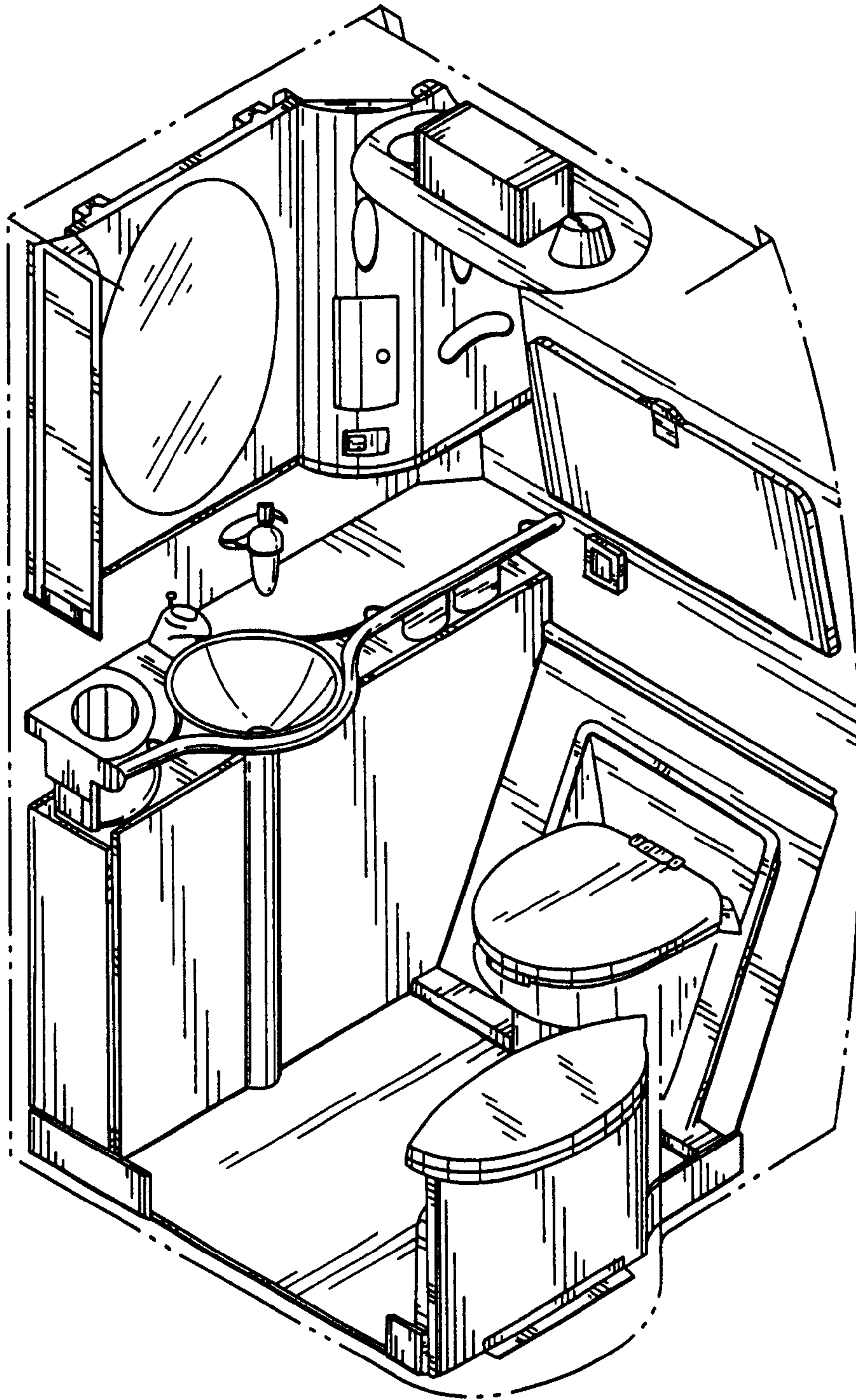
