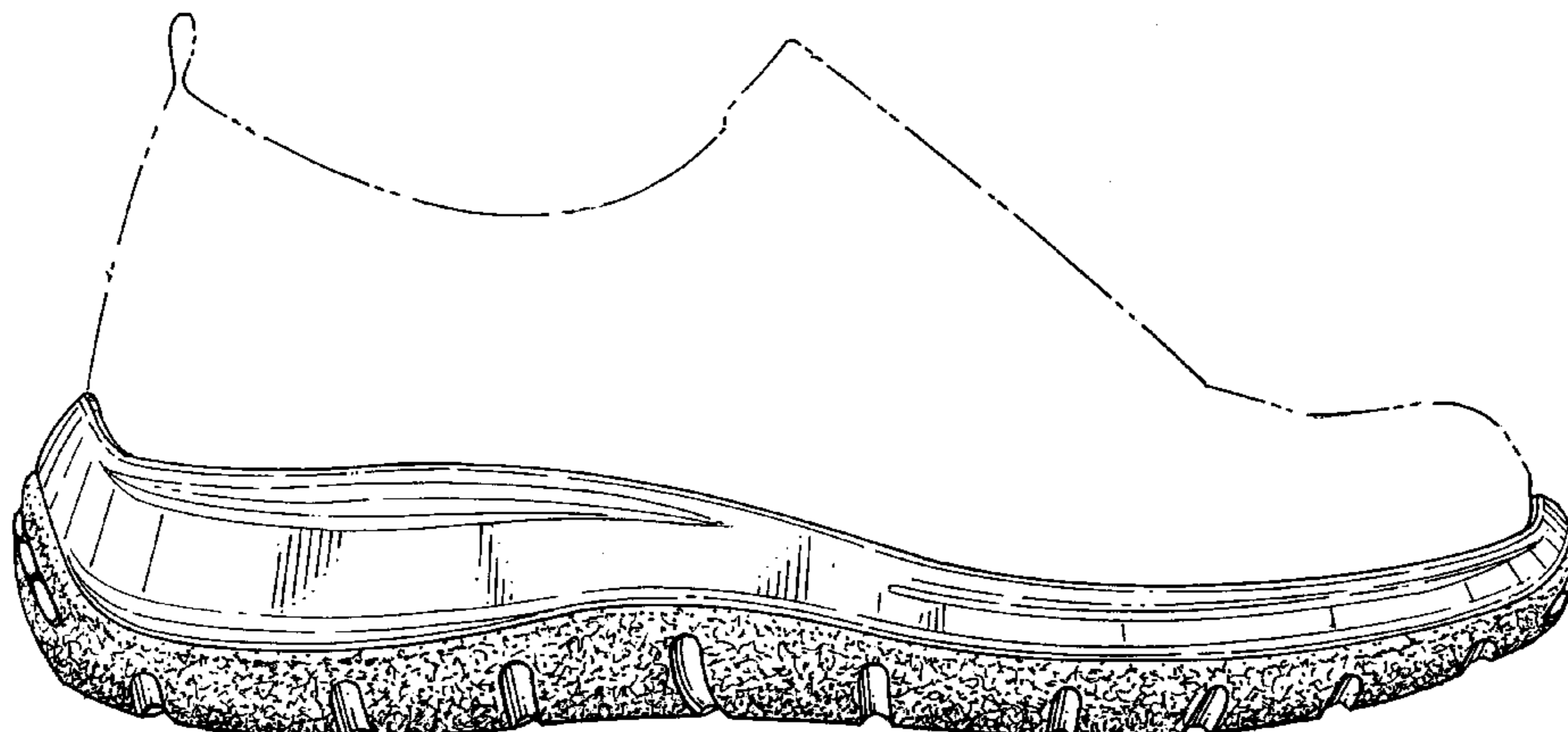
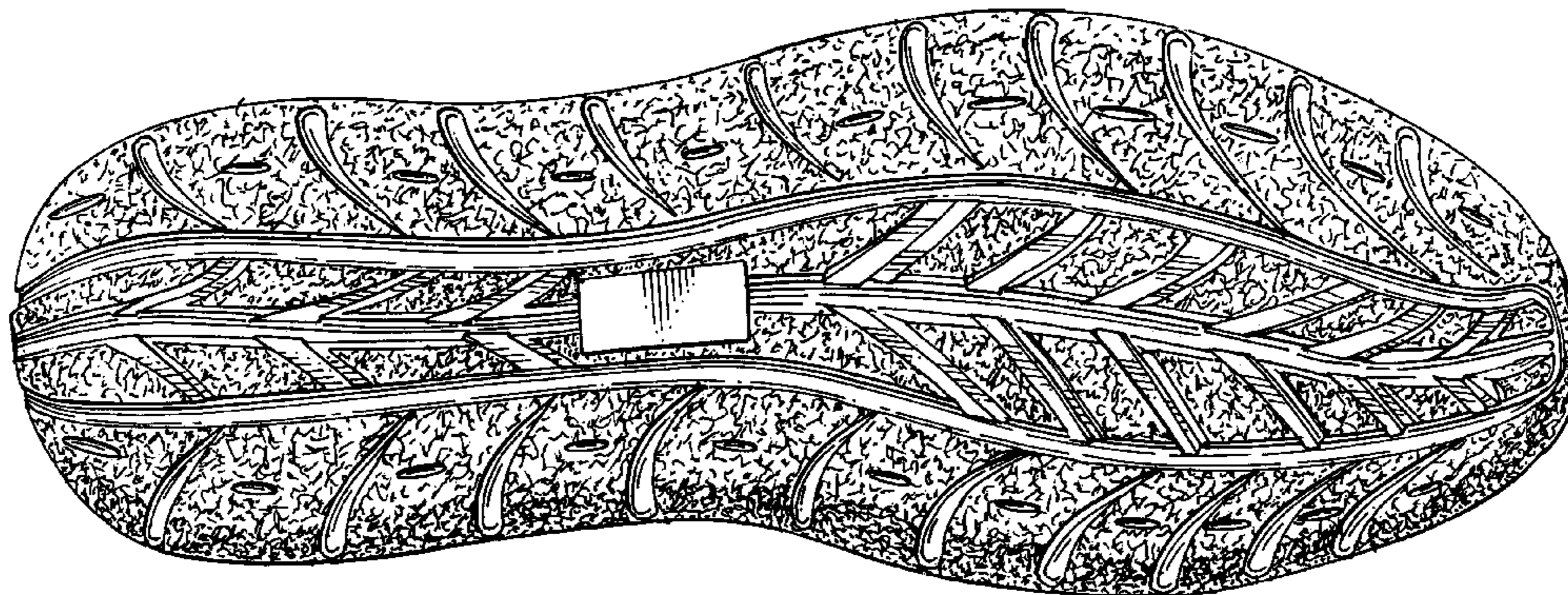
FIG. 6 is a perspective view of the outsole for a shoe in accordance with the embodiment of the new design shown in FIG. 1.

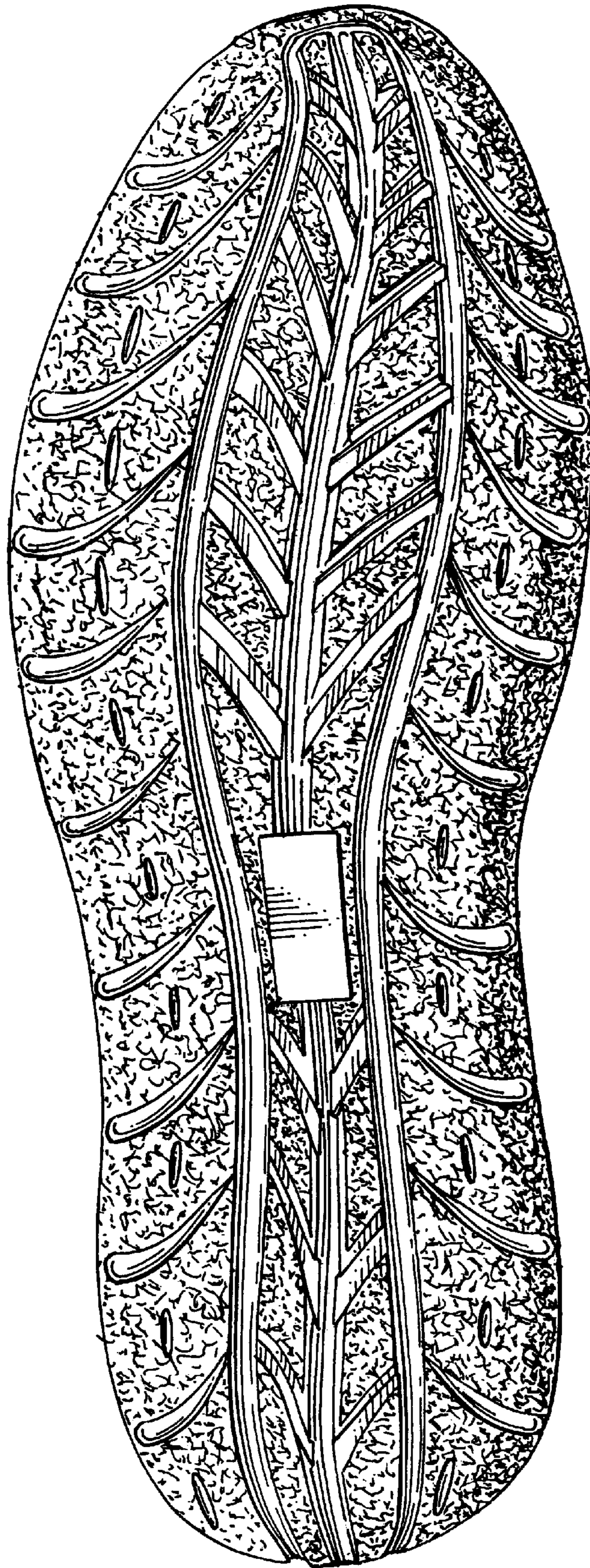

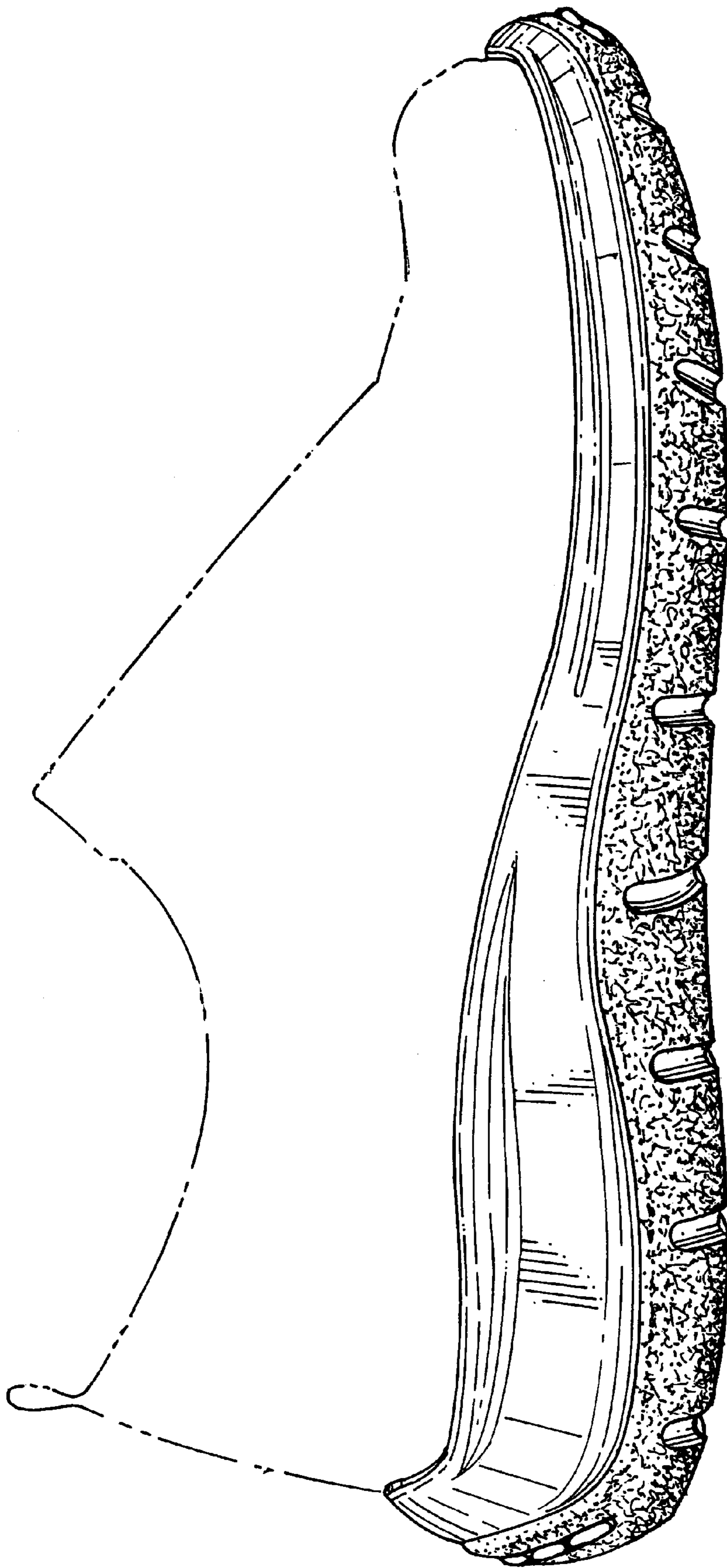

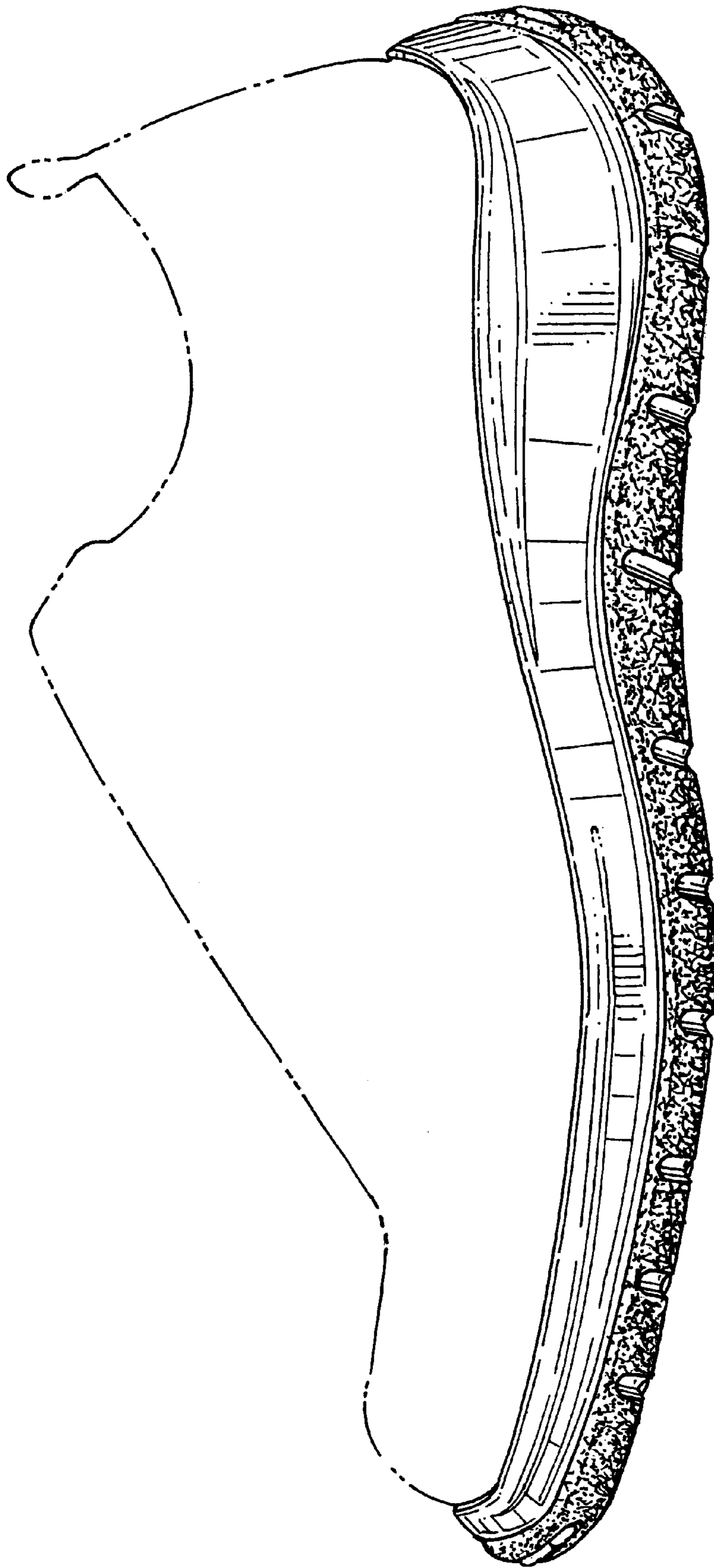

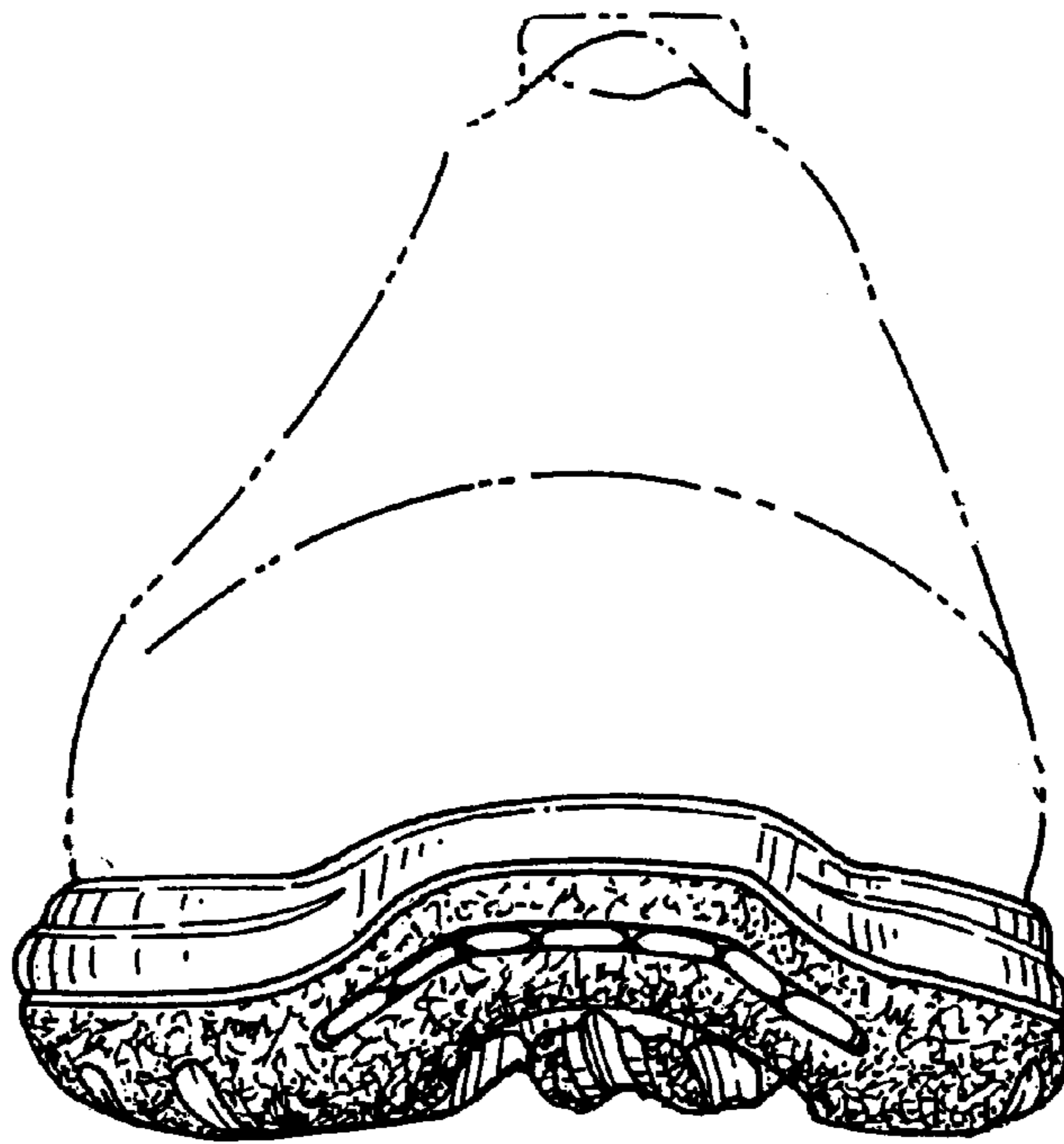

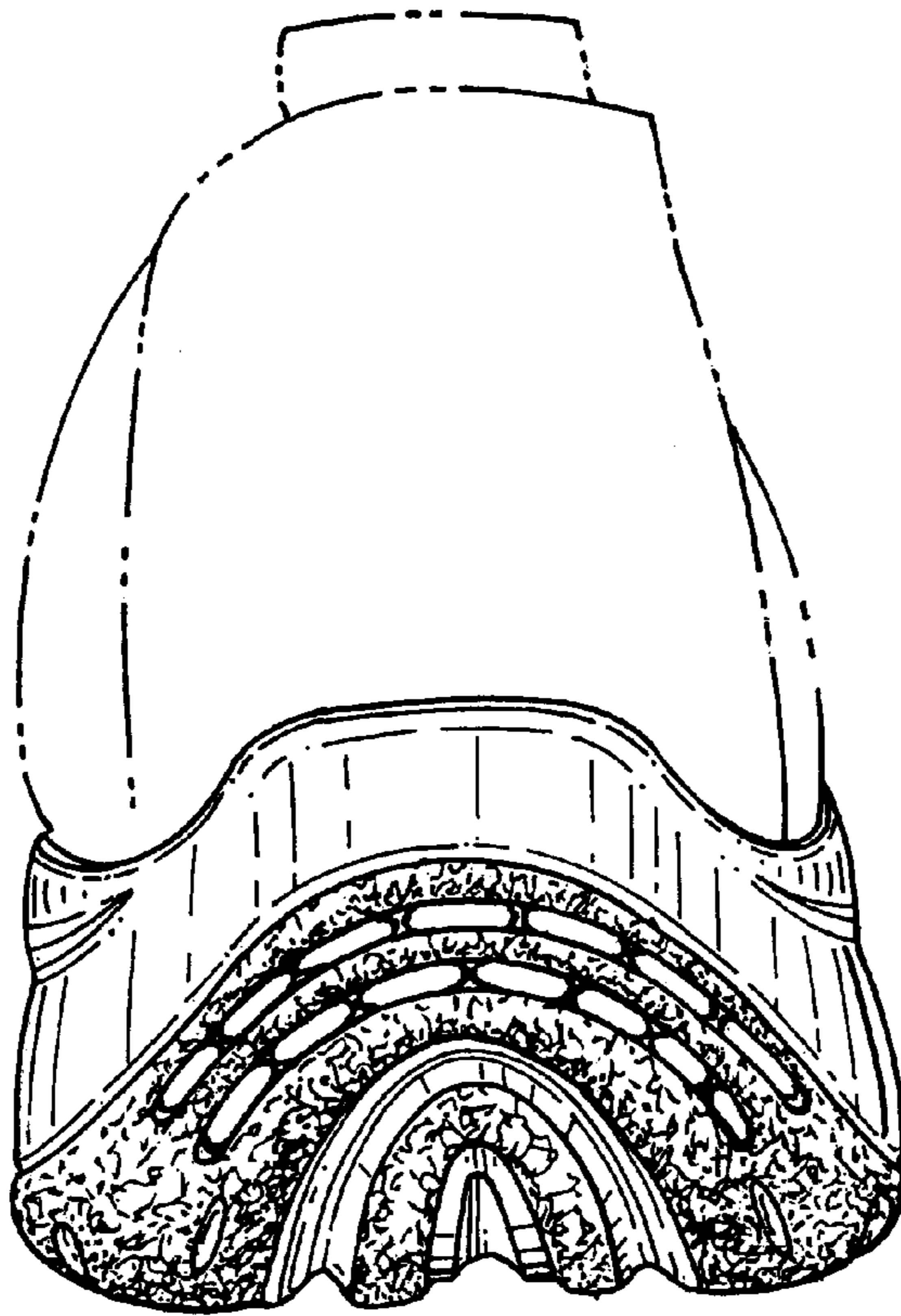
