FIG. 7 is a perspective view of the storage unit illustrated in FIG. 1, shown in a closed position with selected structure indicated in dotted lines;

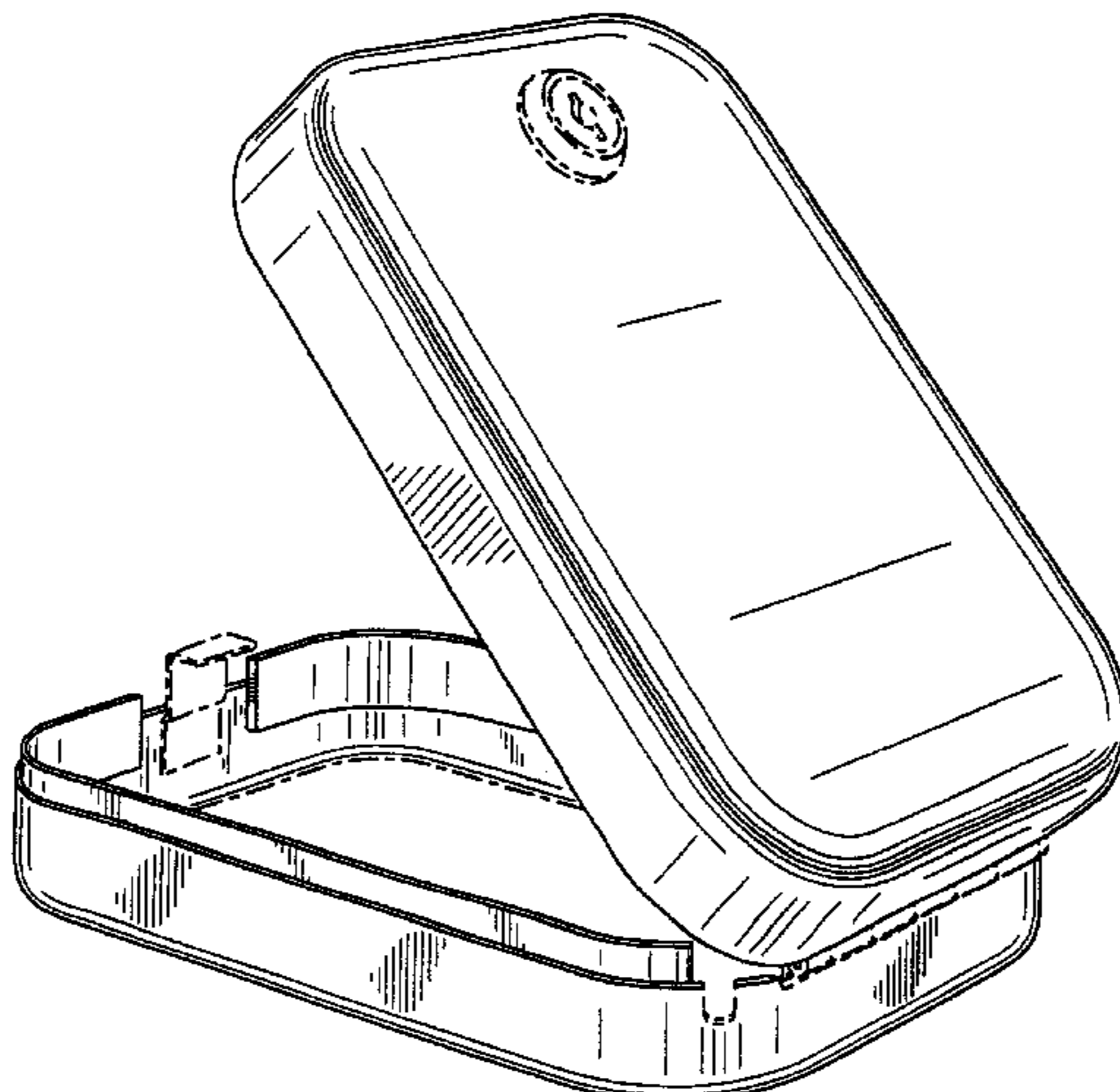

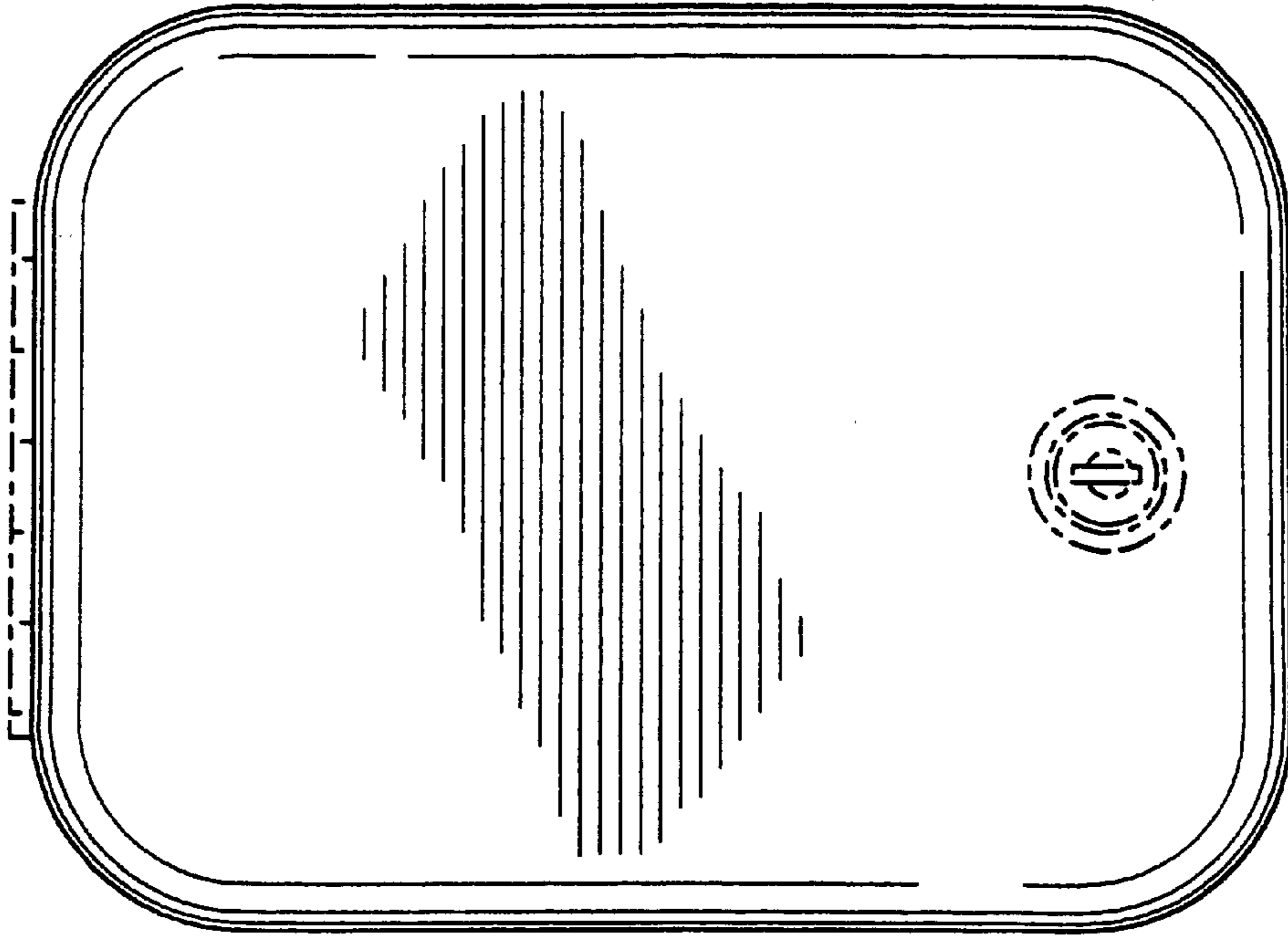

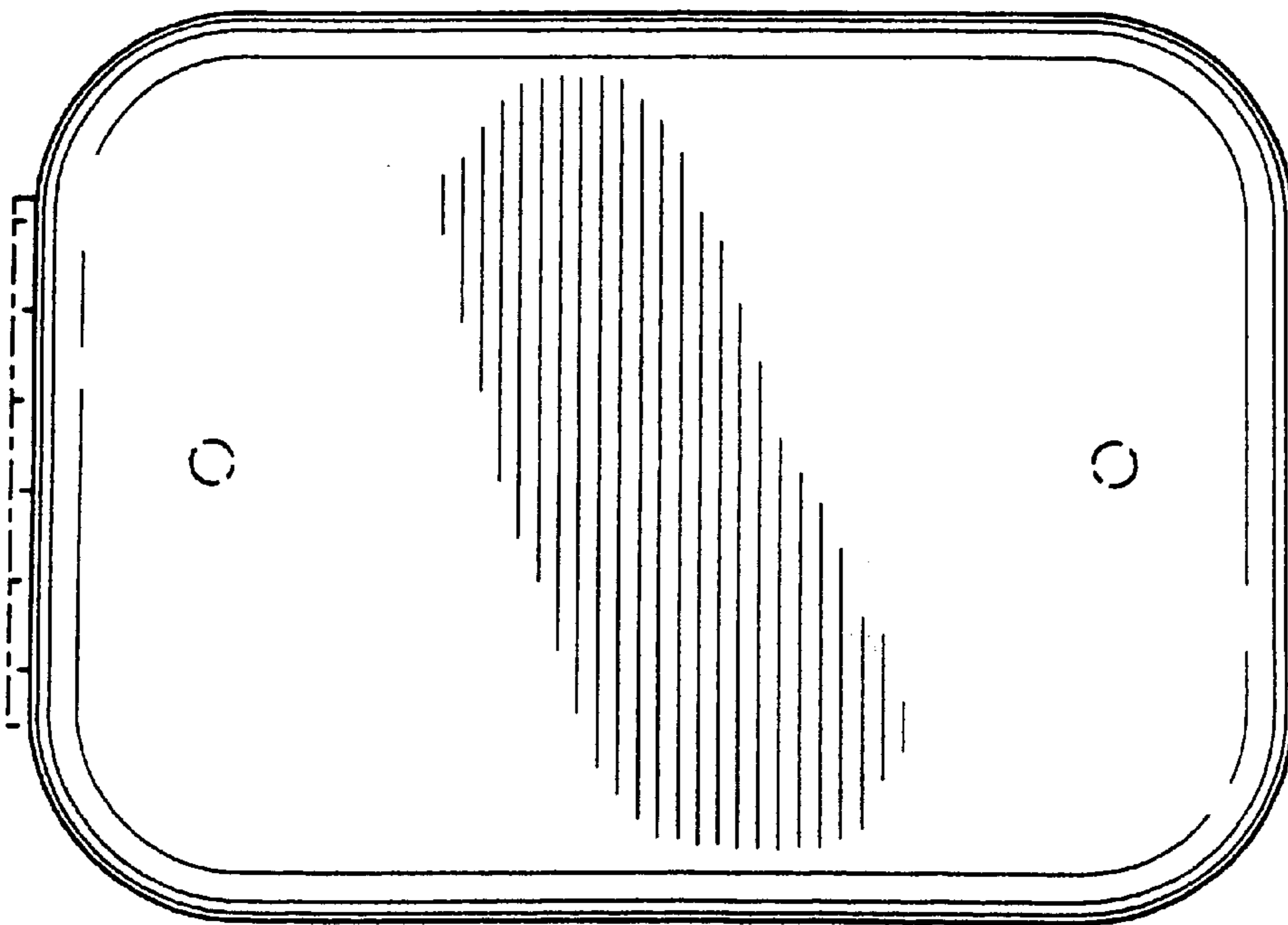

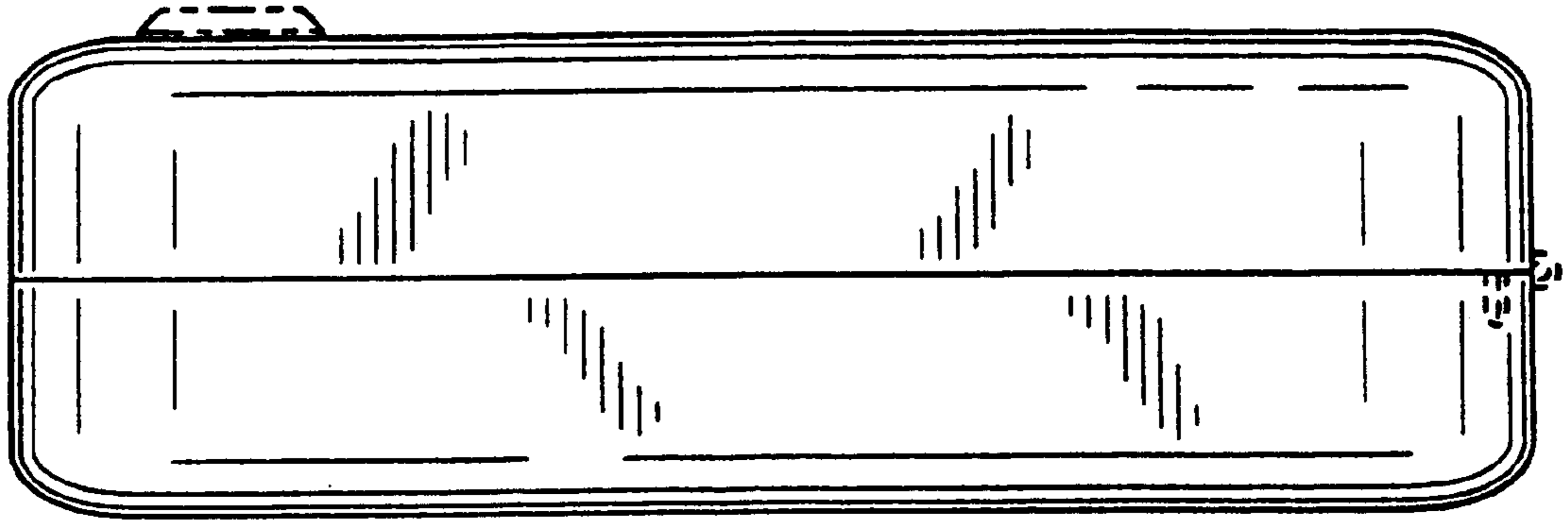

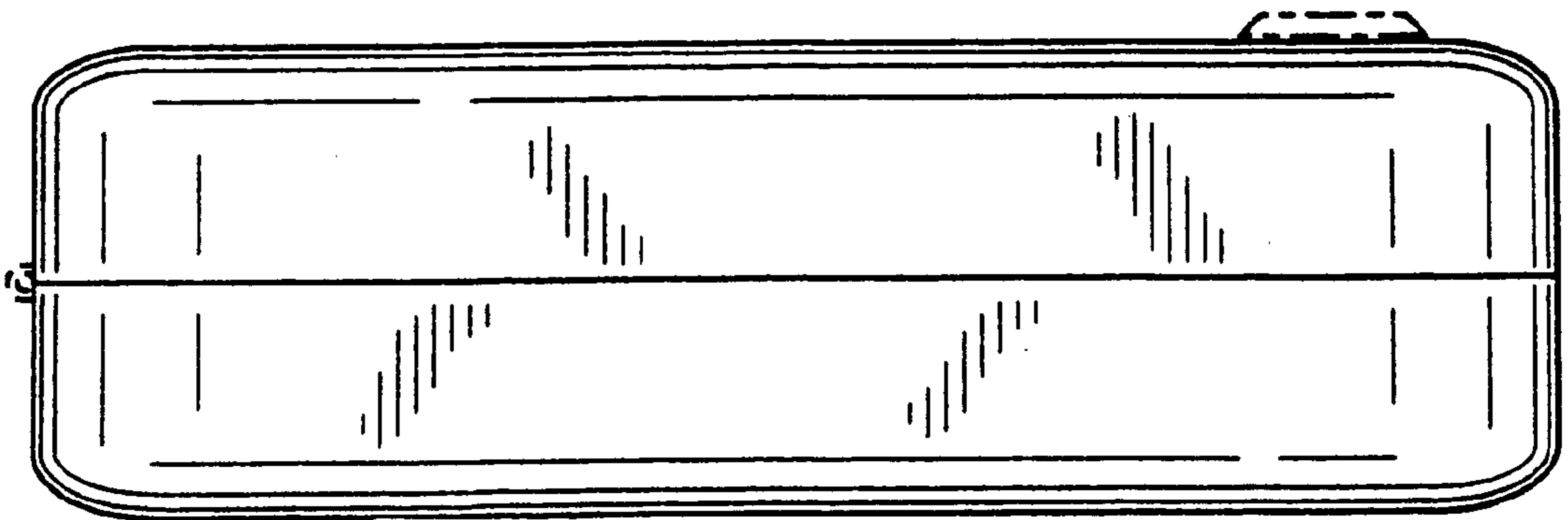

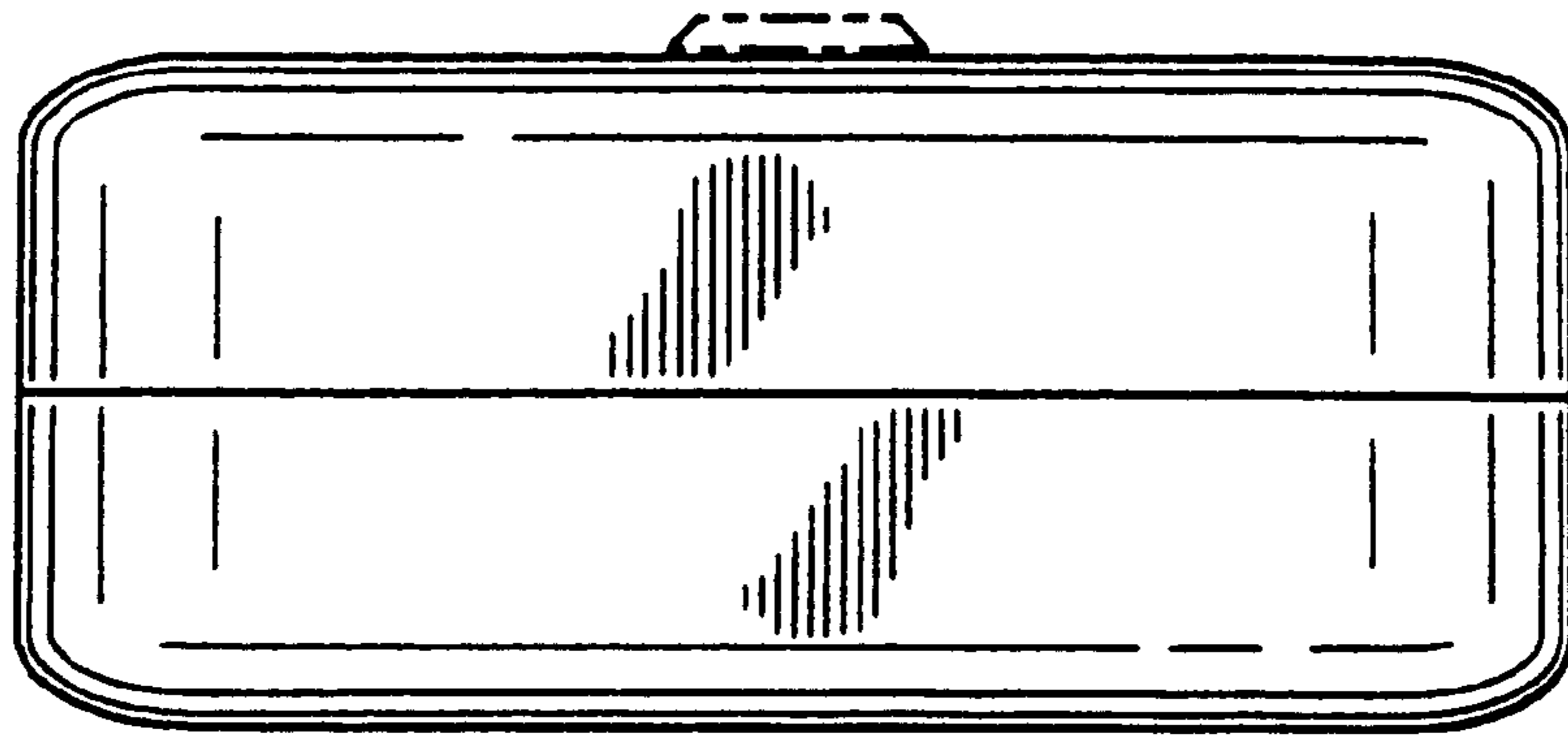

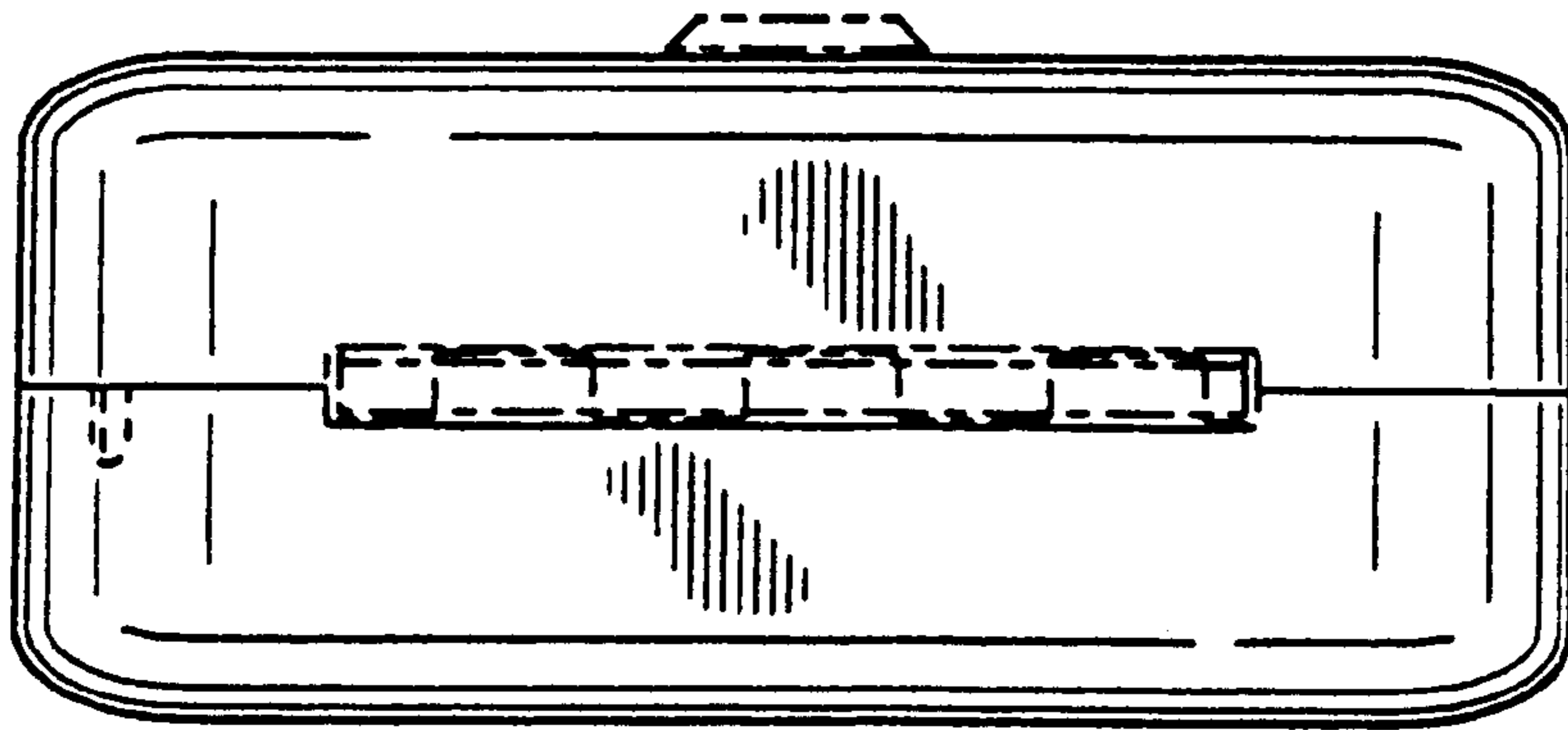

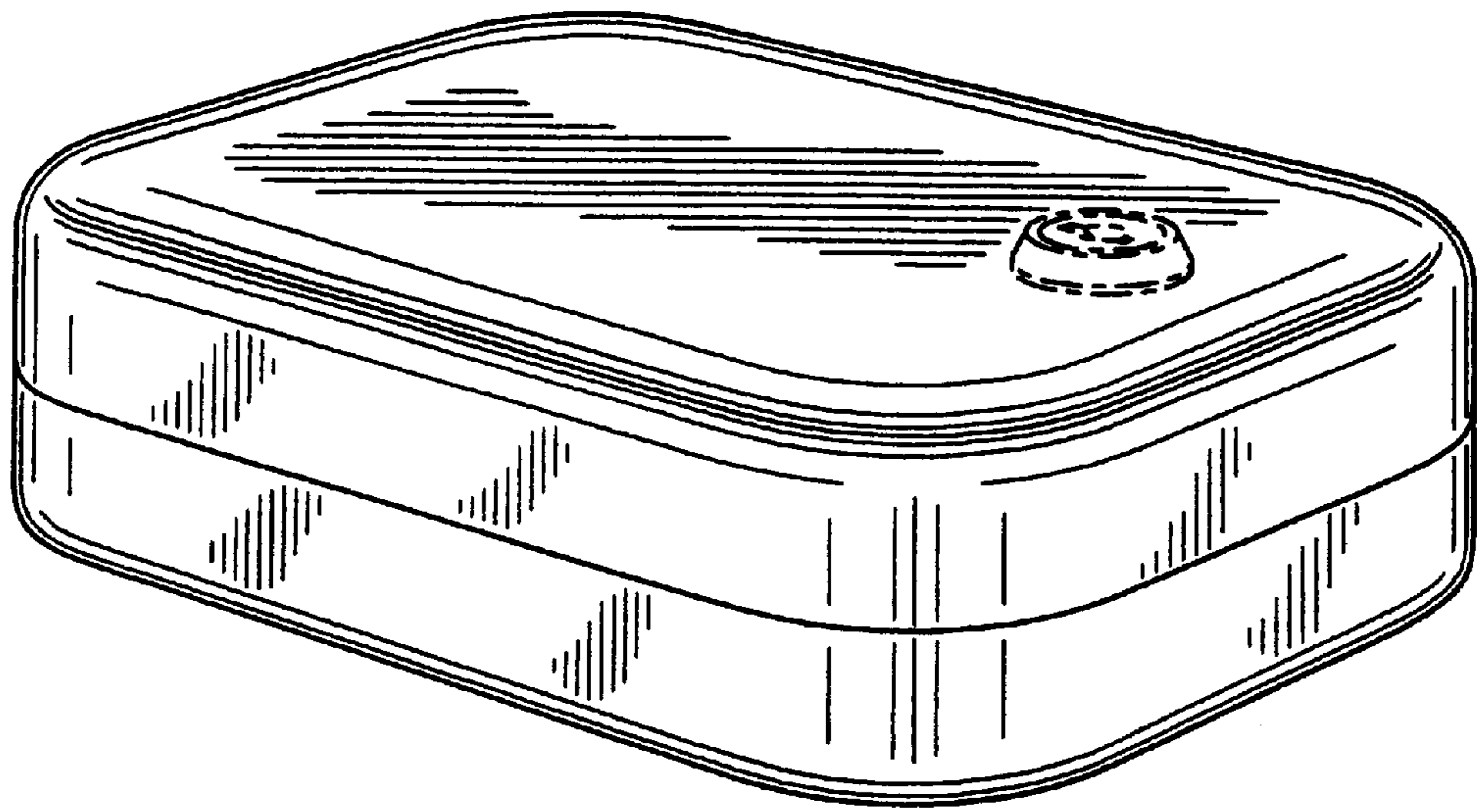

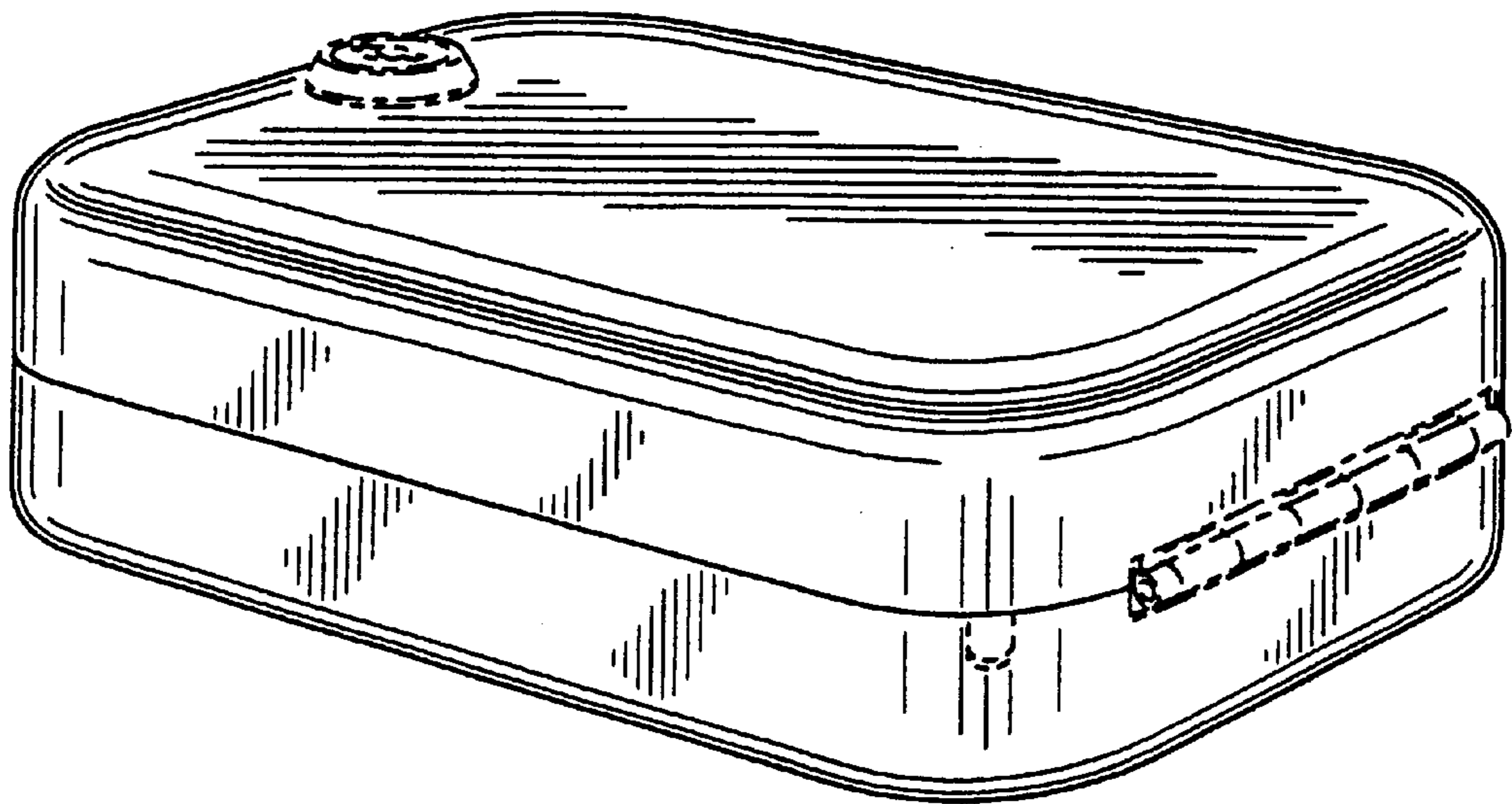

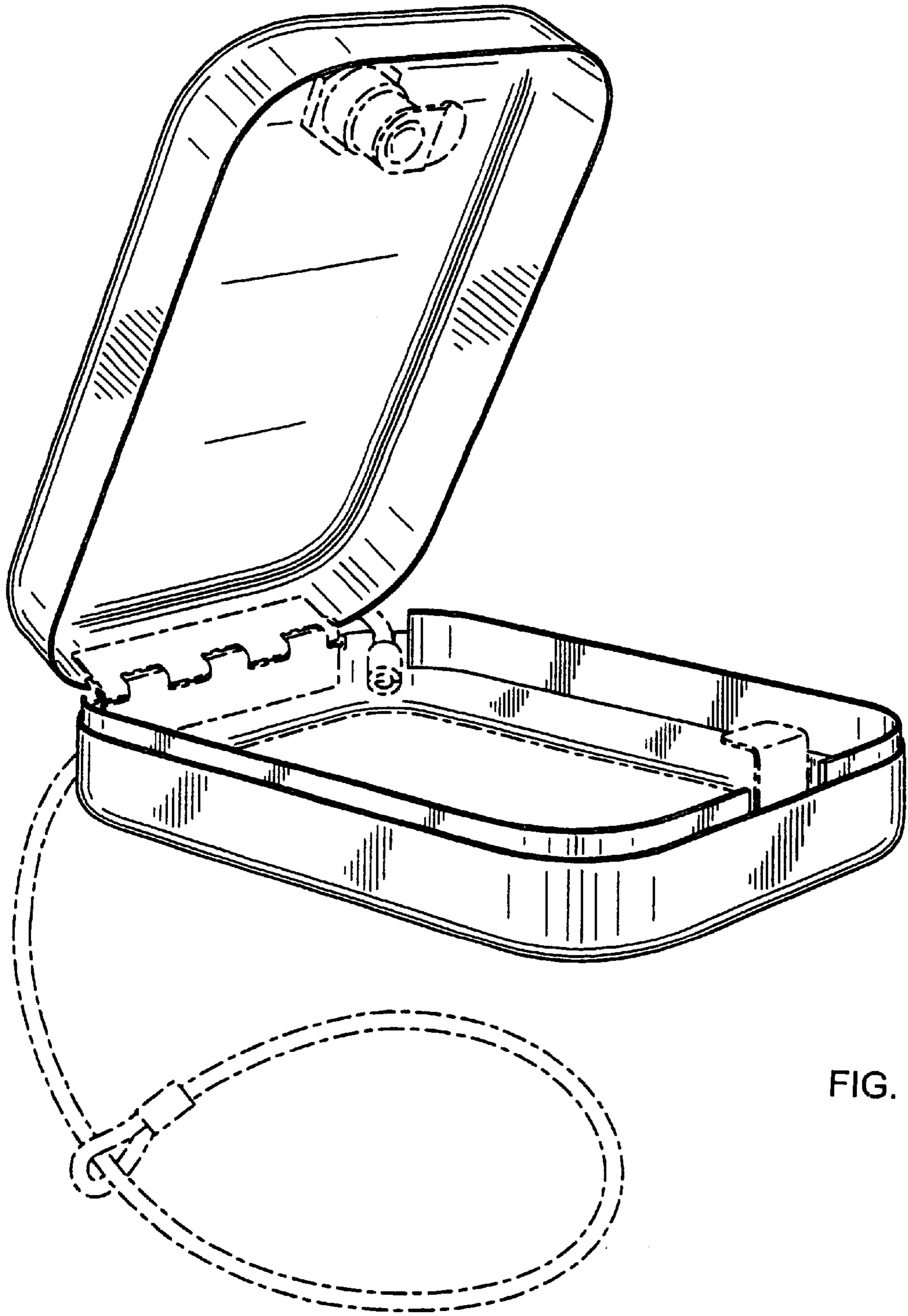

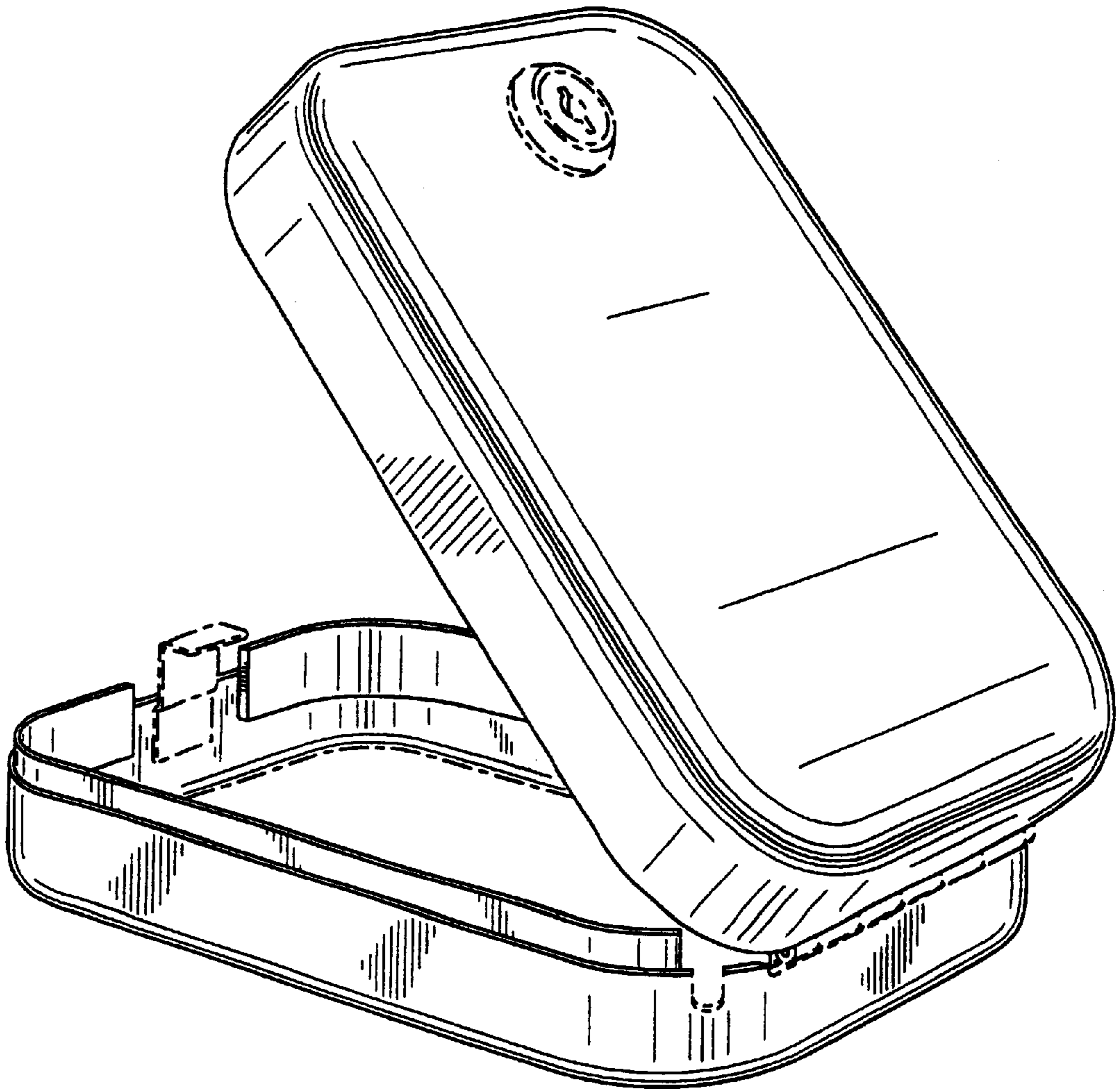
