(57) **CLAIM**

The ornamental design for a reusable bottle stopper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a reusable bottle stopper showing my new design in the opened position; FIG. 2 is a left side elevation view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a rear elevation view thereof; and, FIG. 6 is a front perspective view thereof showing the reusable bottle stopper in the closed position.
