(57) **CLAIM**

The ornamental design for a golf shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the golf shoe outsole of our new design.

FIG. 2 is a left elevation view thereof.

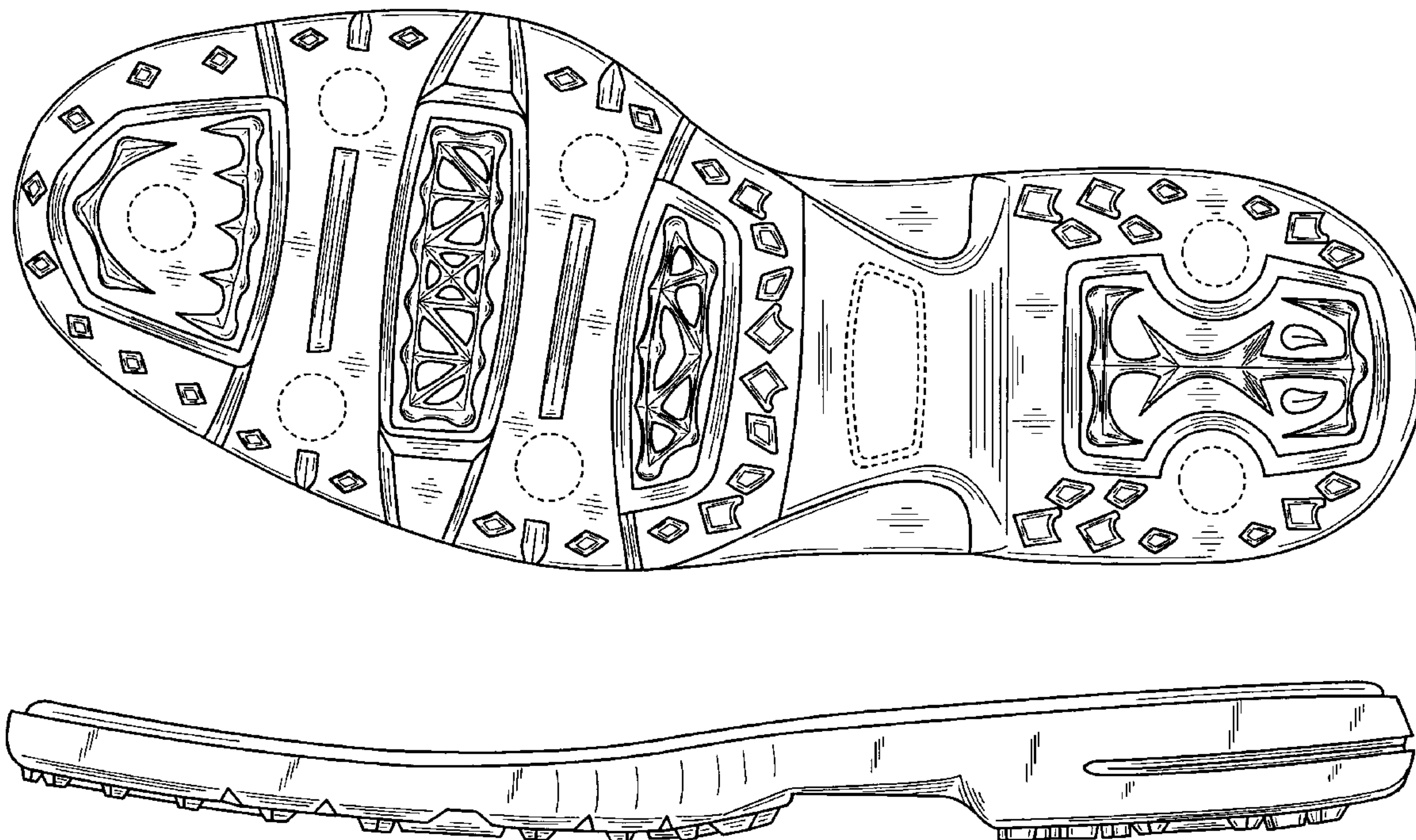
FIG. 3 is a front elevation view of the toe portion thereof.

FIG. 4 is a rear elevation view of the heel portion thereof, and,

FIG. 5 is a right elevation view thereof.

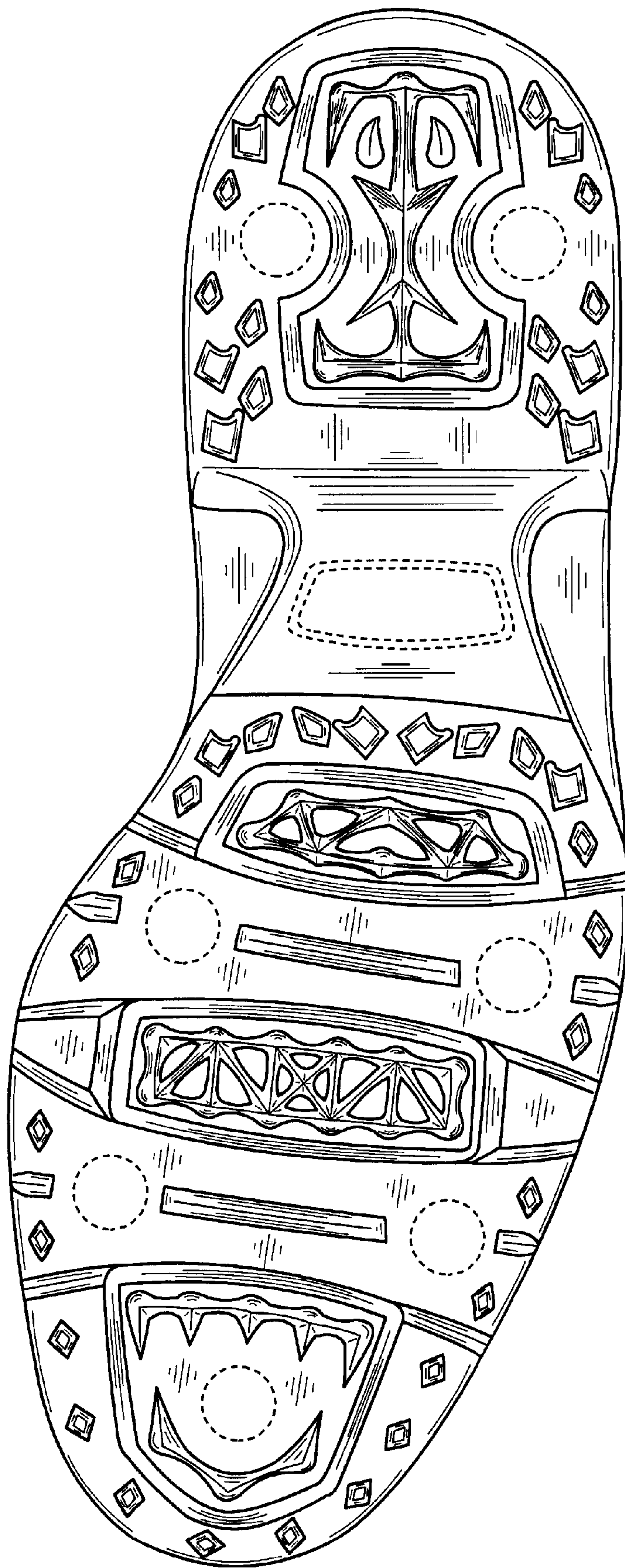

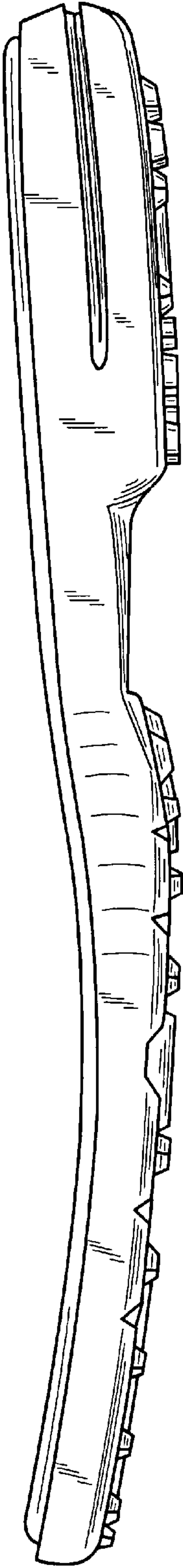

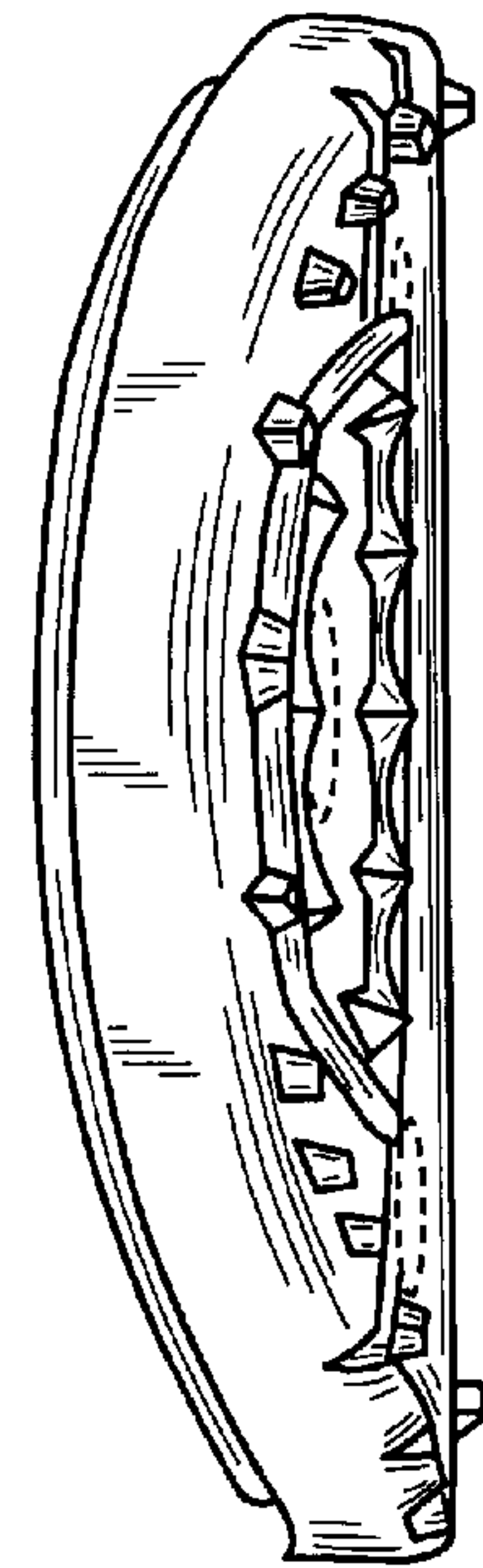

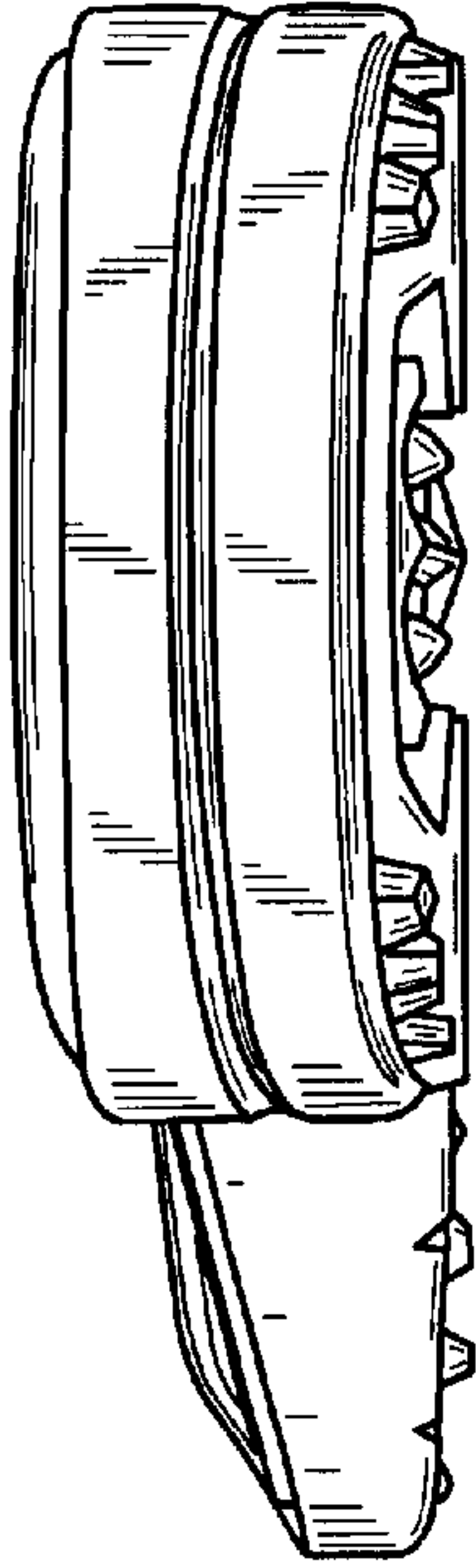

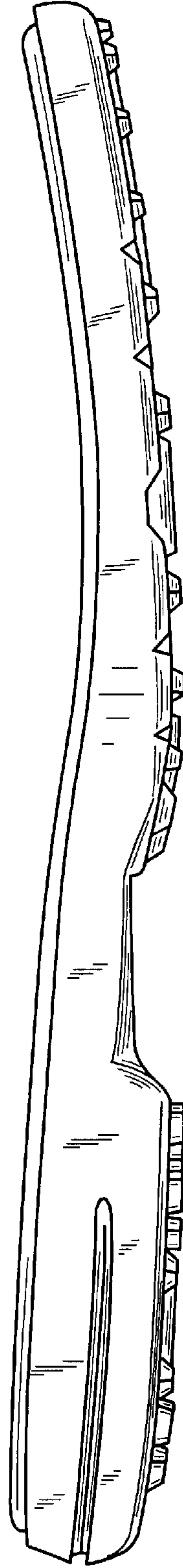
