(57) **CLAIM**

The ornamental design for an eyeglass holder, as shown and described.

DESCRIPTION

FIG. 1 illustrates a side view of the eyeglass holder showing my new and ornamental design, said design including a detachable button on the bottom side thereof;

FIG. 2 illustrates a longitudinal-sectional view of FIG. 1 shown in mirror-image thereof;

FIG. 4 illustrates a top perspective view thereof;

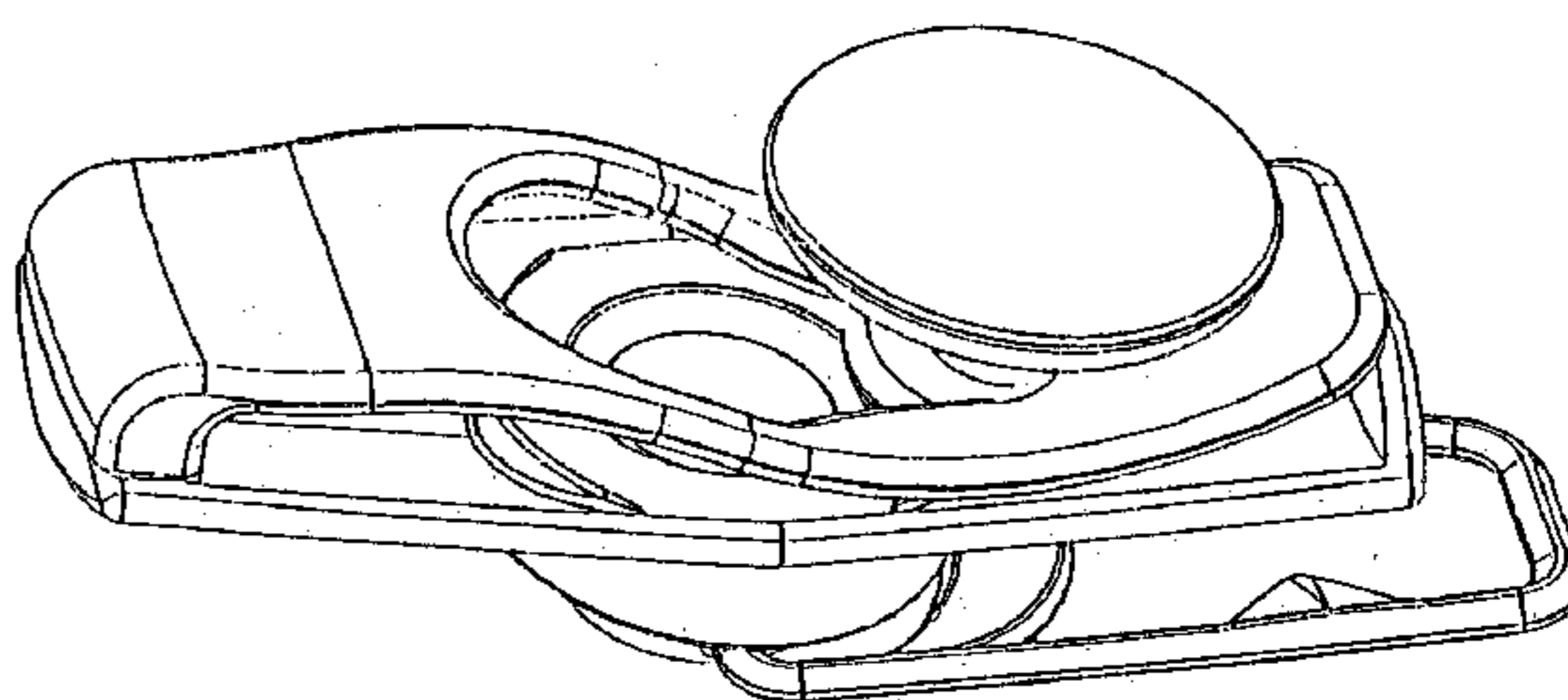
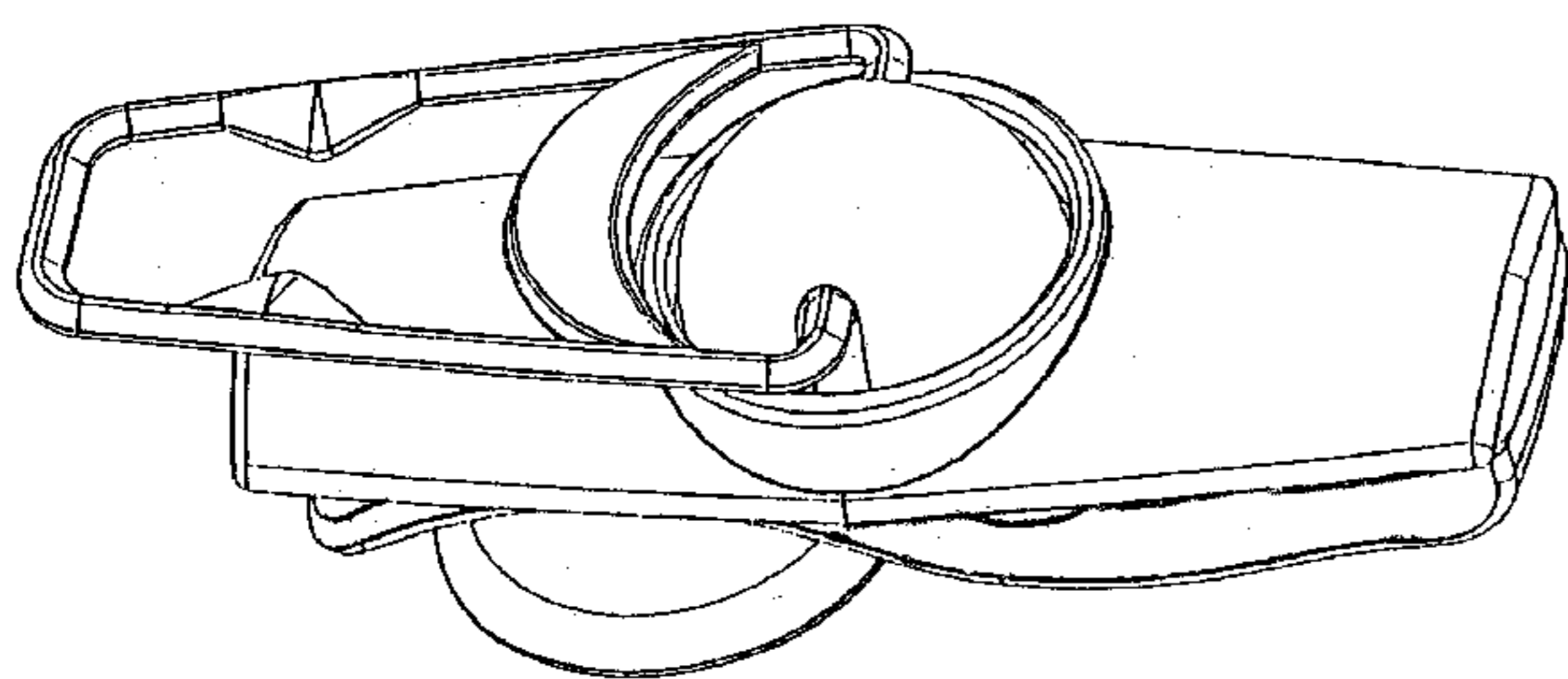
FIG. 5 illustrates a right-side view thereof;

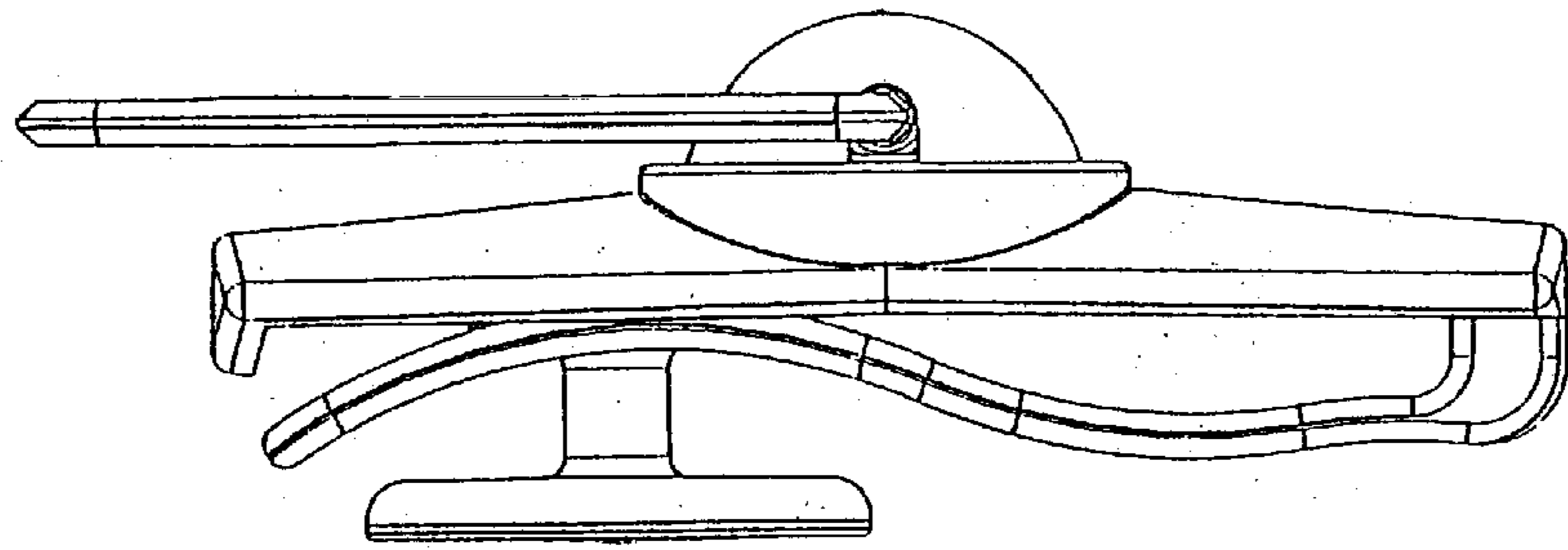

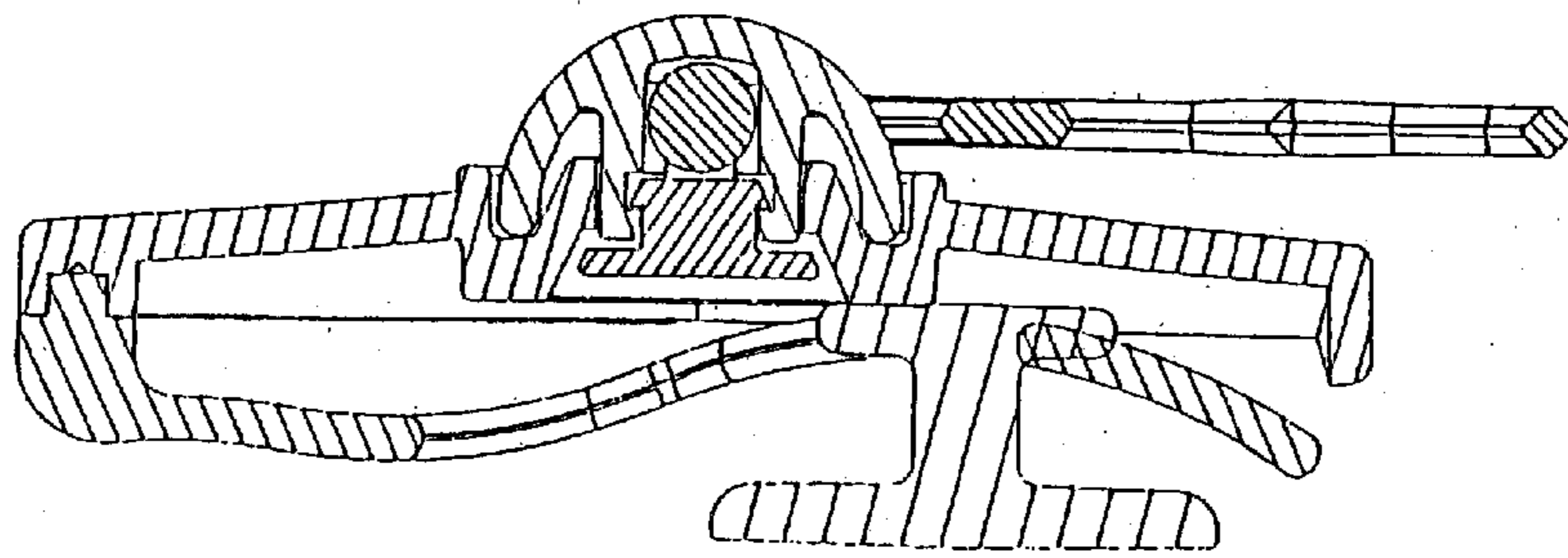

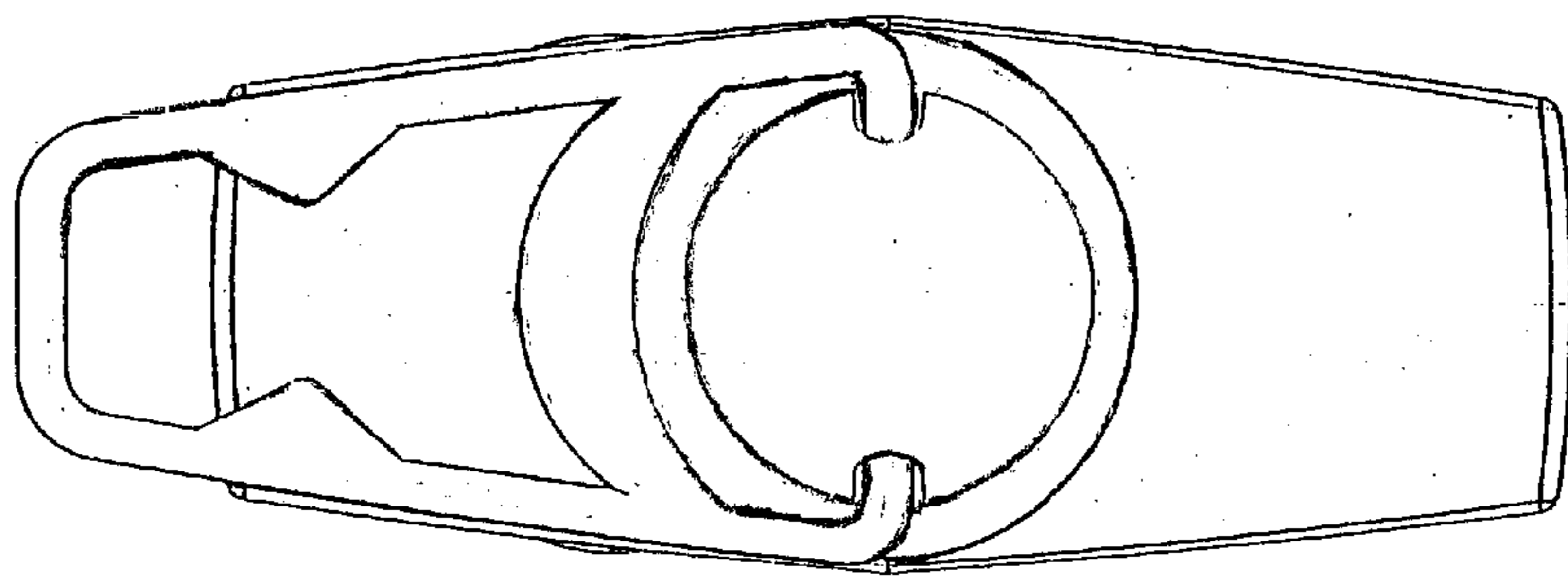

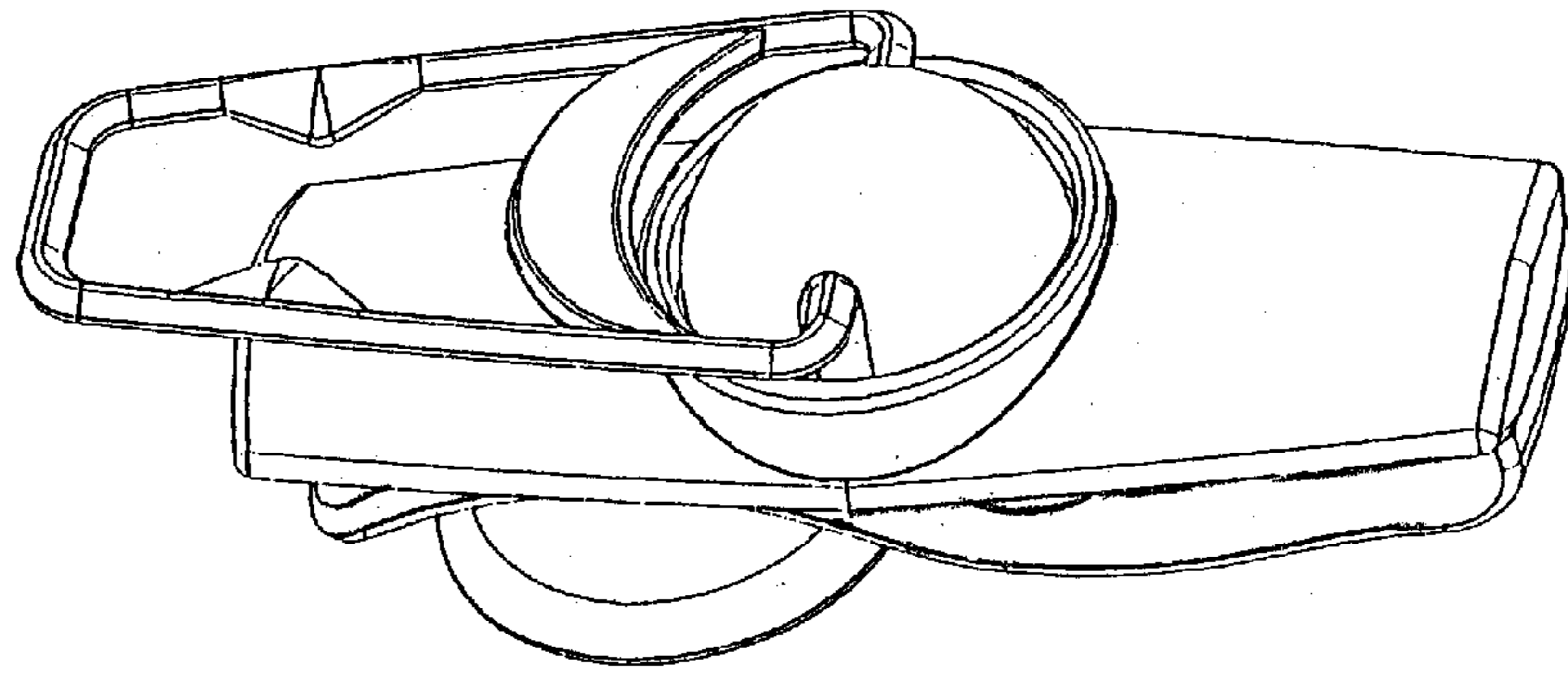

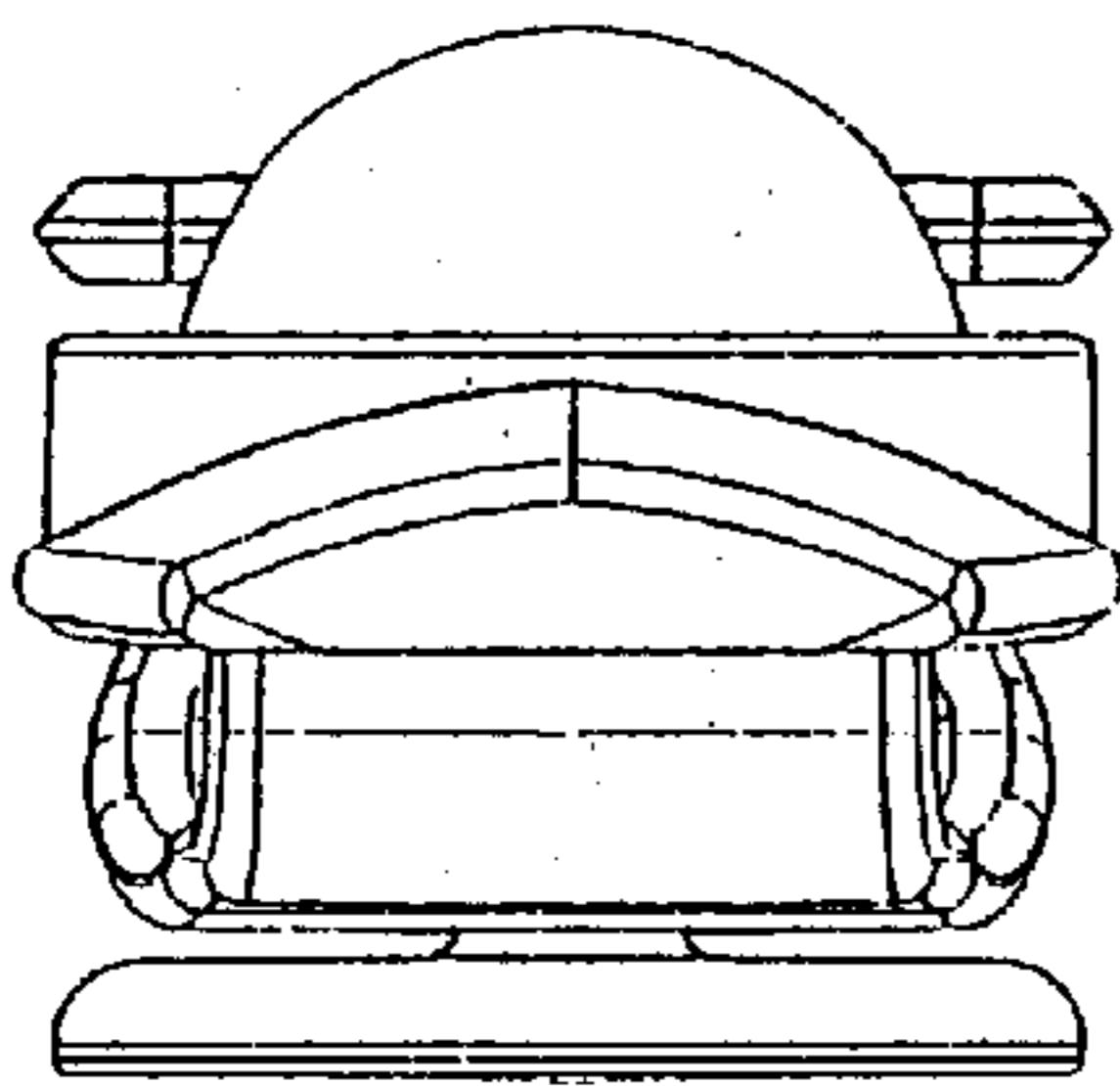

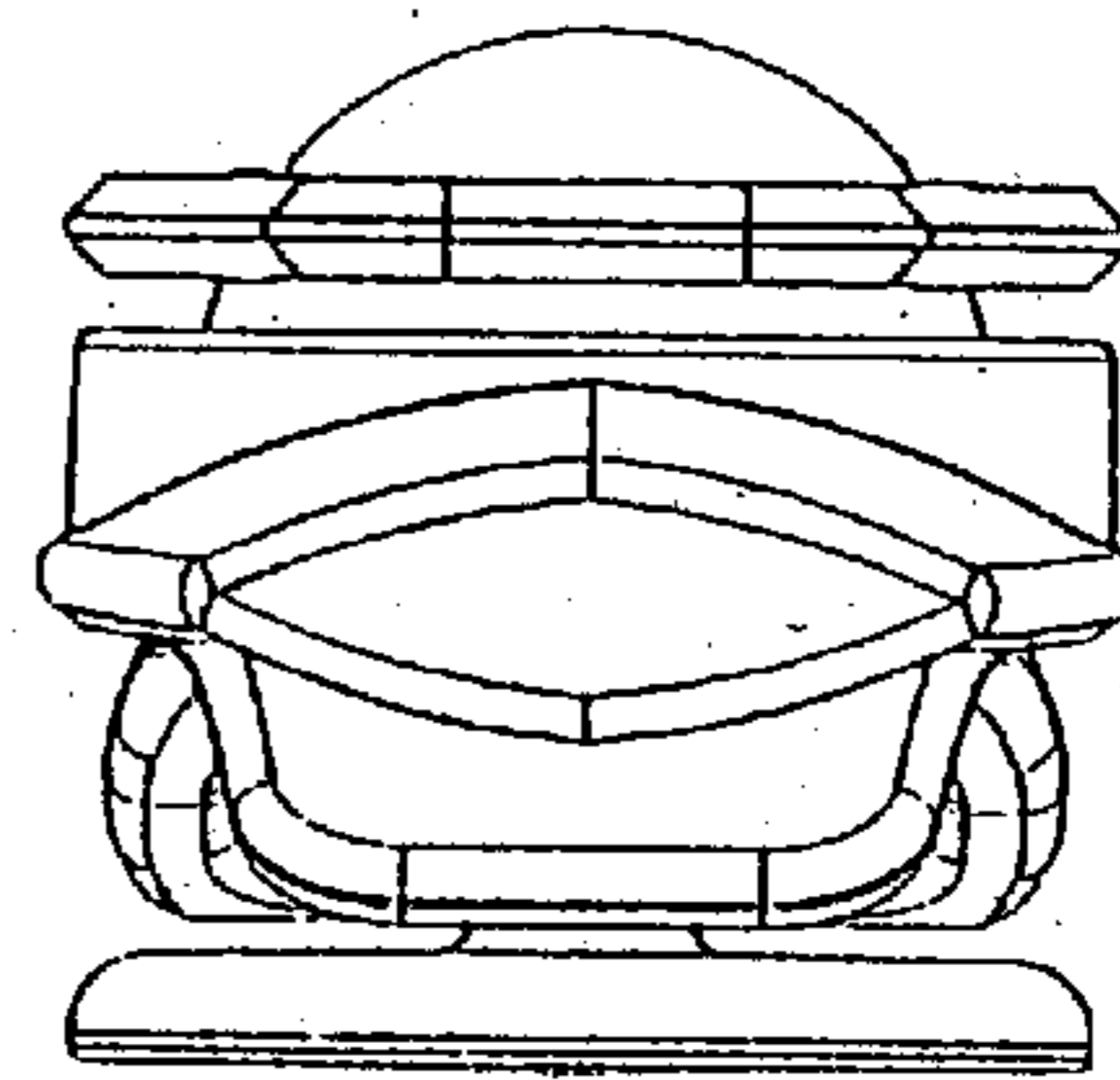

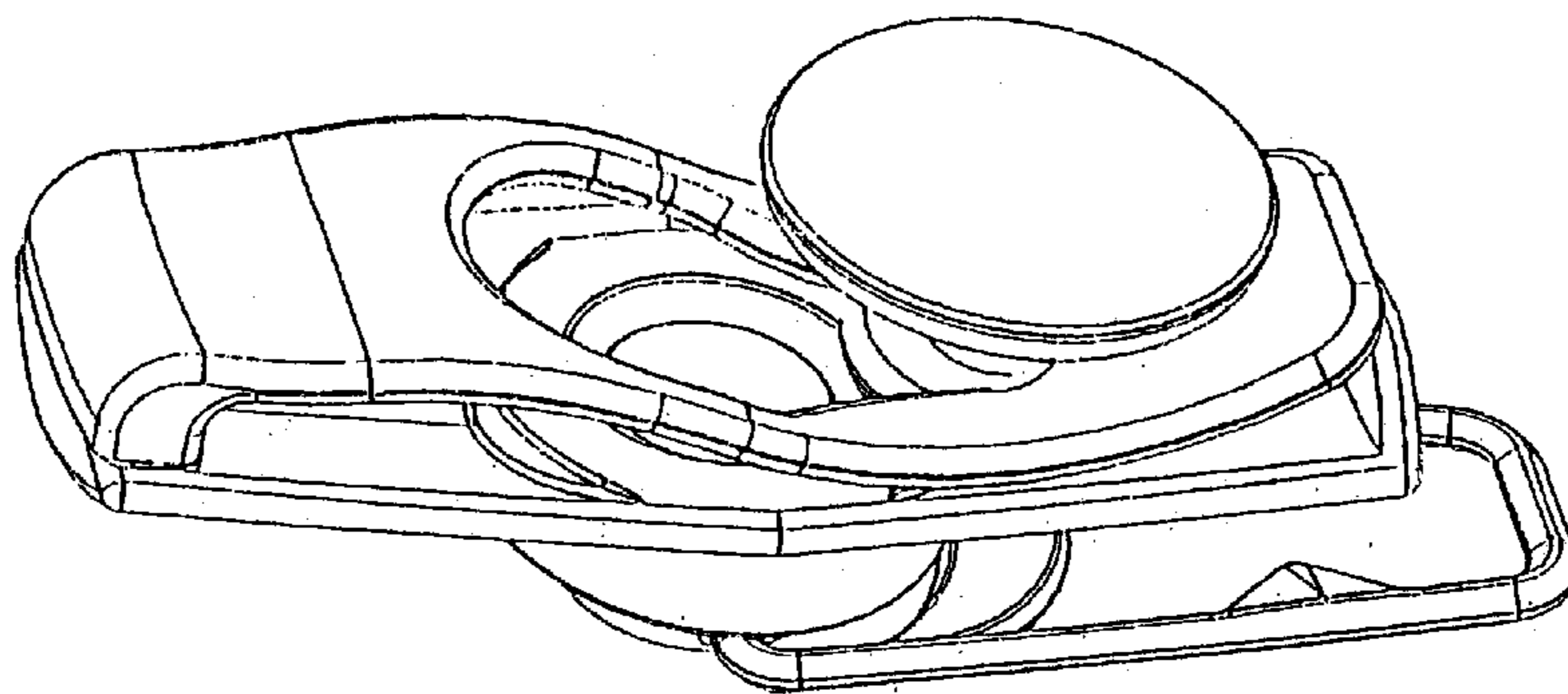

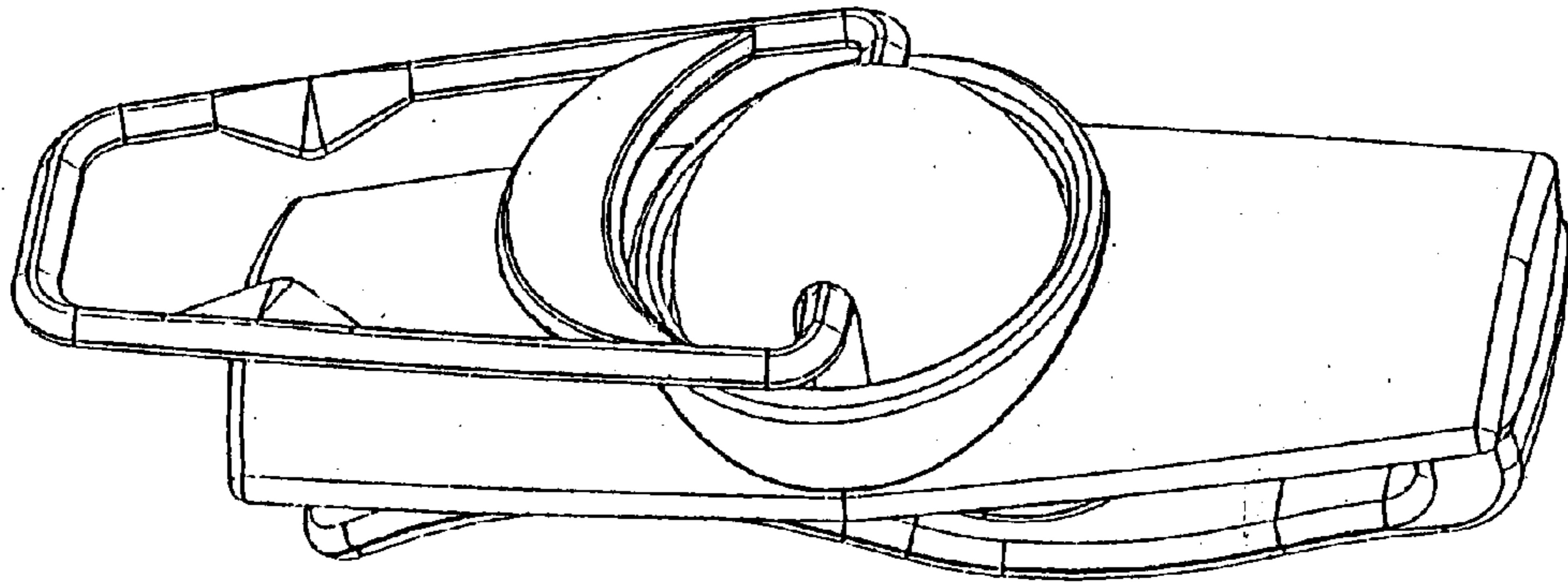

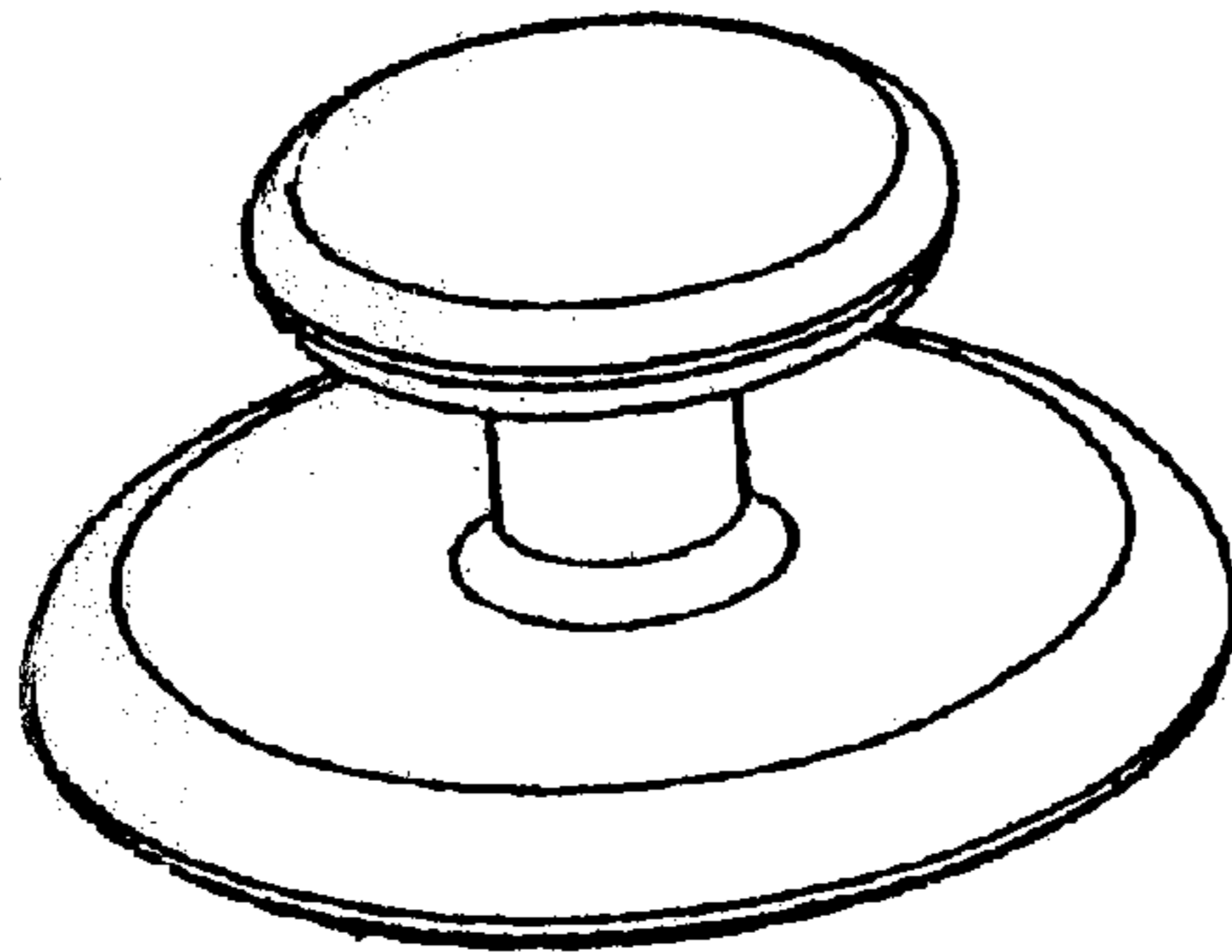
