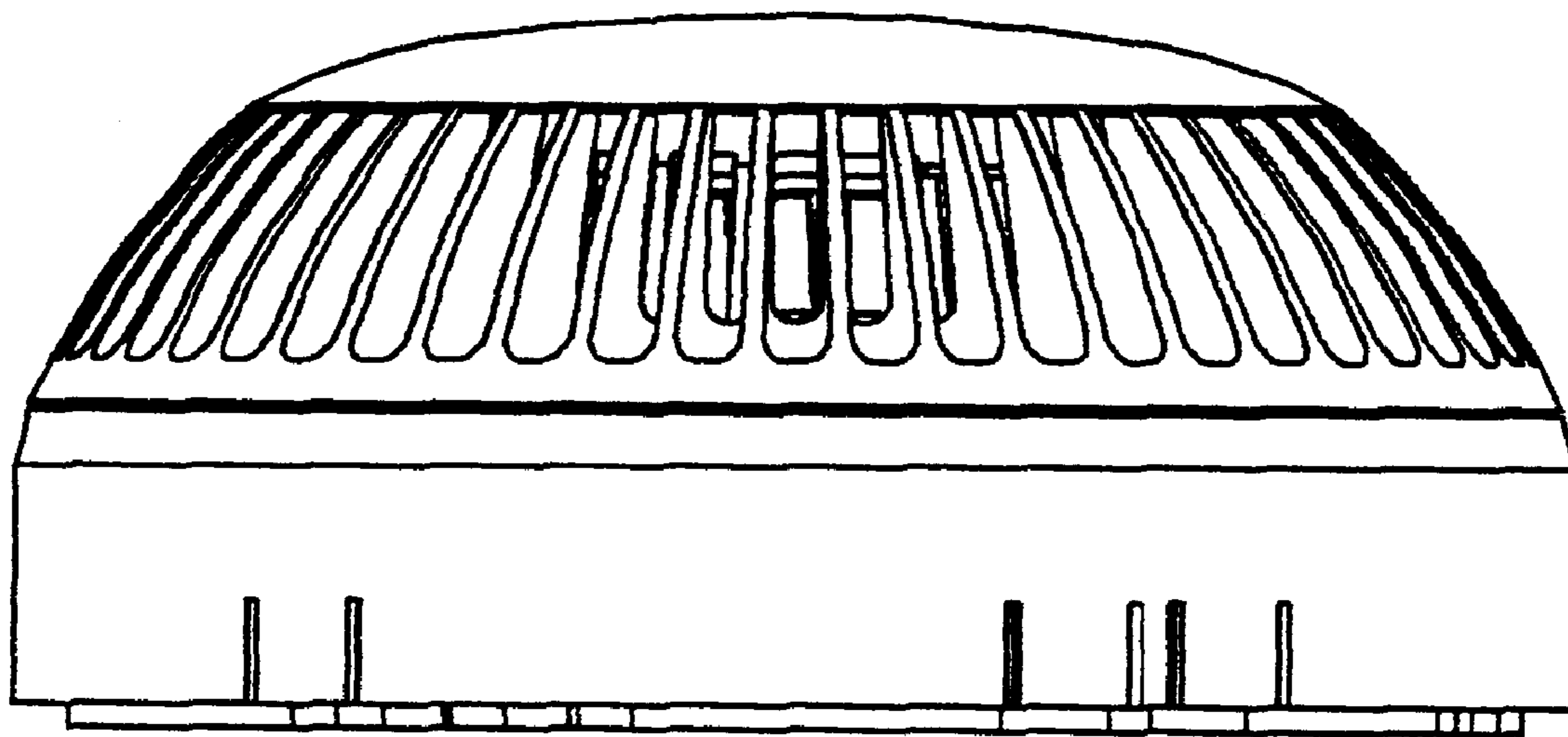
(57) **CLAIM**

The ornamental design for a apparatus for smoke alarm having a hood and an industrial socket, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of a apparatus for smoke alarm having a hood and an industrial socket showing my new design; FIG. 2 is a side view turned by 90° relative to FIG. 1 thereof; FIG. 3 is a side view turned by 90° relative to FIG. 2 thereof; FIG. 4 is a side view turned by 90° relative to FIG. 3 thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

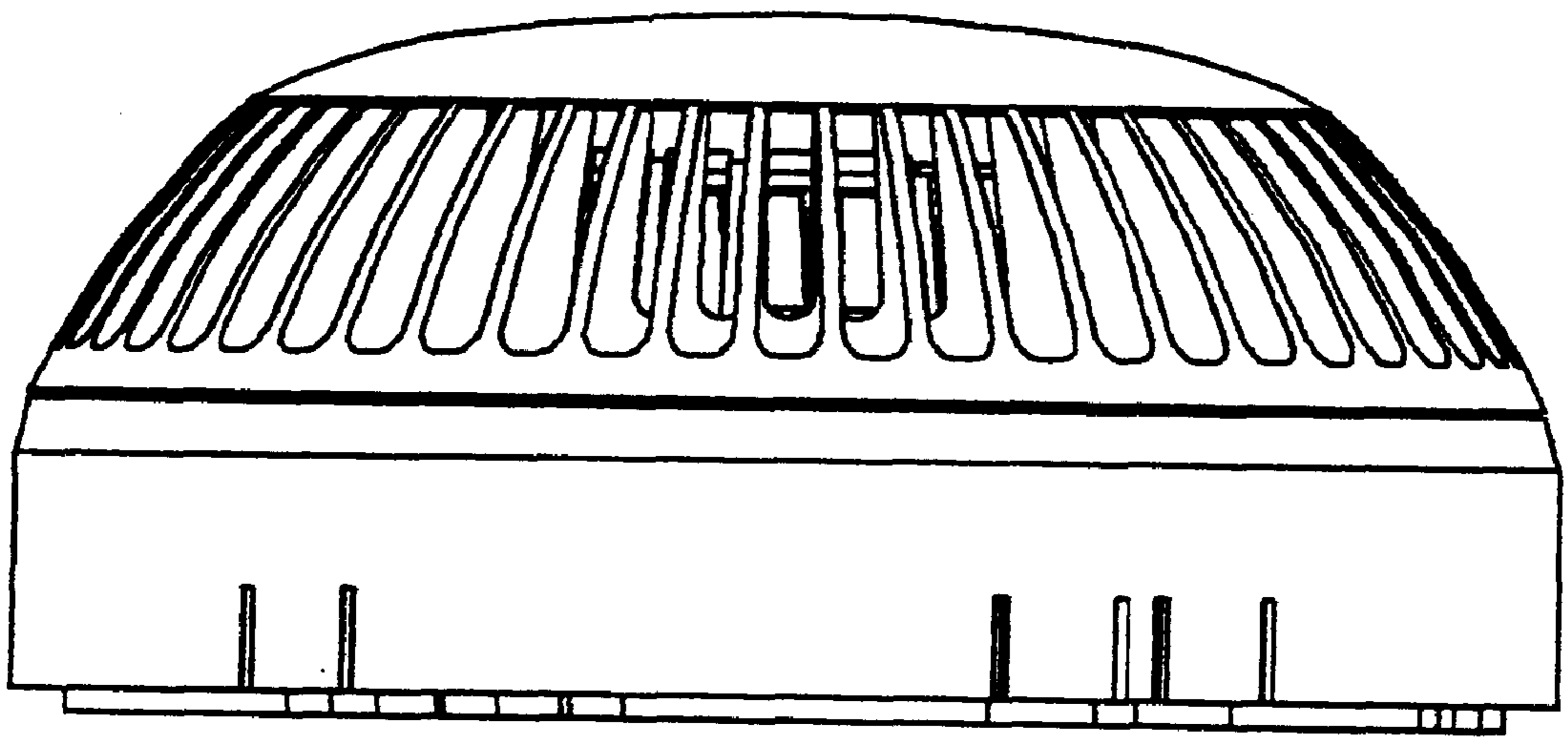

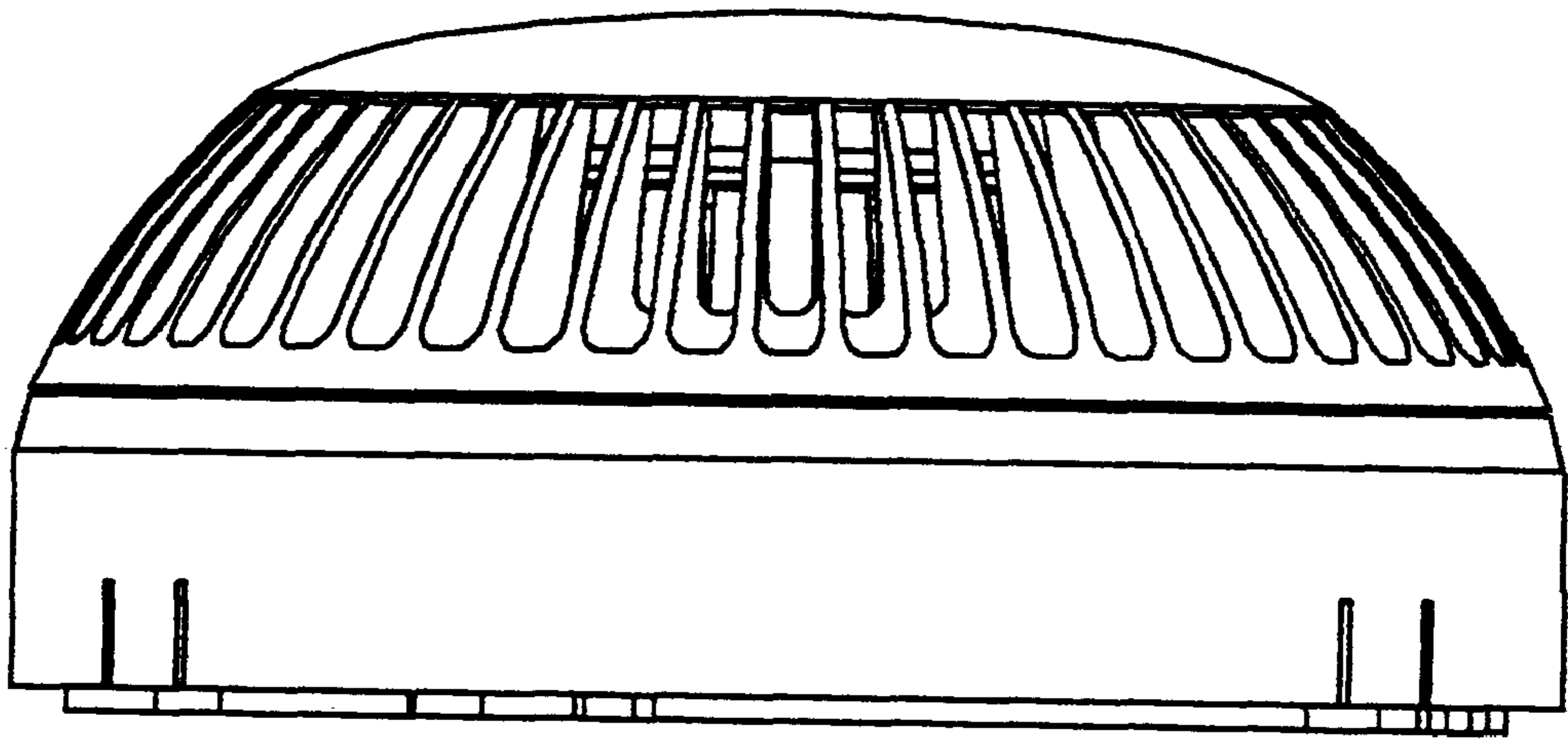

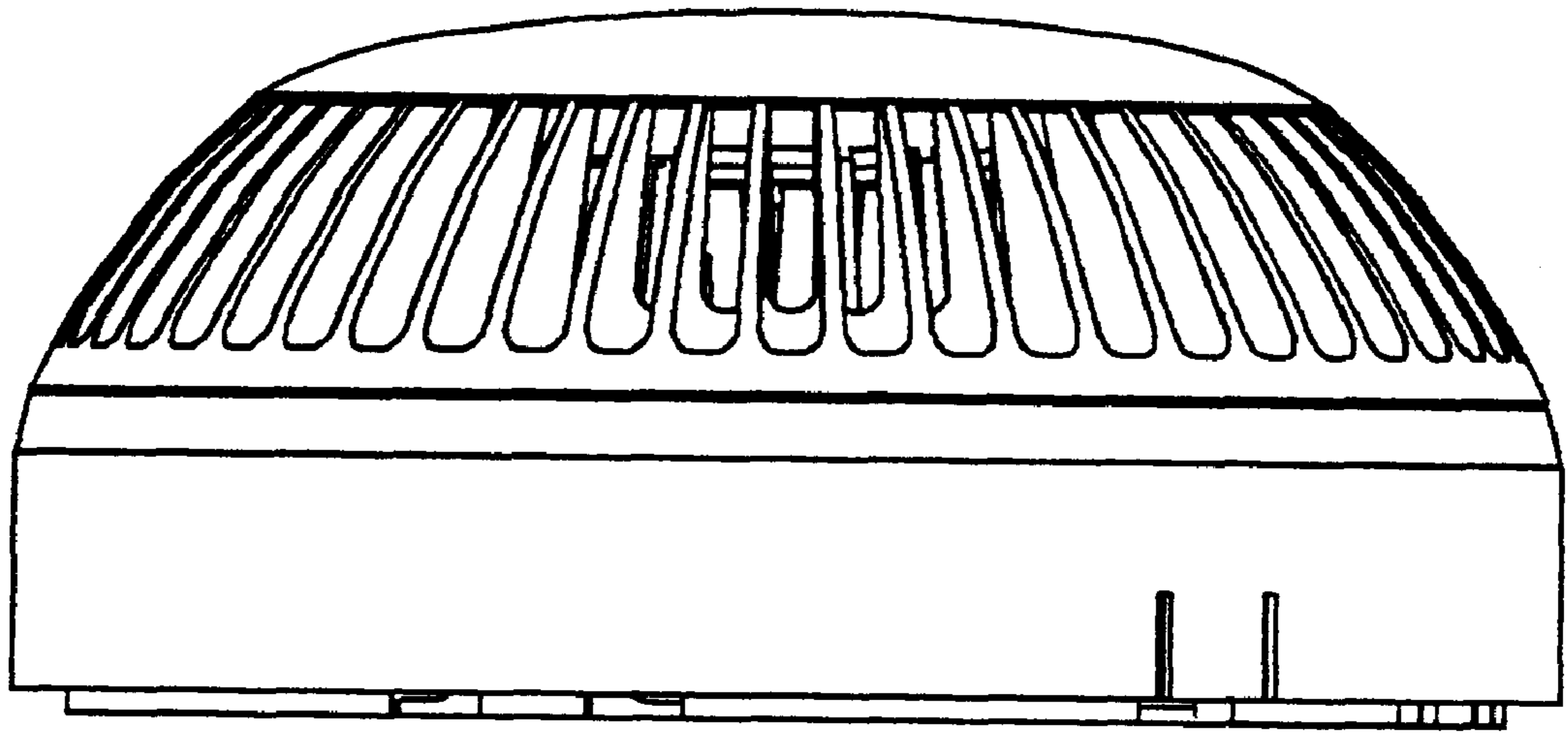

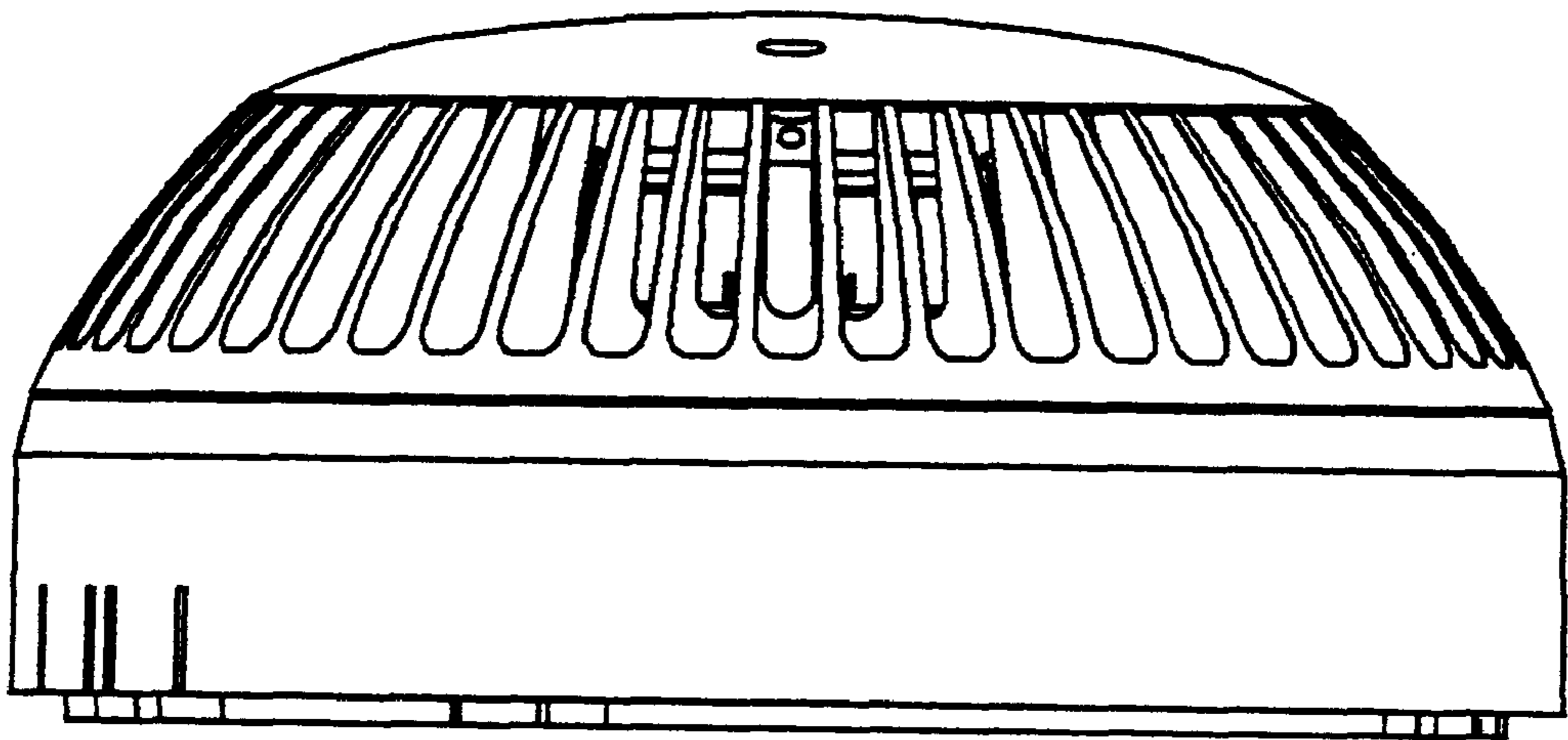

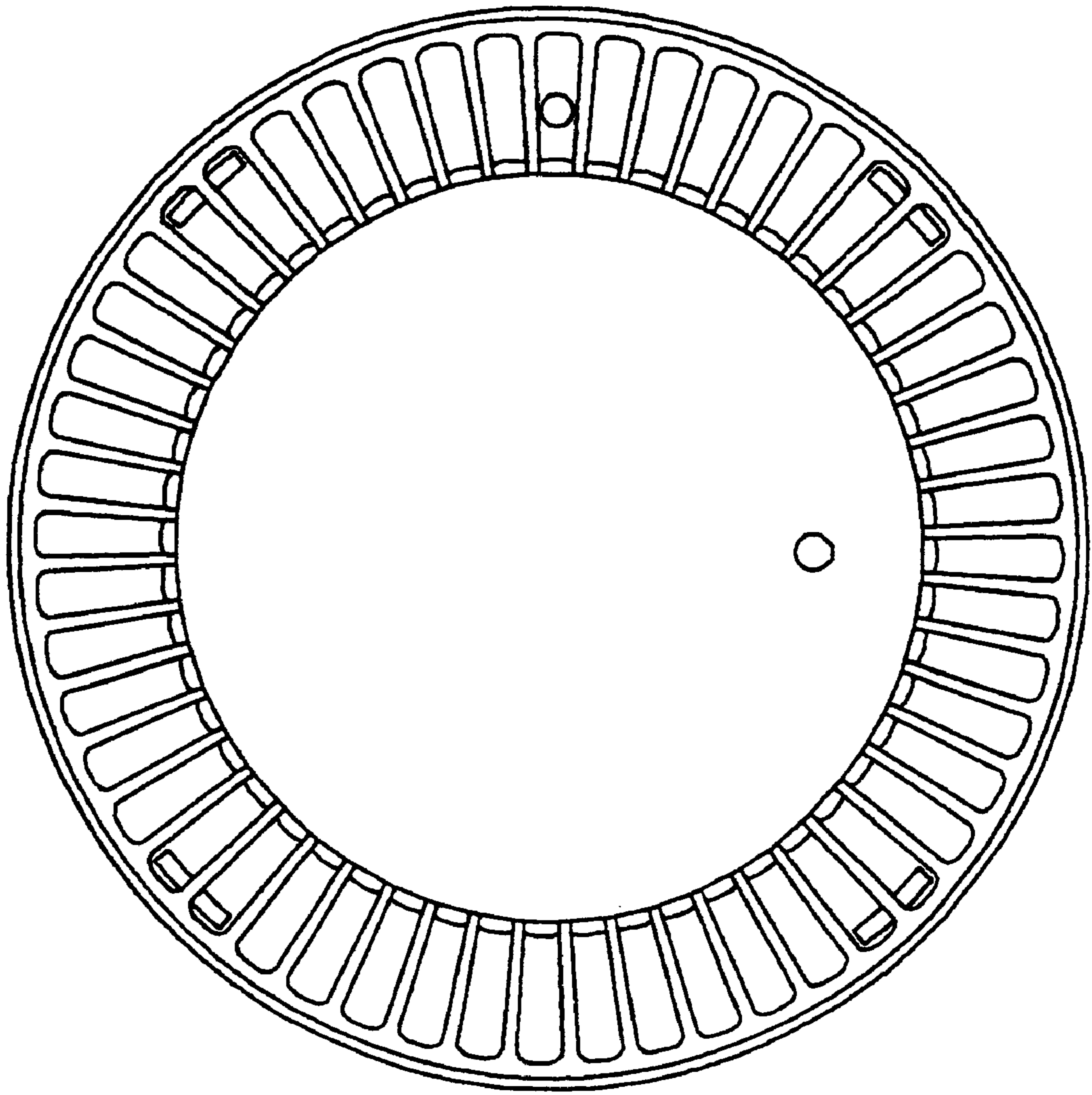

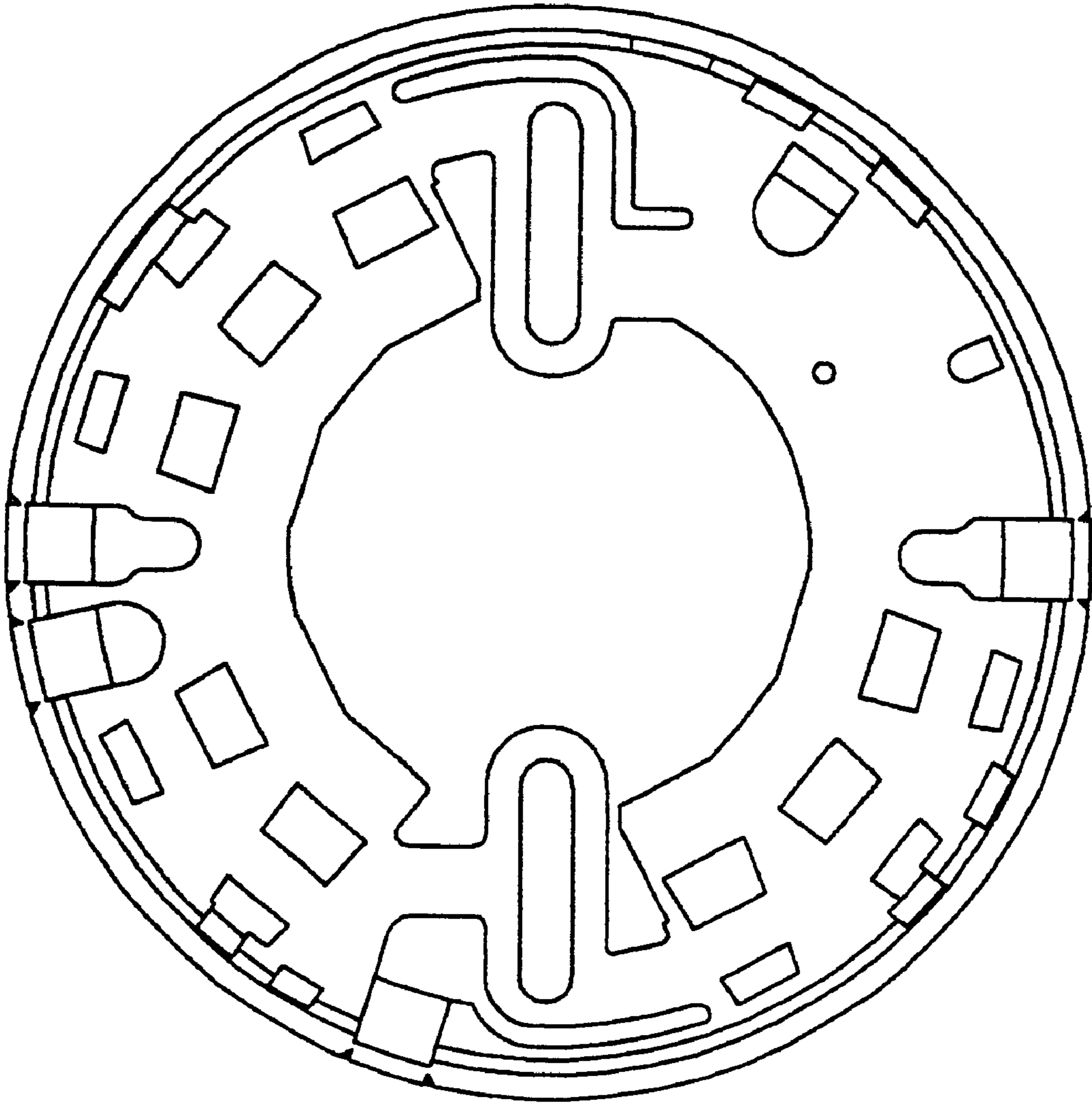
