(57) **CLAIM**

The ornamental design for a cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view of a cellular phone, showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top elevational view thereof;  
FIG. 7 is a bottom elevational view thereof; and,  
FIG. 8 is a front view thereof with the cellular phone in an alternate position.

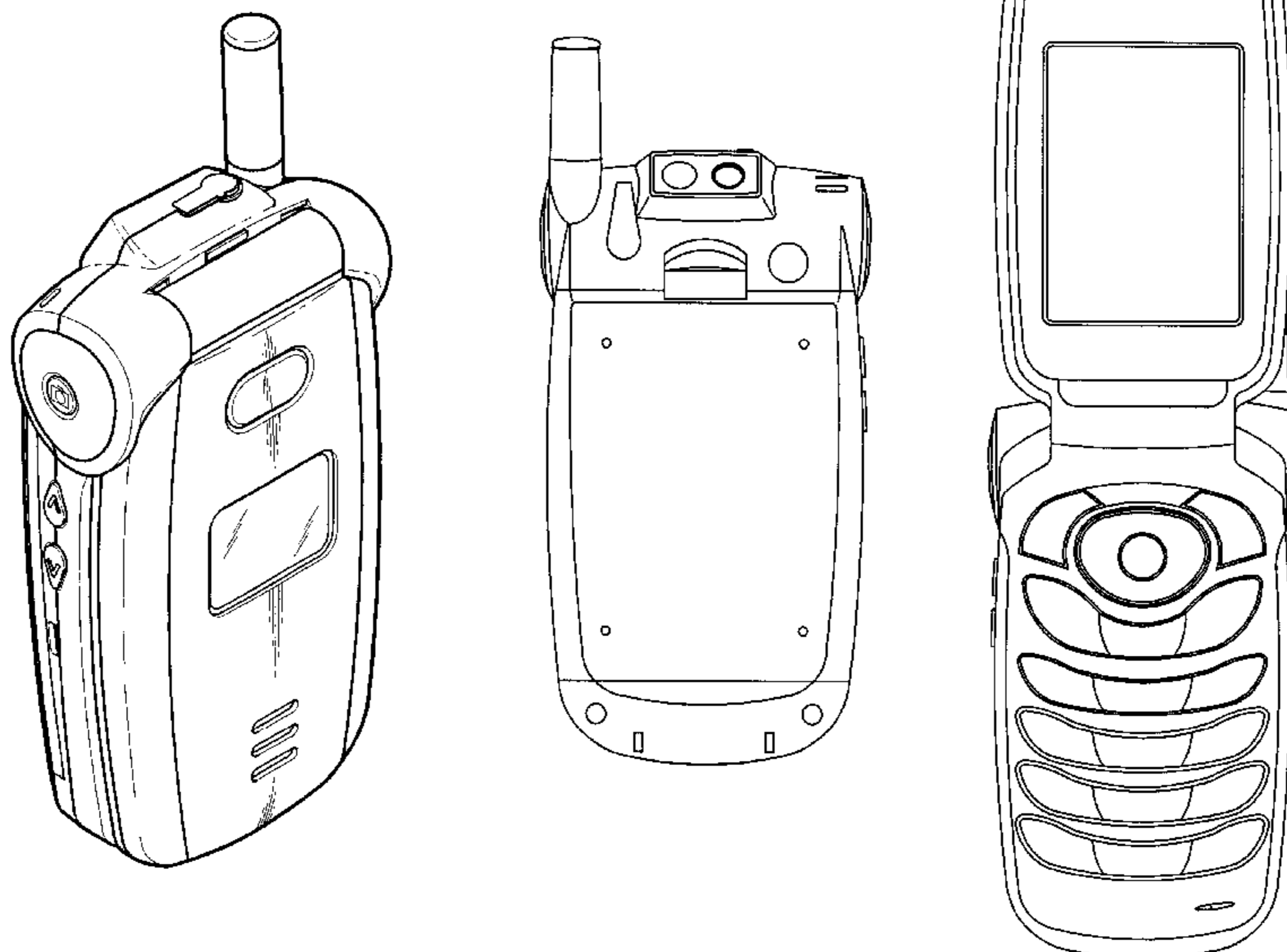

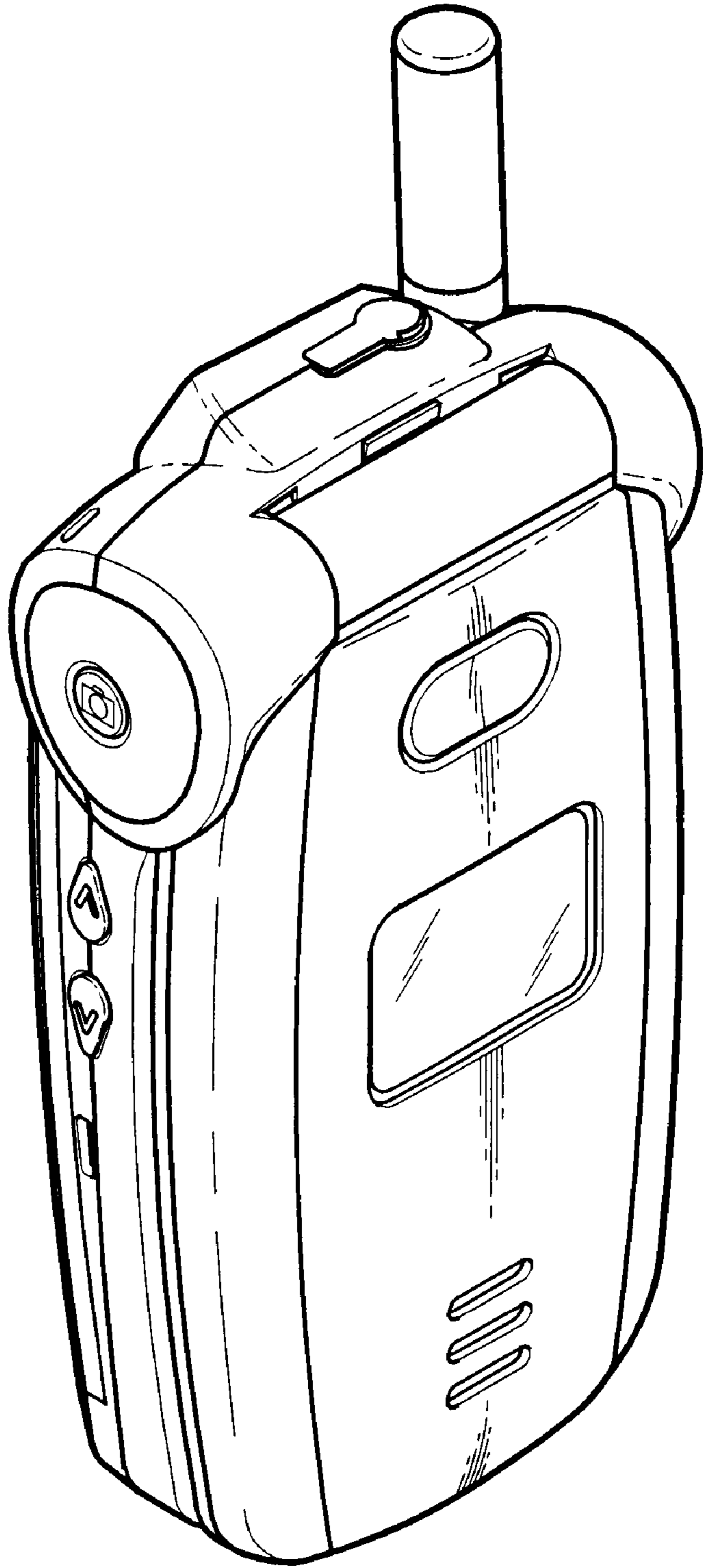

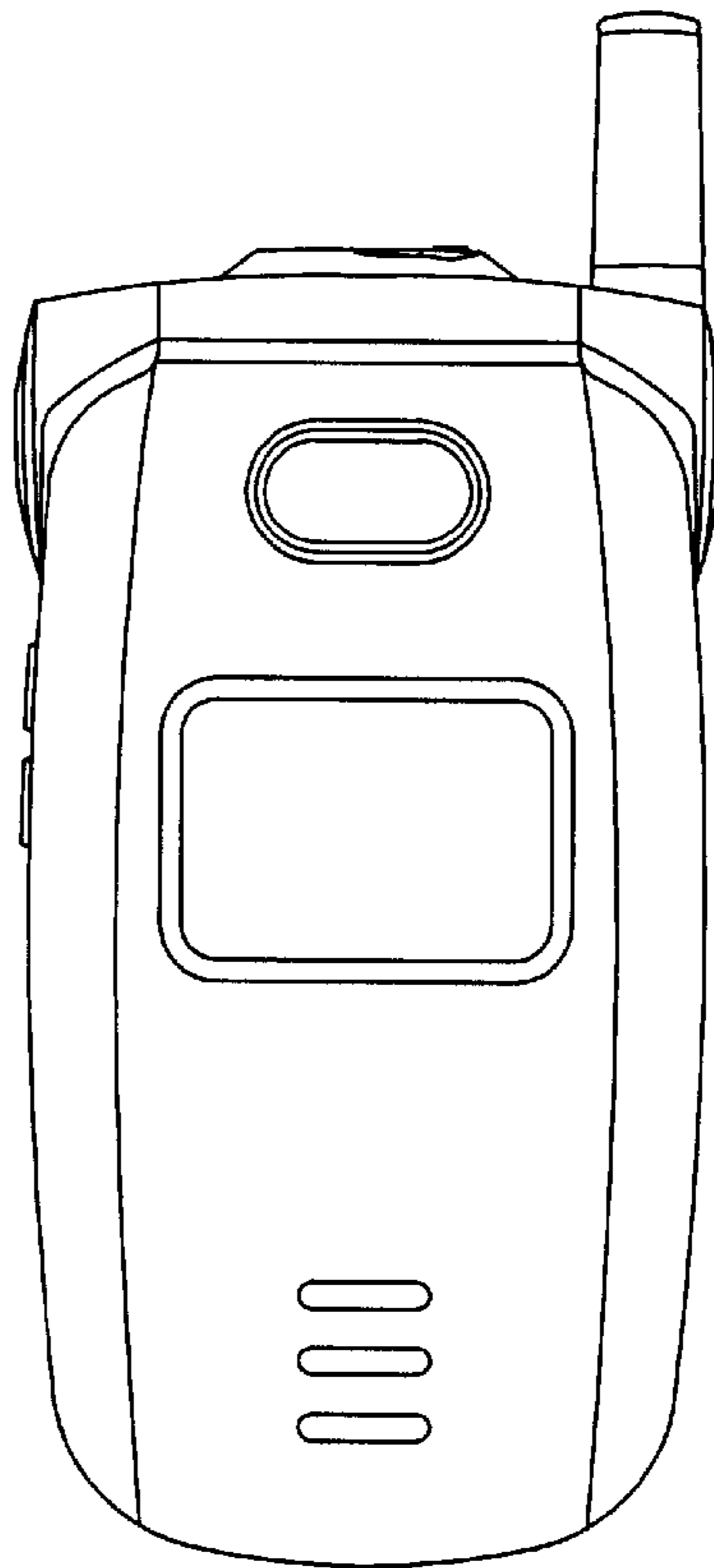

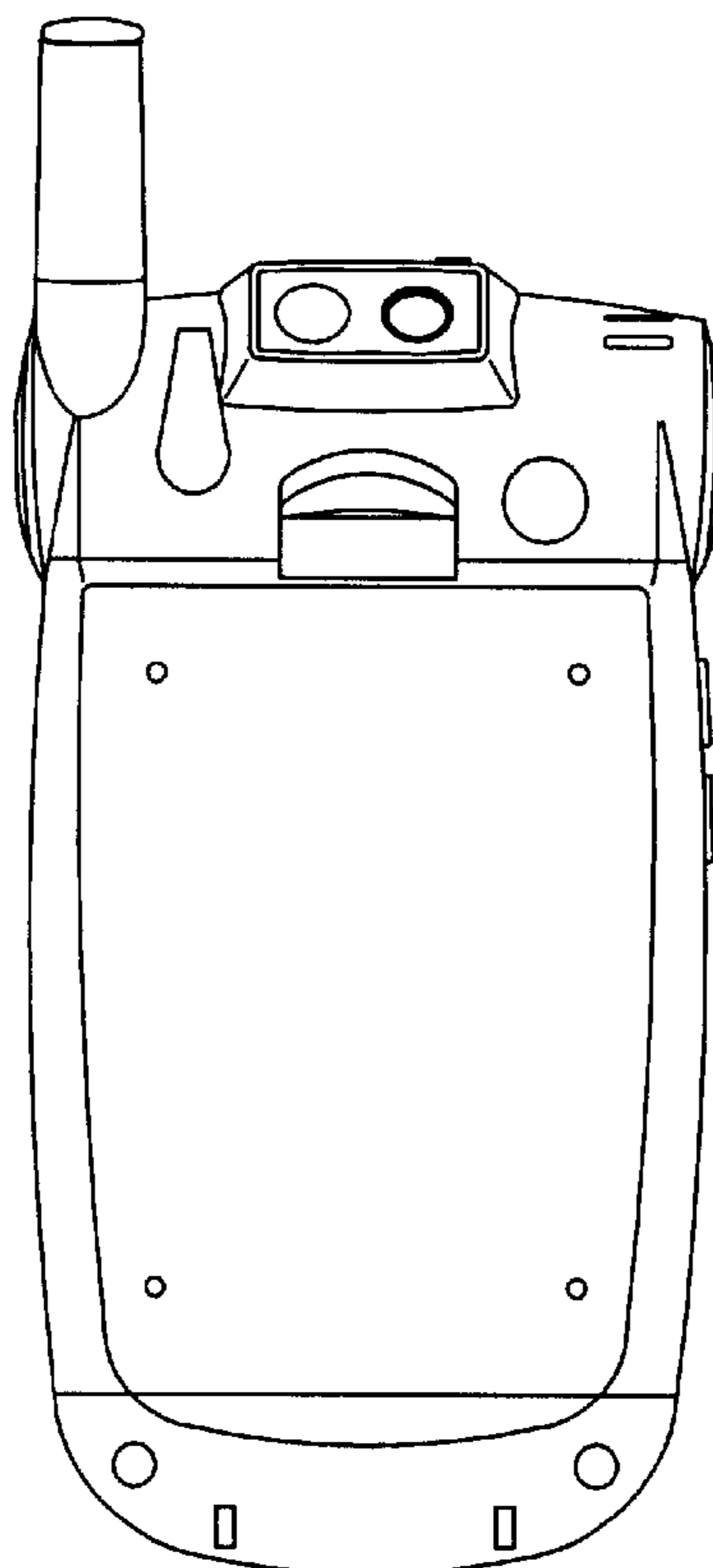

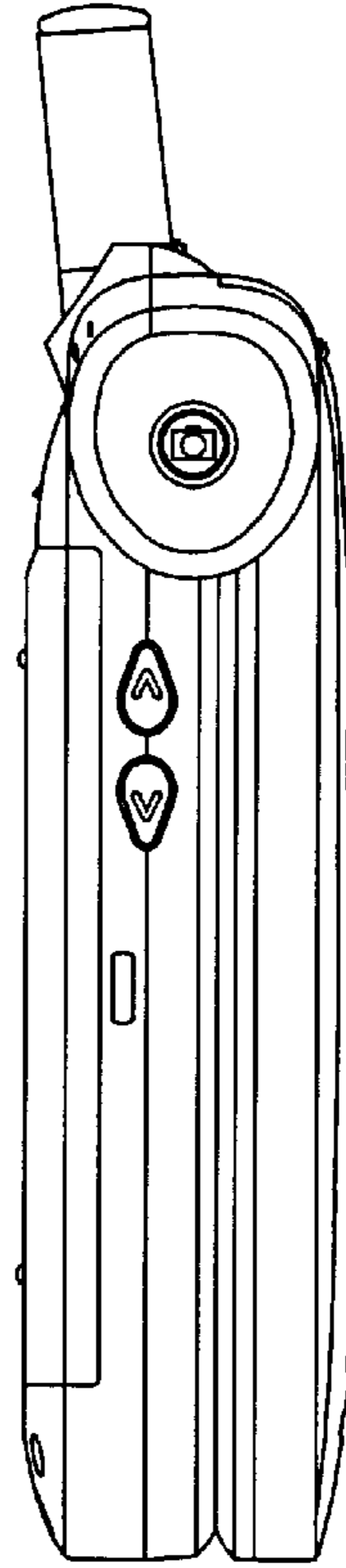

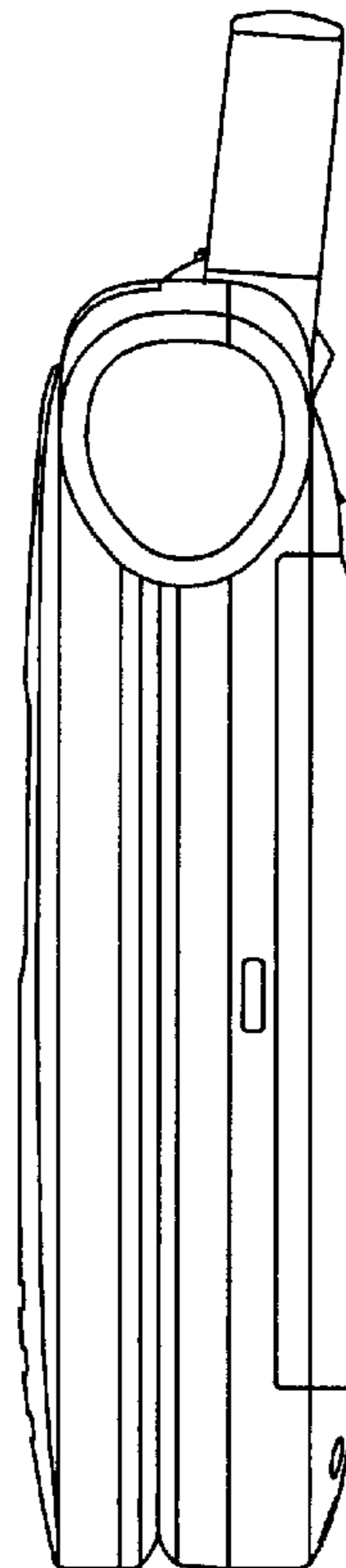

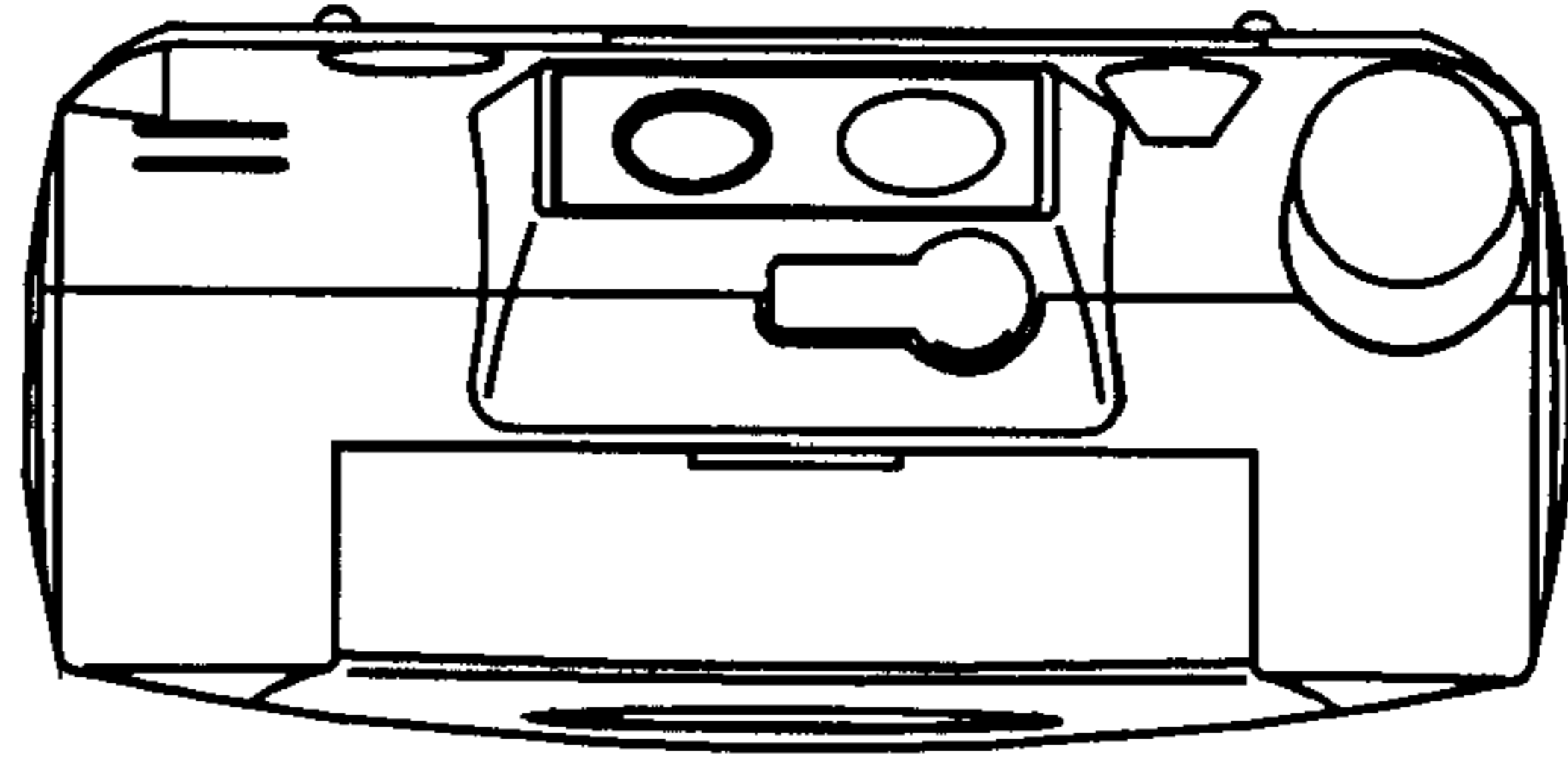

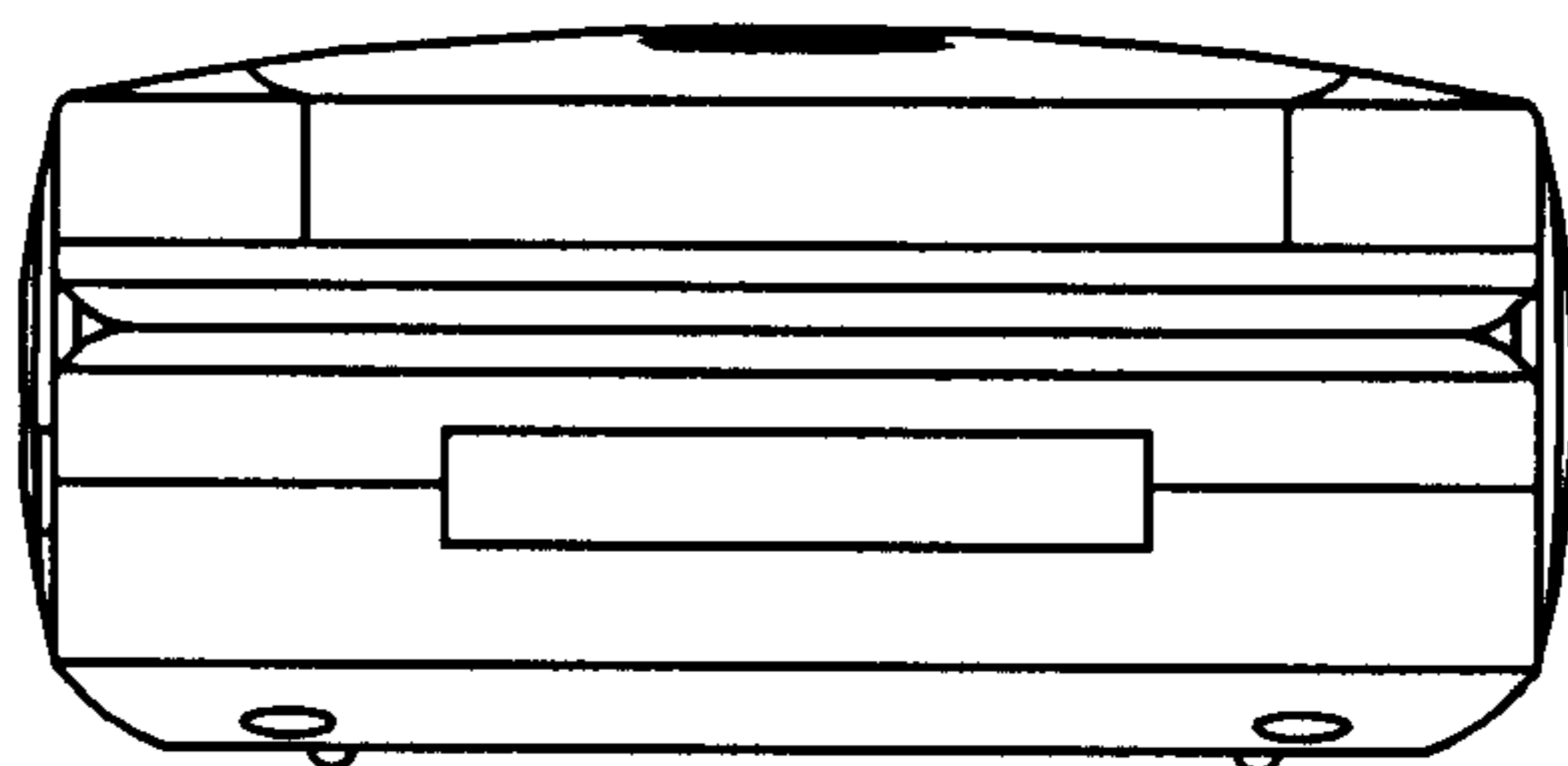
