(57) **CLAIM**

The ornamental design for a housing accessory for communication devices or similar articles, substantially as shown.

DESCRIPTION

FIG. 5 is a side view thereof.

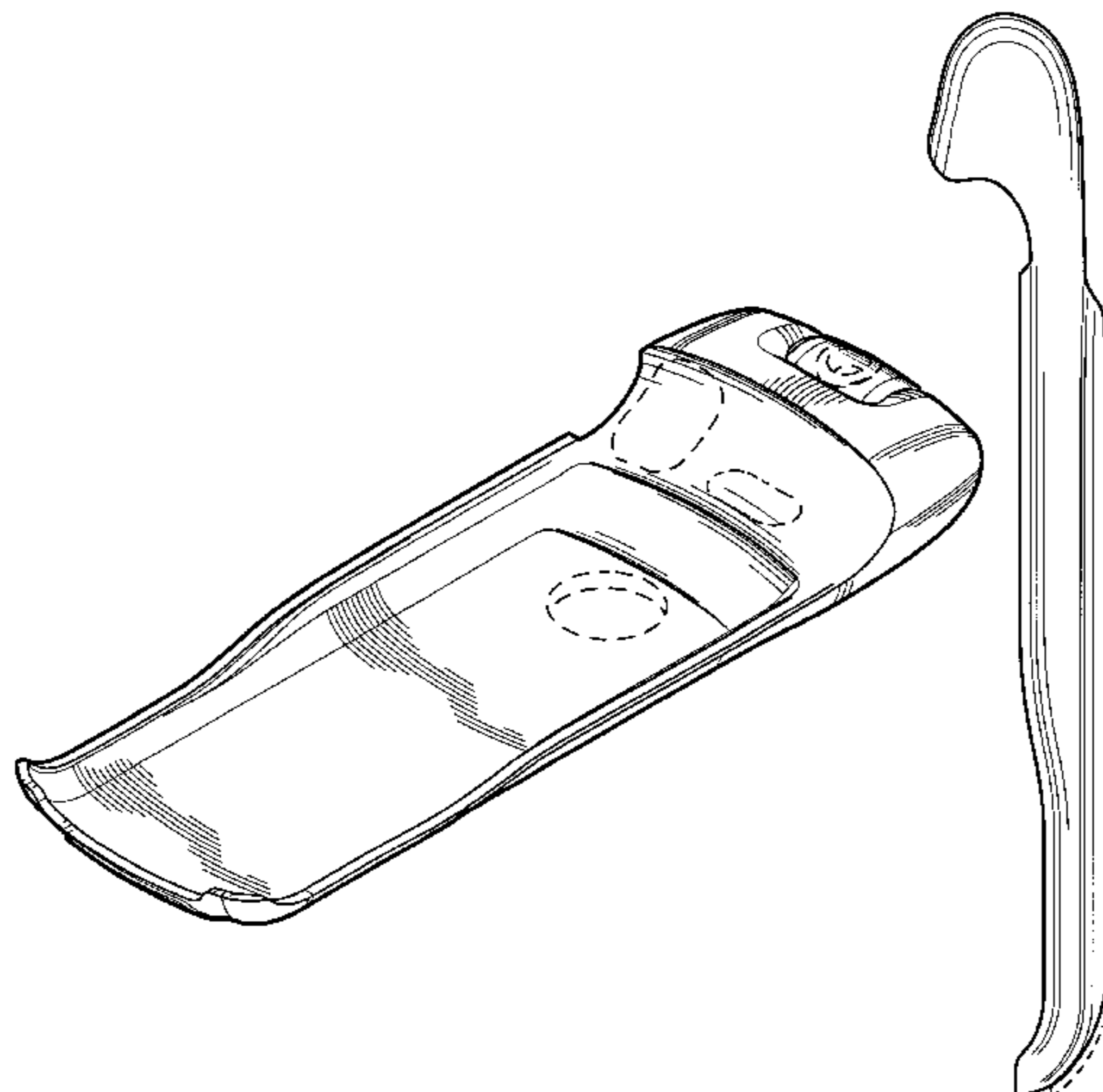
FIG. 6 is an opposite side view thereof.

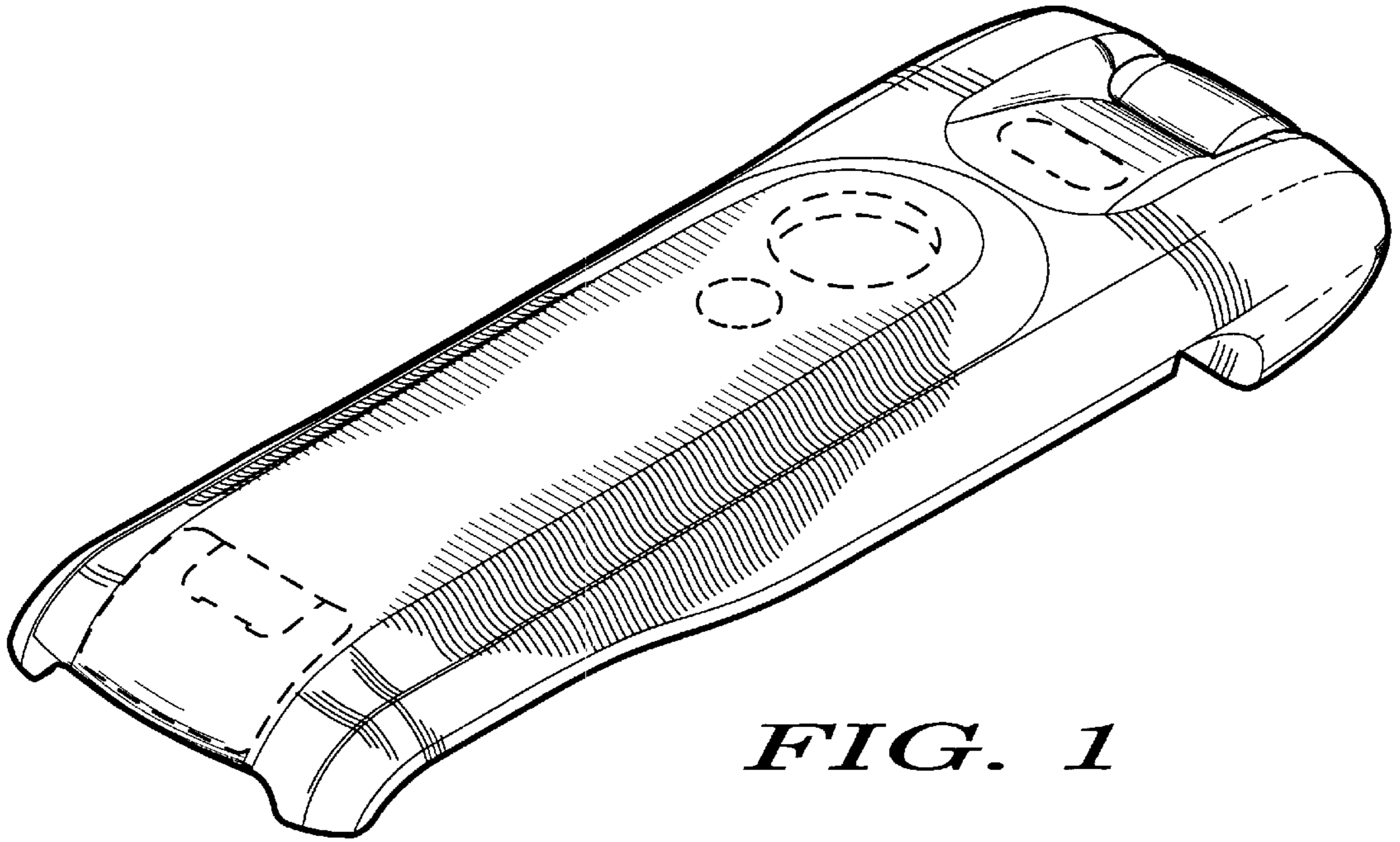

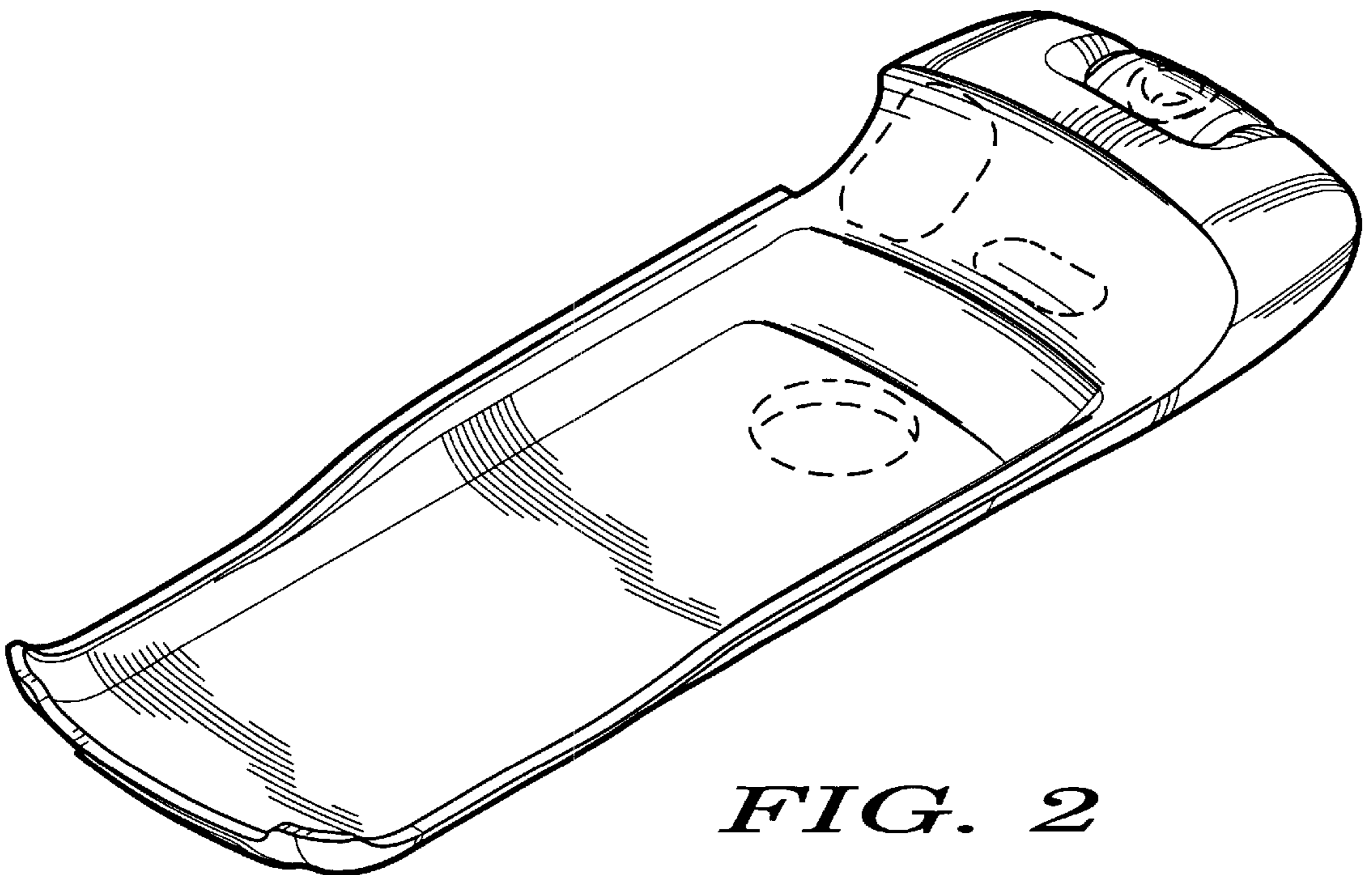

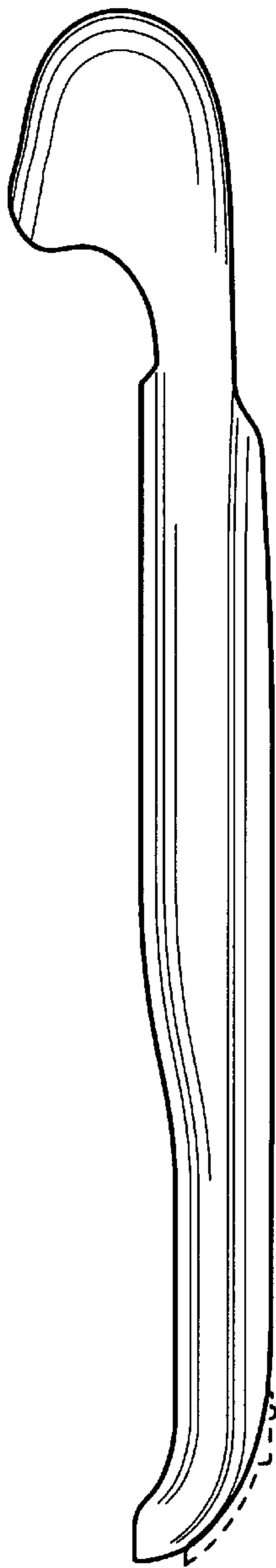

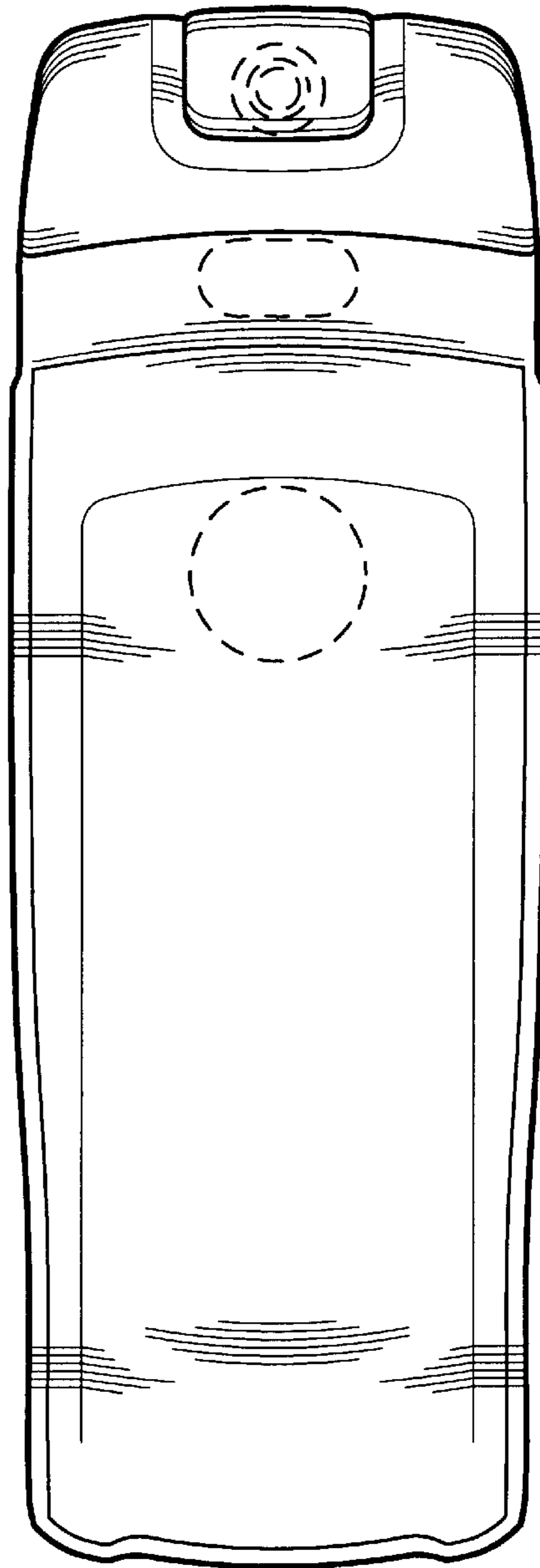

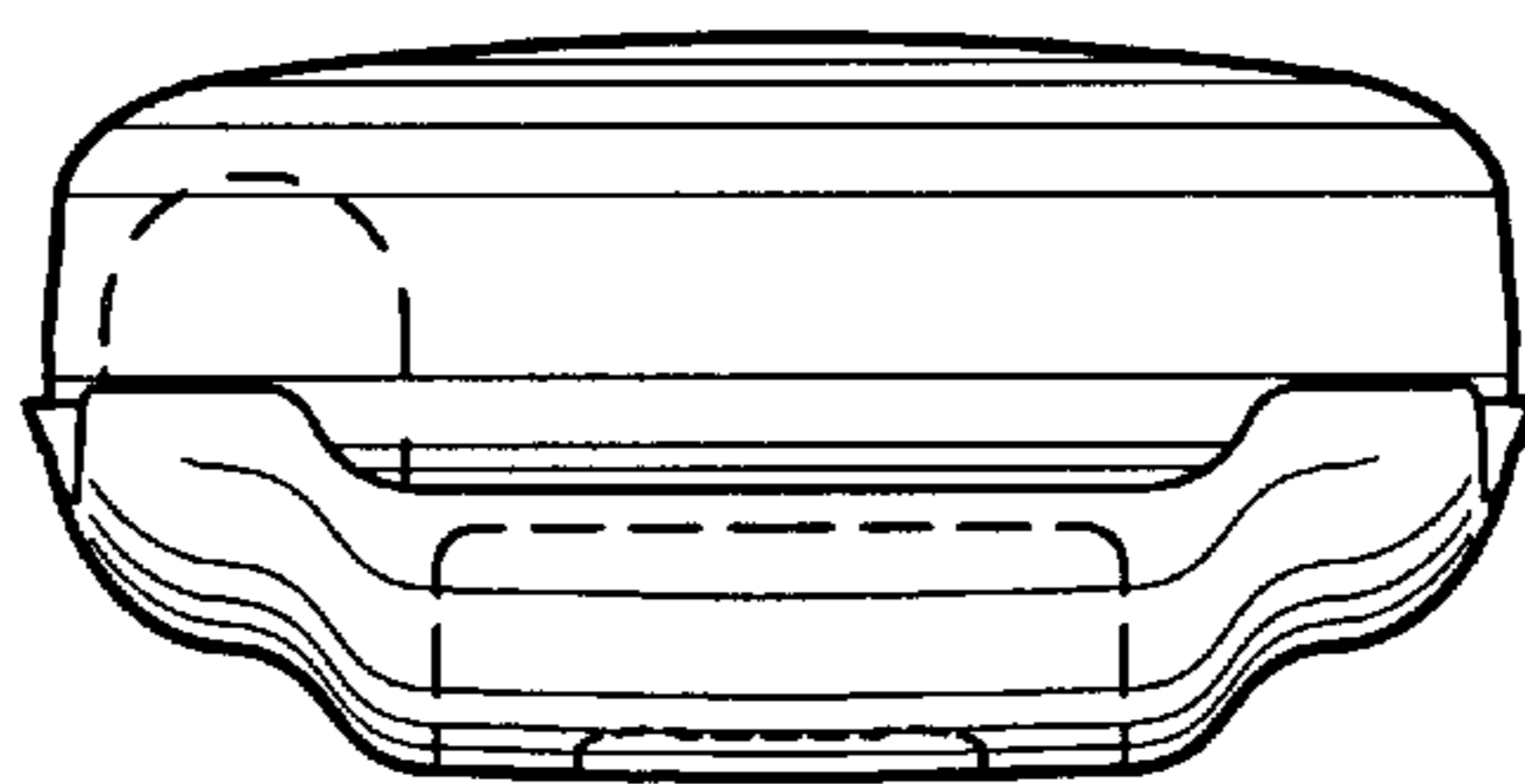

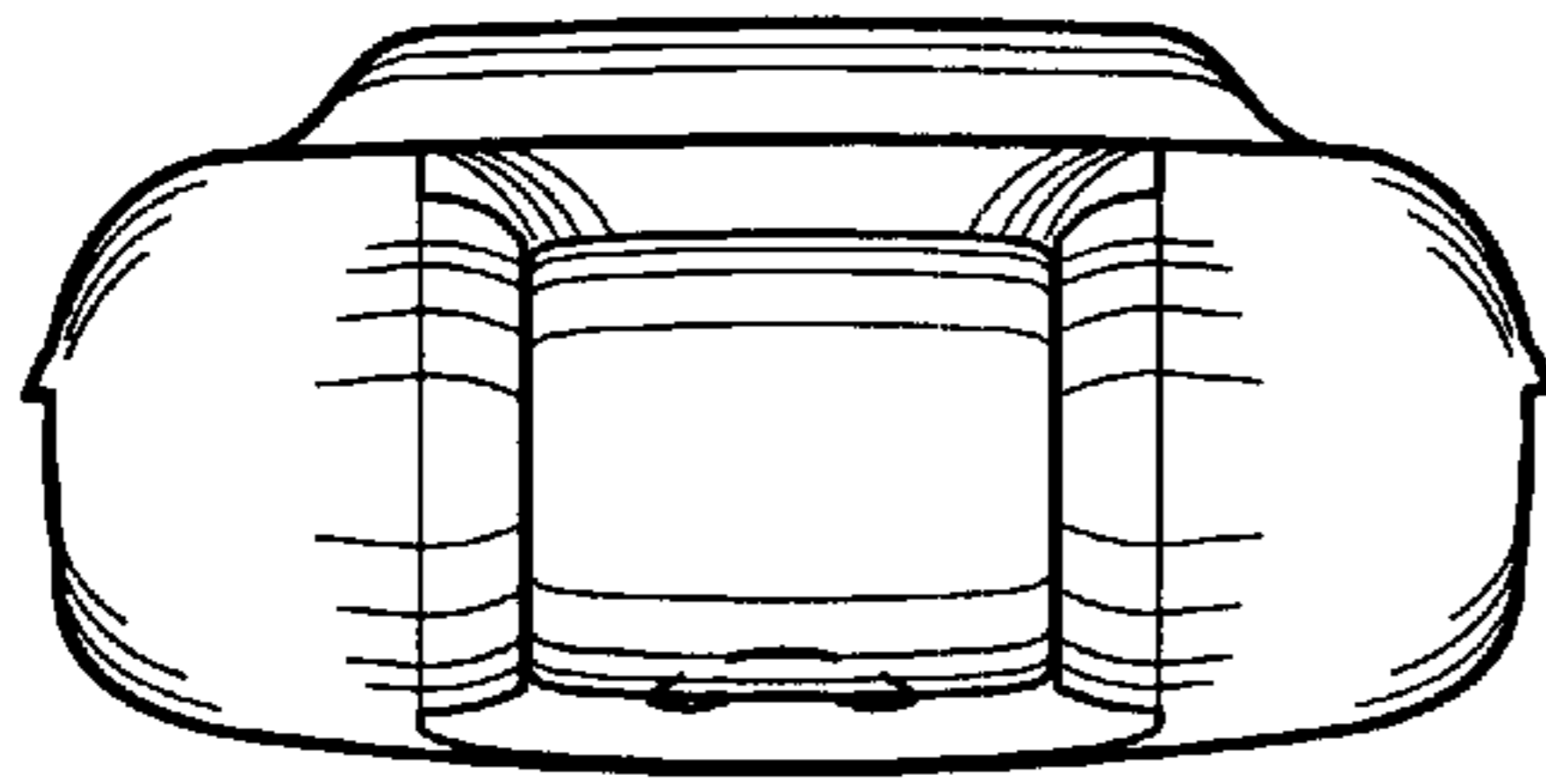

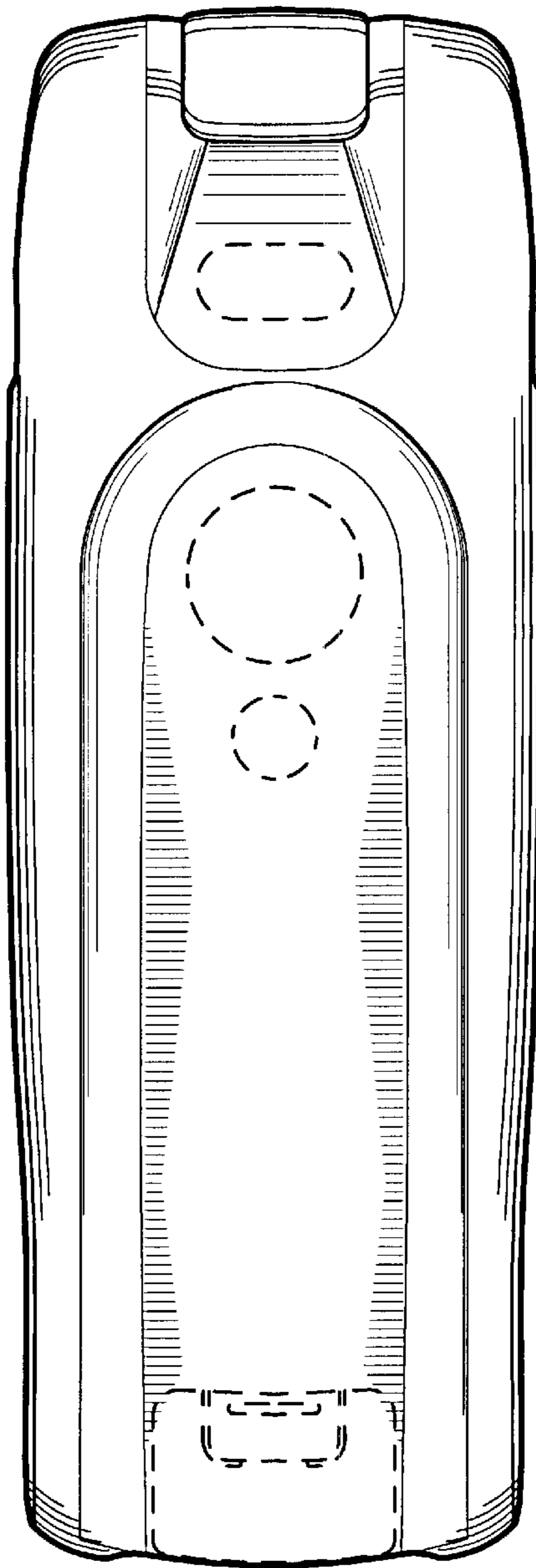

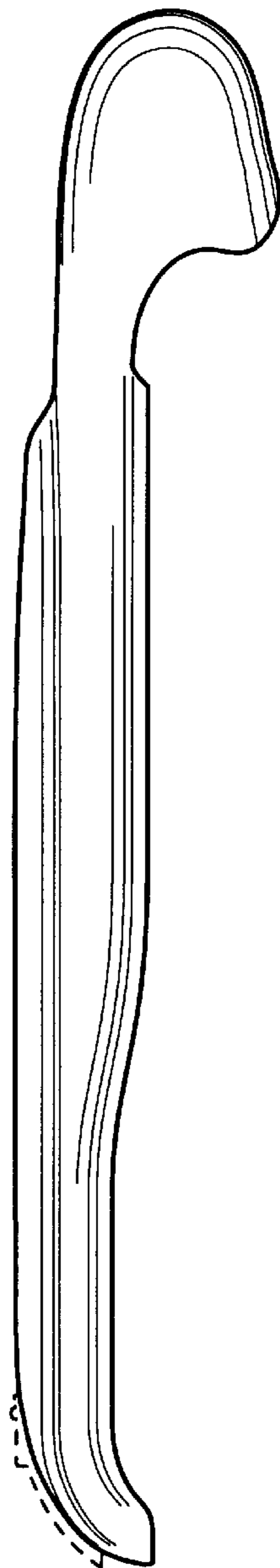
