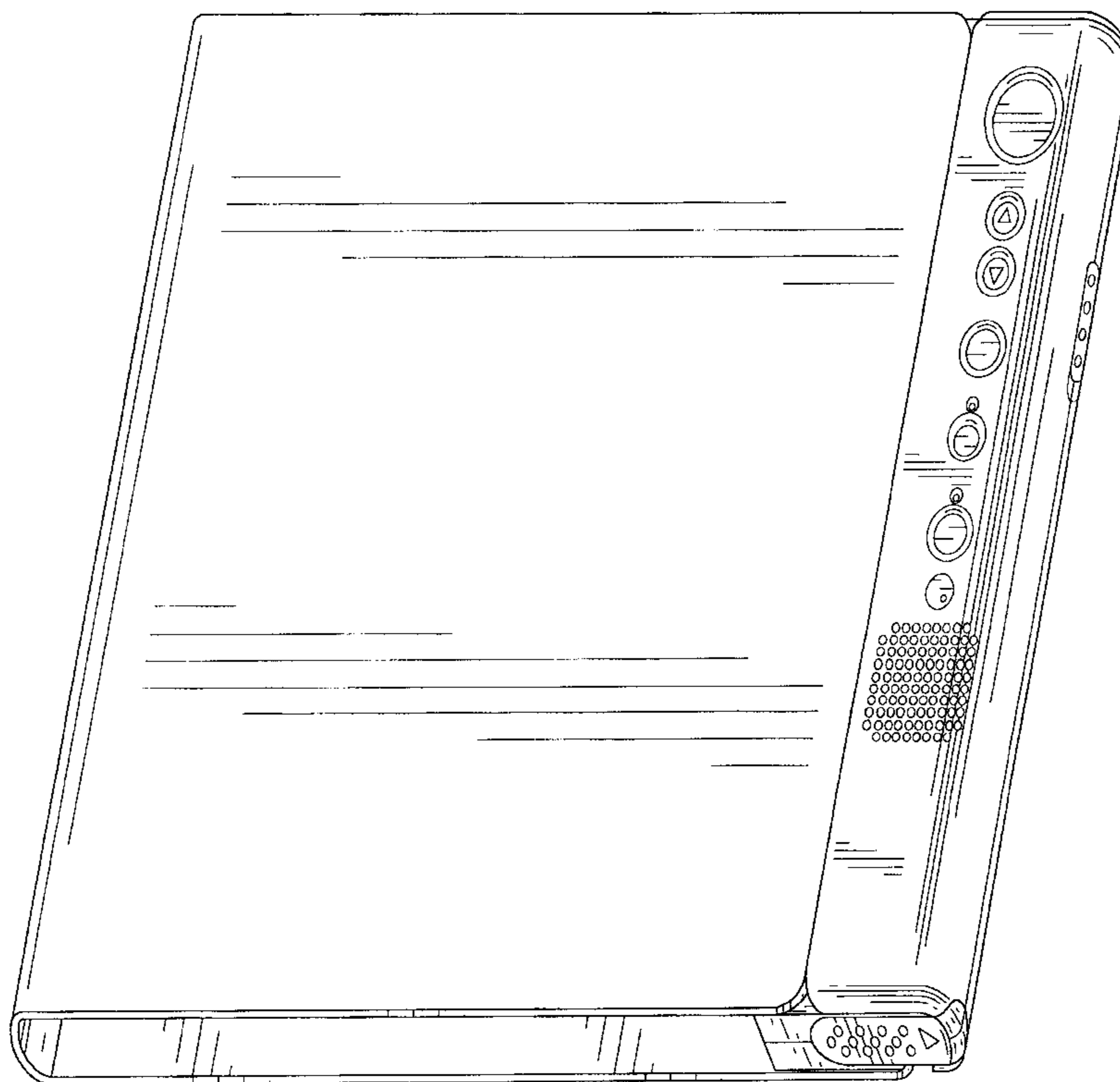
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of the talking photograph album showing a preferred embodiment of our new design; FIG. 2 is a rear view thereof; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a top-end view thereof; FIG. 6 is a bottom-end view thereof; and, FIG. 7 is a perspective view thereof.

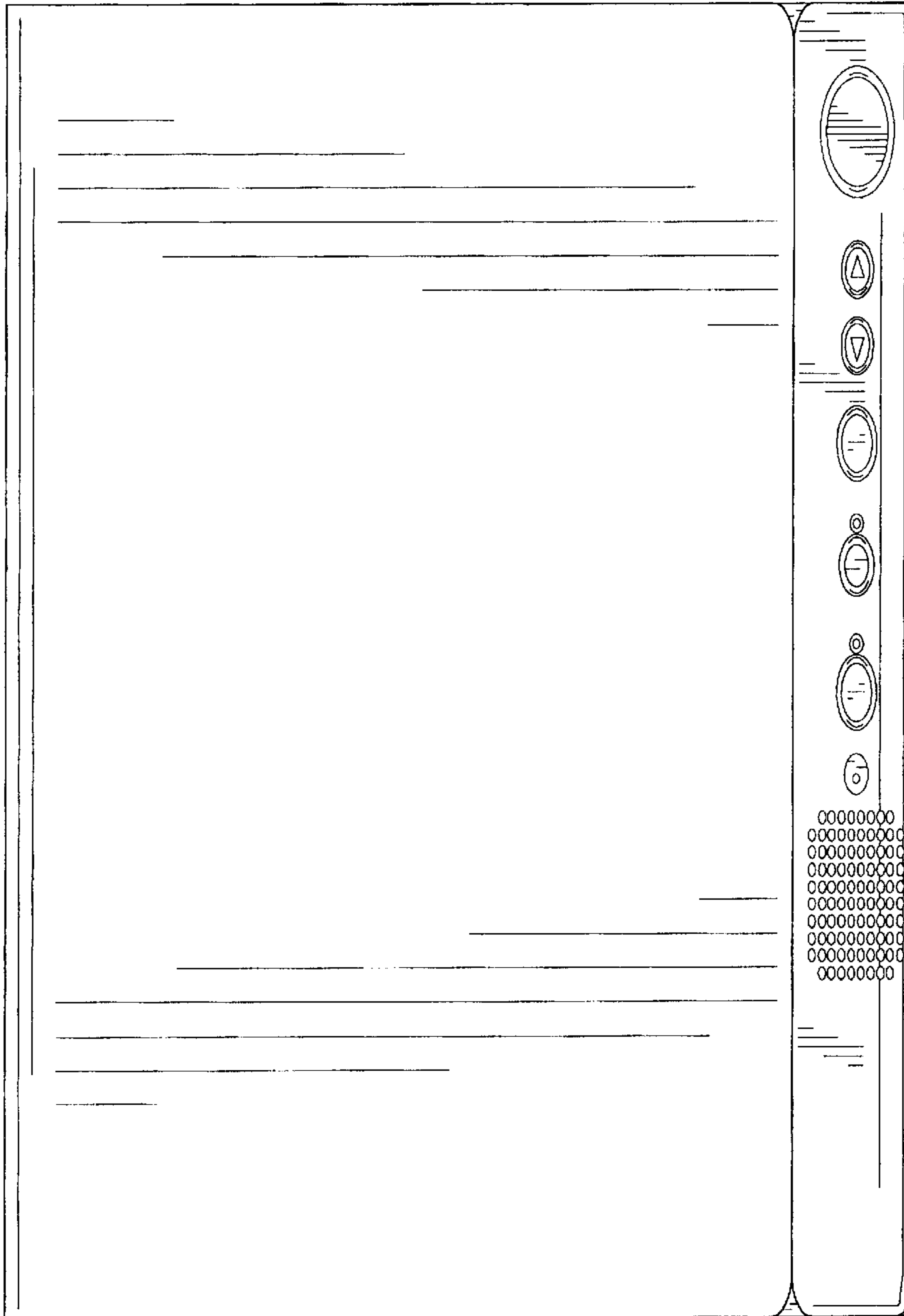

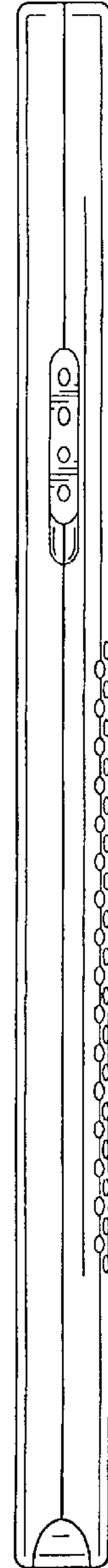

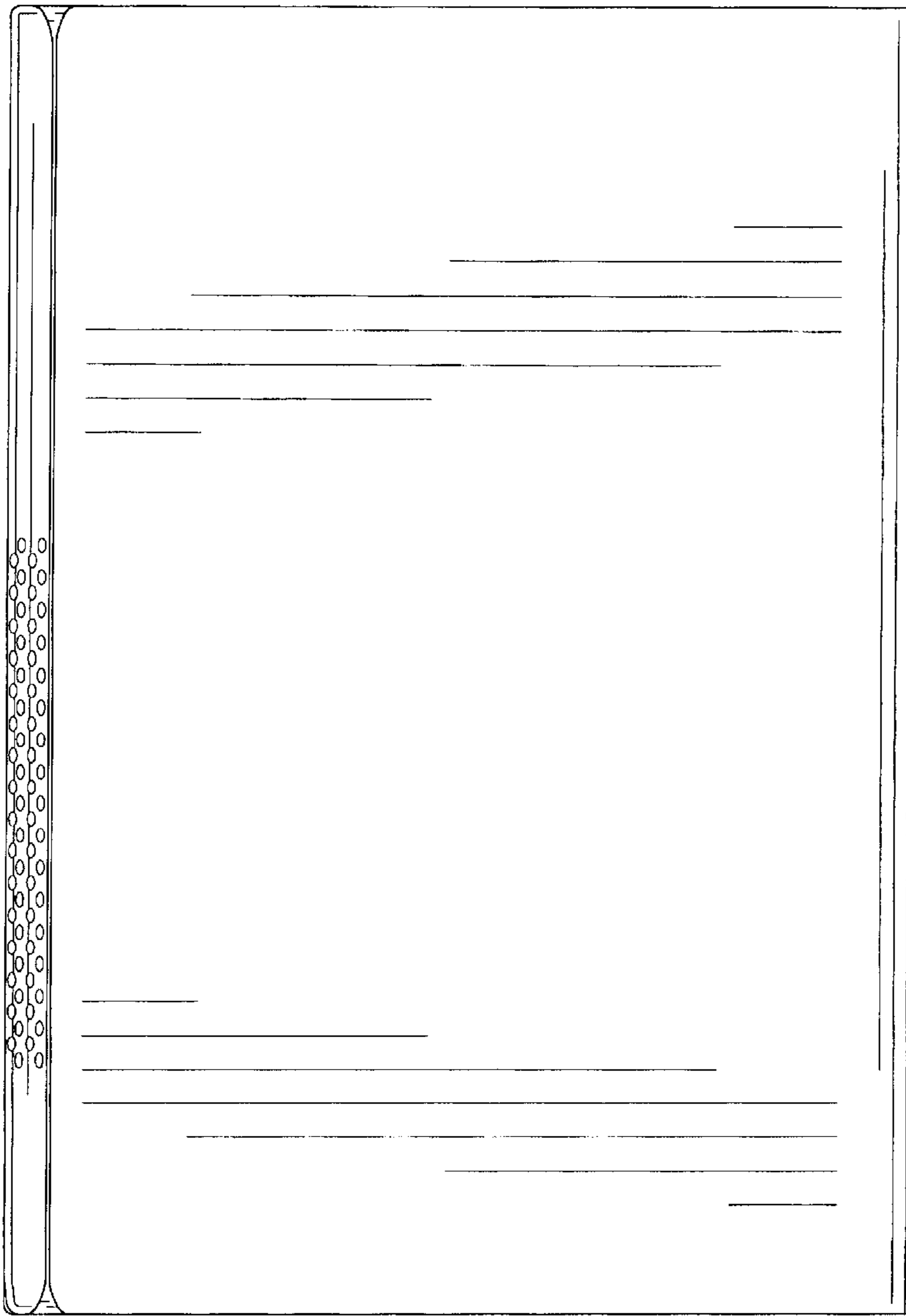

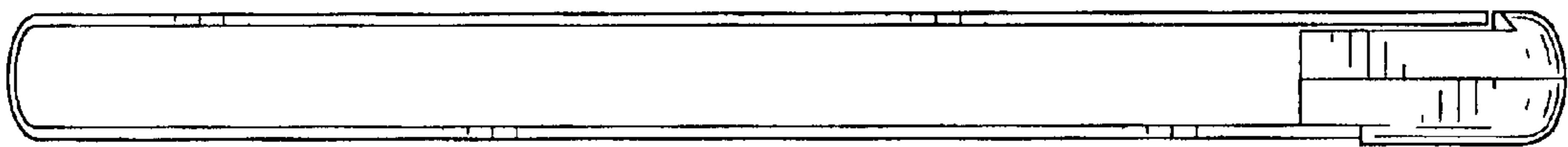

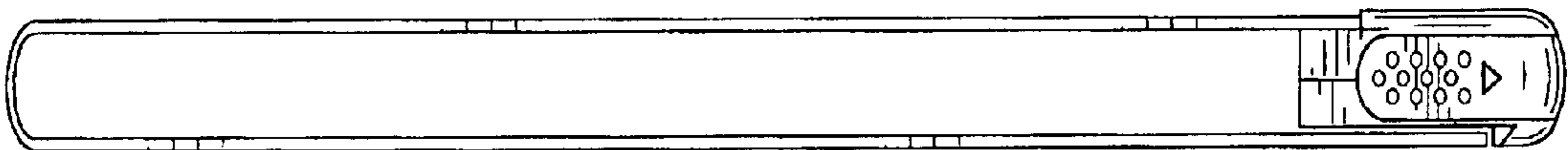

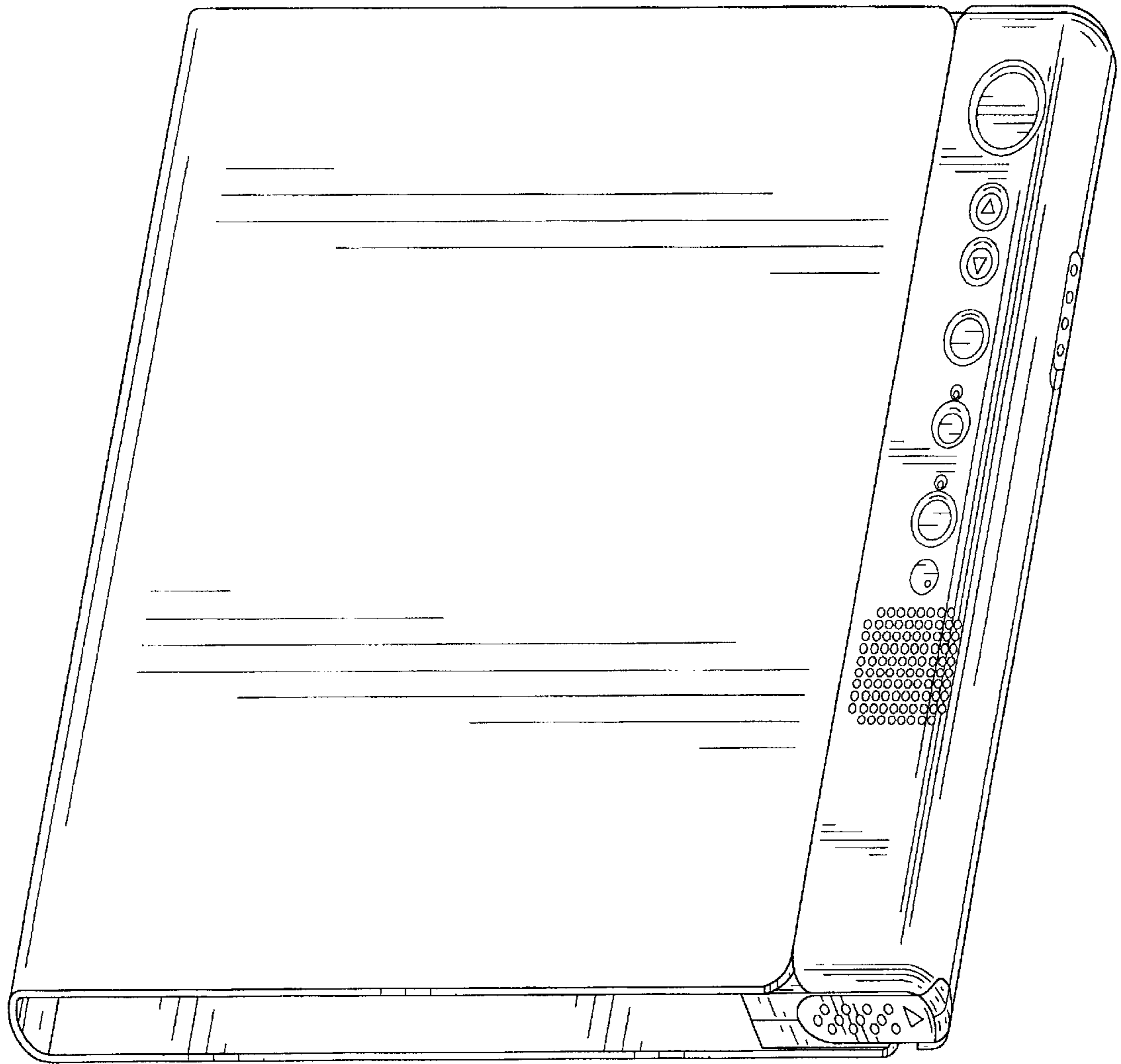
