FIG. 2 is a heel end perspective view thereof;

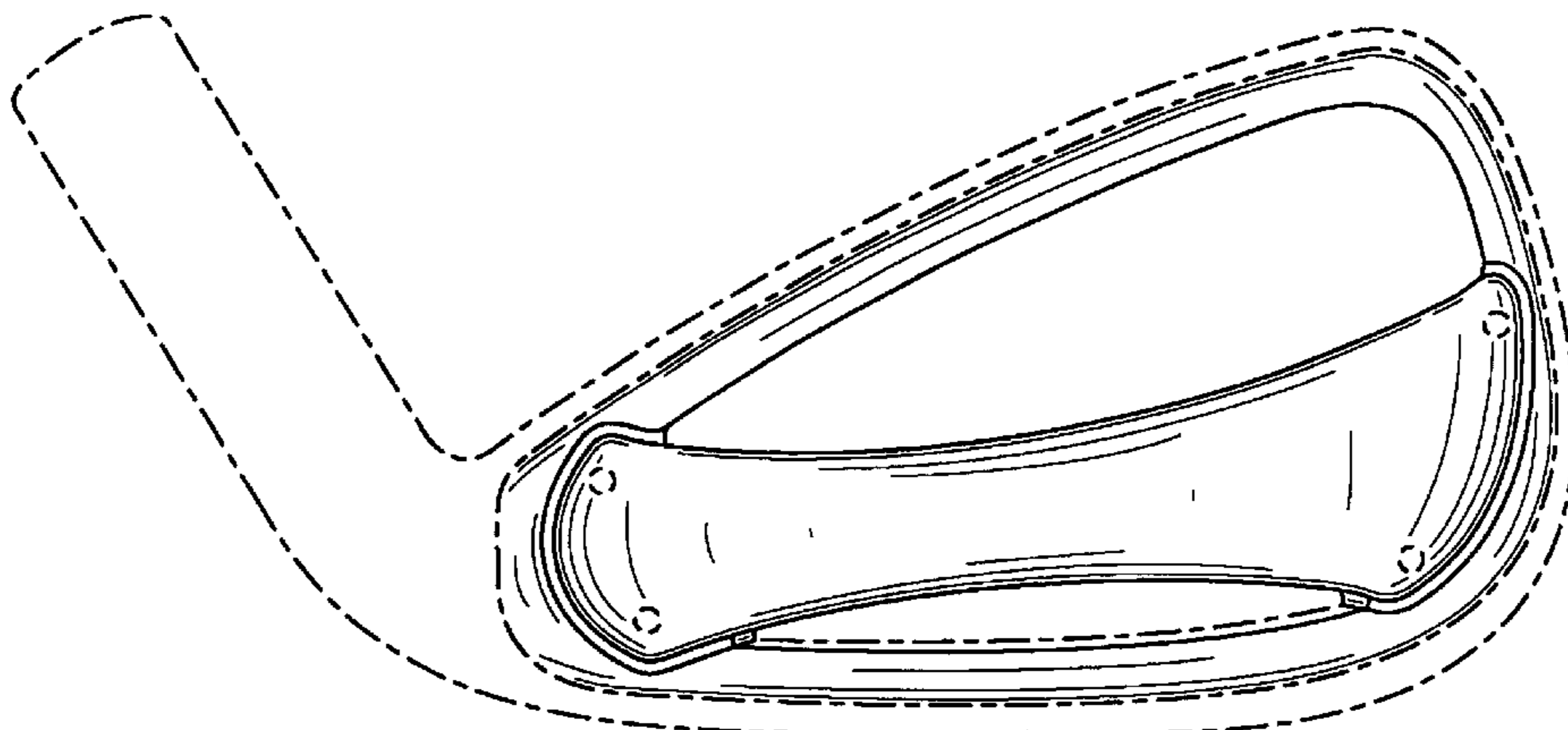
FIG. 3 is a toe end perspective view thereof;

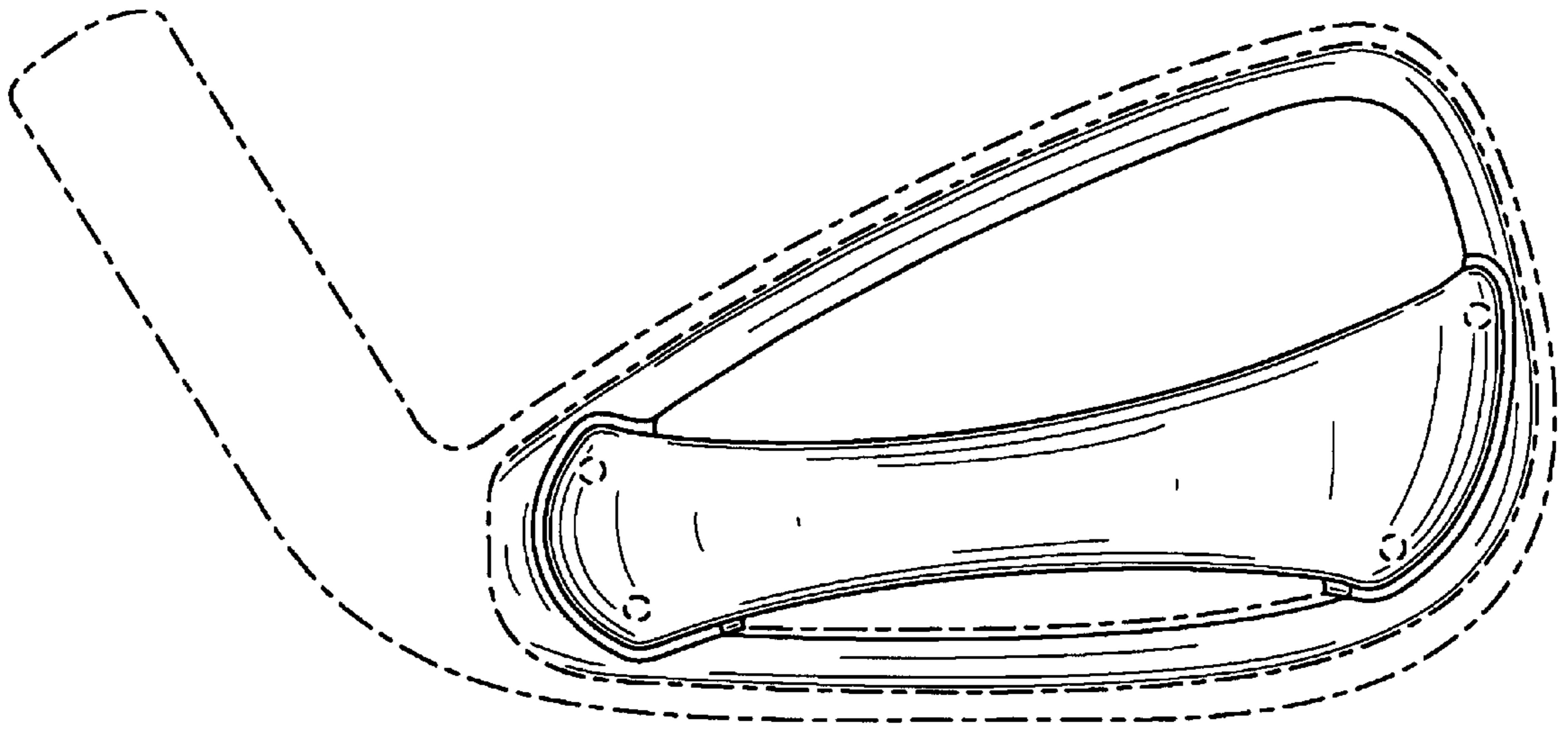

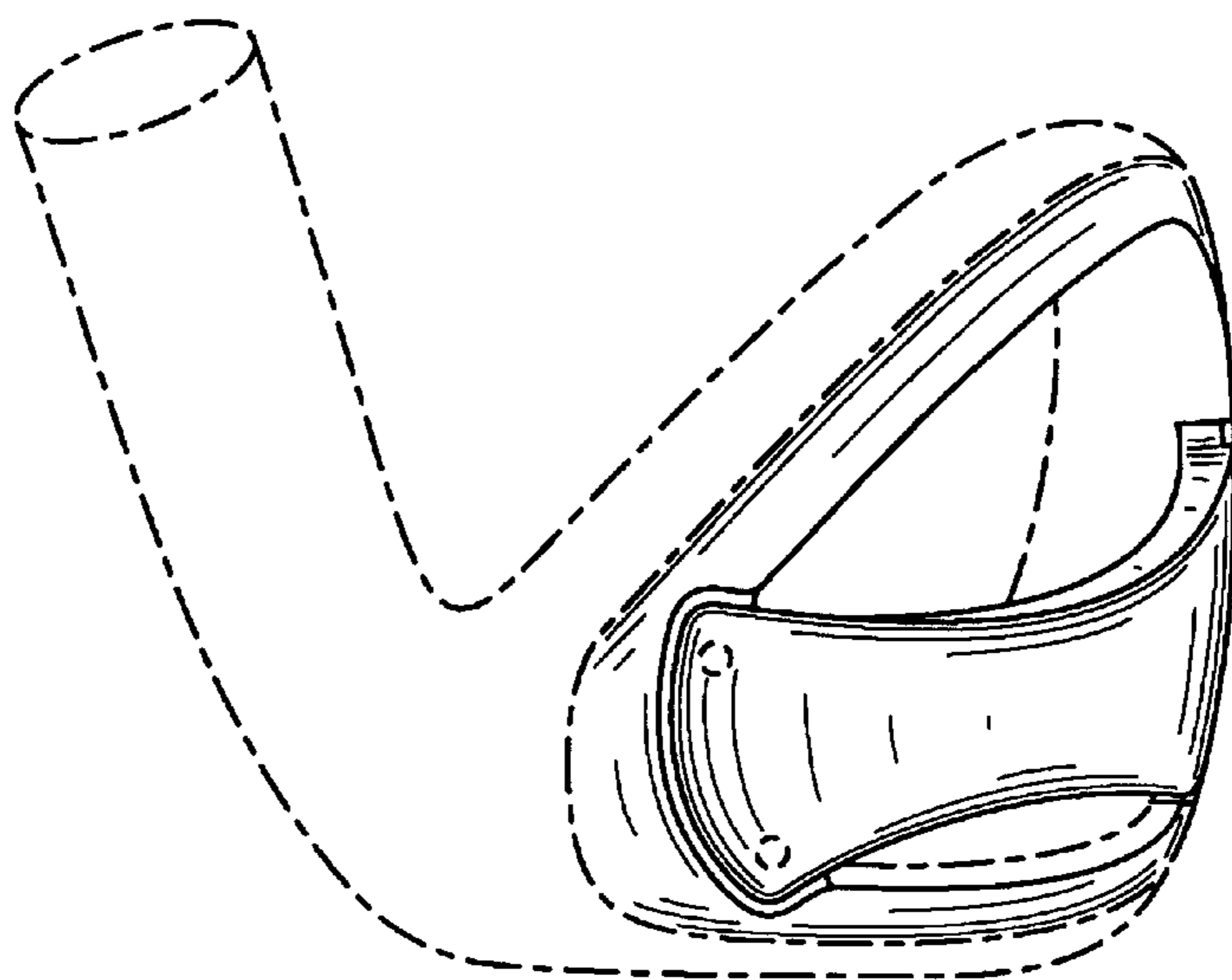

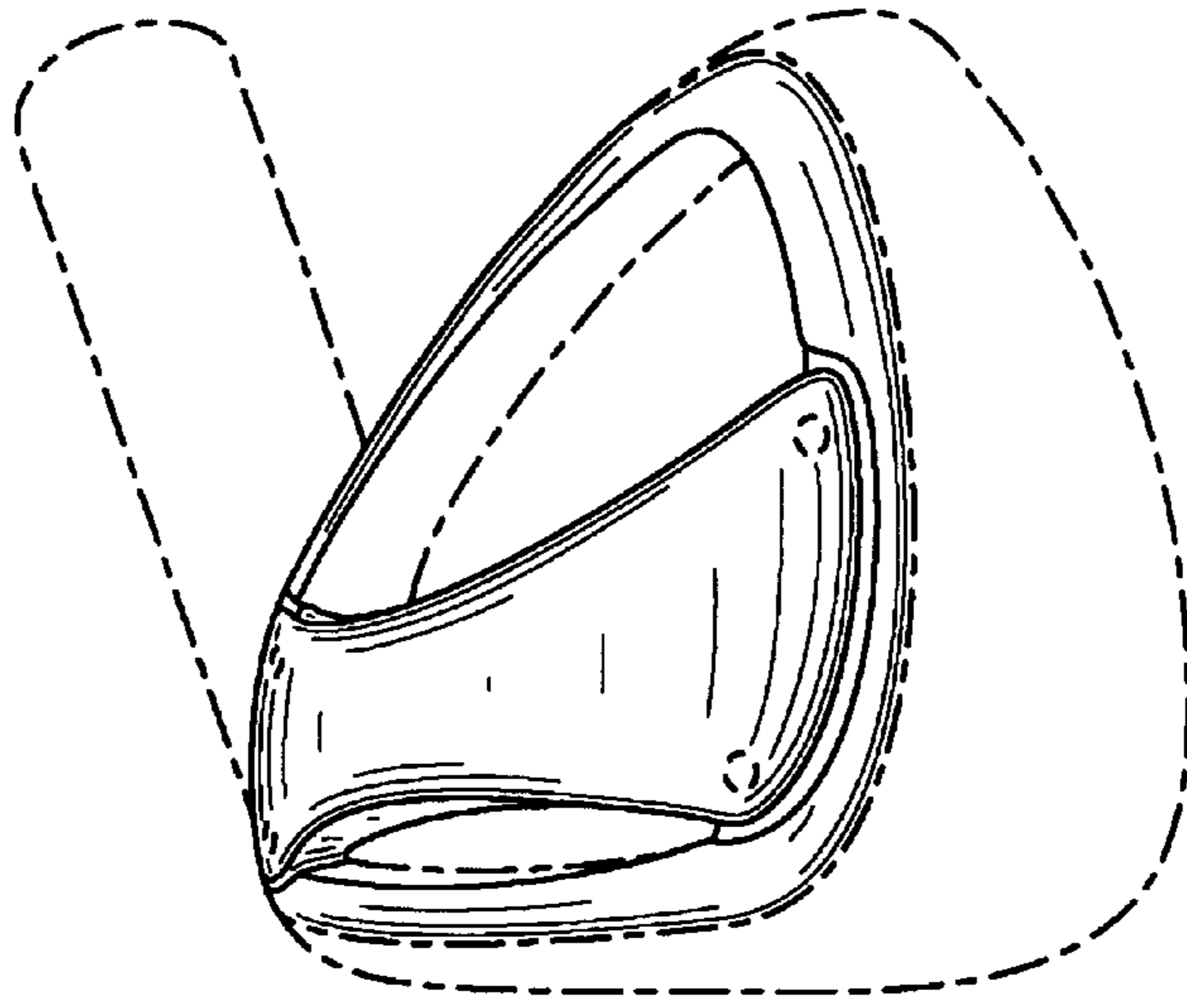

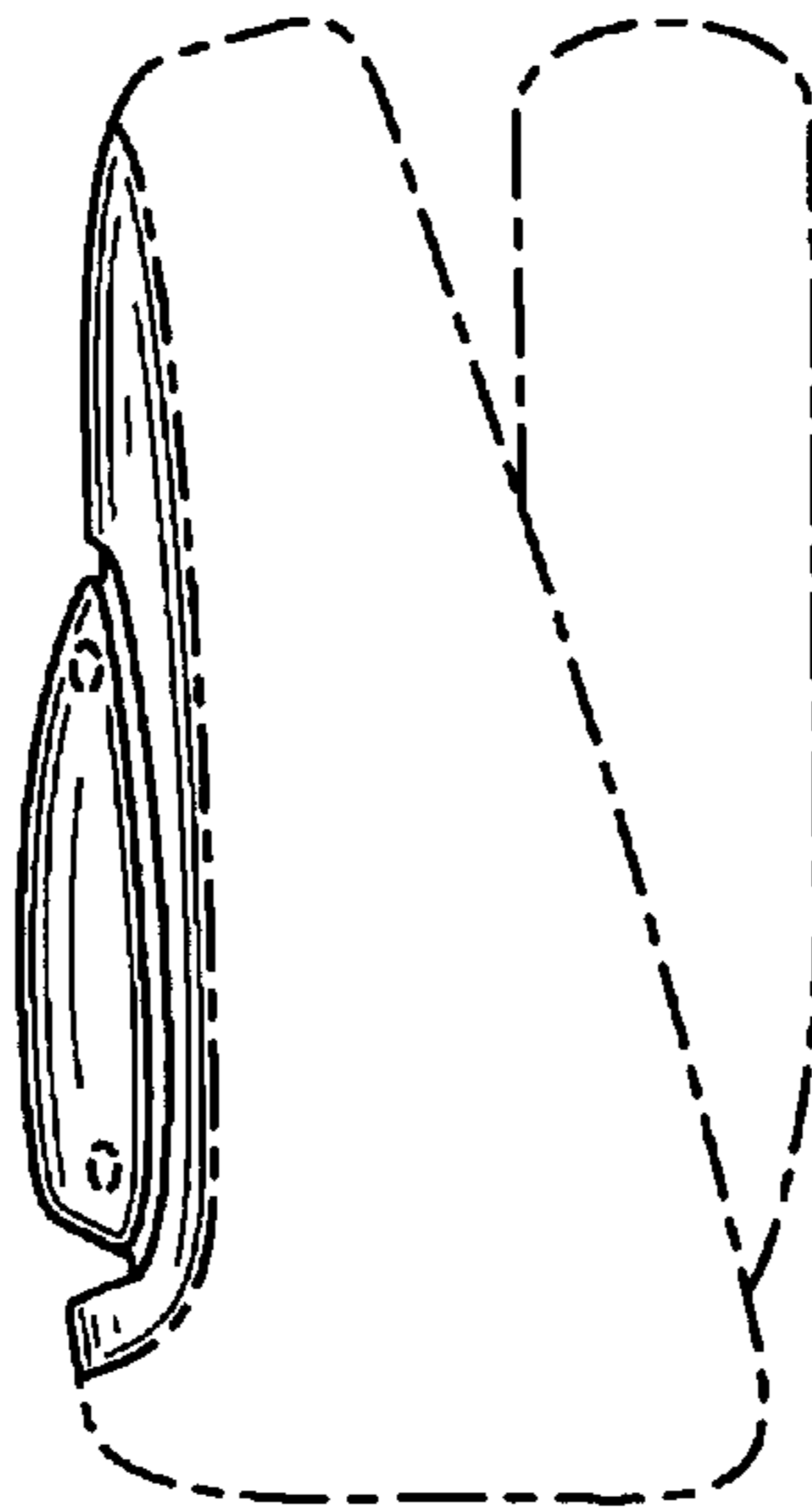

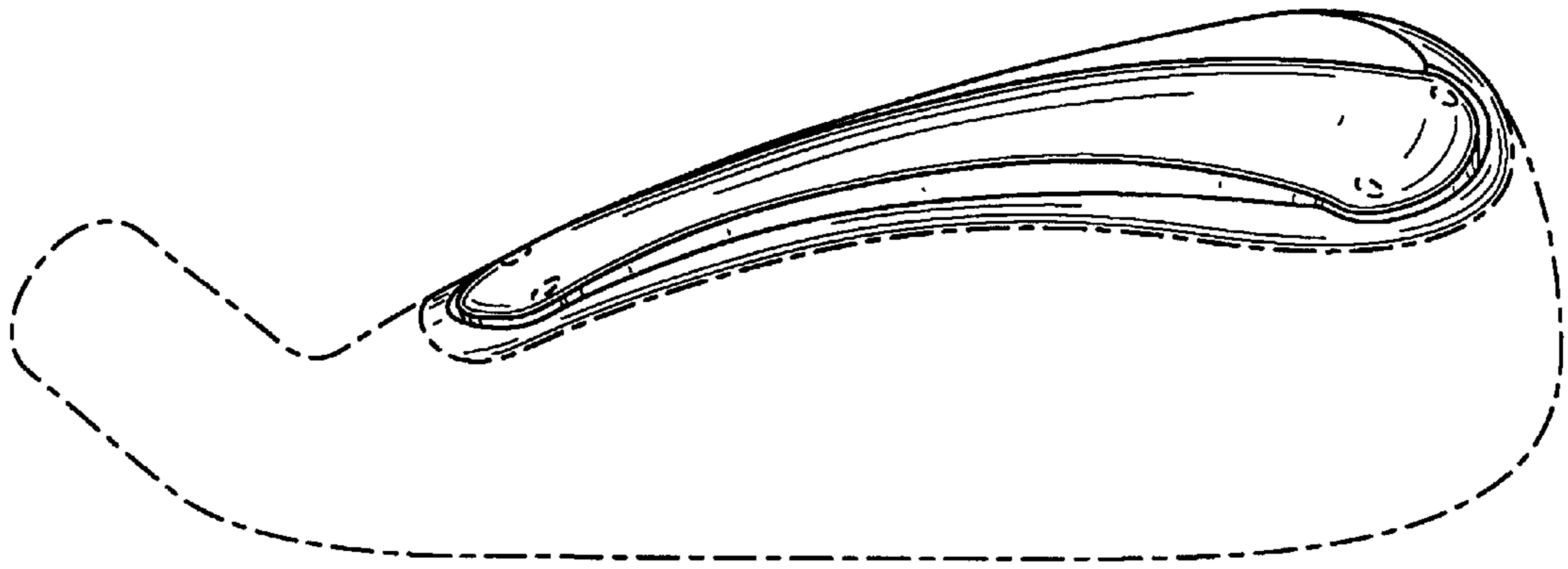
