**DESCRIPTION**

FIG. 1 is an elevational view of a portion of a golf club head showing our new design;

FIG. 2 is a heel end perspective view thereof;

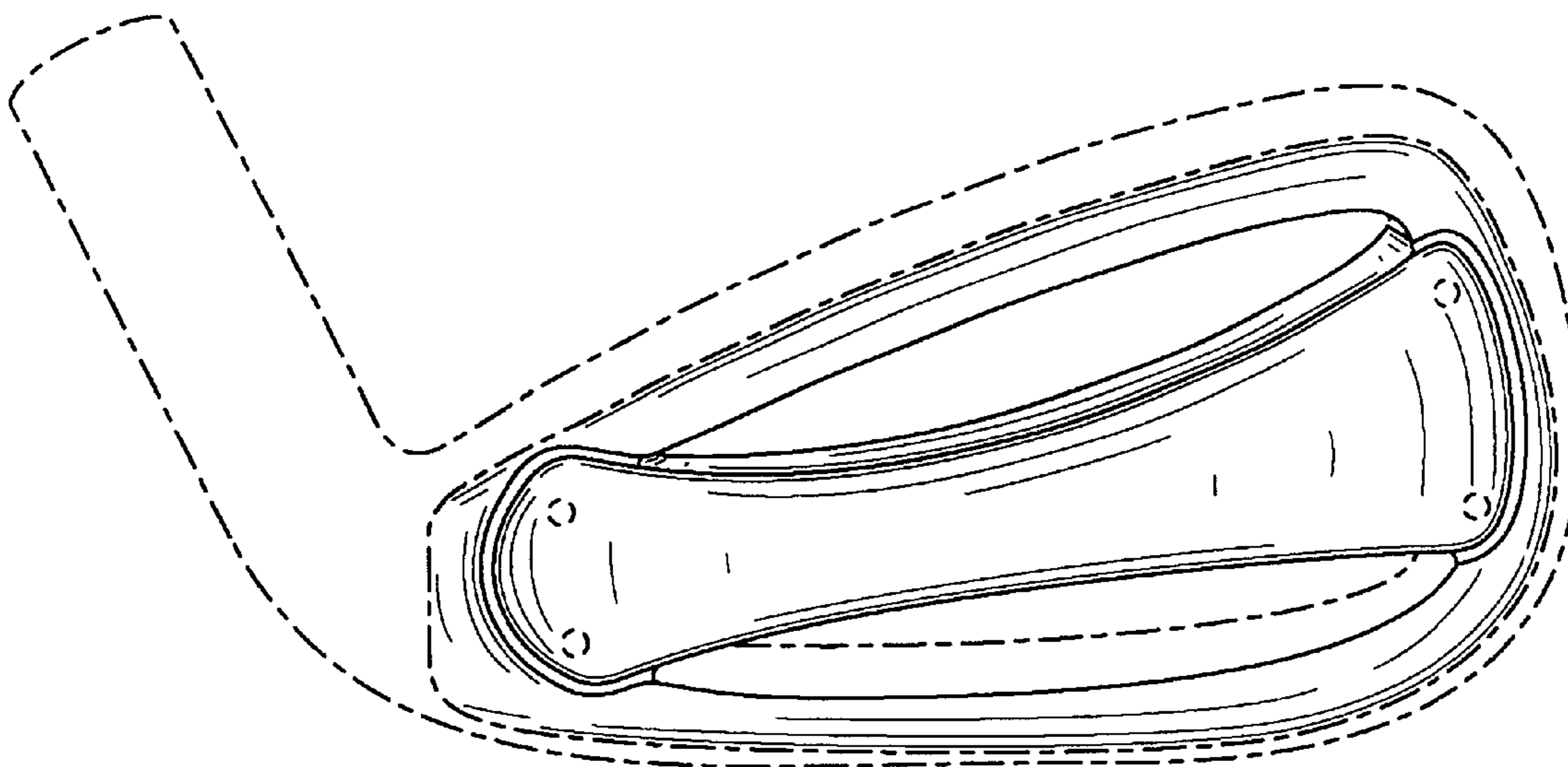
FIG. 3 is a toe end perspective view thereof;

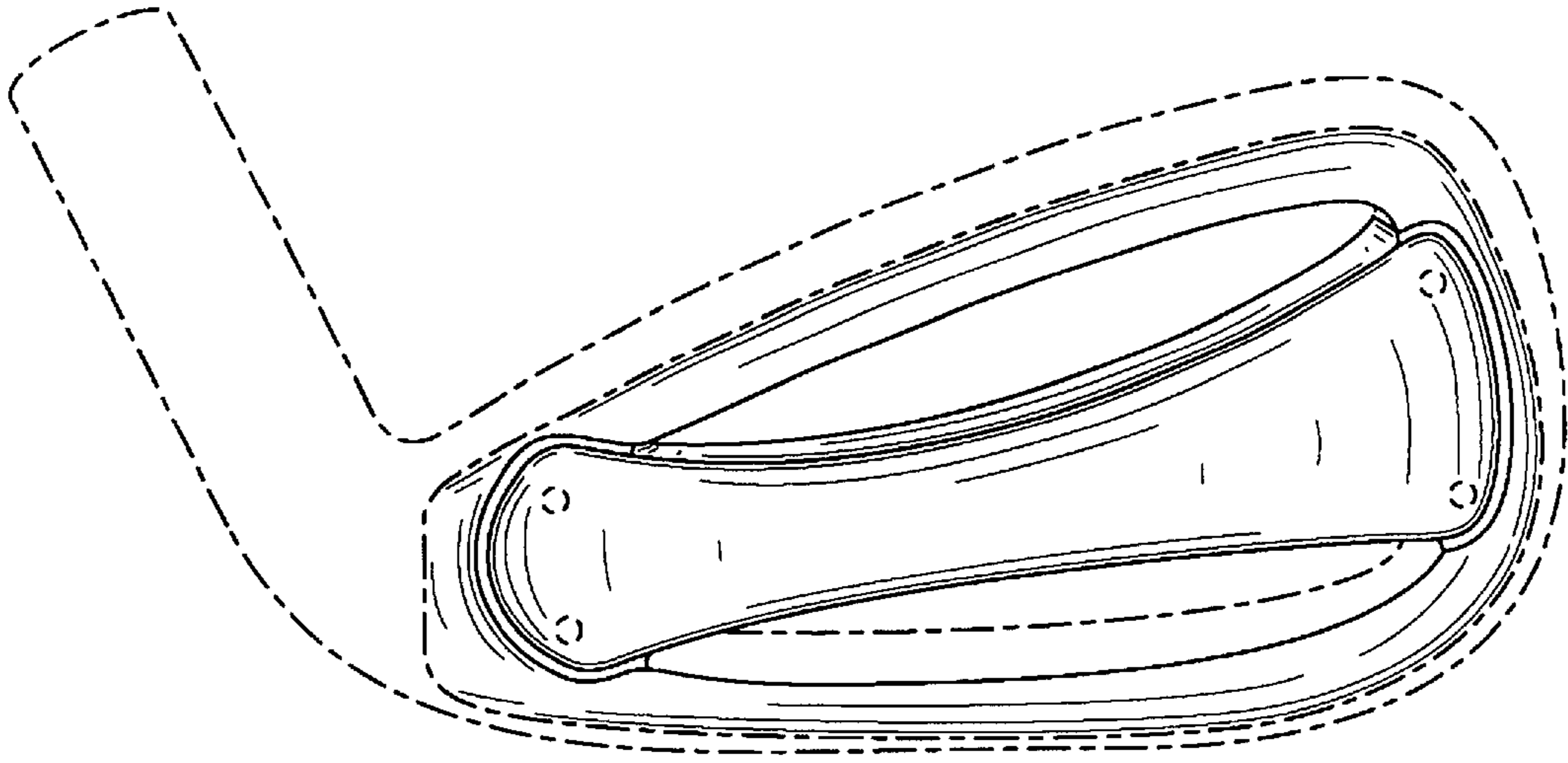

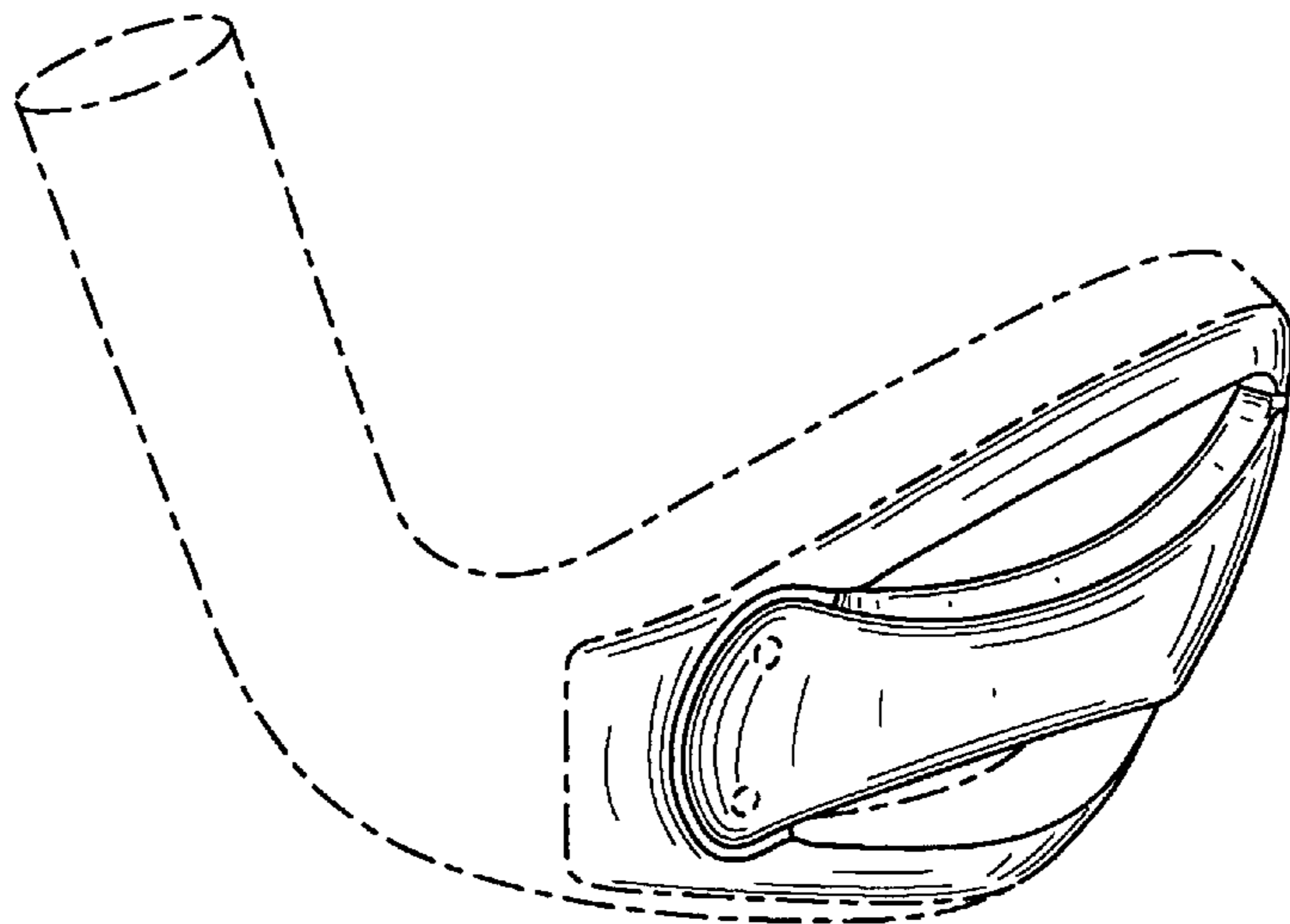

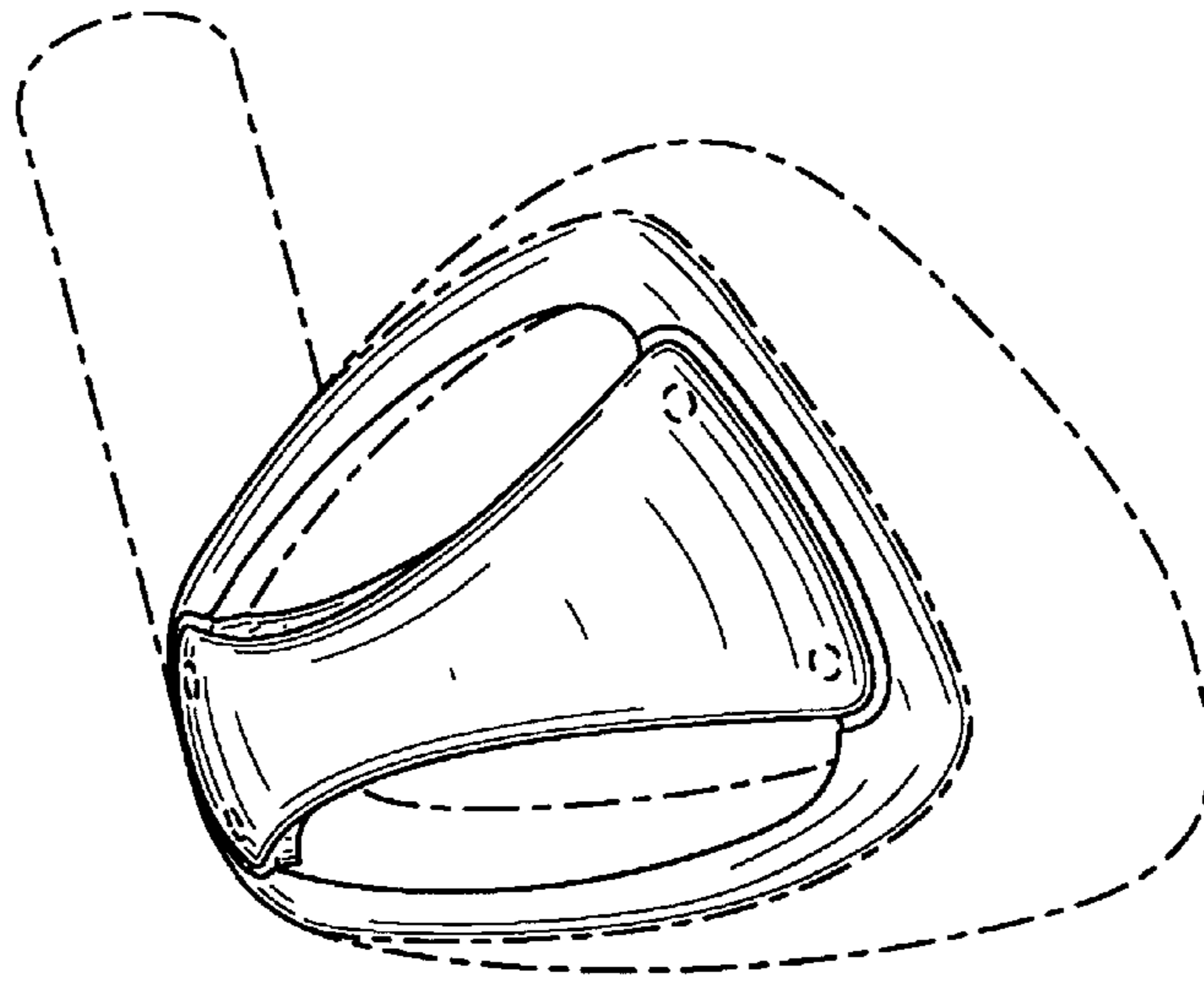

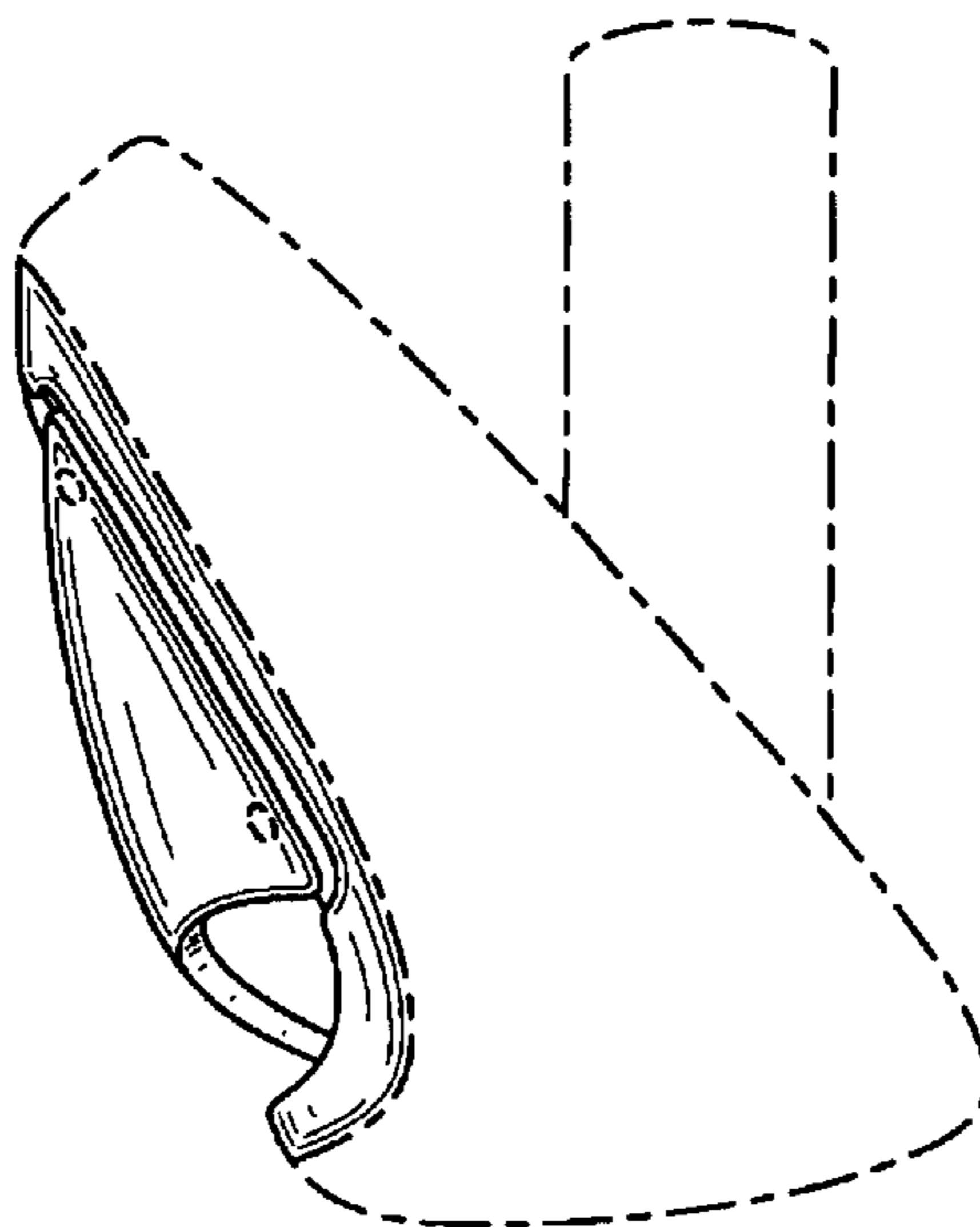

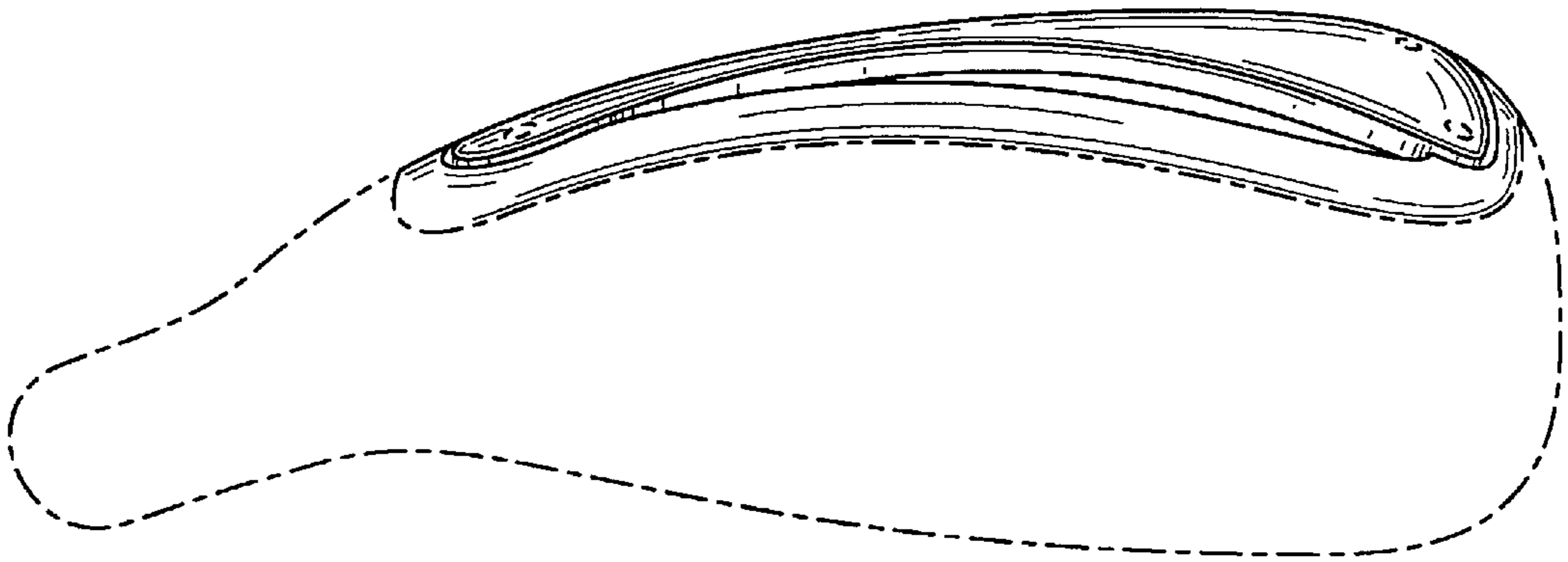
