(57) **CLAIM**

The ornamental design for a feather duster holder vacuum cleaner accessory, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a feather duster holder vacuum cleaner accessory showing my new design without the feather duster;

FIG. 2 is a left side elevation view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a top plan view of a feather duster;

FIG. 9 is a rear elevation view thereof;

FIG. 10 is a front elevation view thereof;

FIG. 11 is a left side elevation view thereof, the right side being a mirror image thereof;

FIG. 12 is a perspective view of a feather duster holder vacuum cleaner accessory in assembled condition;

FIG. 13 is a left side elevation view thereof;

FIG. 14 is a top plan view thereof;

FIG. 15 is a rear elevation view thereof;

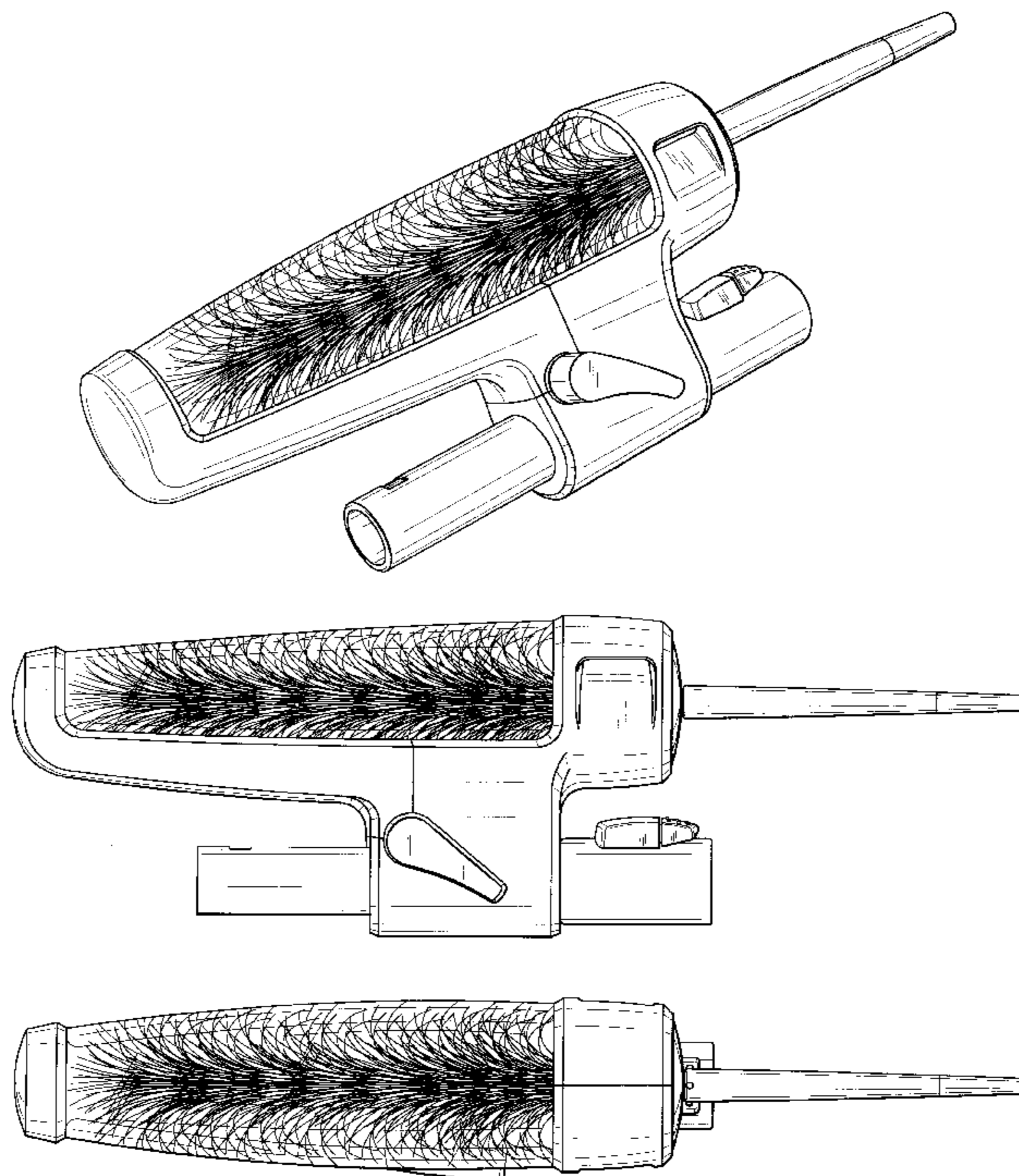
FIG. 16 is a right elevation view thereof;

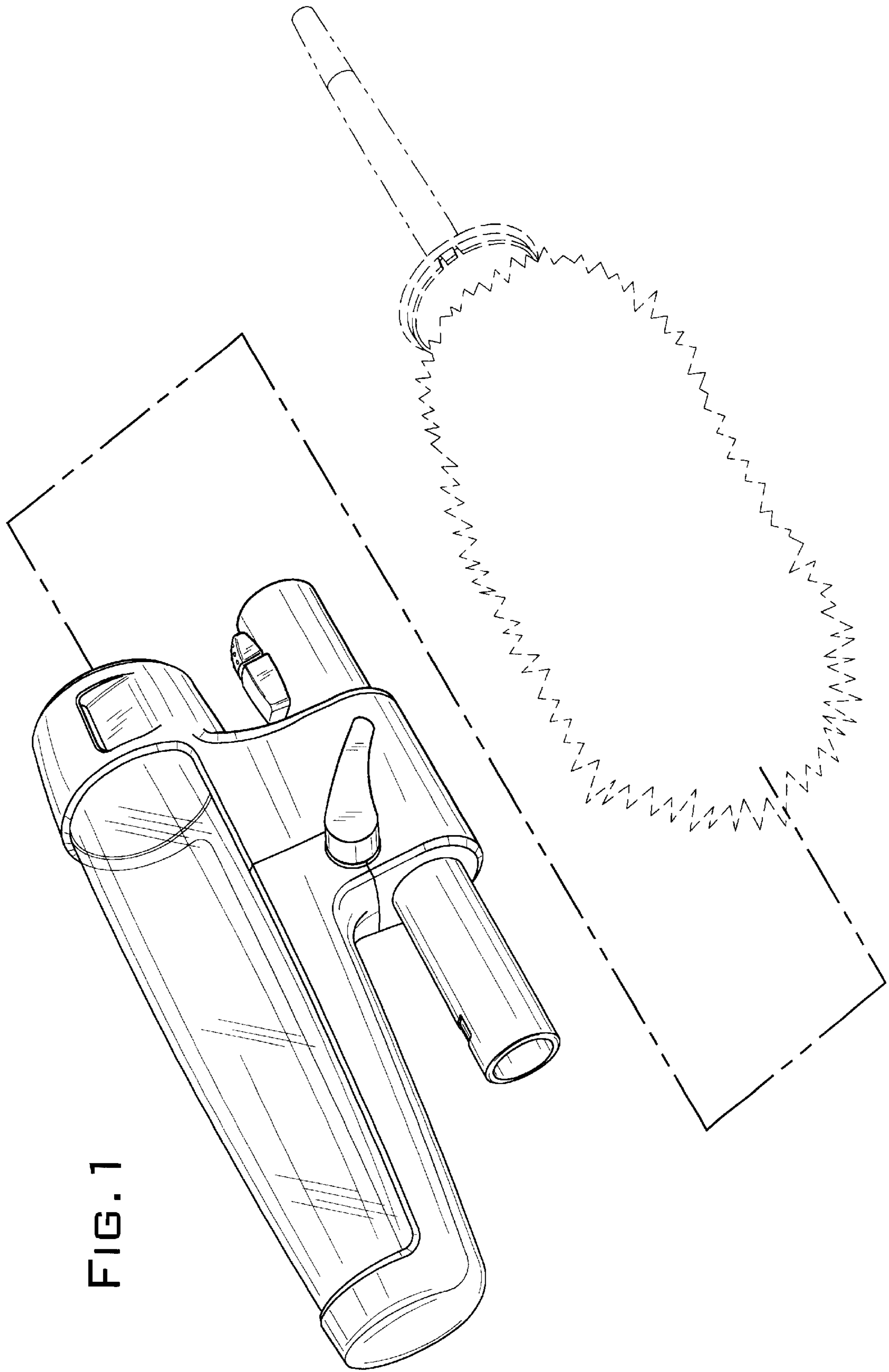

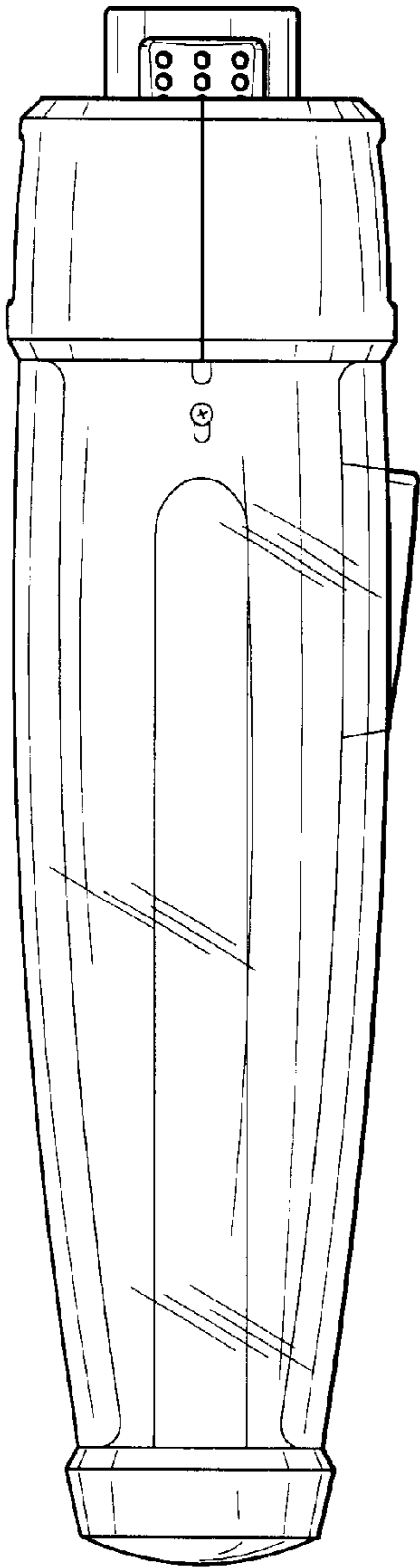

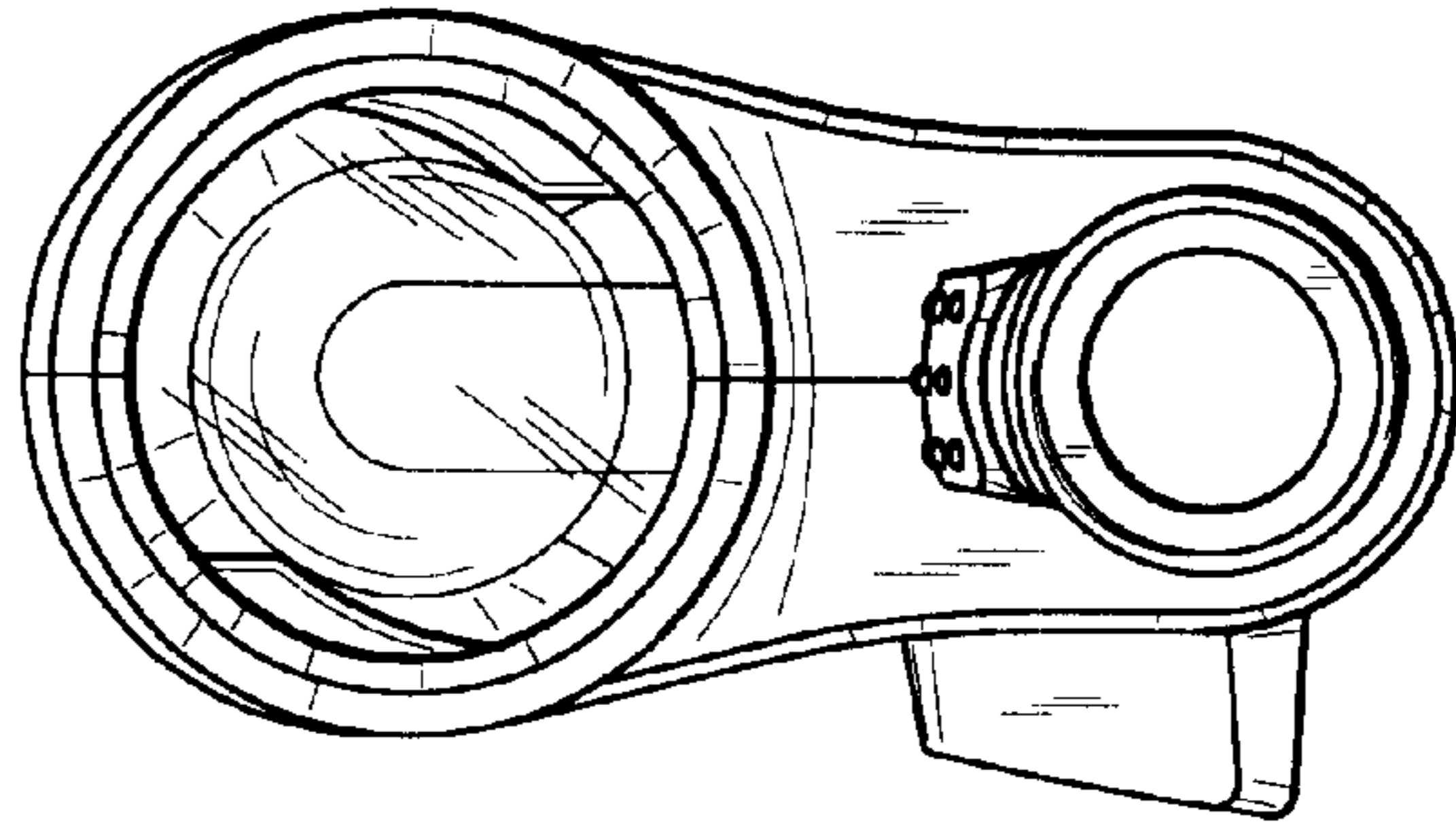

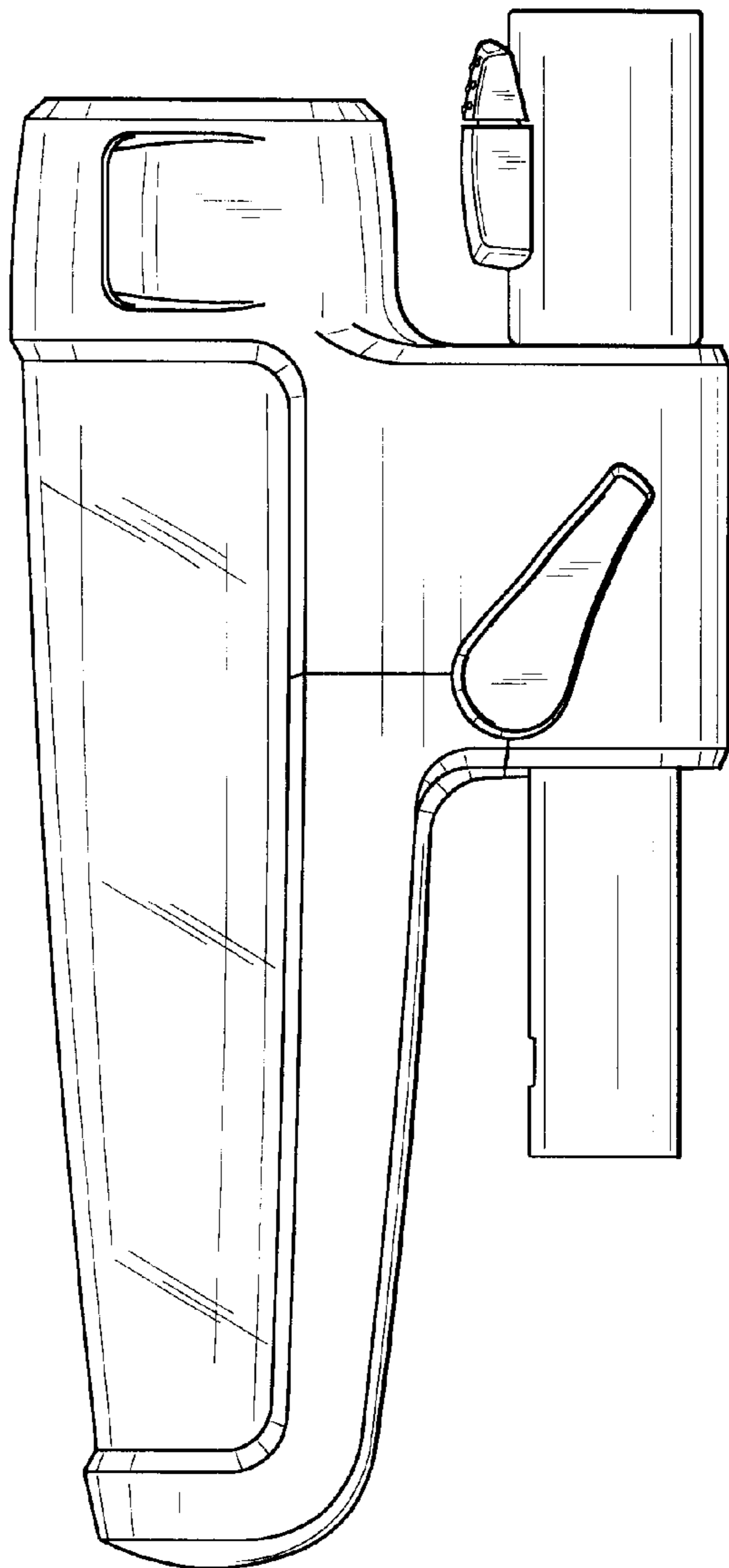

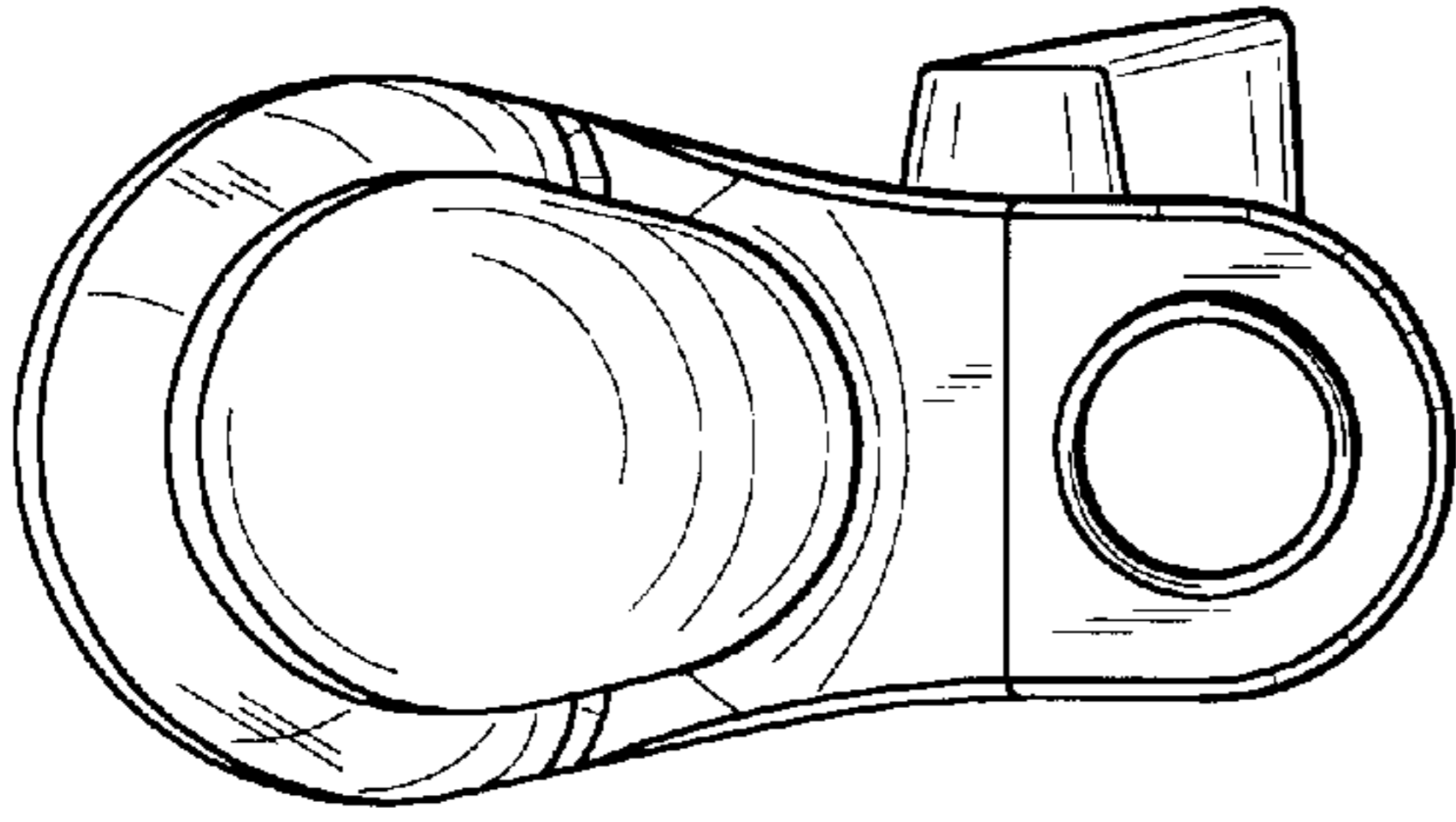

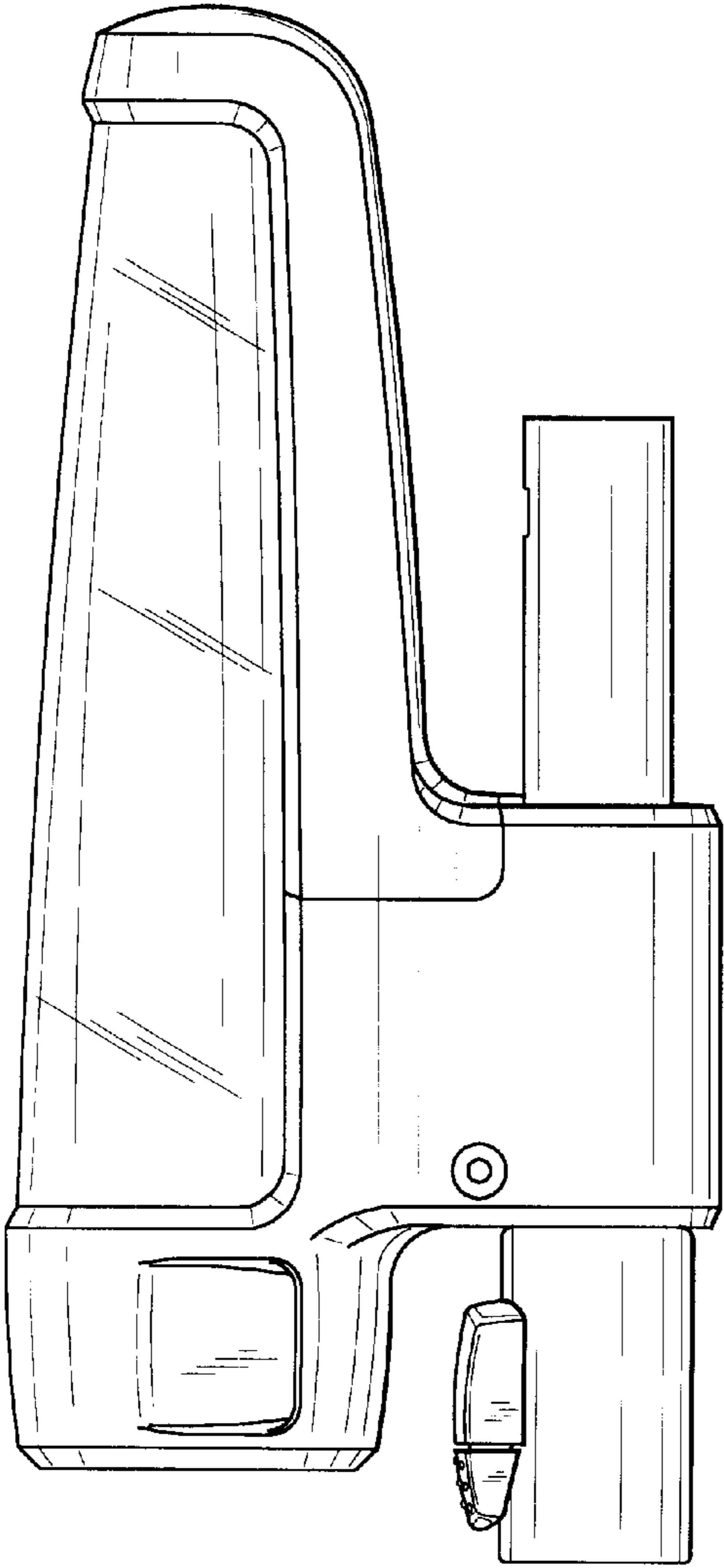

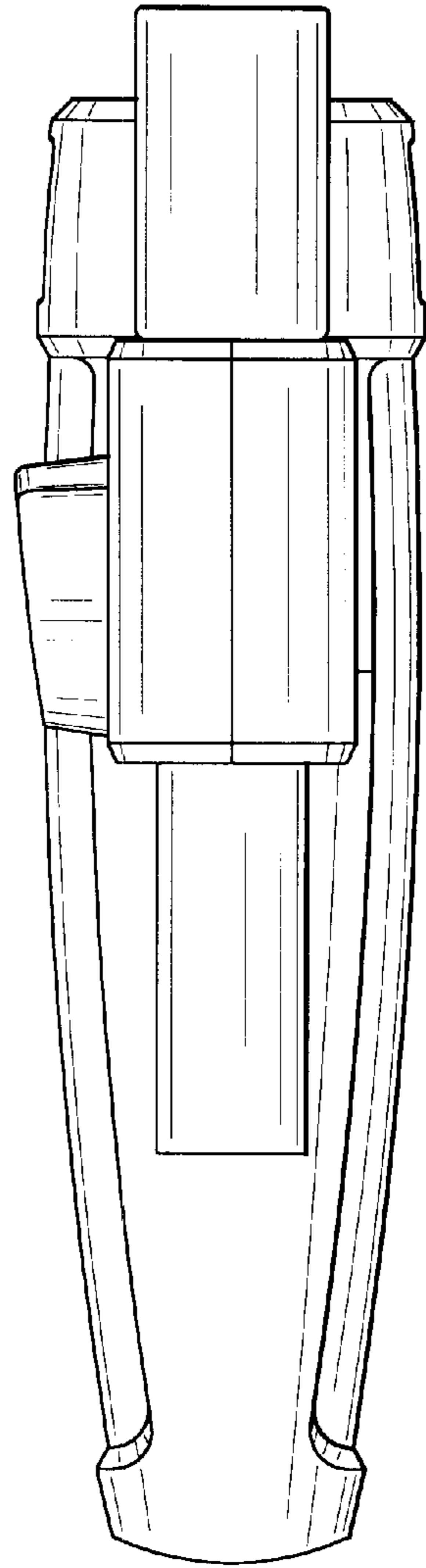

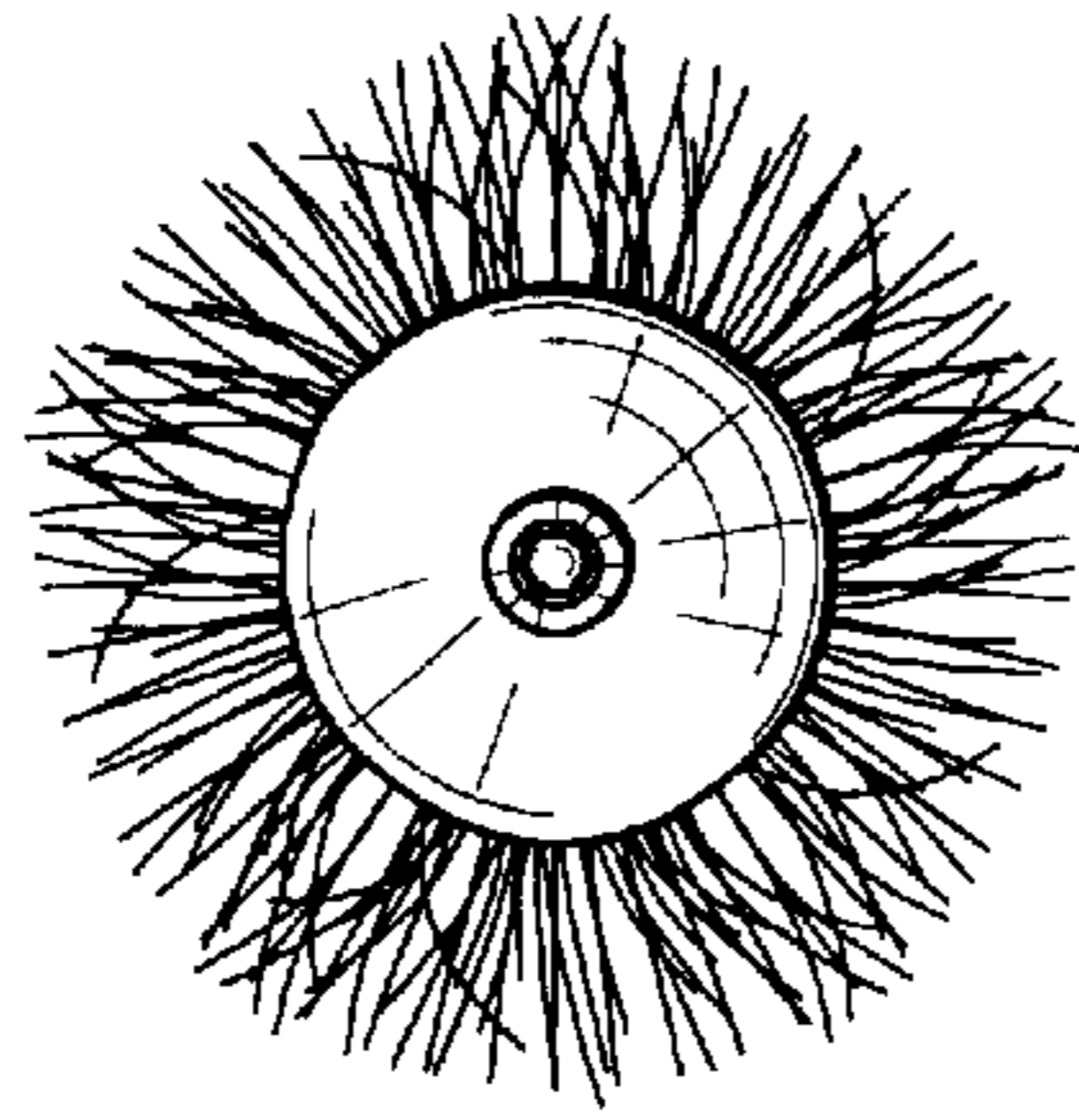

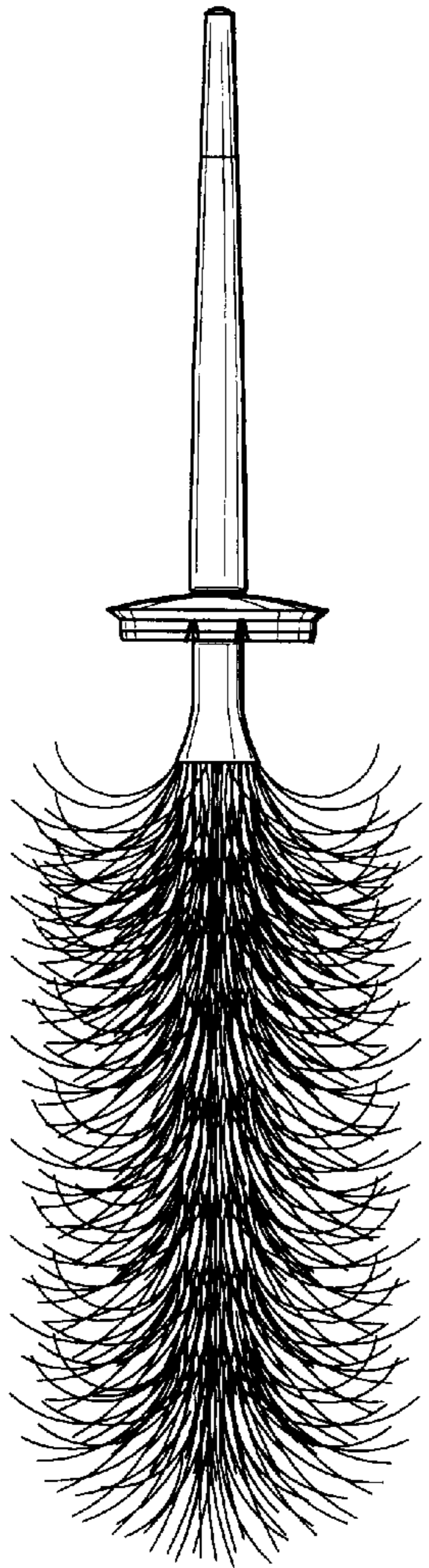

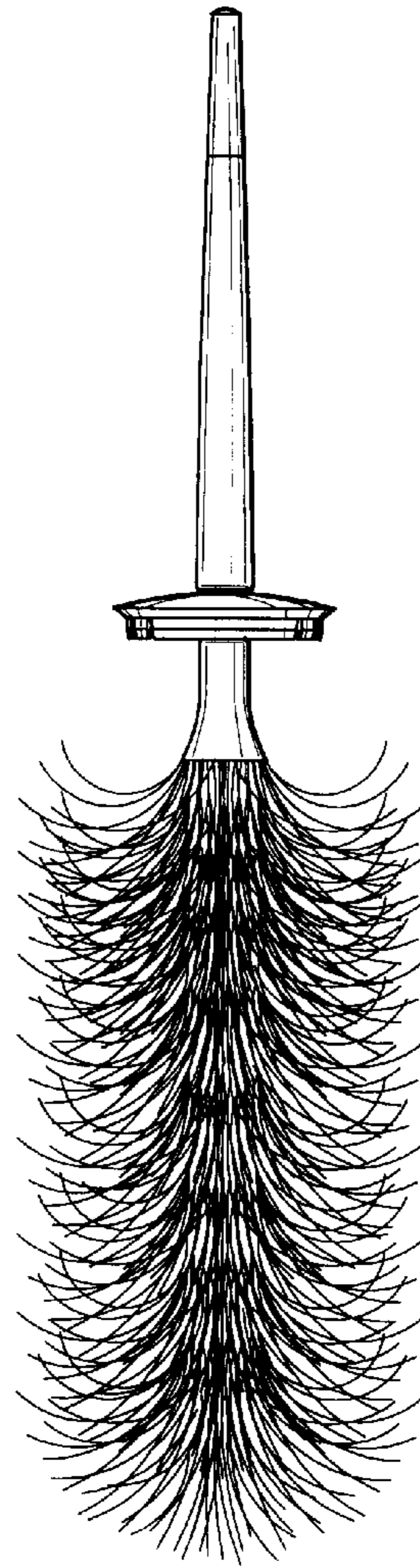

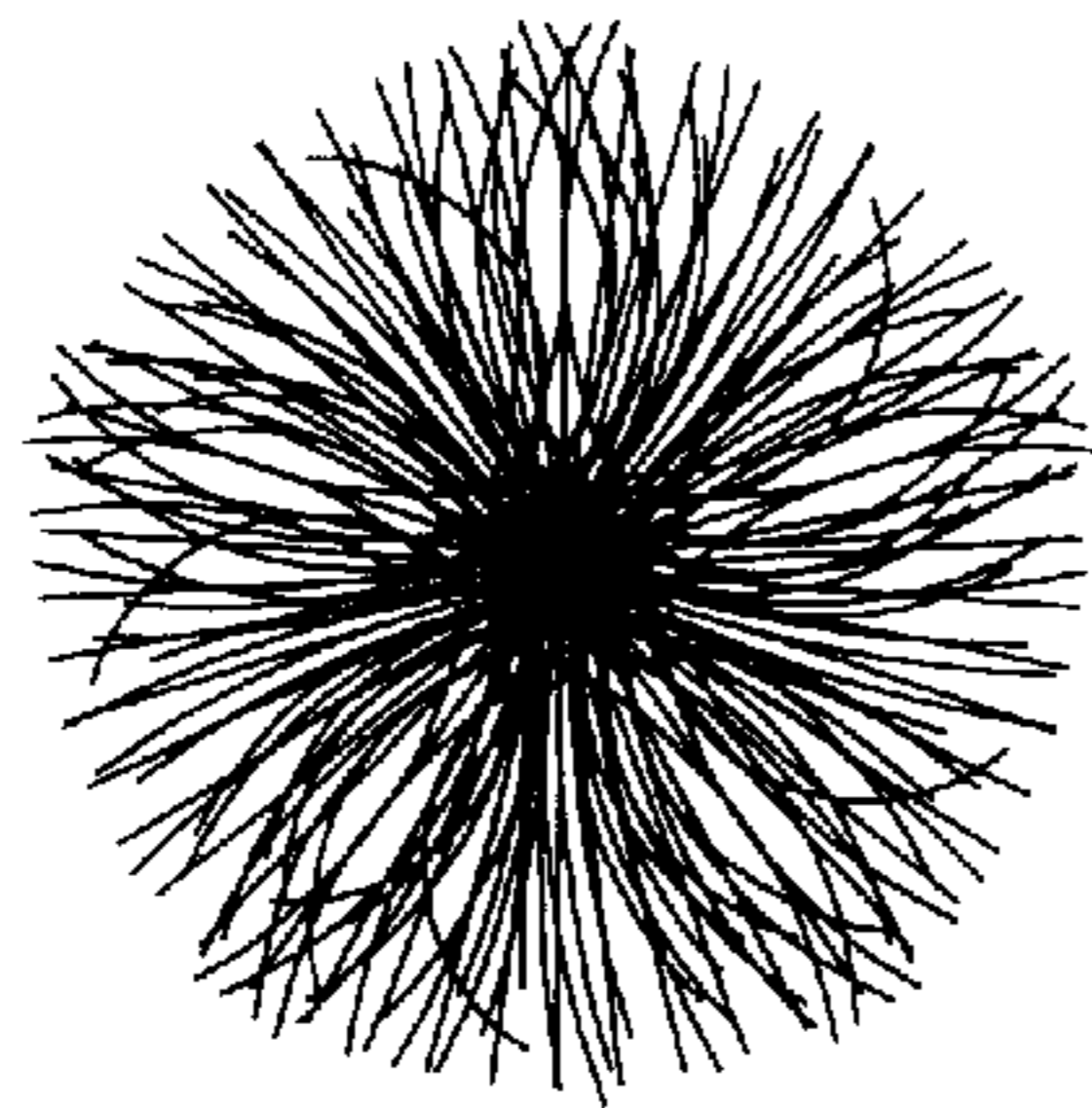

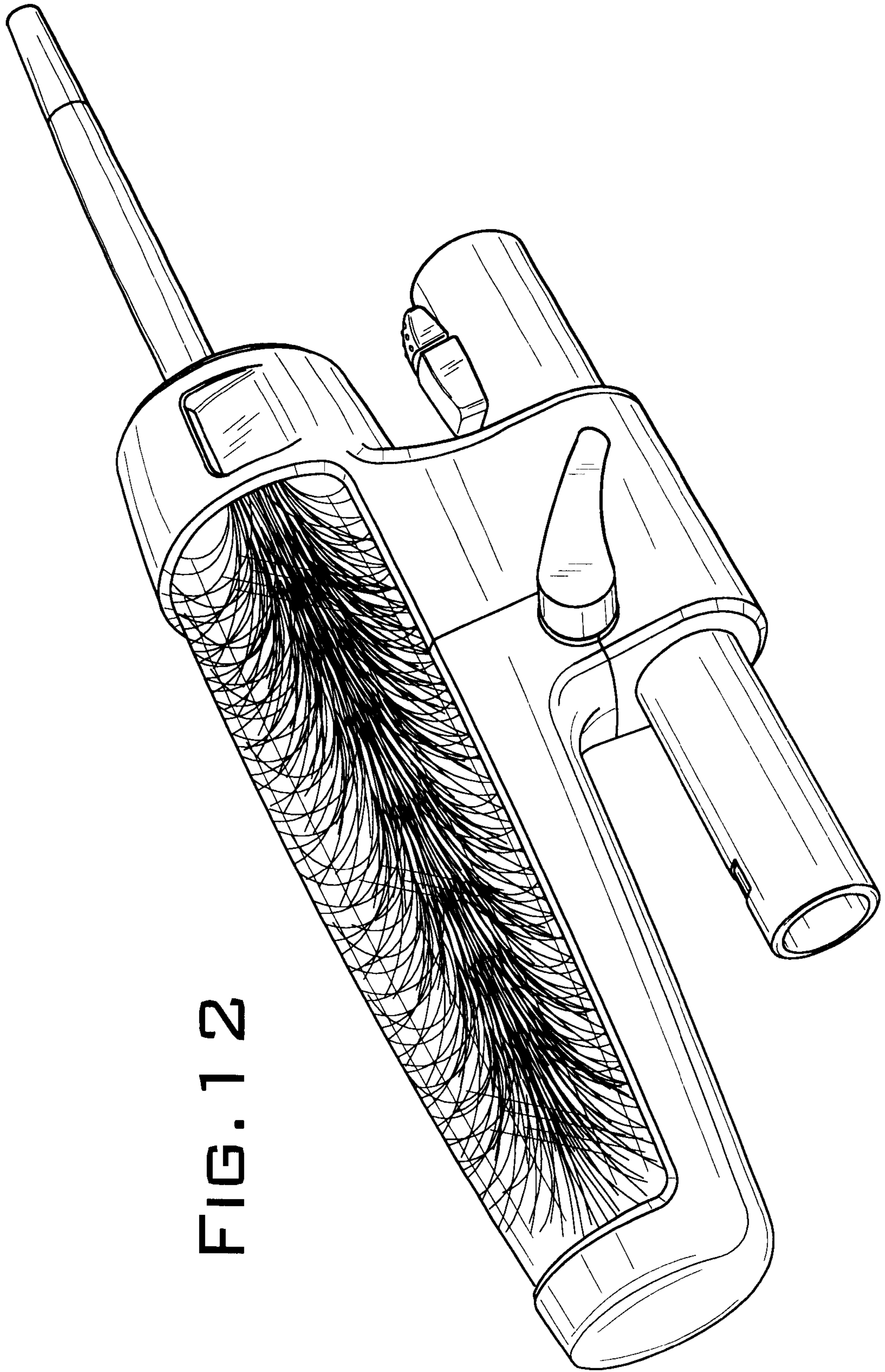

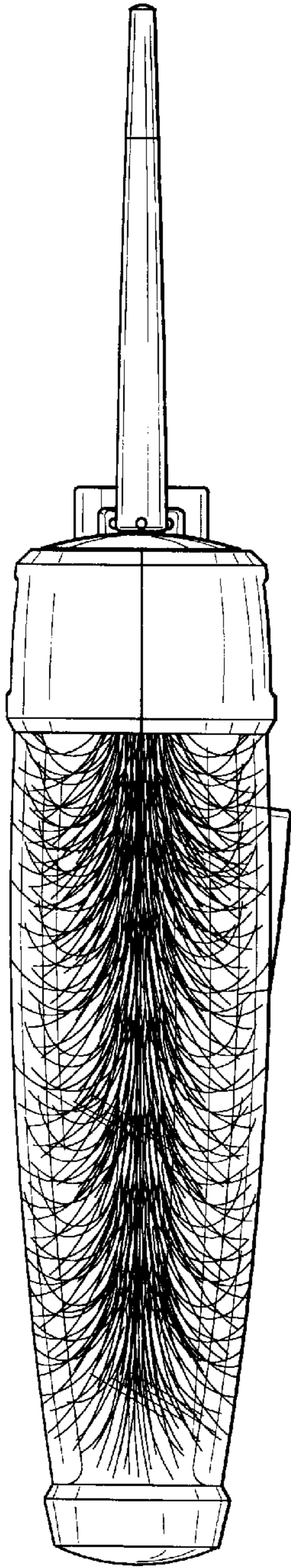

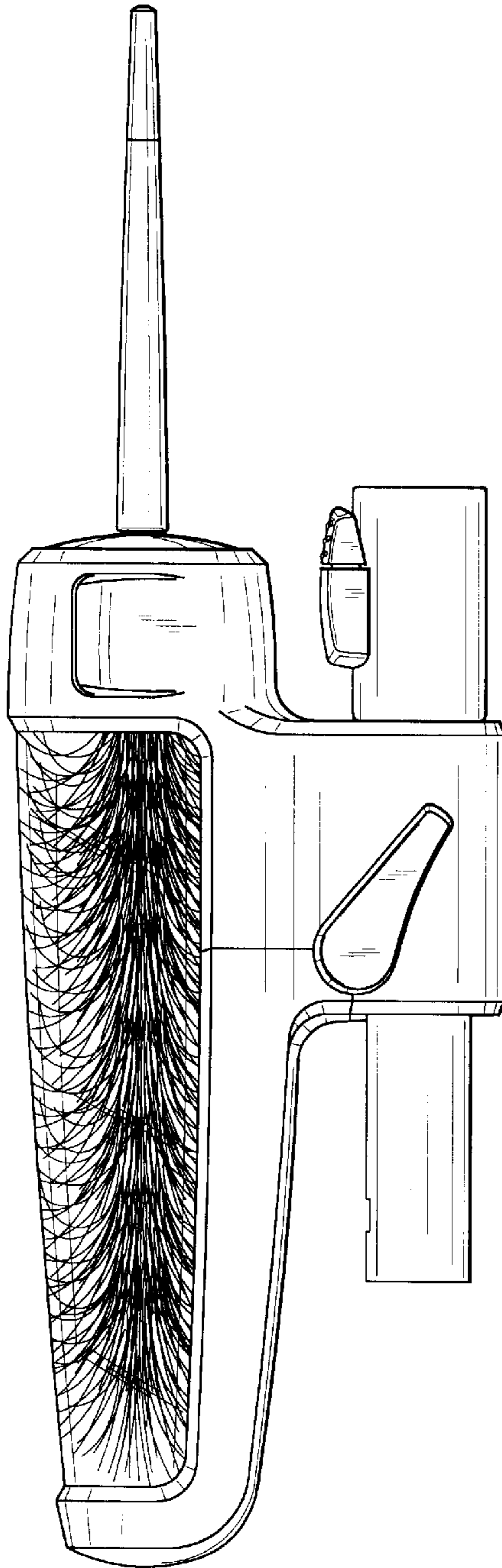

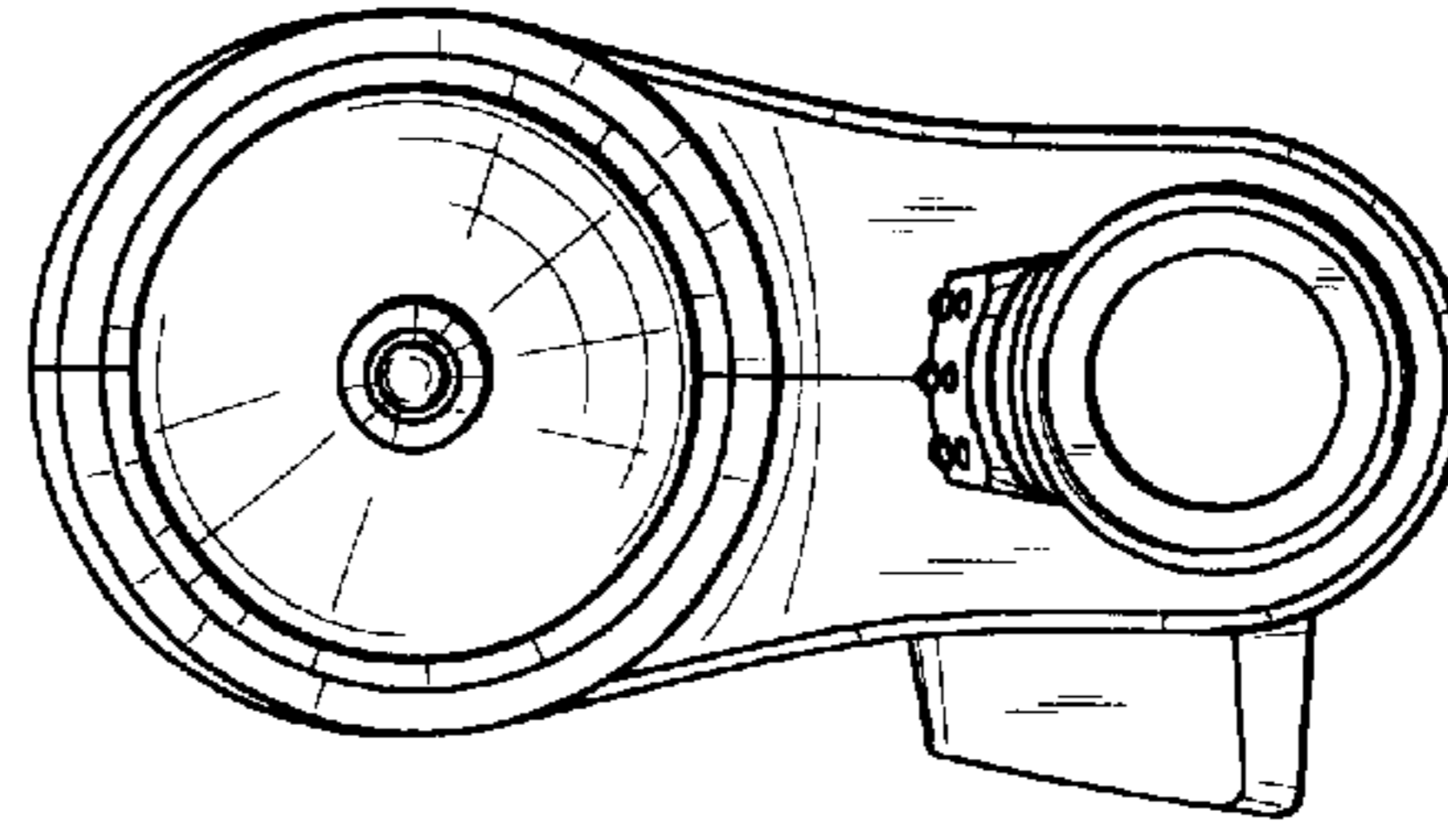

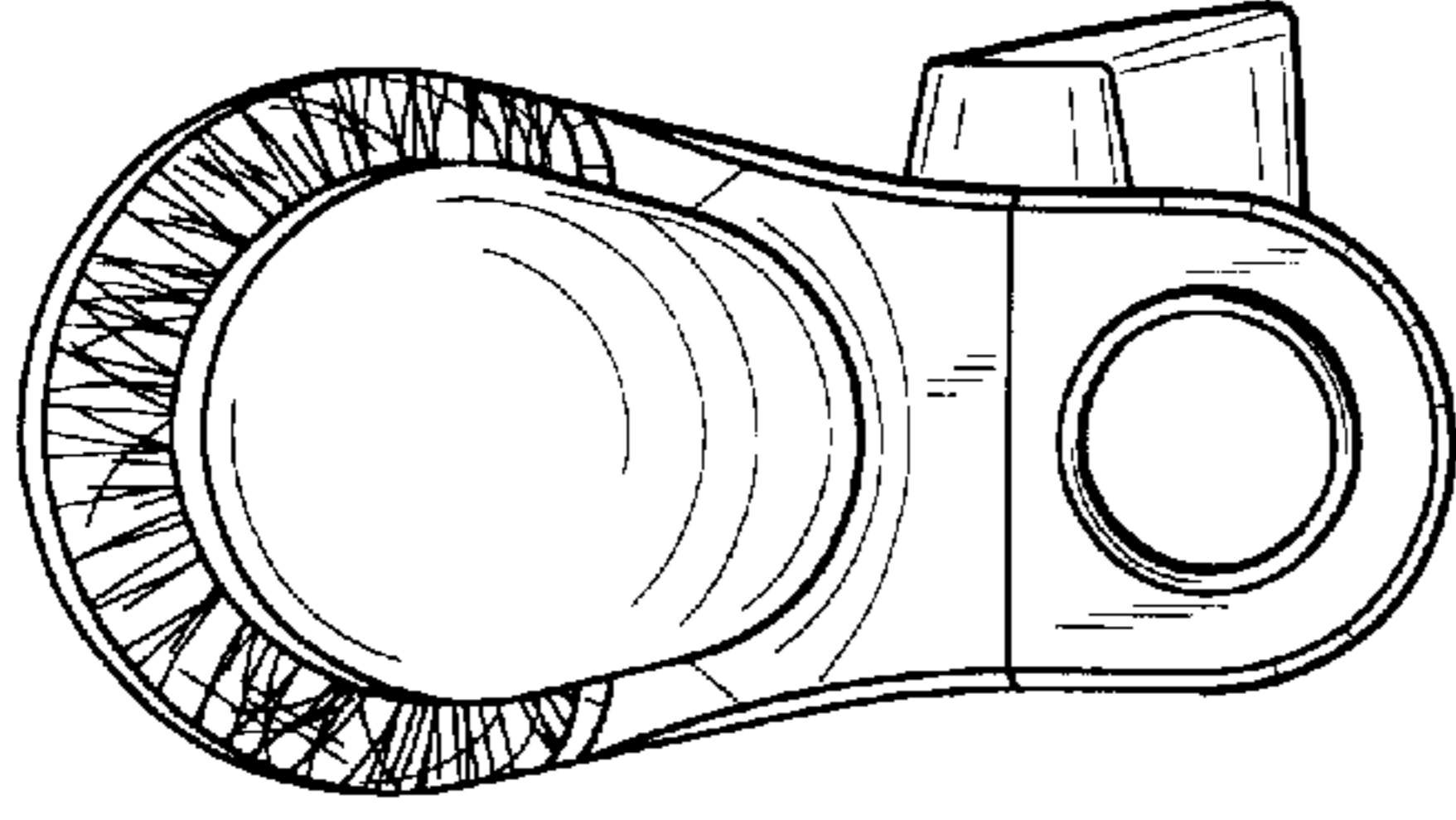

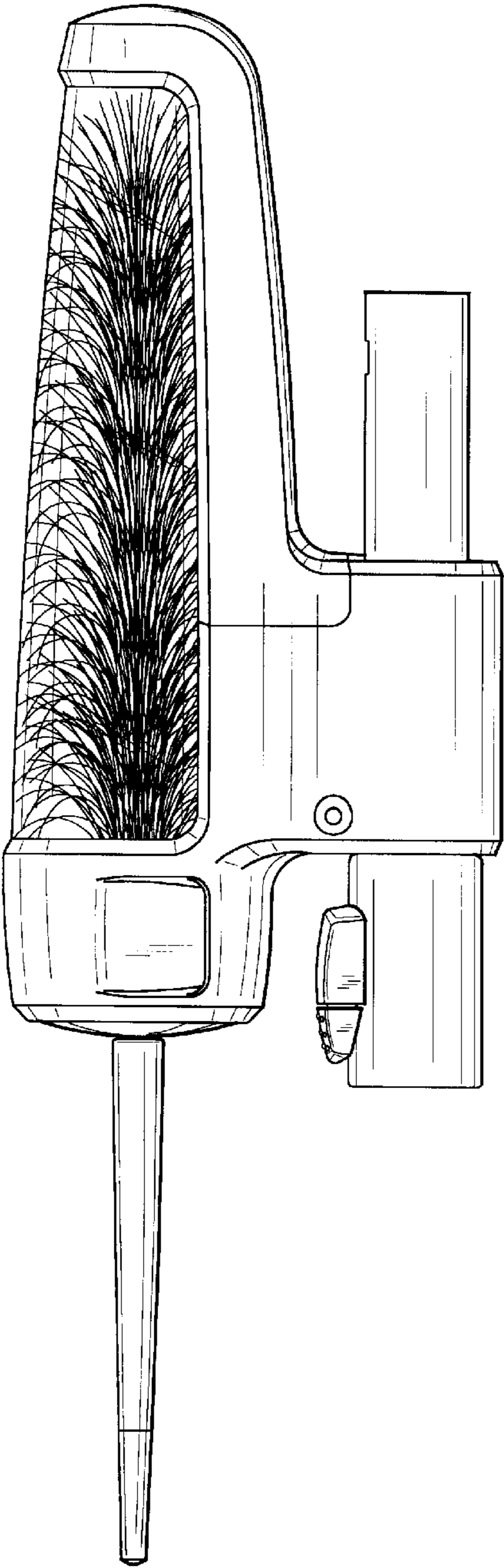

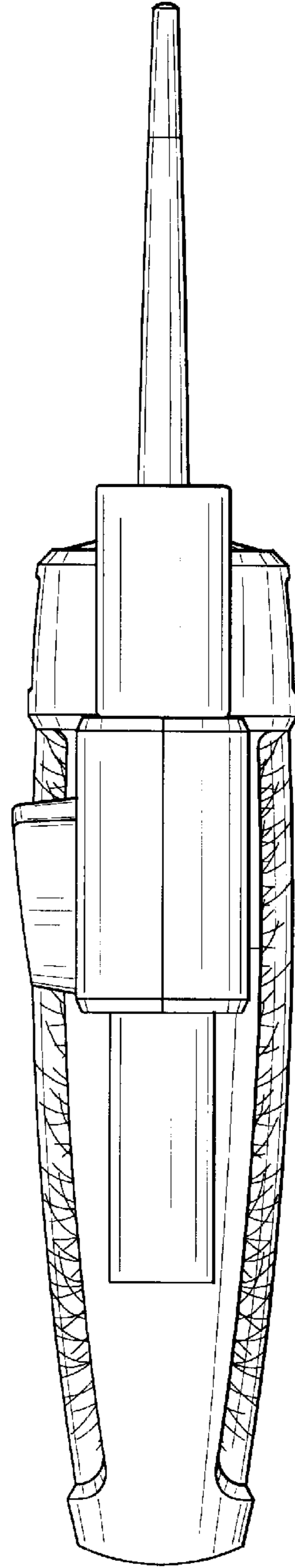
