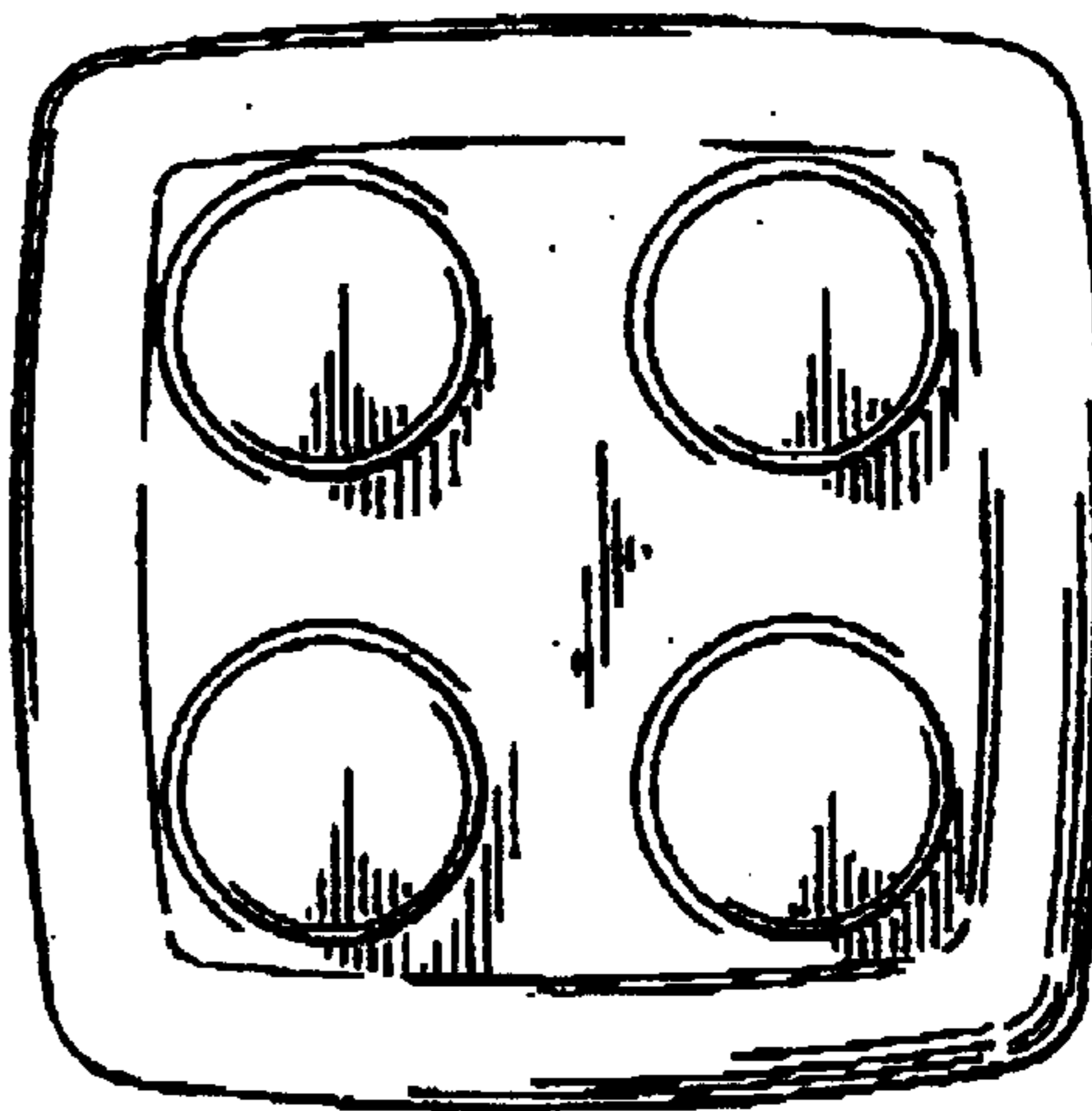
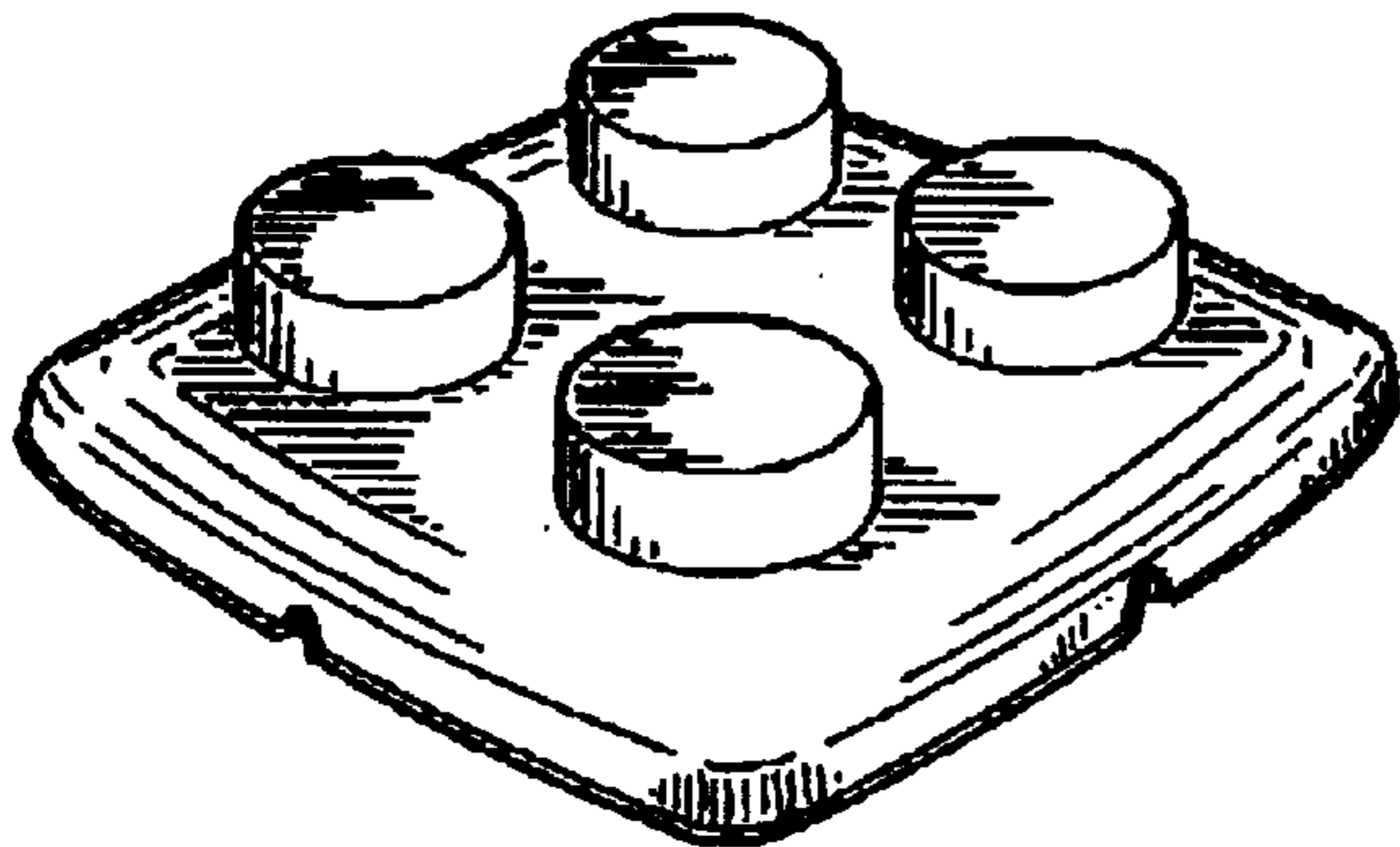
(57) **CLAIM**

The ornamental design for a bucket lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the bucket lid of the present design from the top thereof;  
FIG. 2 is a perspective view thereof from the bottom thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;

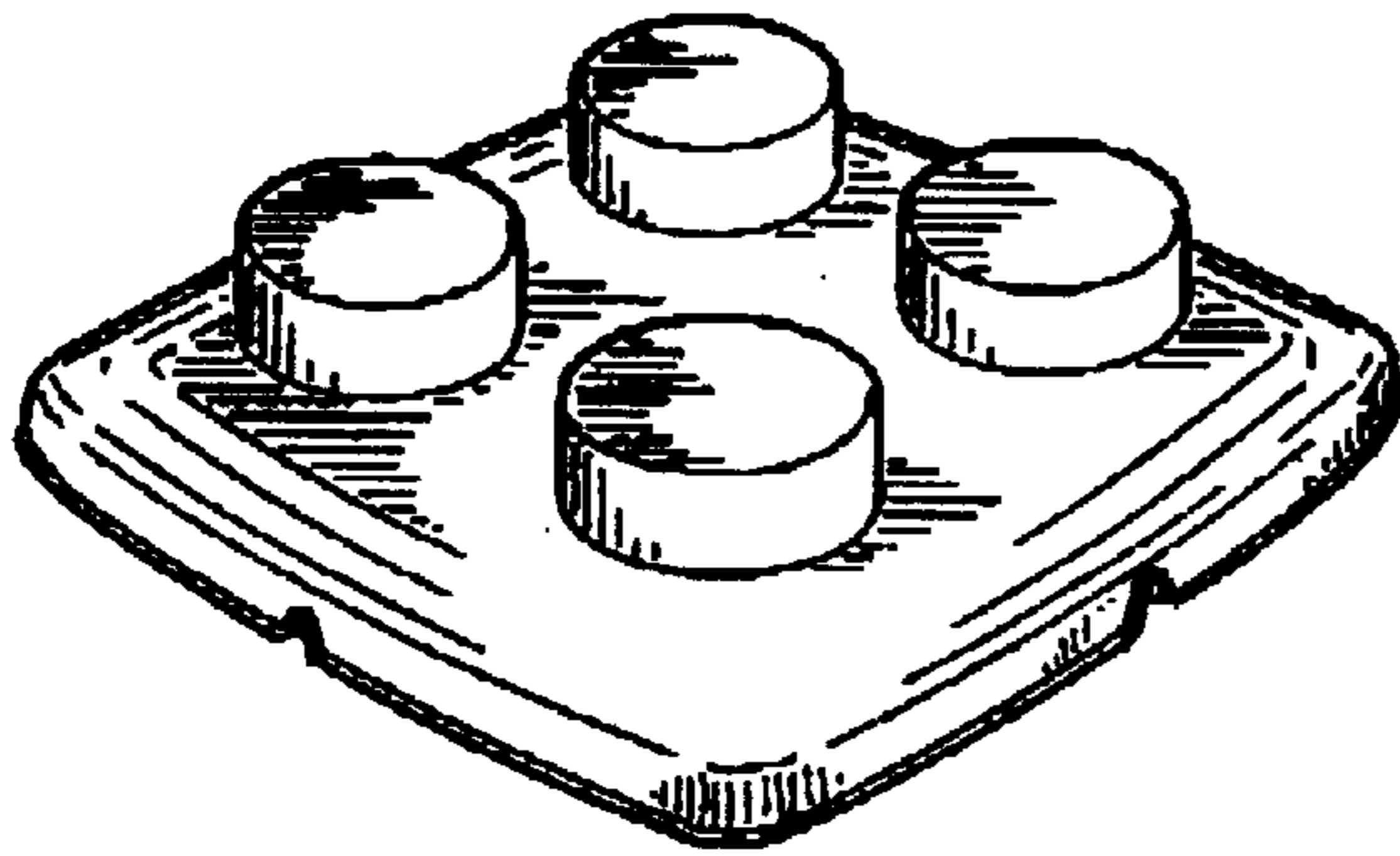

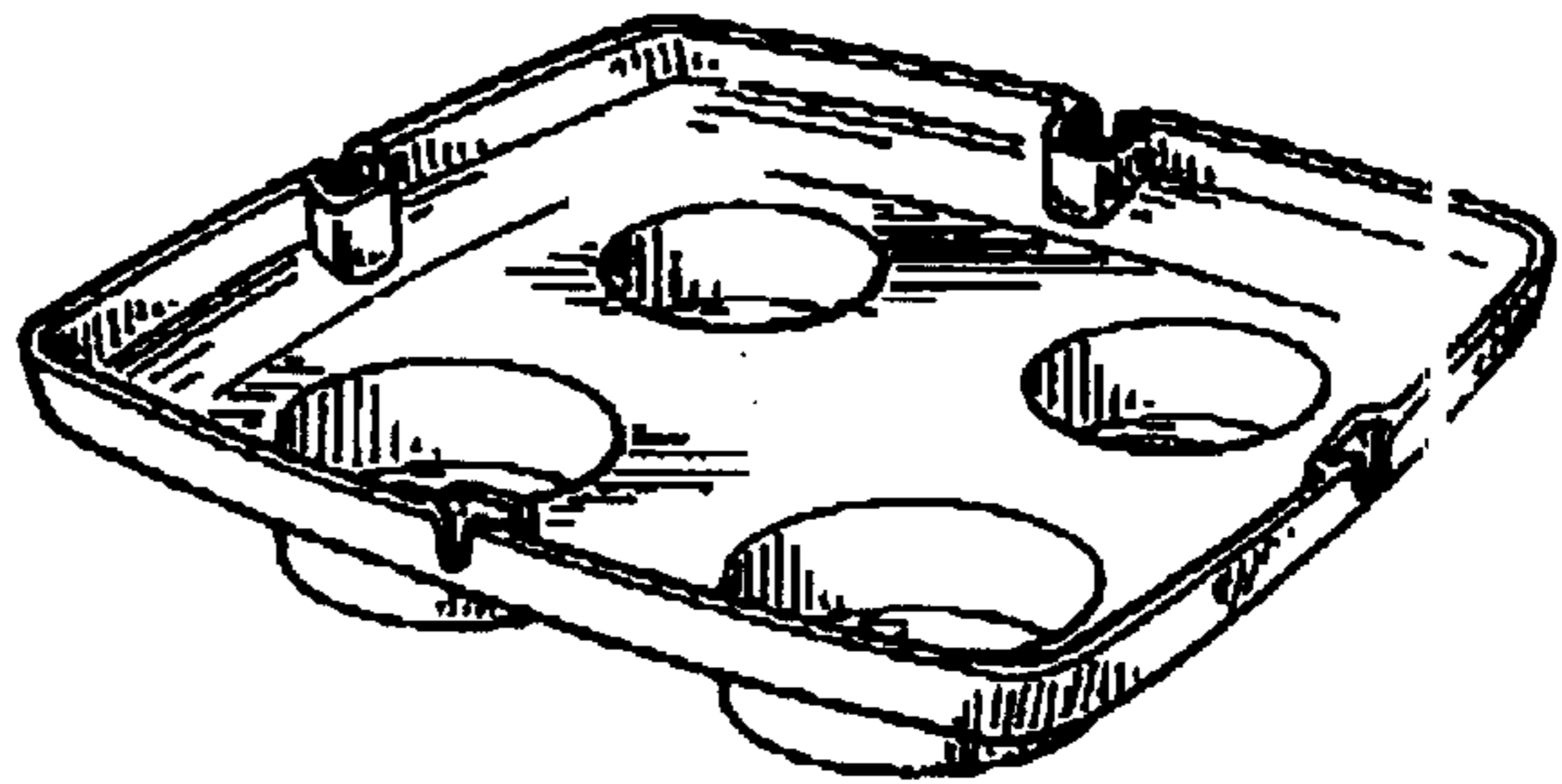

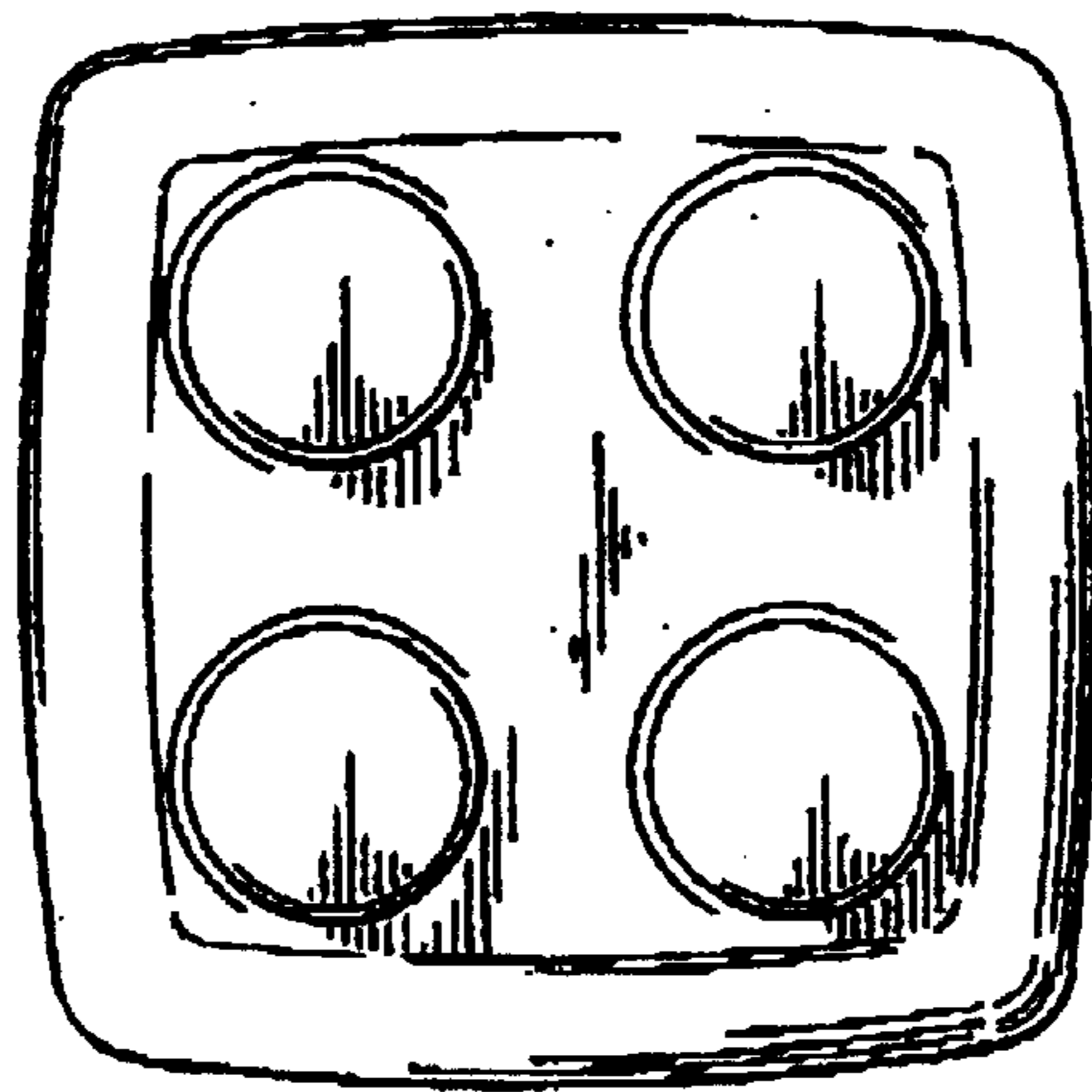

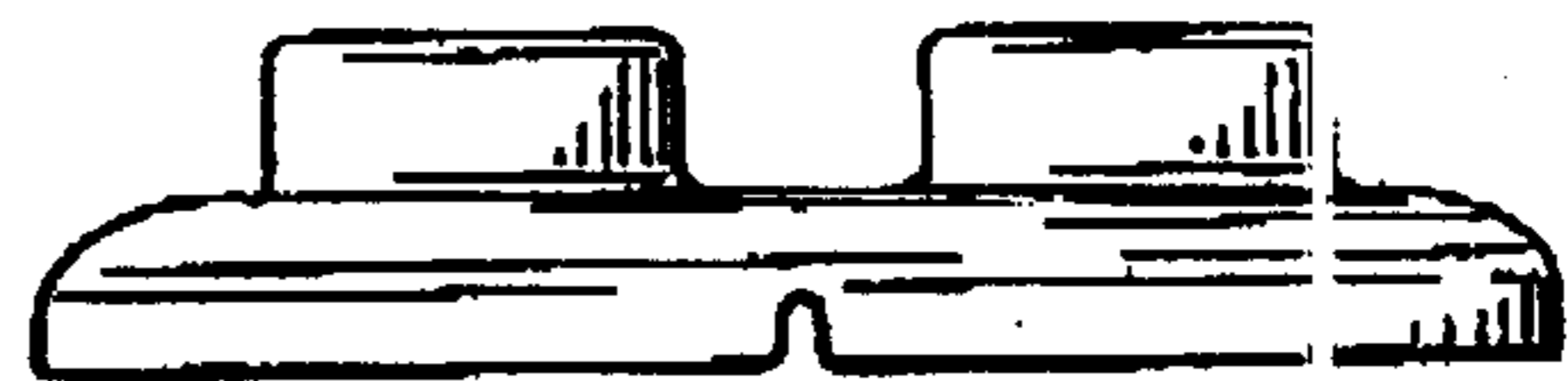

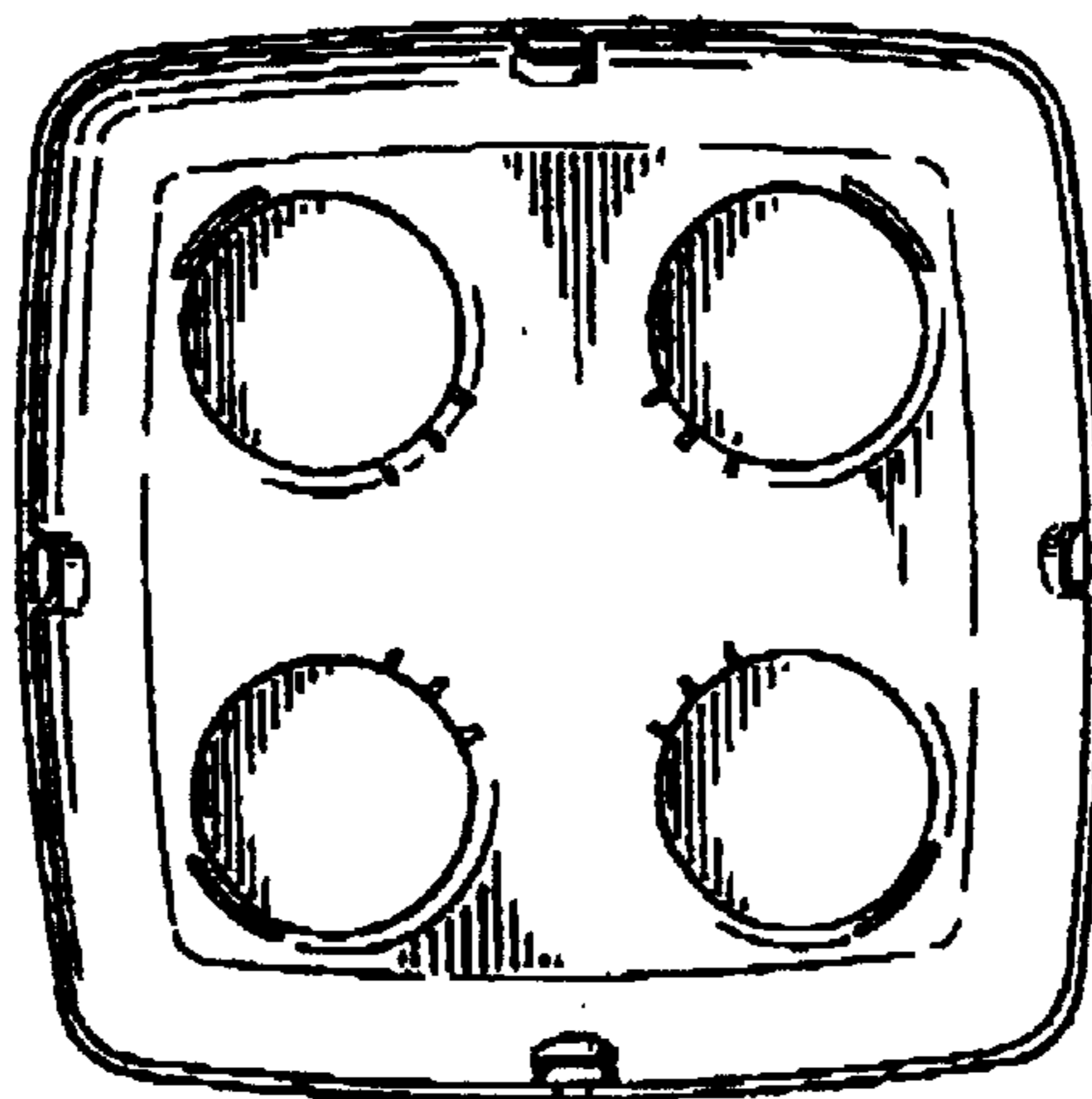
