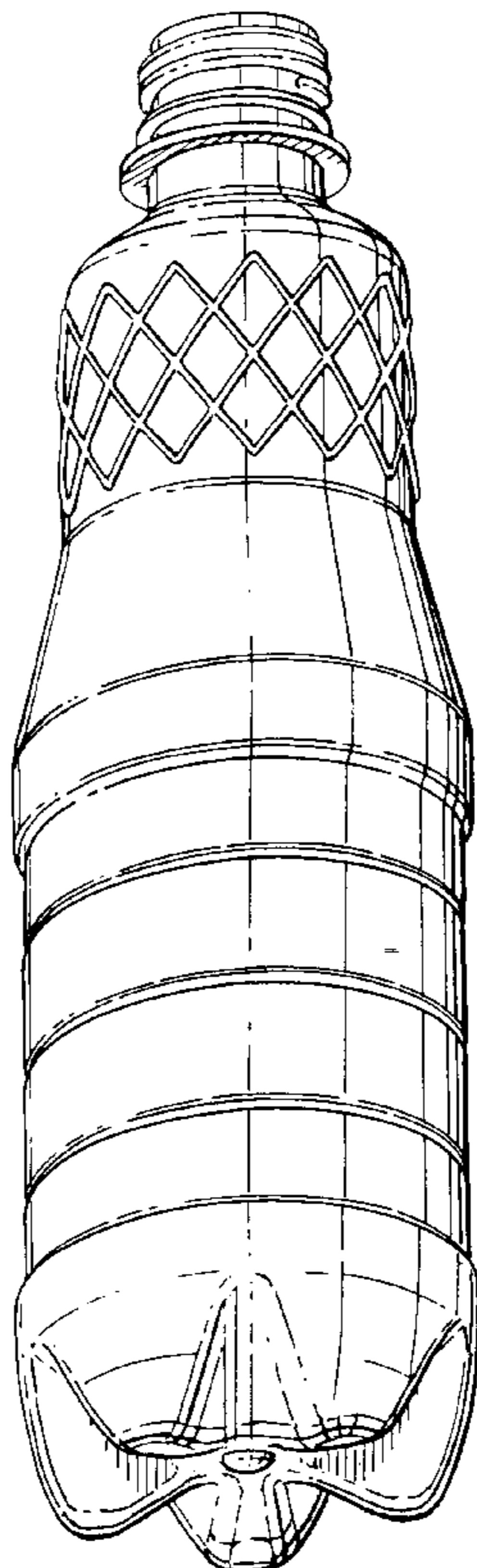
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the beverage bottle;
 FIG. 2 is a rear elevational view of the beverage bottle of FIG. 1;

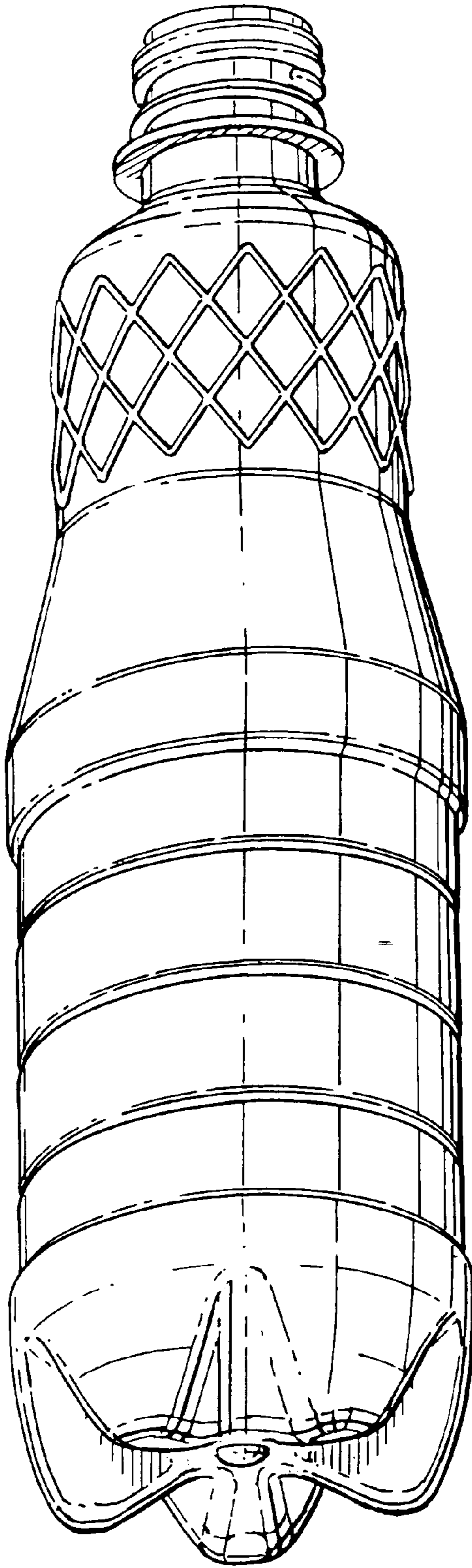

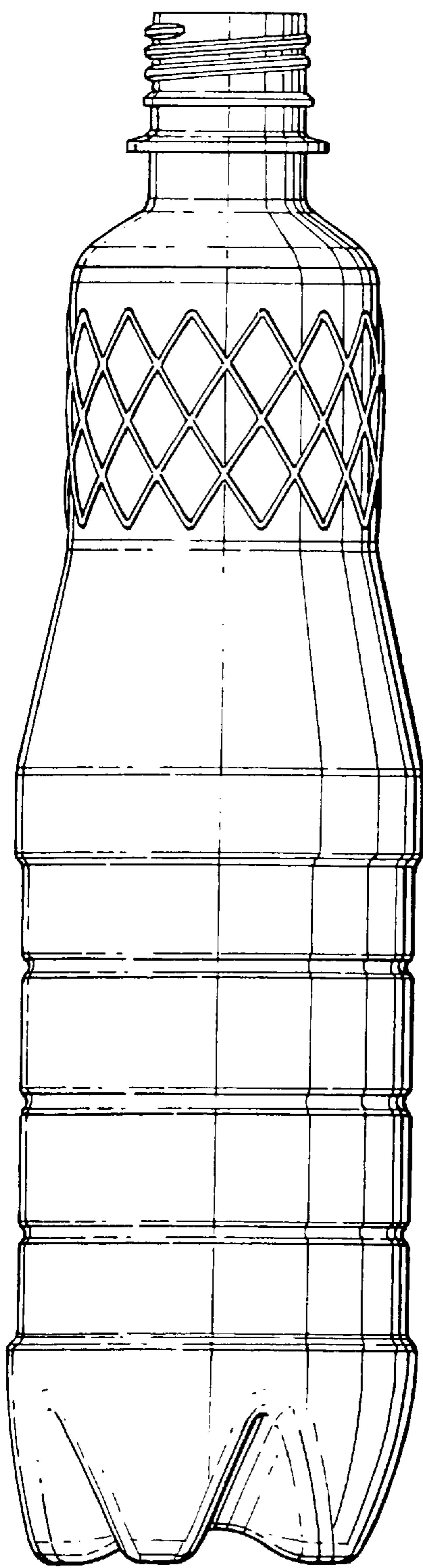

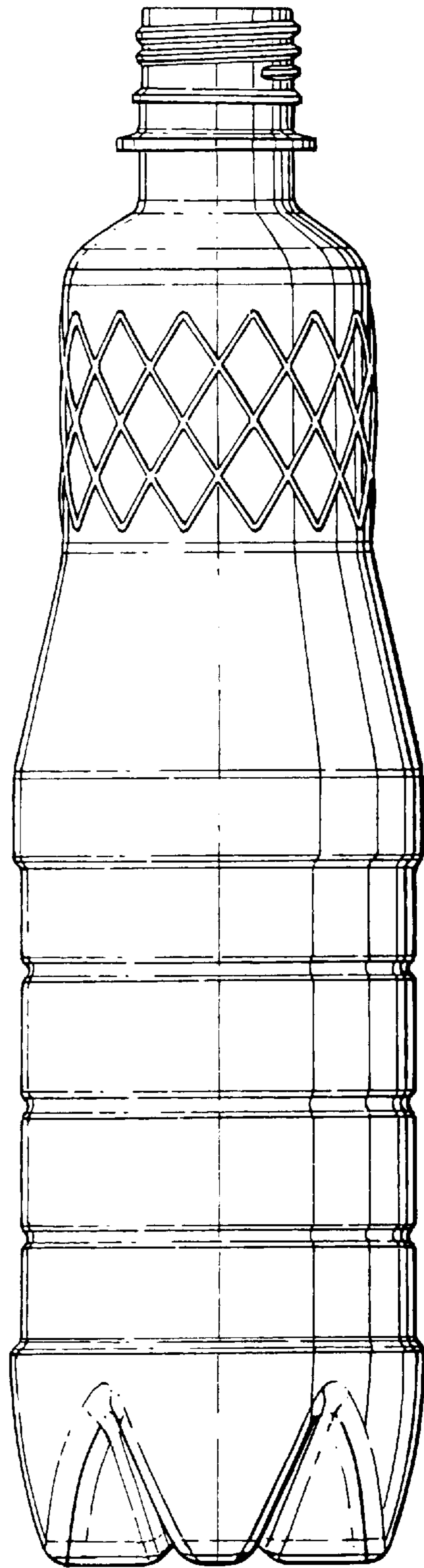

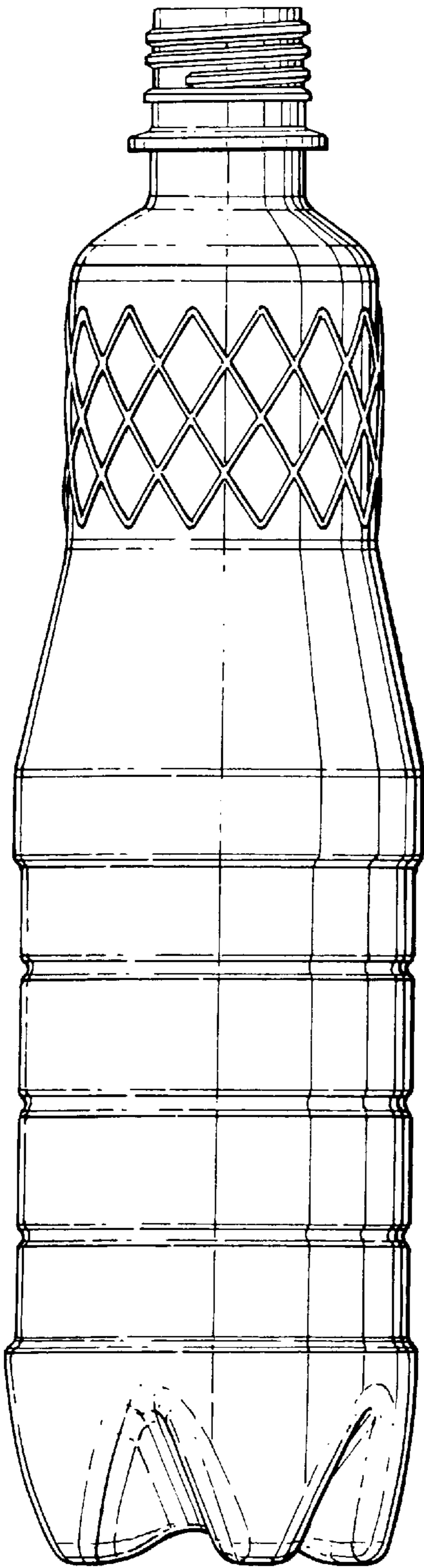

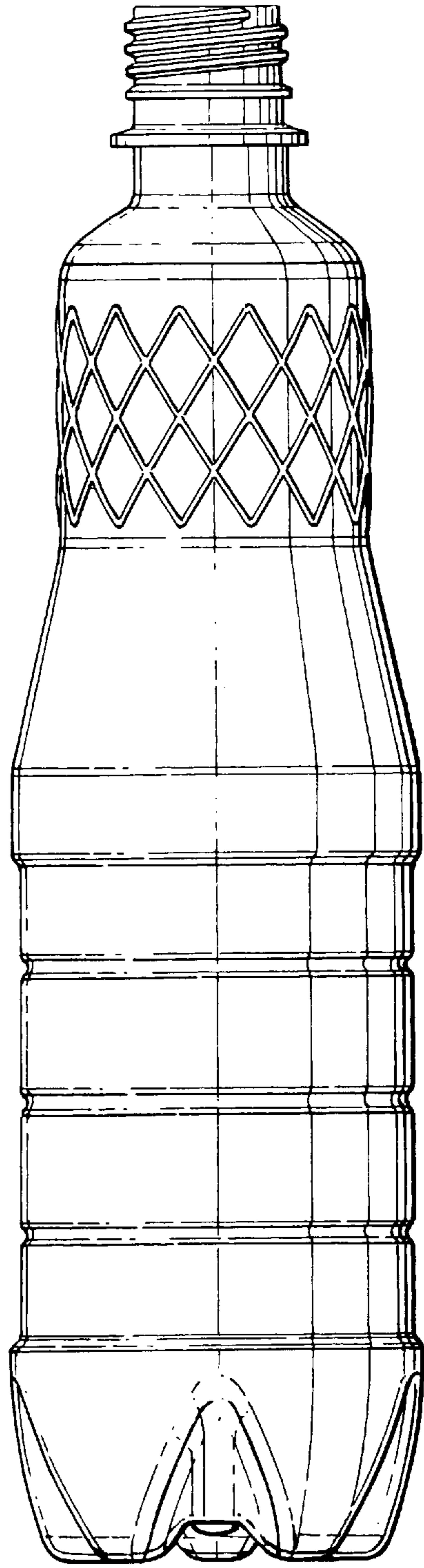

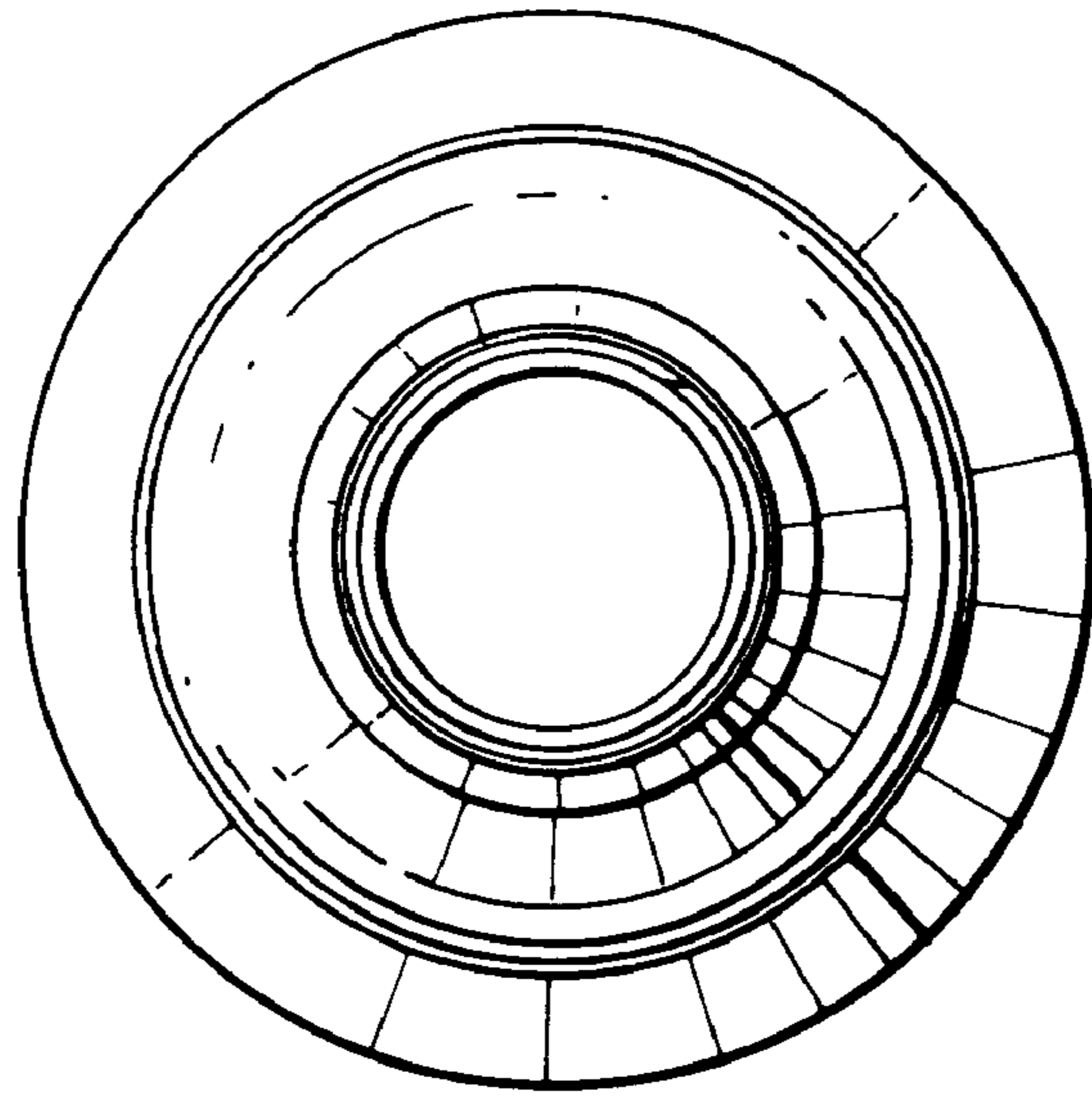

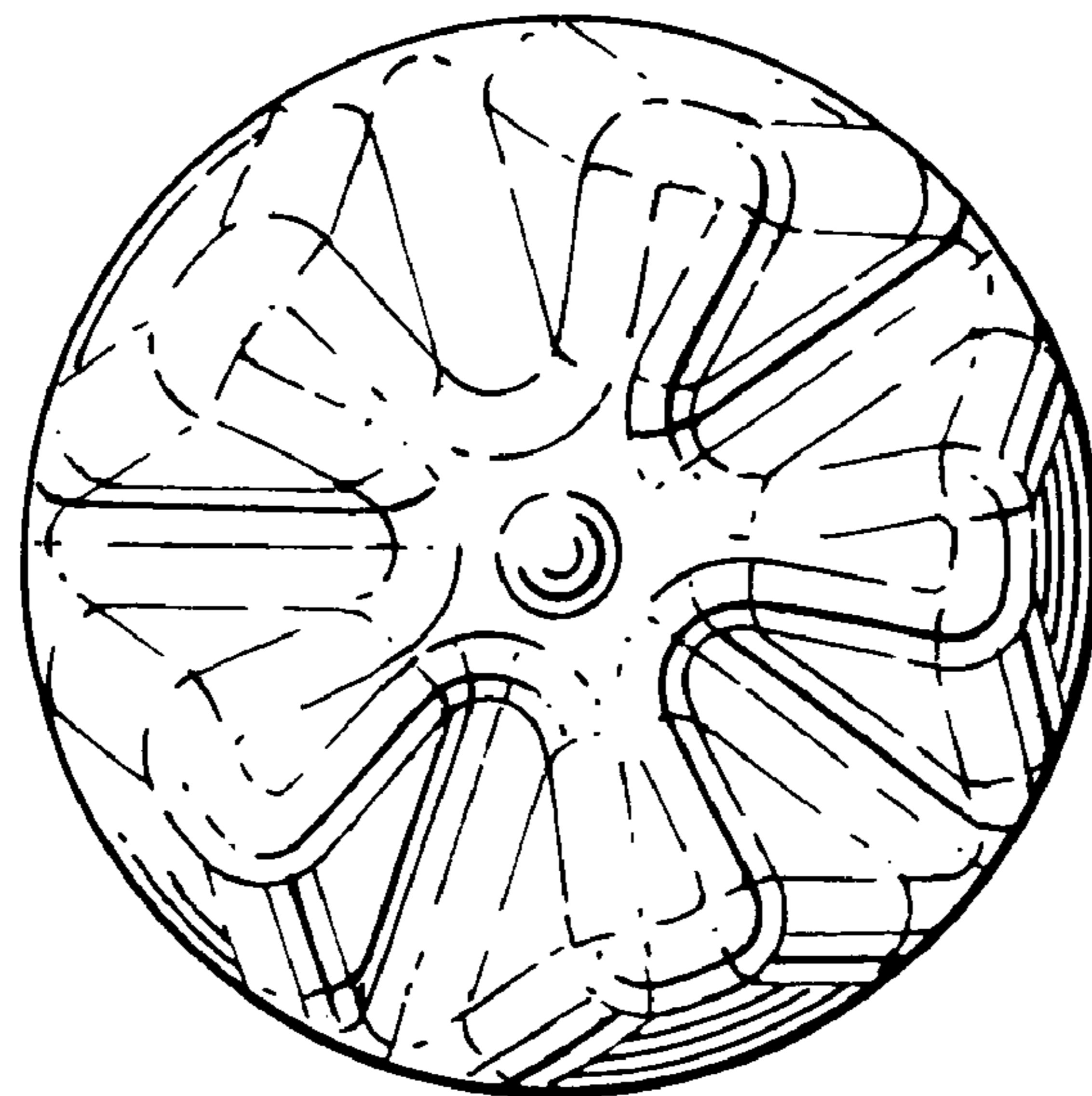
