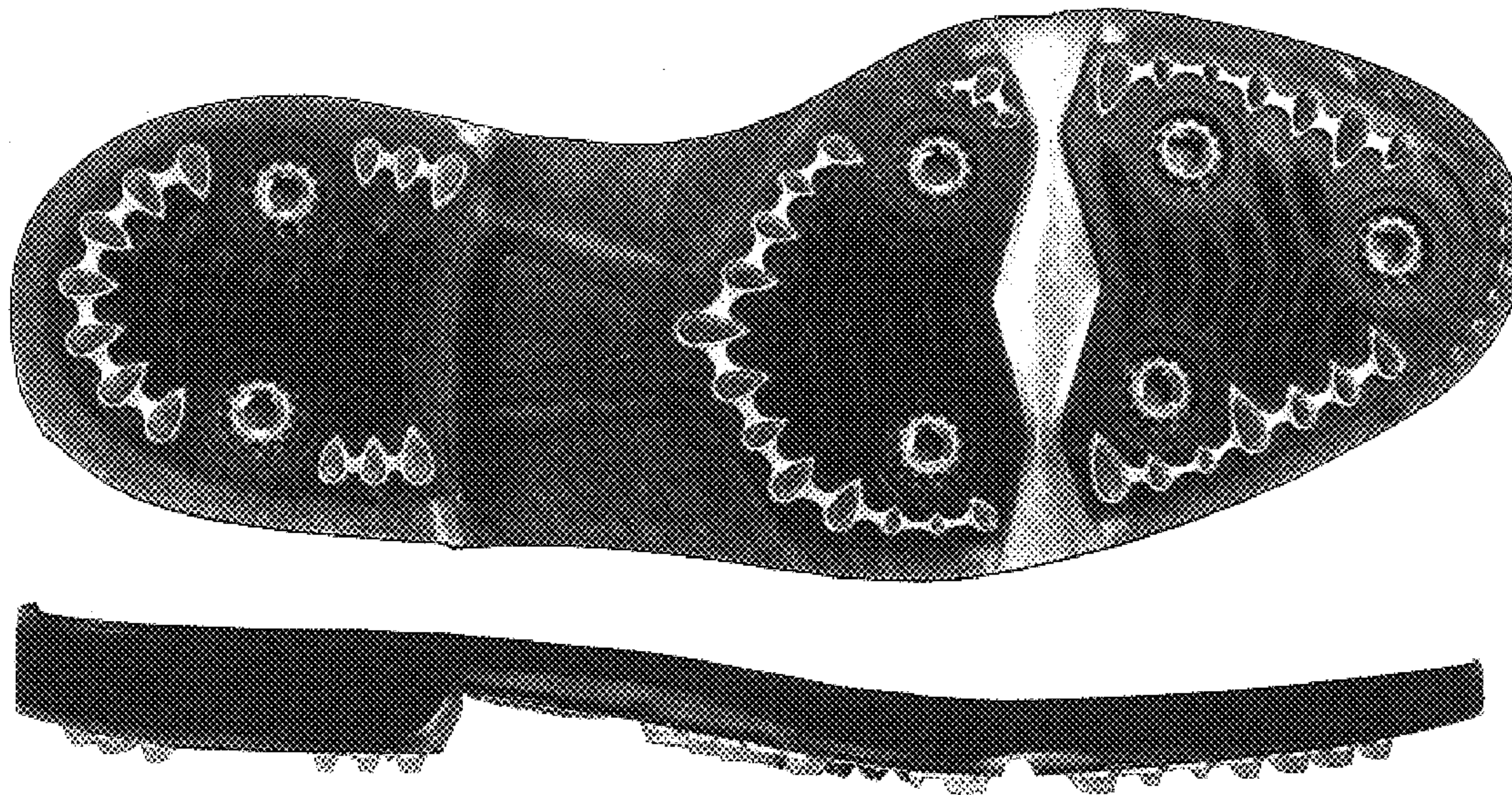
(57) **CLAIM**

The ornamental design for a golf shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of the shoe outsole showing our new design;
FIG. 2 is a right side perspective view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is an enlarged front view thereof; and,
FIG. 5 is an enlarged rear view thereof, the sides of the wider portion of the shoe sole being omitted for convenience of illustration.

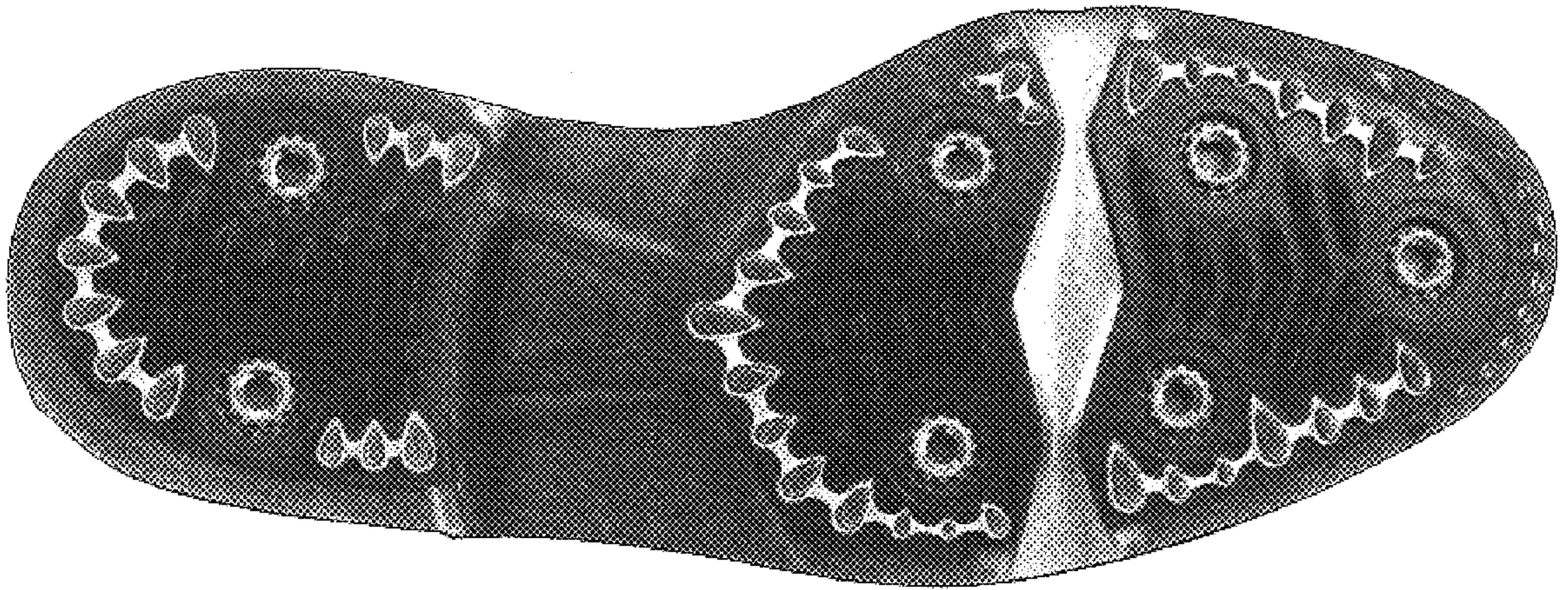

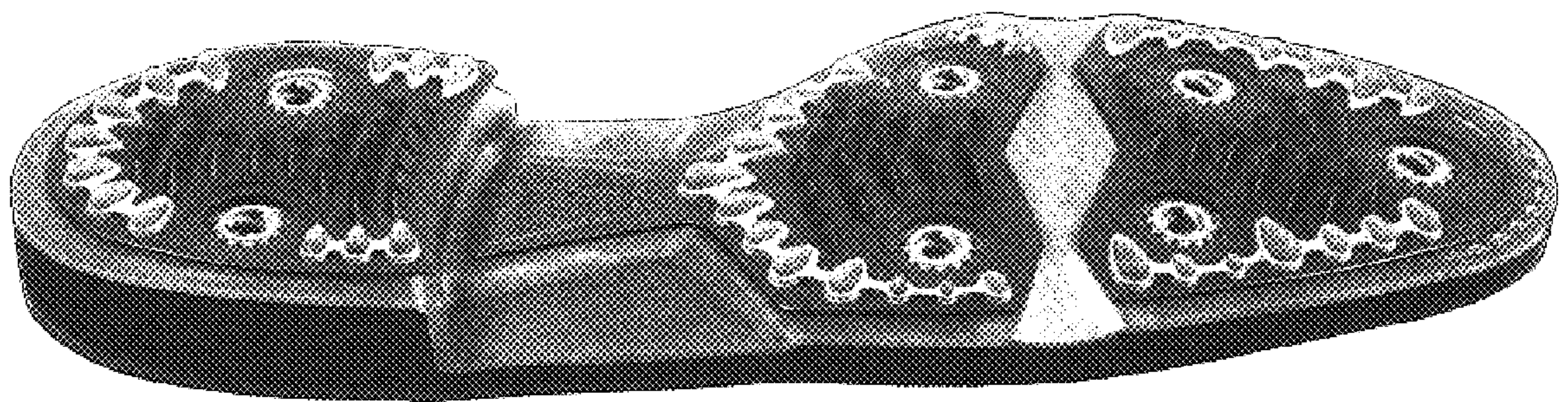

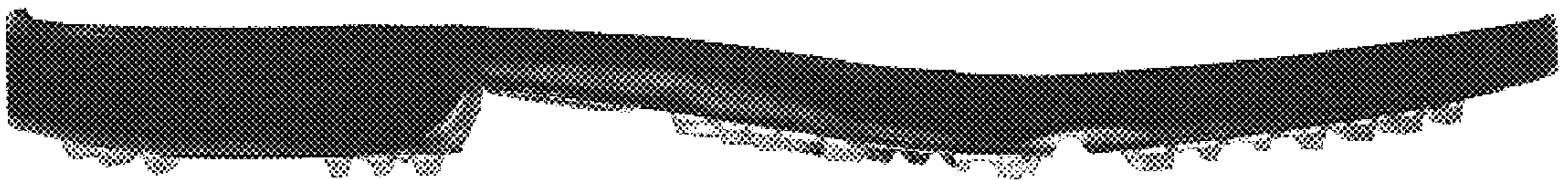

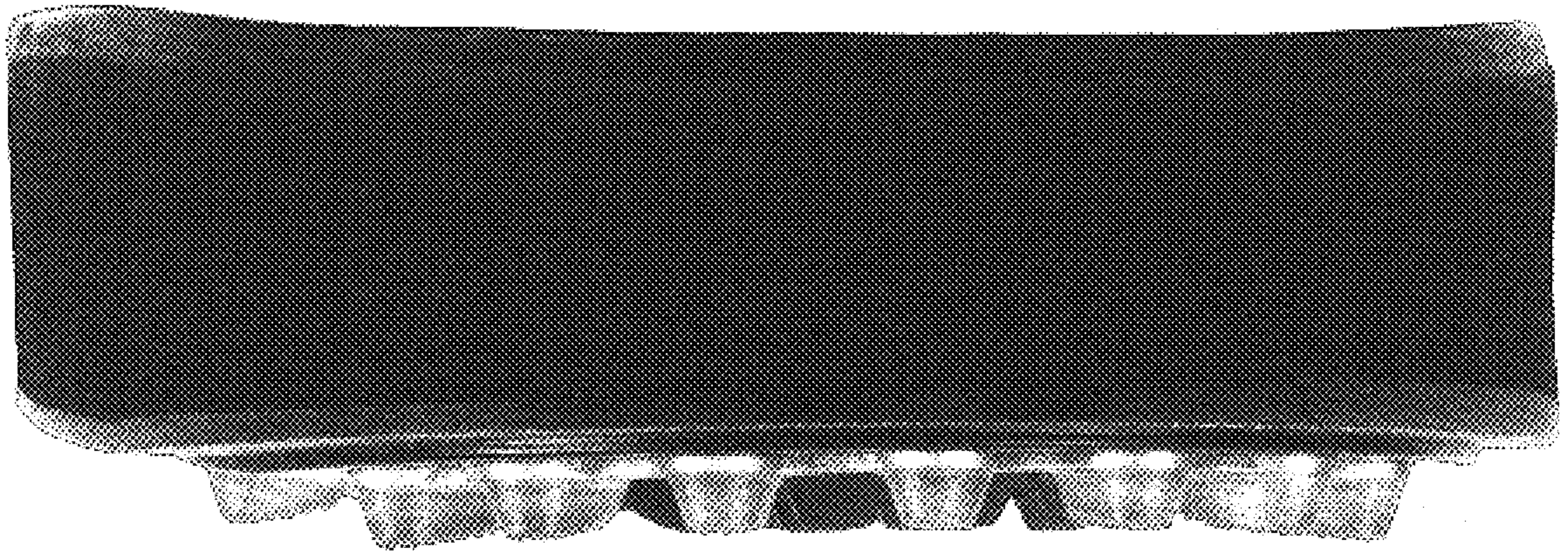
