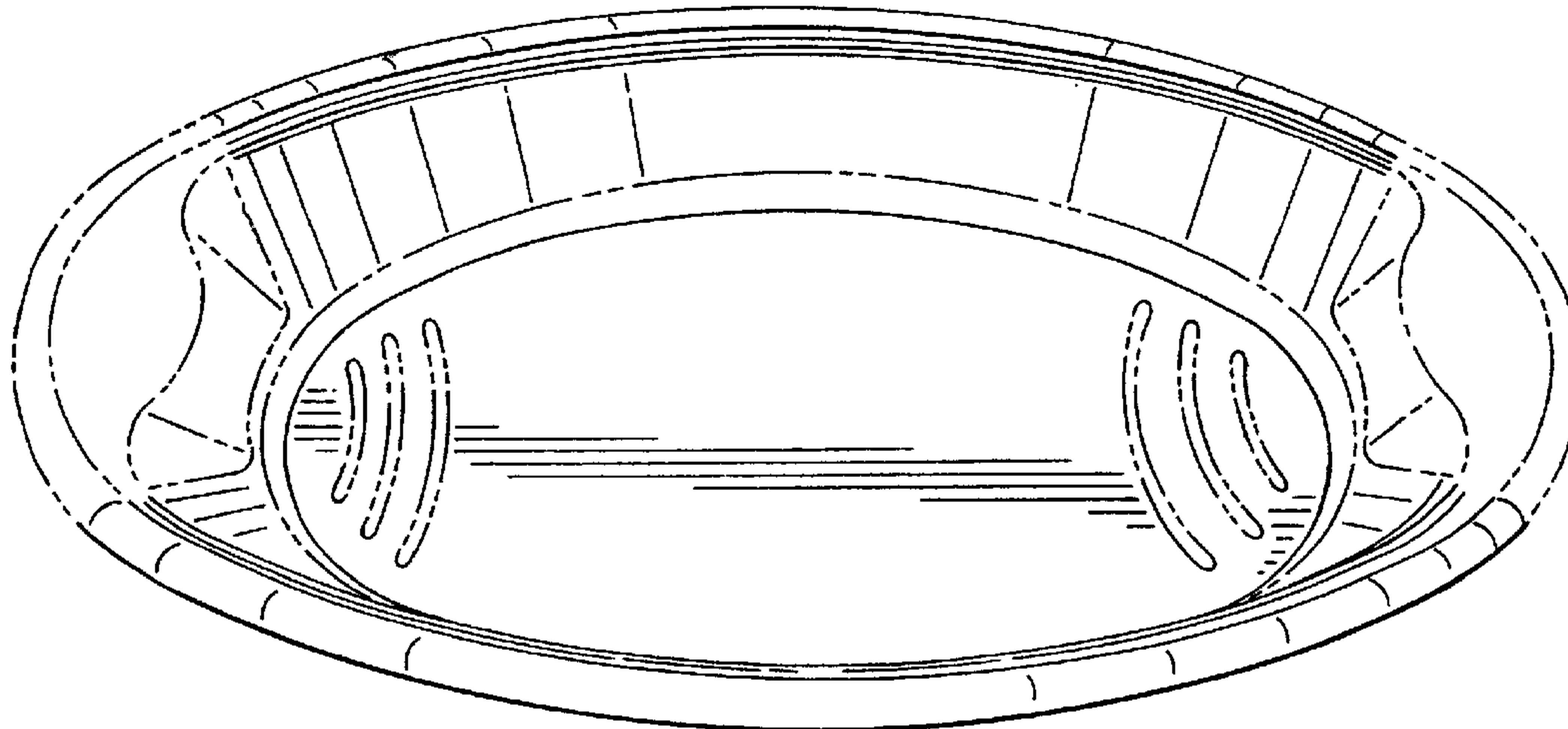
(57) **CLAIM**

We claim the ornamental Design for an ergonomic dispo-  
sable plate sidewall, as shown and described. Broken lines in  
the Figures form no part of the claimed design.

**DESCRIPTION**

FIG. 1 is a perspective view of an ergonomic disposable  
plate sidewall;  
FIG. 2 is a front elevation view of the plate of FIG. 1, with  
an opposite view being identical thereto;  
FIG. 3 is a side elevation view of the plate of FIG. 1, with  
an opposite view being identical thereto;  
FIG. 4 is a top plan view of the plate of FIG. 1;  
FIG. 5 is a bottom plan view of the plate of FIG. 1;  
FIG. 6 is a cross-sectional front view of the plate of FIG. 1,  
with an opposite view being identical thereto; and,  
FIG. 7 is a cross-sectional side view of the plate of FIG. 1,  
with an opposite view being identical thereto.

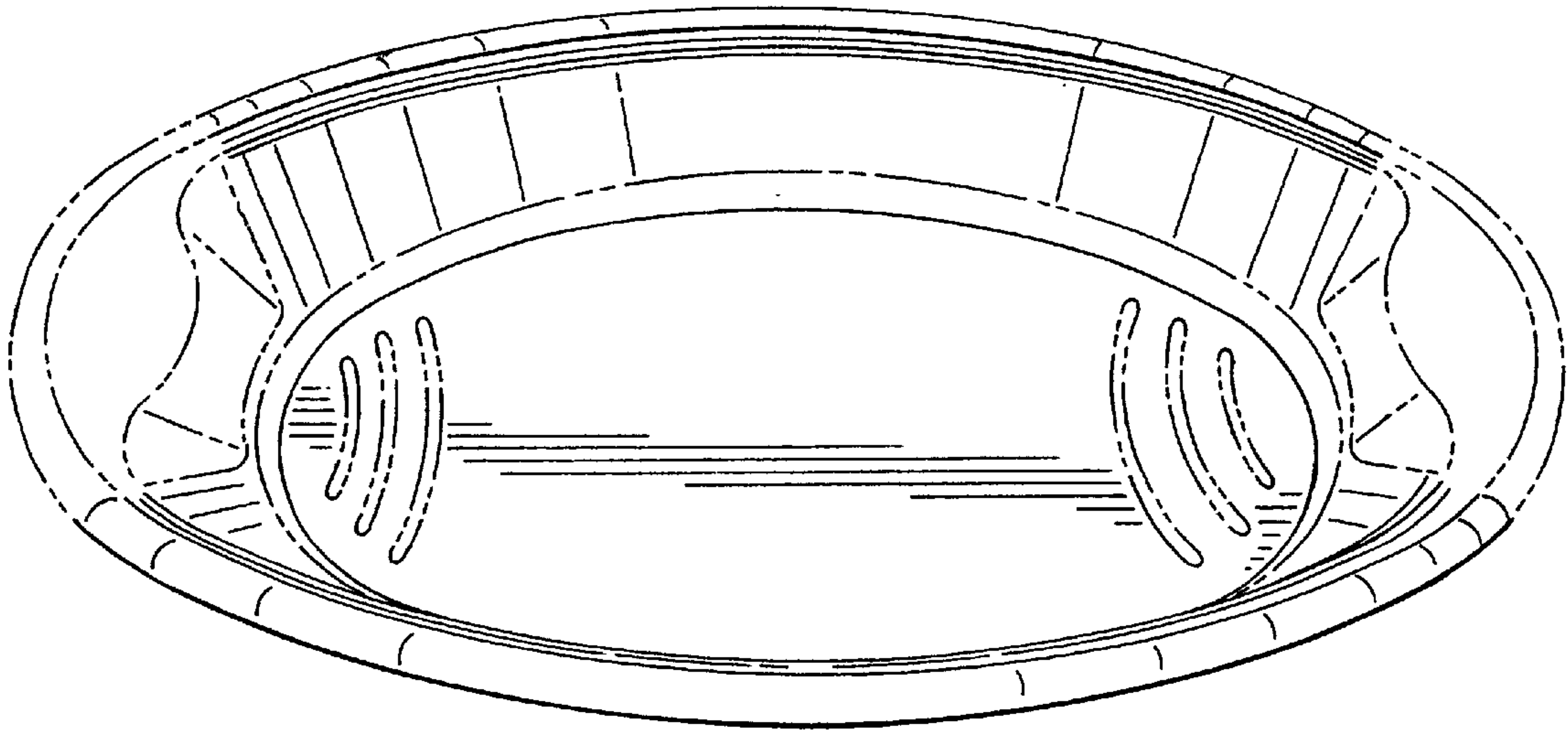

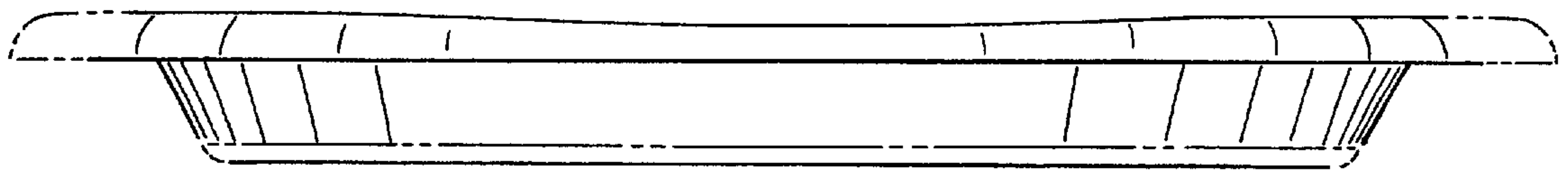

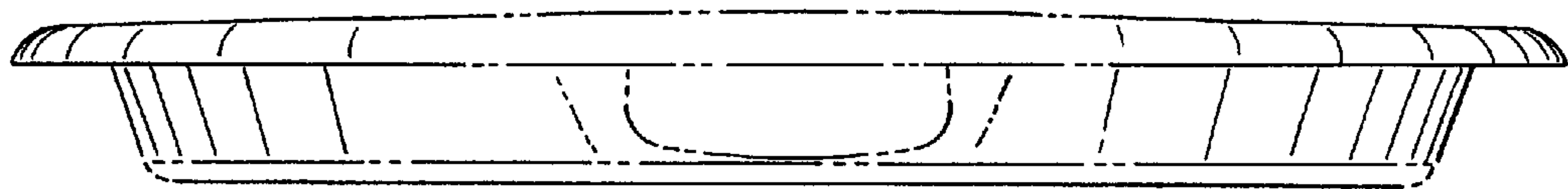

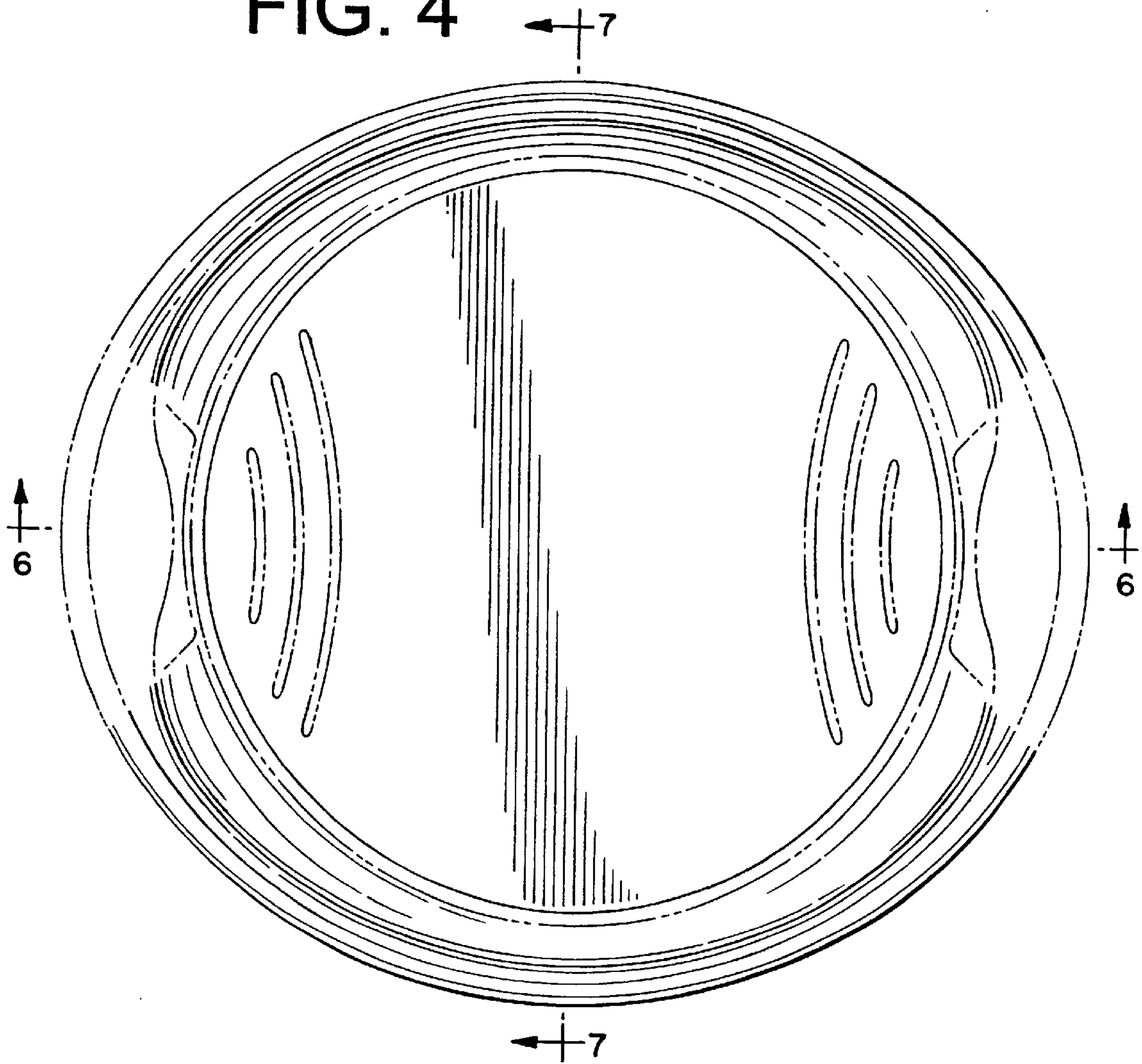

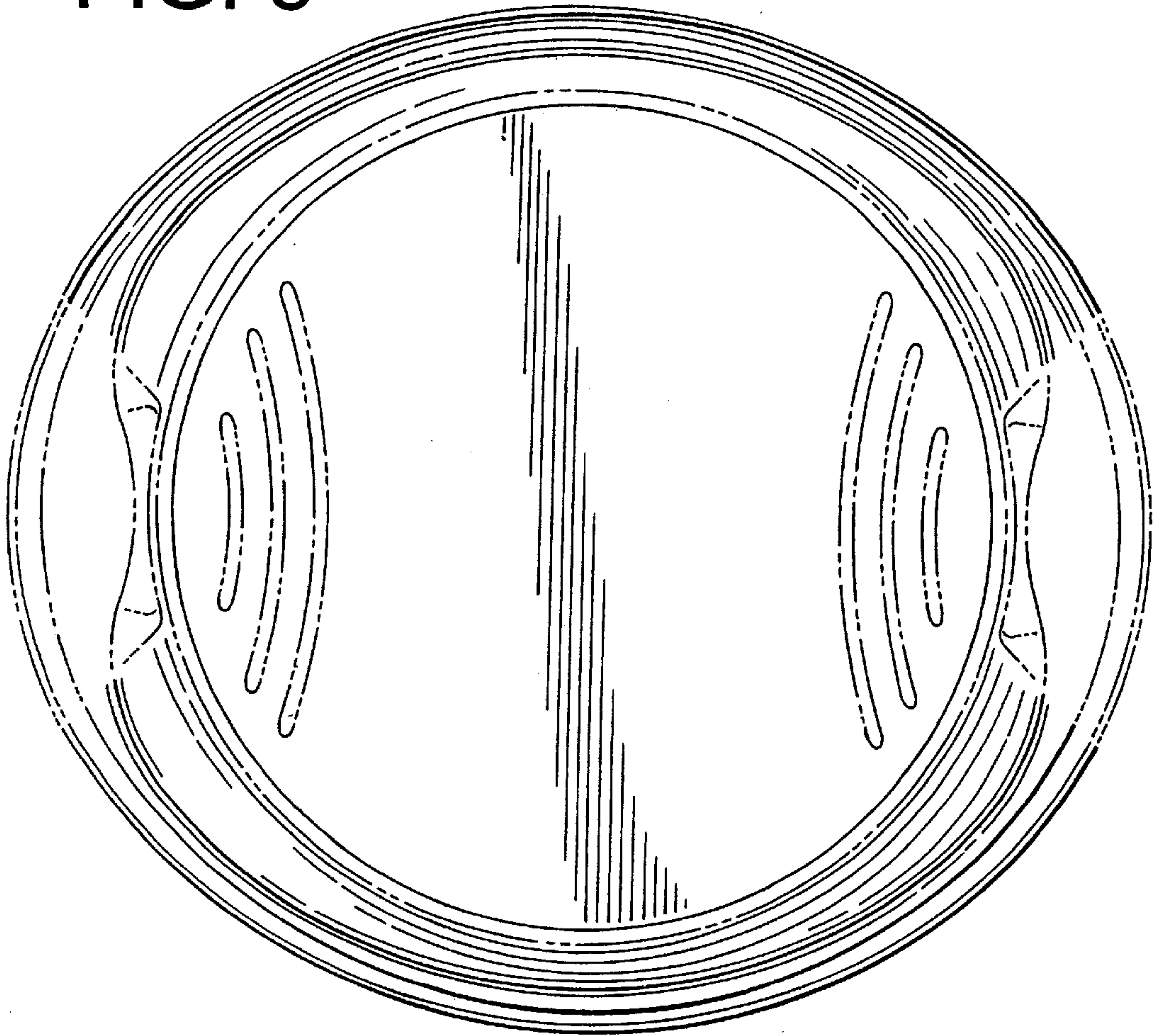

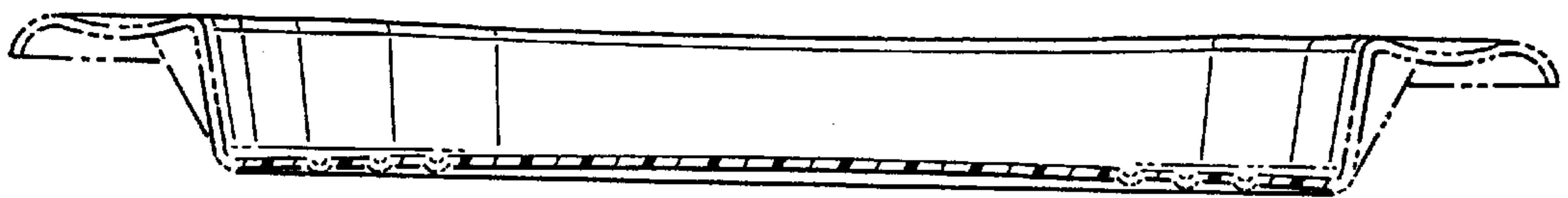
