 The subject matter depicted in dashed lines in FIG. 9 is shown for illustrative purposes only and forms no part of the claimed design.

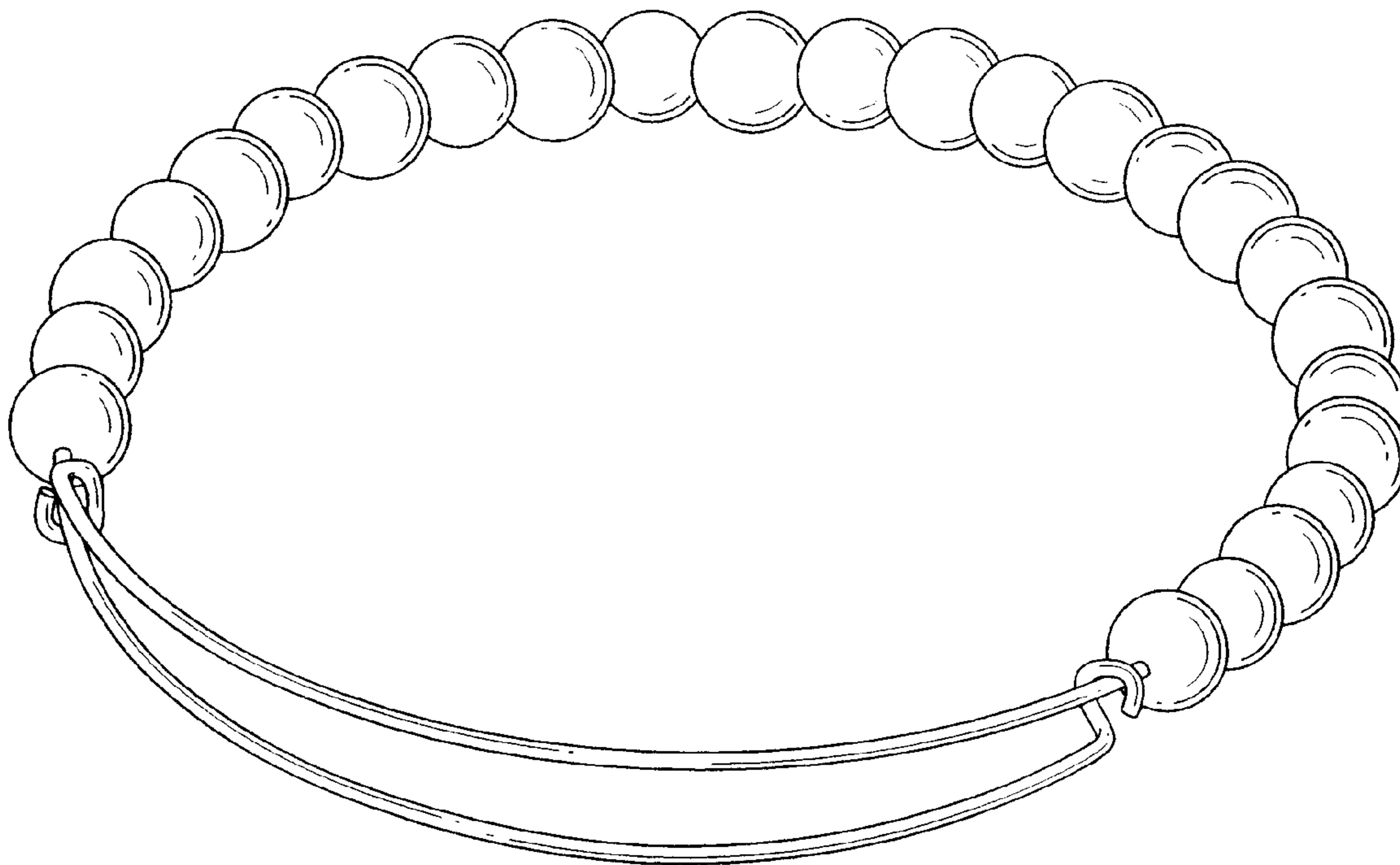

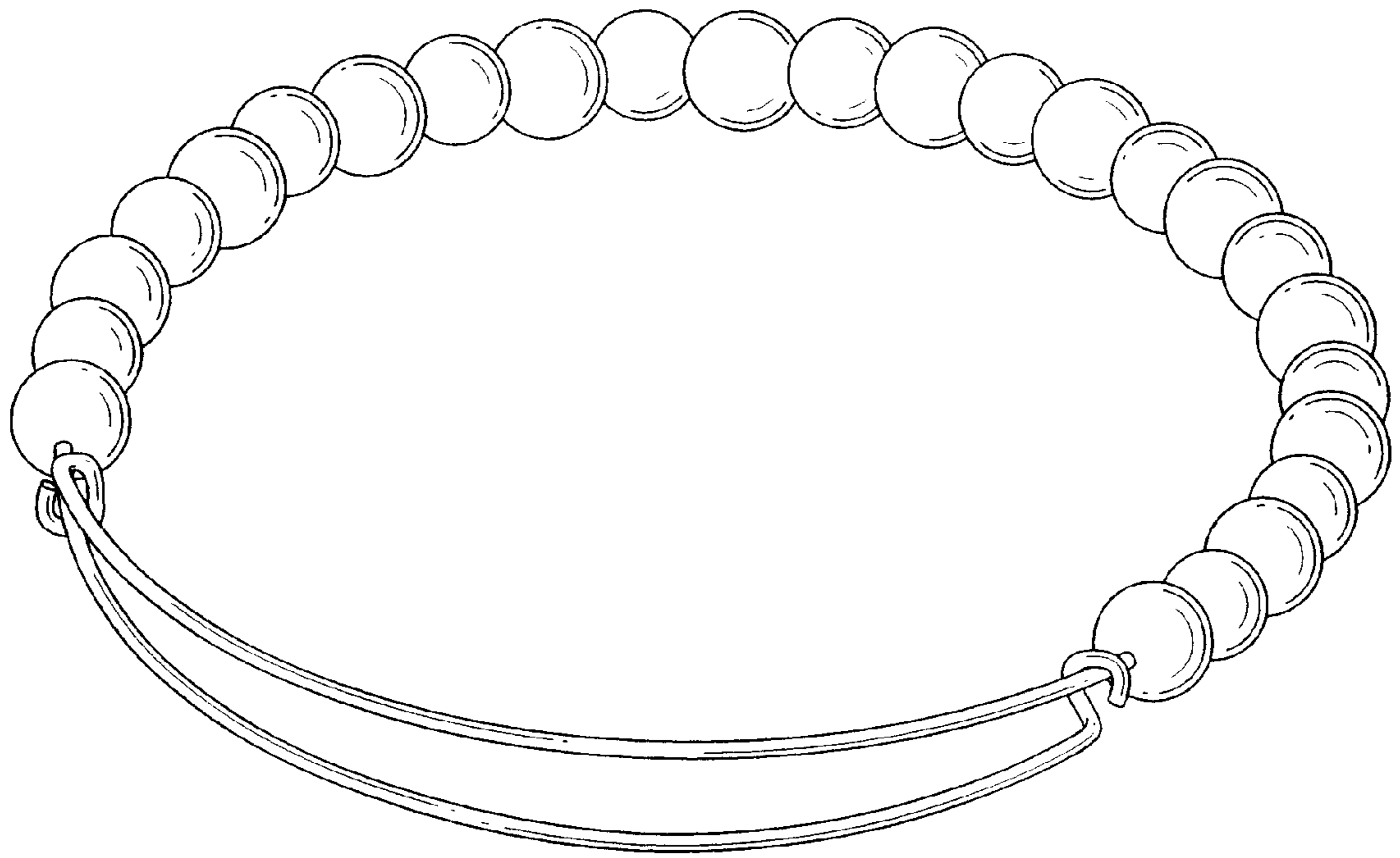

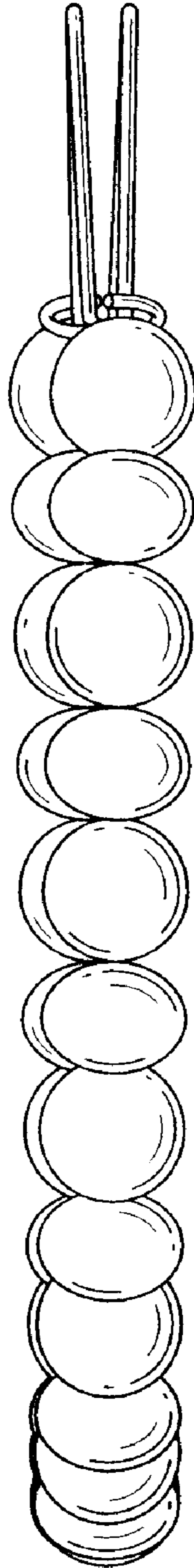

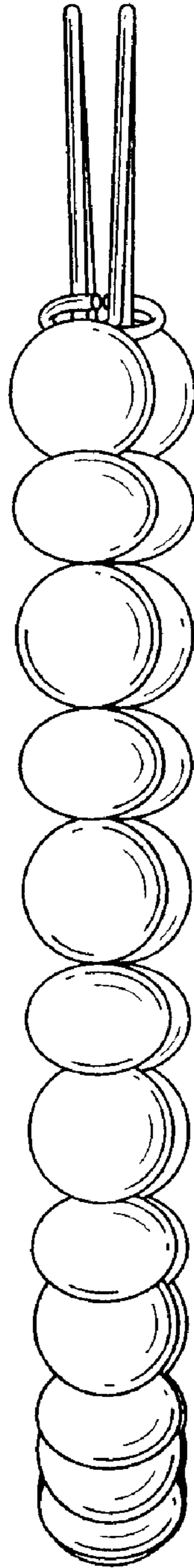

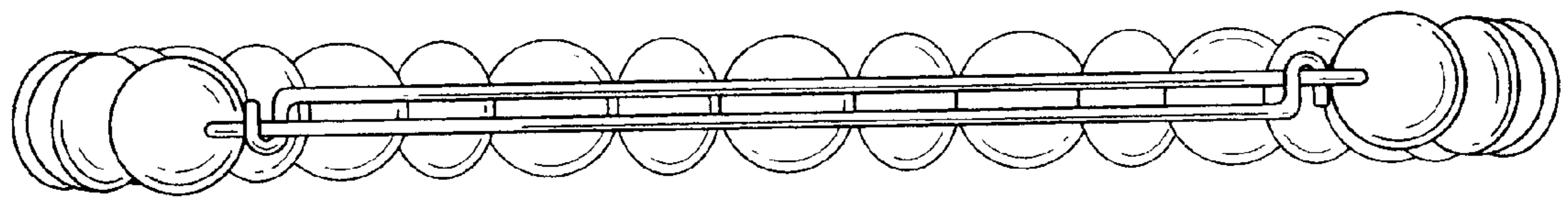

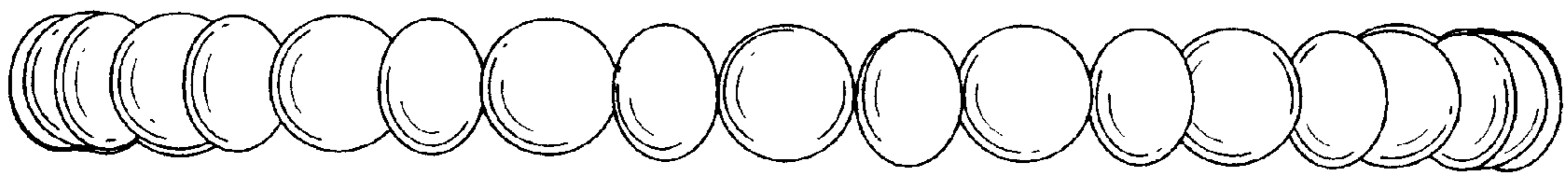

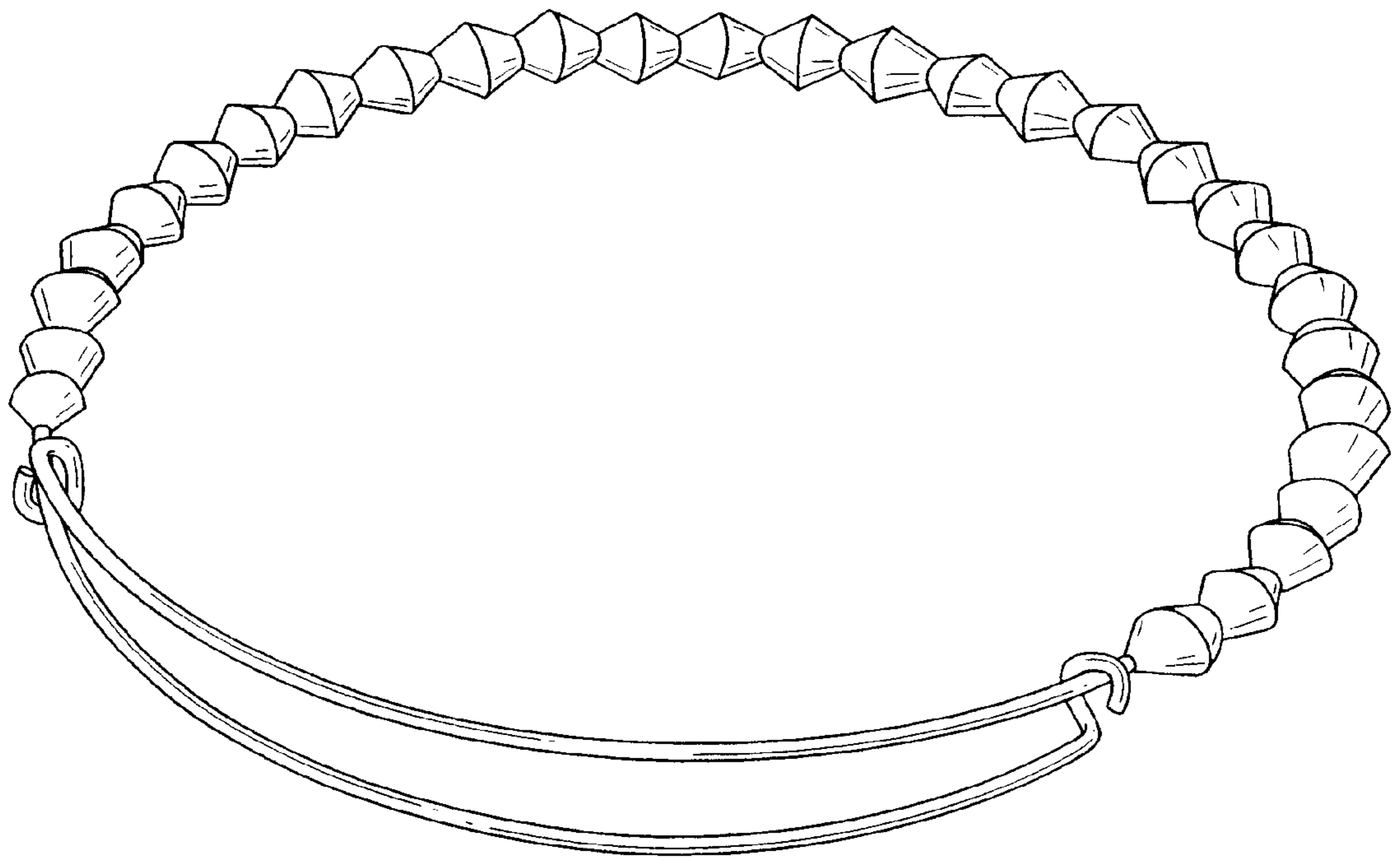
