DESCRIPTION

FIG. 1. Is a front perspective view of our flamingo-planter feeder with the dotted line shown being for illustrative purposes only and to which no claim is made;

FIG. 5. Is a top plan view thereof; and,

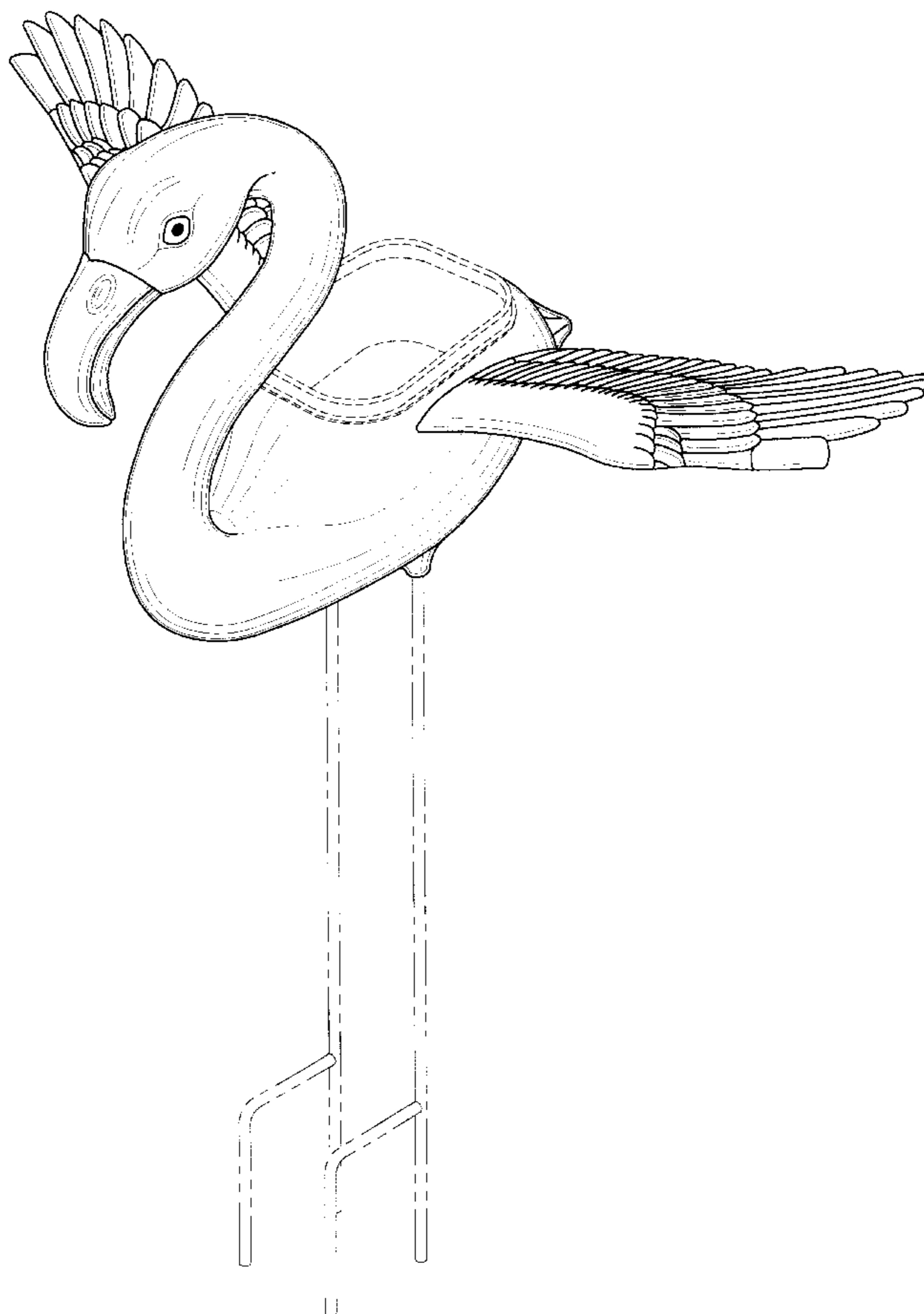
FIG. 6. Is a bottom plan view thereof.

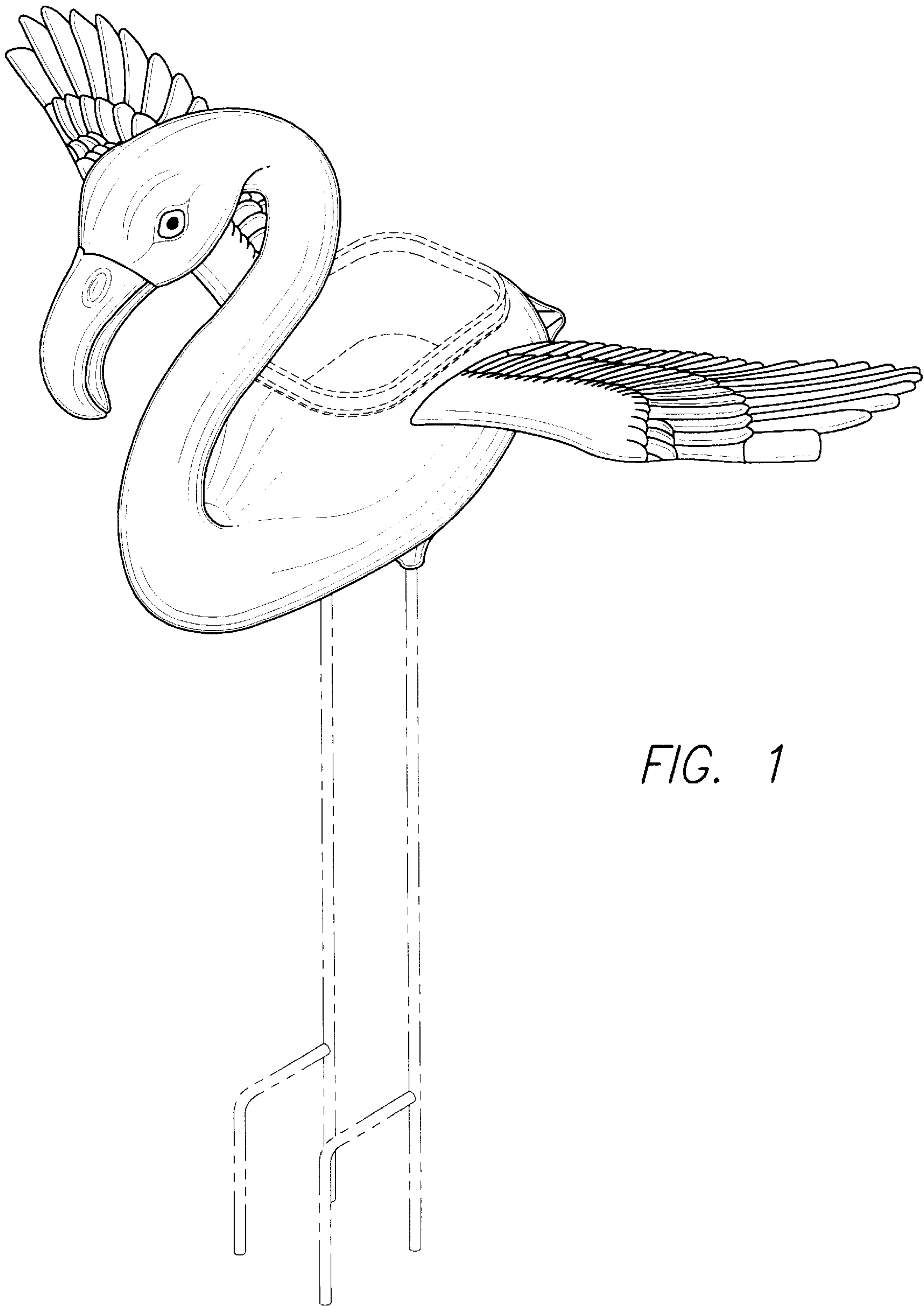

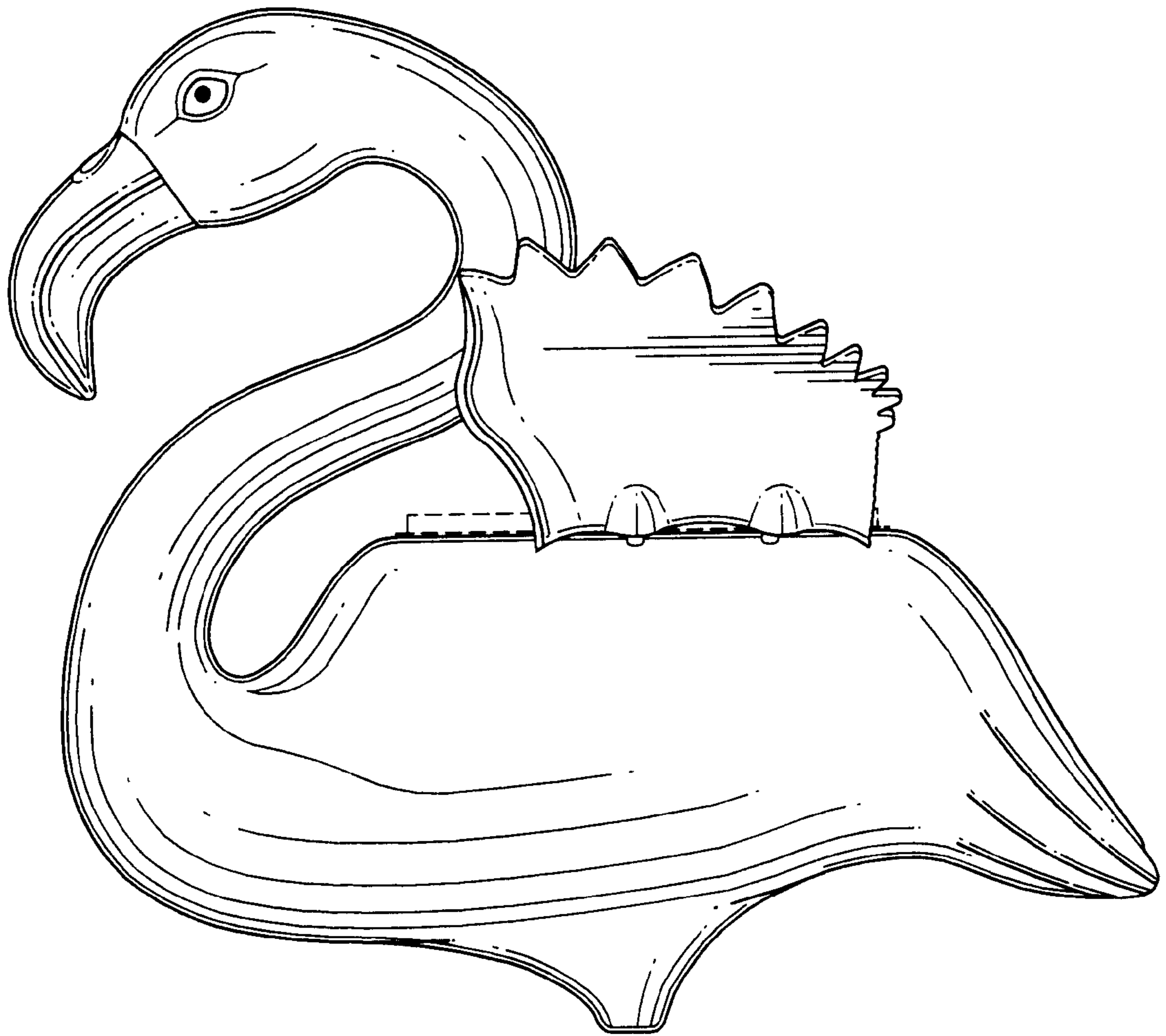

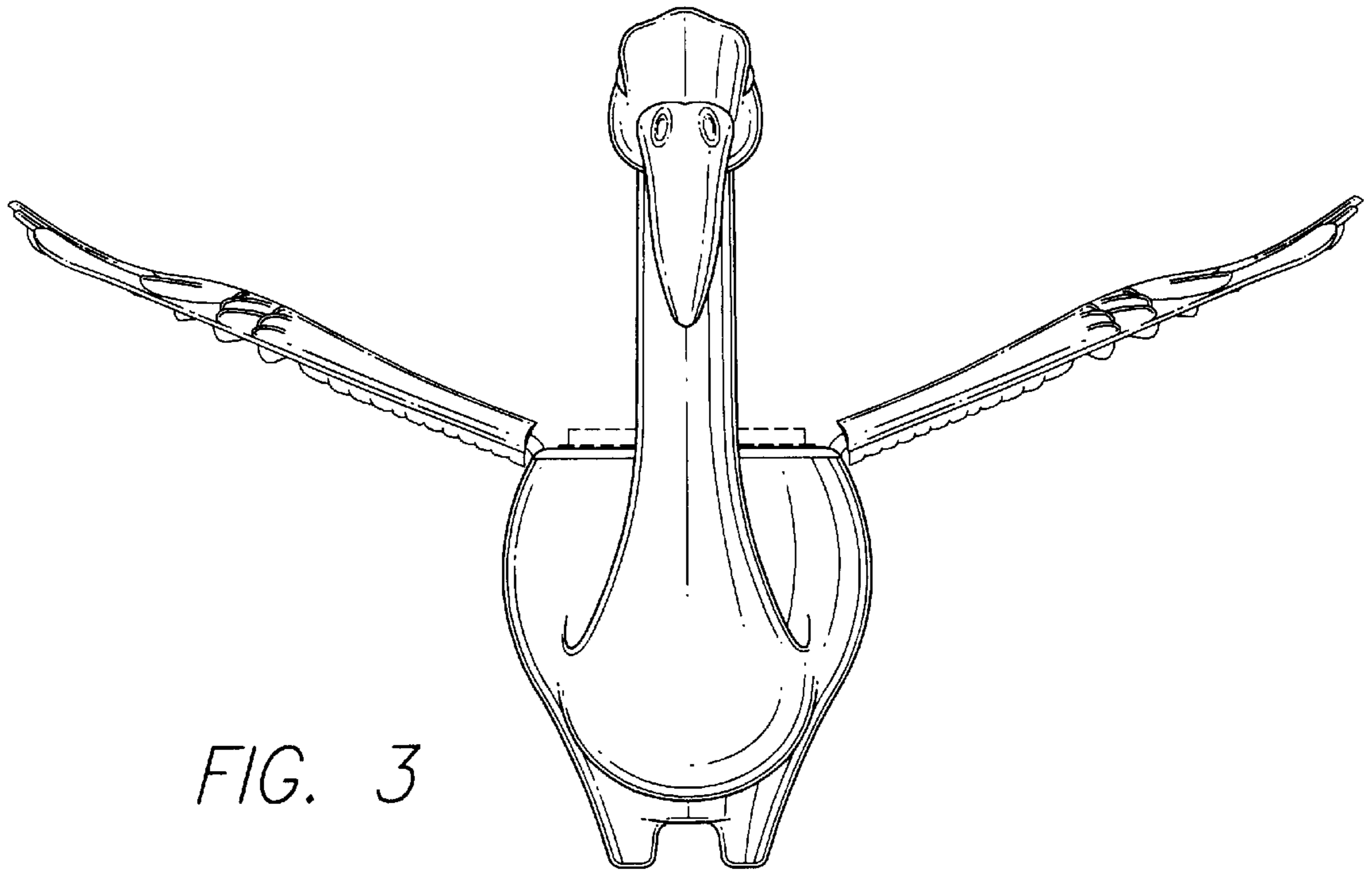

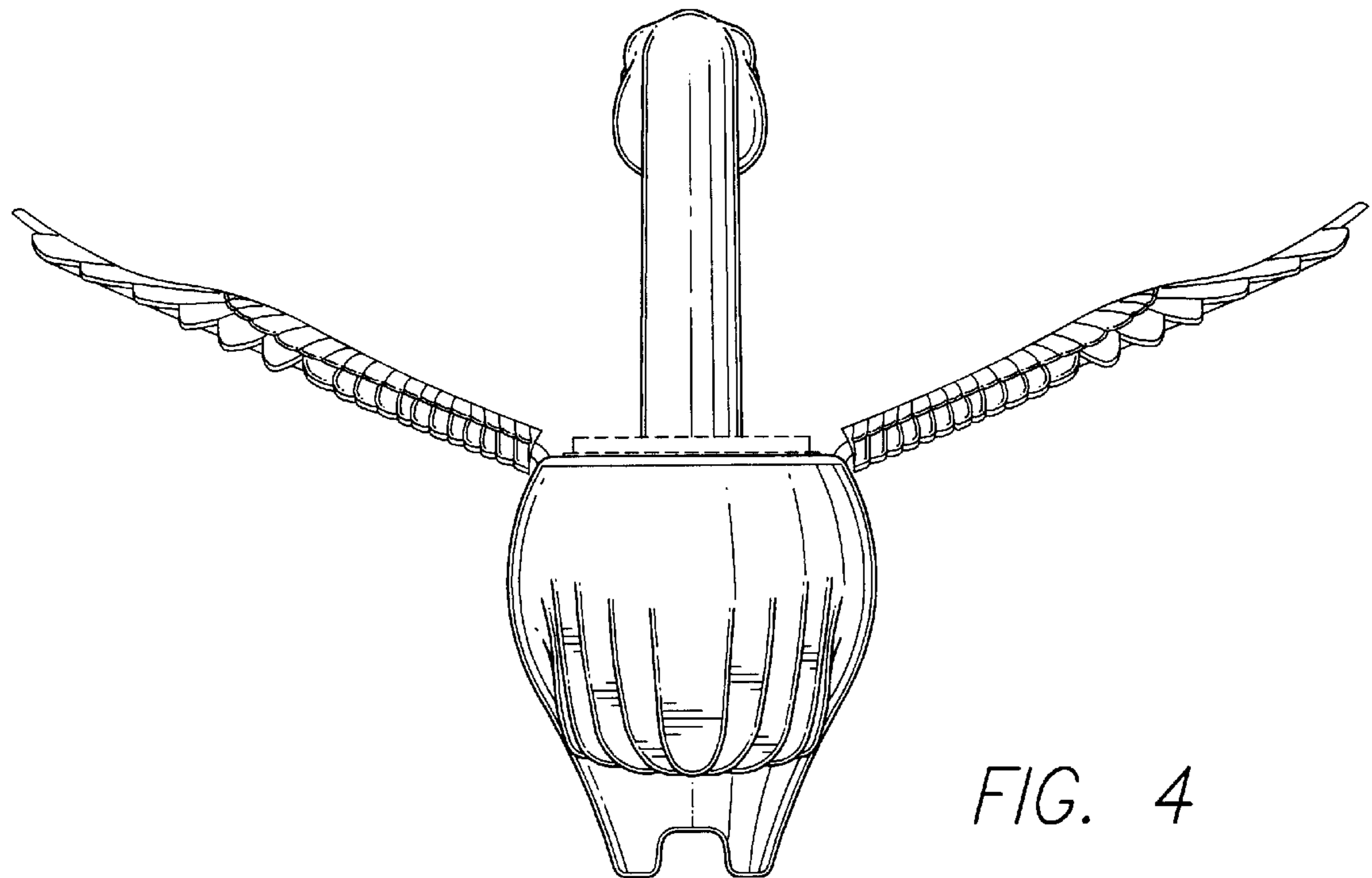

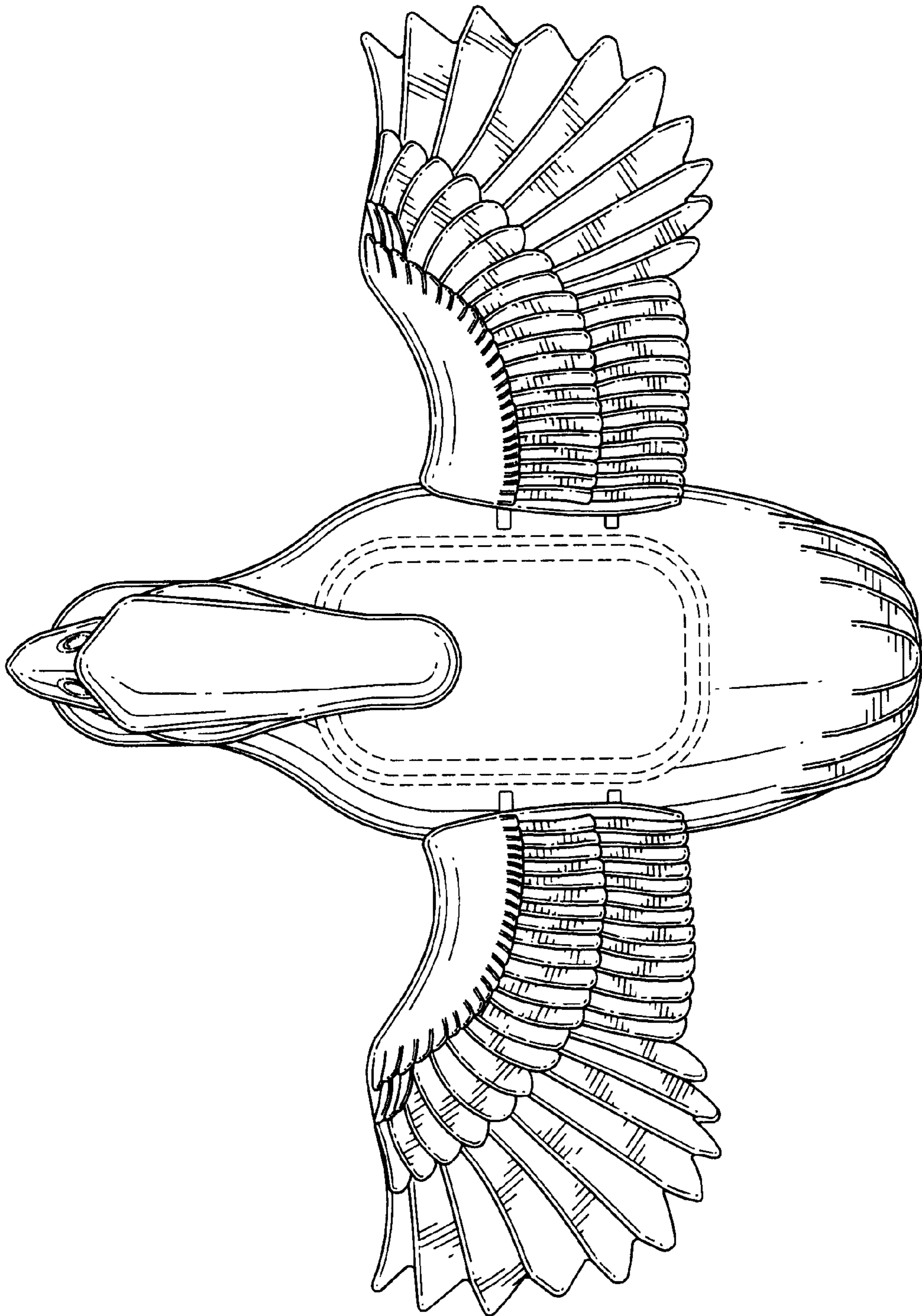

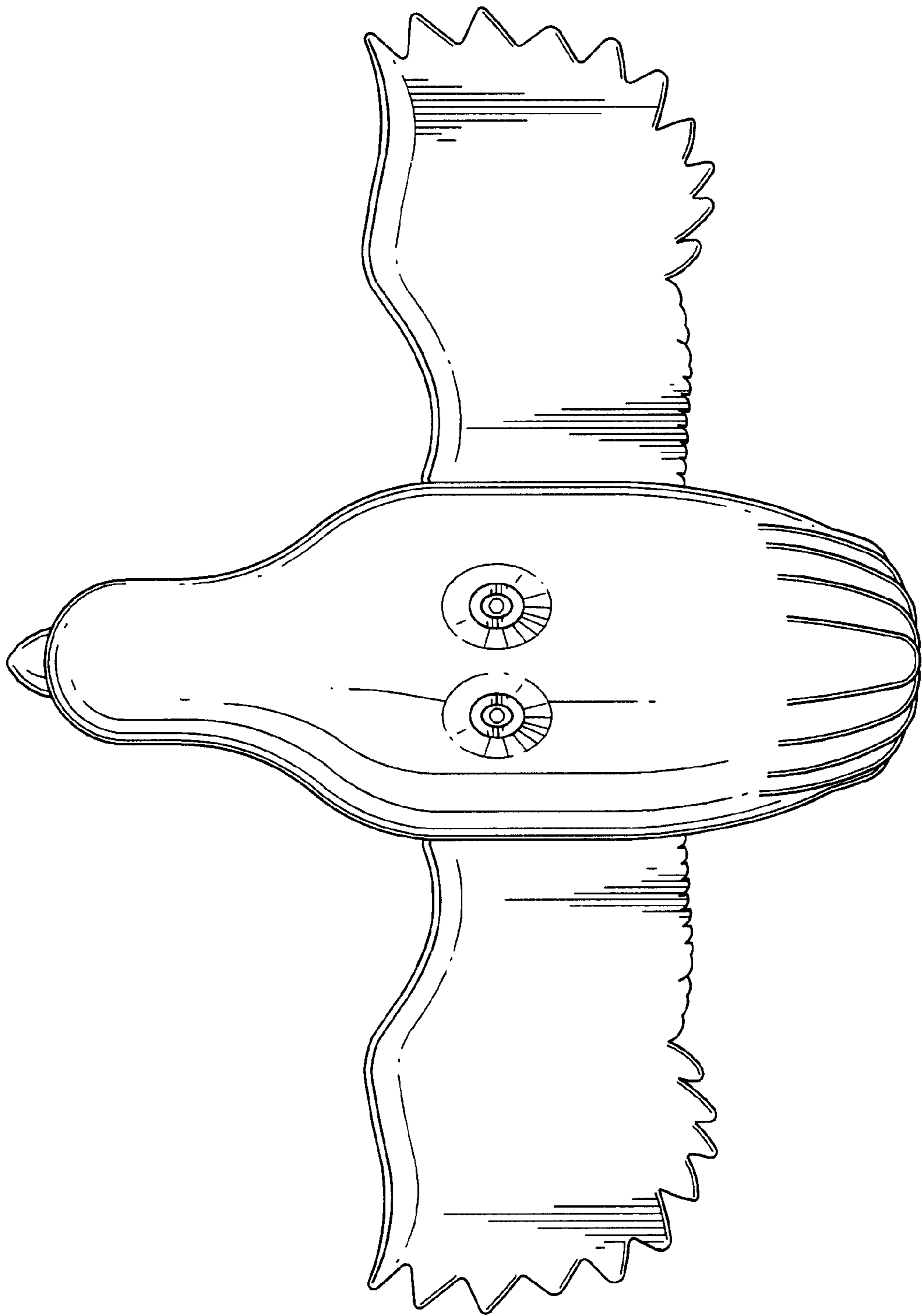
