The ornamental design for a device for recording and sending biomedical data, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the device embodying the design;

FIG. 4 is the other side elevation view of the device;

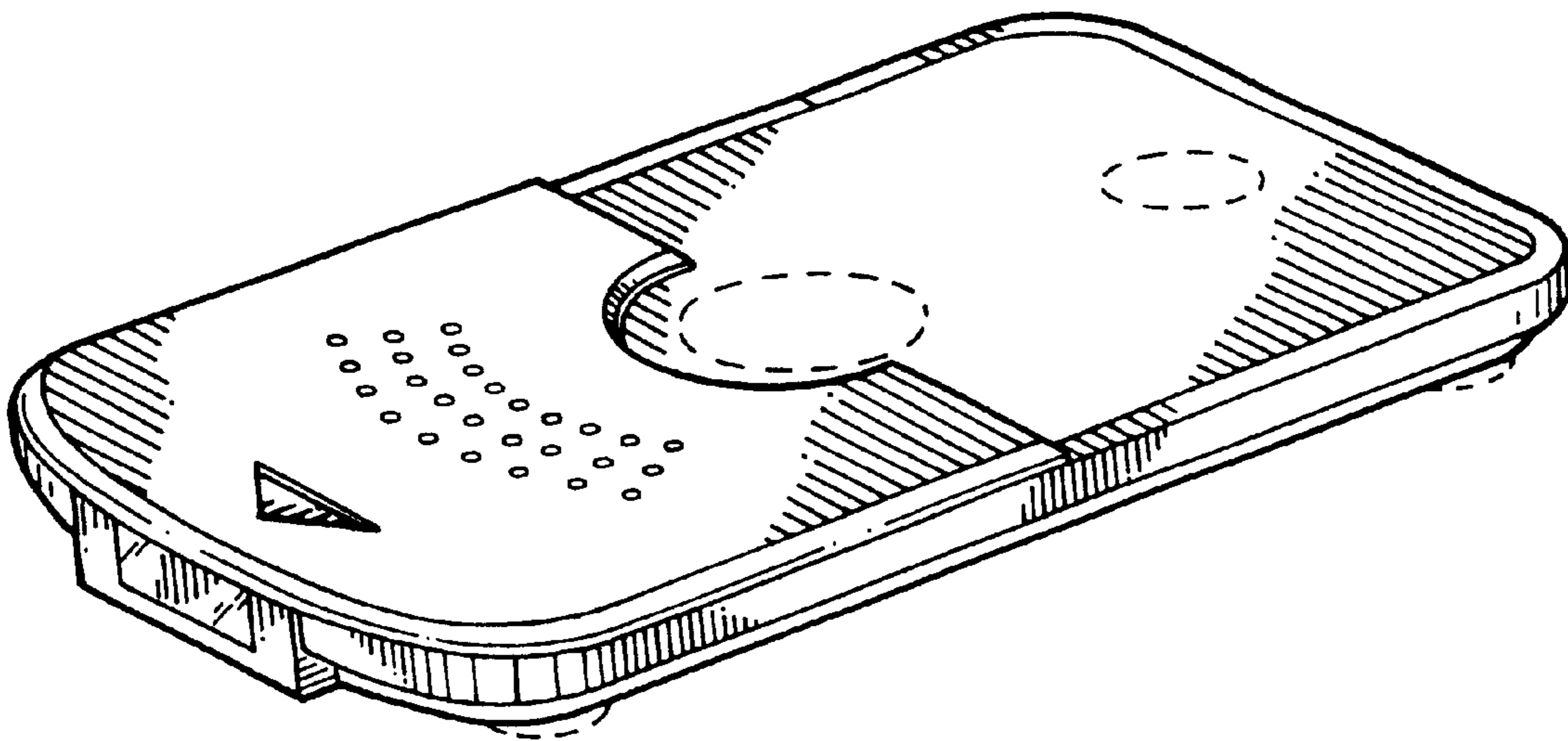
FIG. 5 is a bottom plan view of the device;

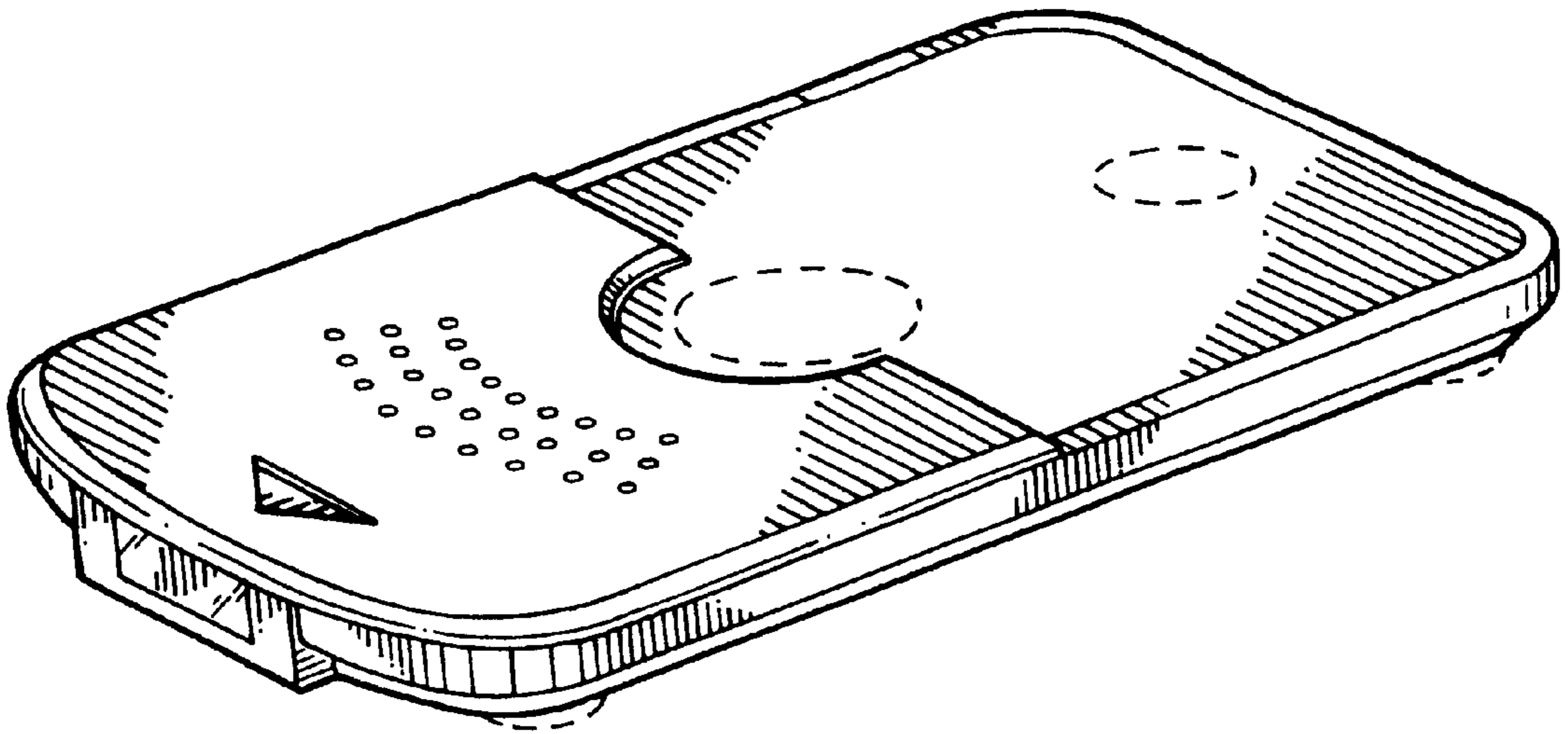

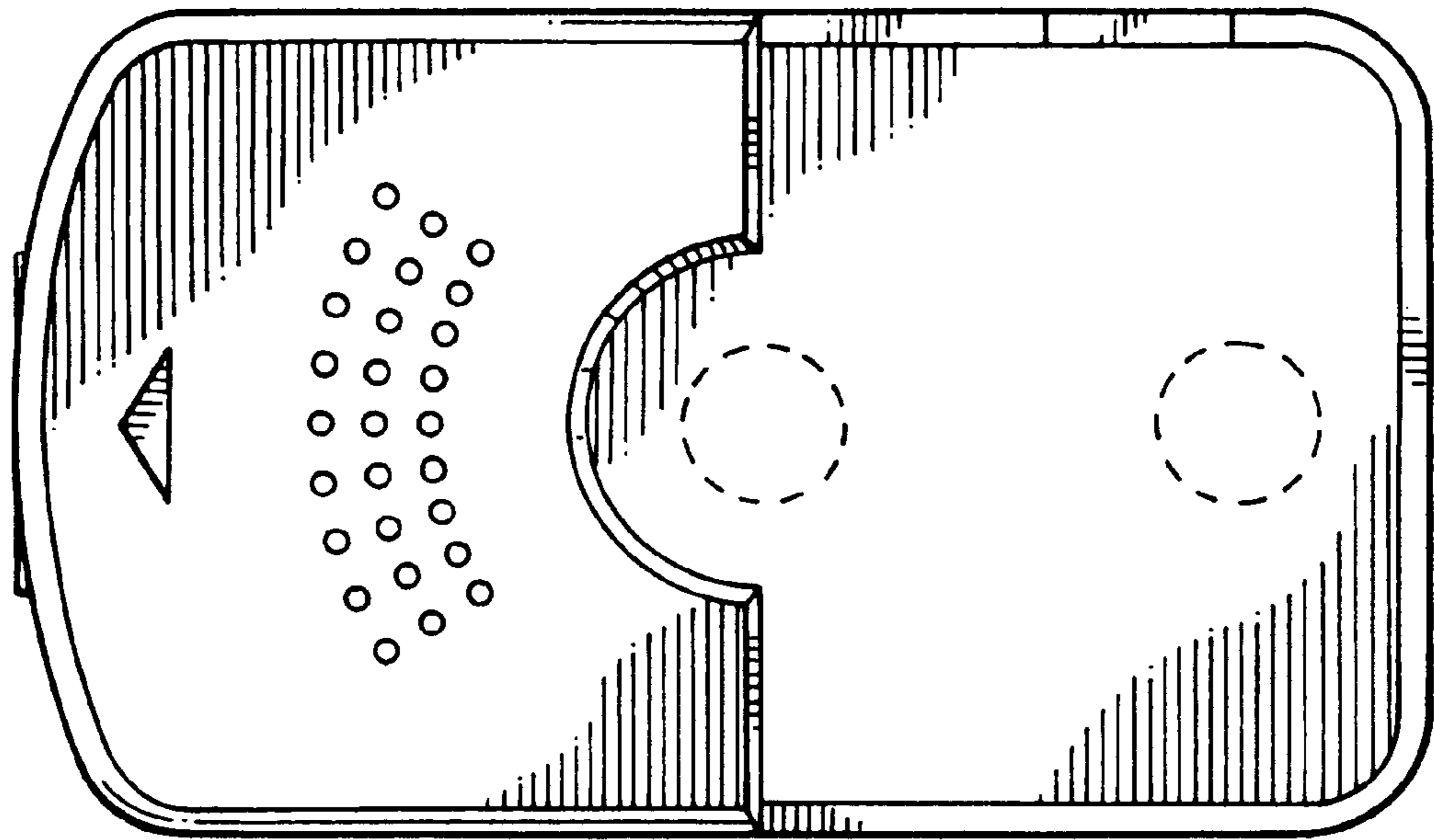

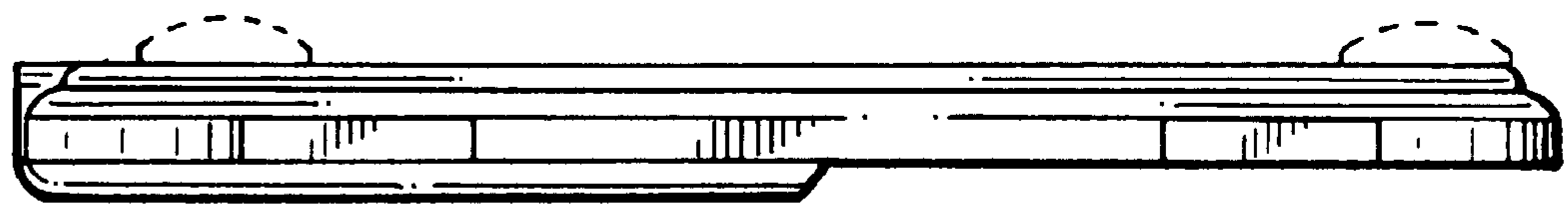

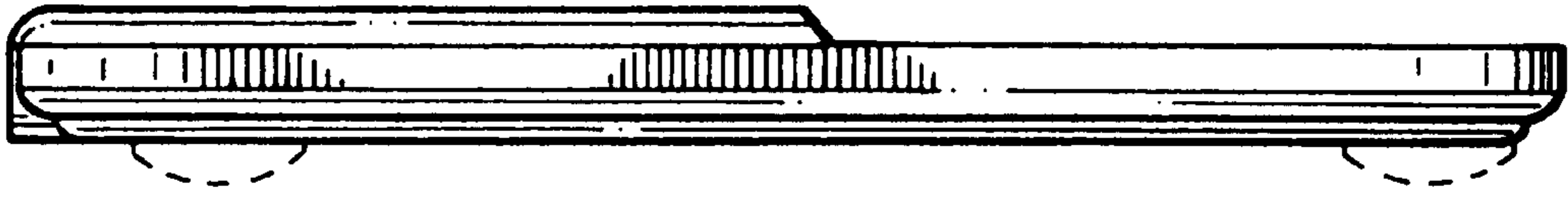

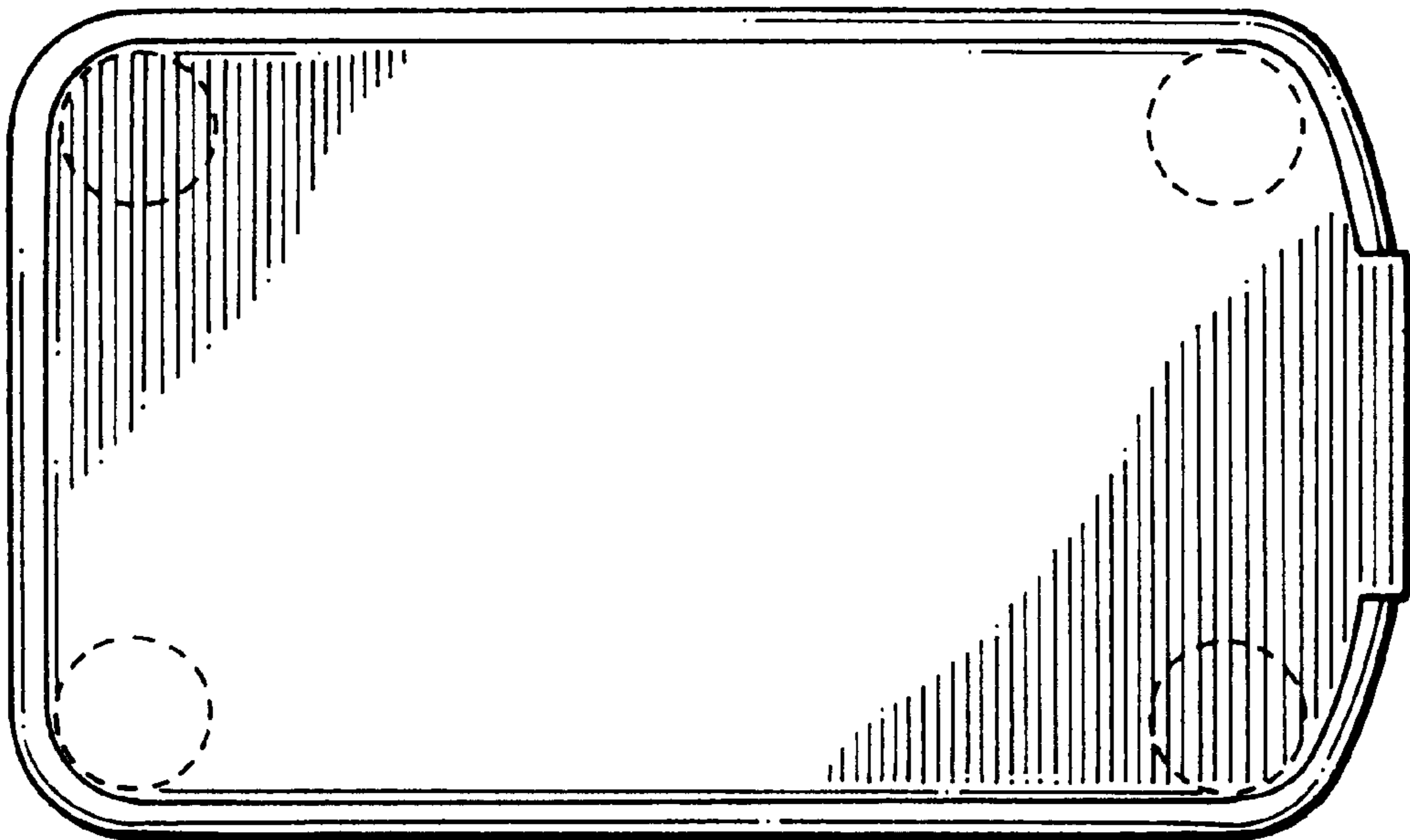

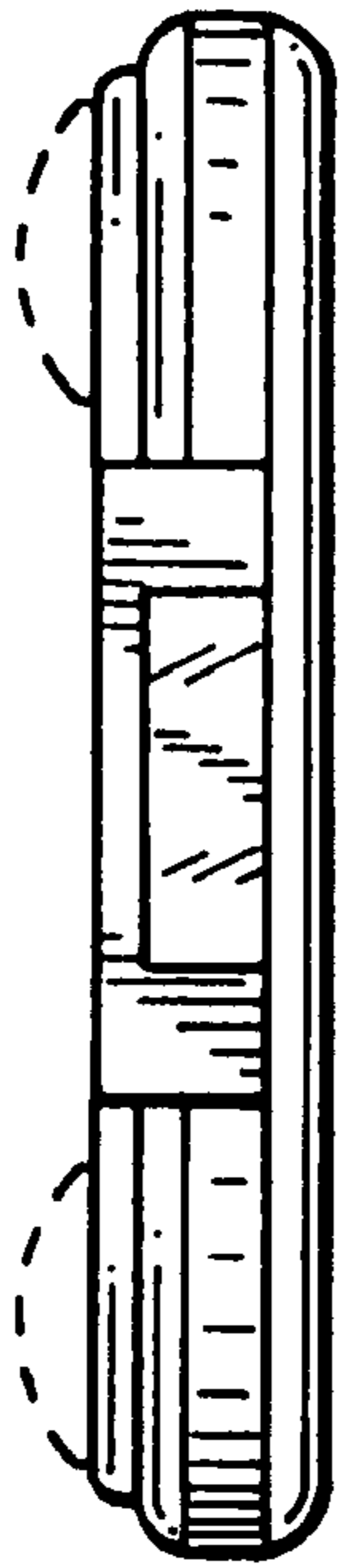

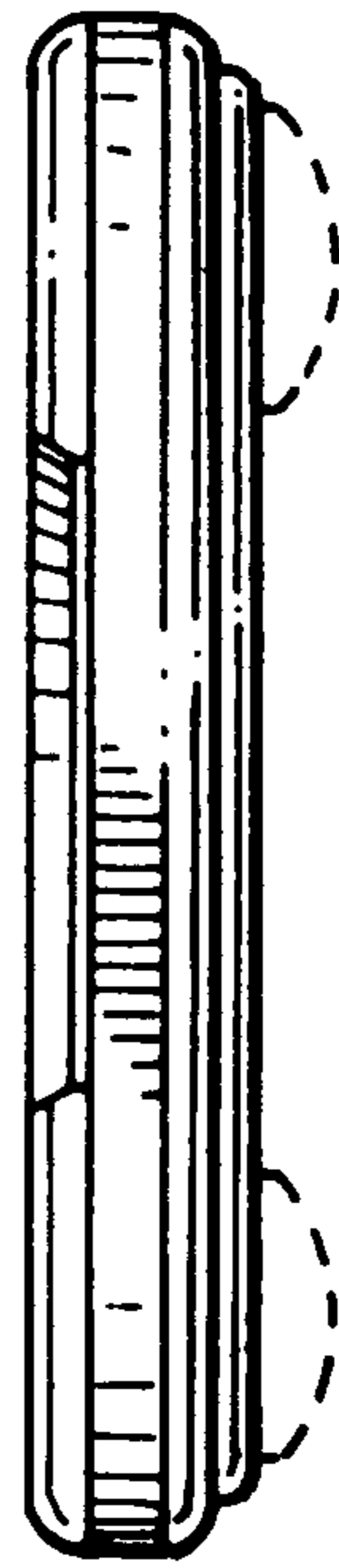
