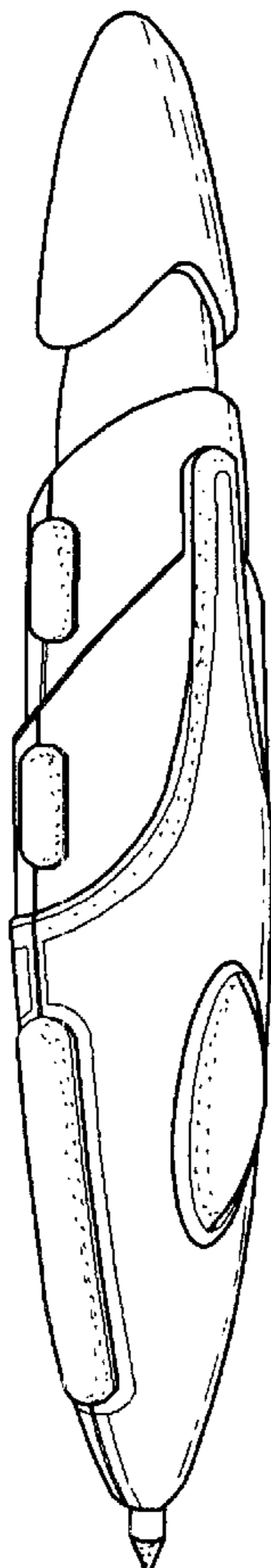
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of a pen showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a left-side view thereof; FIG. 4 is a right-side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a perspective view thereof; and, FIG. 8 is a second perspective view thereof, with the writing tip shown in an extended position.

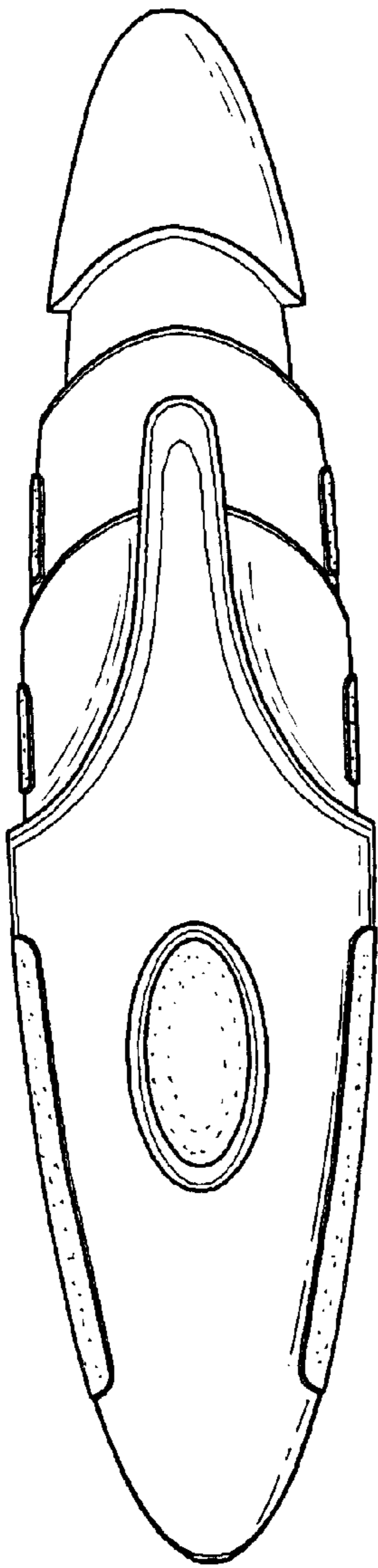

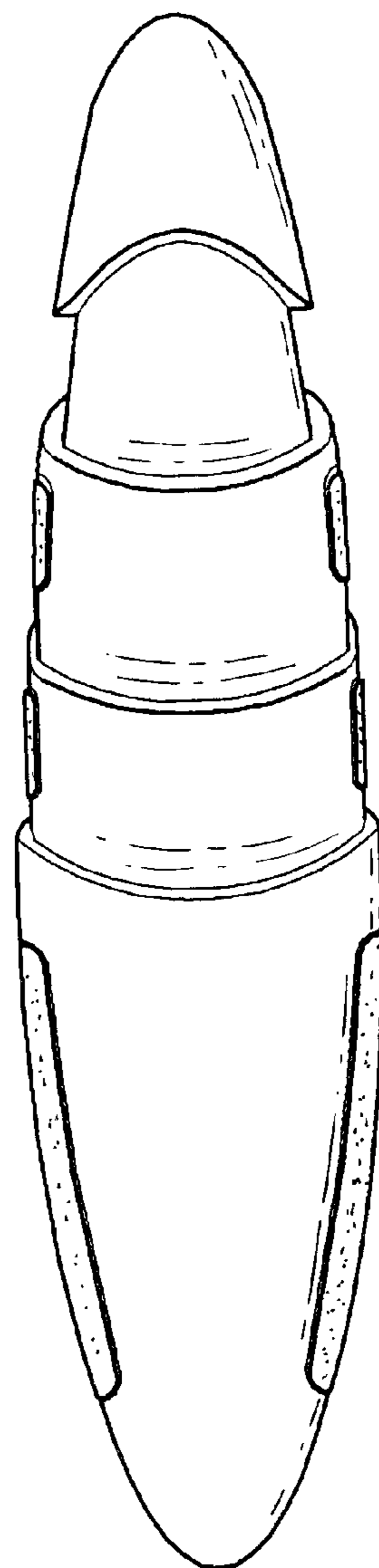

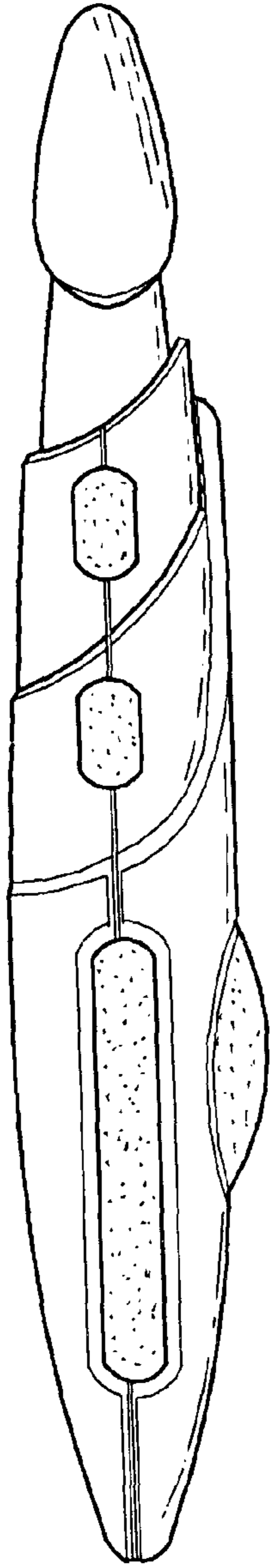

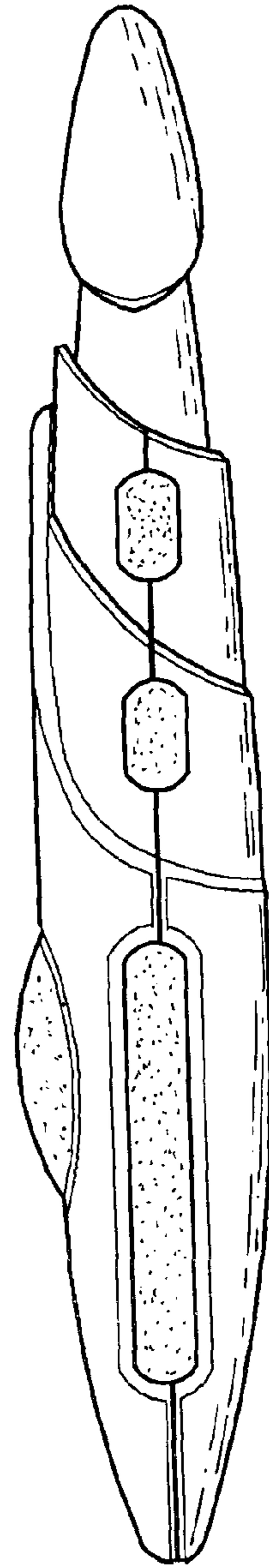

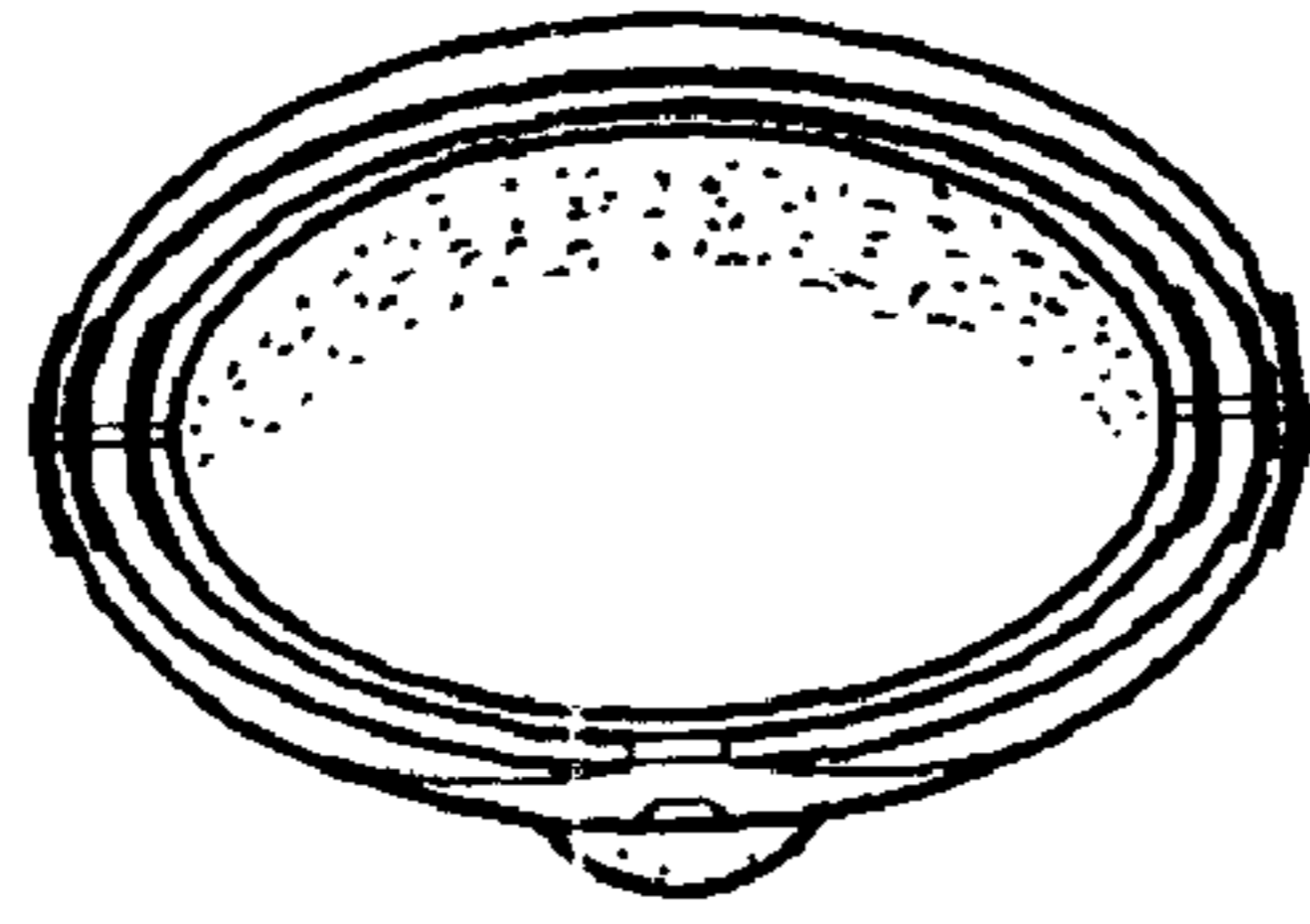

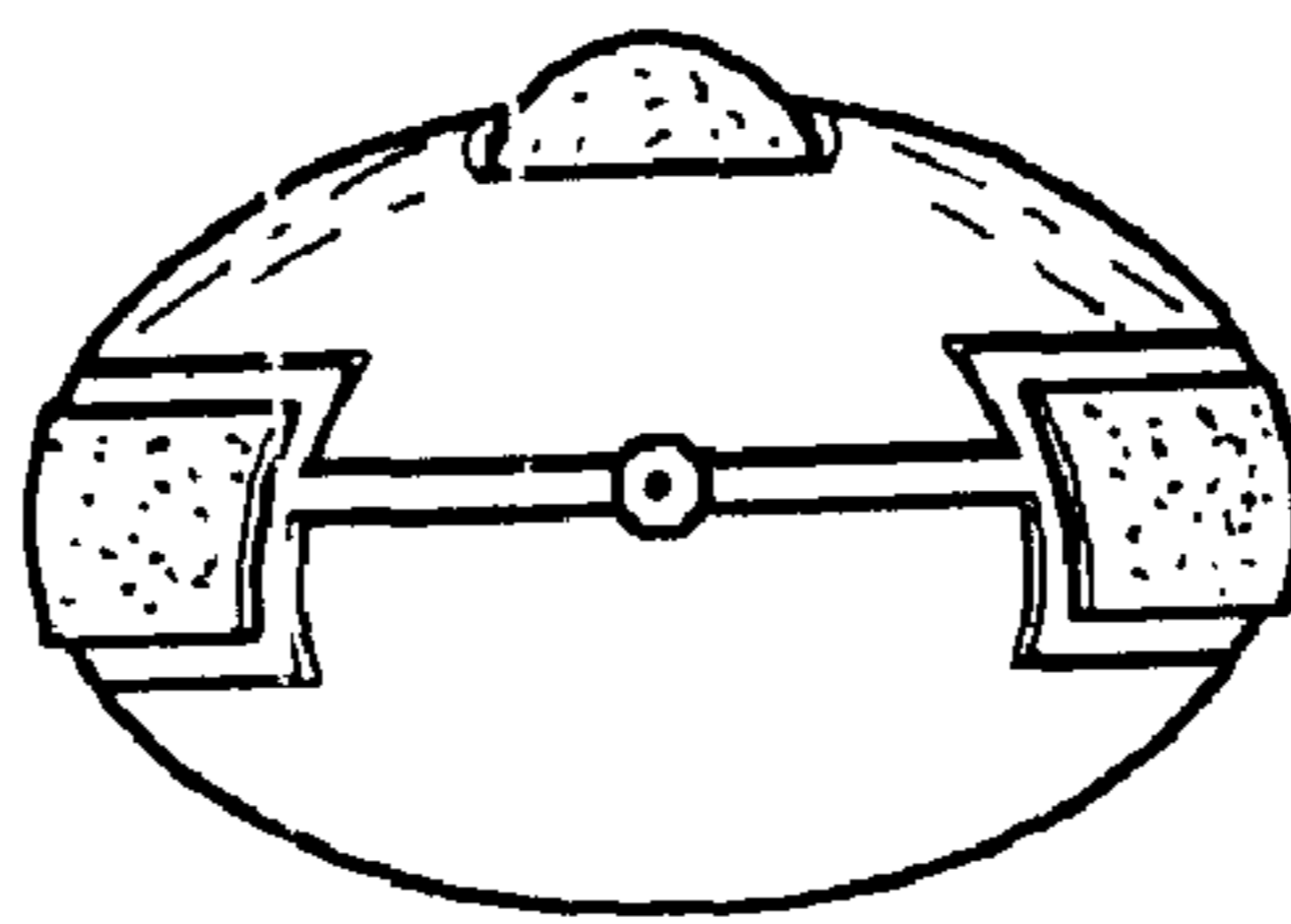

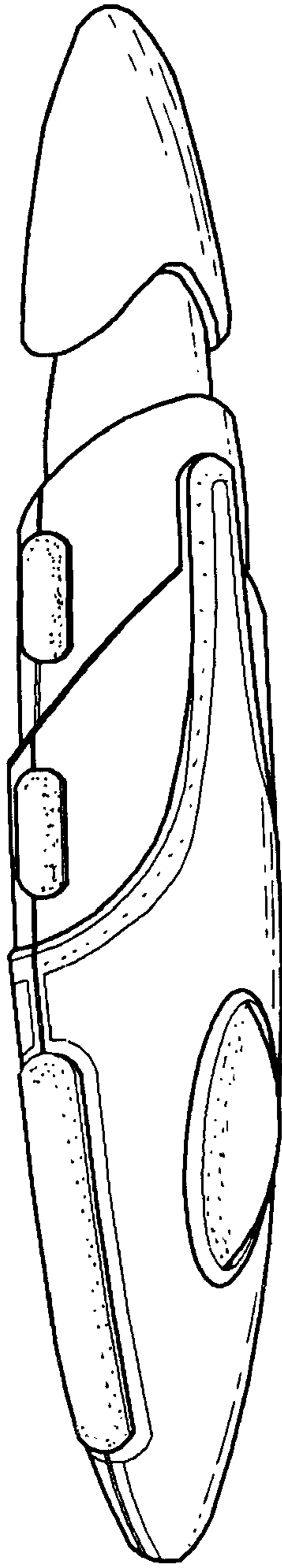

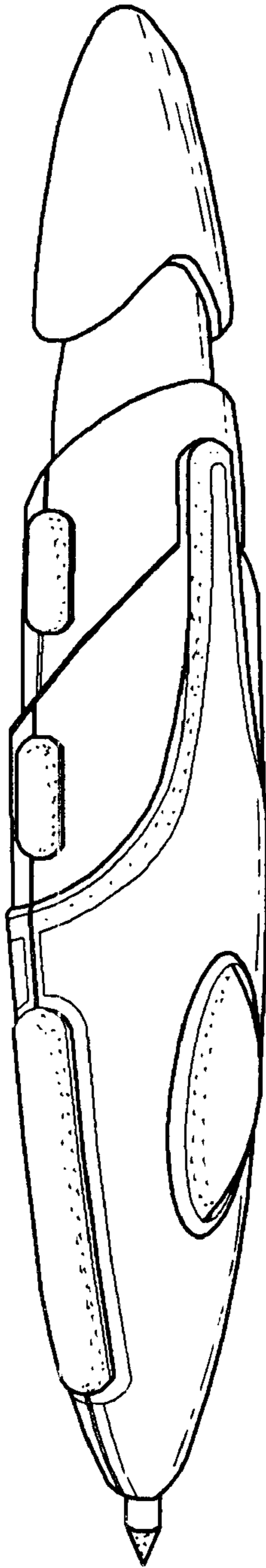
