FIG. 3 is a top plan view of a sofa according to an embodiment of the invention; and,

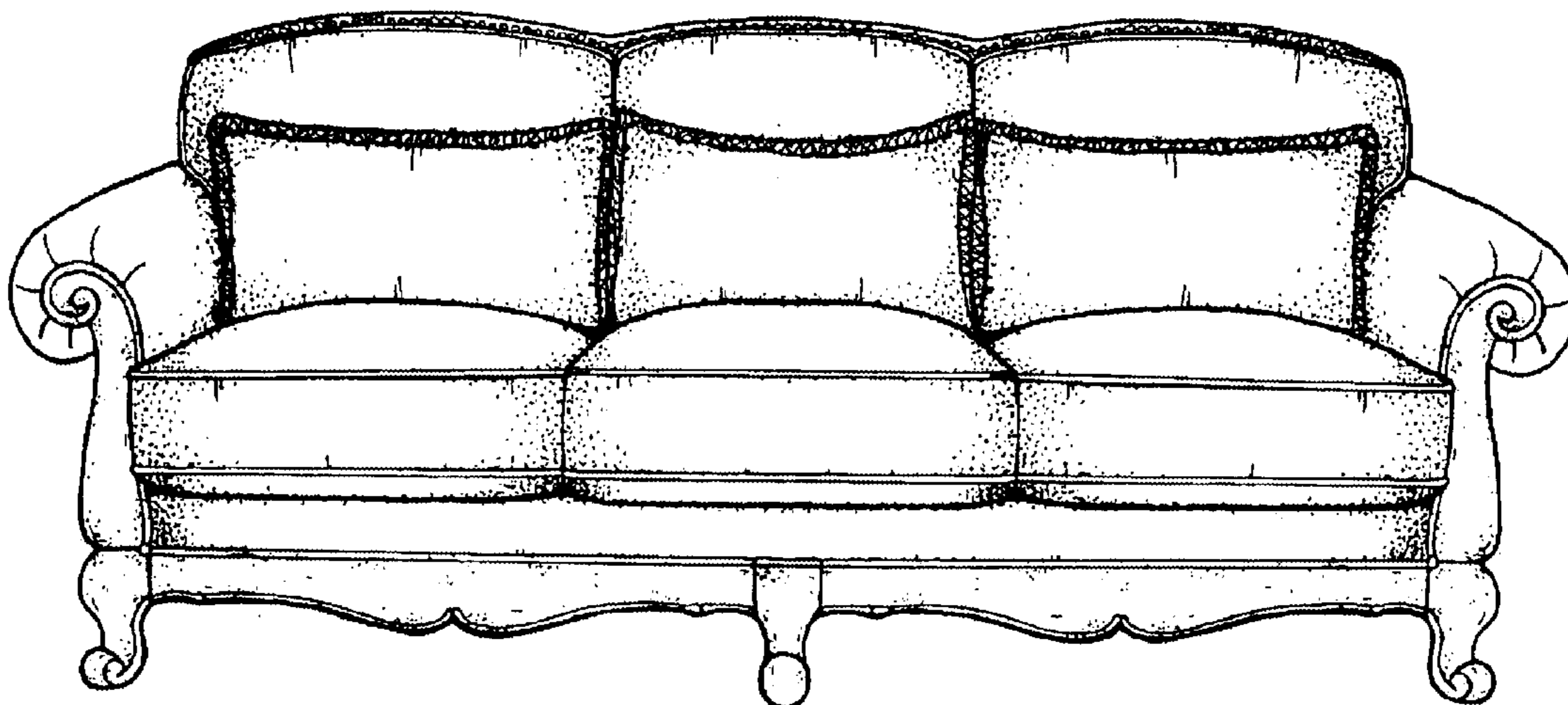
FIG. 4 is a perspective view of a sofa according to an embodiment of the invention.

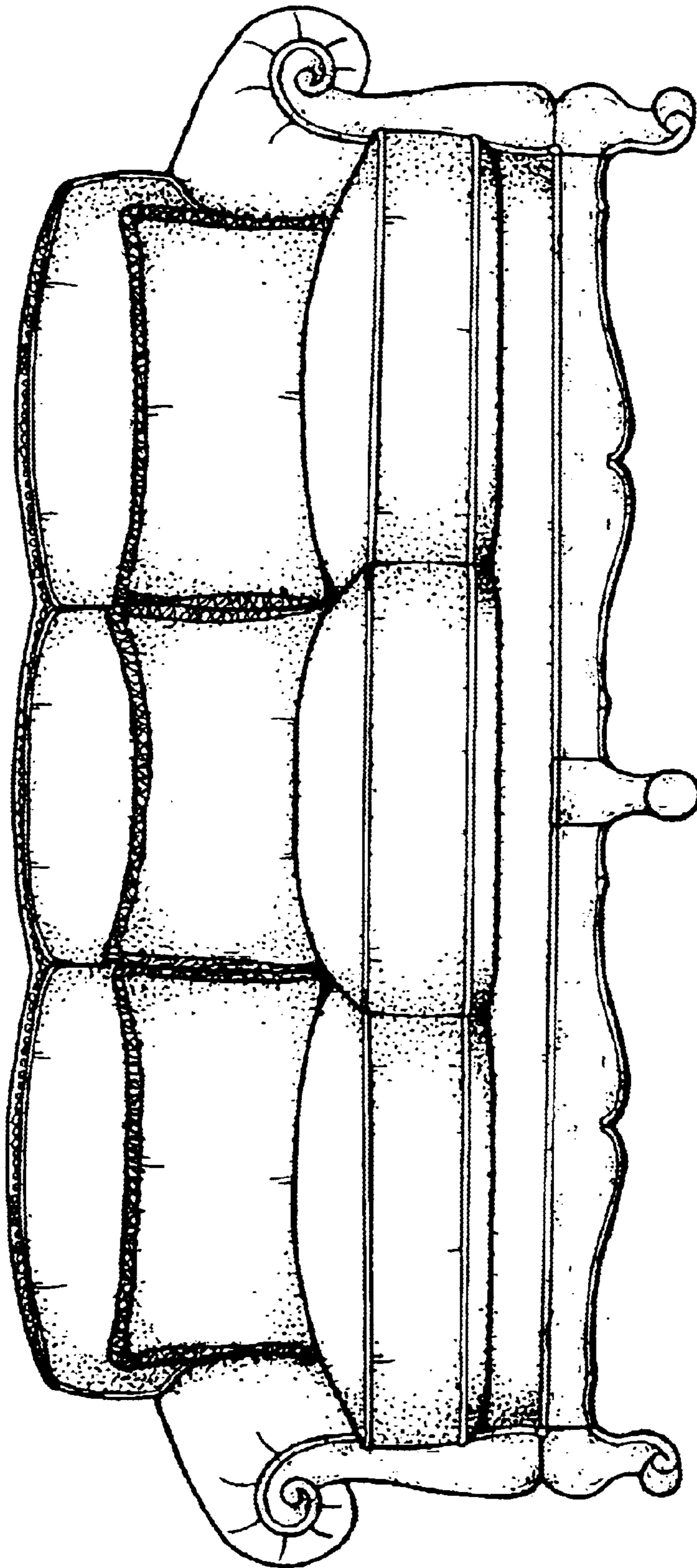

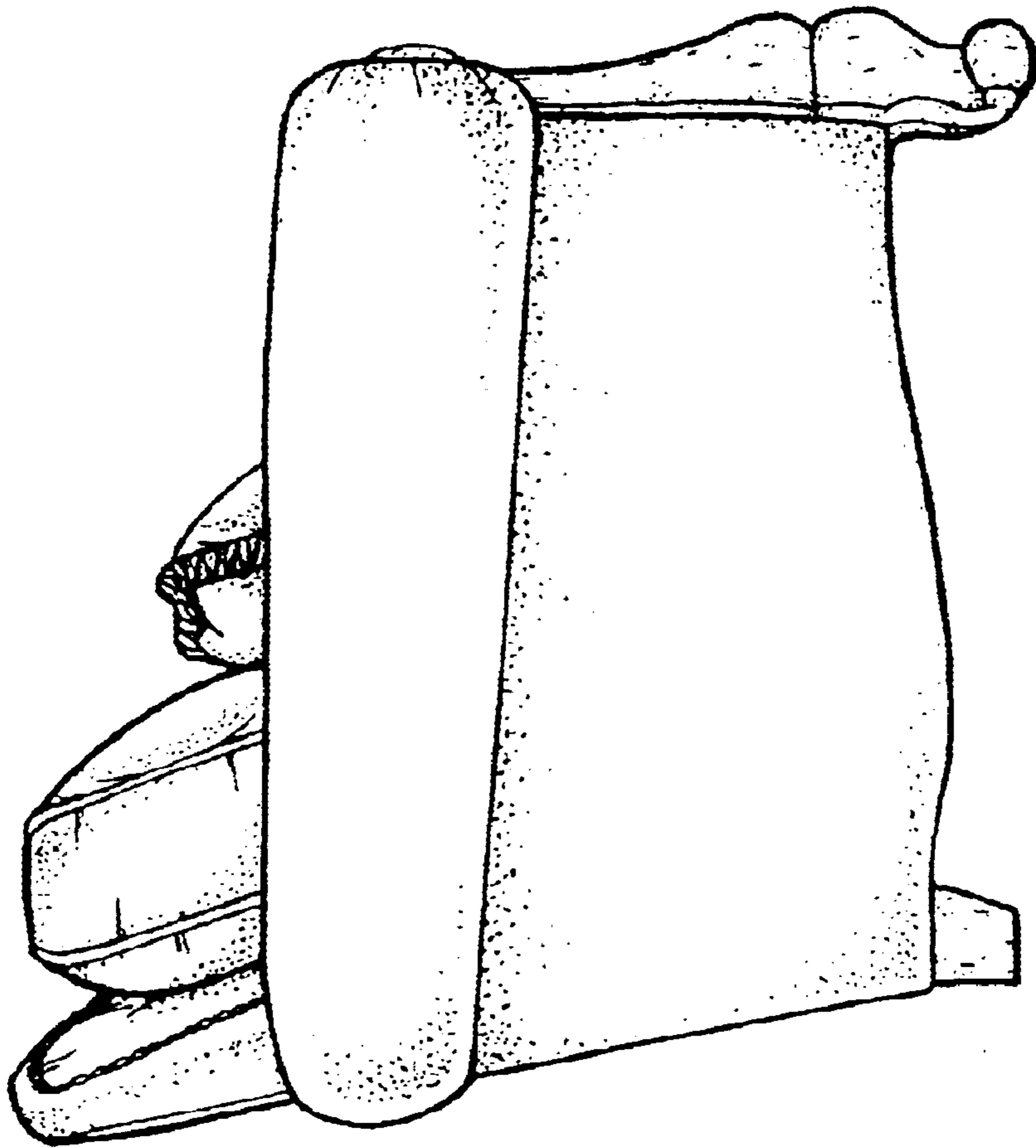

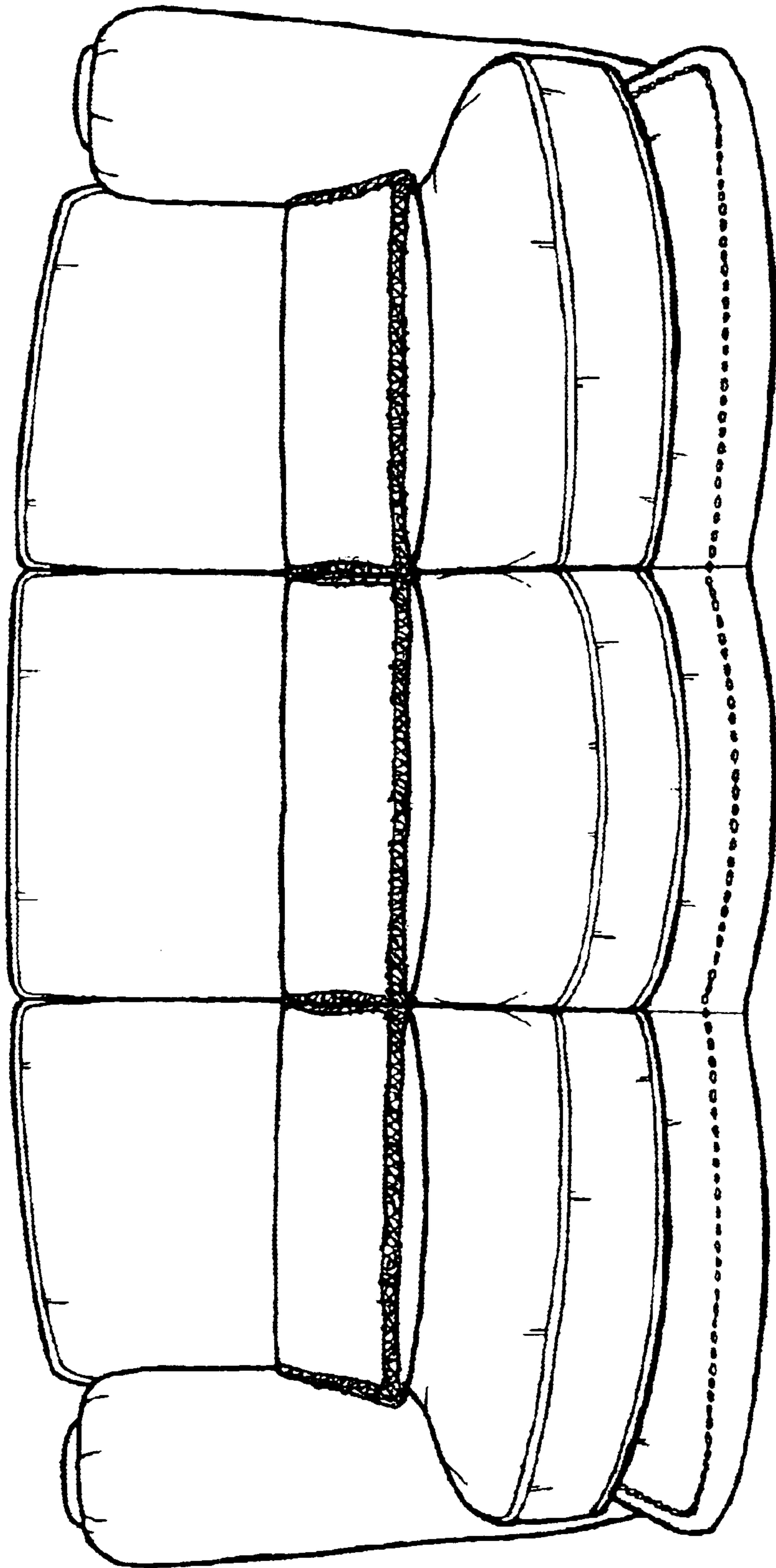

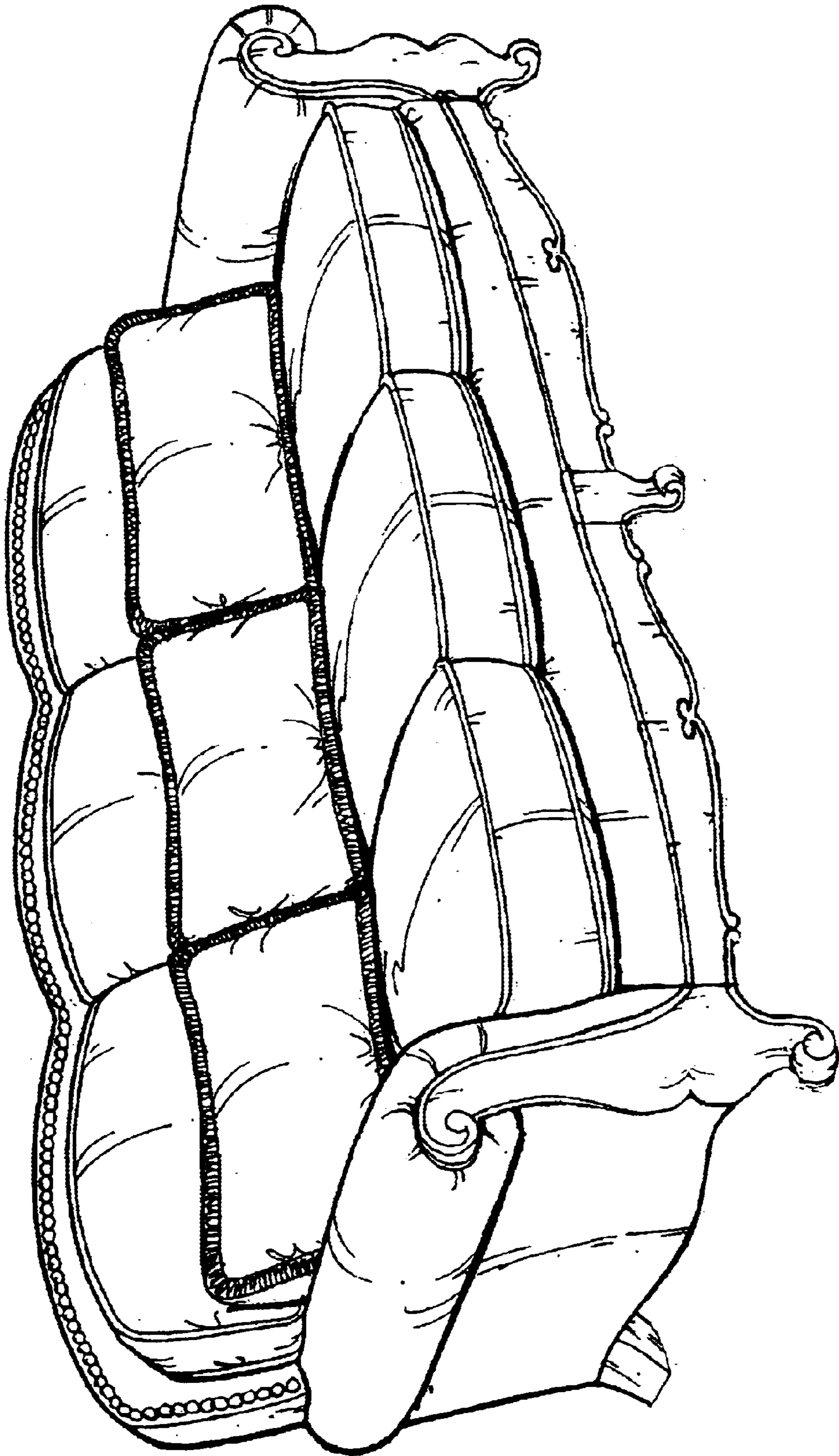
