(57) **CLAIM**

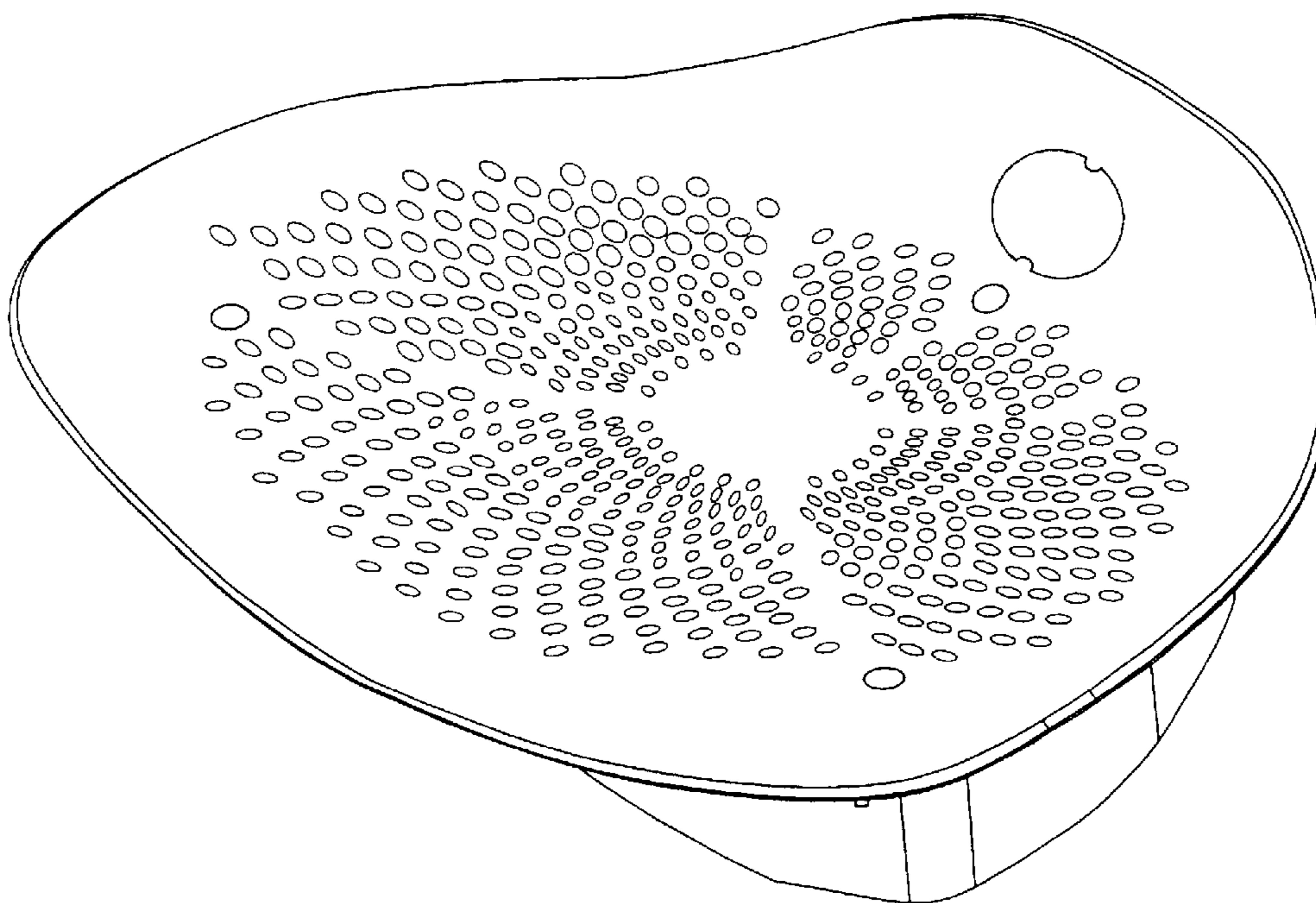
The ornamental design for a seat, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a seat of the present invention, having holes in the seat.
 FIG. 2 is a rear perspective view of the seat of FIG. 1.
 FIG. 3 is a perspective view from the bottom of the seat of FIG. 1.
 FIG. 4 is a front elevational view of the seat of FIG. 1.
 FIG. 5 is a right side elevational view of the seat of FIG. 1 with the left side elevational view being a mirror image thereof.
 FIG. 6 is a top plan view of the seat of FIG. 1; and,
 FIG. 7 is a bottom plan view of the seat of FIG. 1.

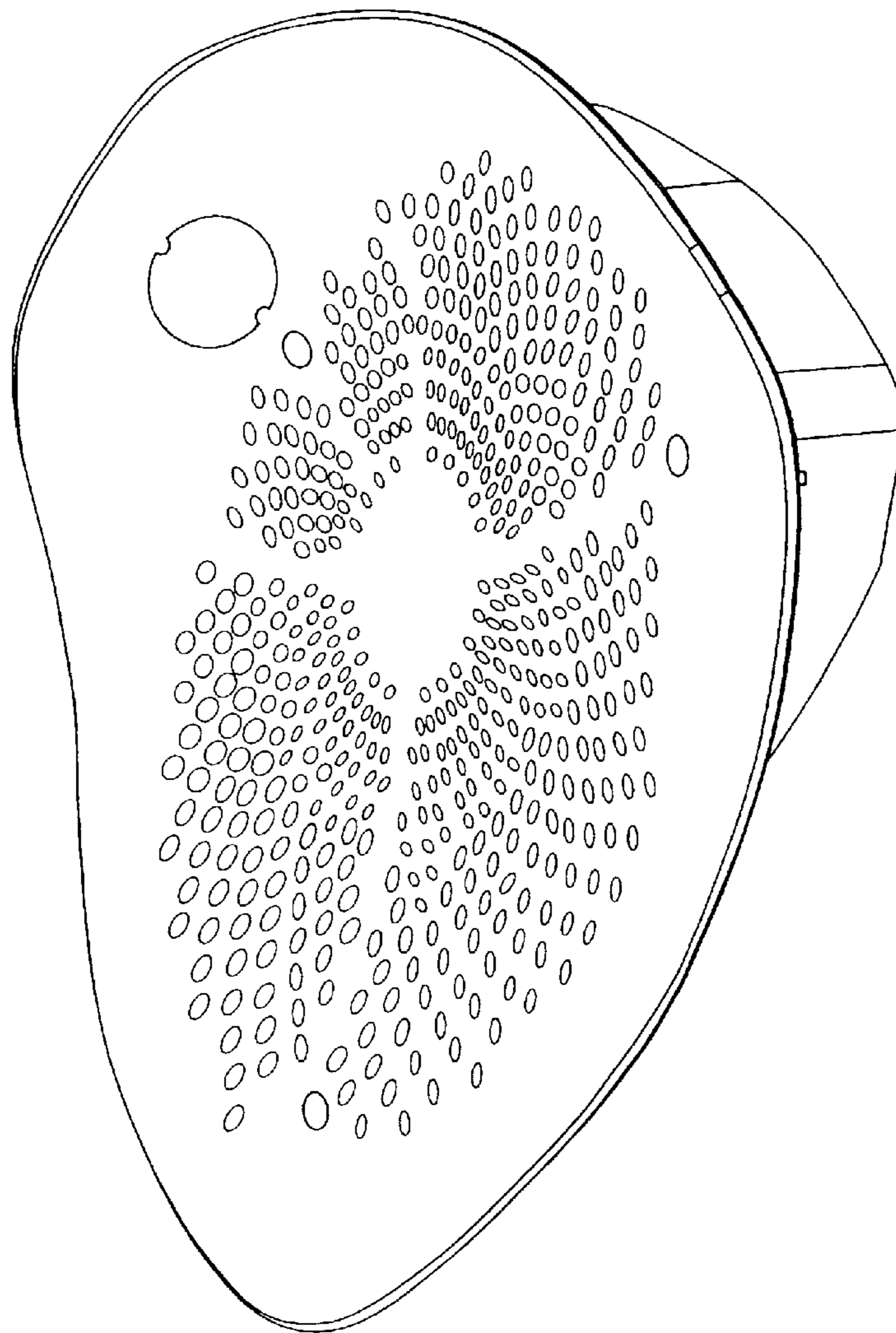

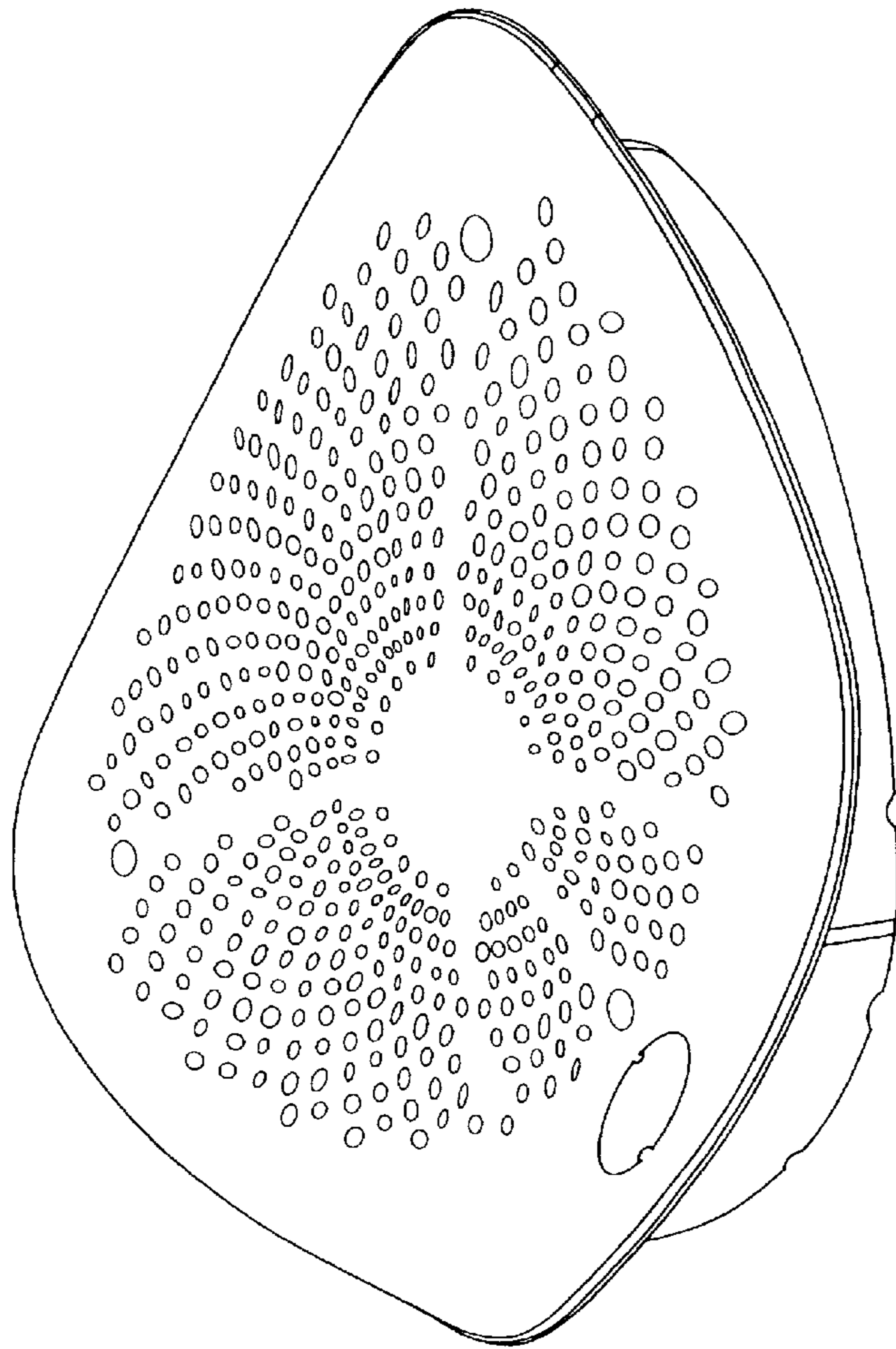
FRONT PERSPECTIVE VIEW

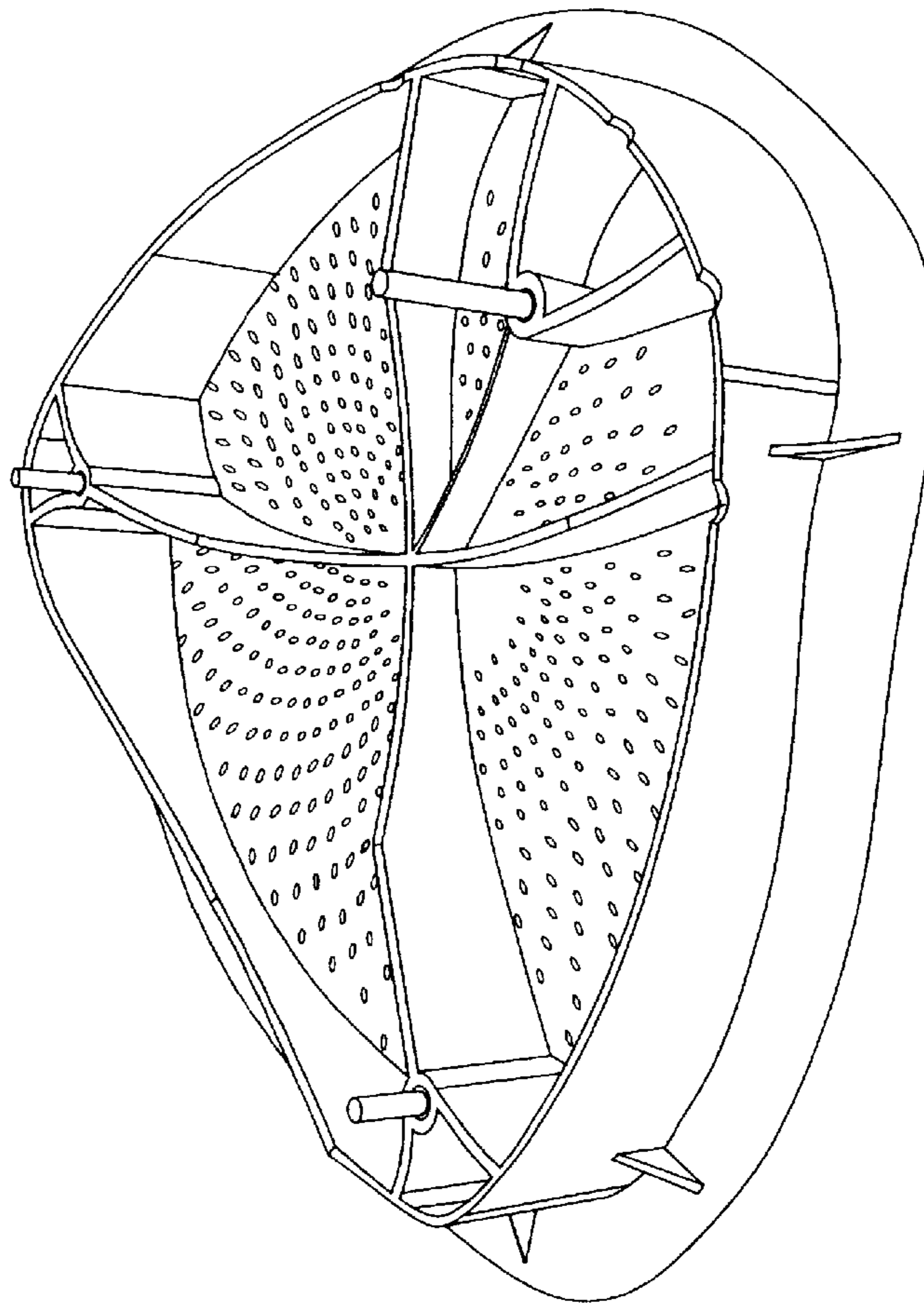
FRONT PERSPECTIVE VIEW

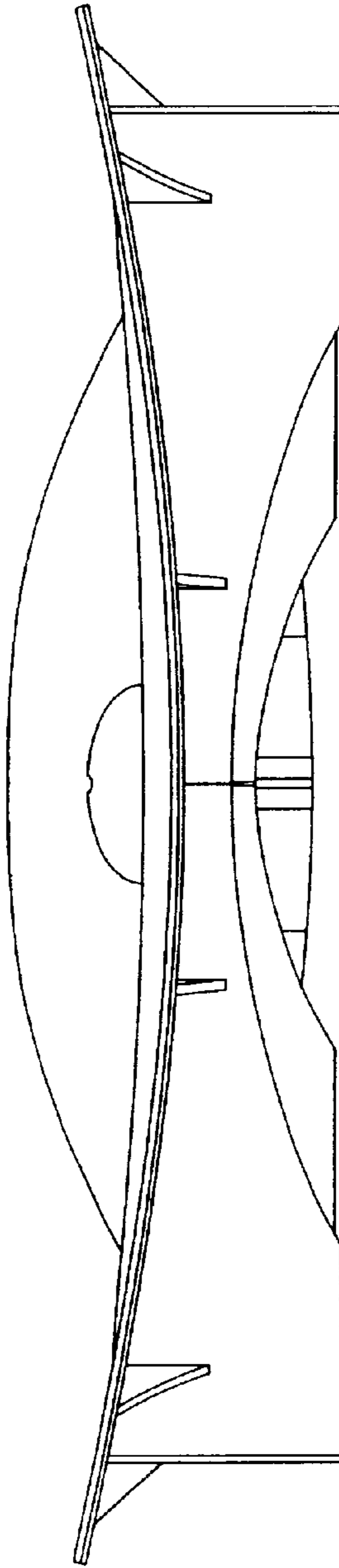
REAR PERSPECTIVE VIEW

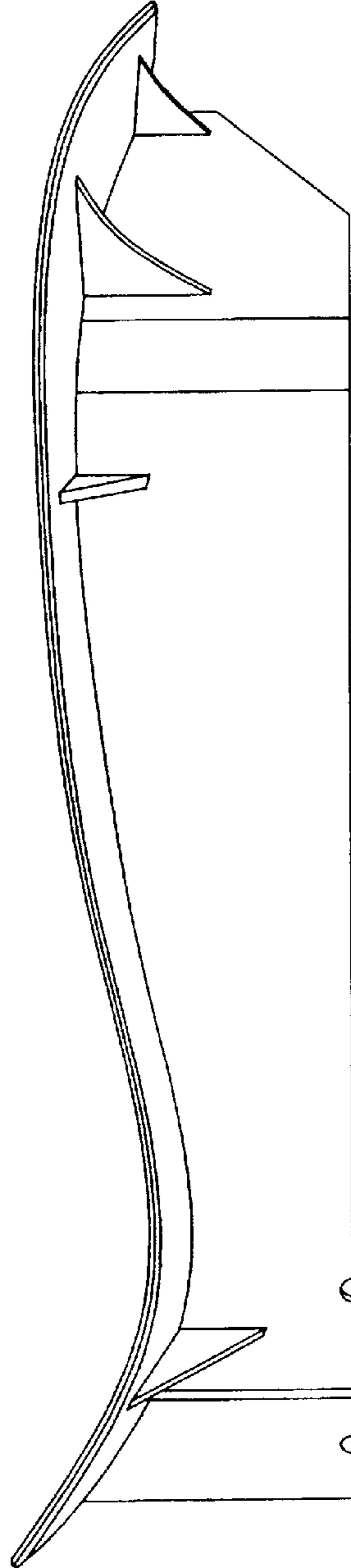
PERSPECTIVE VIEW FROM BOTTOM

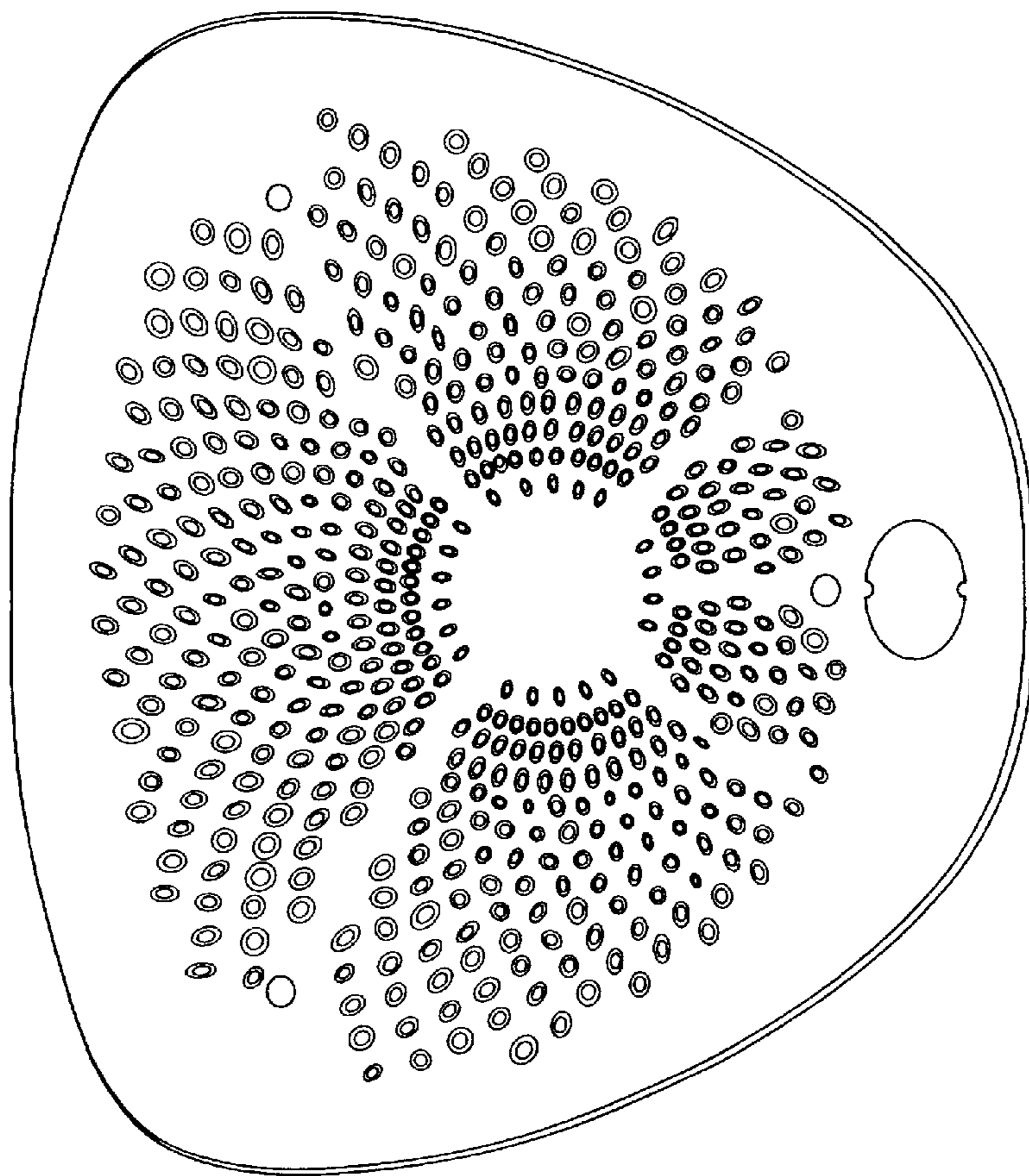
SIDE VIEW FROM FRONT

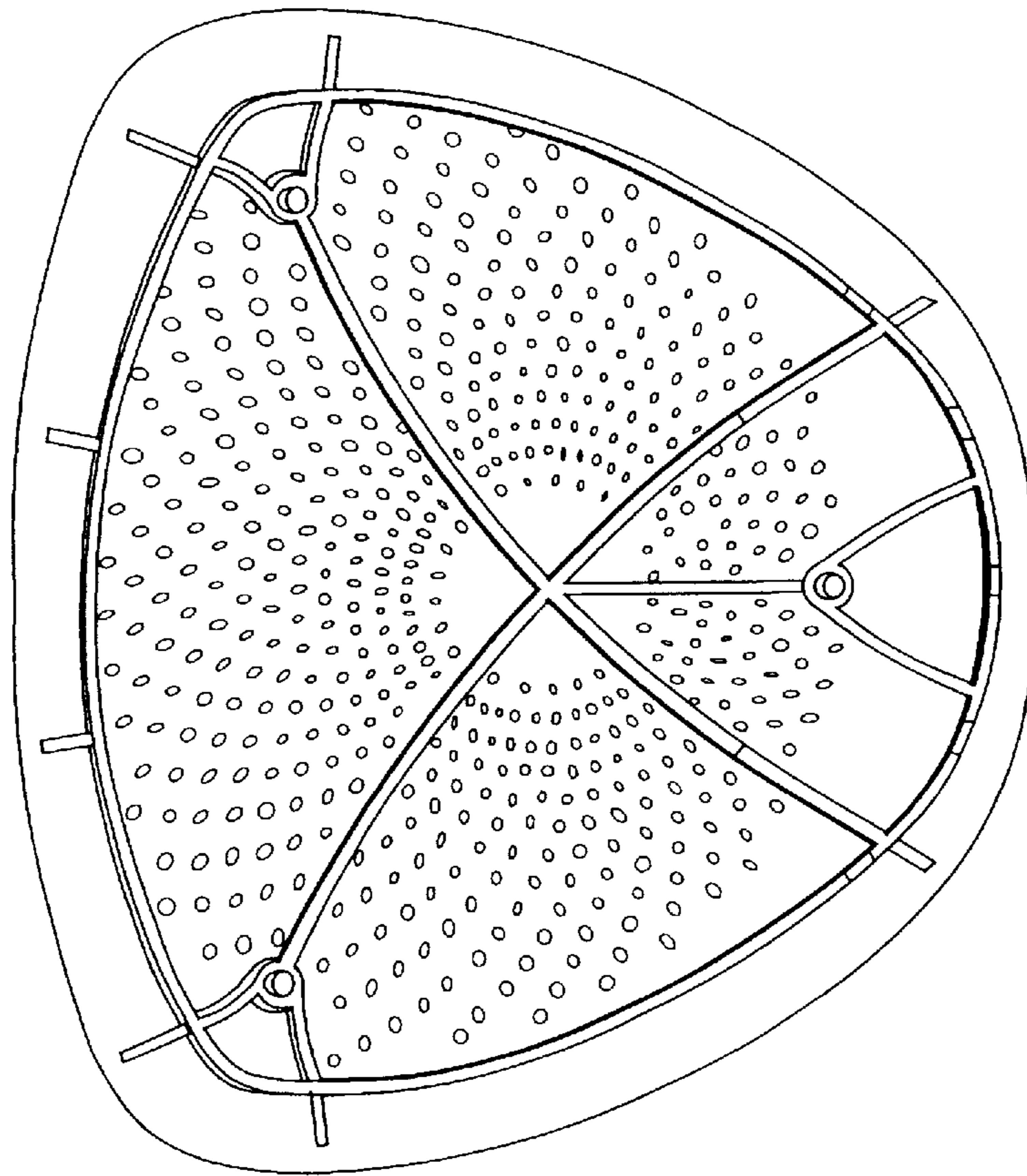
PERSPECTIVE SIDE VIEW
