(57) **CLAIM**

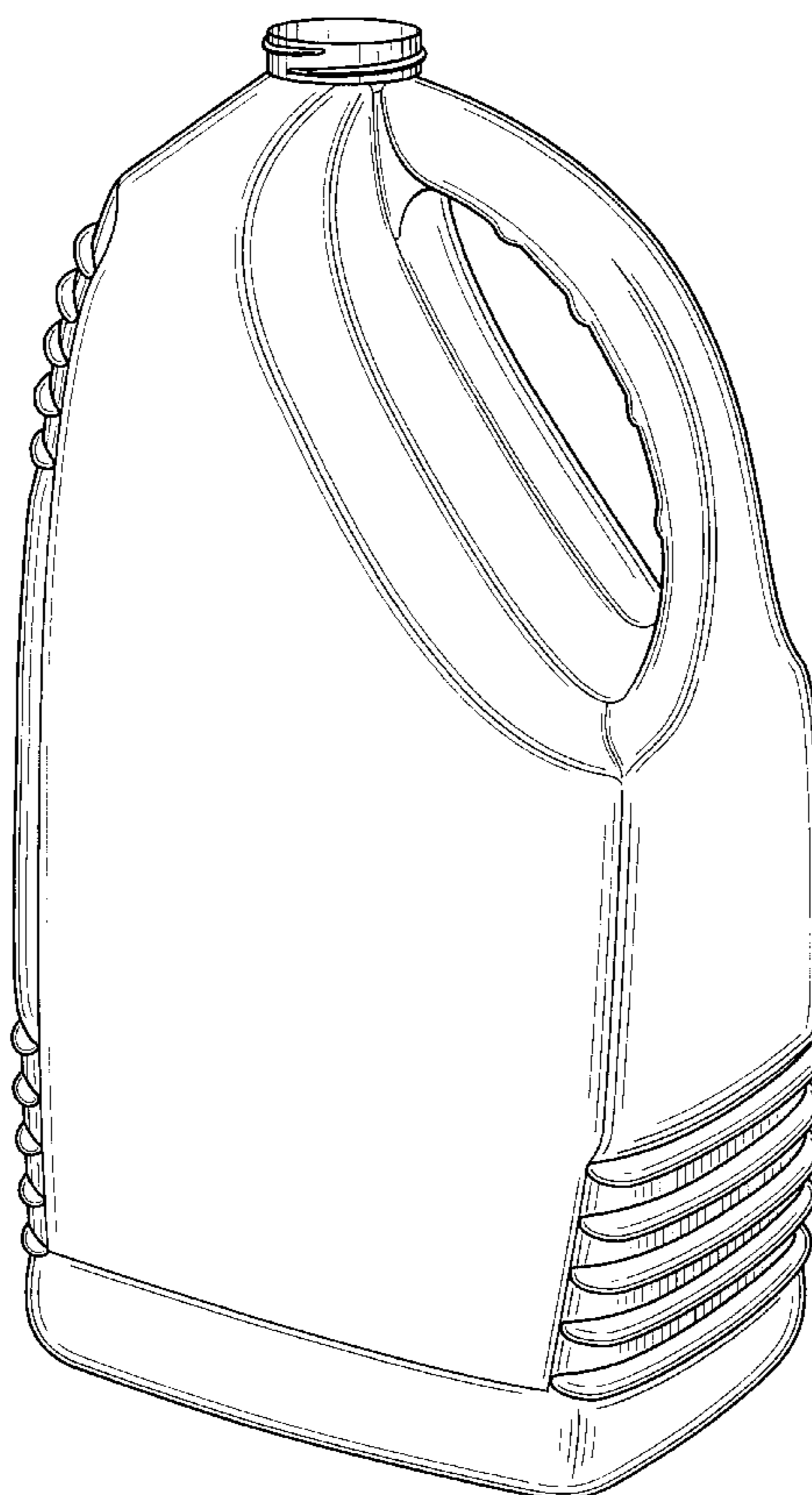
The ornamental design for a jug with ribbed sides, as shown and described.

DESCRIPTION

FIG. 1 is a front and right side perspective view of my new design;
FIG. 2 is a front elevational view thereof;

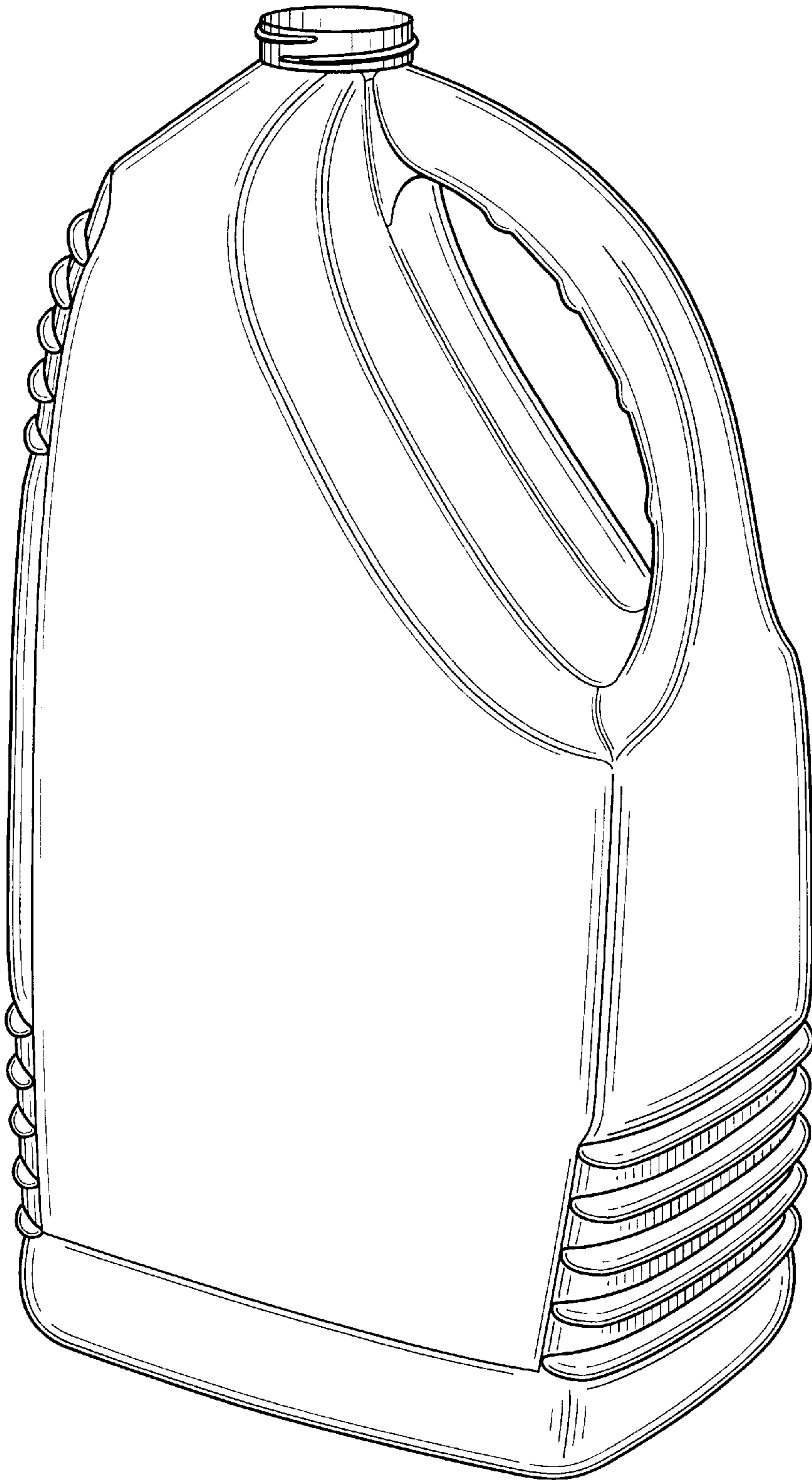

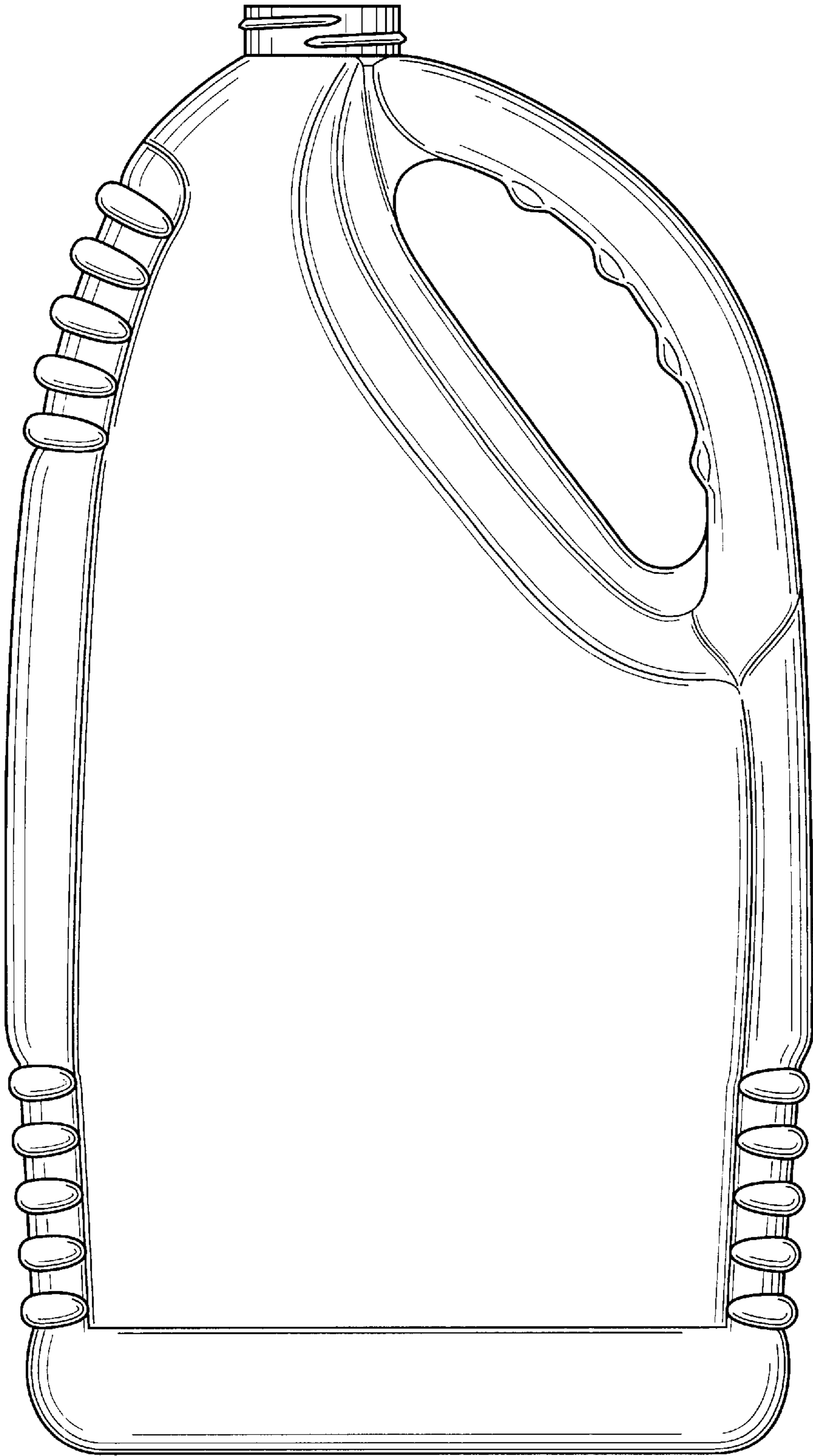

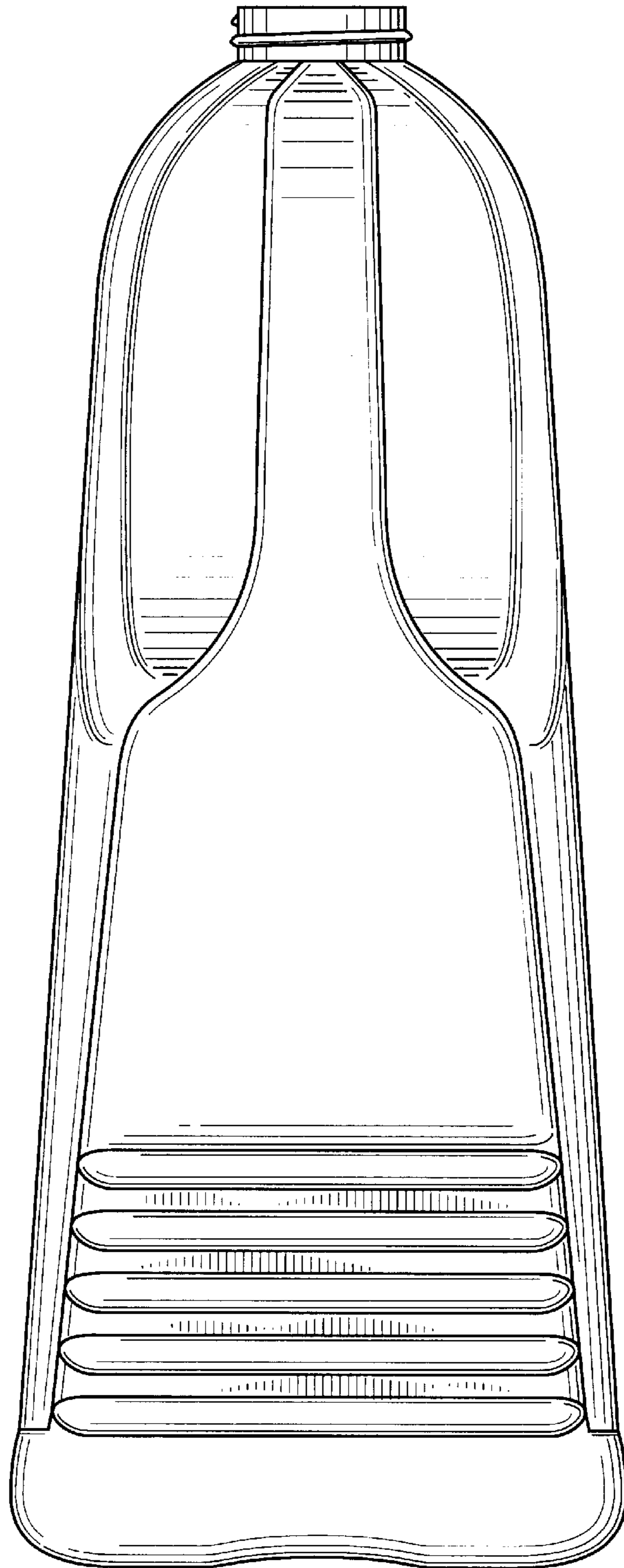

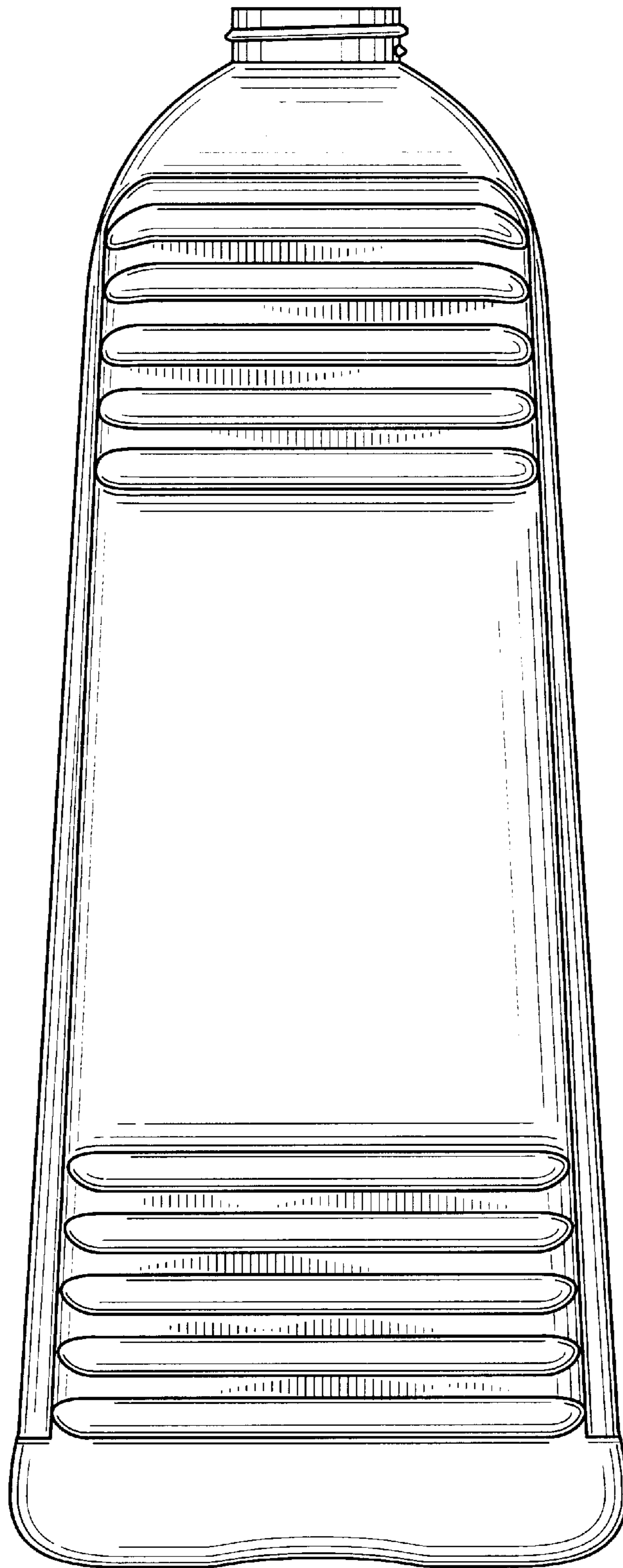

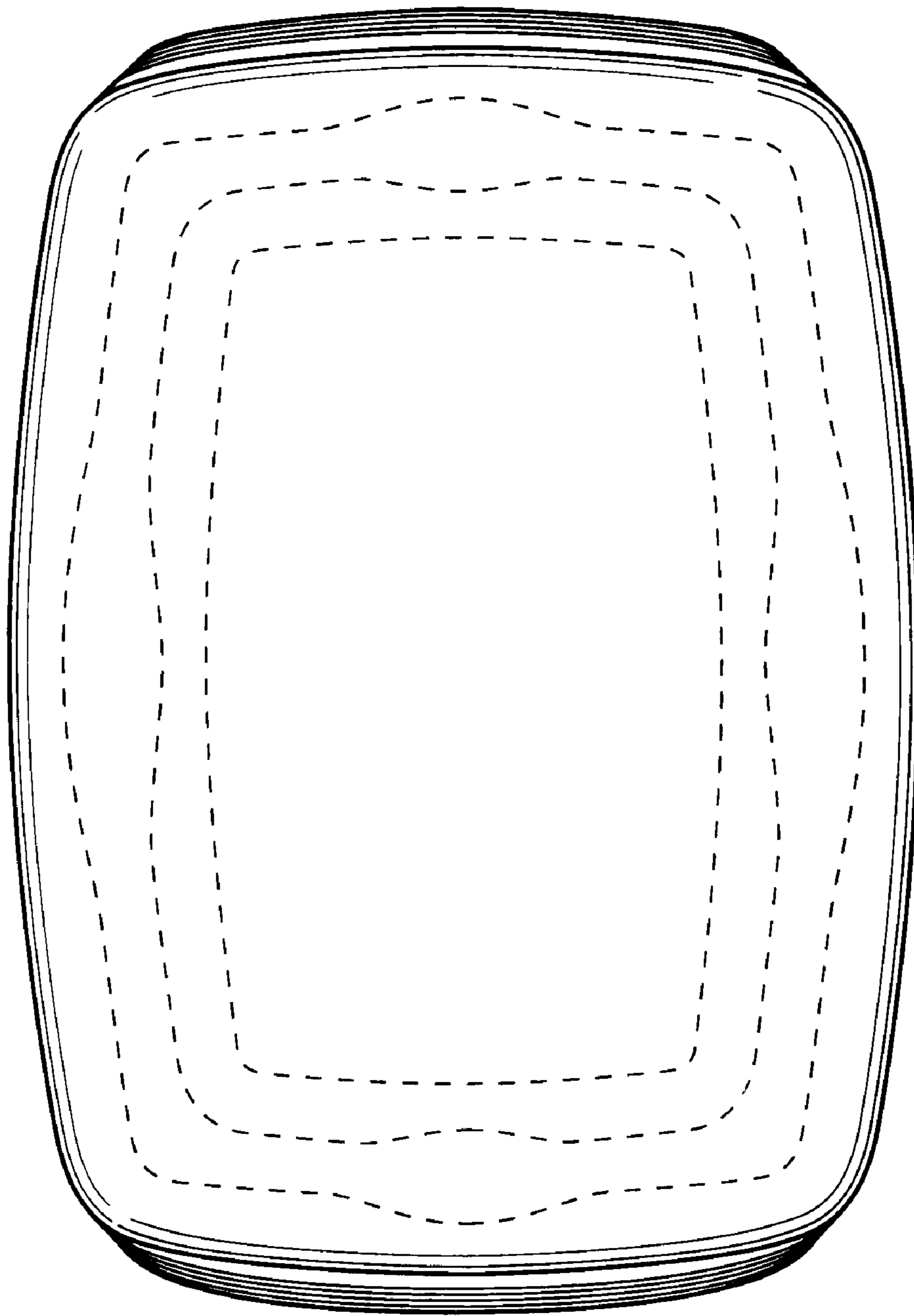
