(57) **CLAIM**

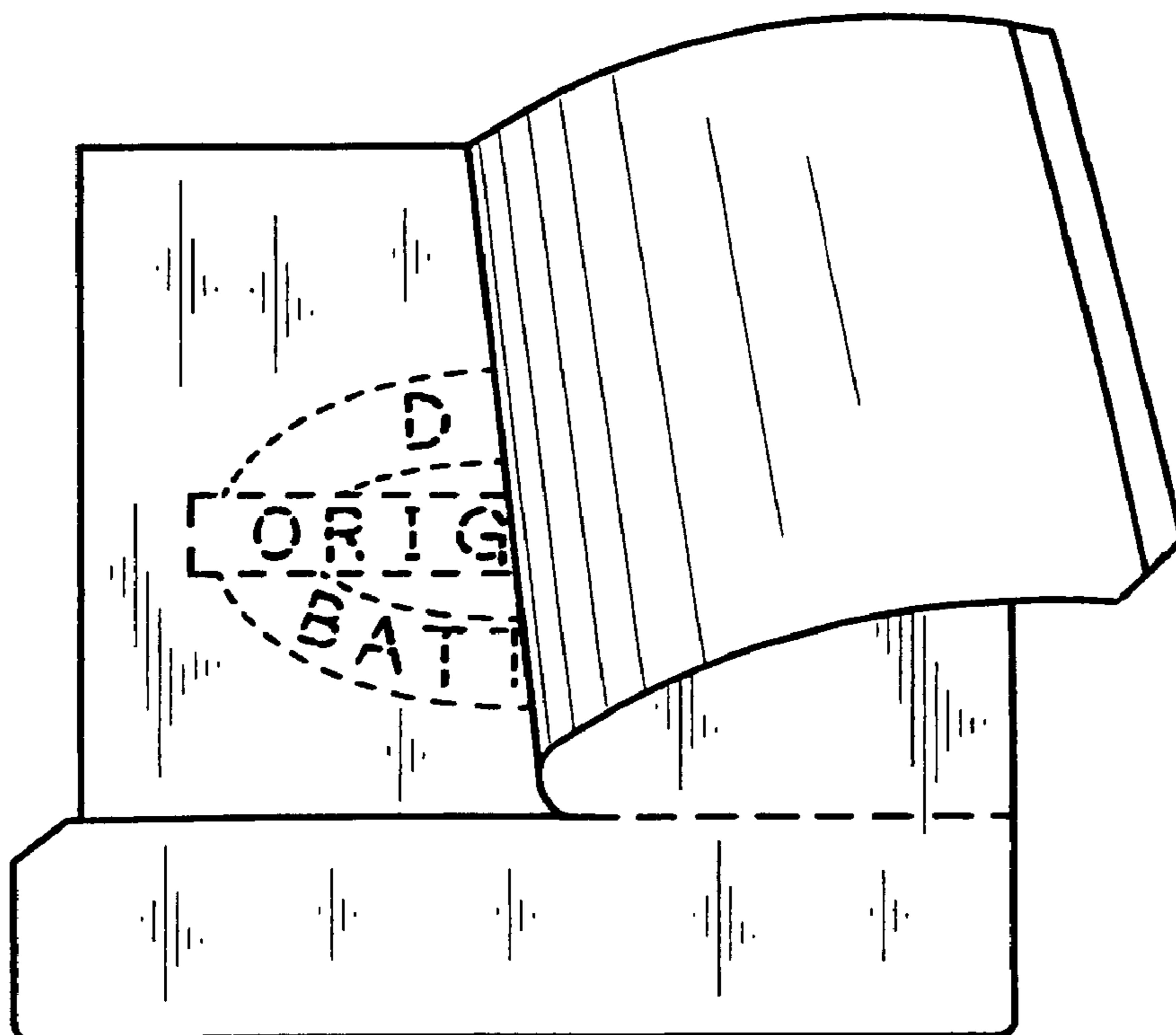
The ornamental design for a label, as shown and described.

**DESCRIPTION**

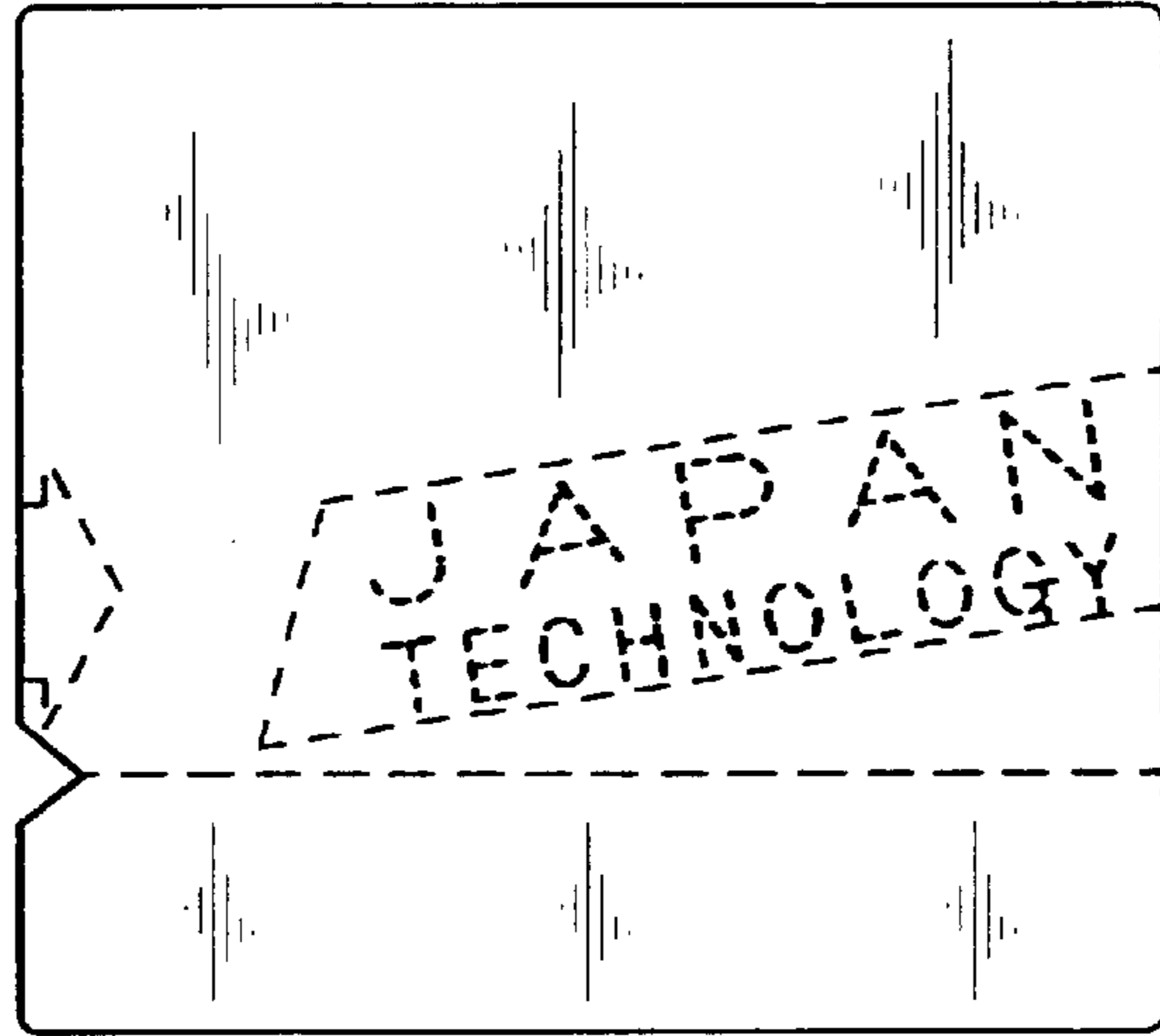

The elements shown in phantom lines do not form any part of the claimed design.

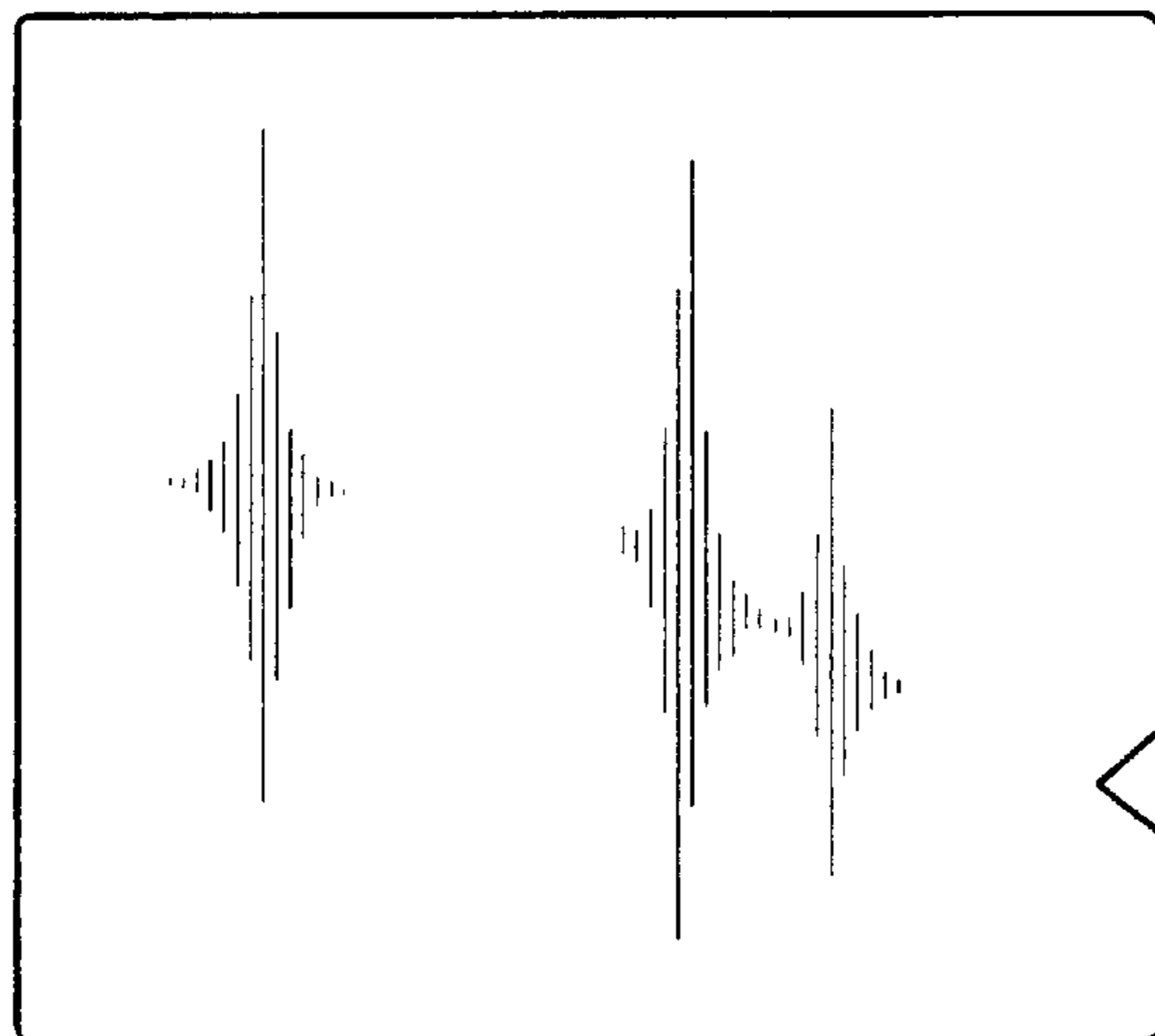

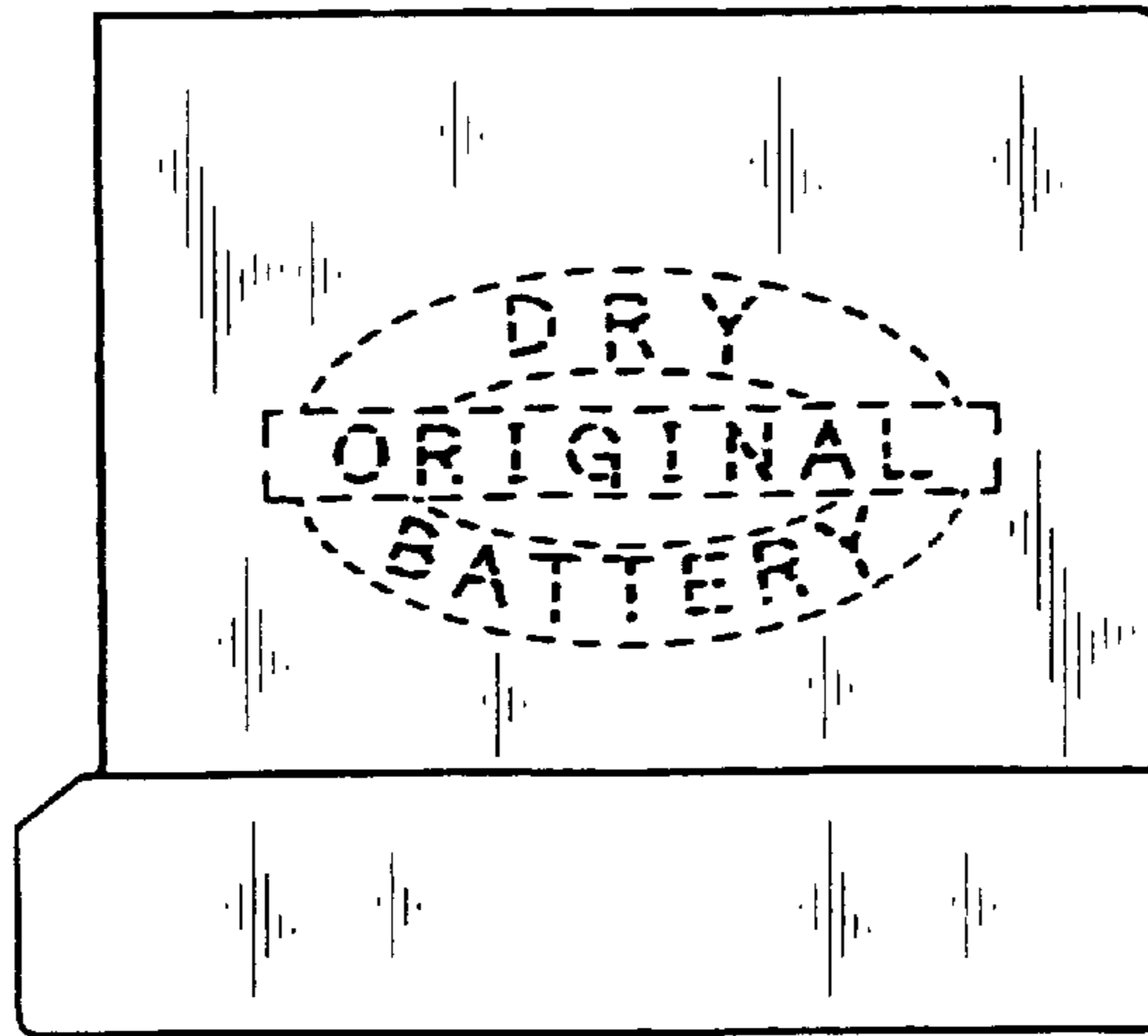
