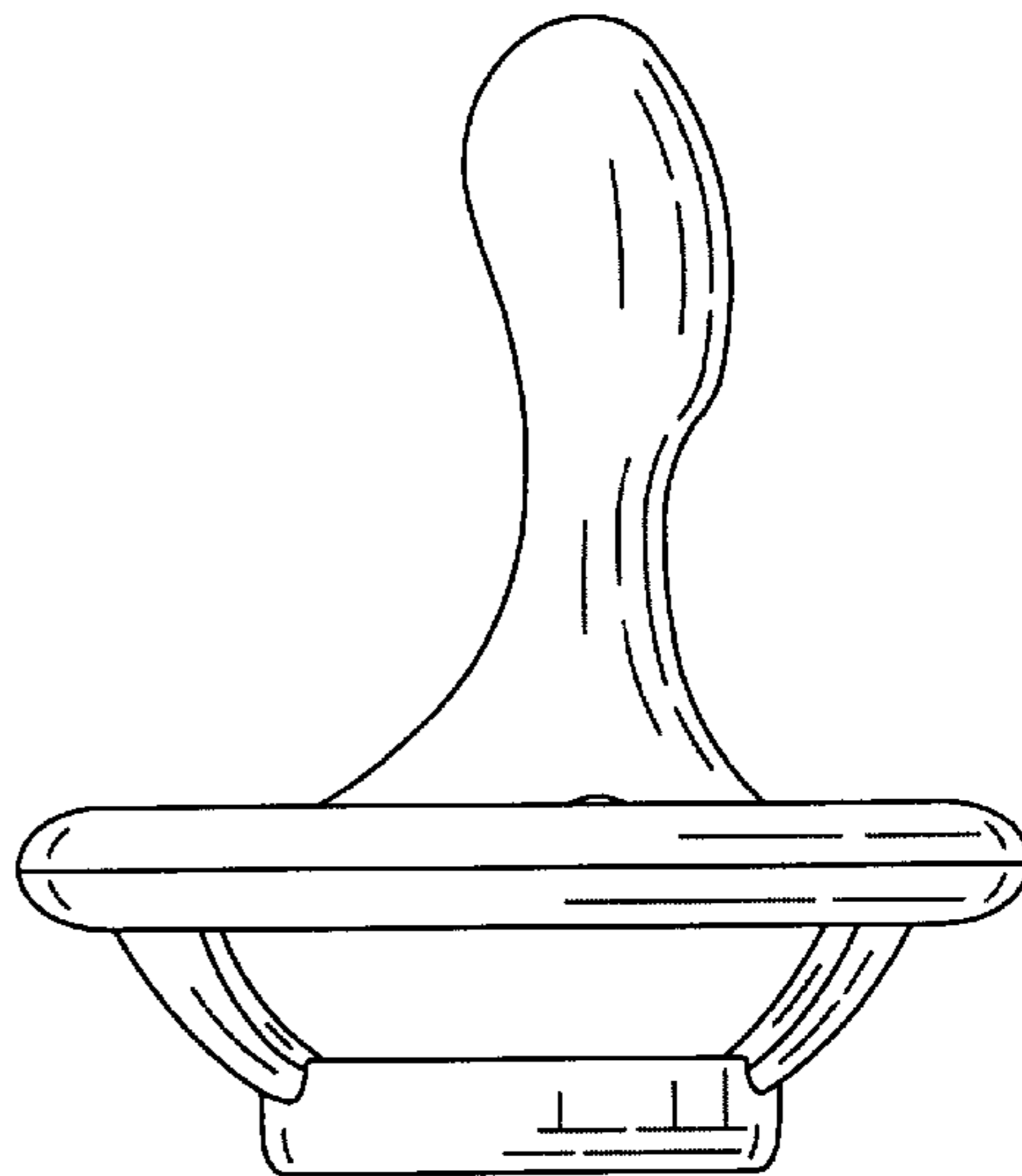
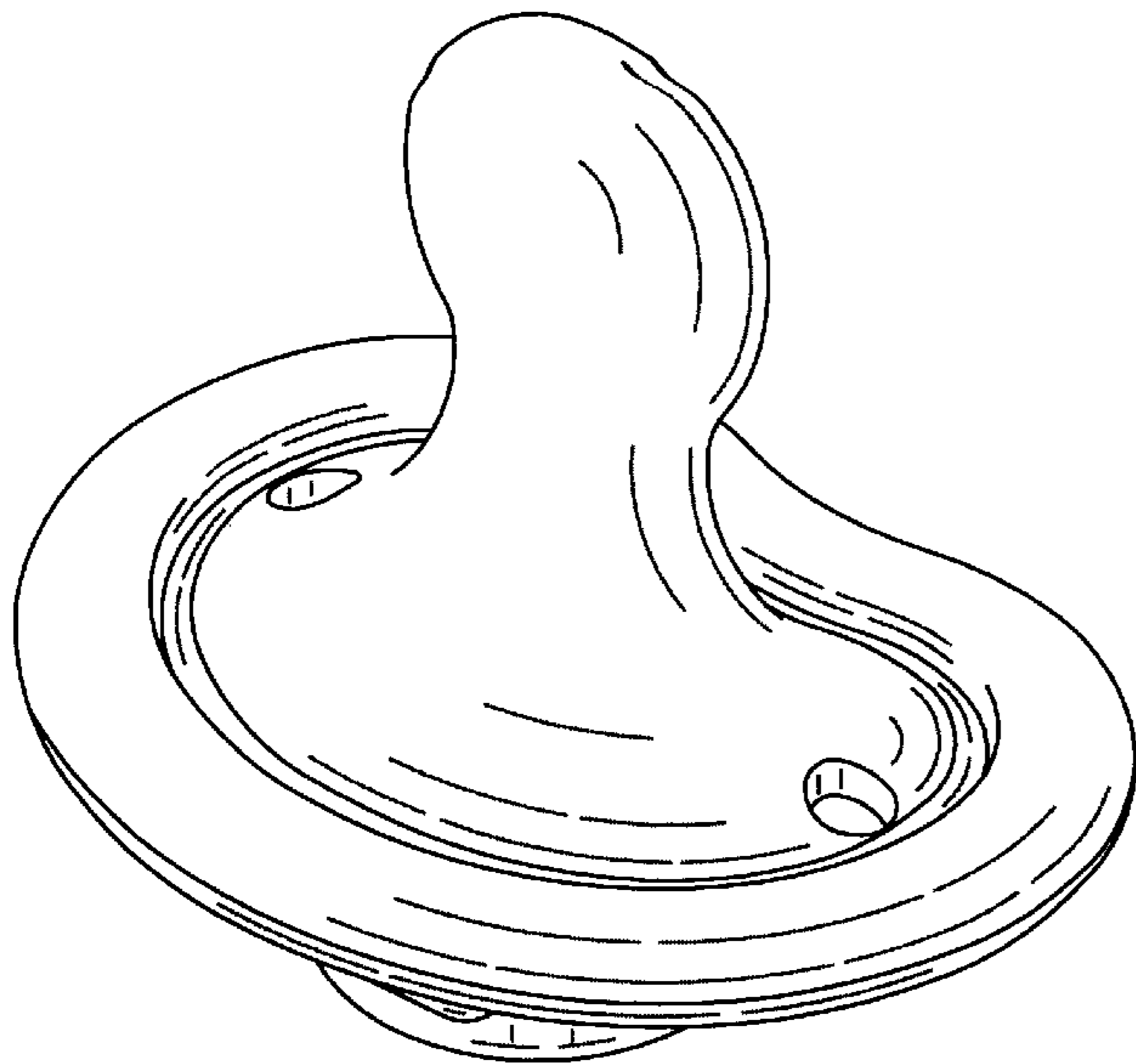

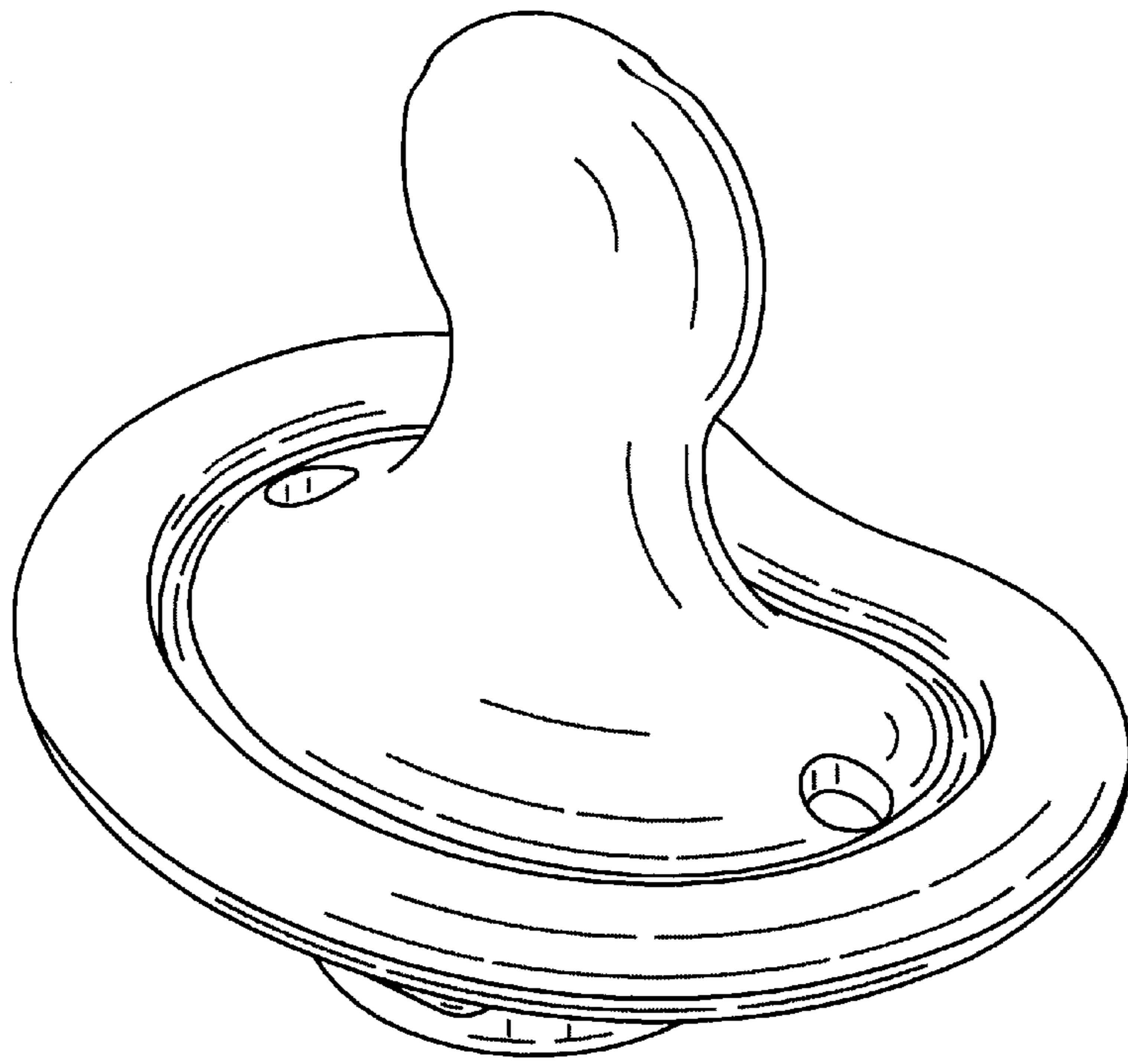
The ornamental design for an infant nipple, as shown and described.

**DESCRIPTION**

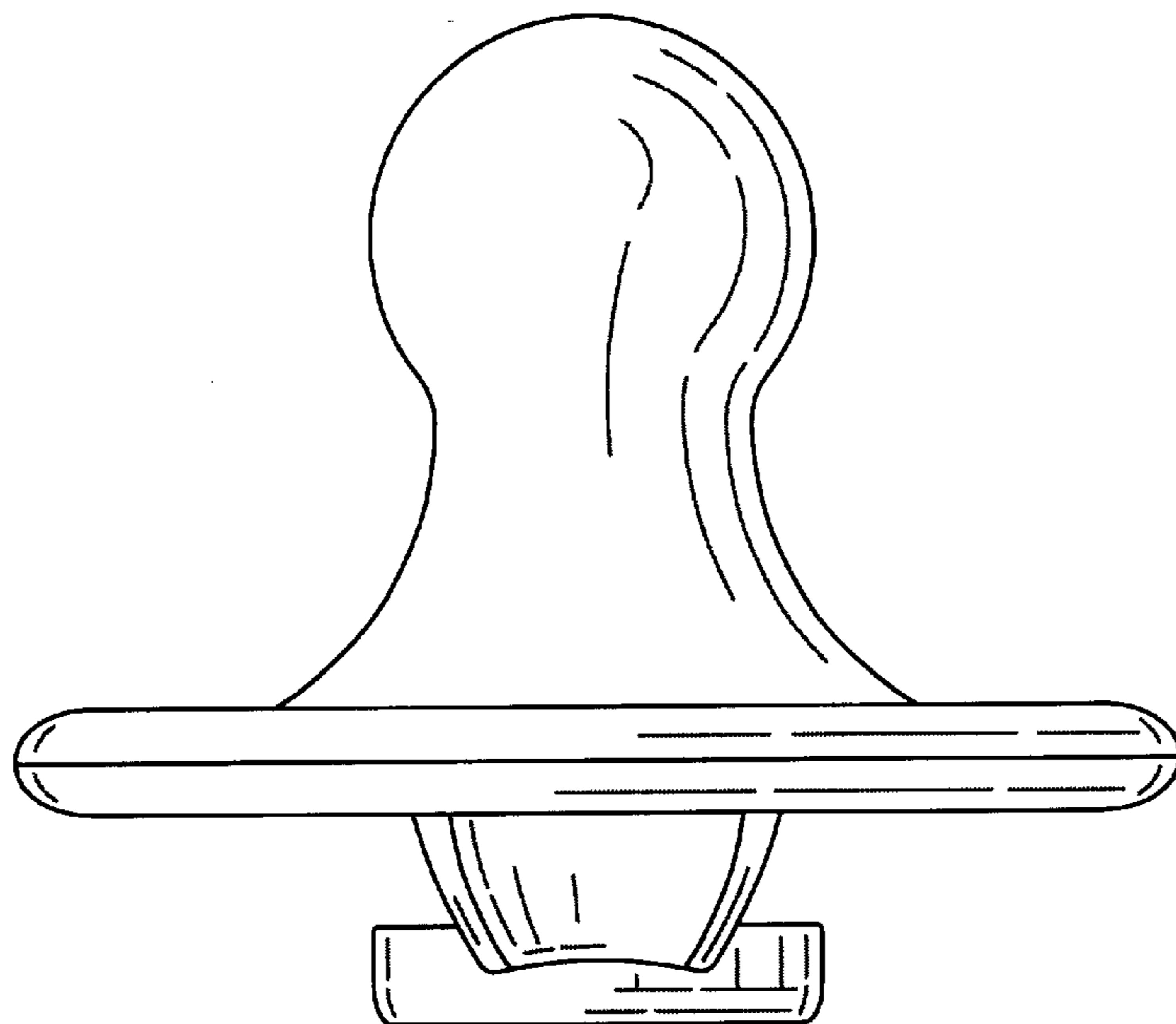
FIG. 1 is a top, side and front perspective view of an infant nipple, showing our new design;

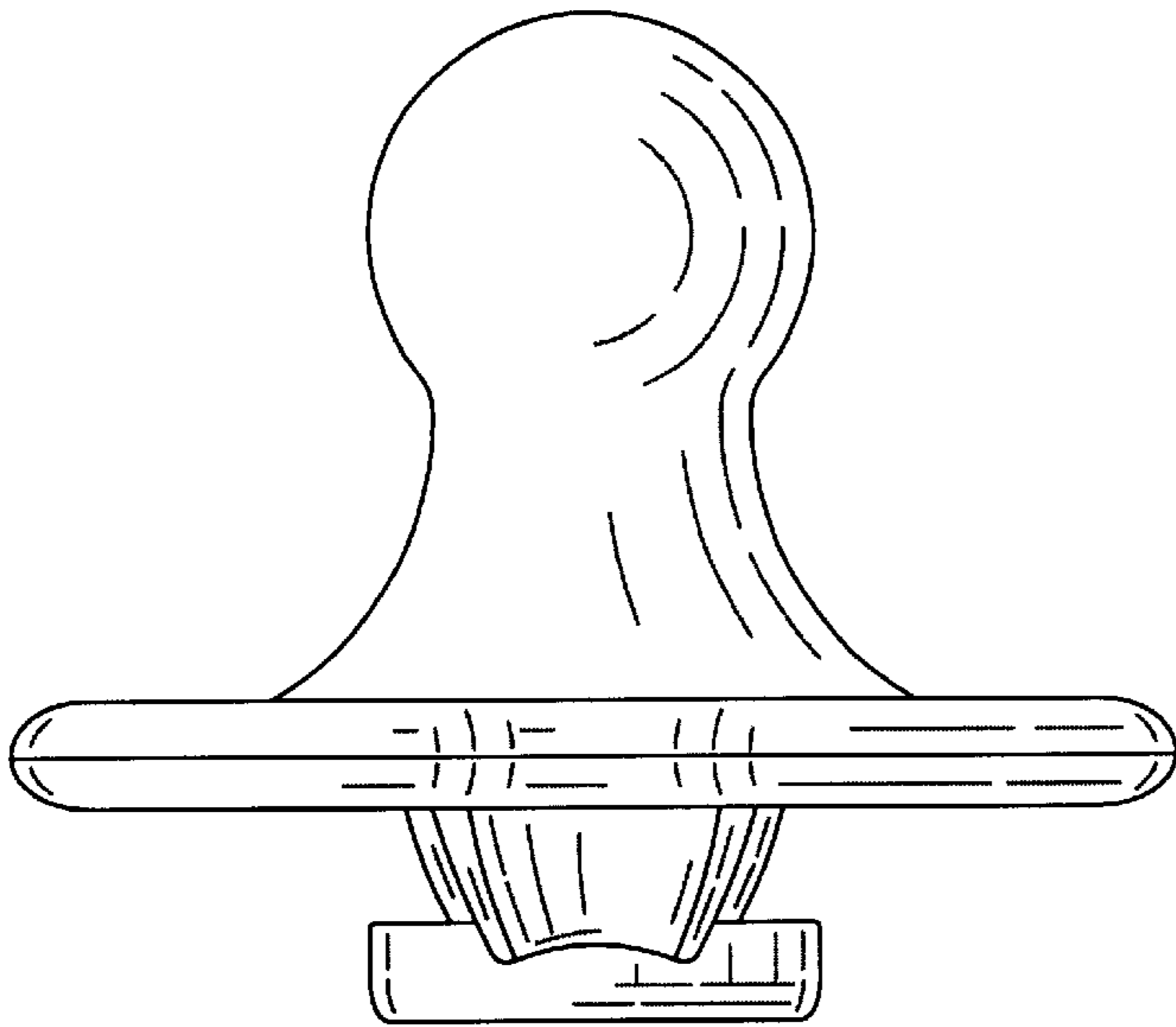

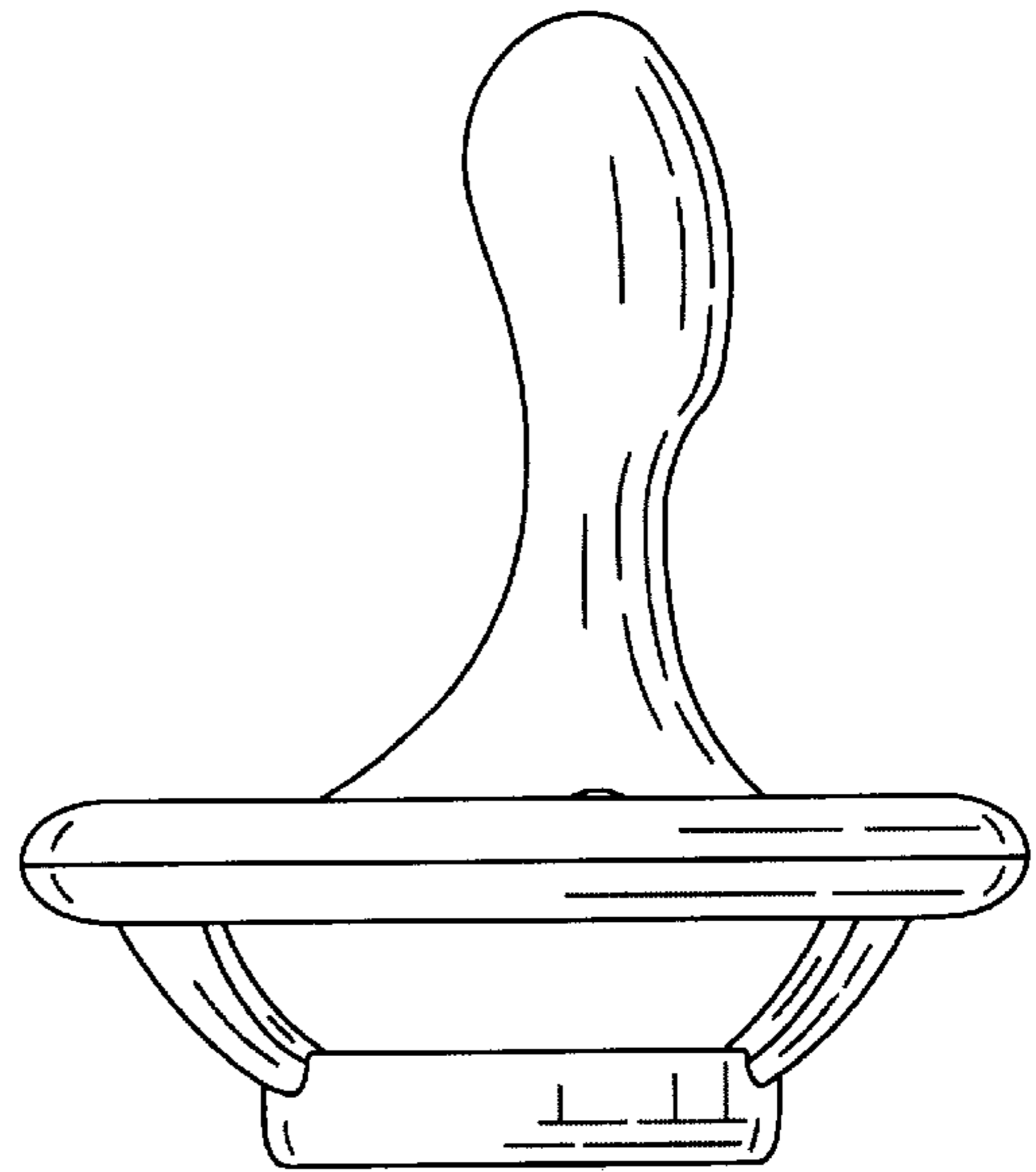

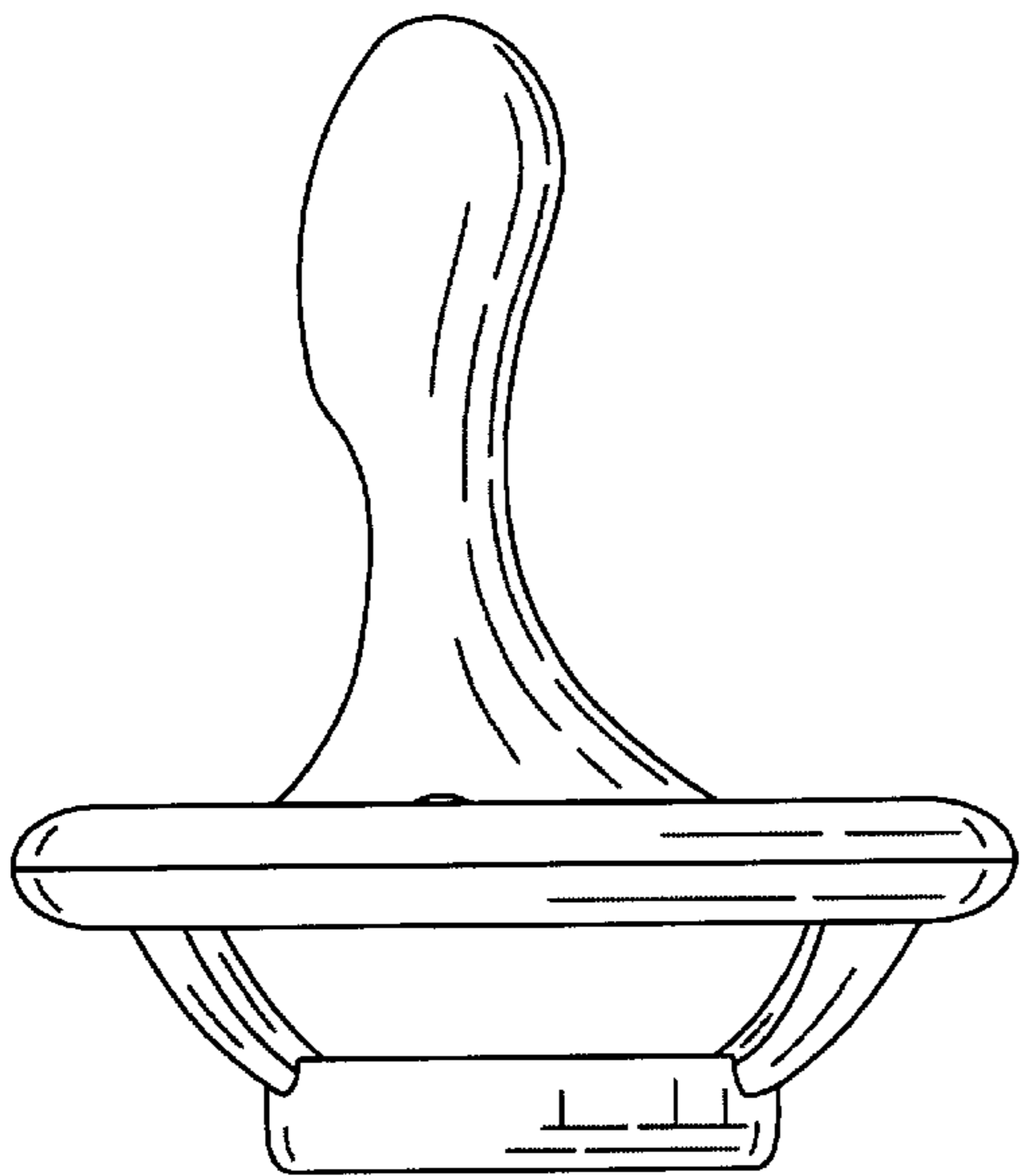

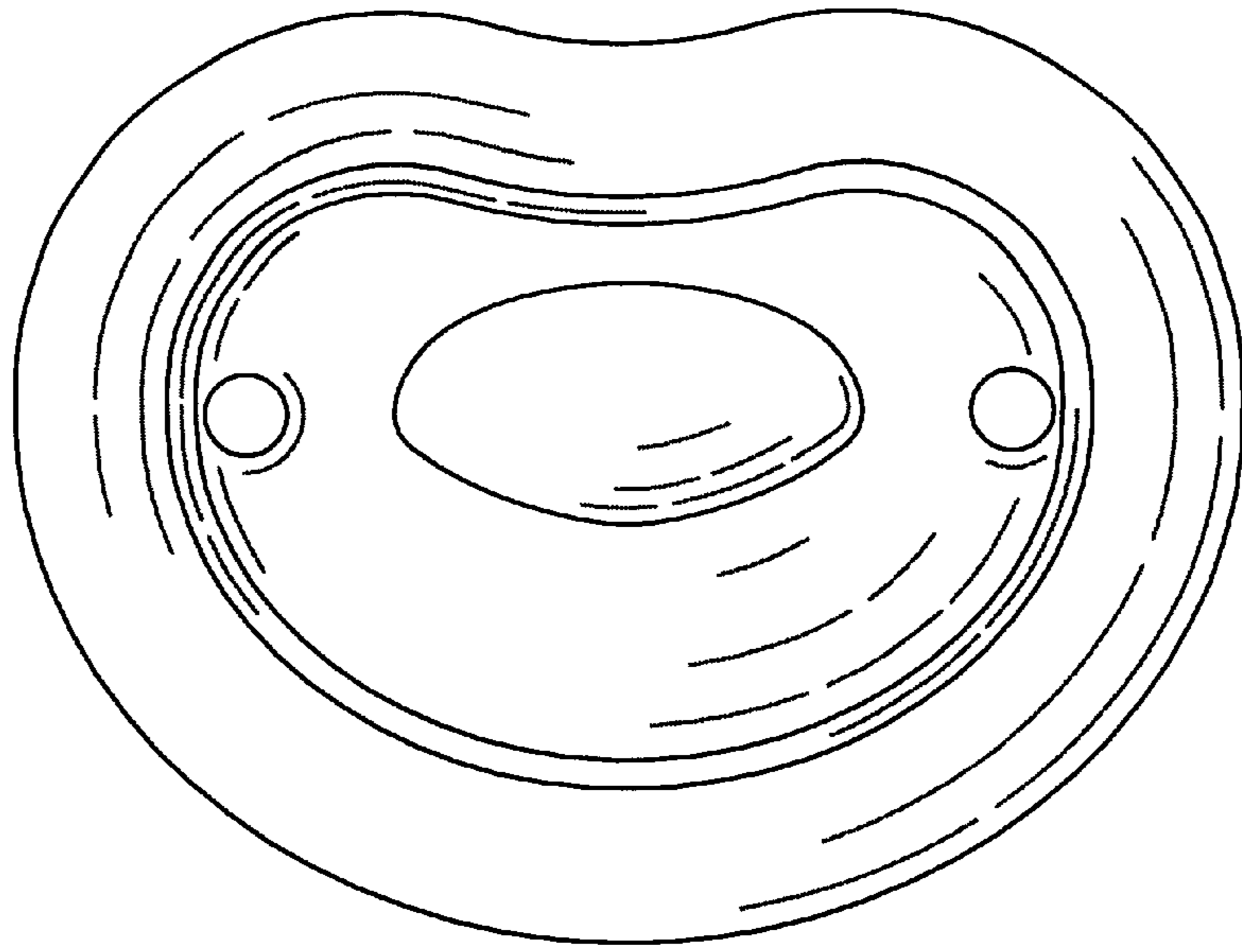

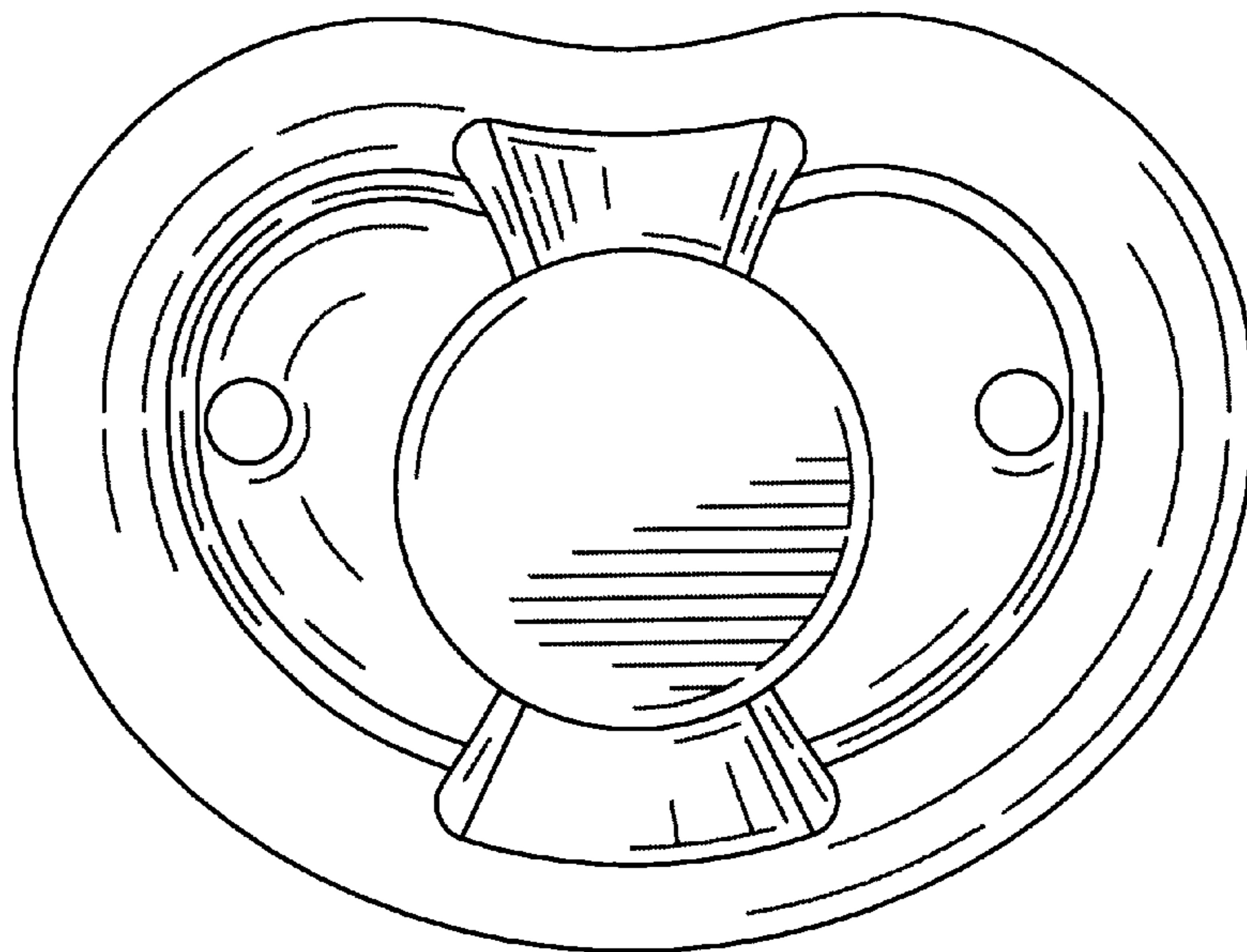
