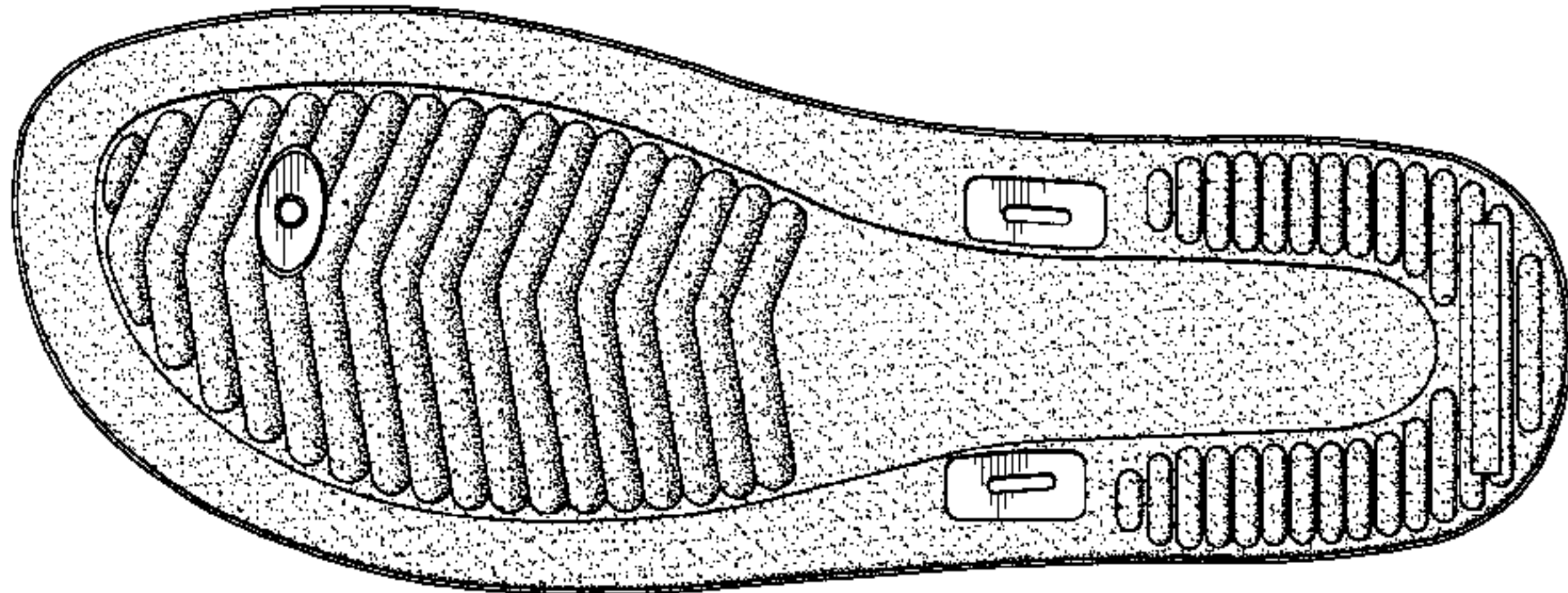
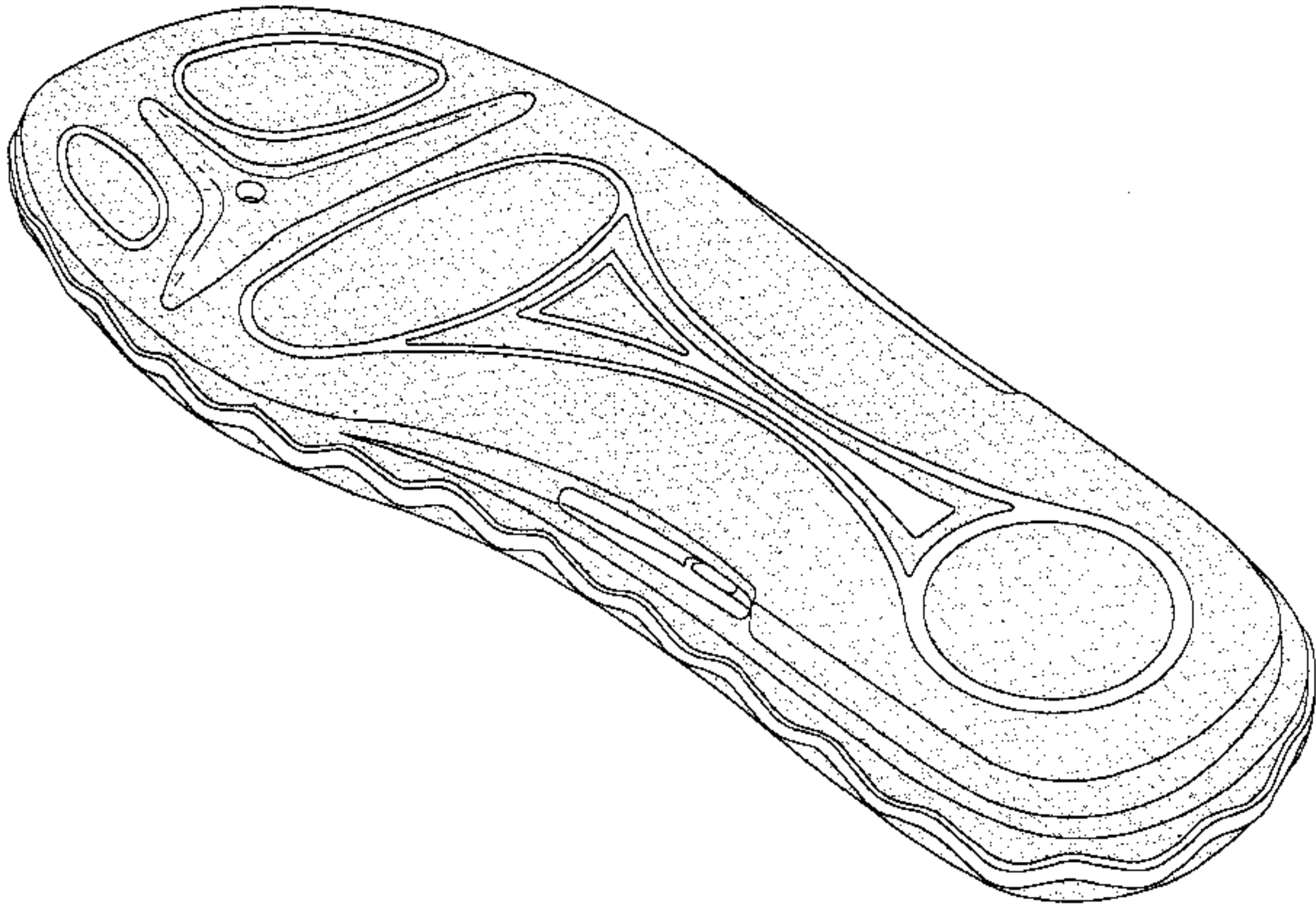
(57) CLAIM

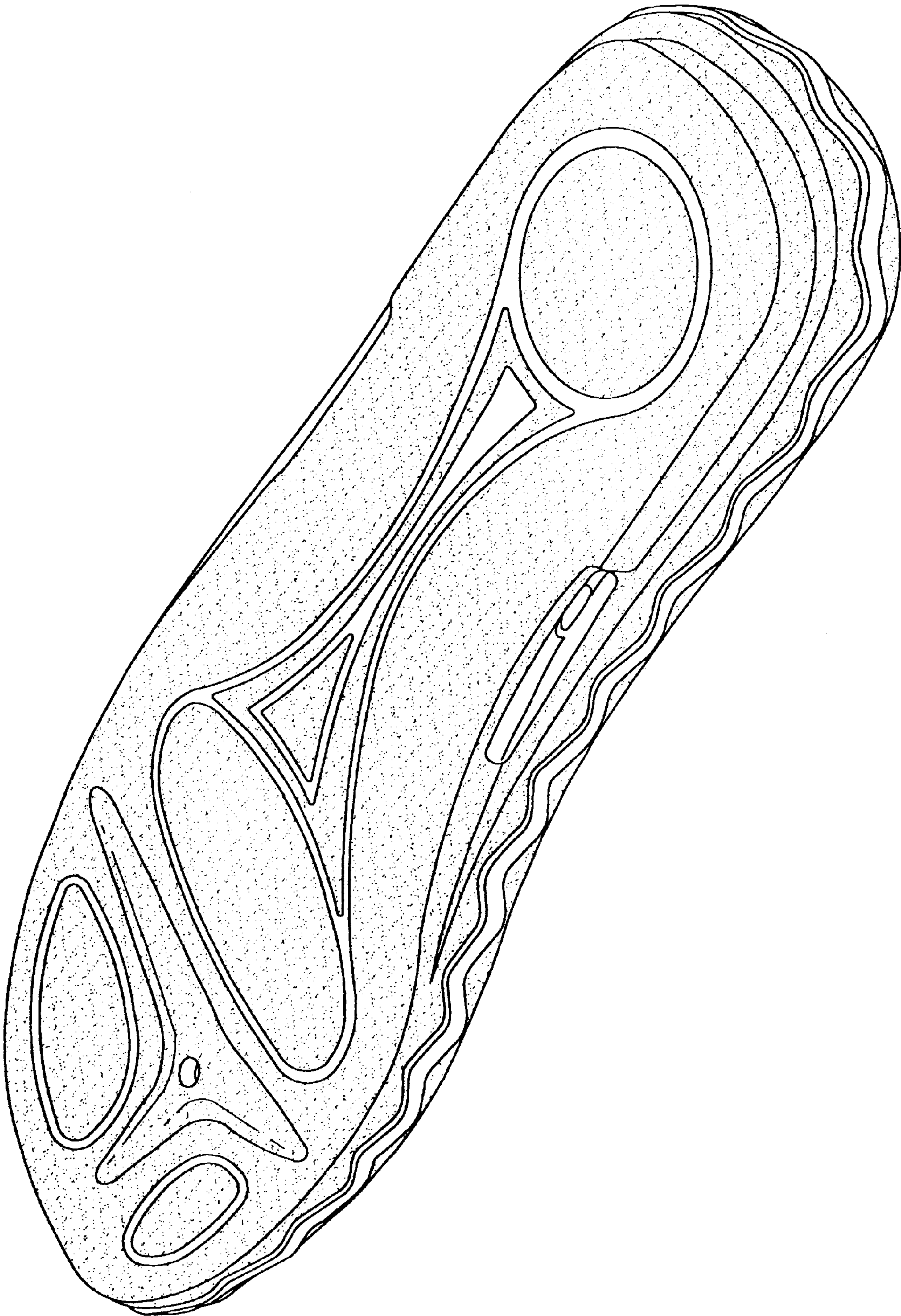

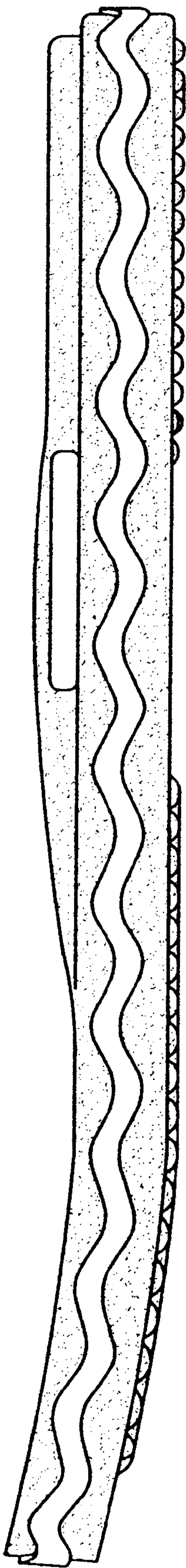

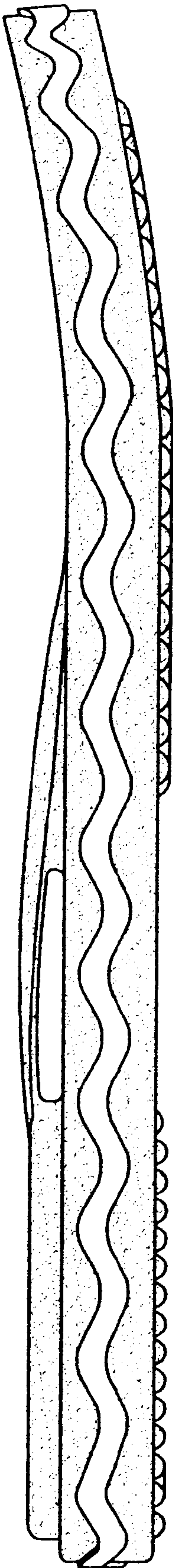

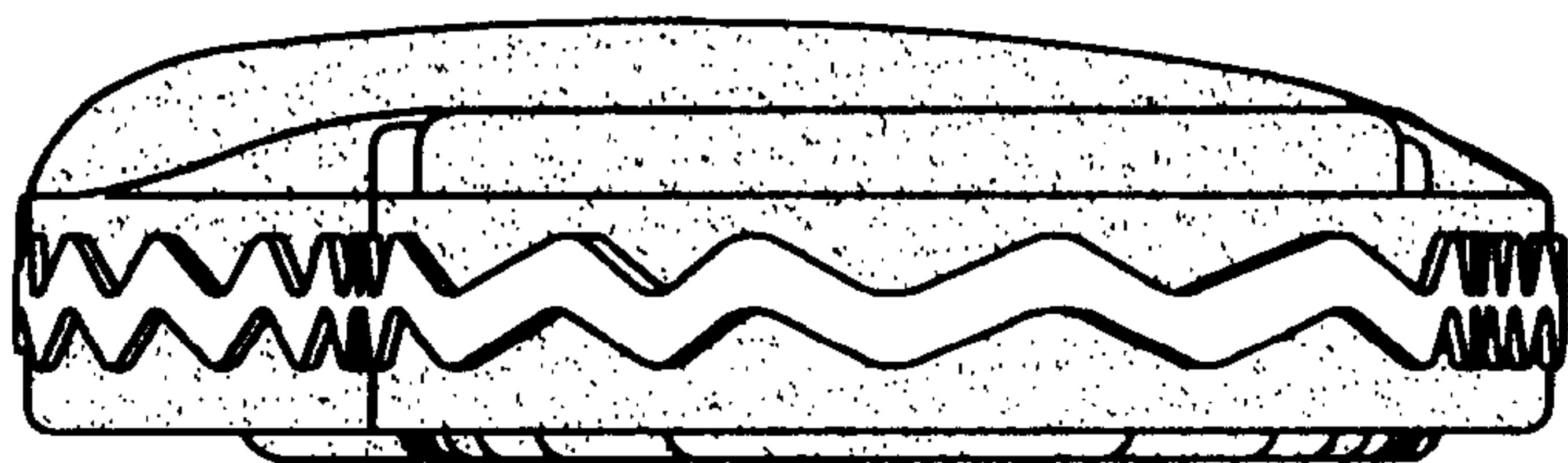

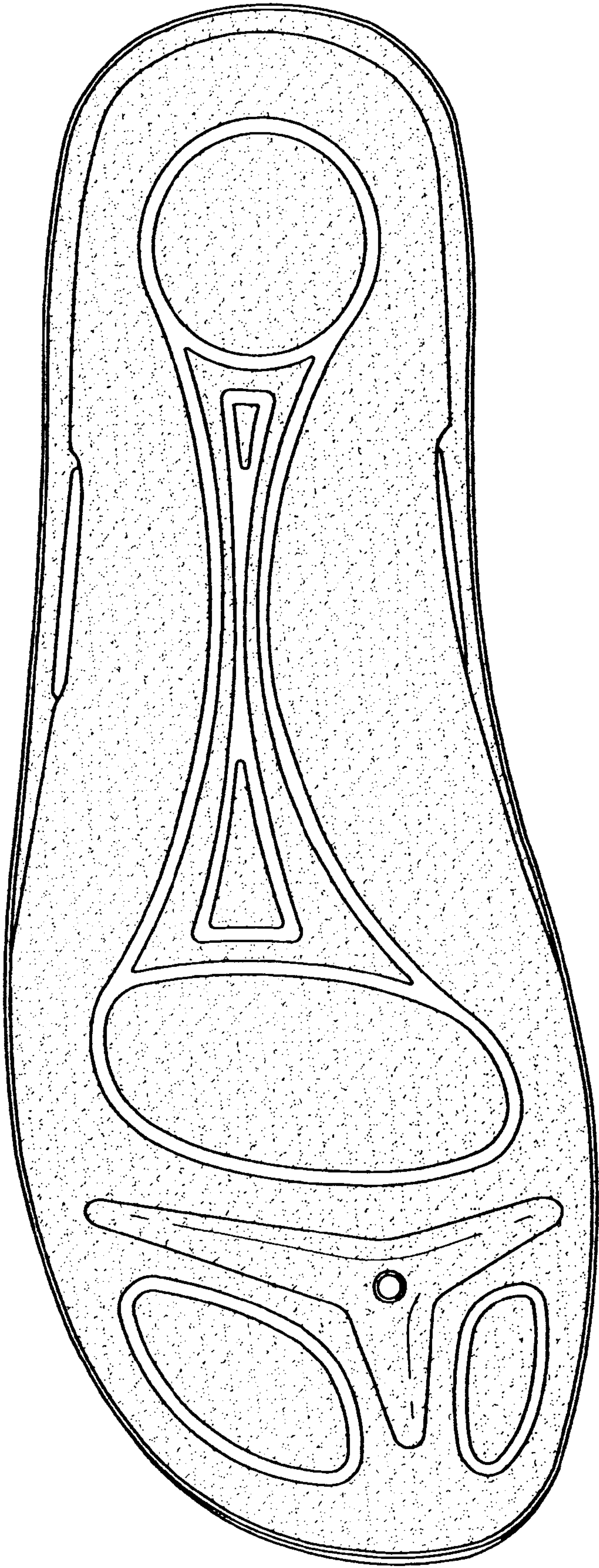

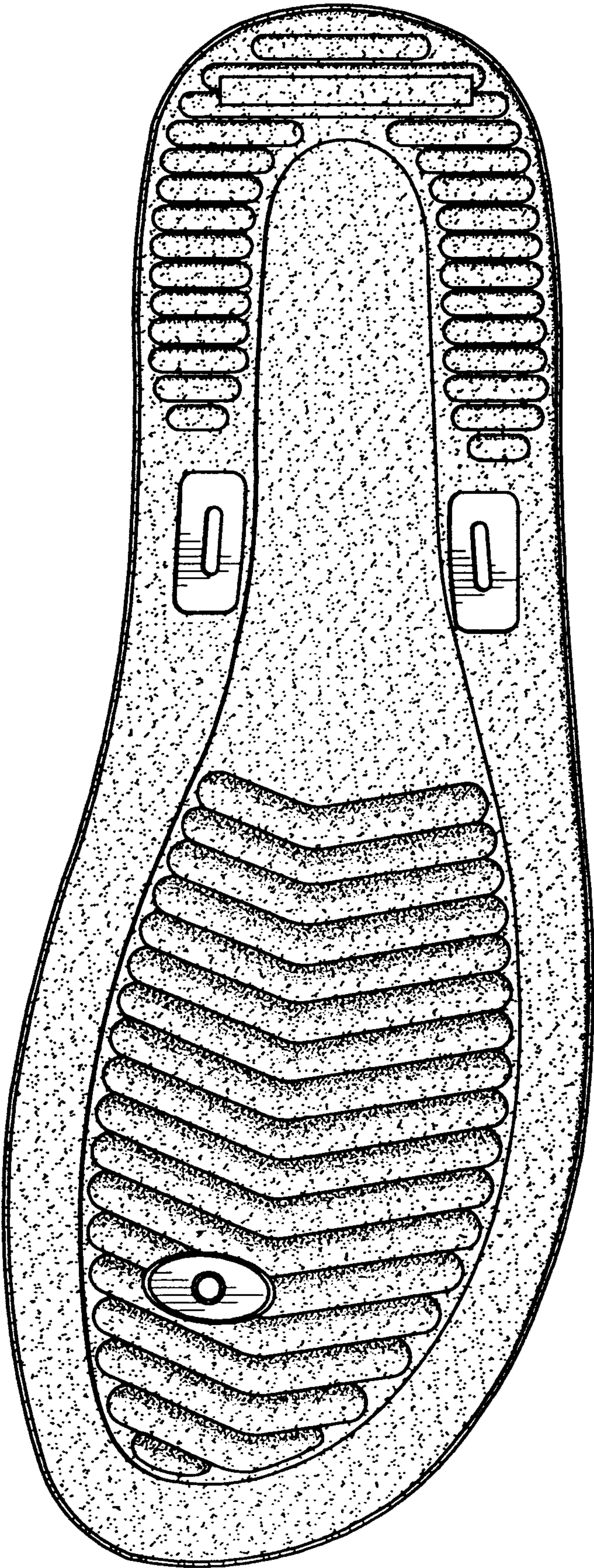
