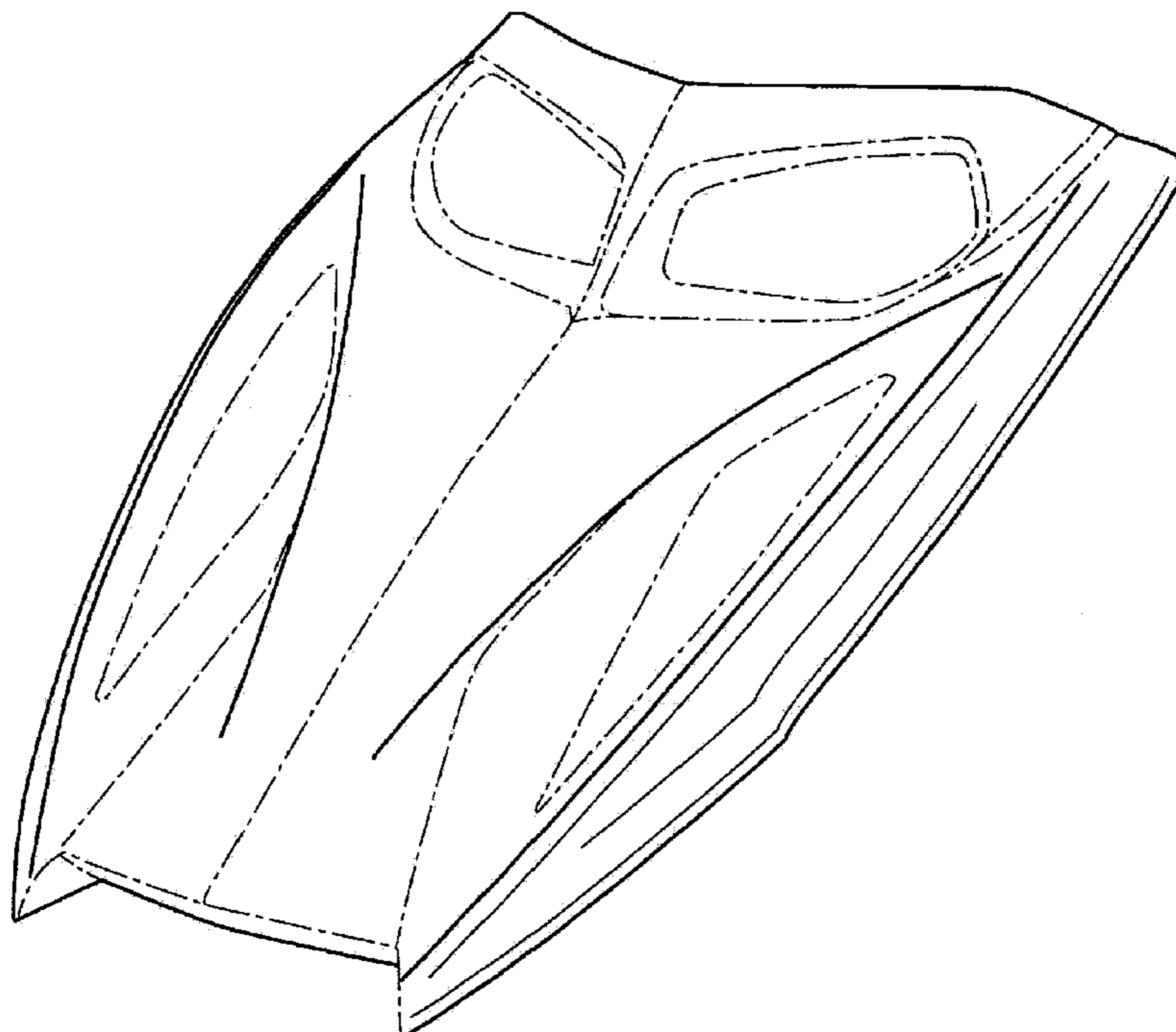
(57) **CLAIM**

The ornamental design for a hood for a snowmobile, as shown and described.

DESCRIPTION

FIG. 1 is a right-front perspective view of a hood for a snowmobile showing our new design; FIG. 2 is a left side elevational view thereof, the right side view being a mirror image; FIG. 3 is a top plan view thereof; and, FIG. 4 is a front elevational view thereof.

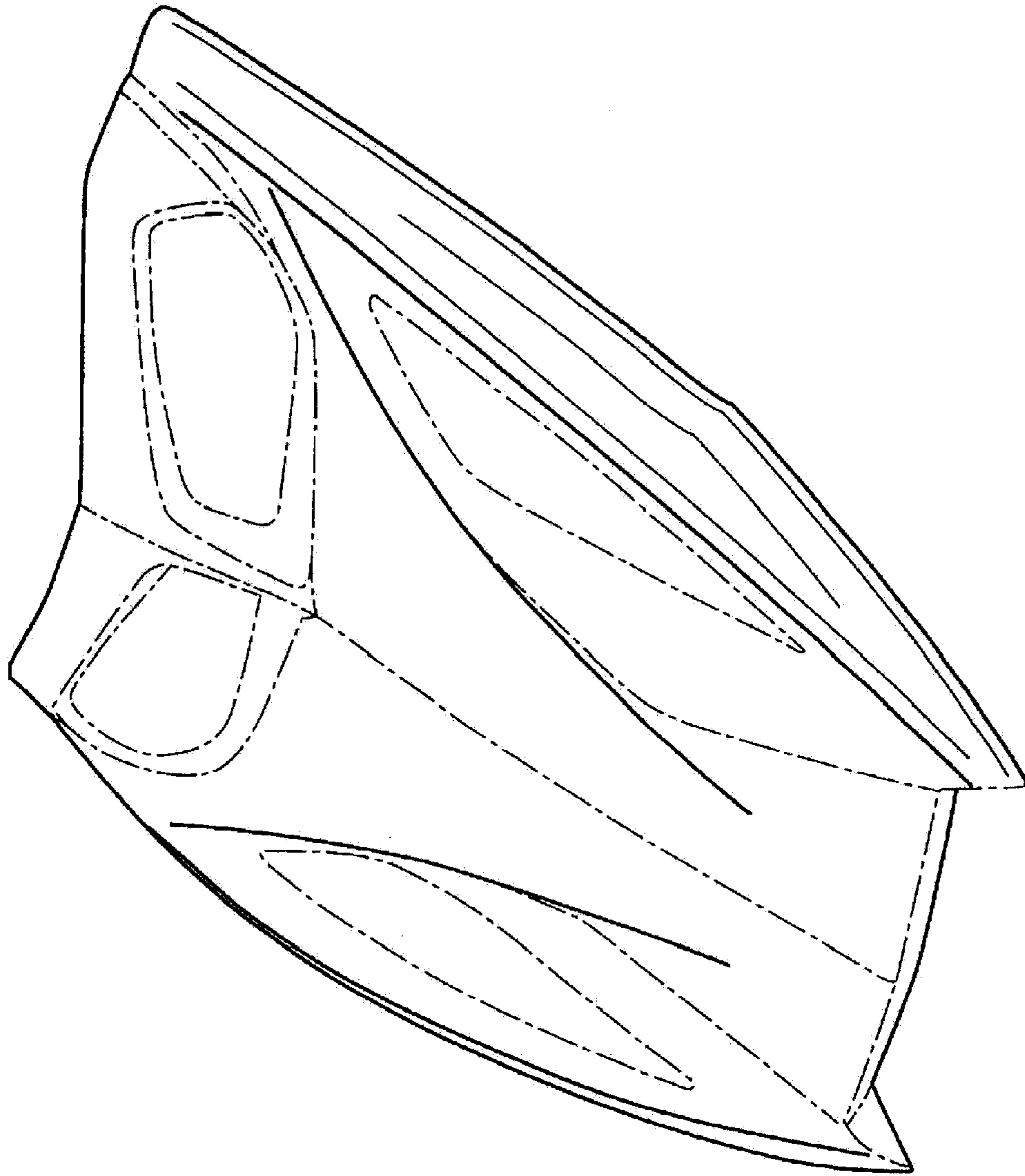

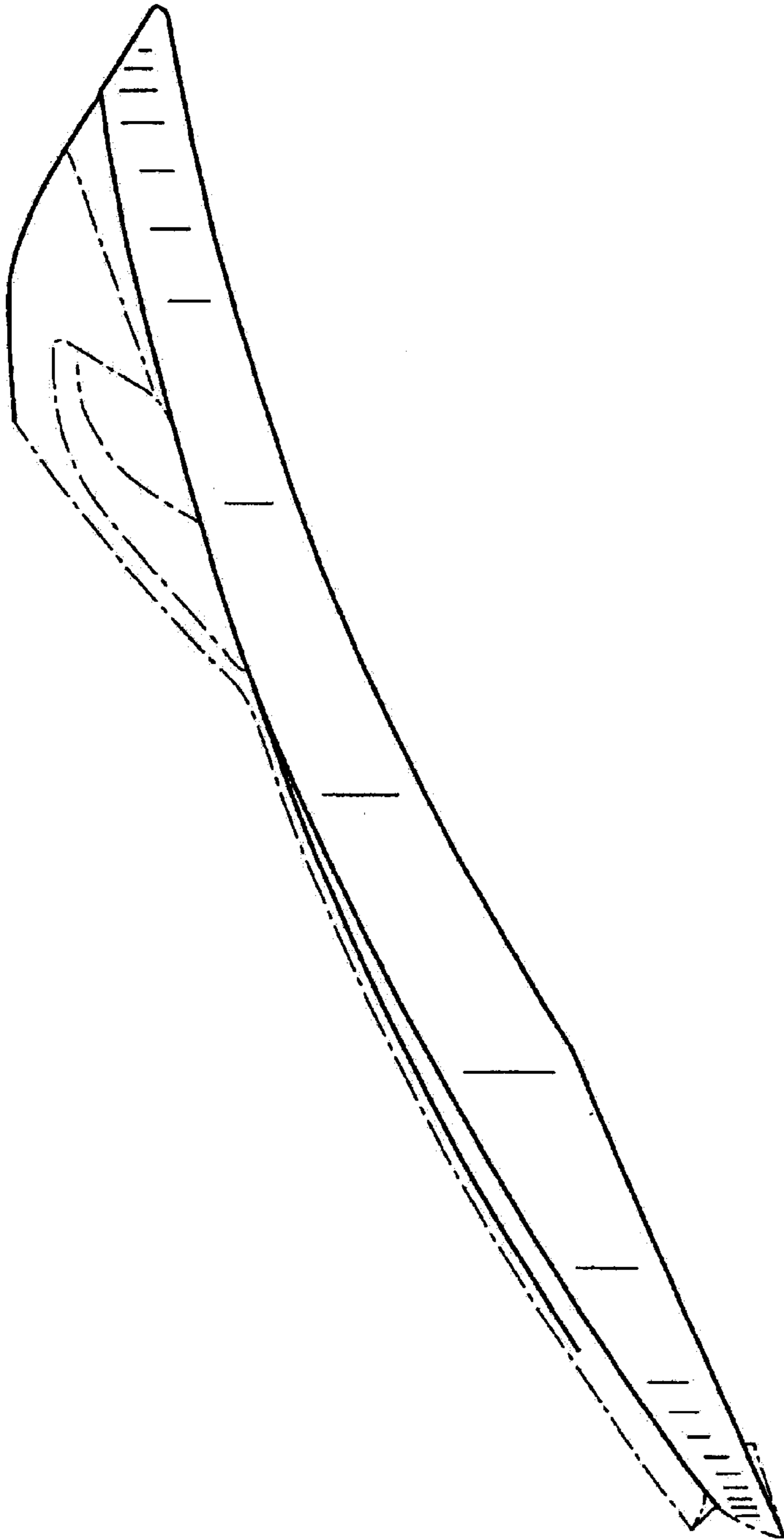

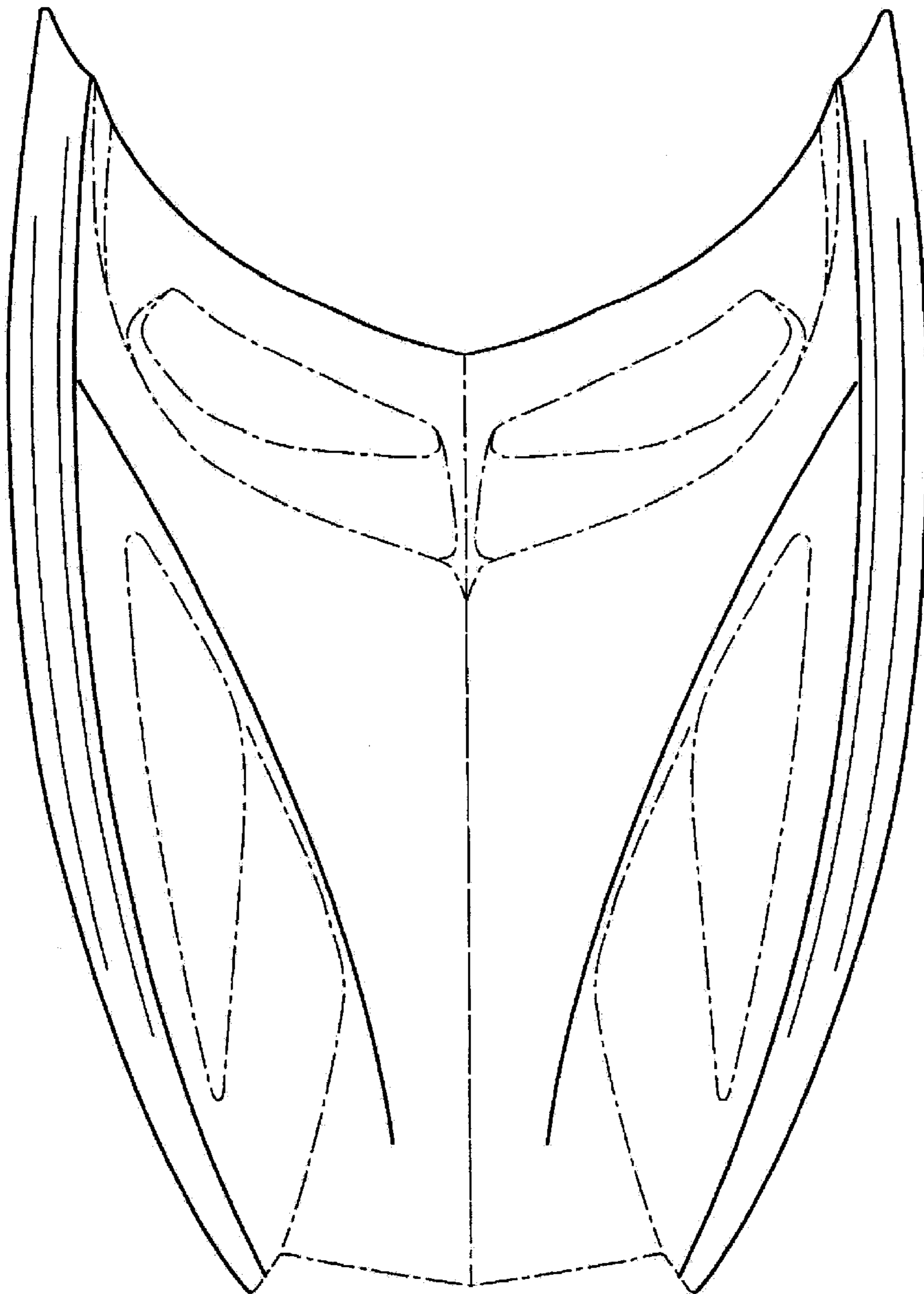

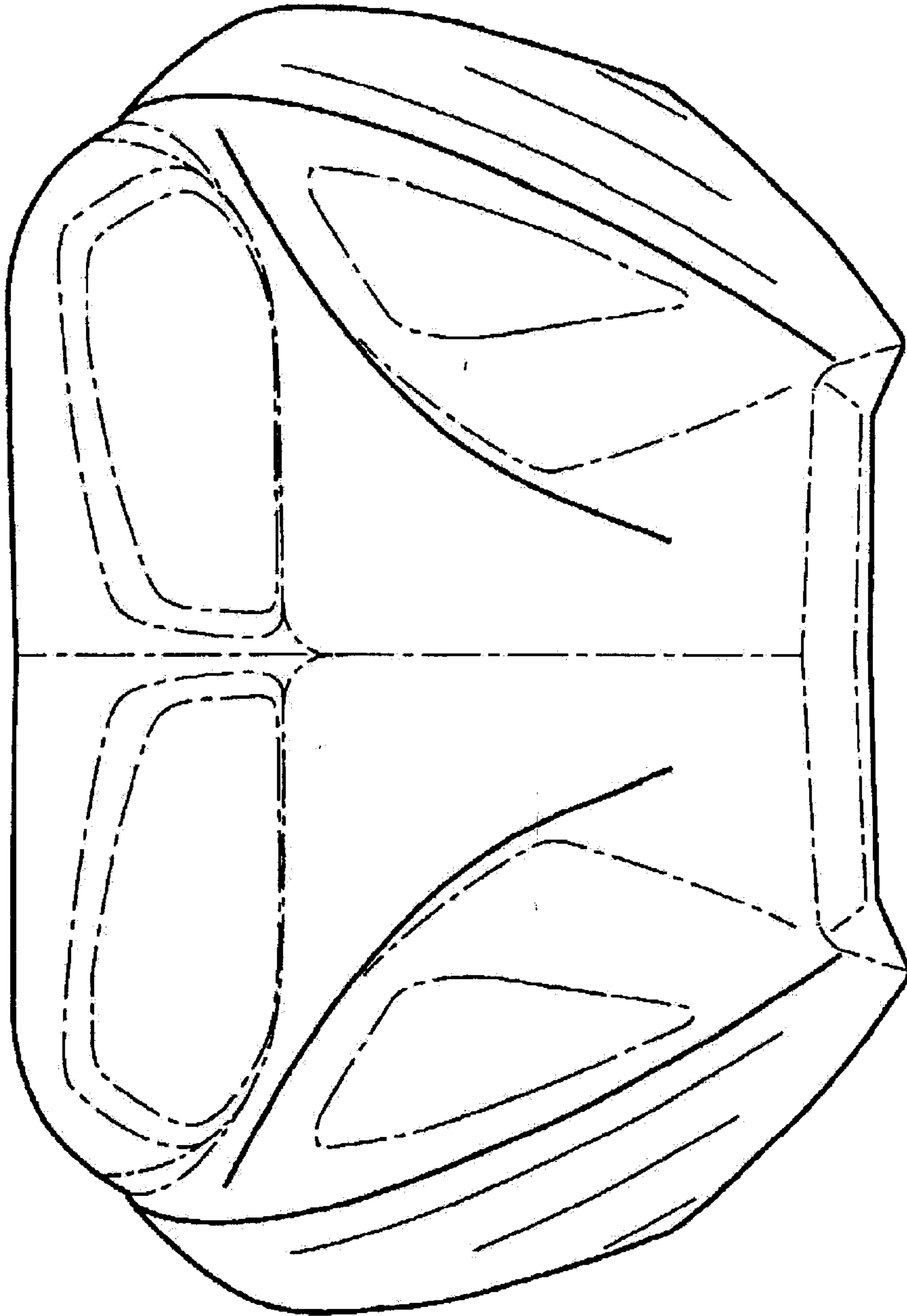
