FIG. 6 is a left side view of the surface configuration of an exhaust pipe for a vehicle according to my novel design.

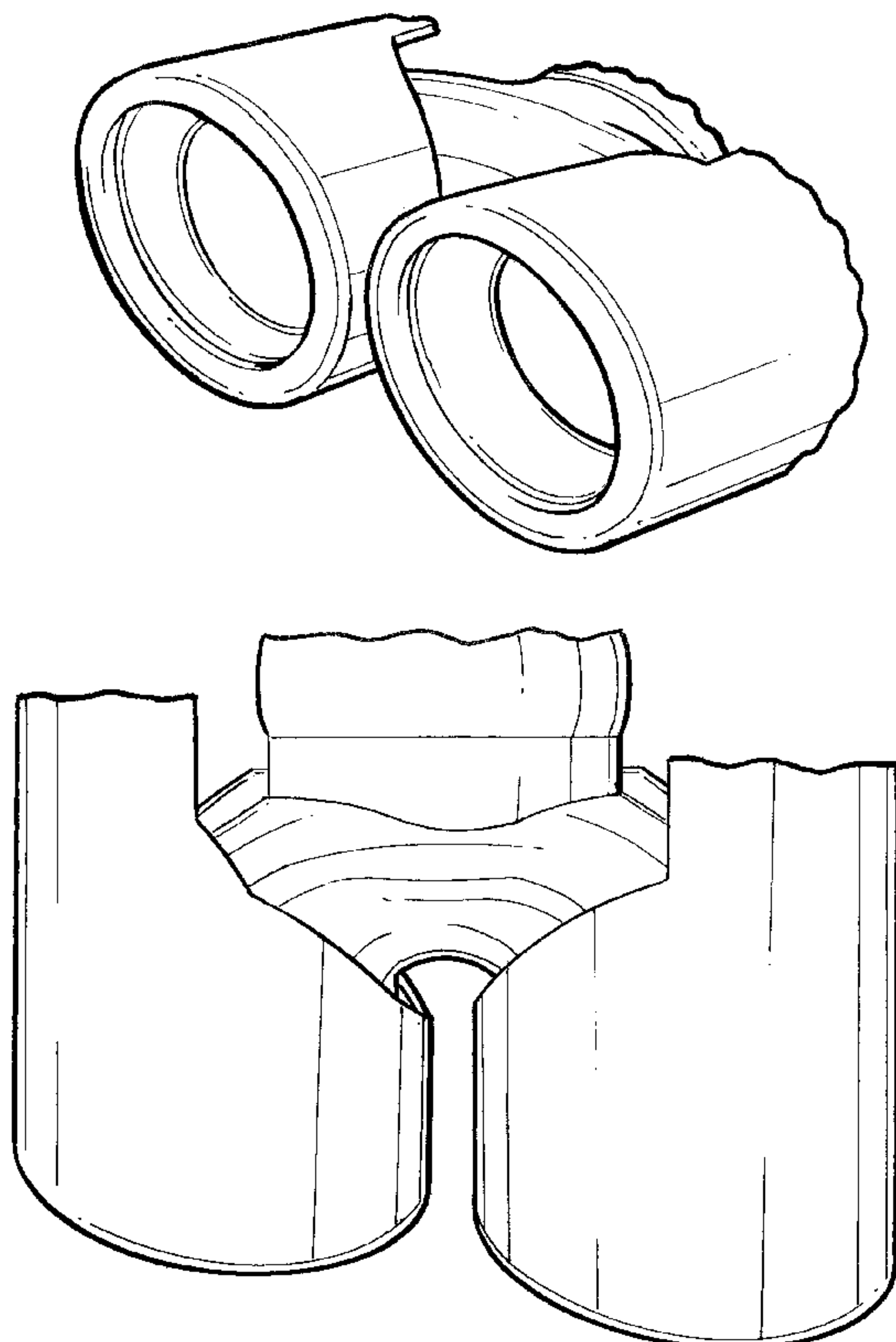
Also enclosed is a set of photographs of an embodiment of my invention. The dash lines included depict environment and are not part of the claimed design.

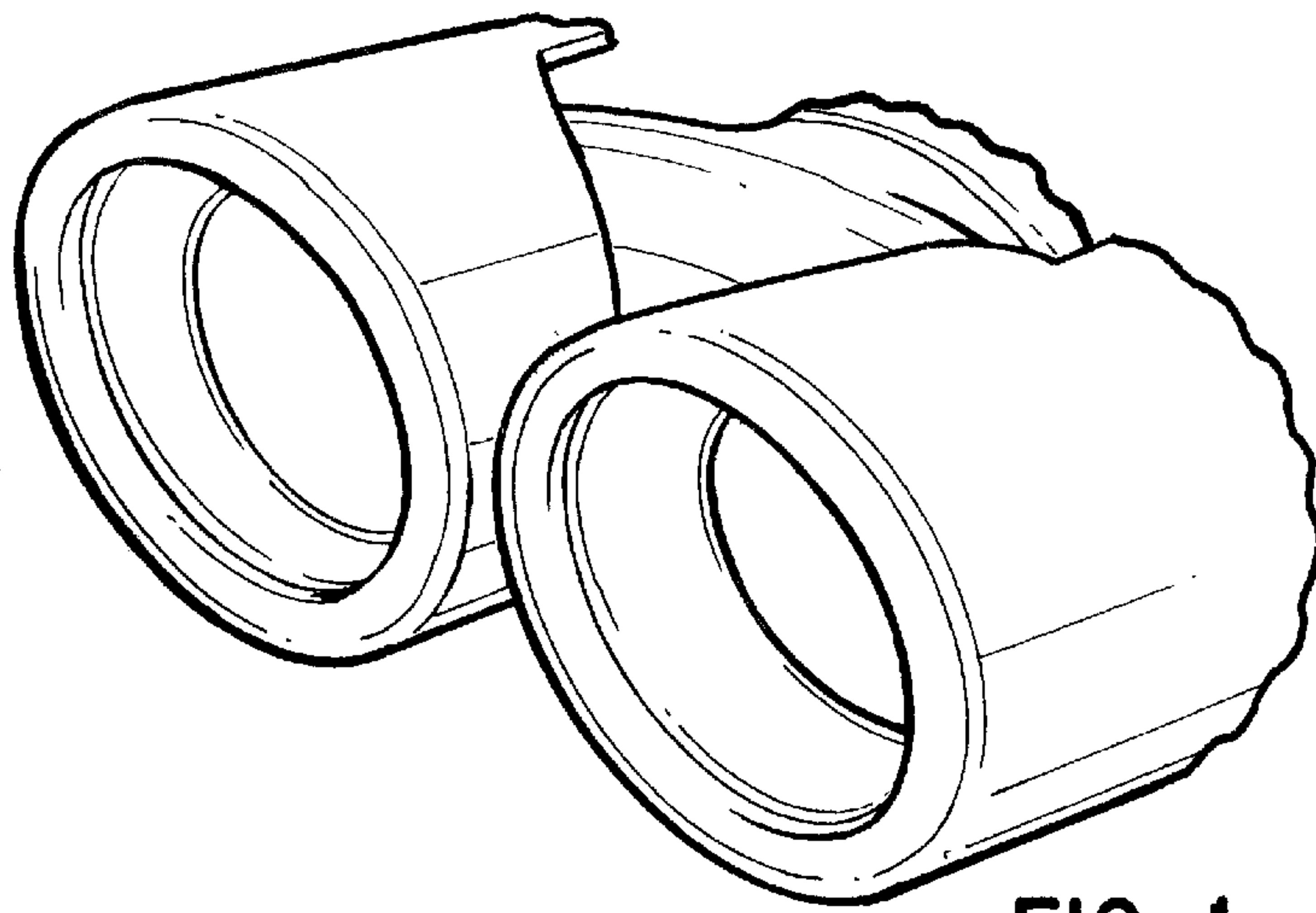

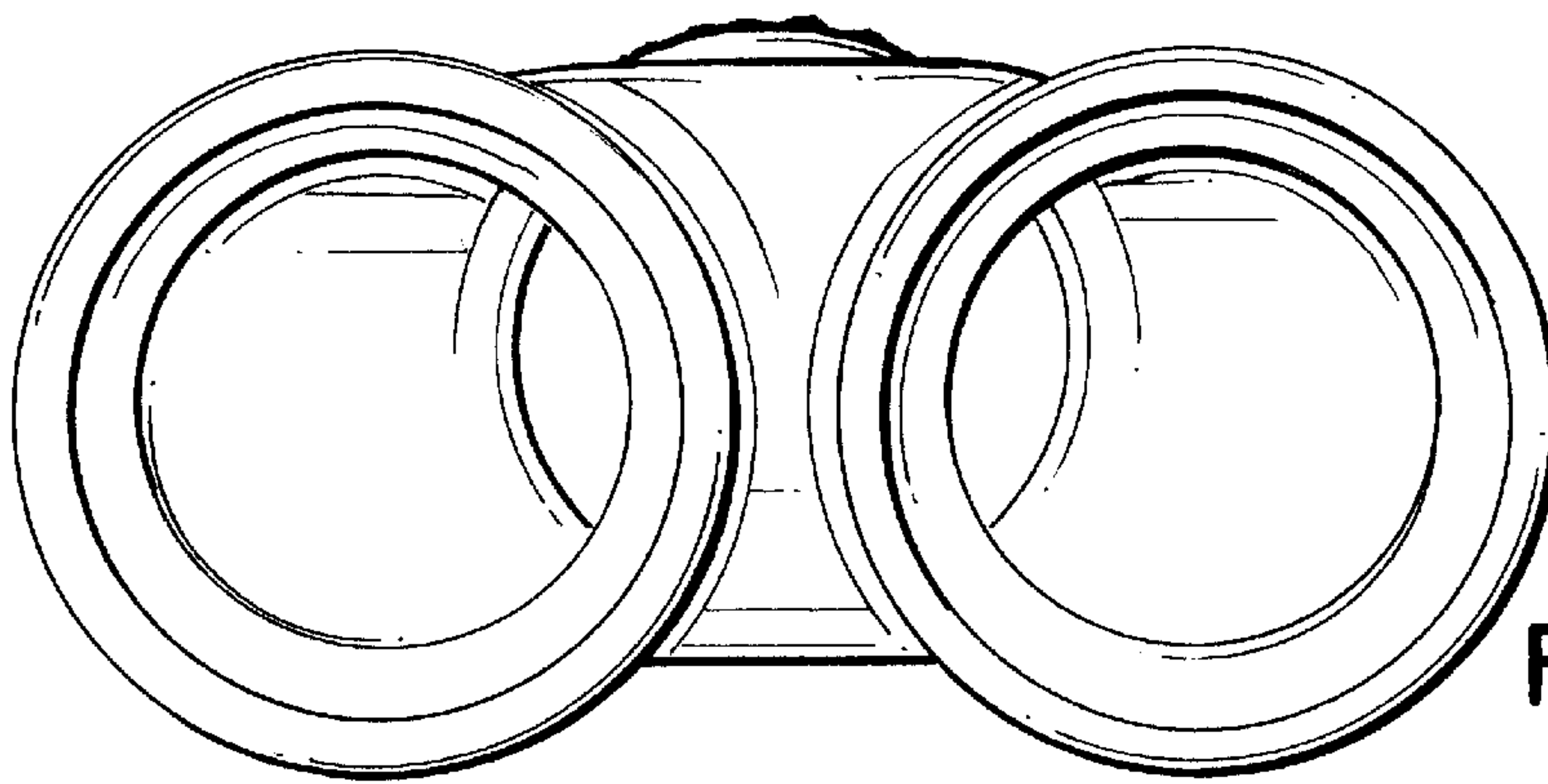

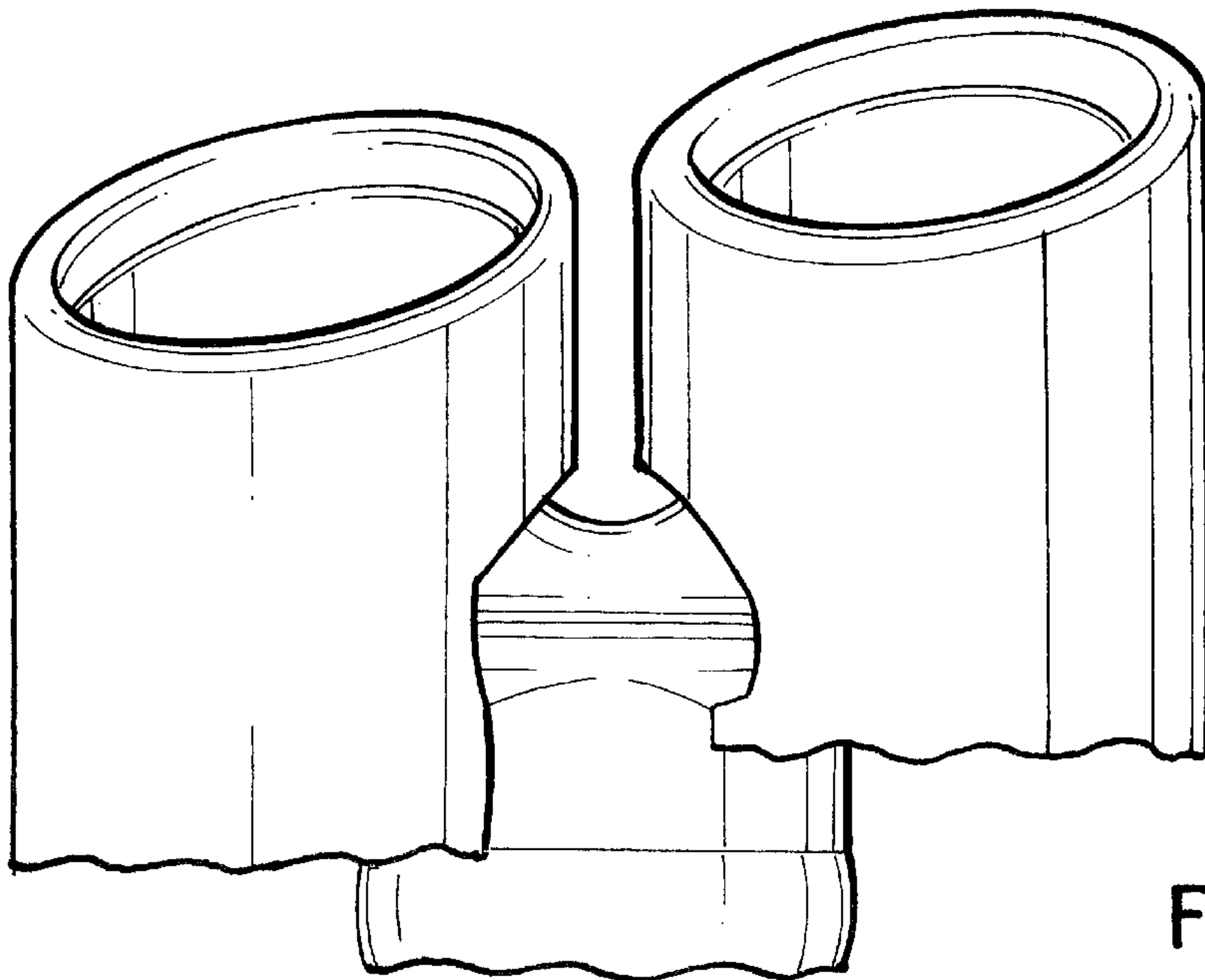

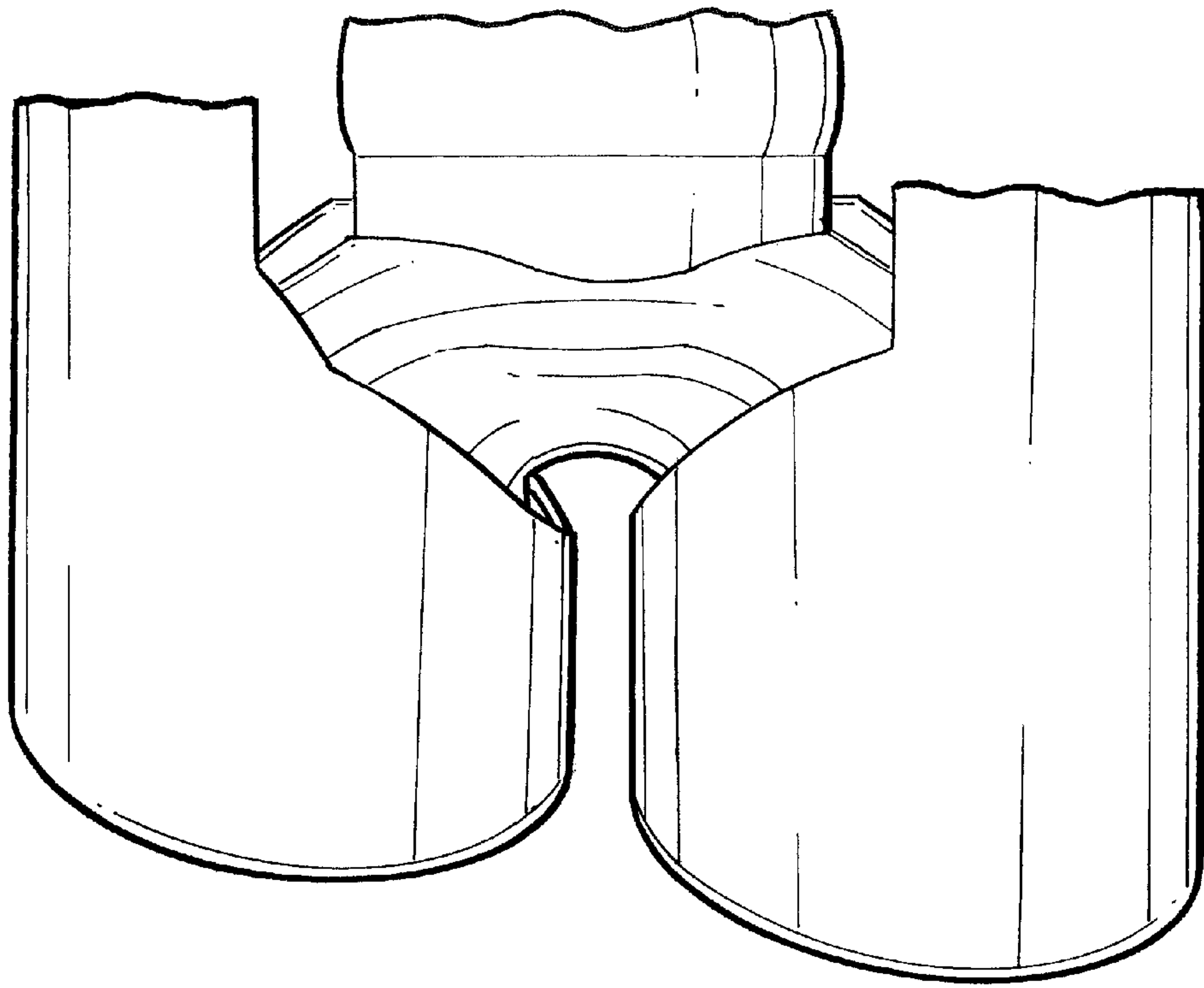

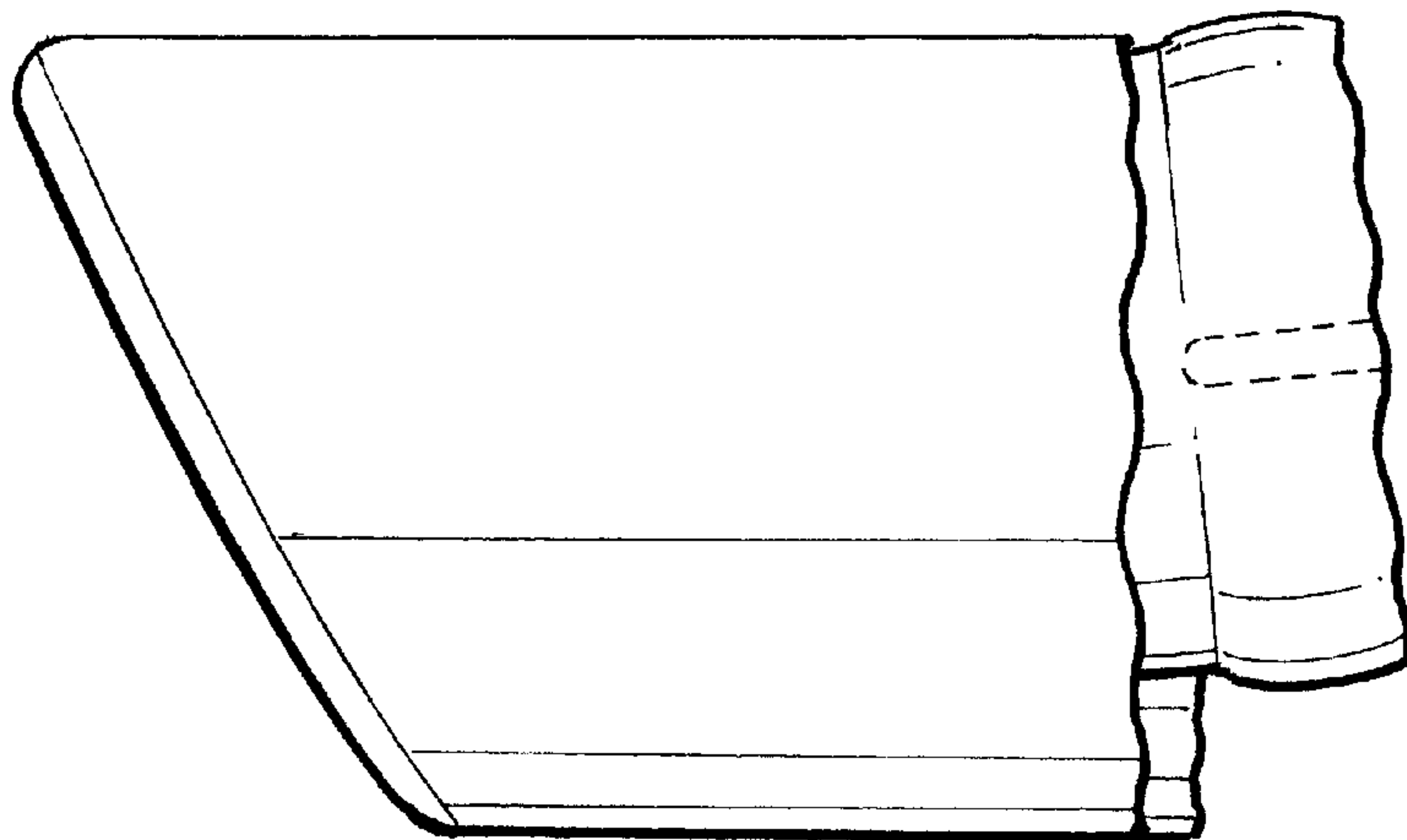

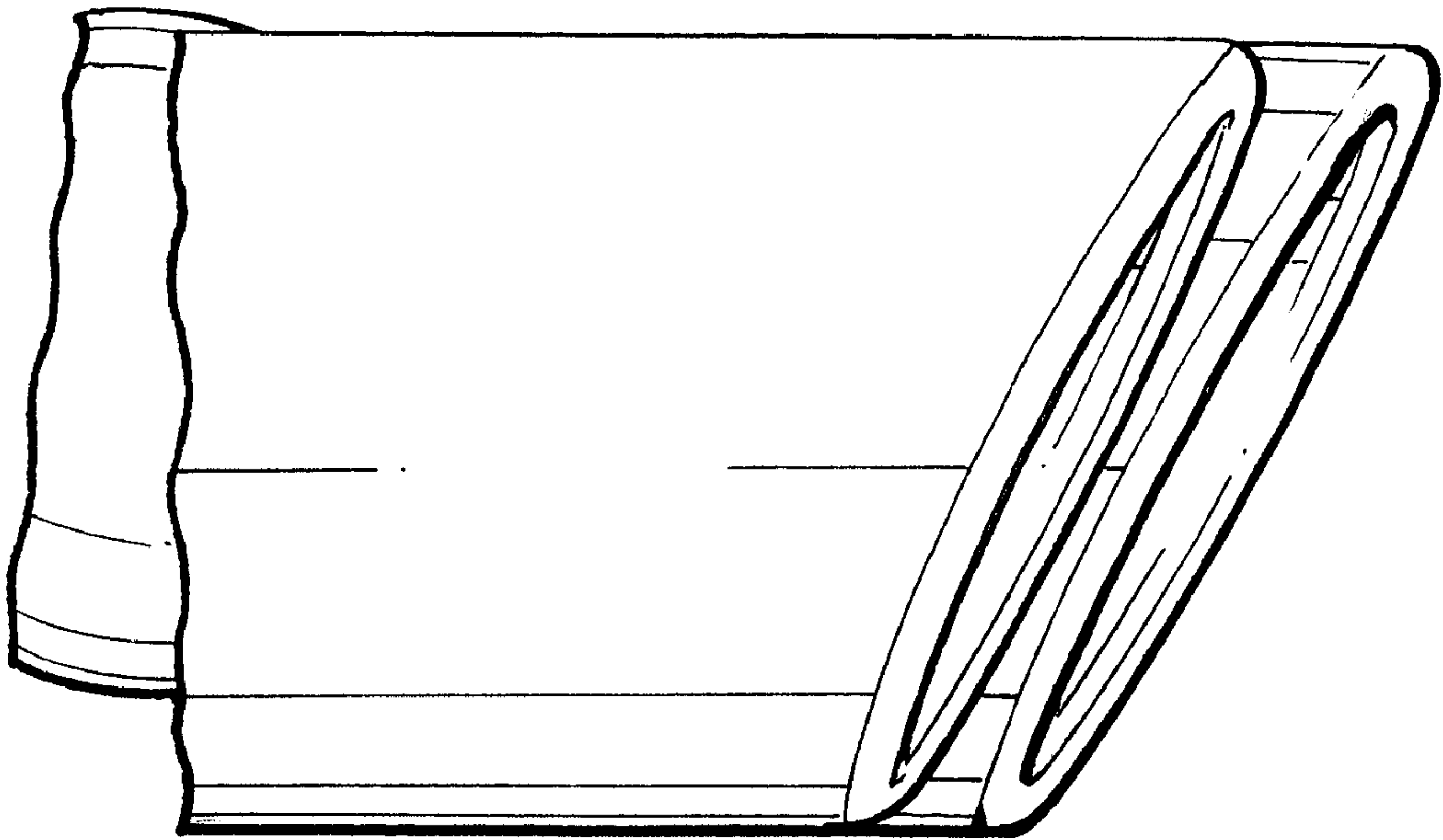
