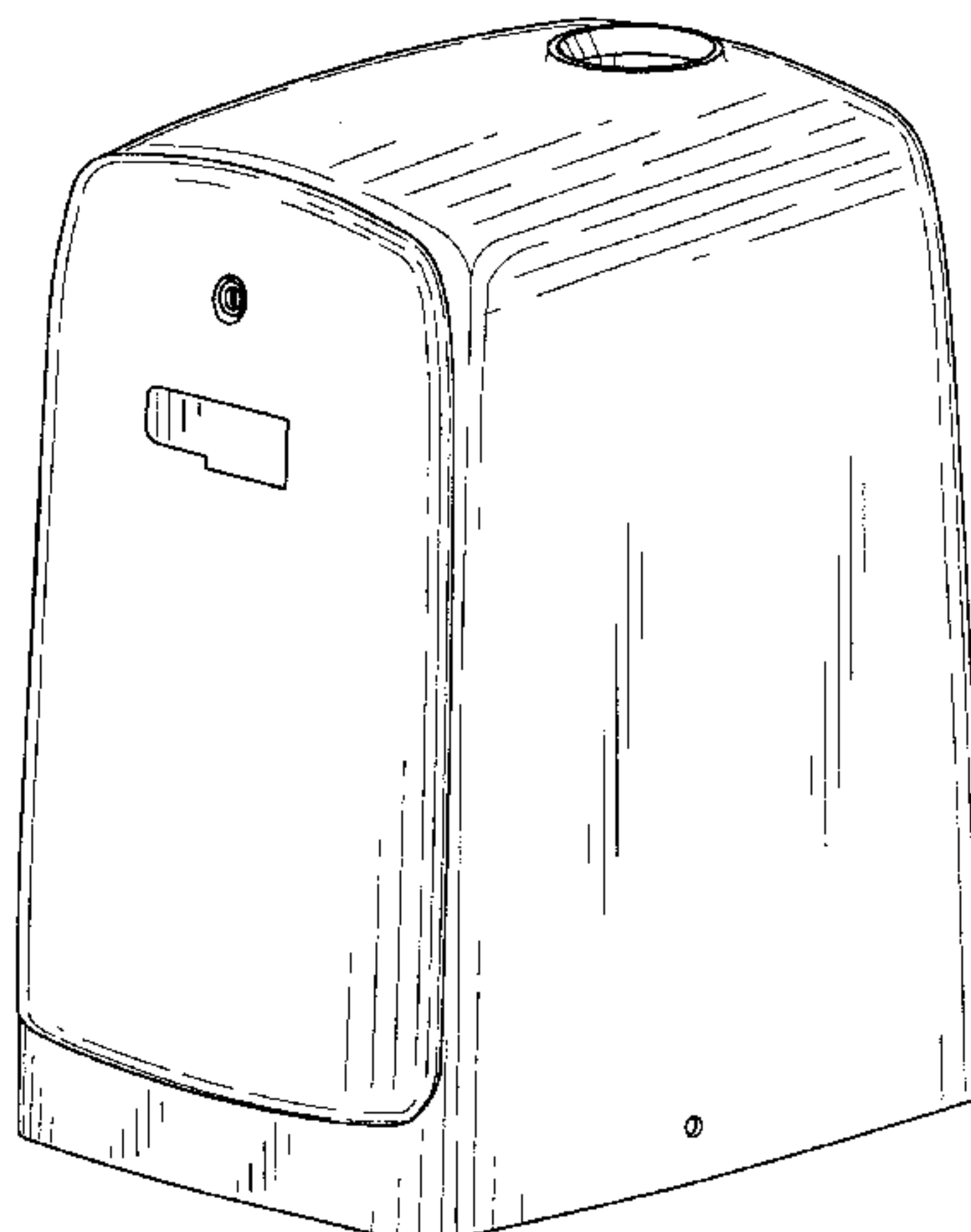
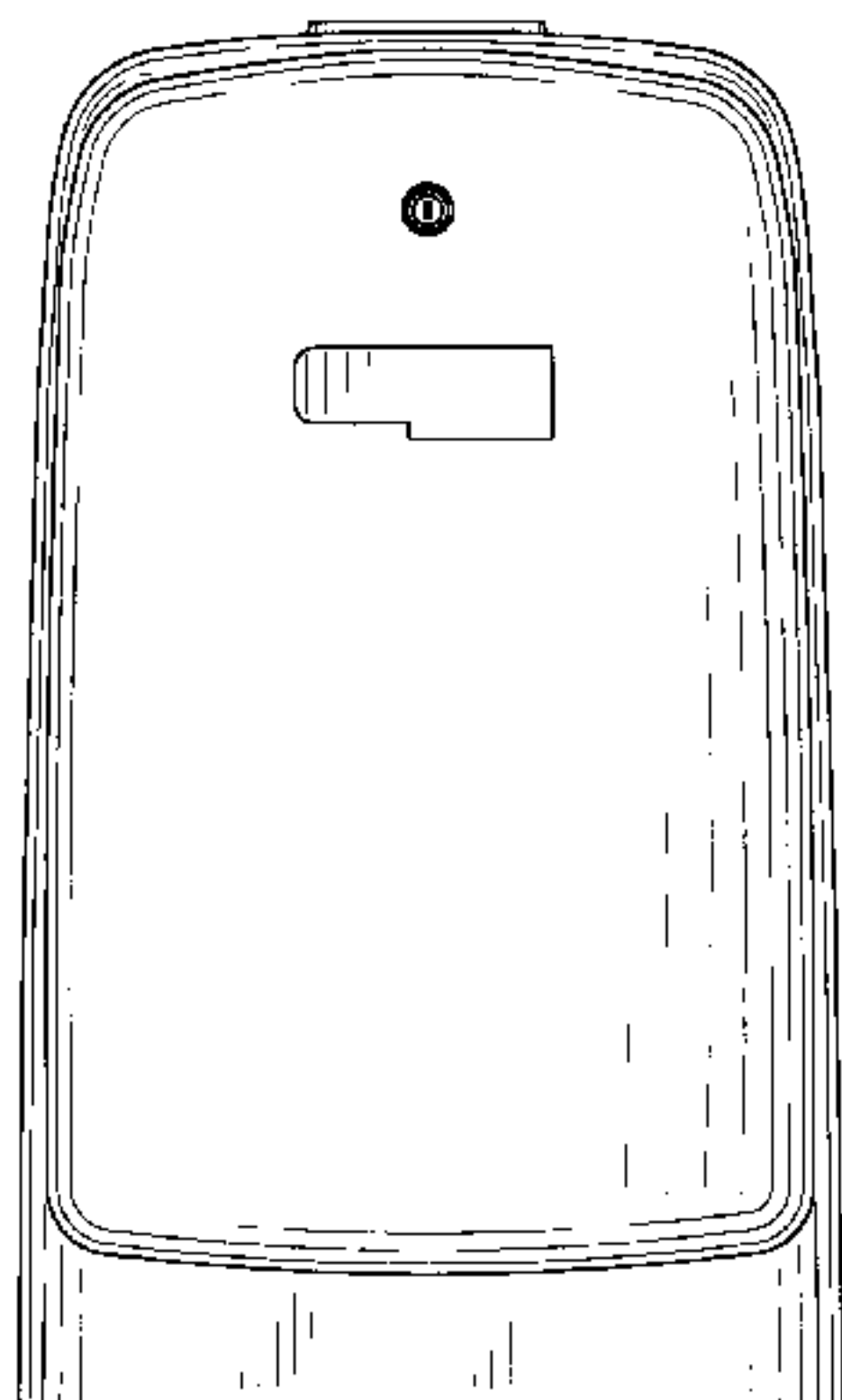
CLAIM

The ornamental design for a gate operator housing, as shown and described.

DESCRIPTION

FIG. 1 is a front elevated view of a gate operator housing showing my new invention; FIG. 2 is a right side view thereof; FIG. 3 is a perspective view thereof; and, FIG. 4 is a perspective view, having the front cover plate shown in an exploded view.

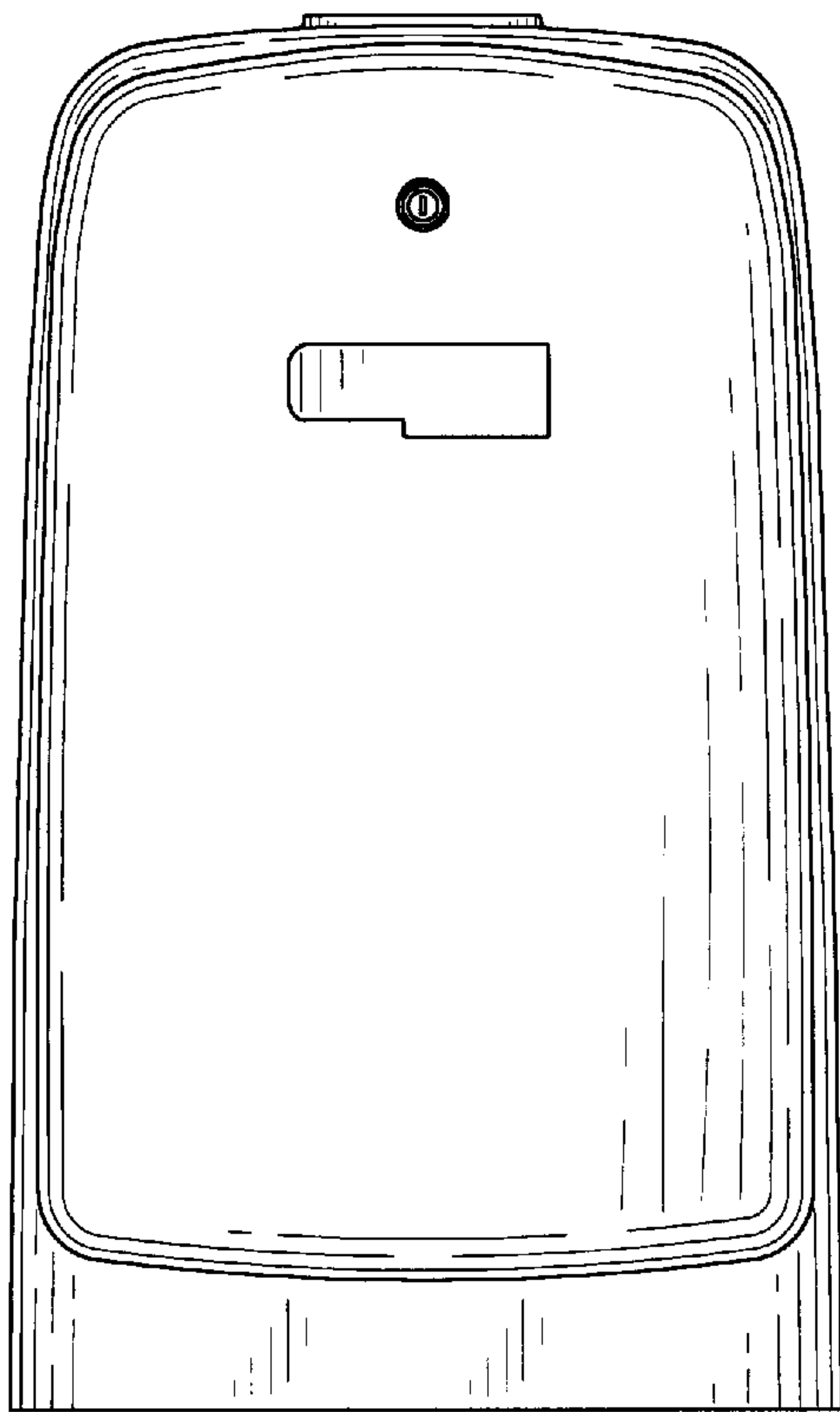

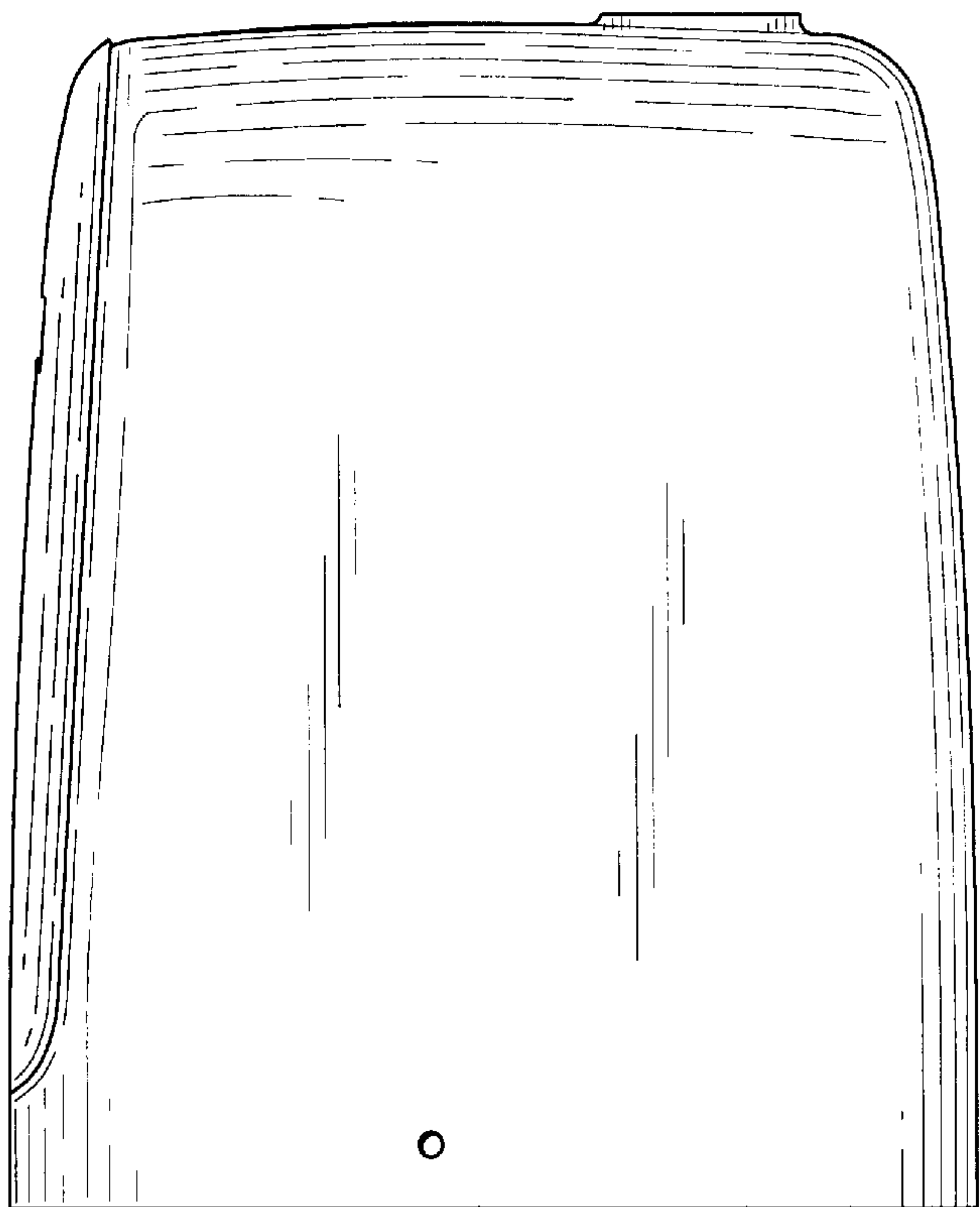

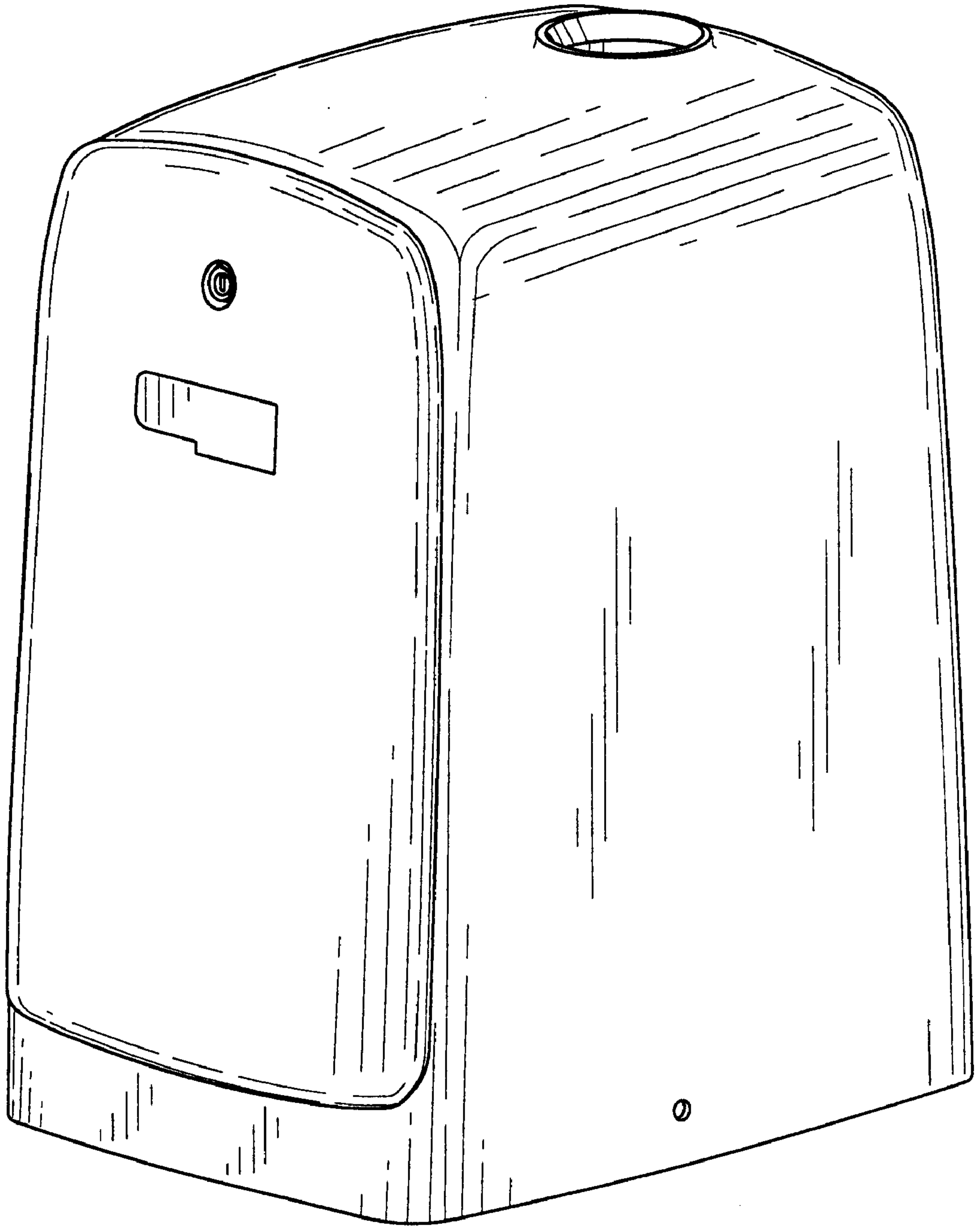

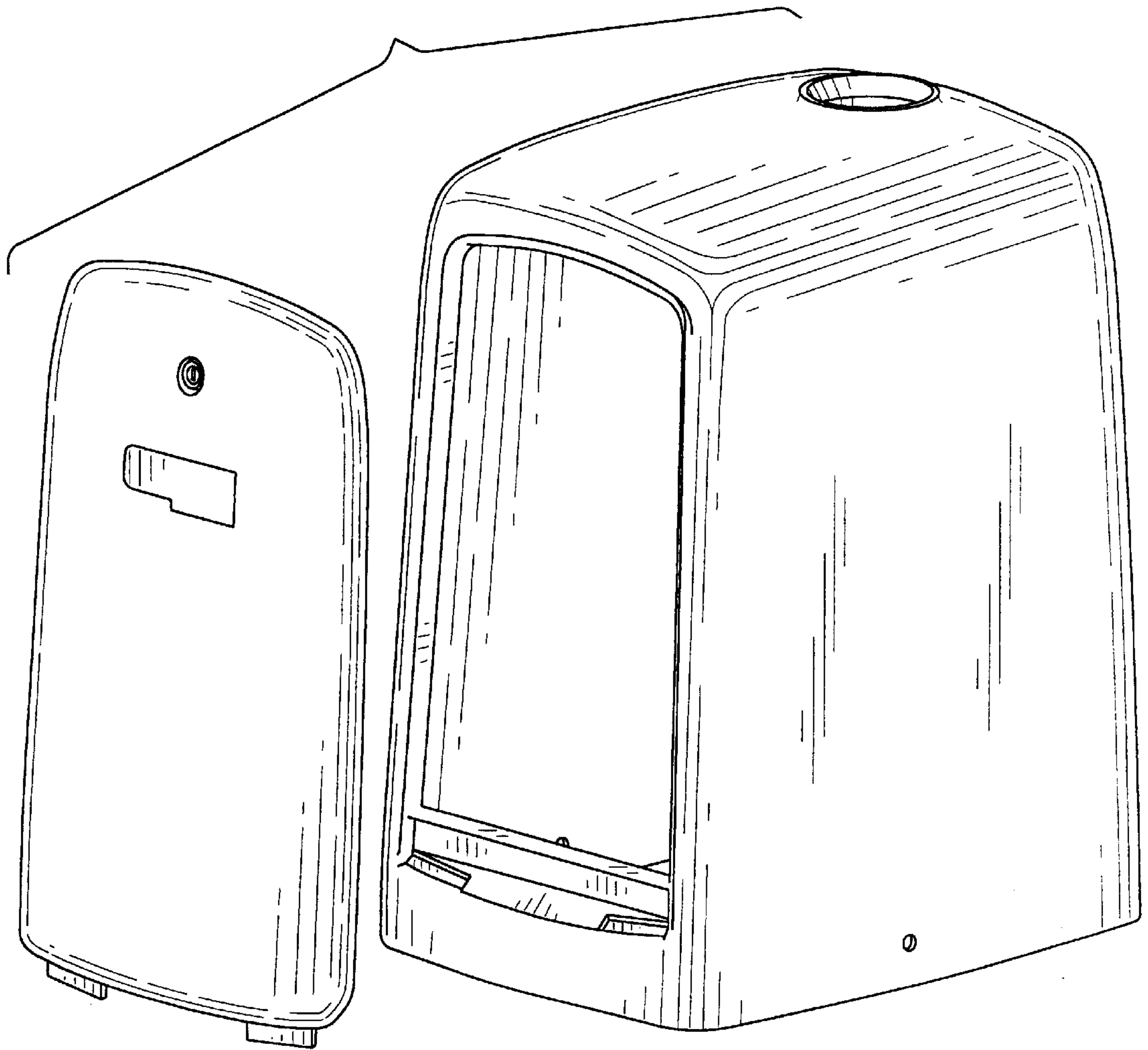
