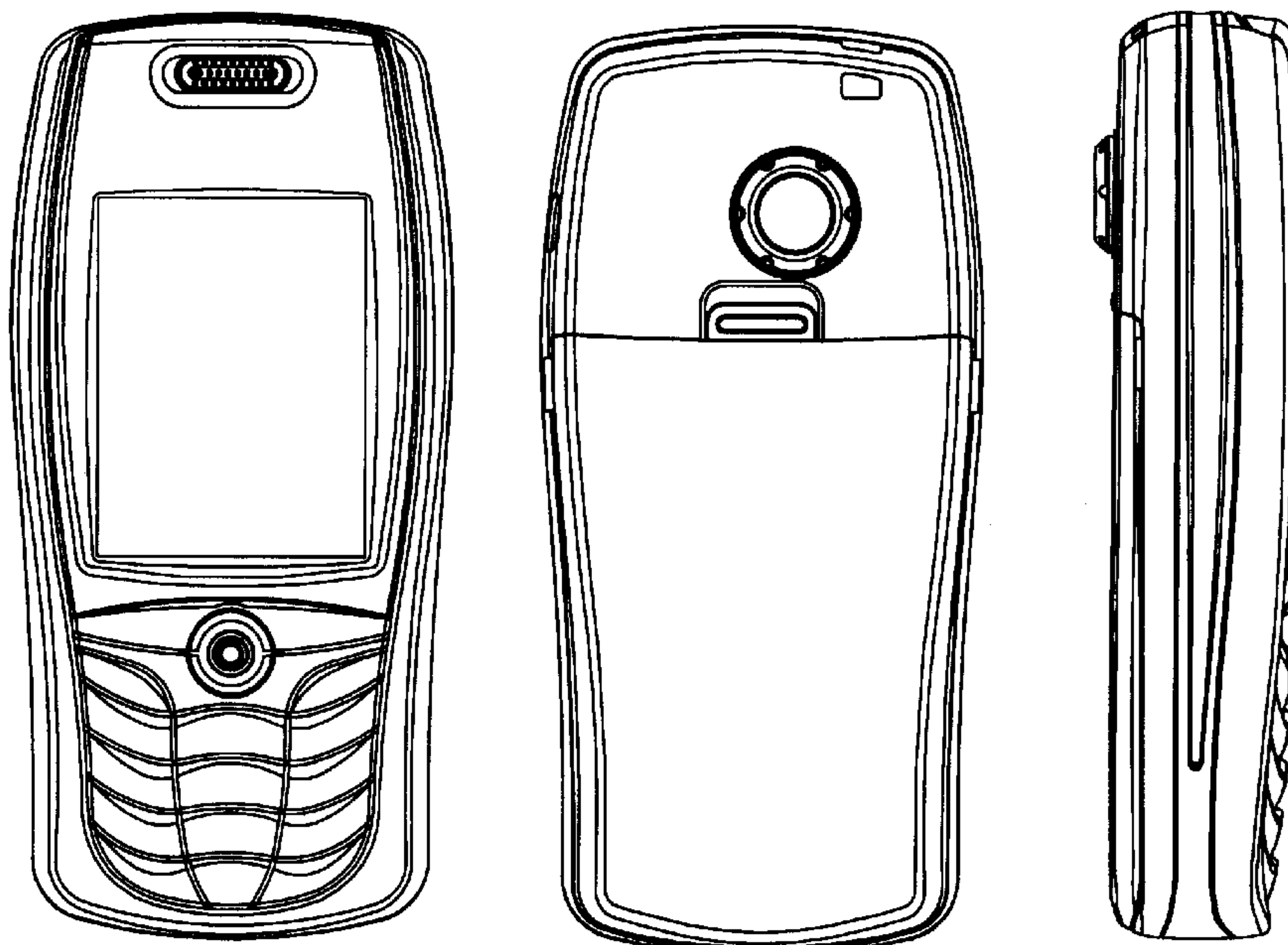
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, side perspective view of a cellular phone showing my new design;
FIG. 2 is a front elevational view thereof;

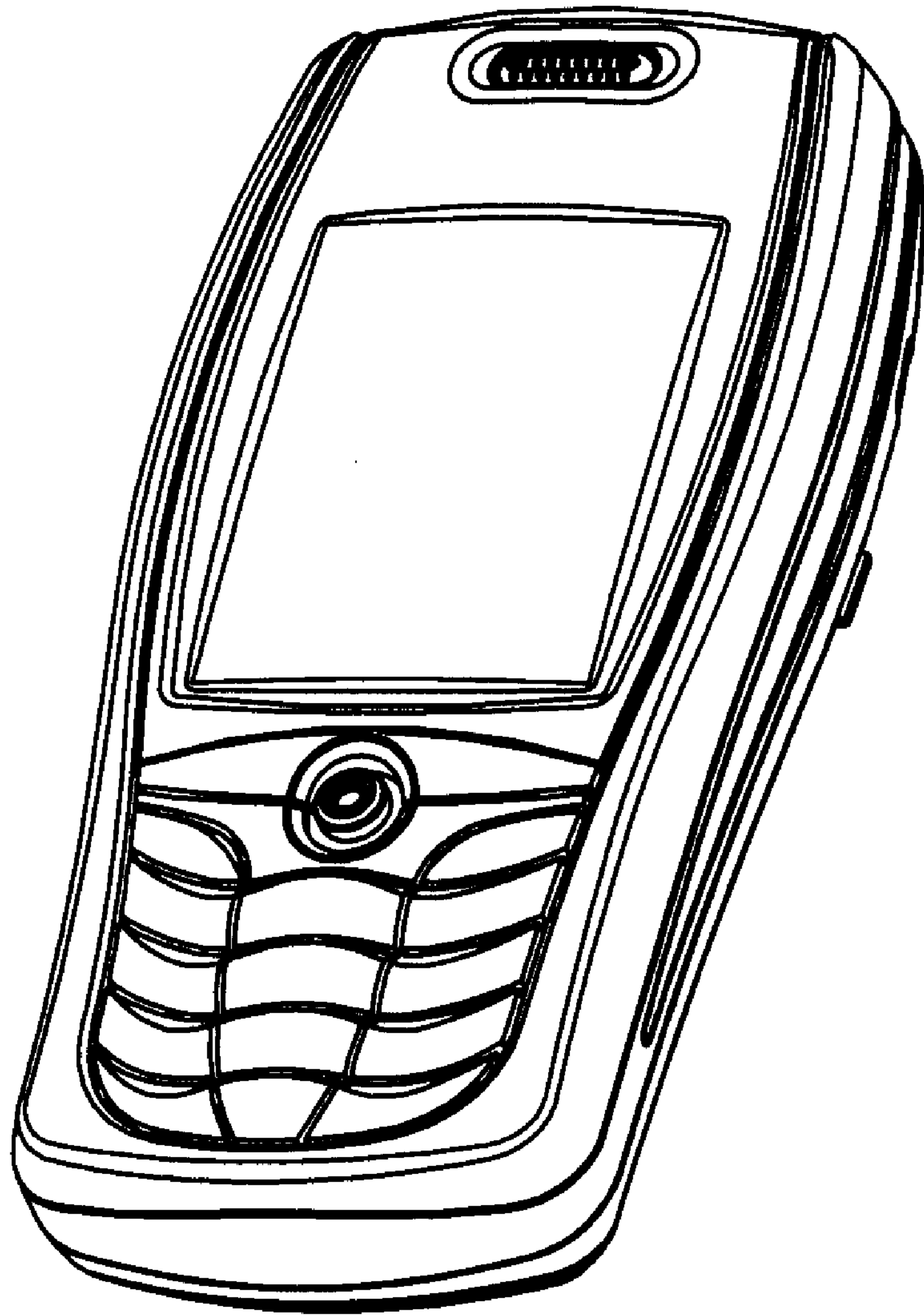

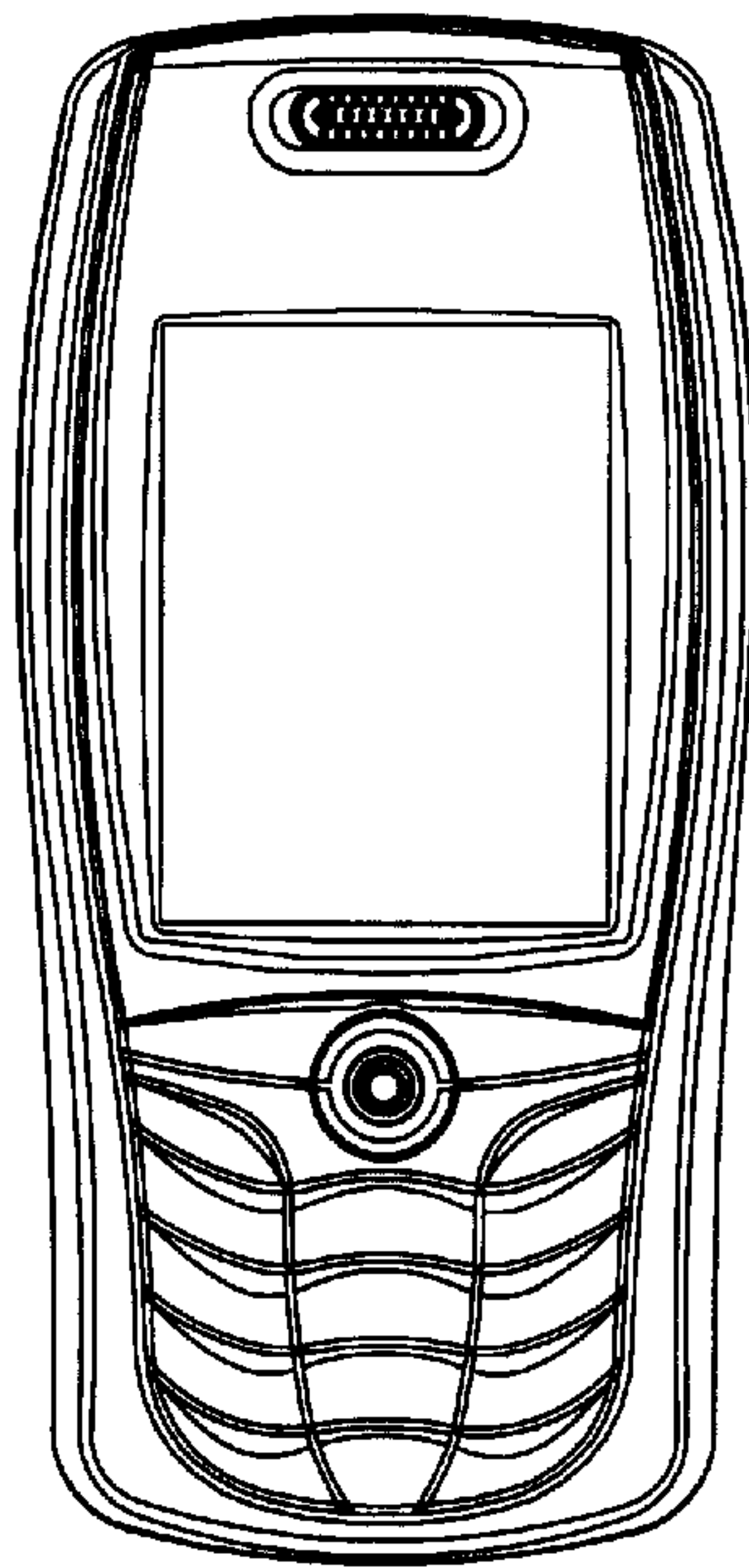

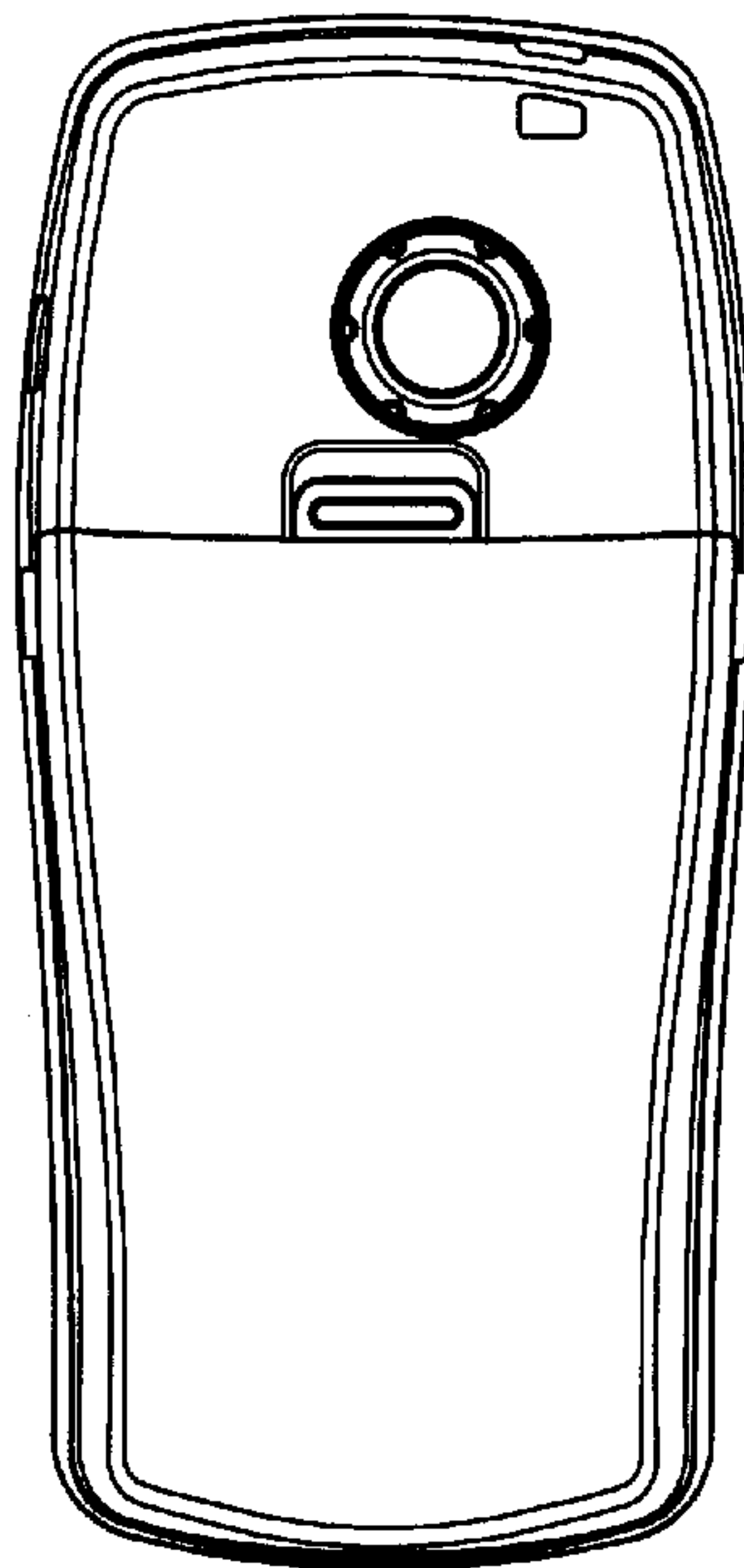

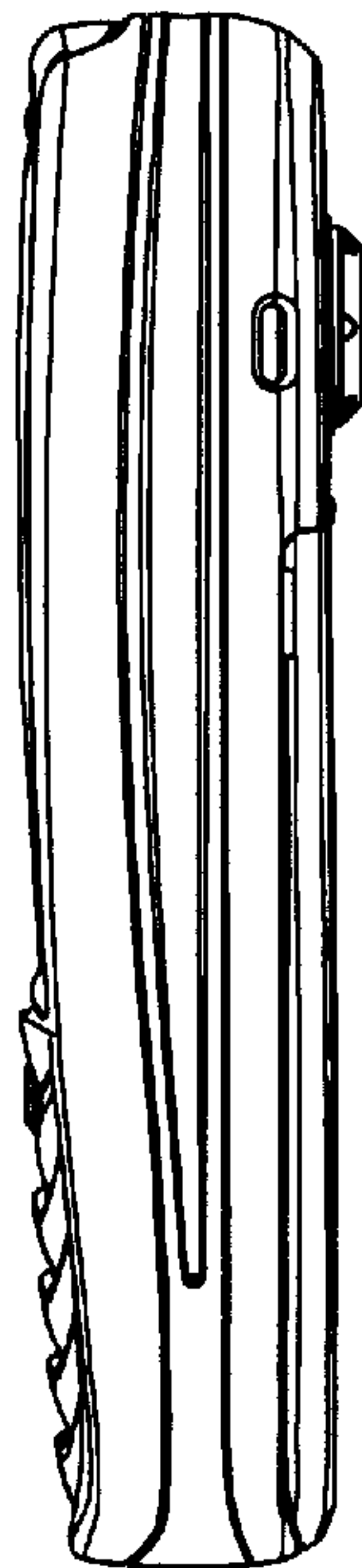

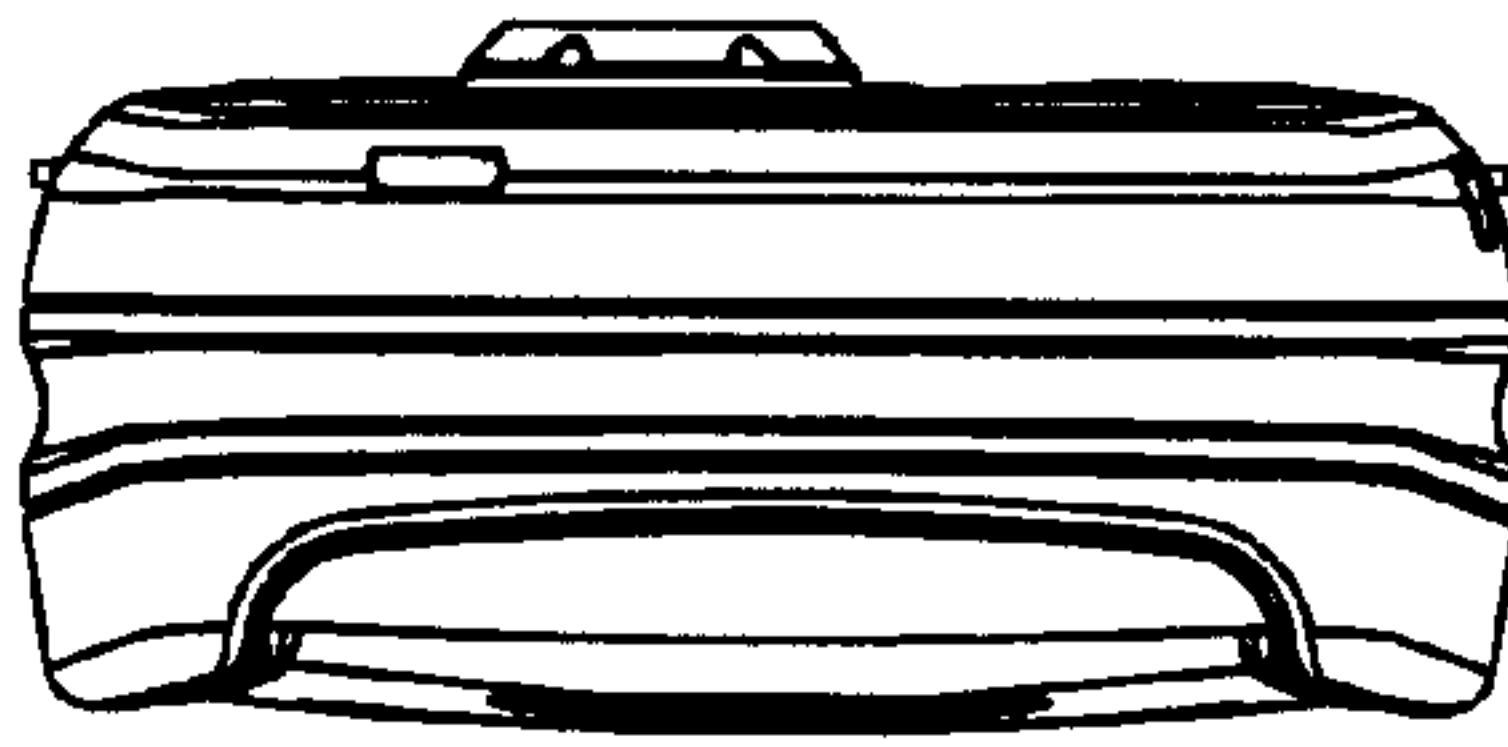

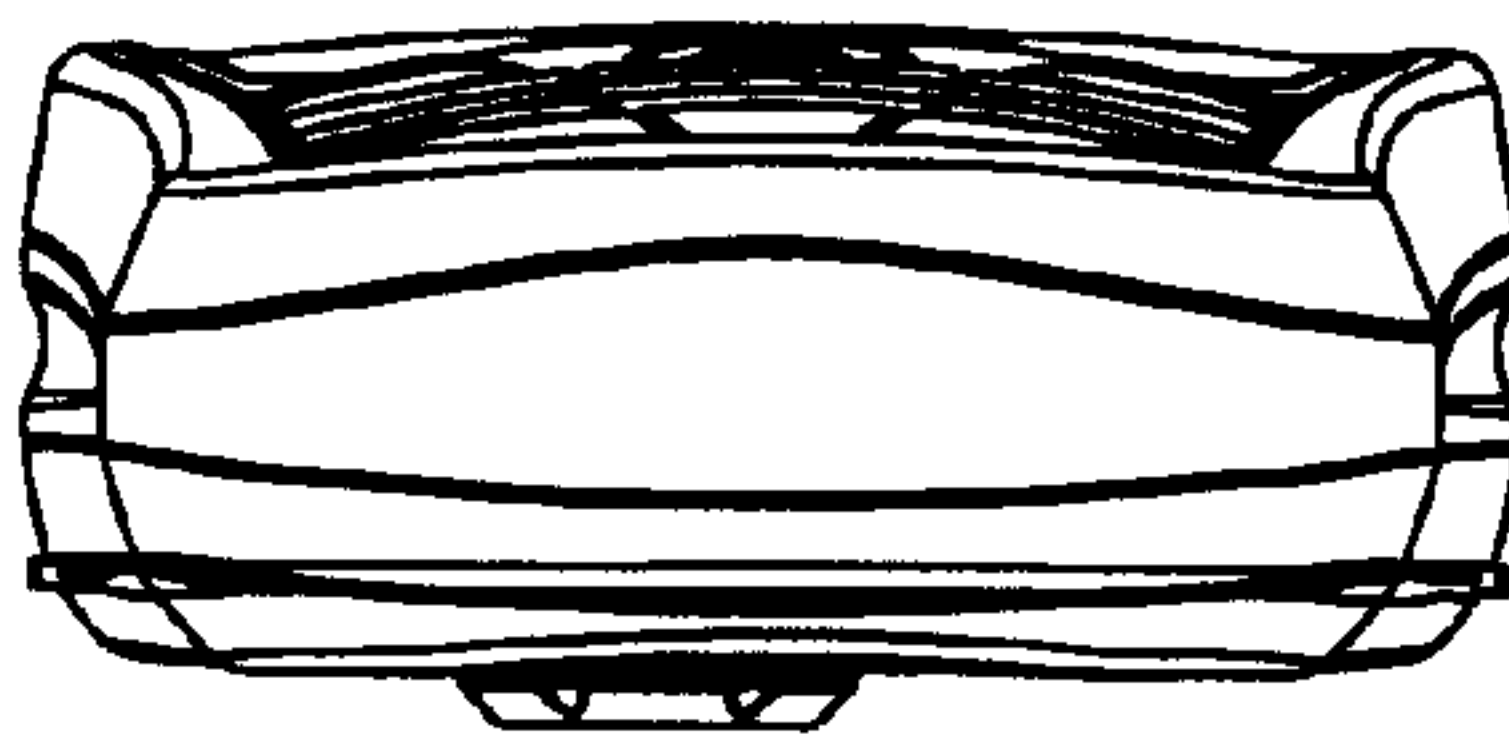
