(57) **CLAIM**

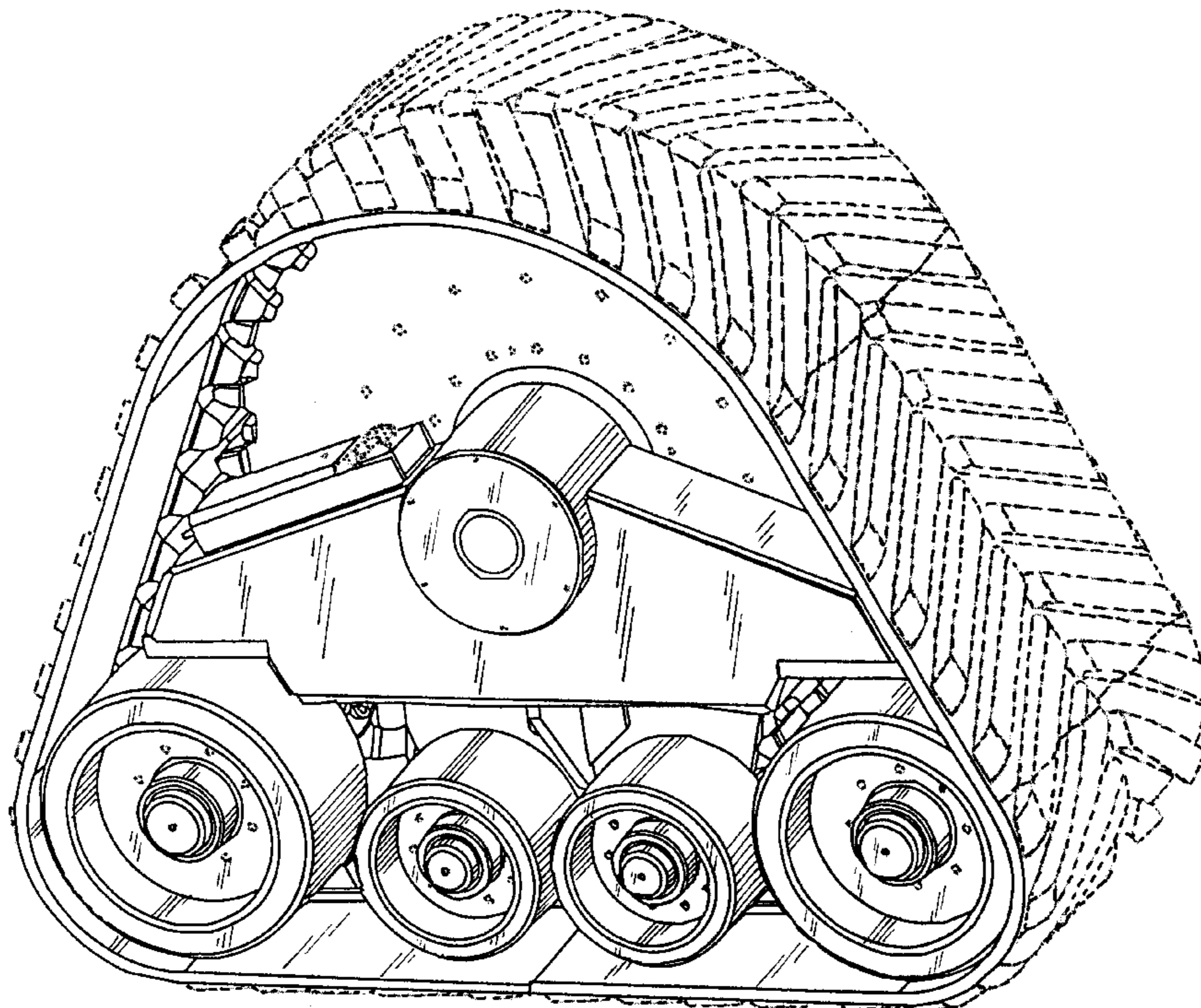
The ornamental design for a track apparatus for use in place of a vehicle wheel, substantially as shown and described.

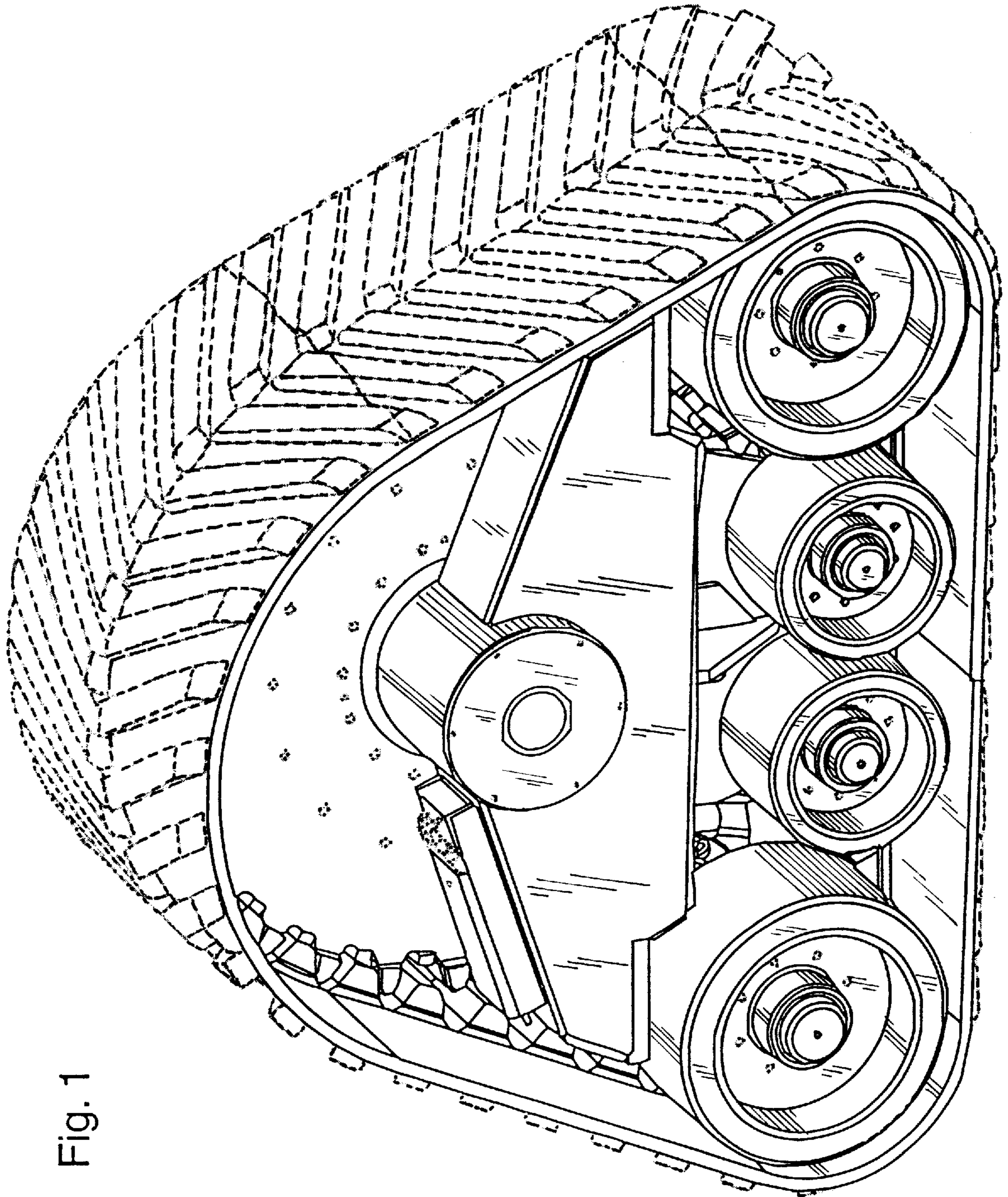

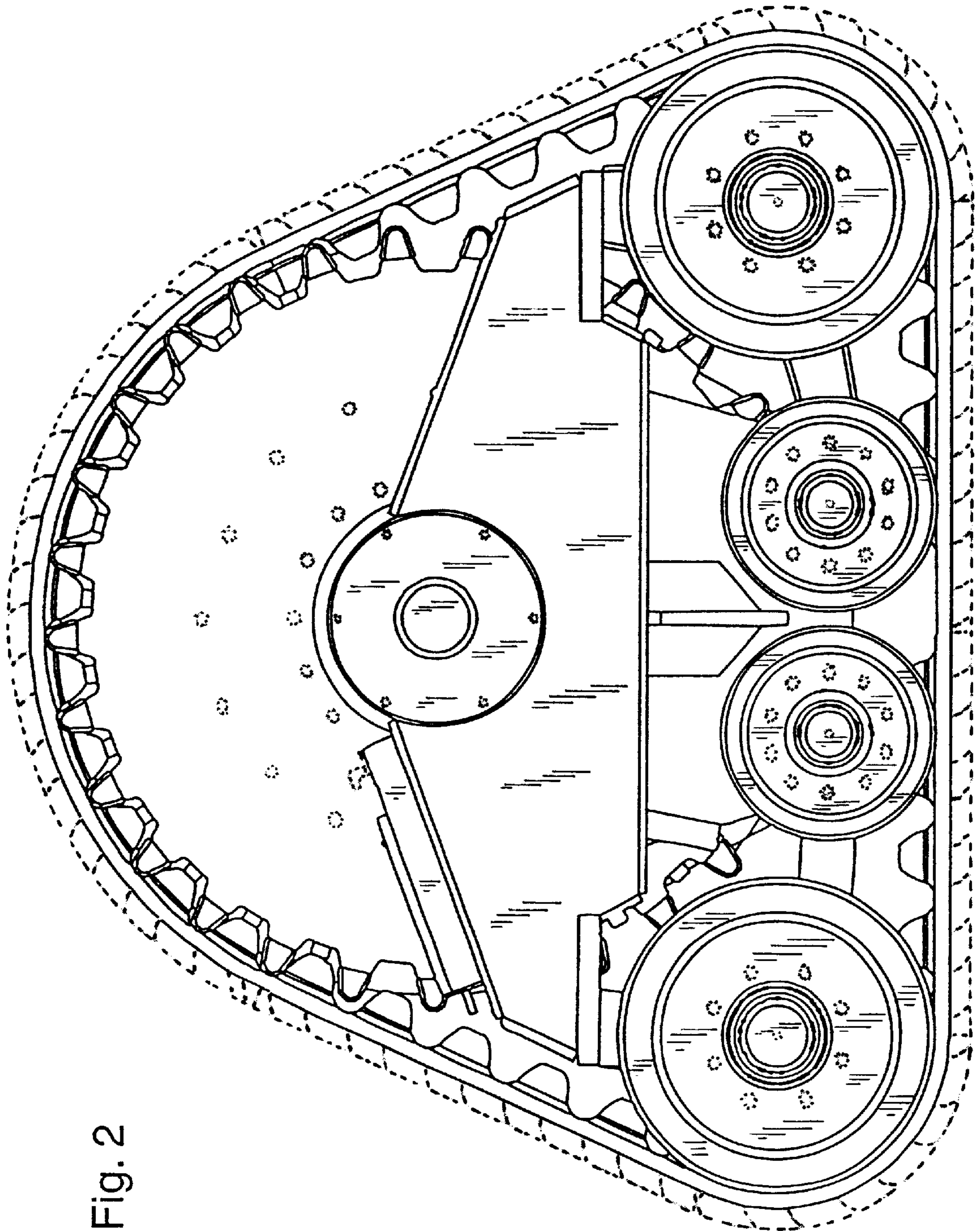

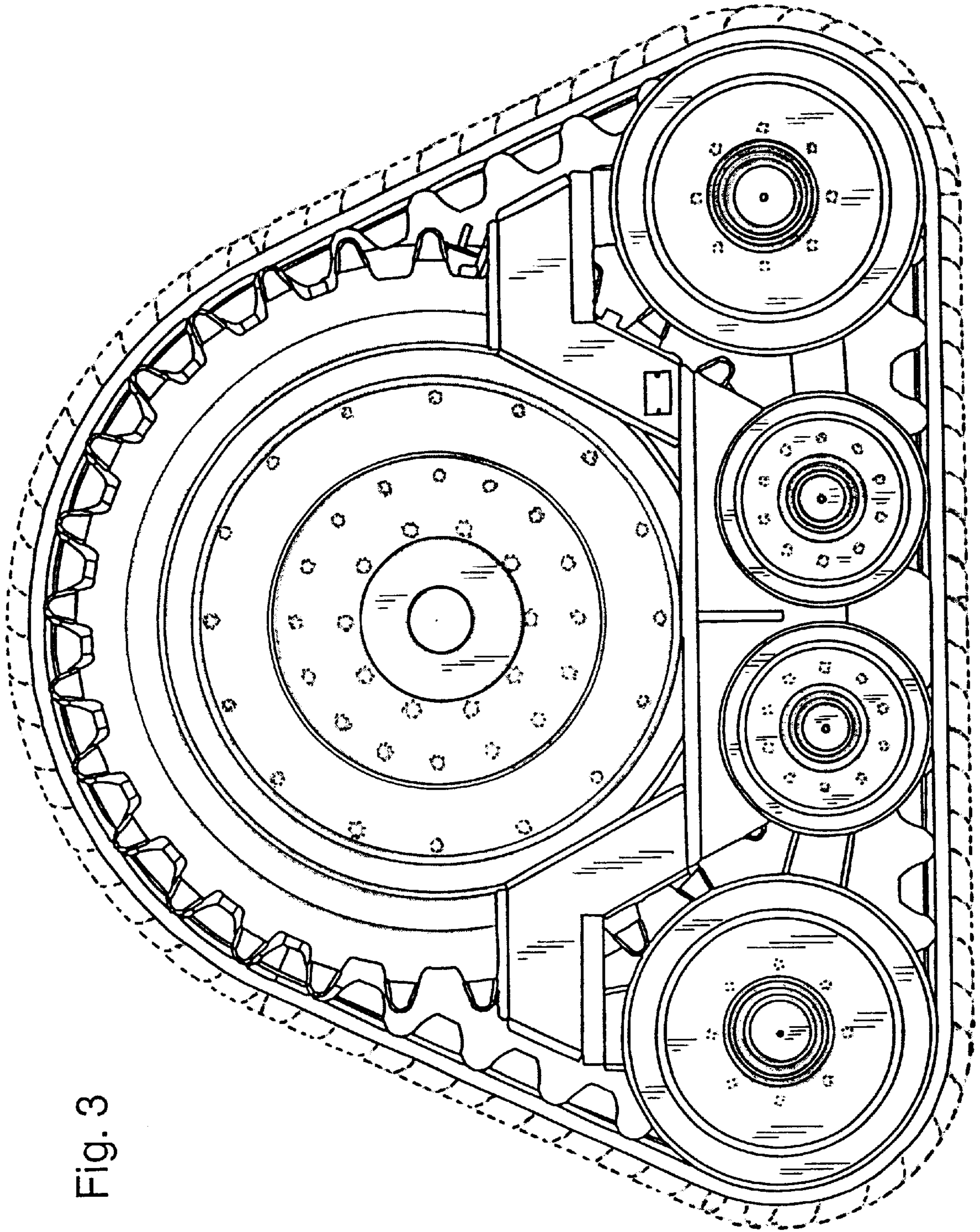

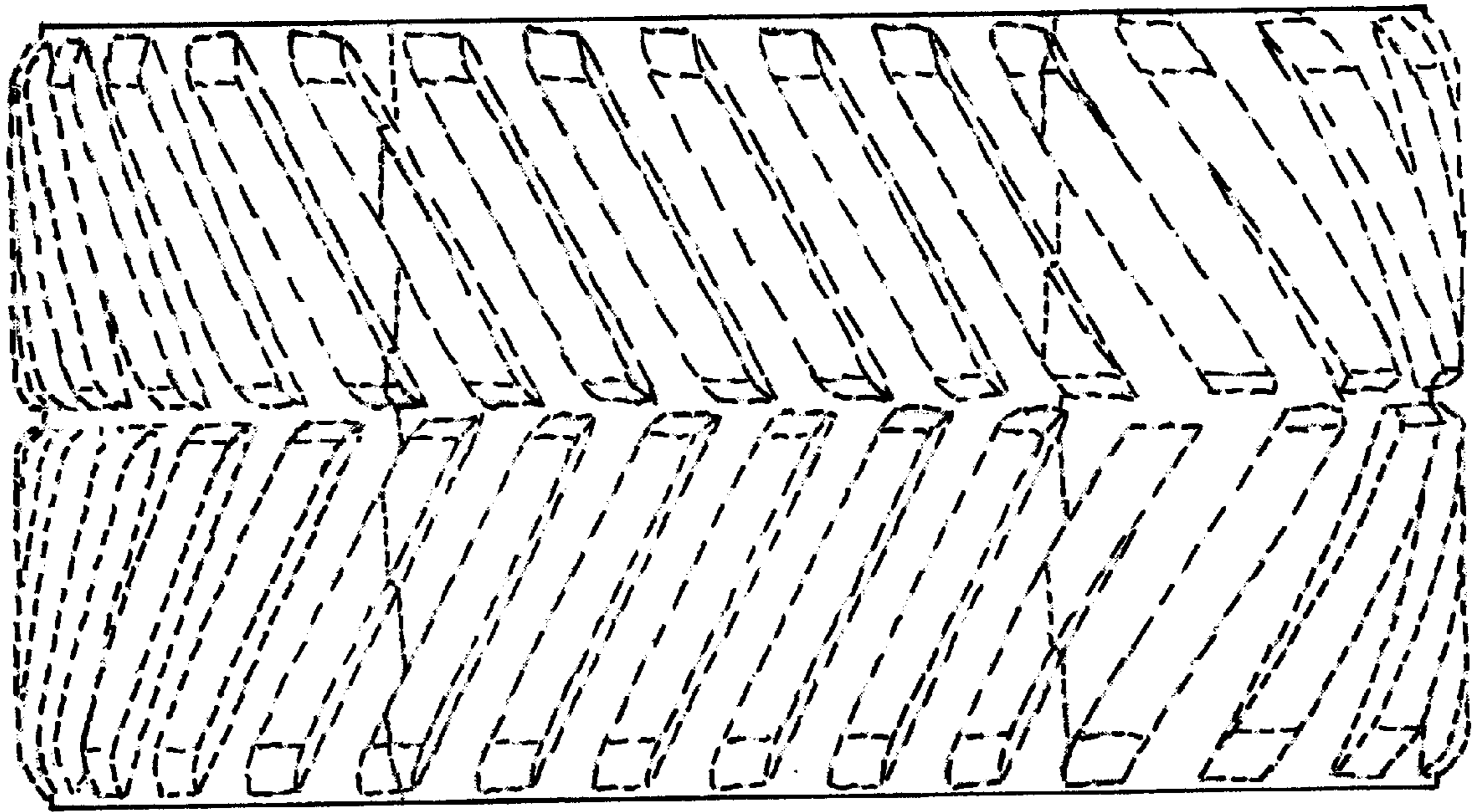

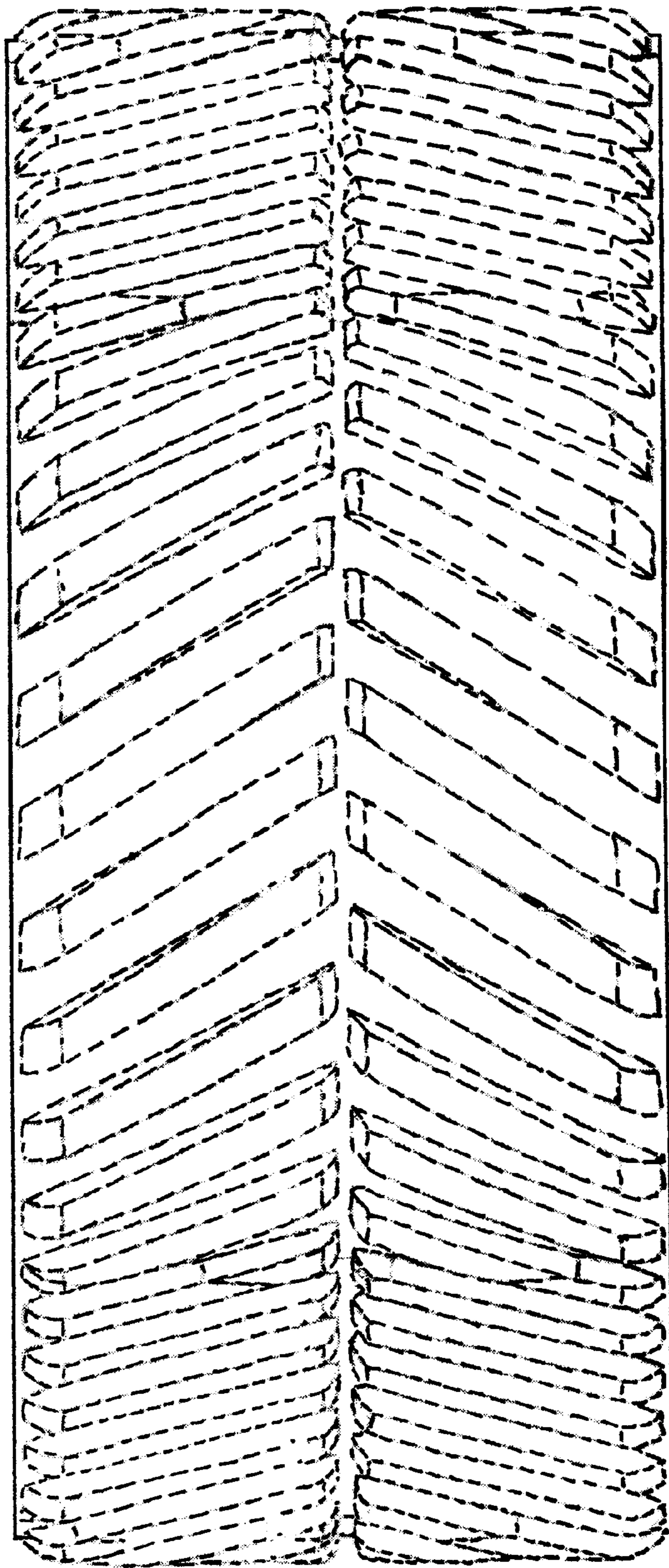

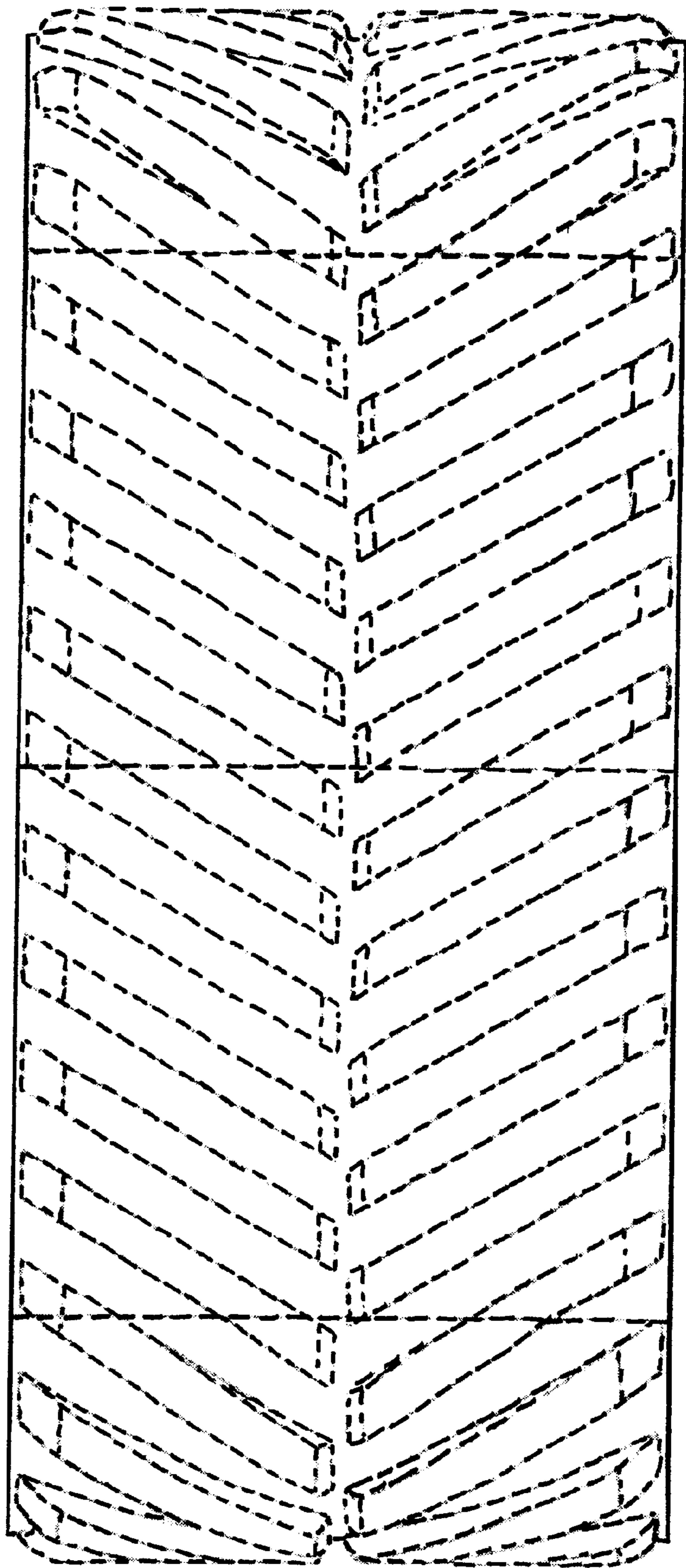
