FIG. 6 is a plan view of the washstand with pedestal of FIG. 1.

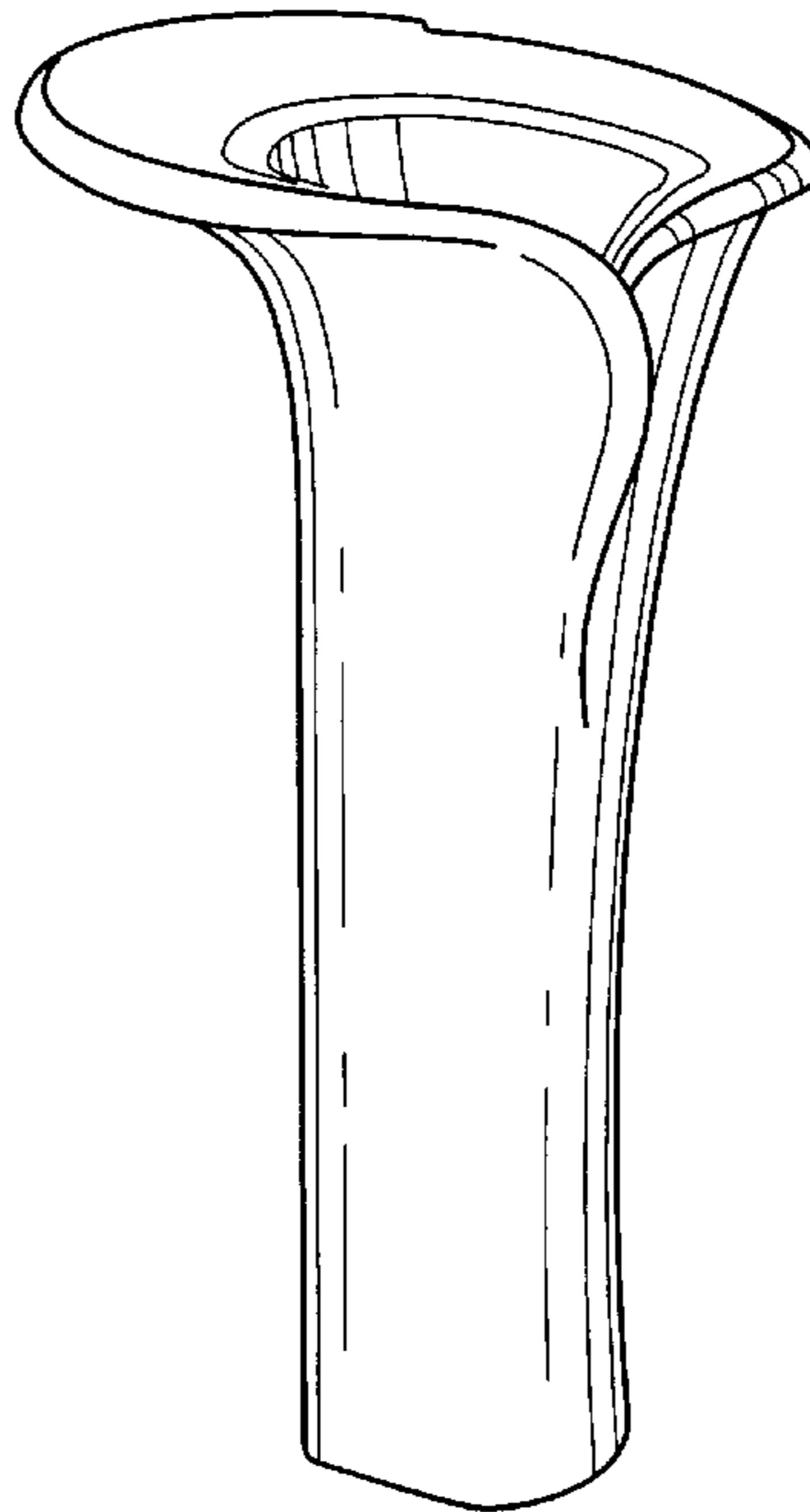
The bottom view of the washstand with pedestal of FIG. 1 is plain and unornamental.

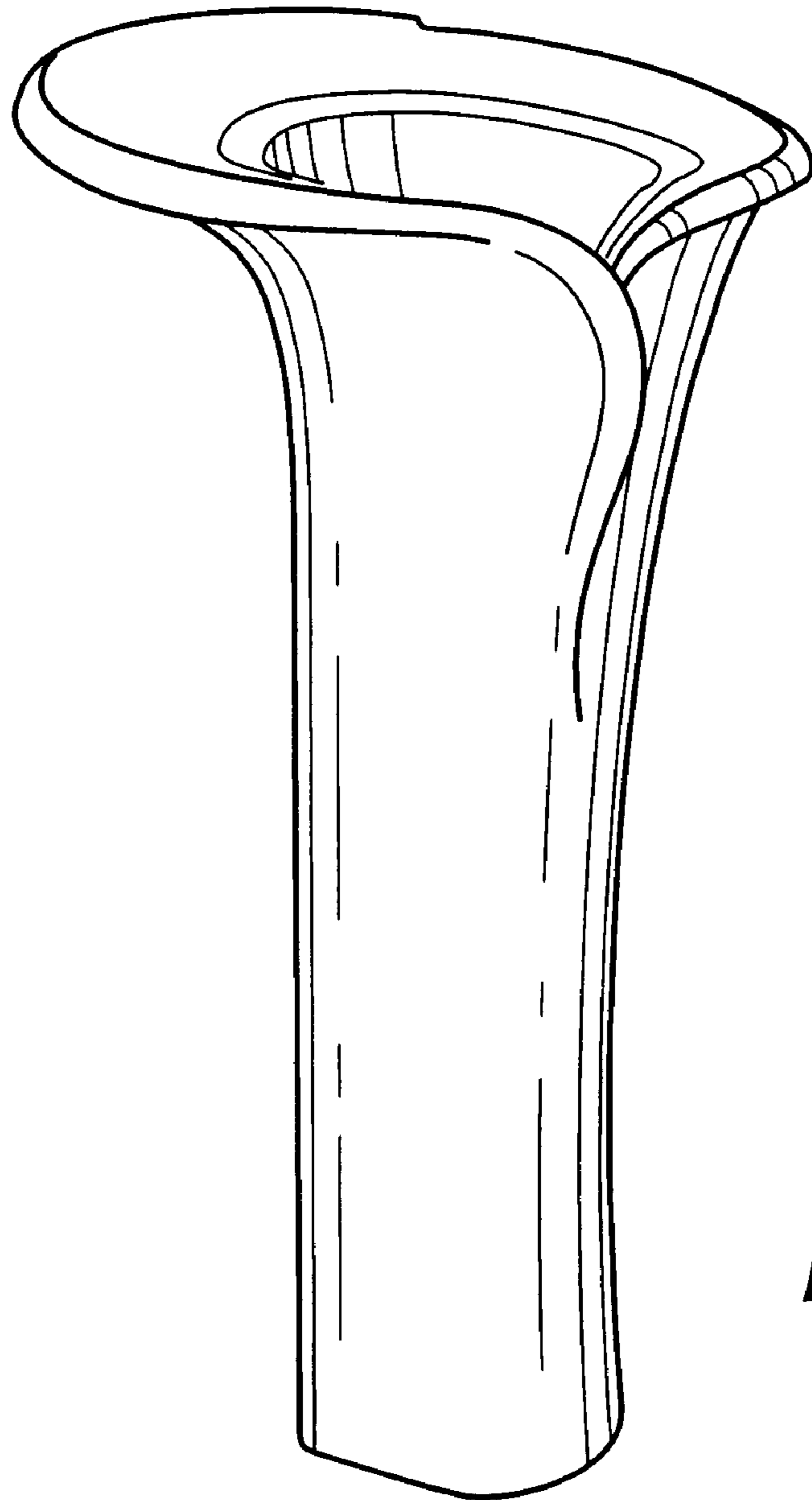

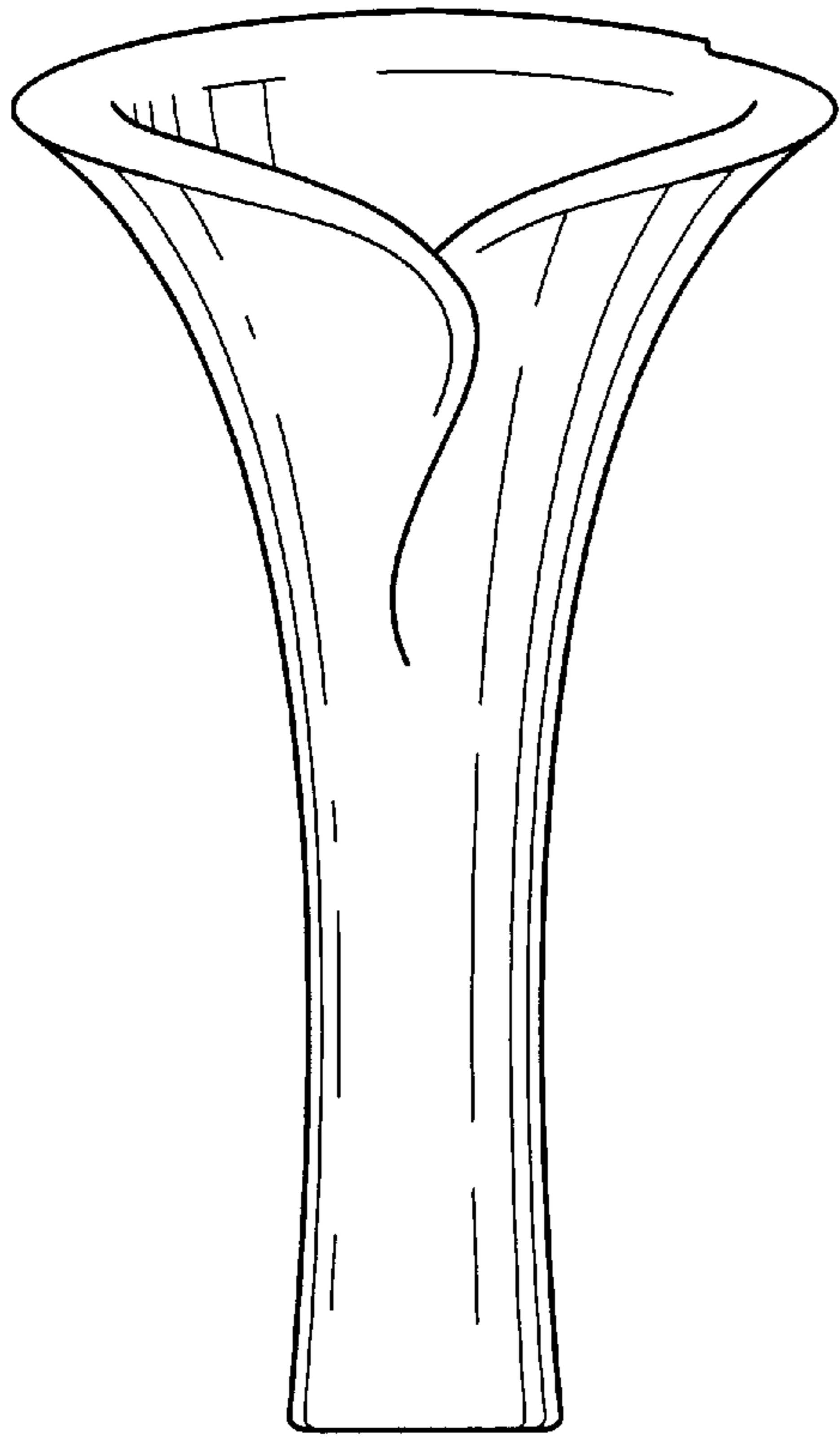

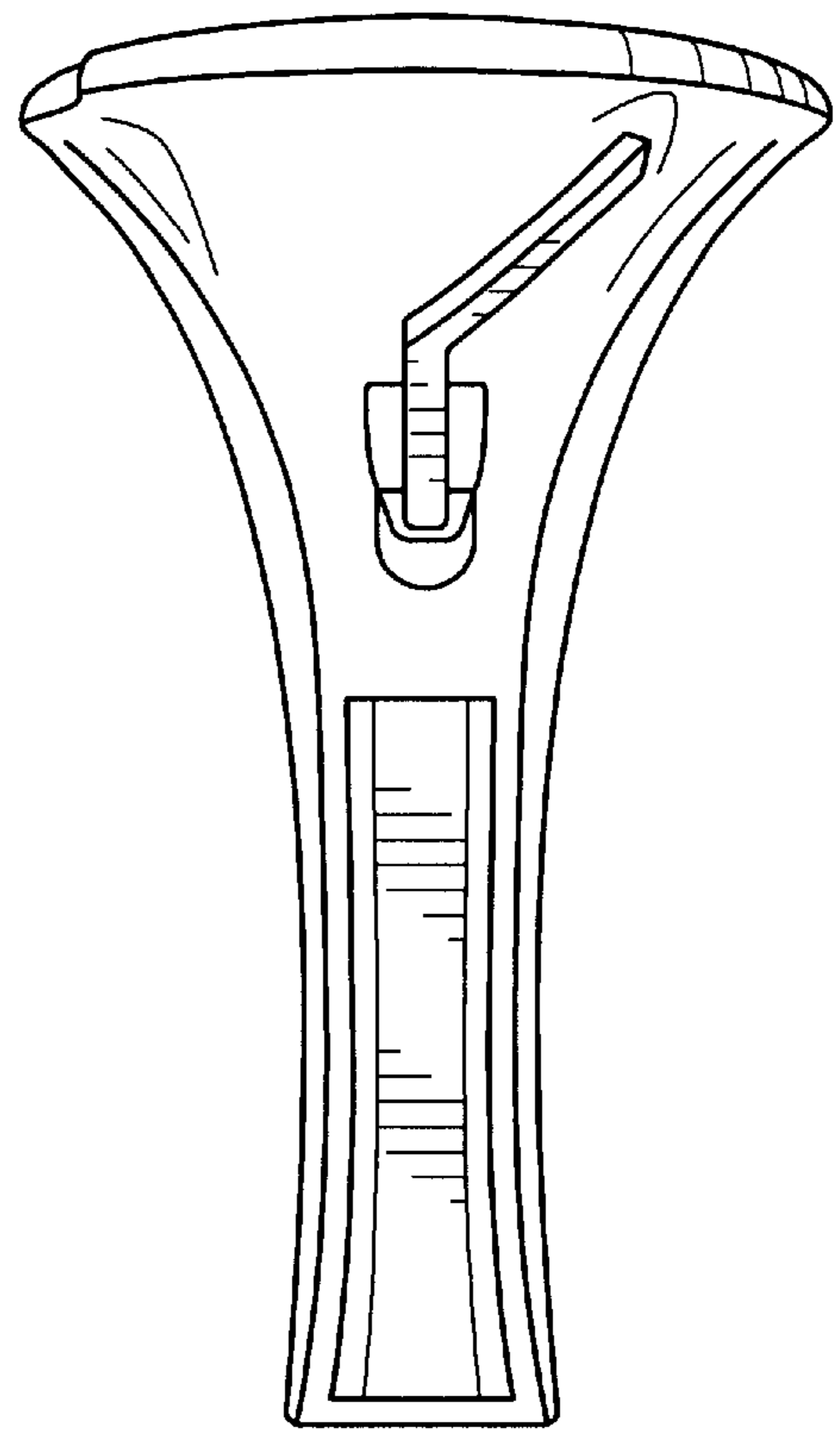

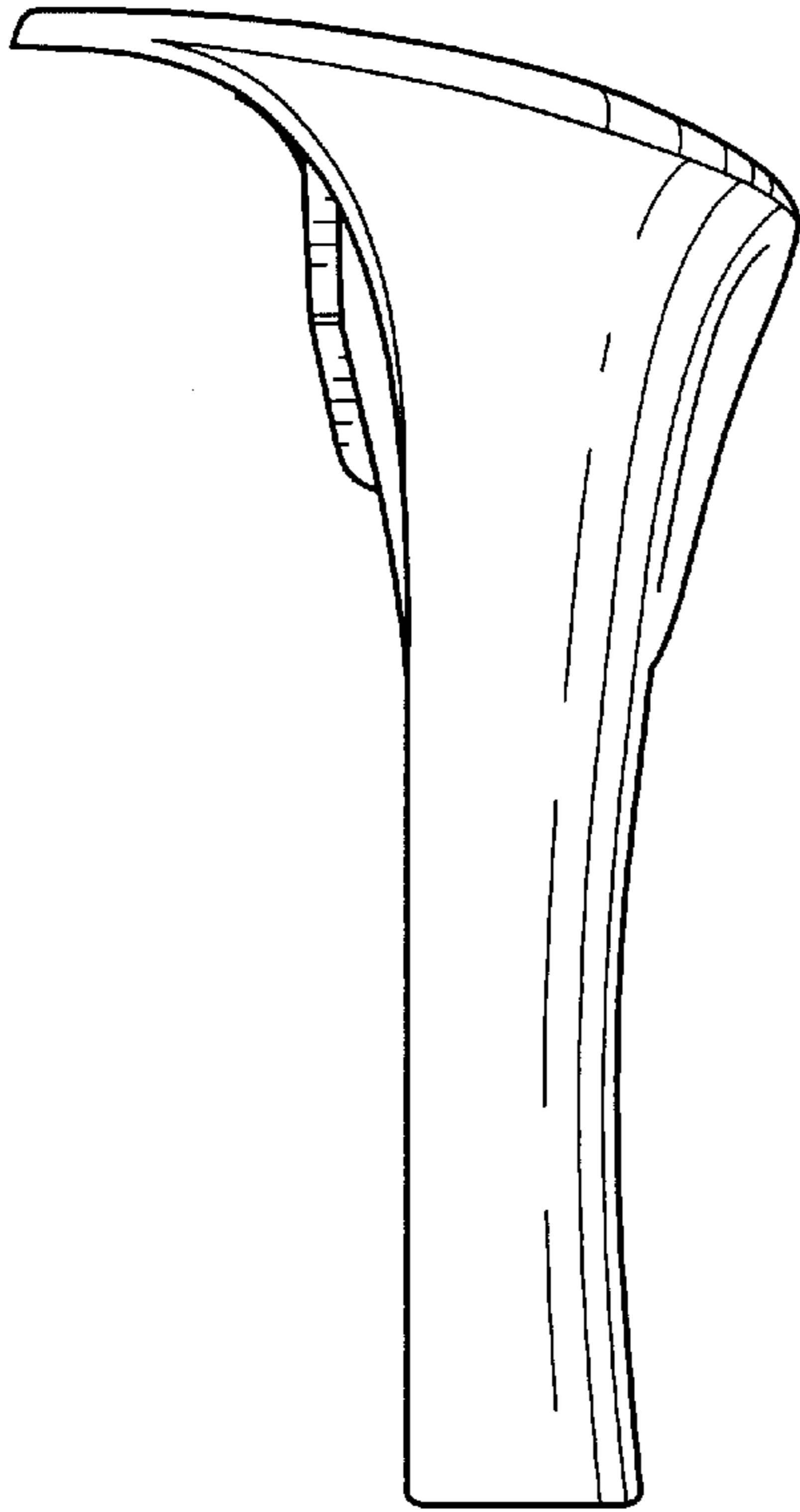

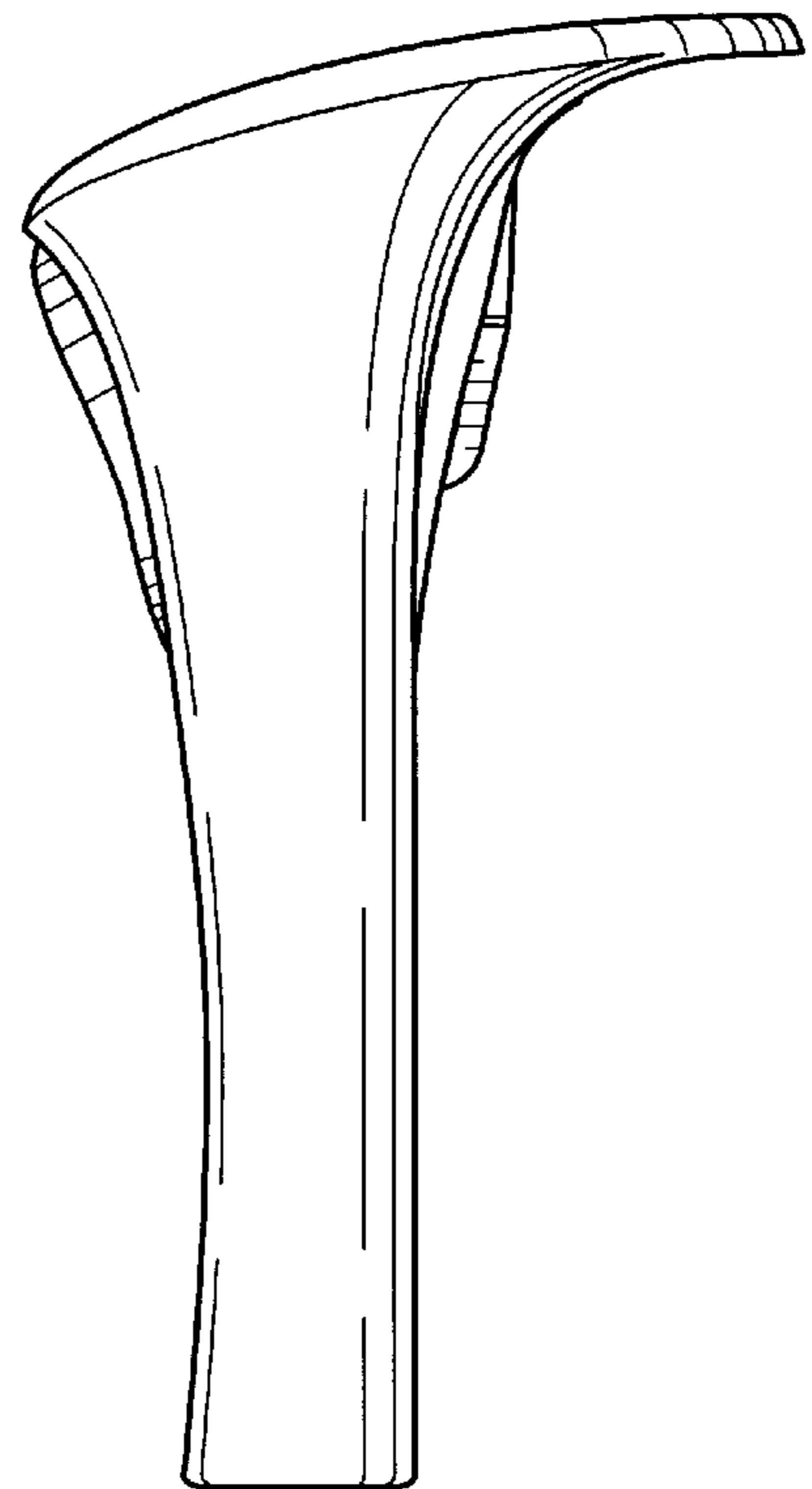

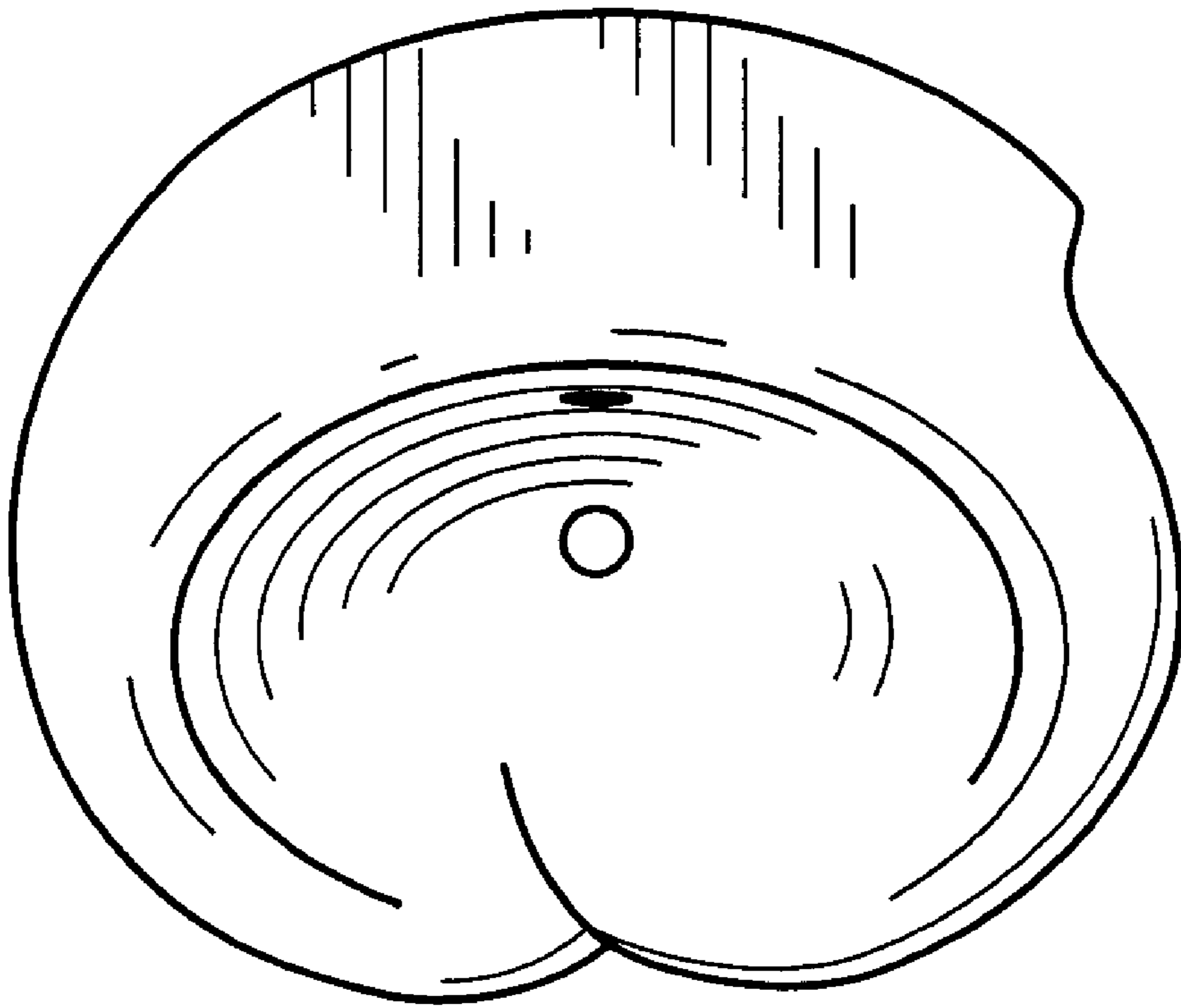
