(57) **CLAIM**

The ornamental design for a combined vacuum cleaner handle and attachments, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of the combined vacuum cleaner handle and attachments, showing my new design, with the broom unfolded and deployed and the brush in a retracted position;

FIG. 2 is a bottom perspective view thereof with the broom folded and the brush retracted;

FIG. 3 is a bottom perspective view thereof with the brush extended;

FIG. 4 is a bottom perspective view thereof with the telescoping wand attachment reversed and in an extended position;

FIG. 5 is a top perspective view of FIG. 4;

FIG. 6 is a top perspective view of FIG. 1;

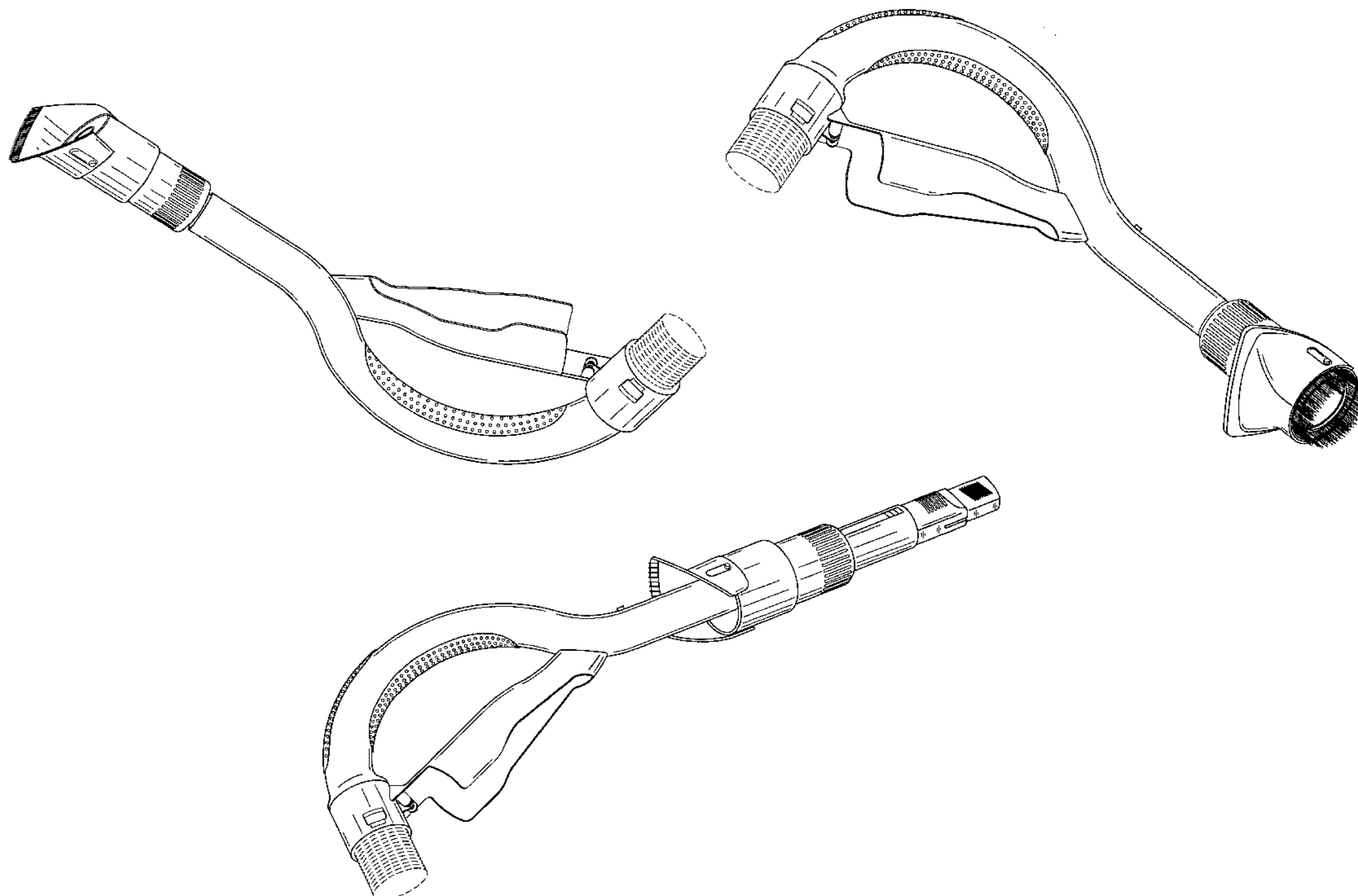
FIG. 7 is a top perspective view of FIG. 3 with the broom rotated;

FIG. 8 is a top perspective view of FIG. 2;

FIG. 9 is a top perspective view of FIG. 3; and,

FIG. 10 is a top perspective view of FIG. 3 with the broom rotated and brush in a retracted position.

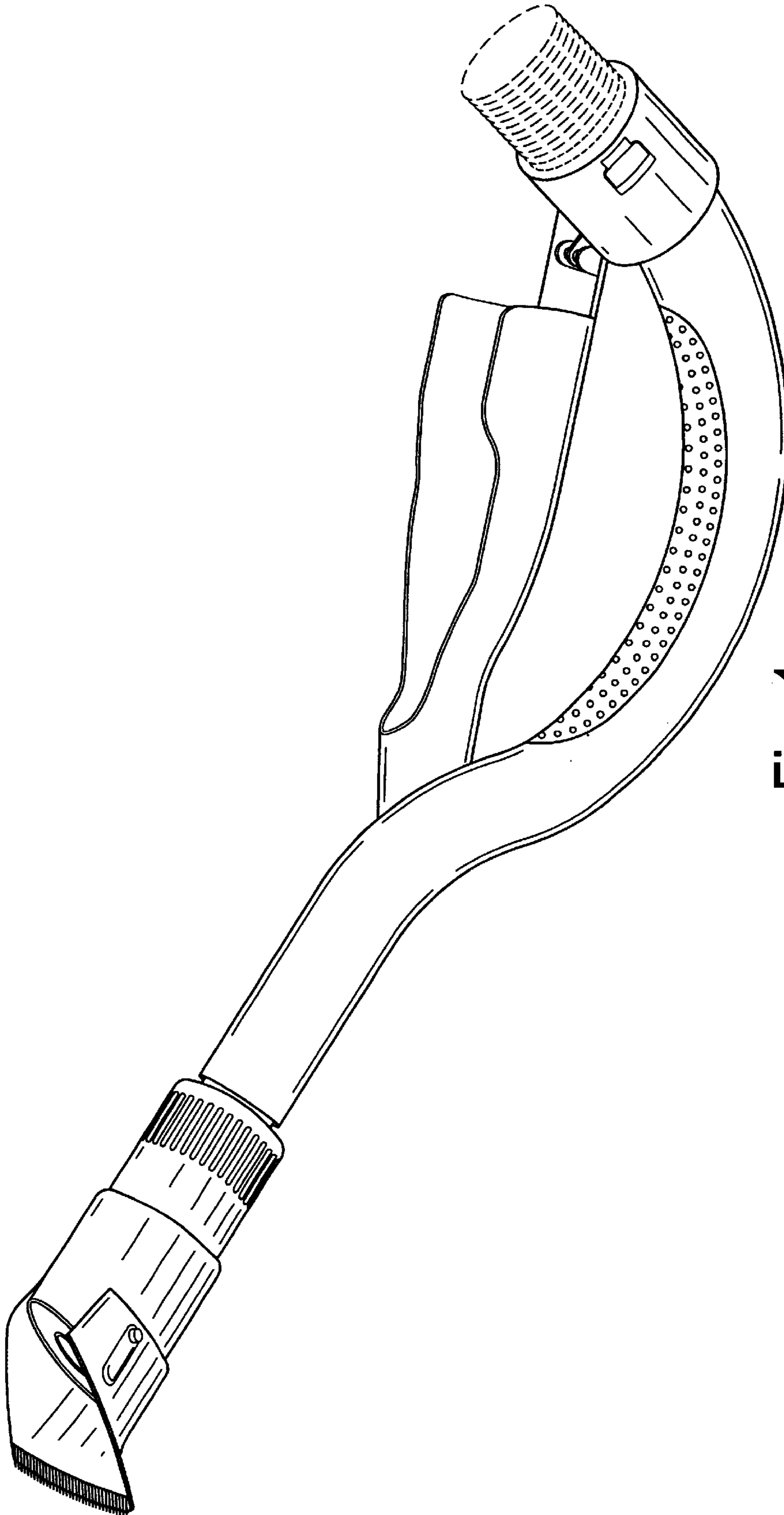

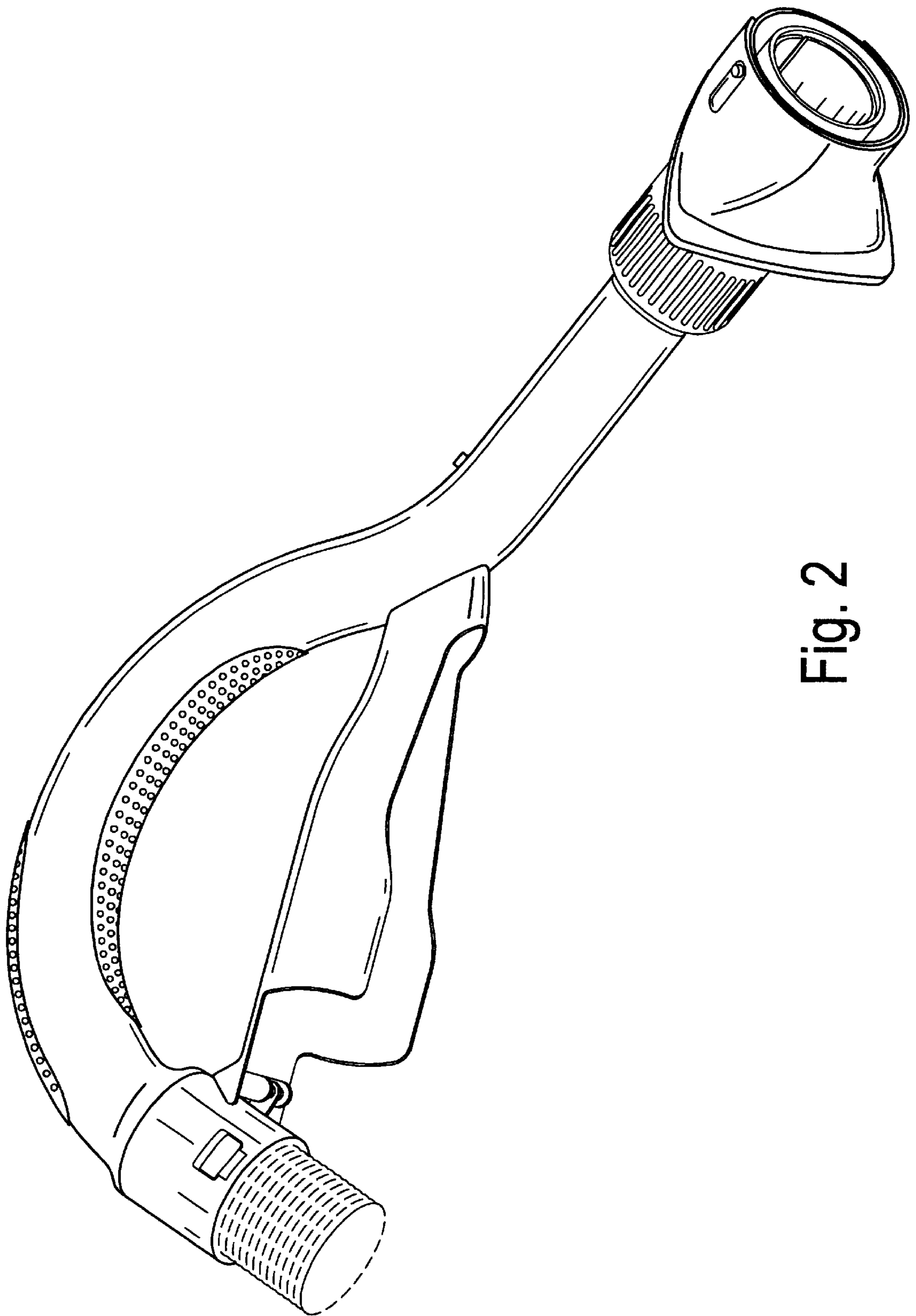

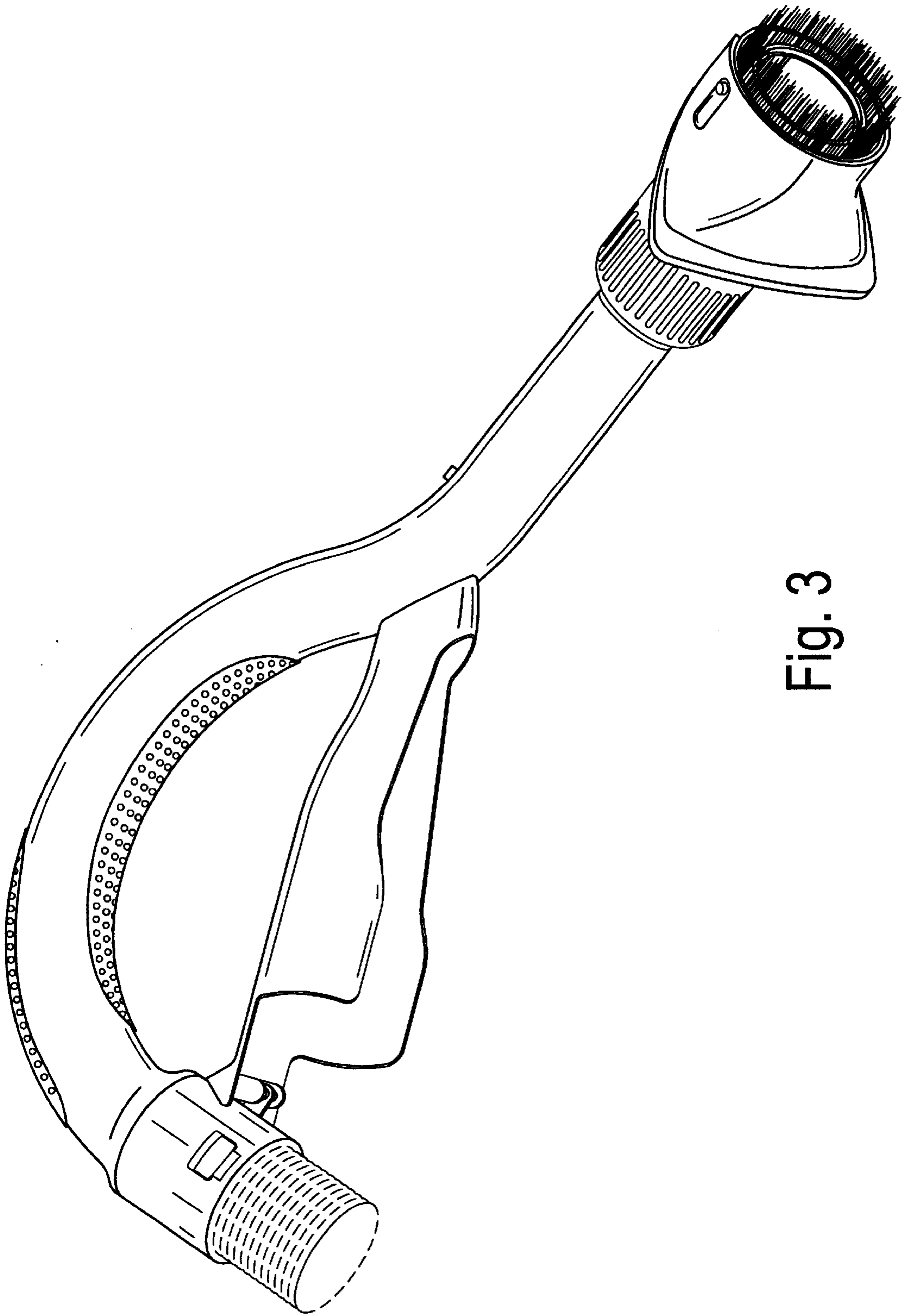

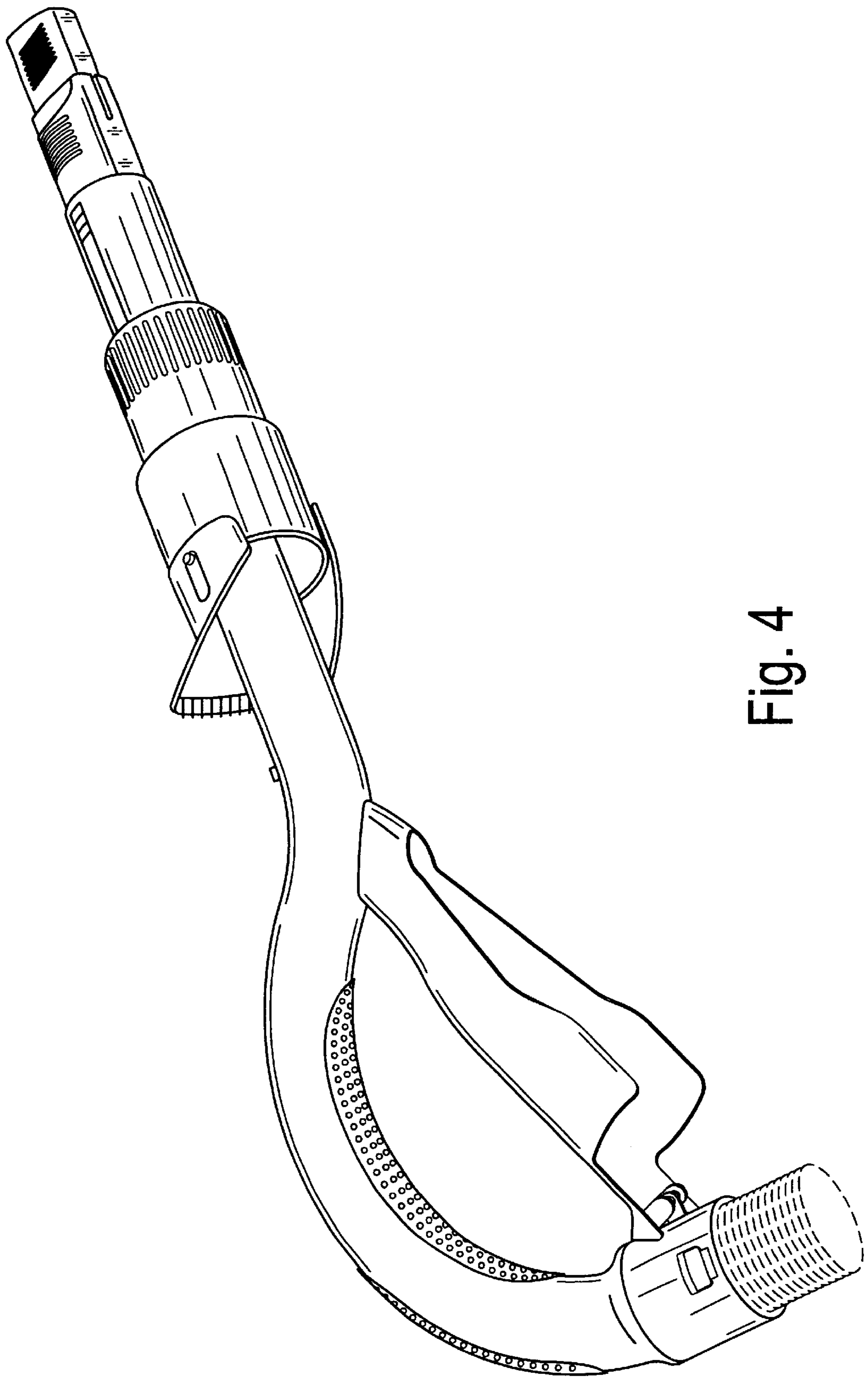

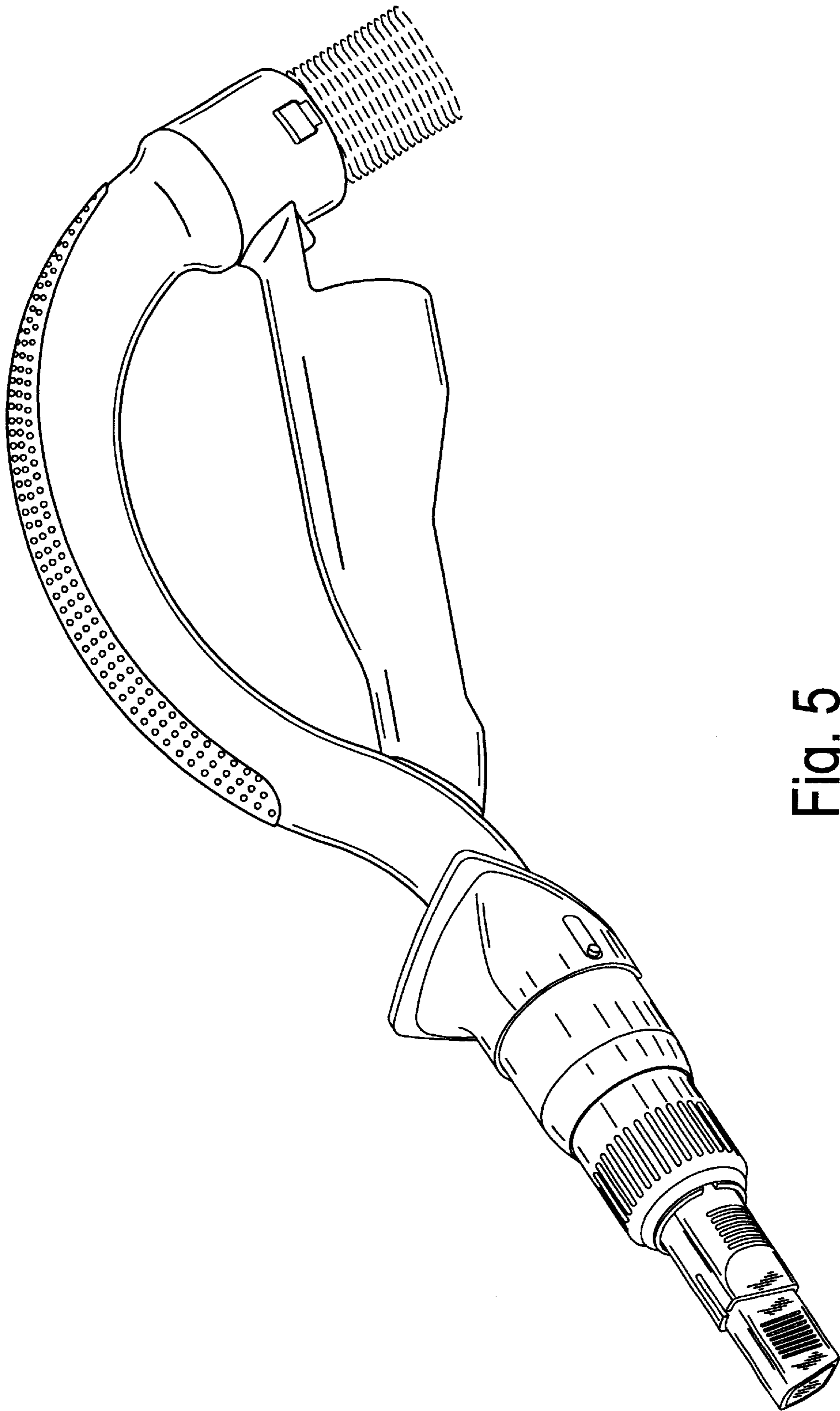

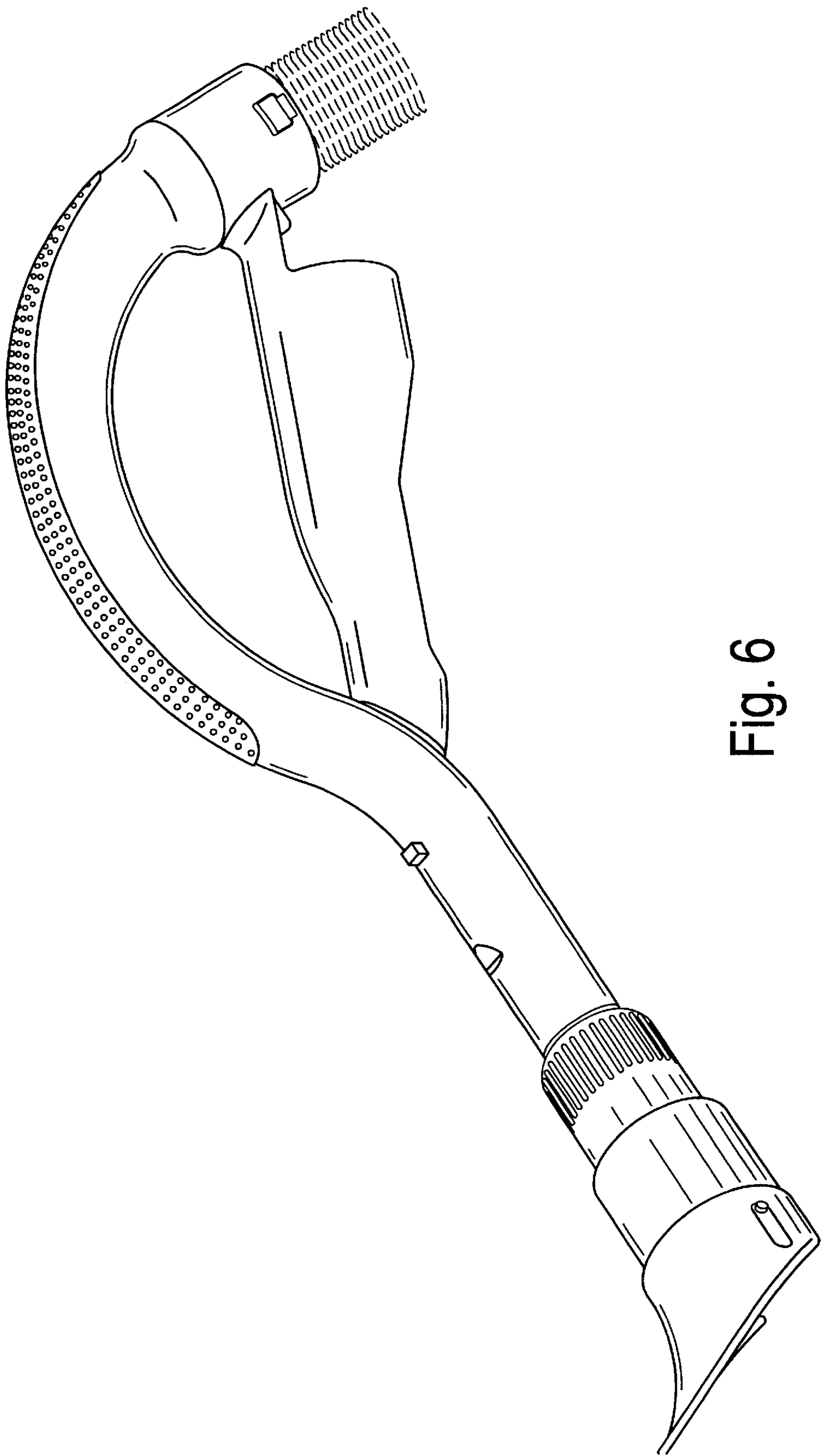

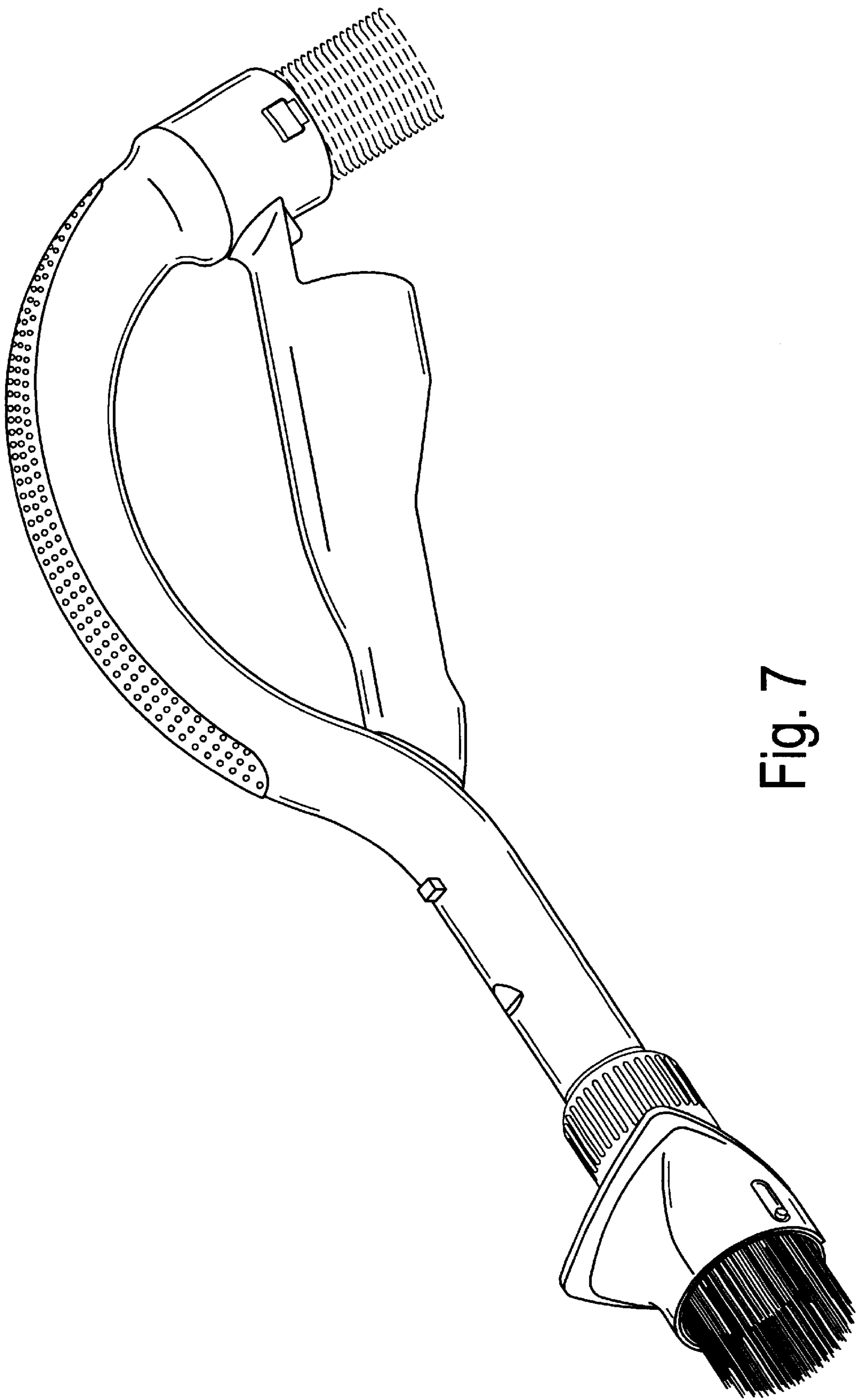

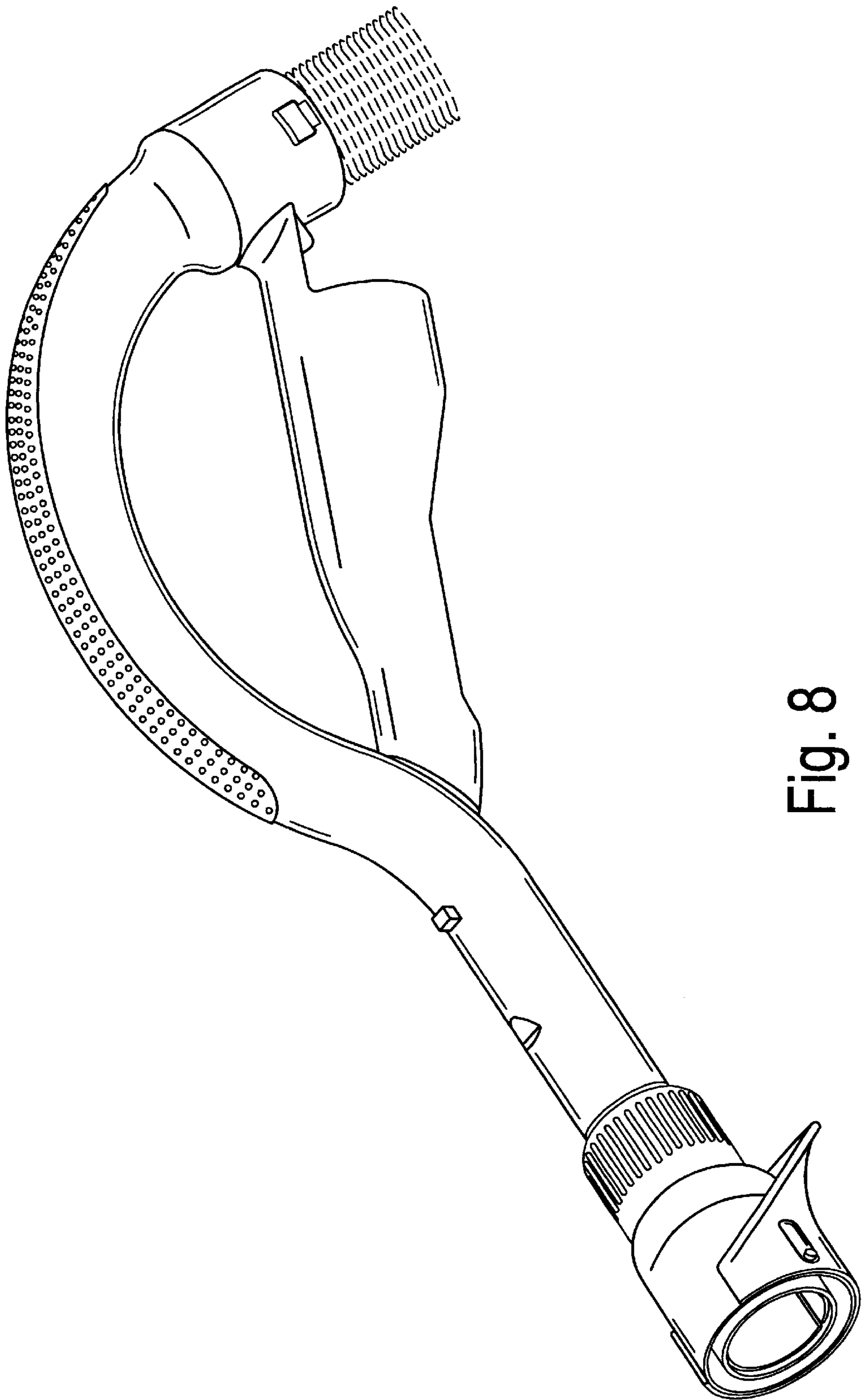

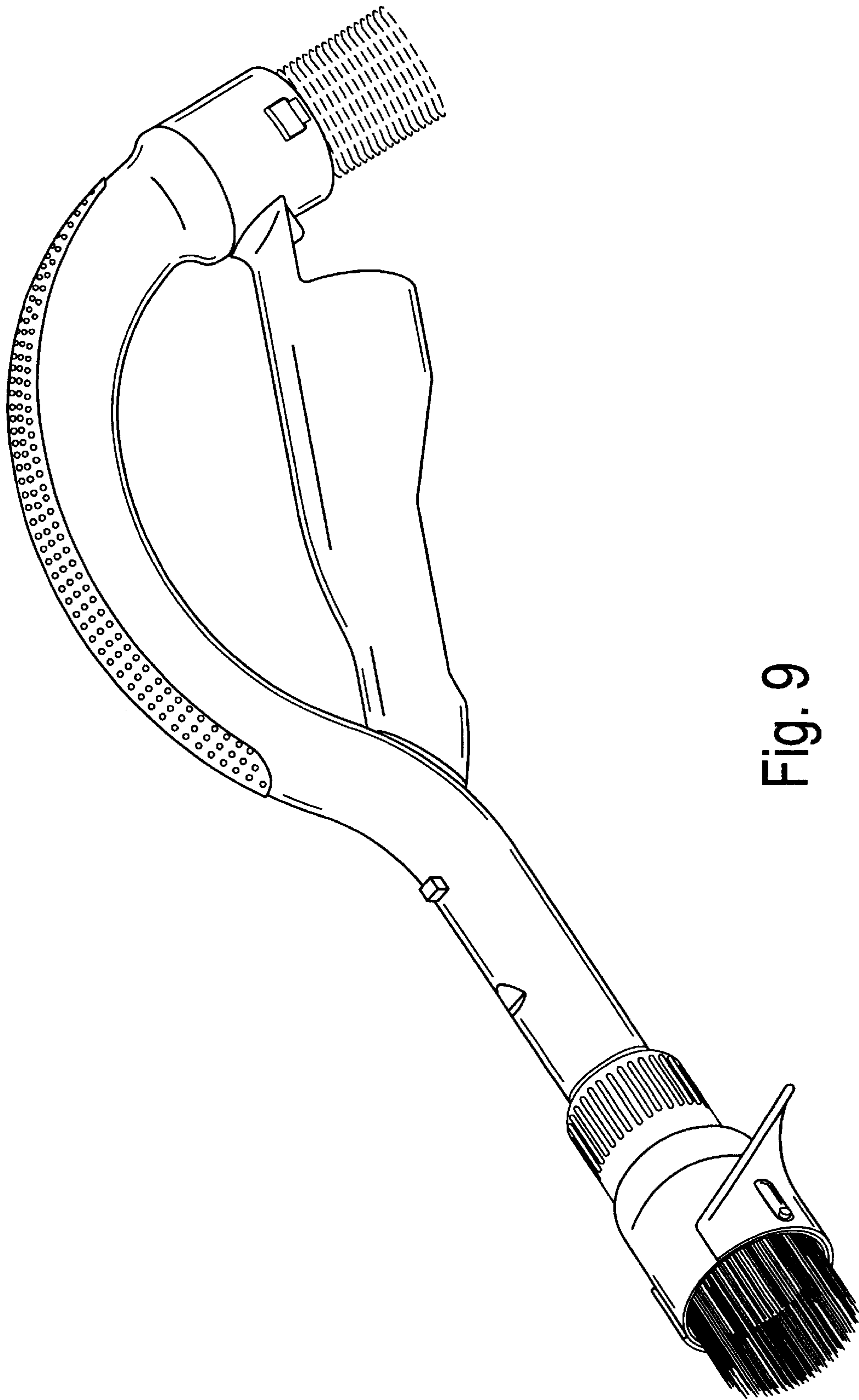

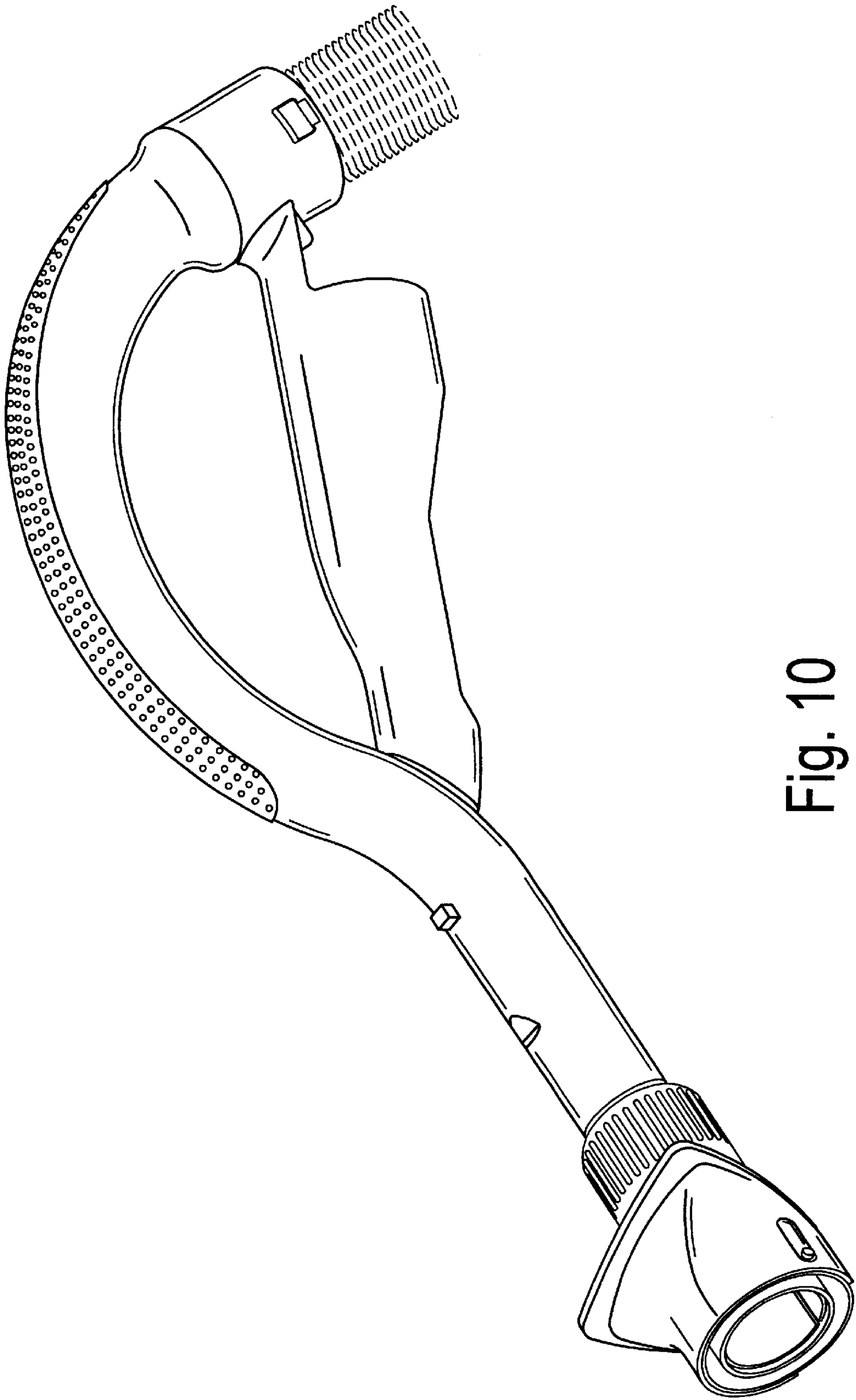
