We claim the ornamental design for candy cane-shaped chew, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a candy cane-shaped chew showing my new design;
FIG. 2 is a side elevational view opposite FIG. 1 thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right end elevational view thereof; and,

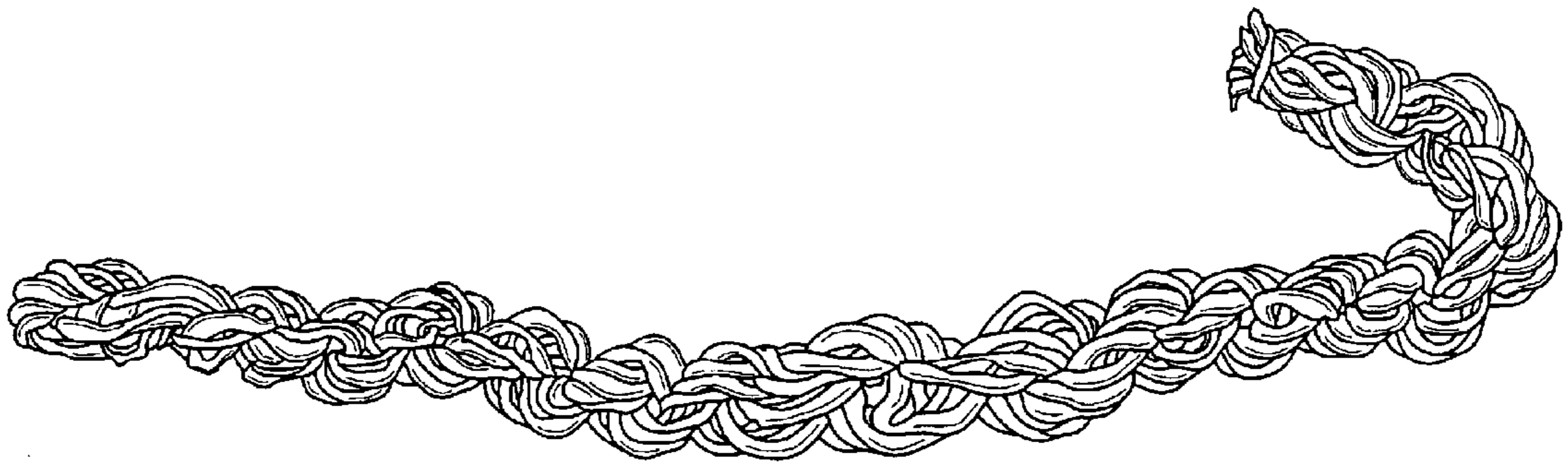

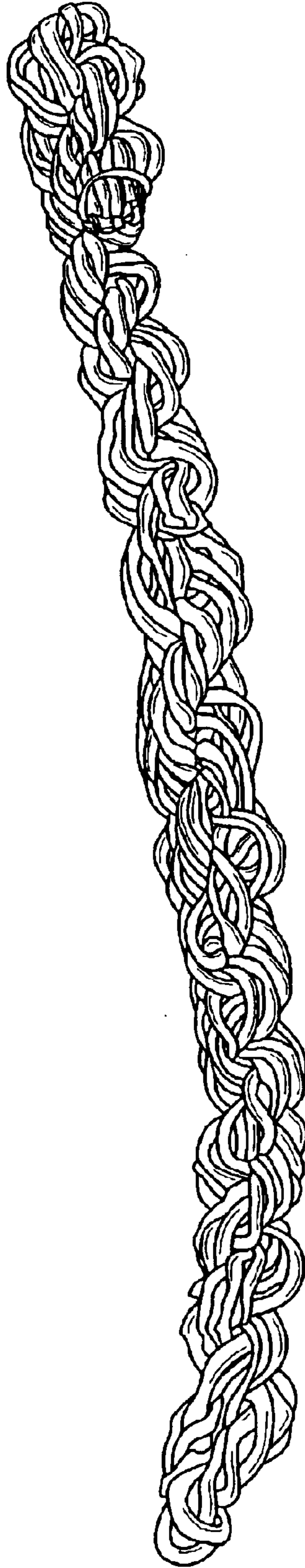

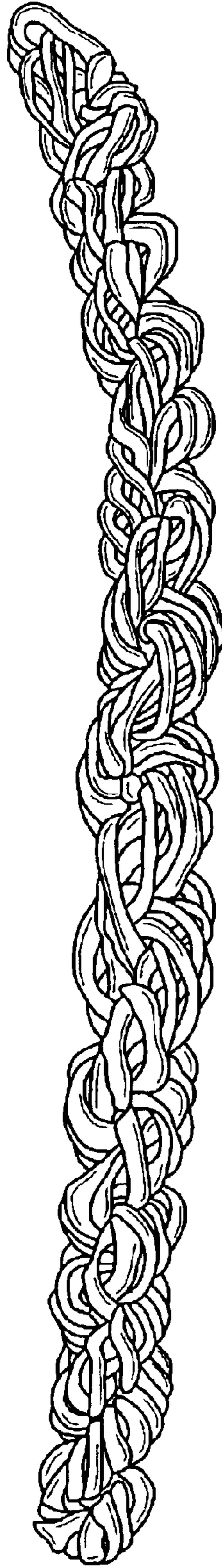
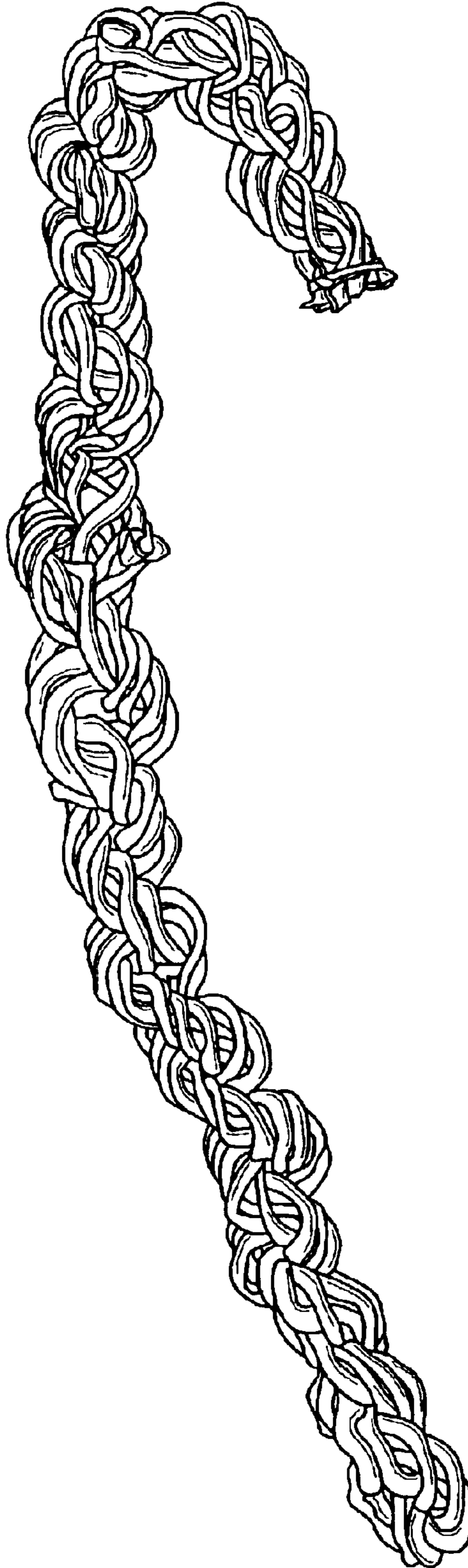

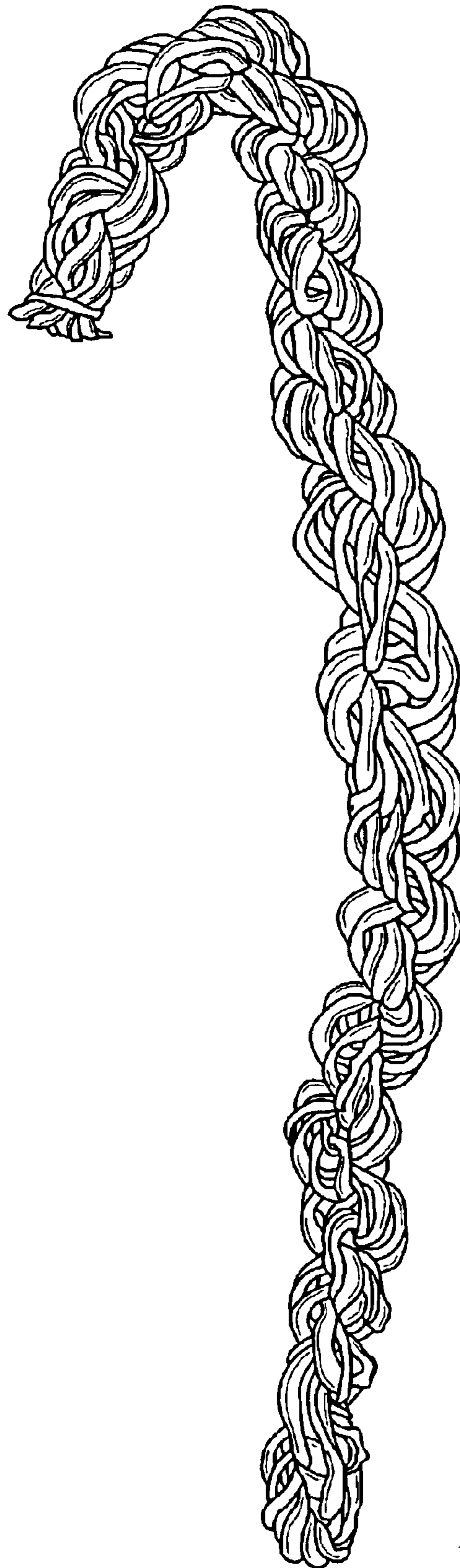

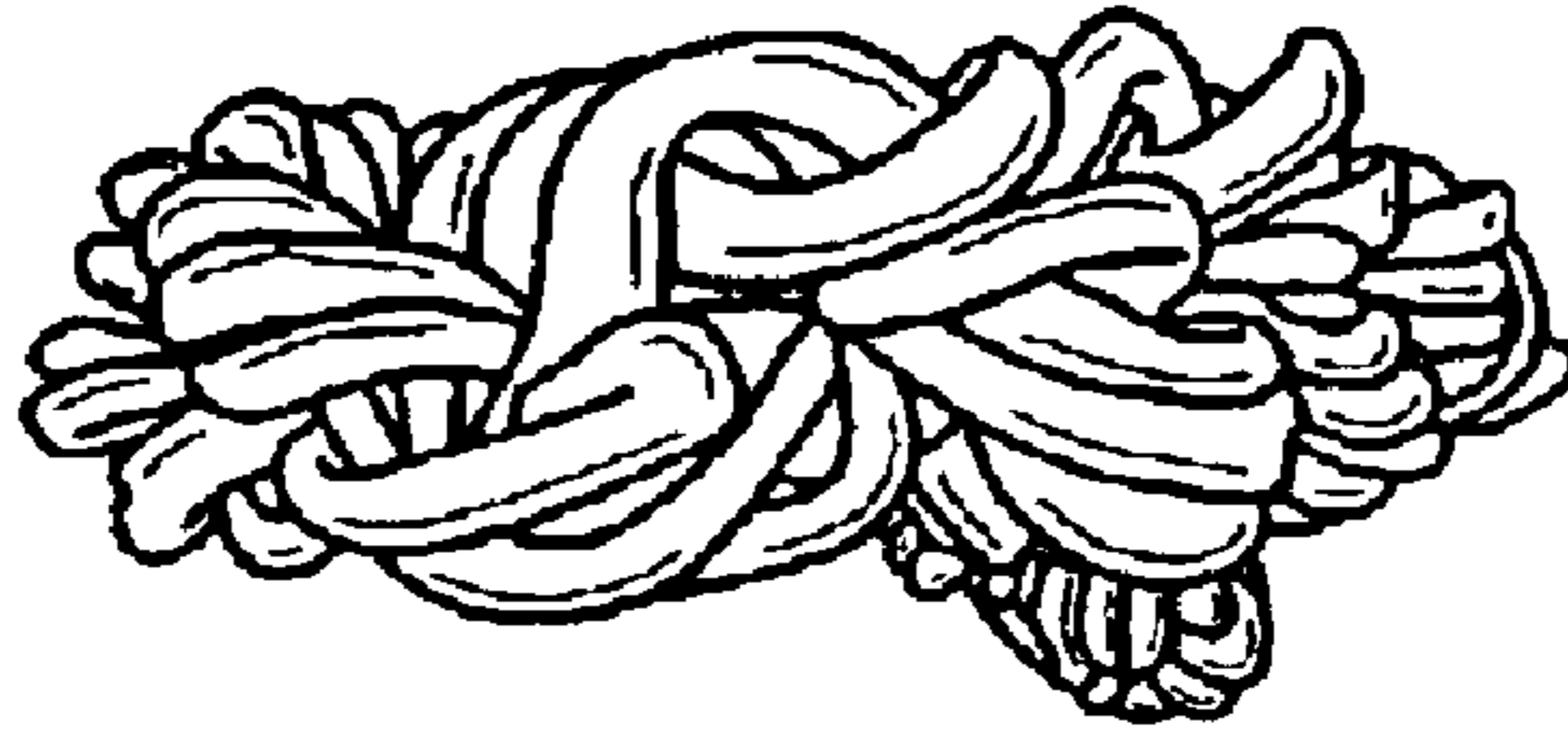
