FIG. 3 is a front end view thereof;

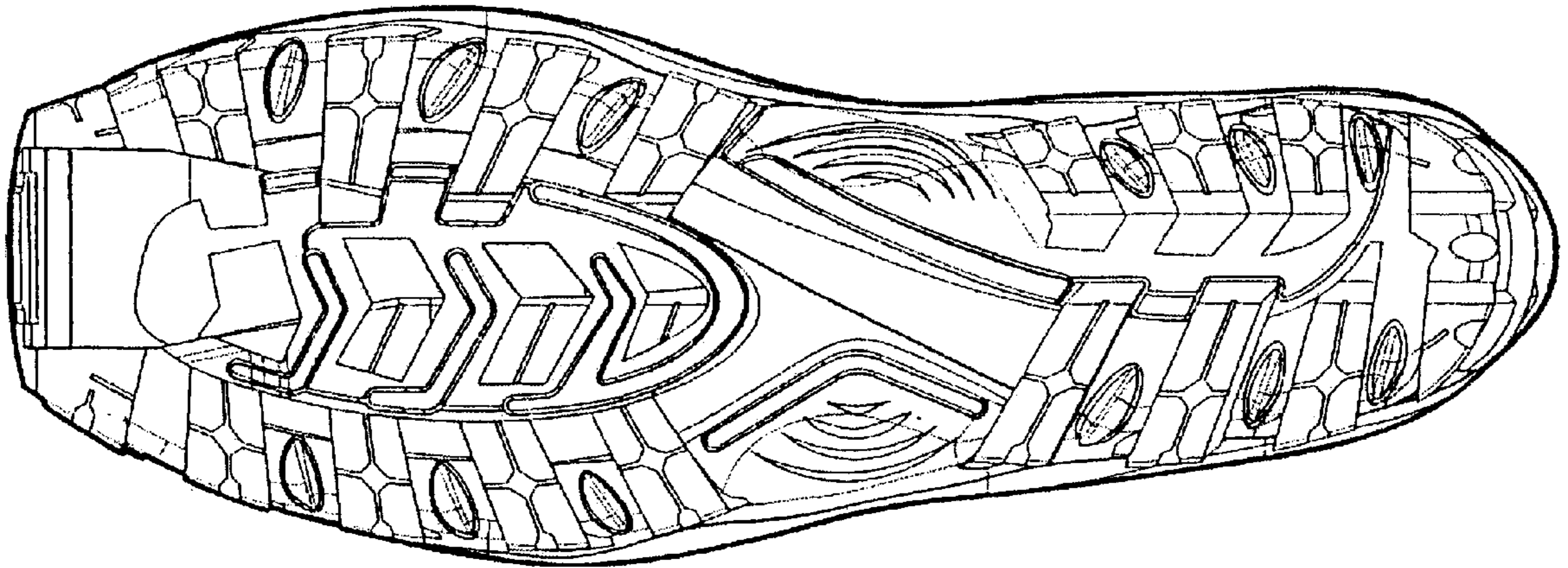
FIG. 4 is a rear end view thereof;

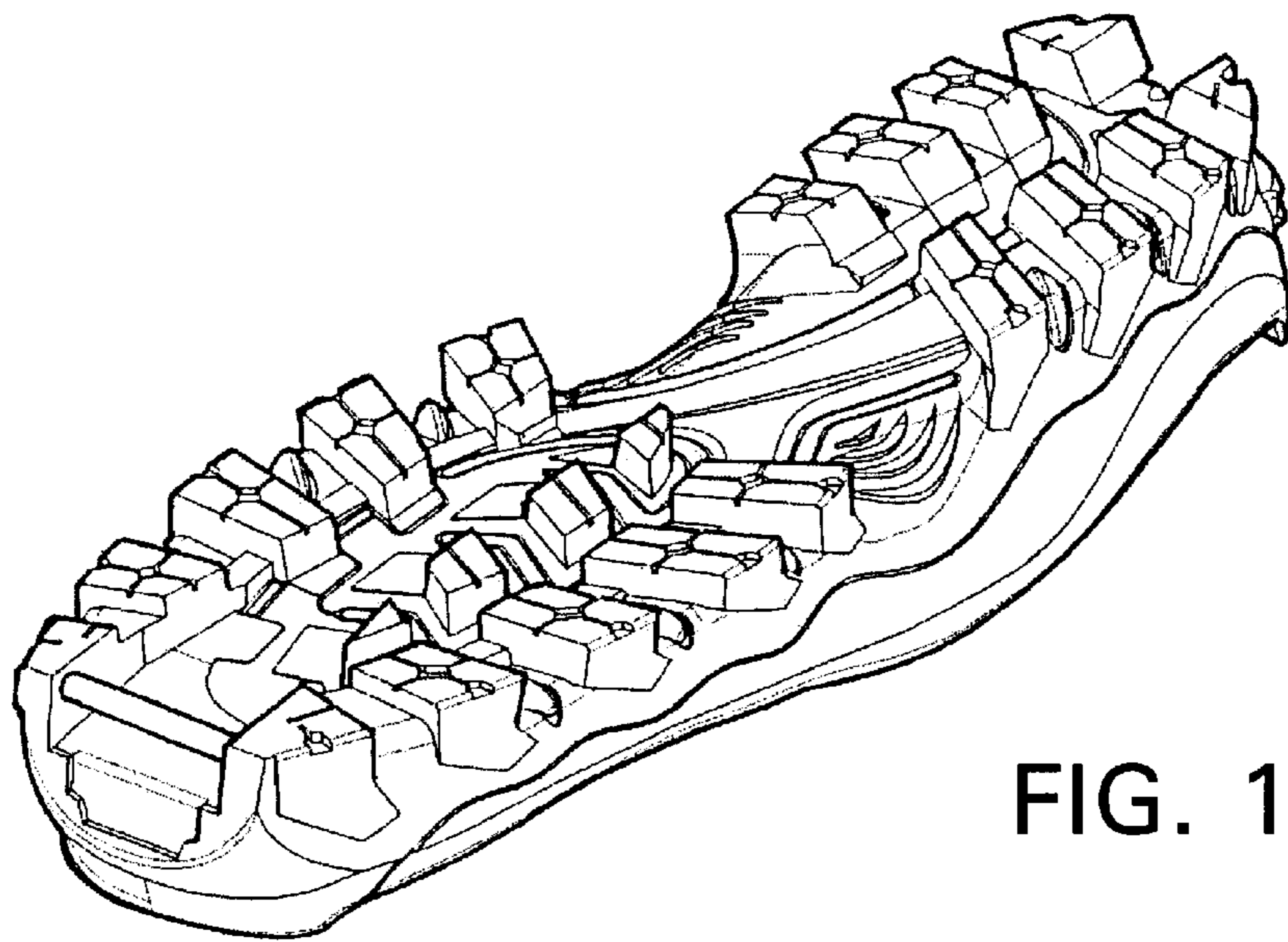

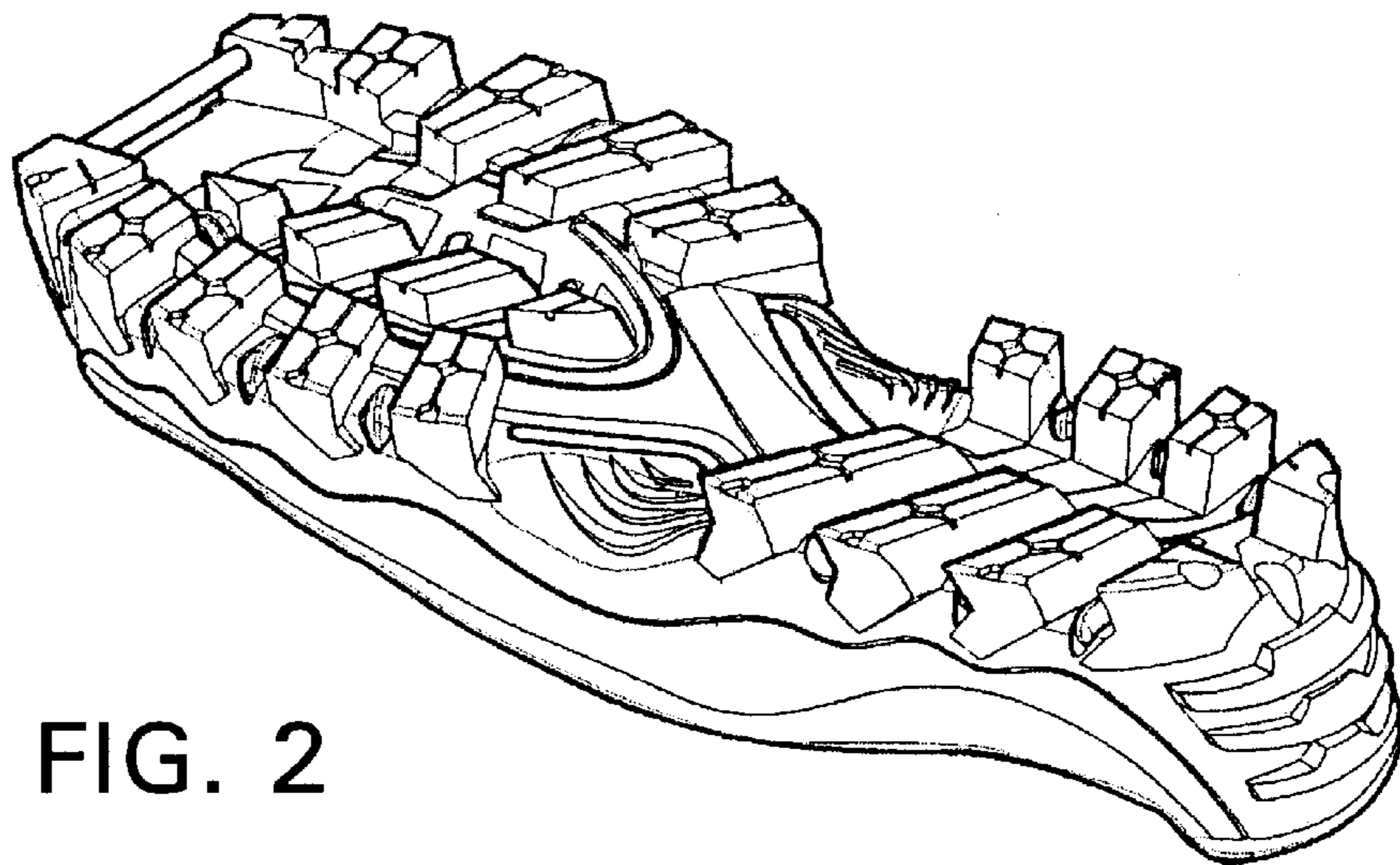

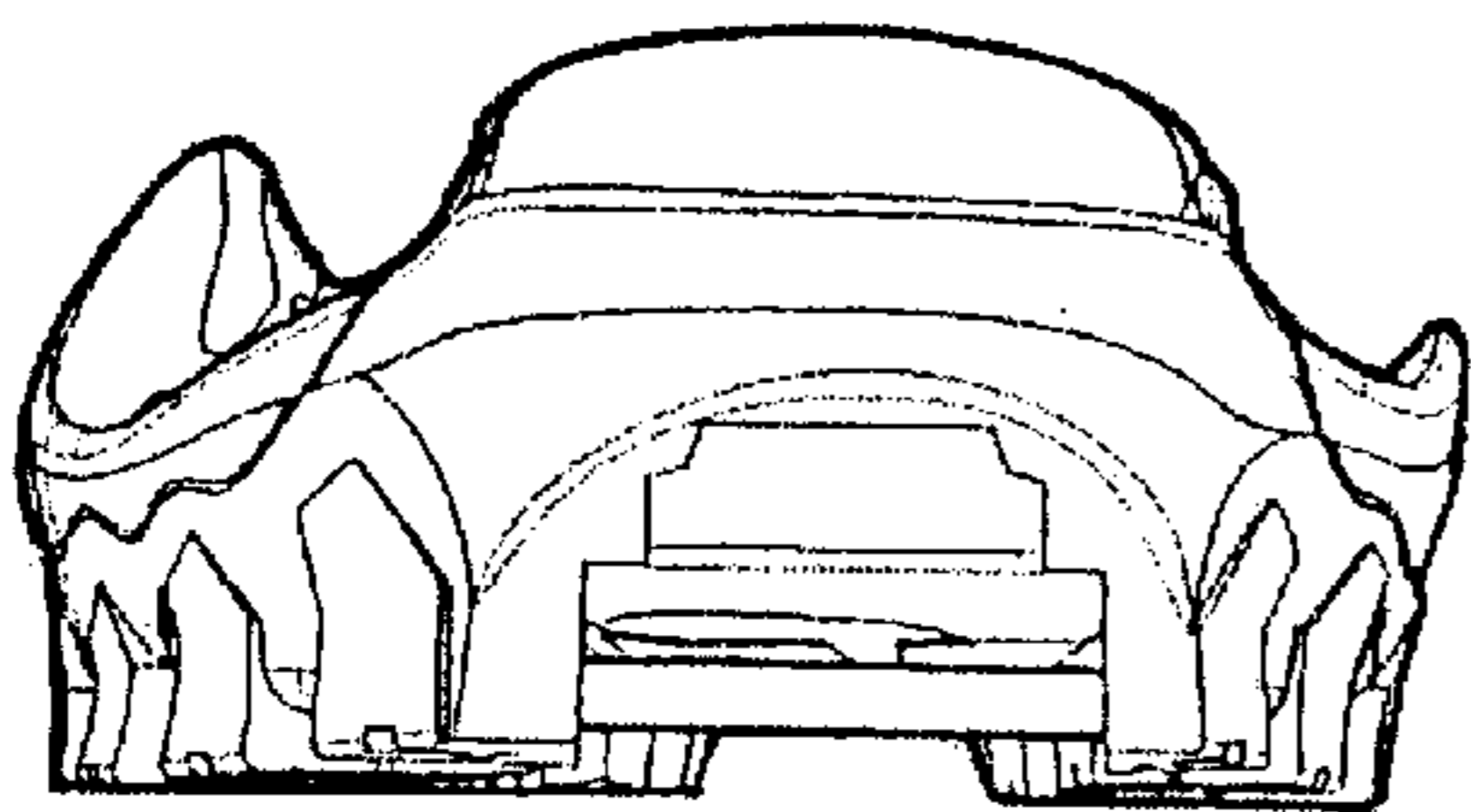

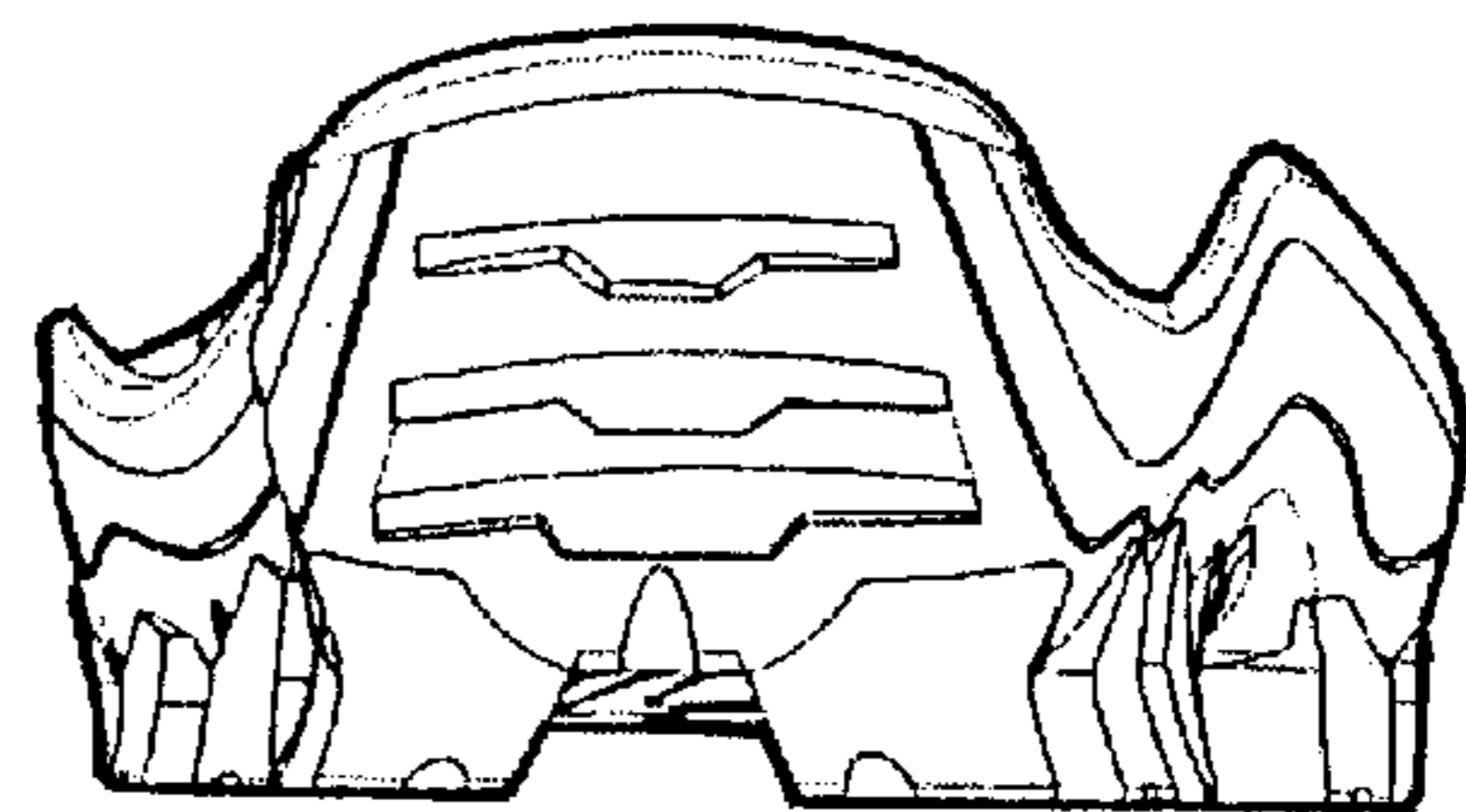

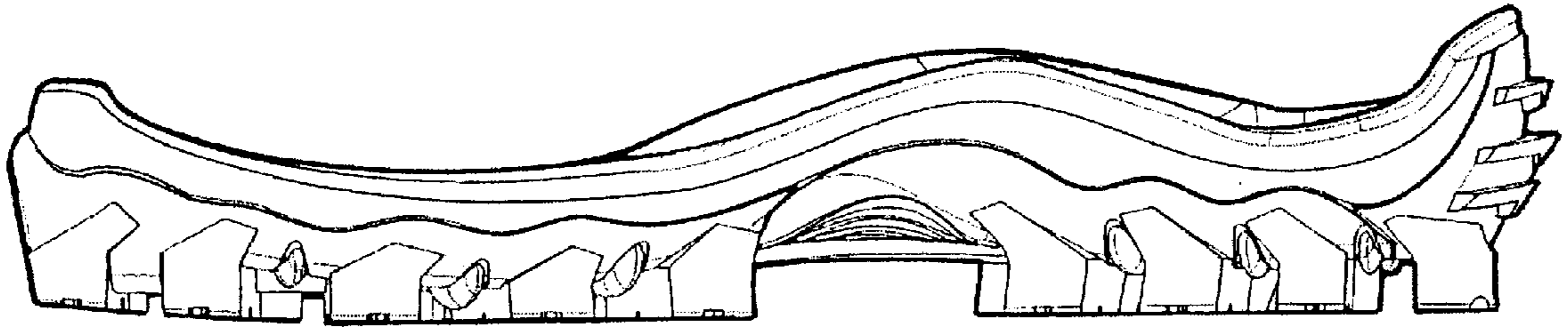

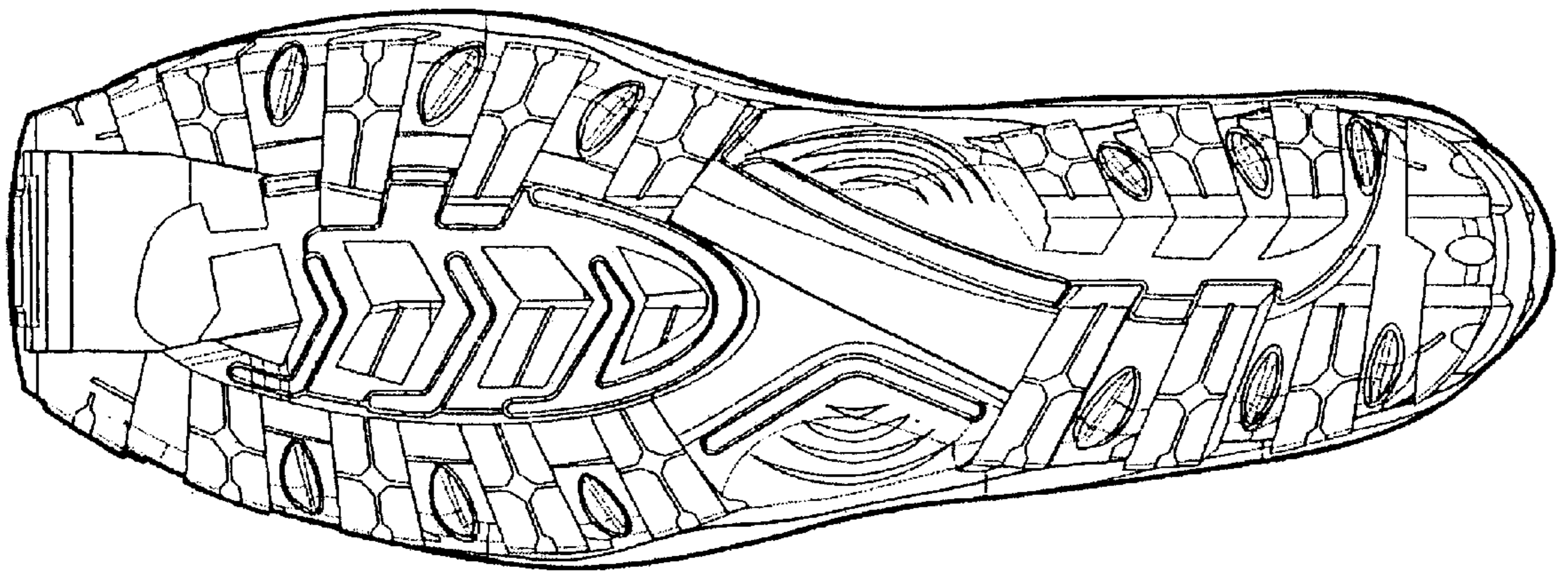

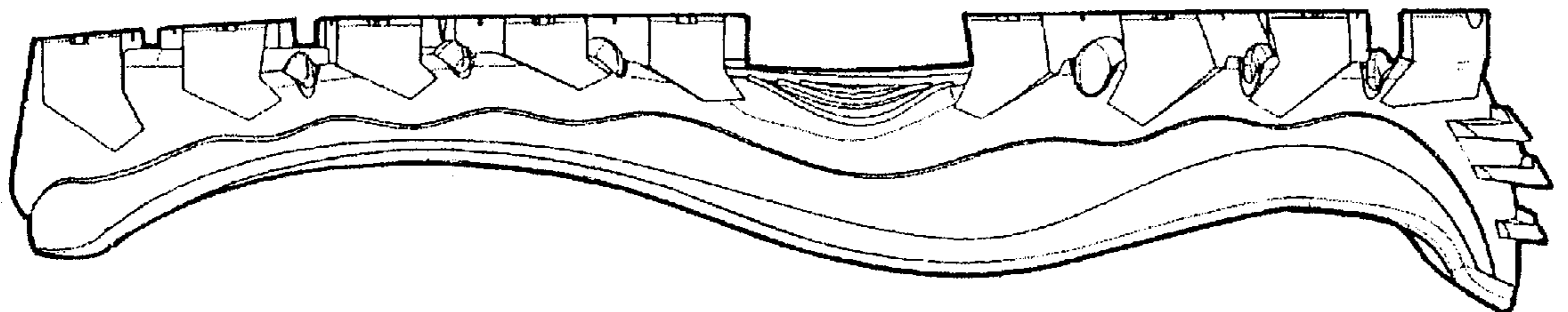

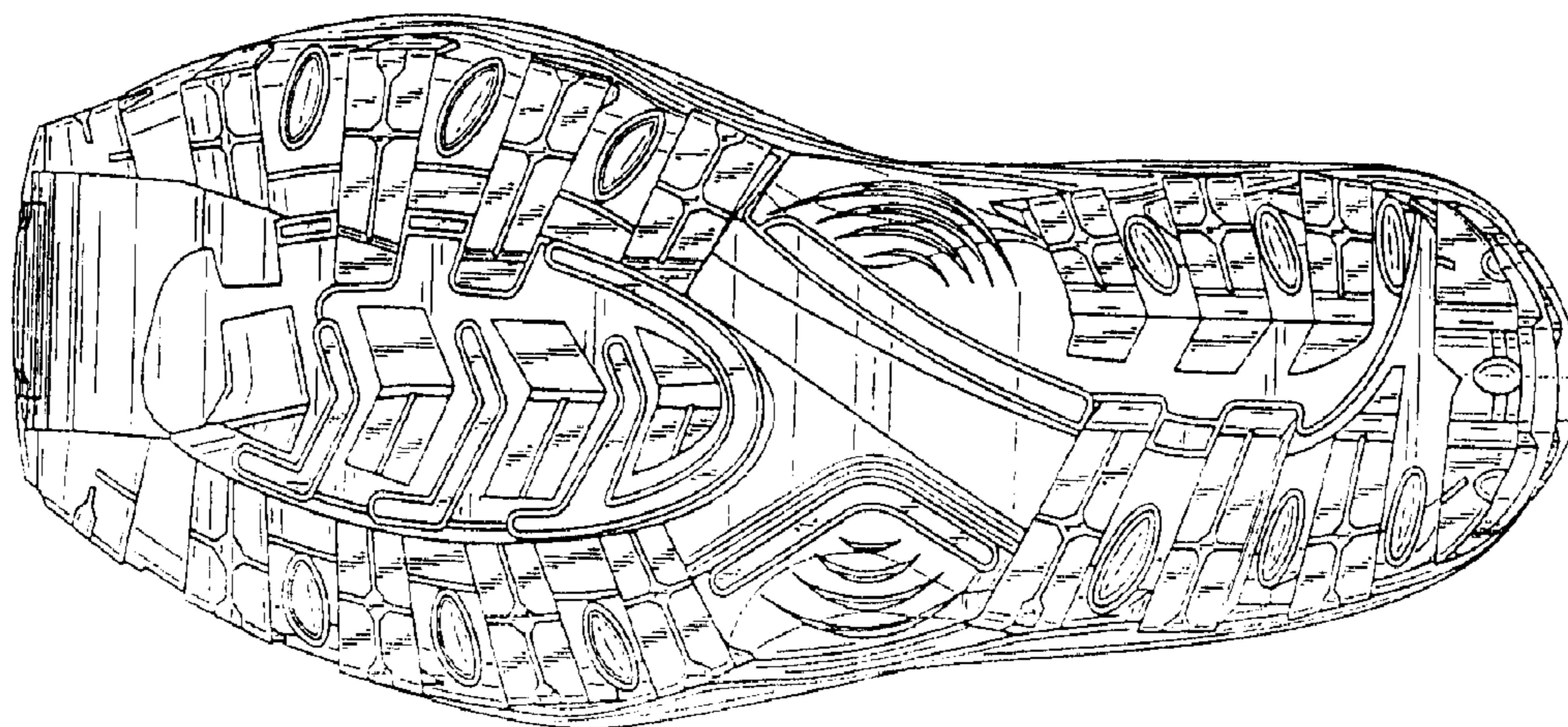
(57) **CLAIM**

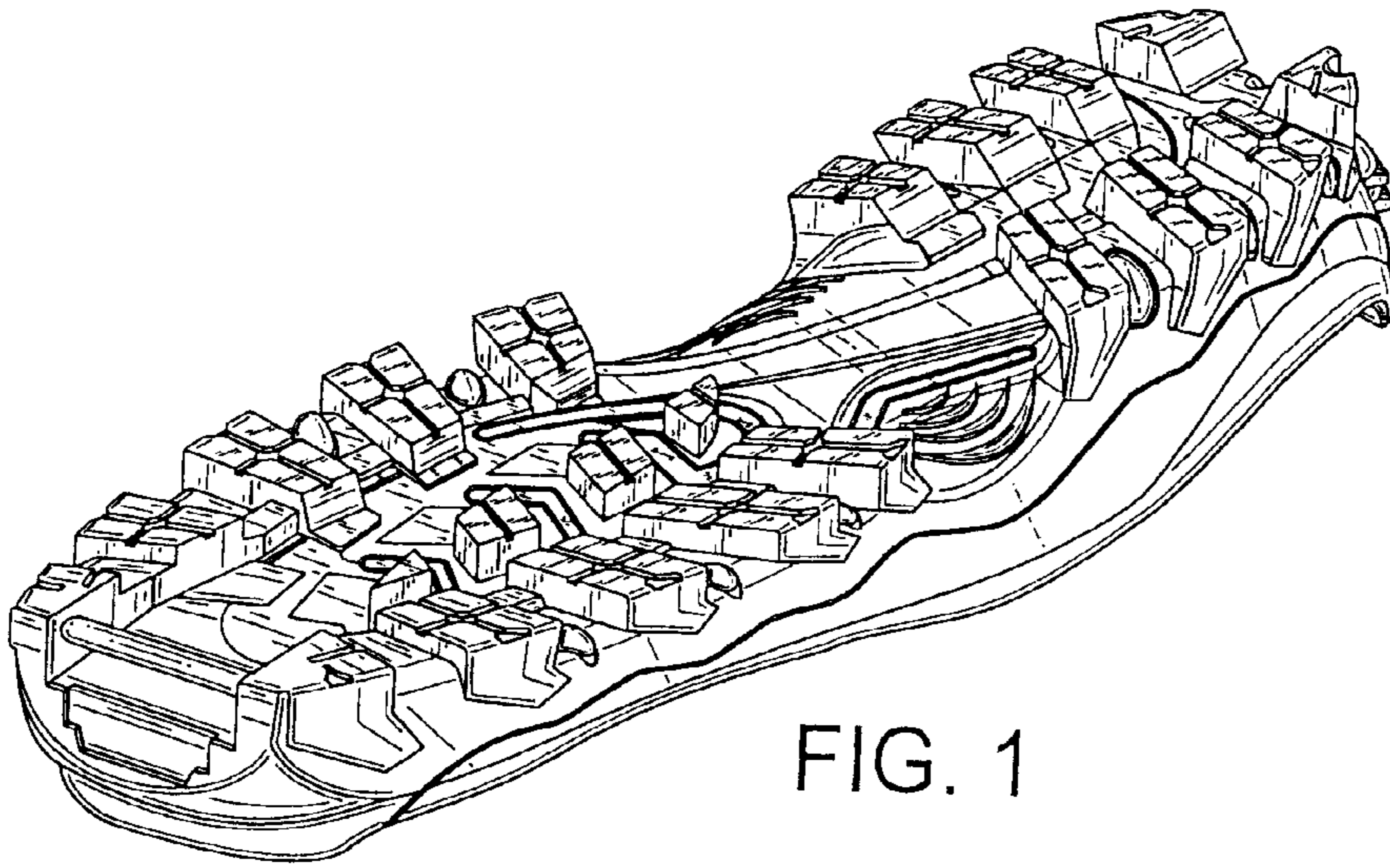

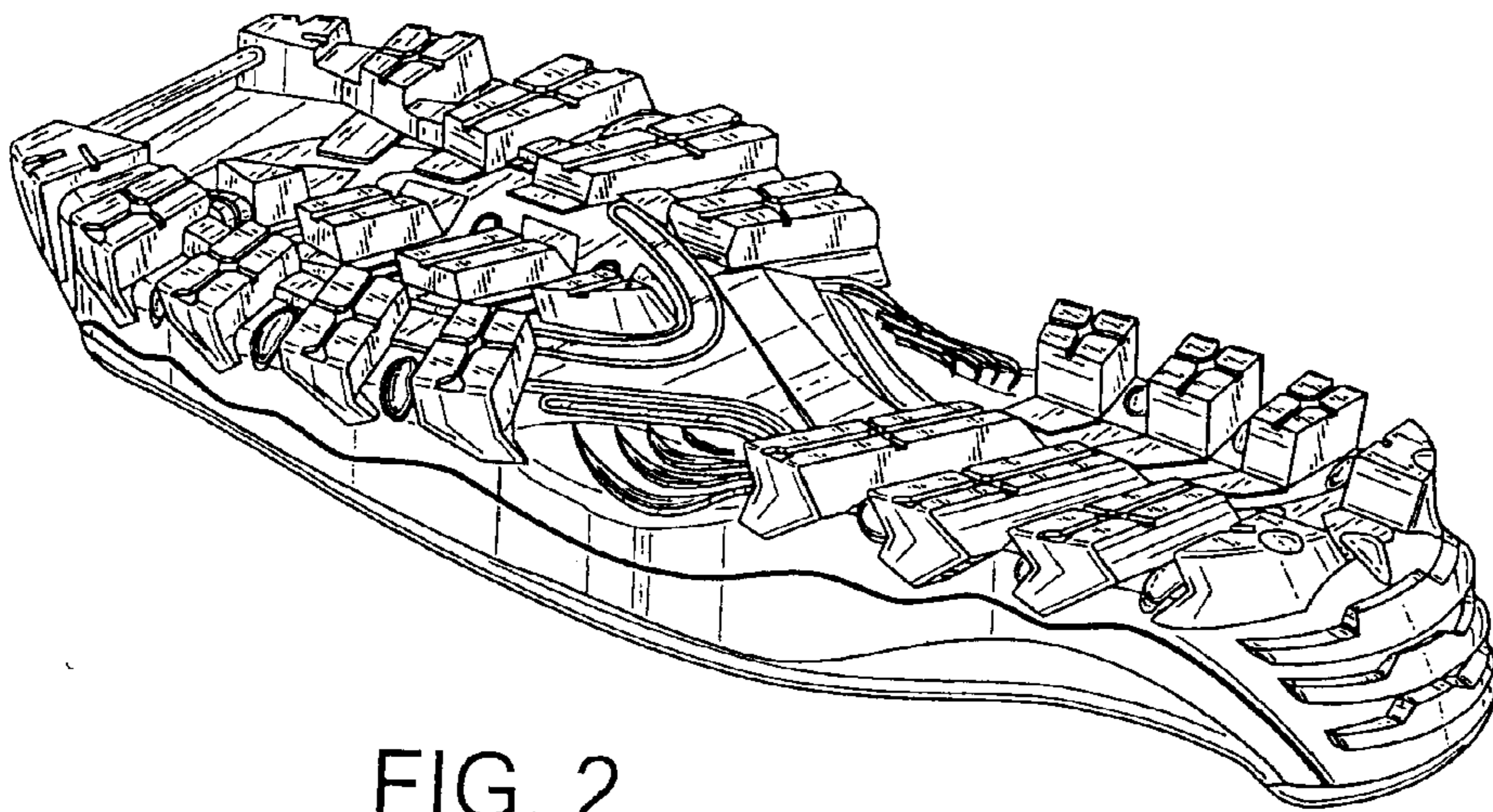

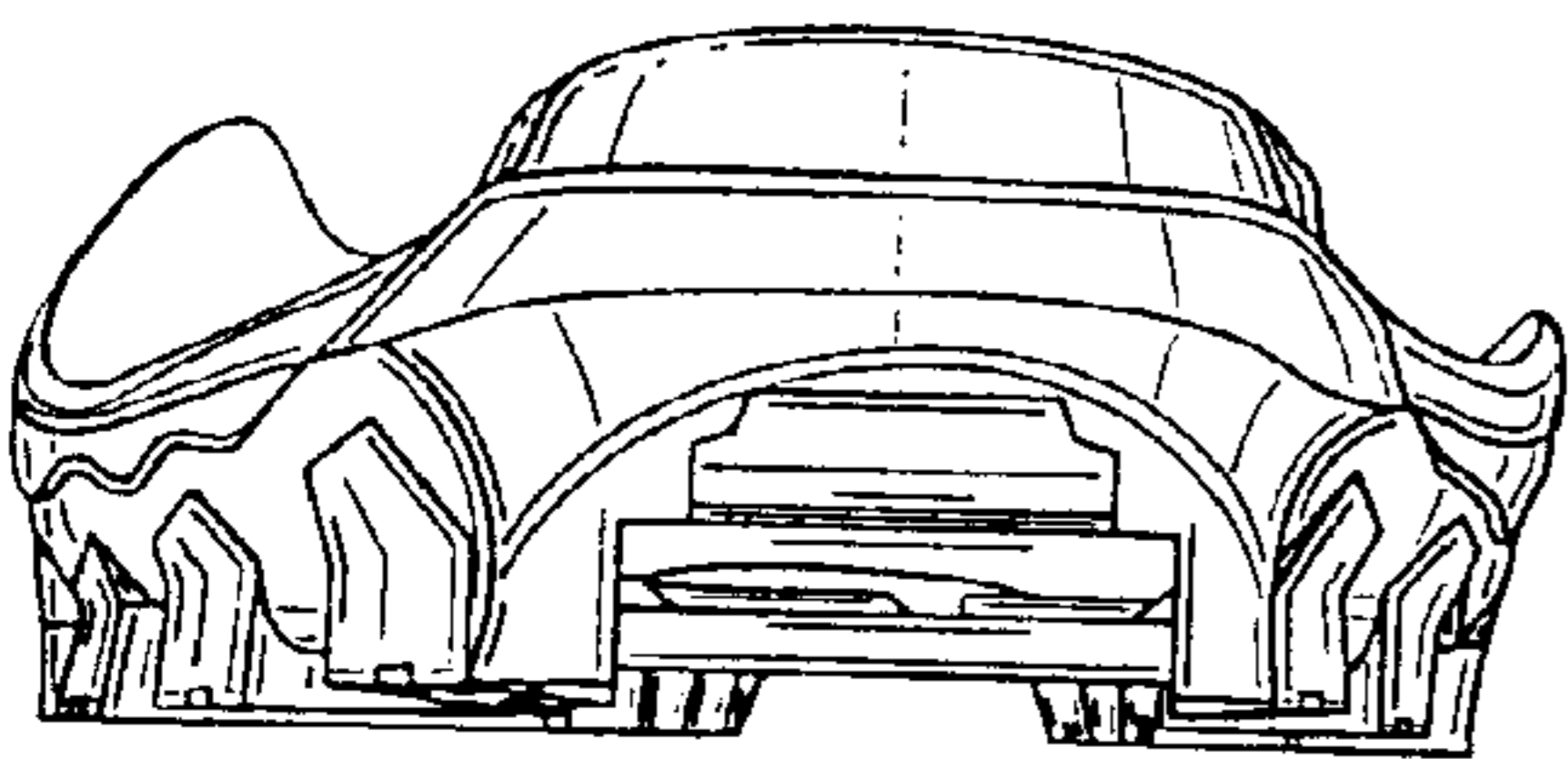

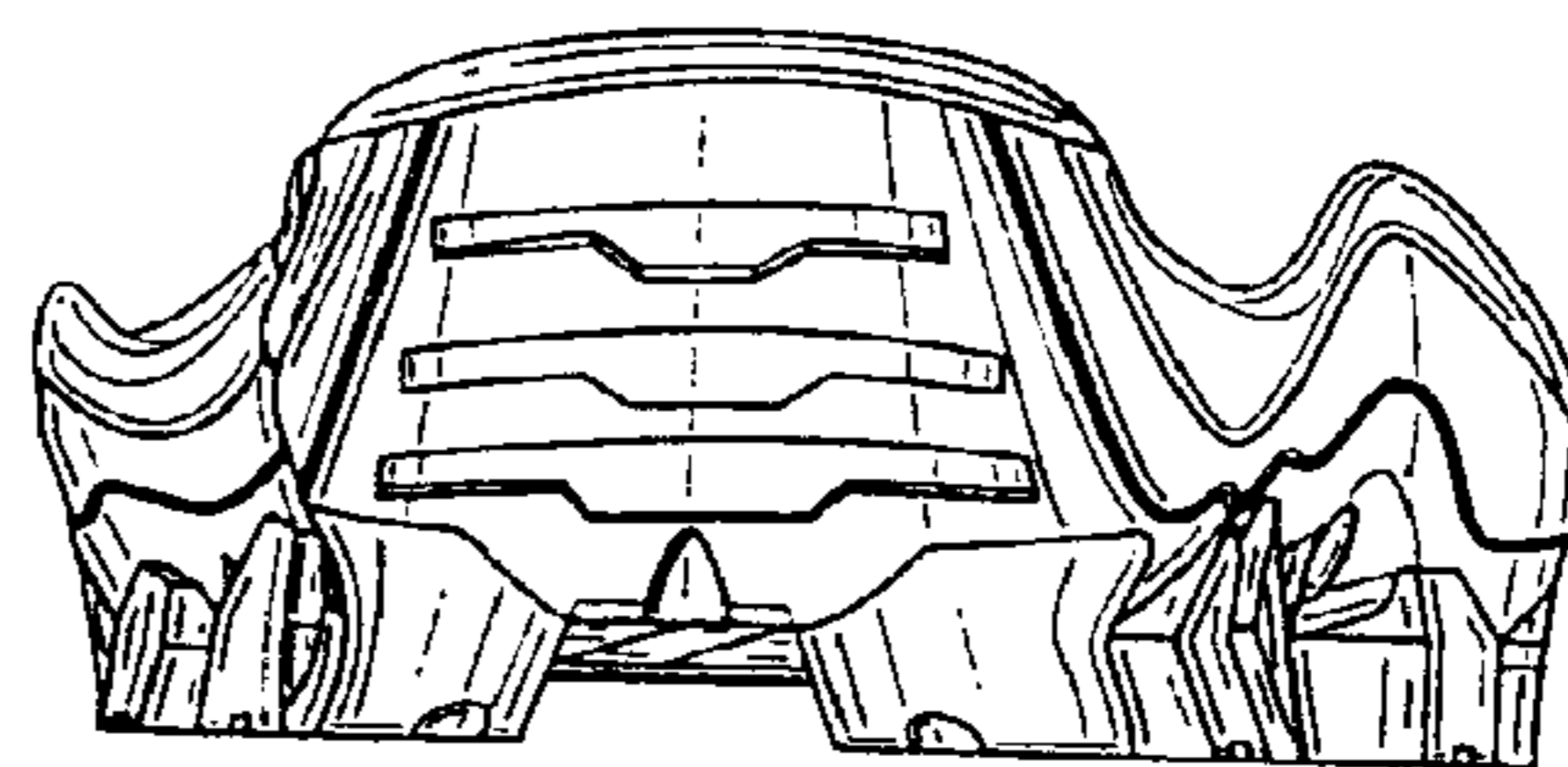

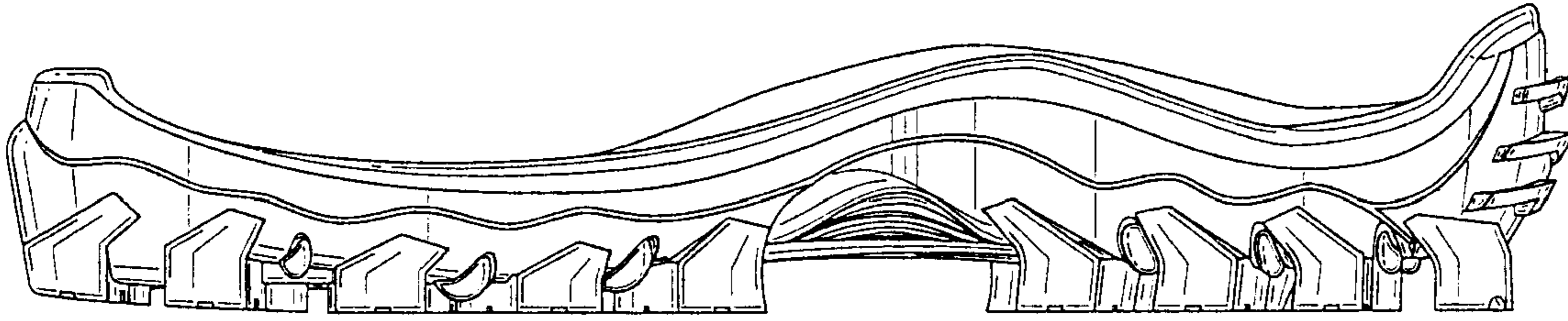

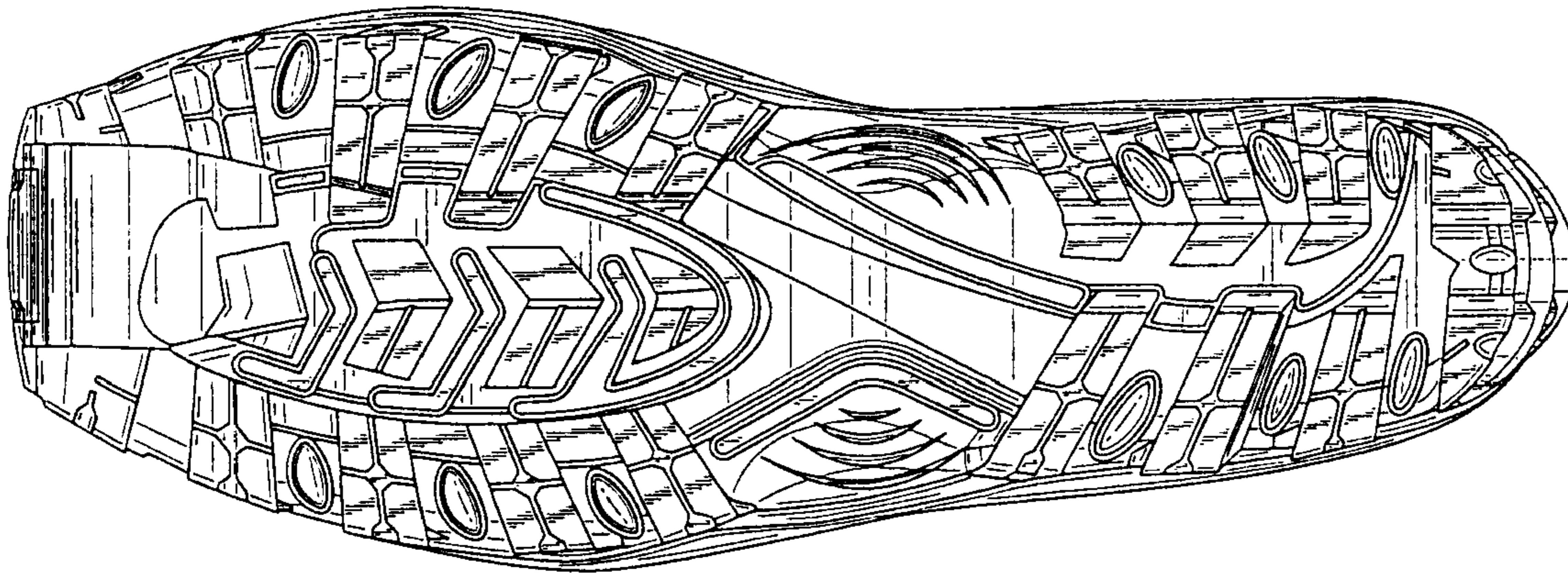

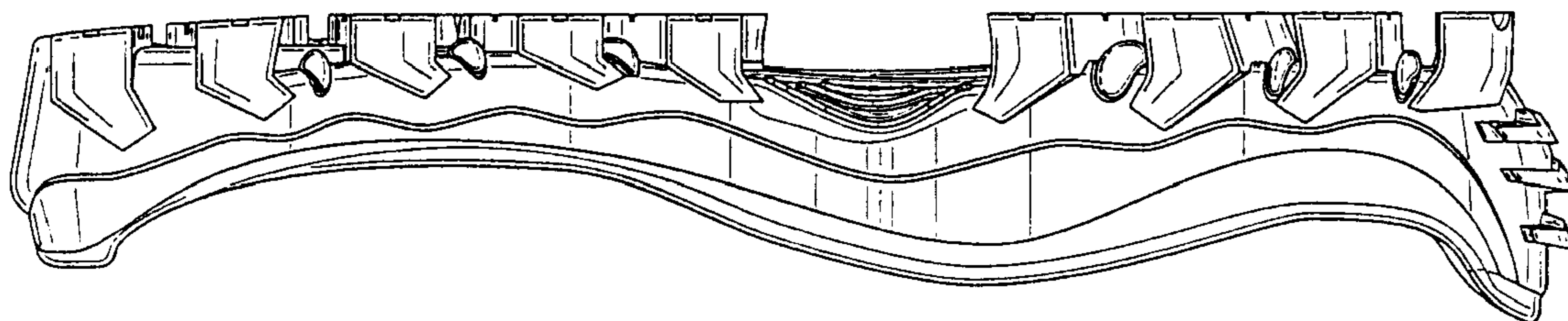
