The ornamental design for a toothbrush, as shown and described.

DESCRIPTION

FIG. 11 is a left side elevation view thereof;

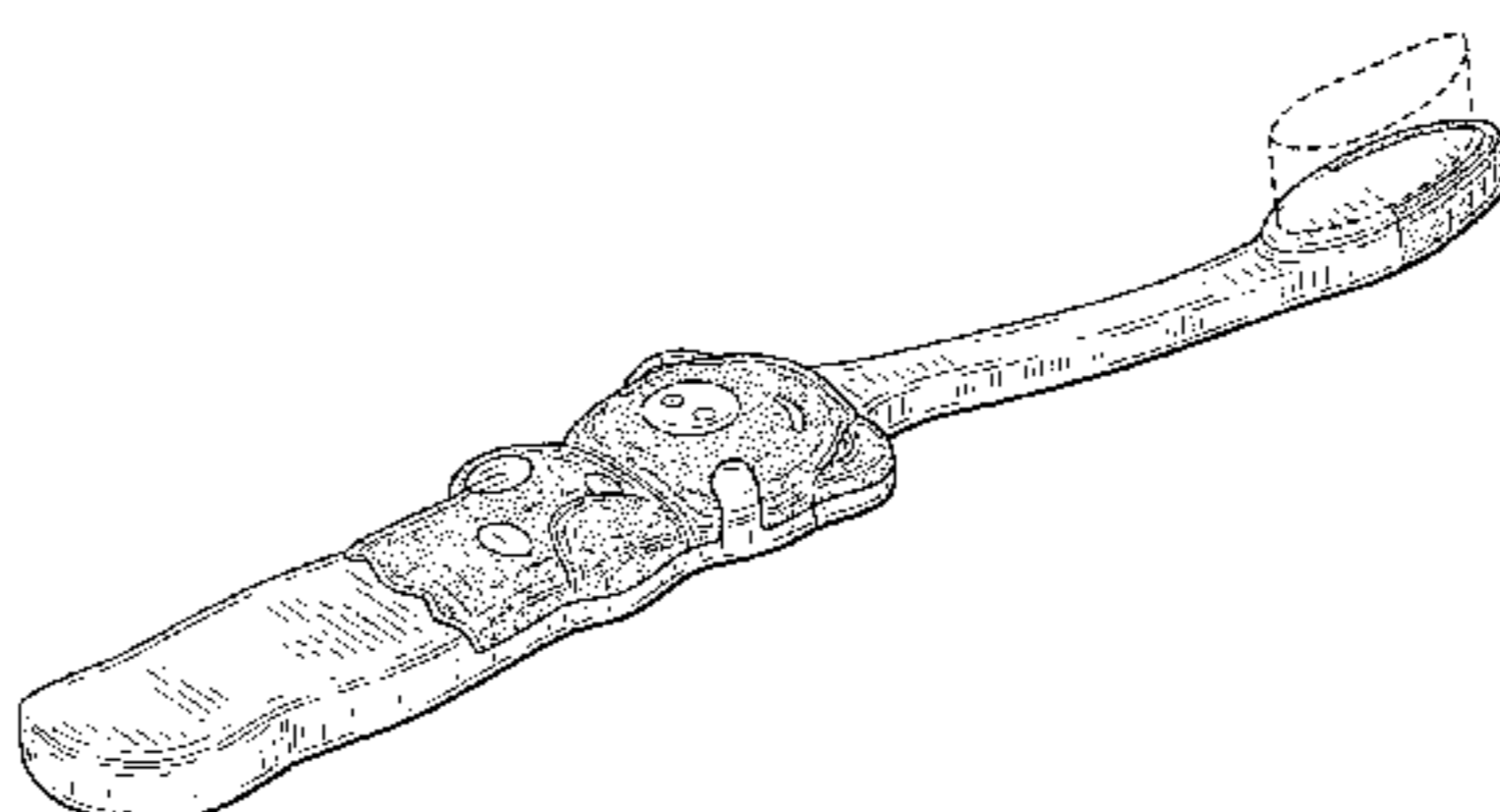
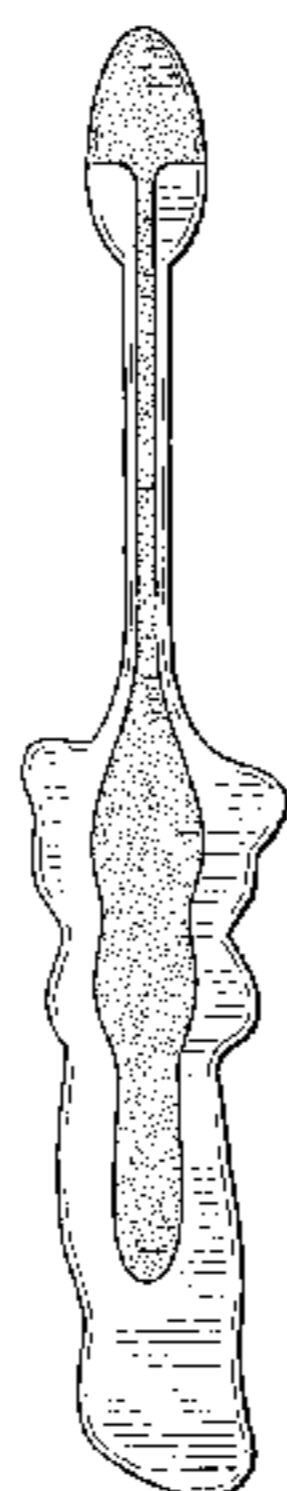
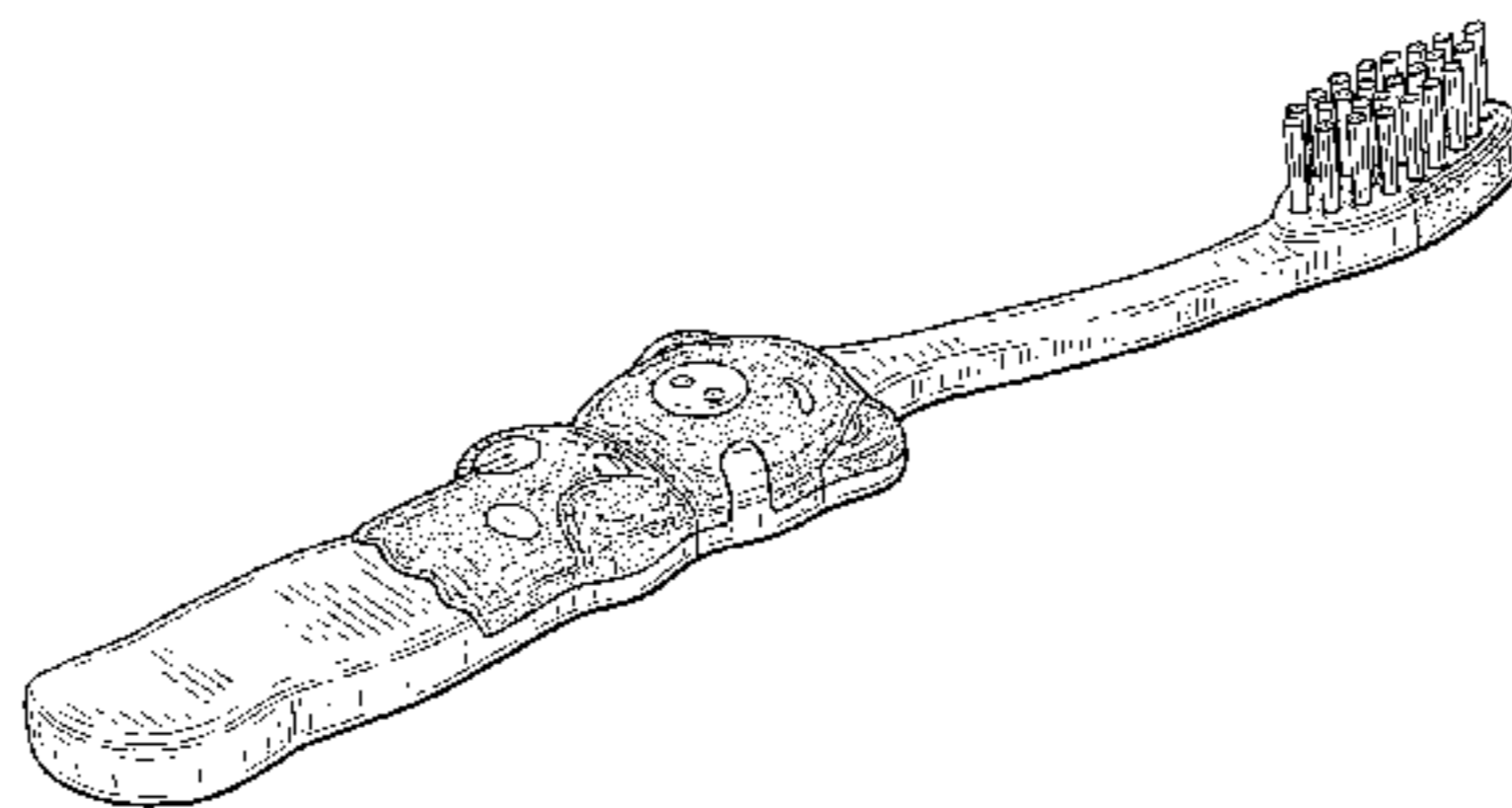
FIG. 12 is a right side elevation view thereof;

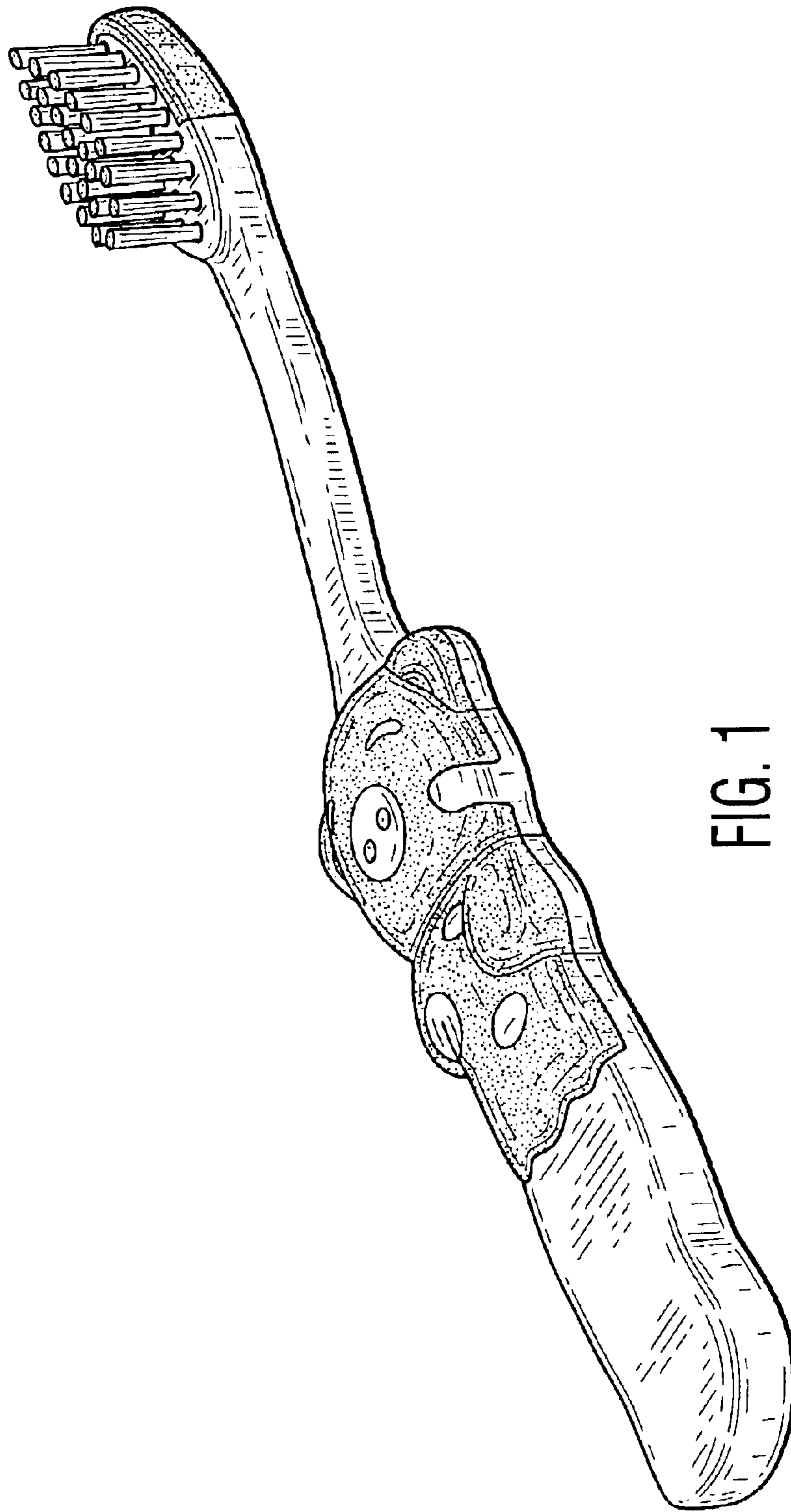

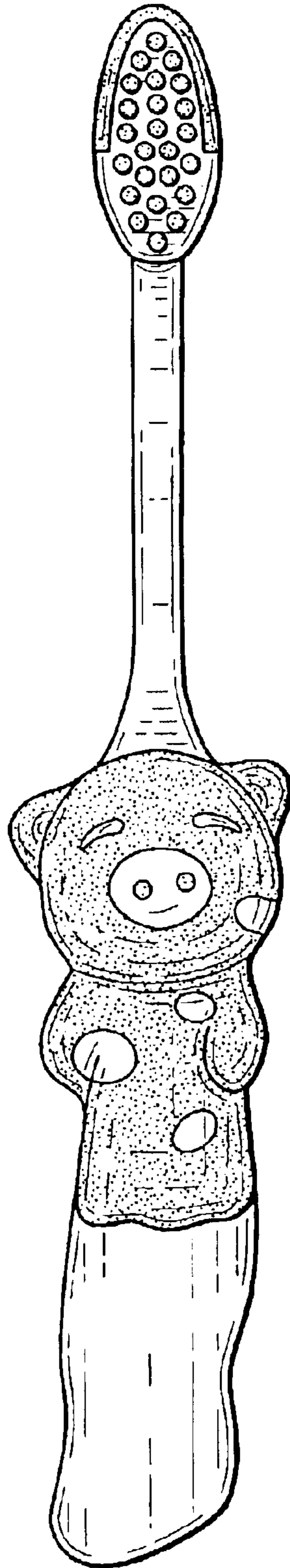

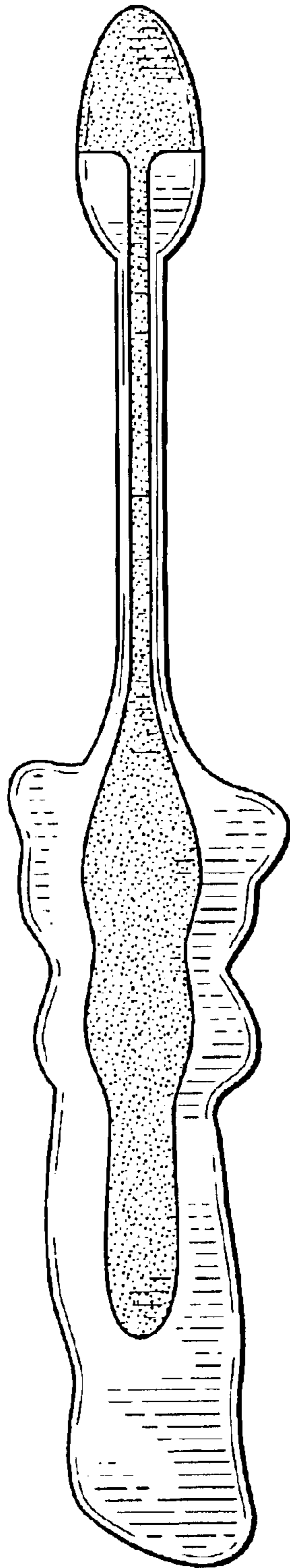

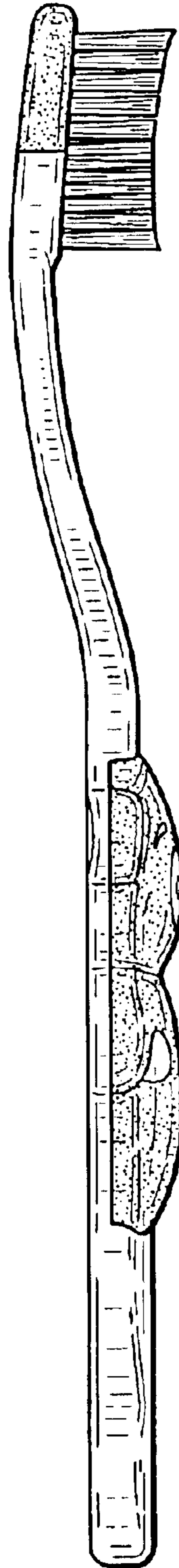

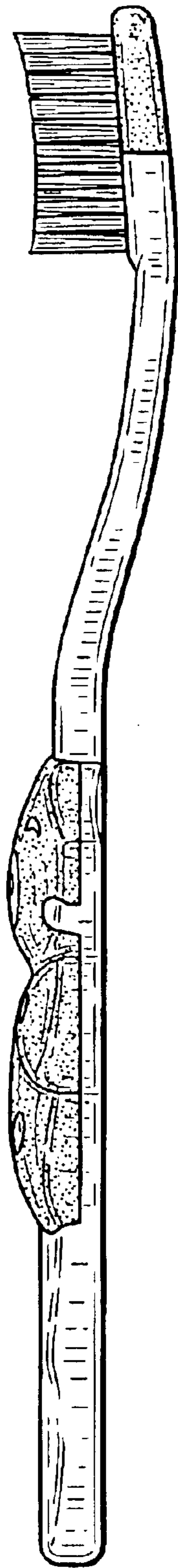

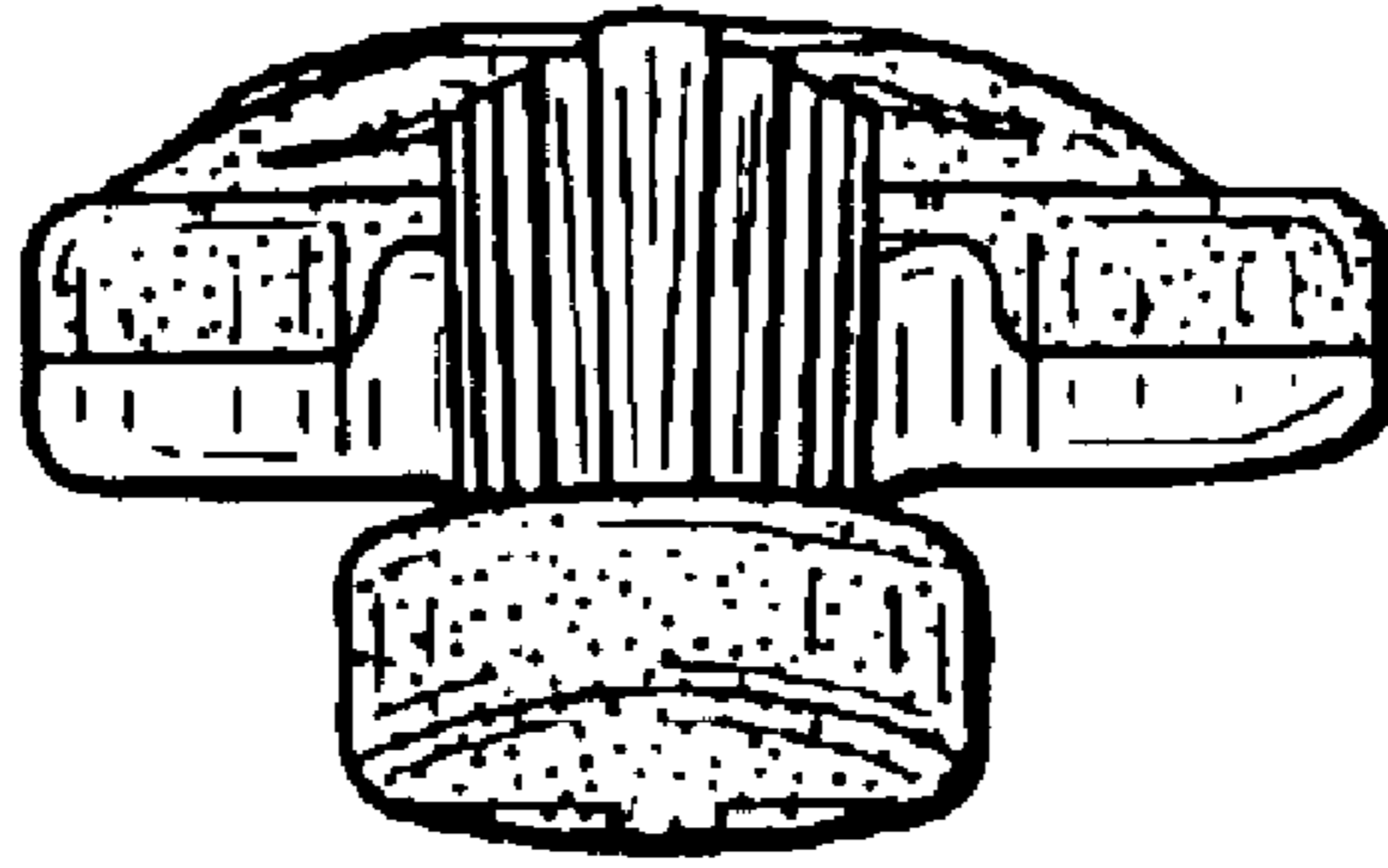

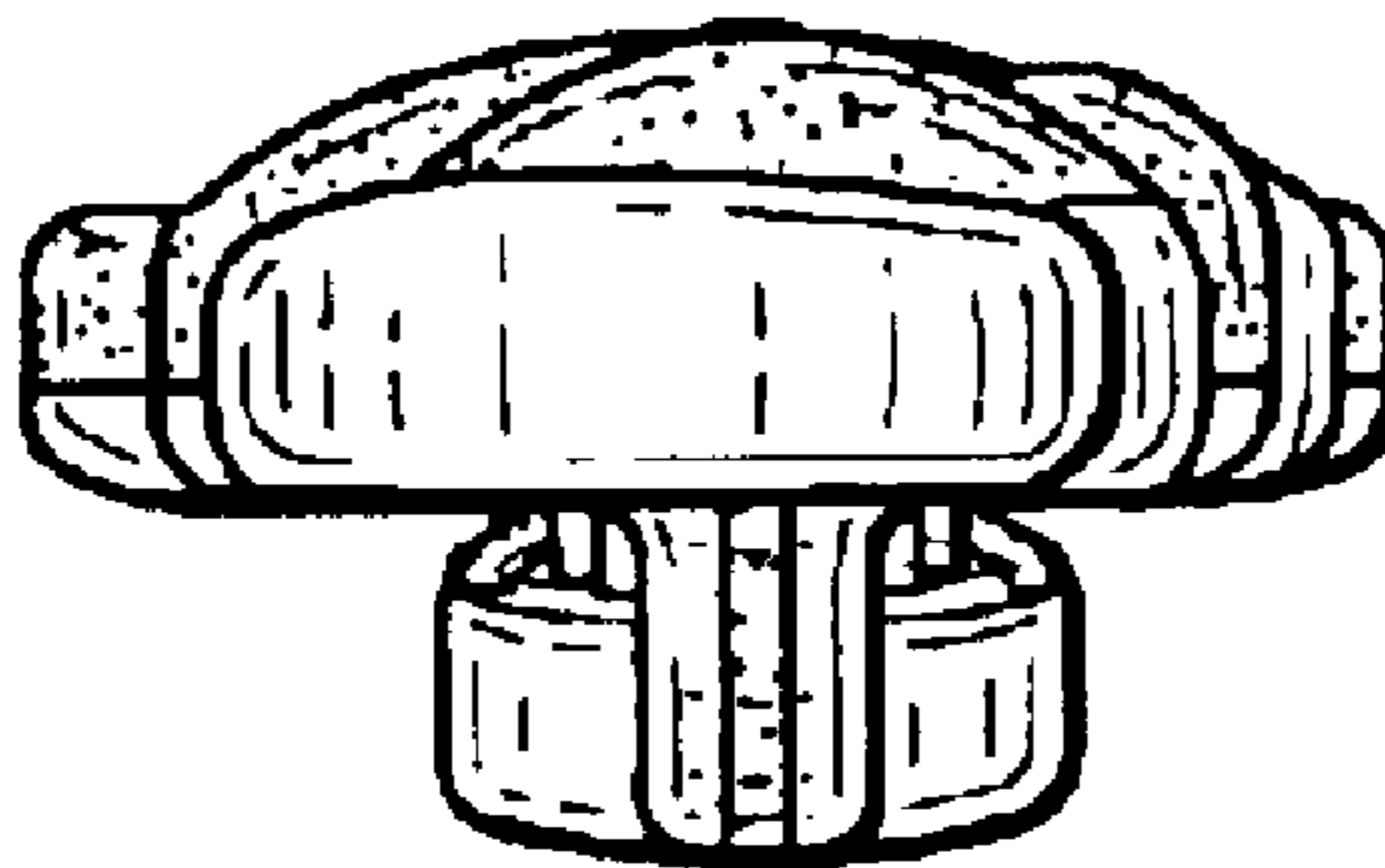

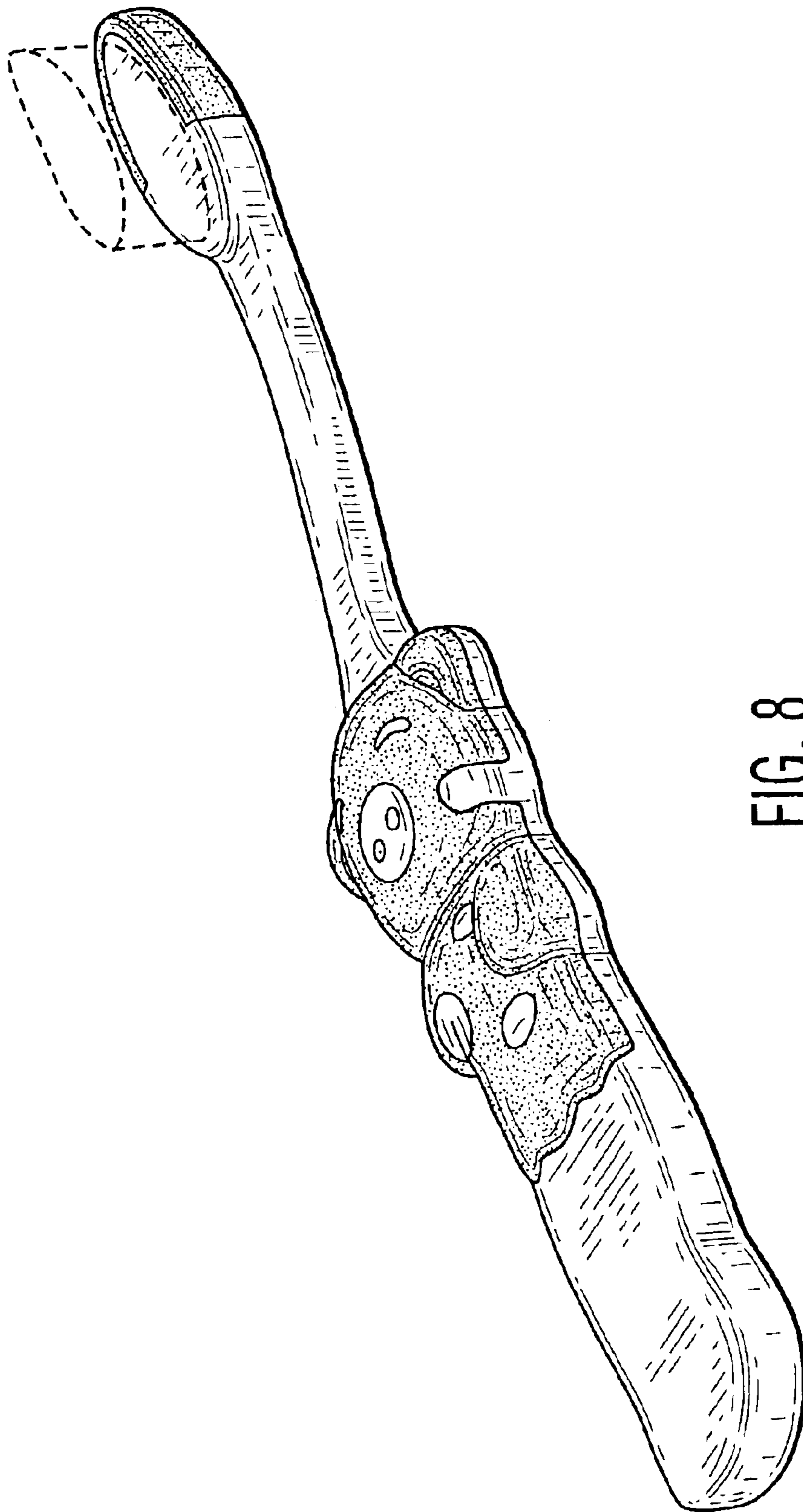

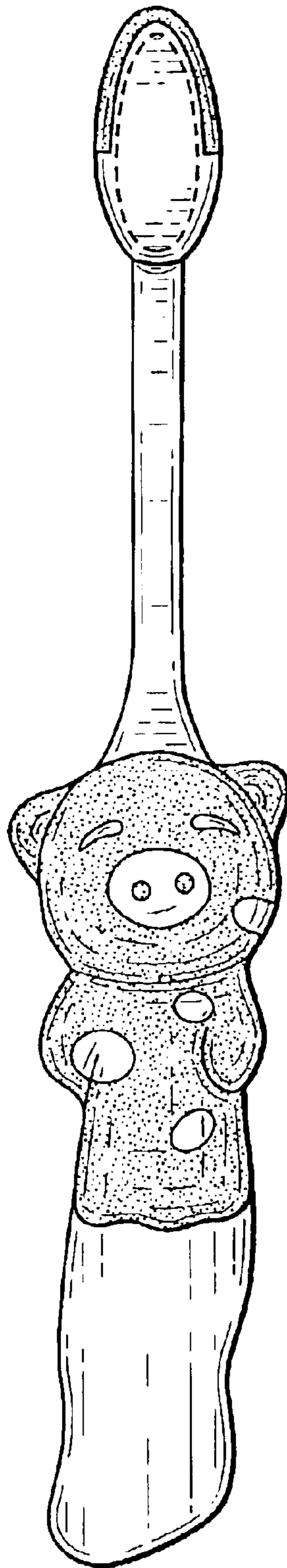

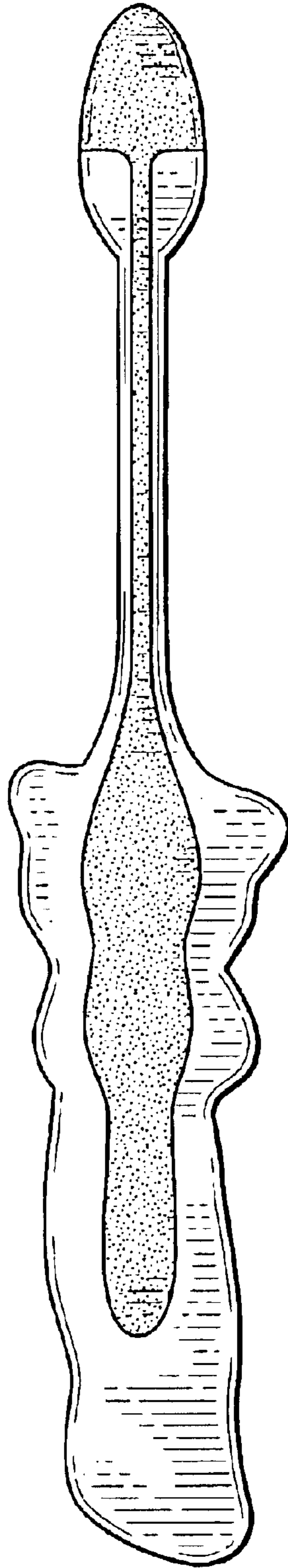

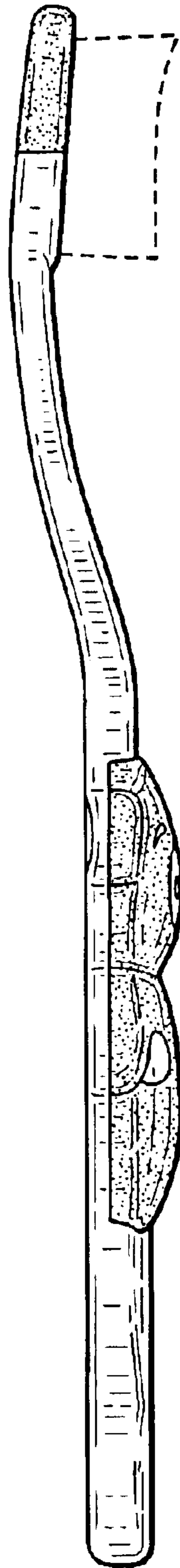

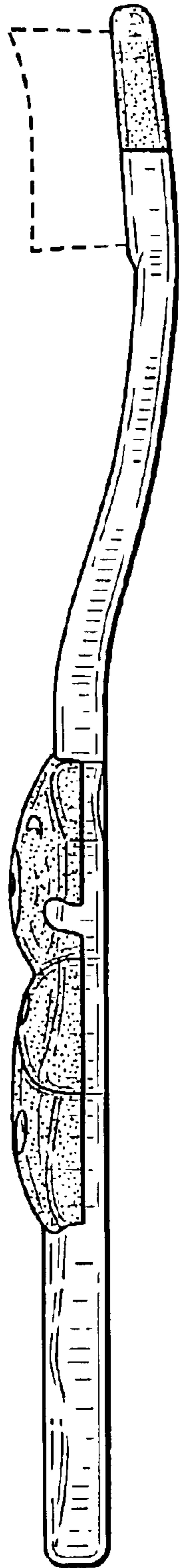

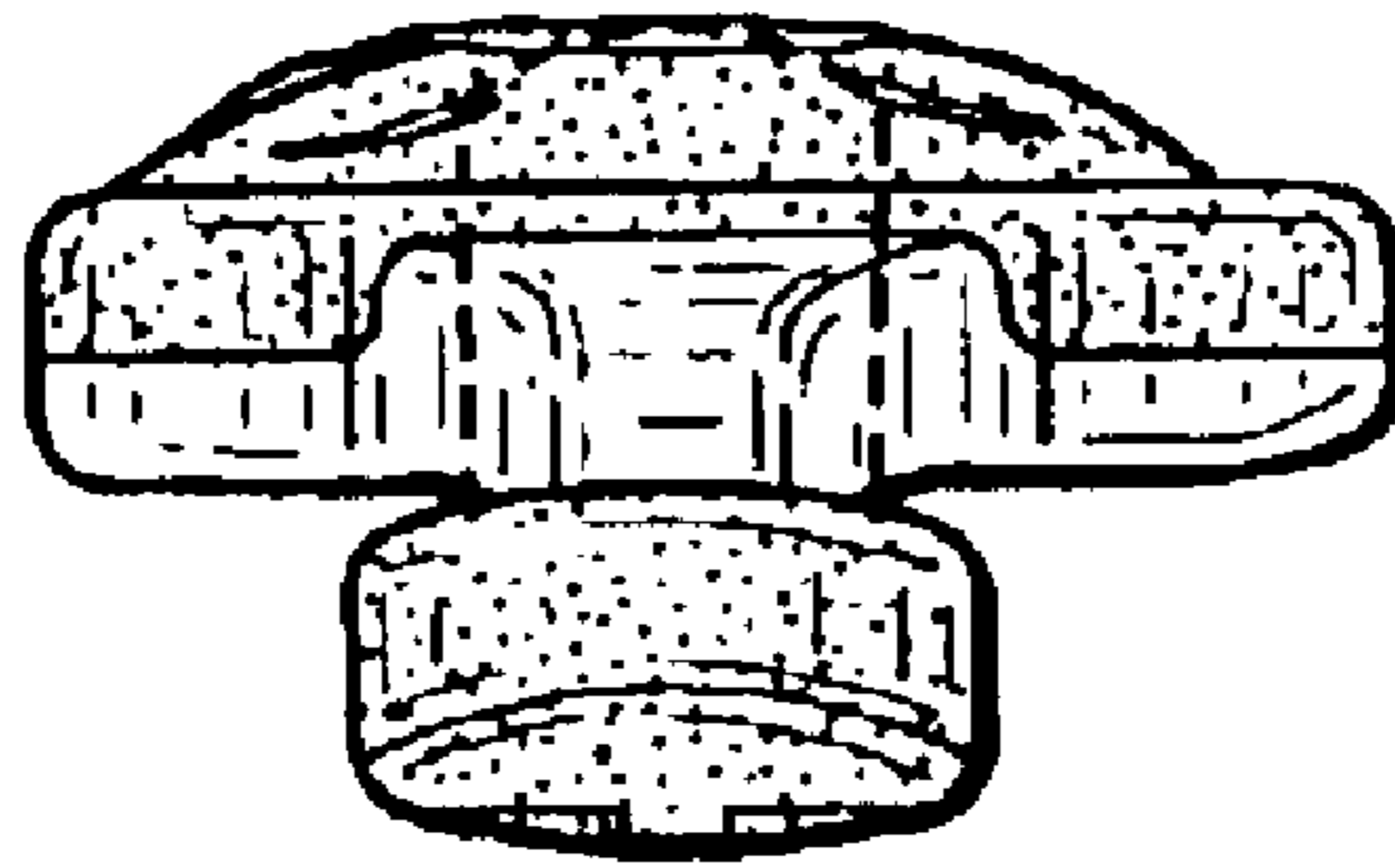

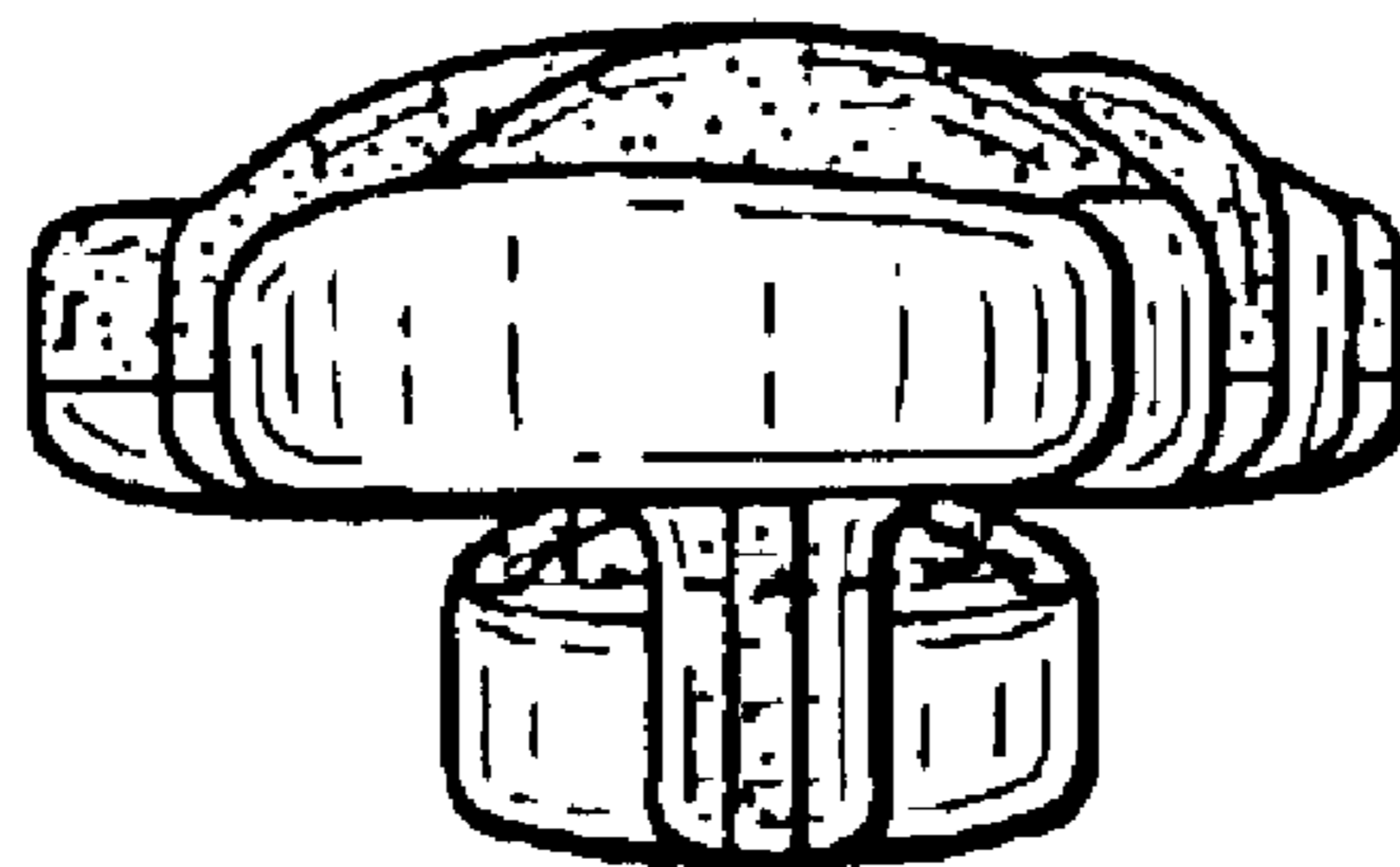
