a mirror image;

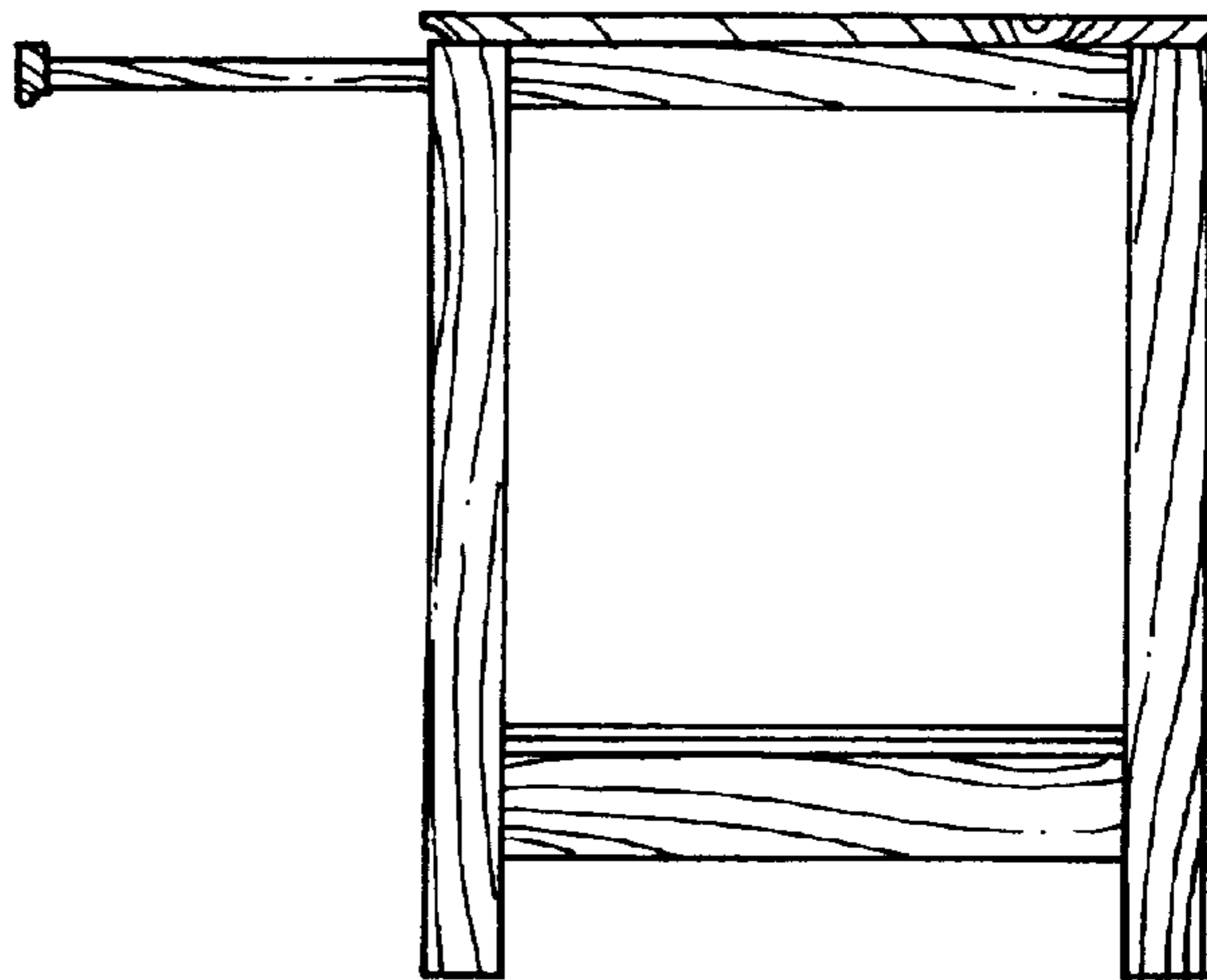
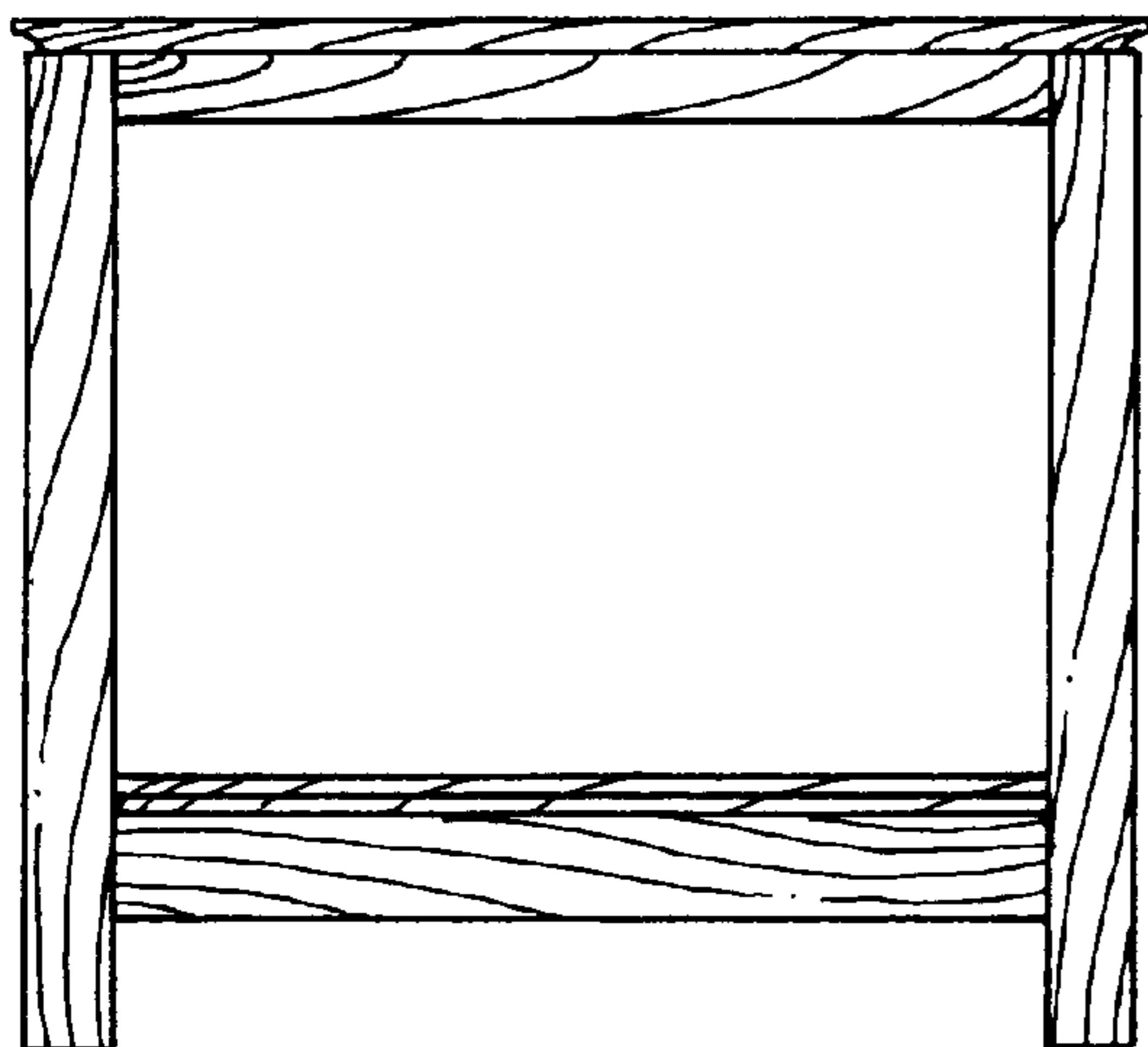
FIG. 5 is a front view of a second embodiment showing my

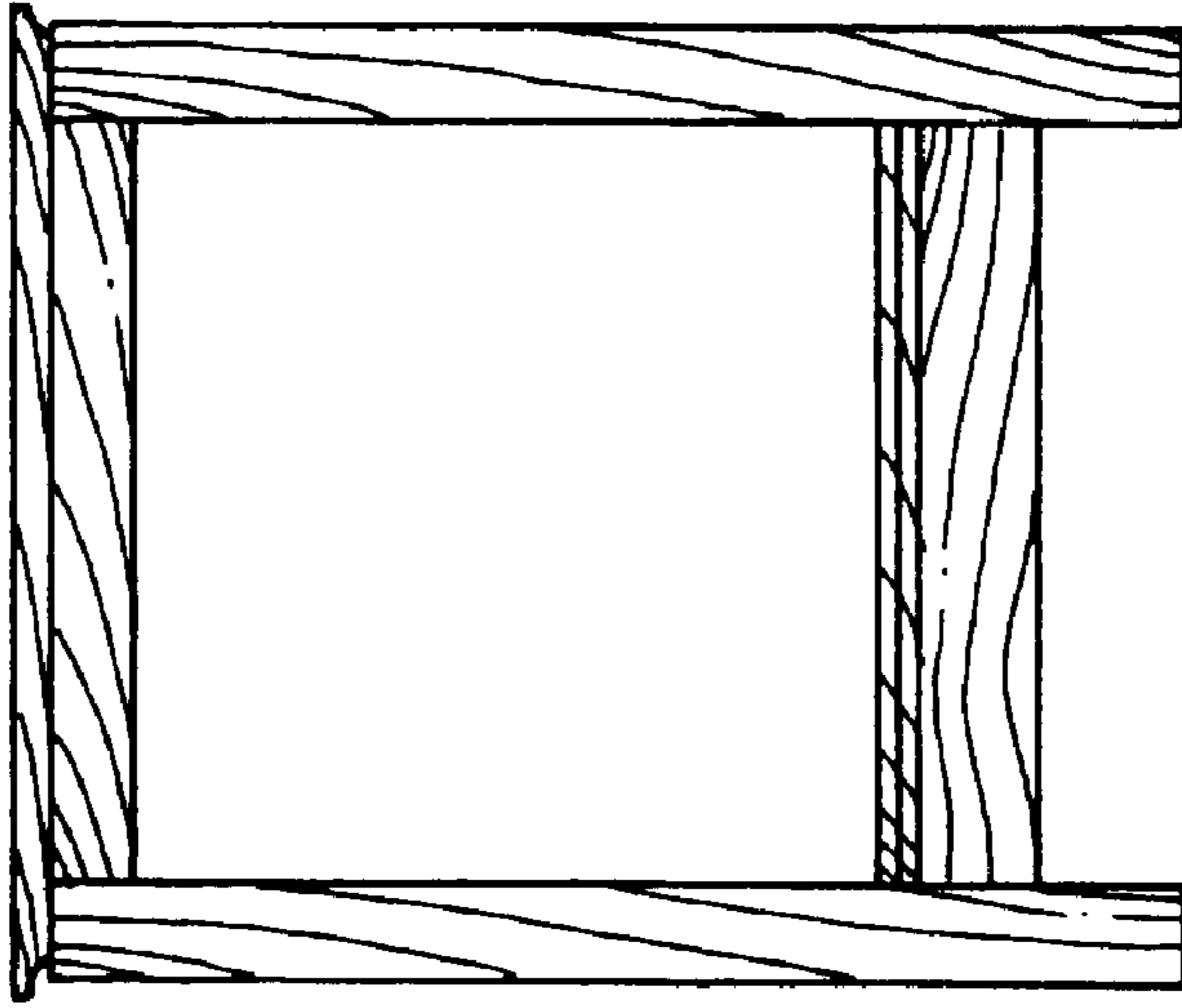

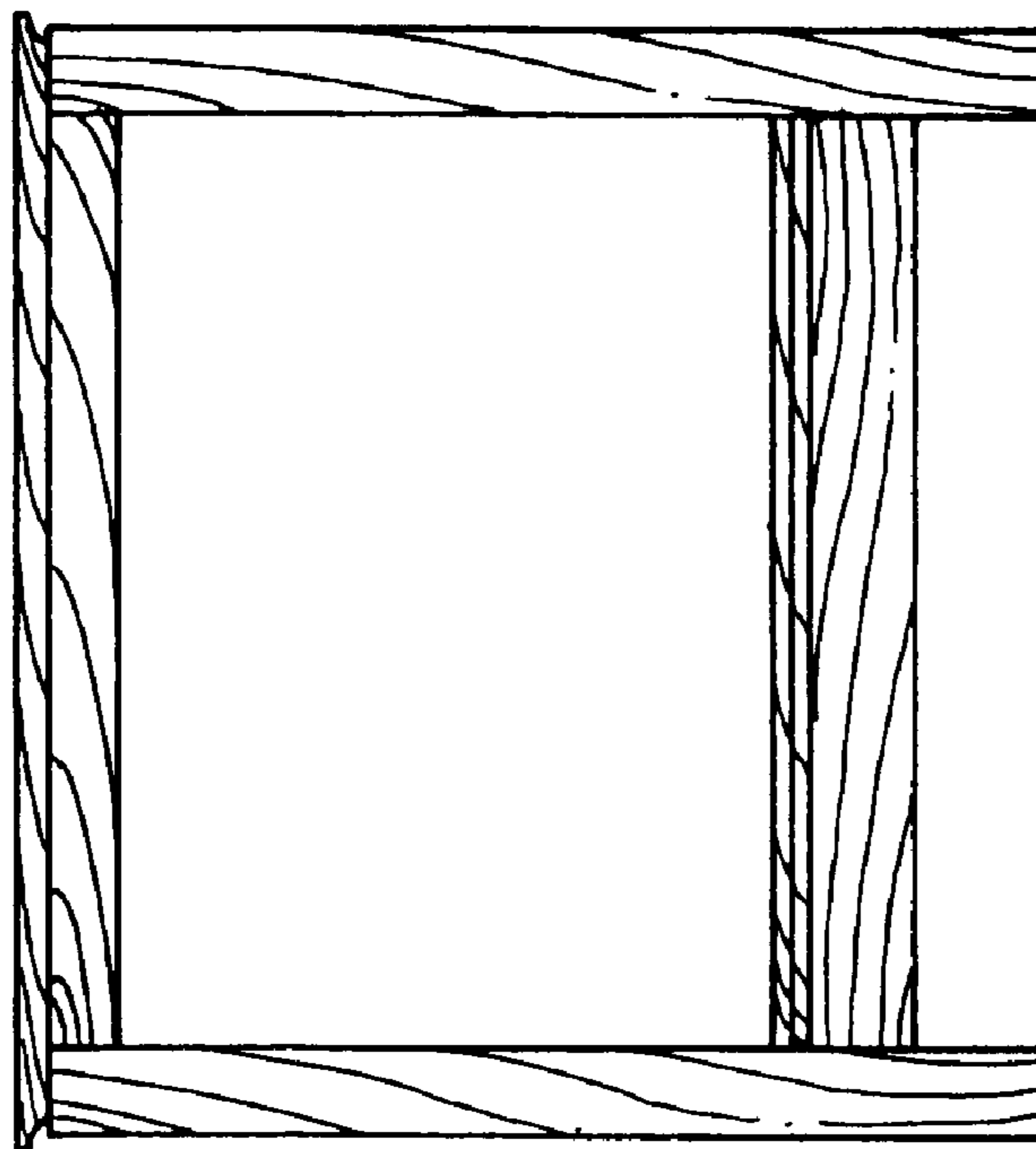

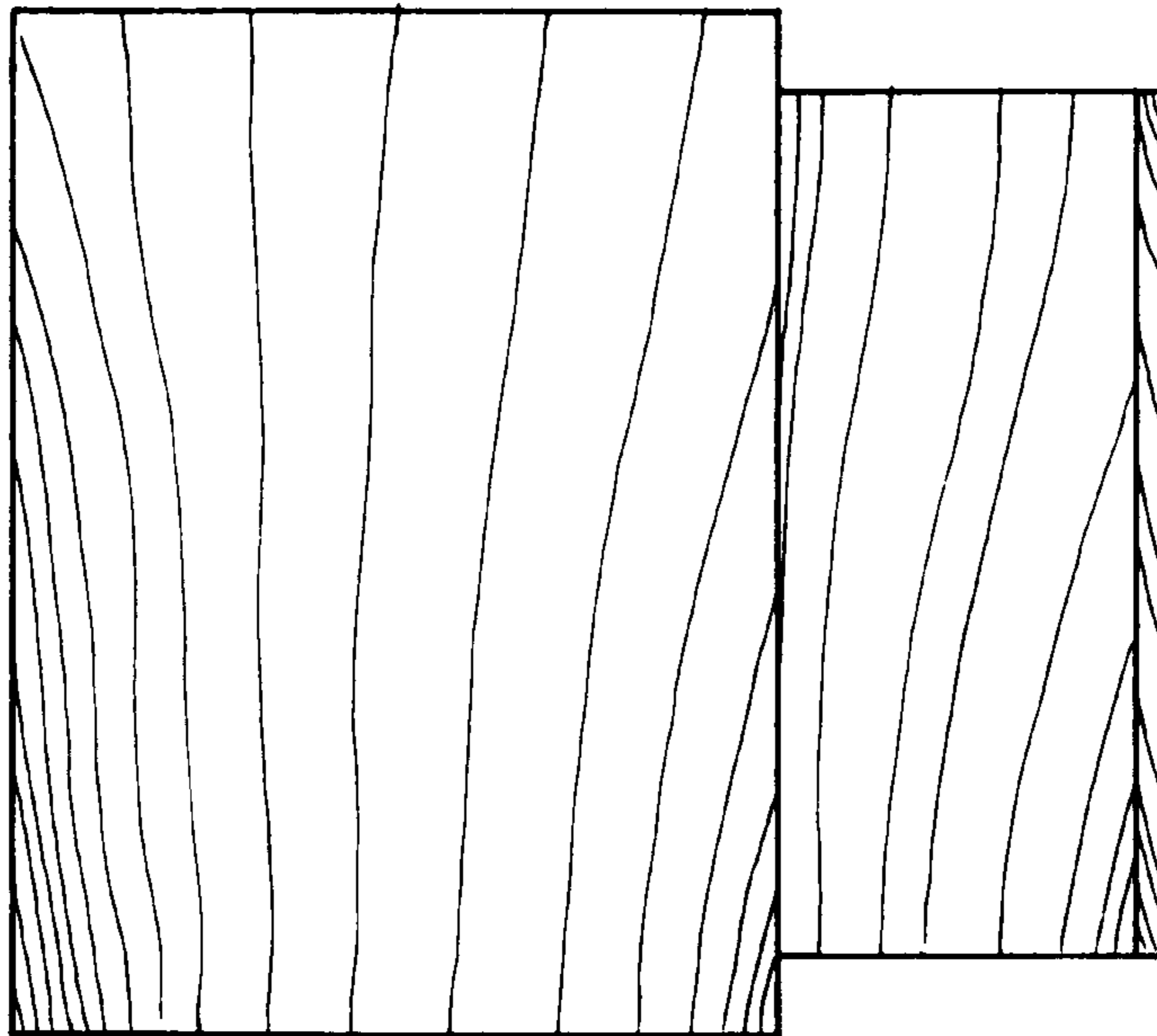

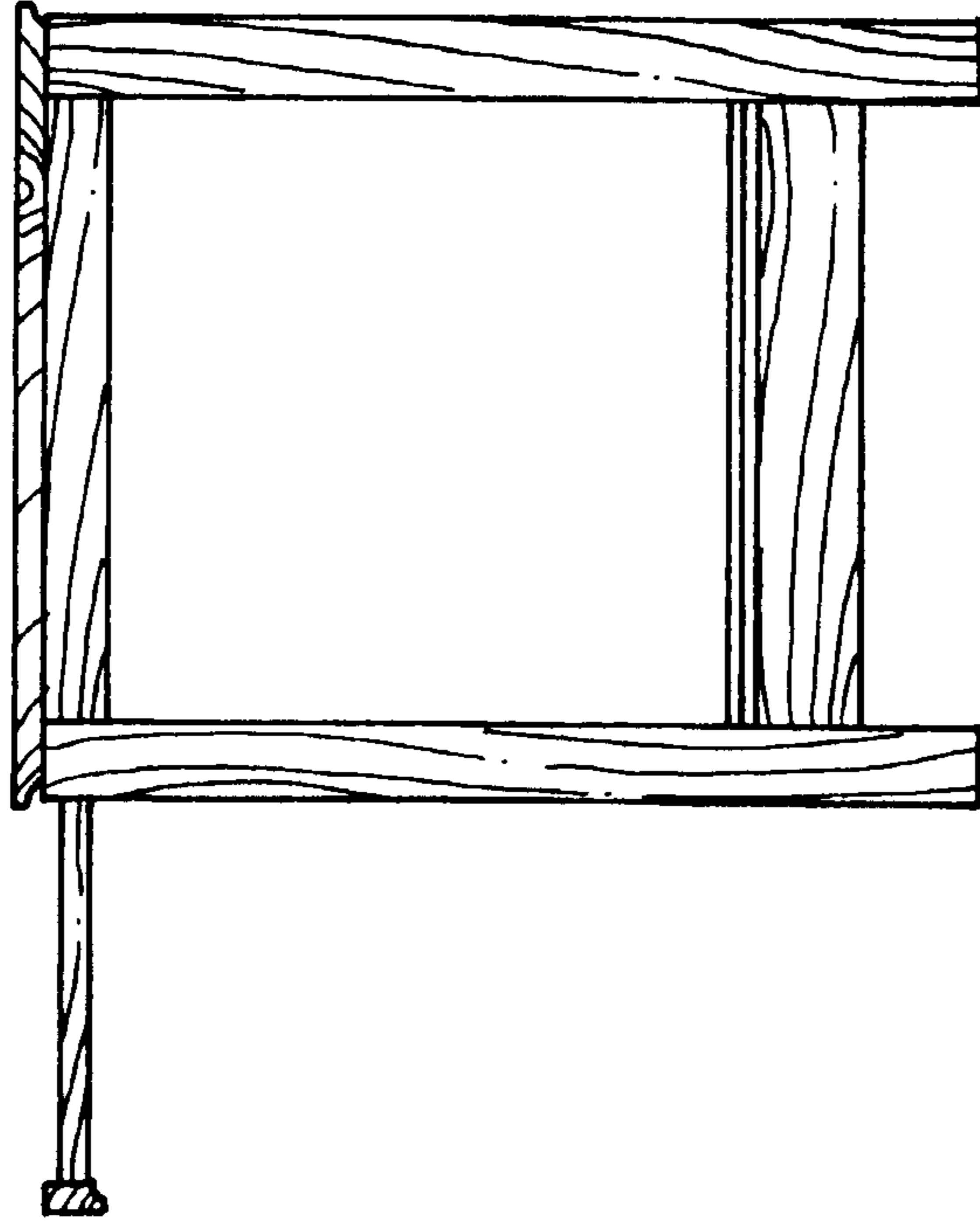

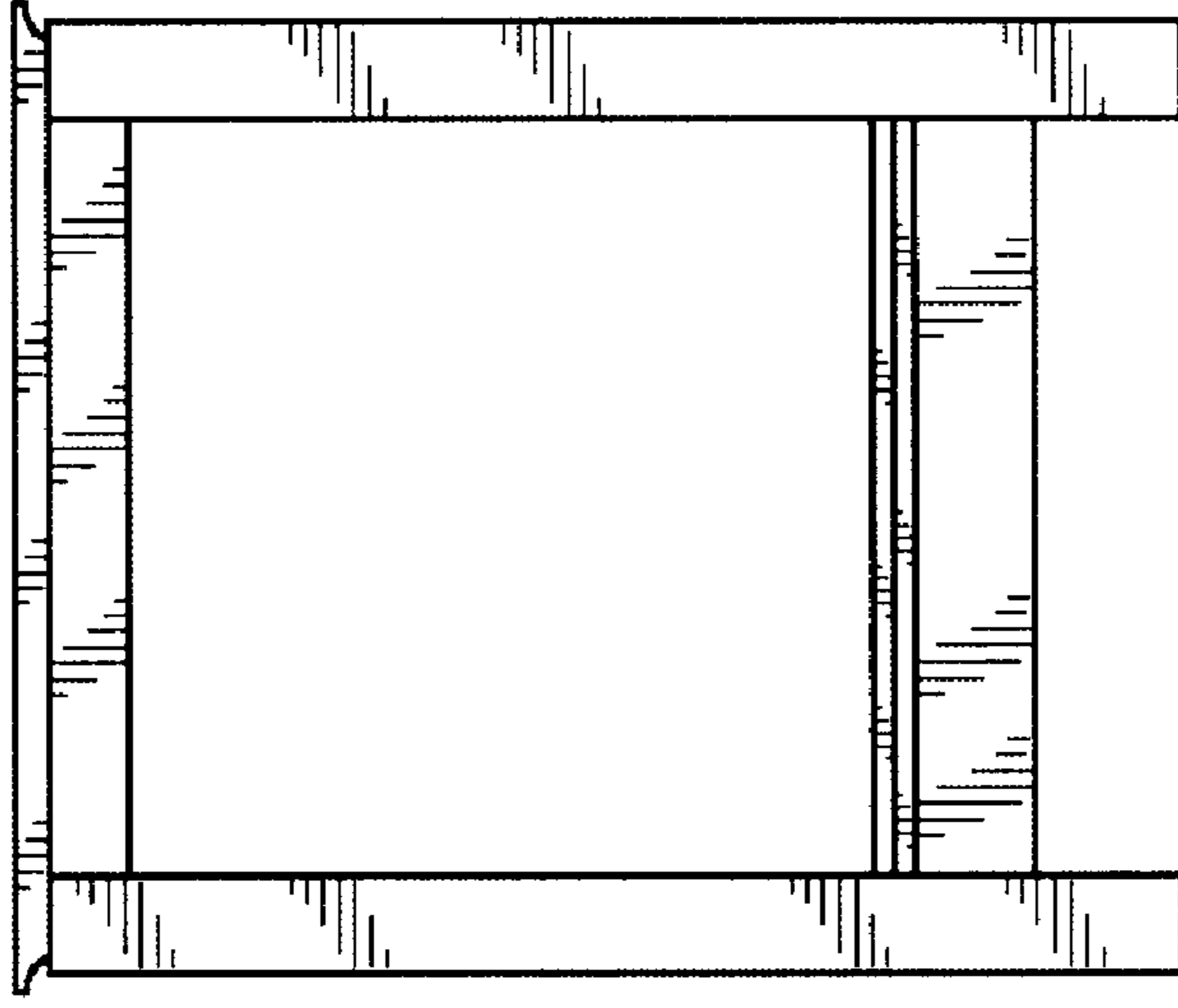

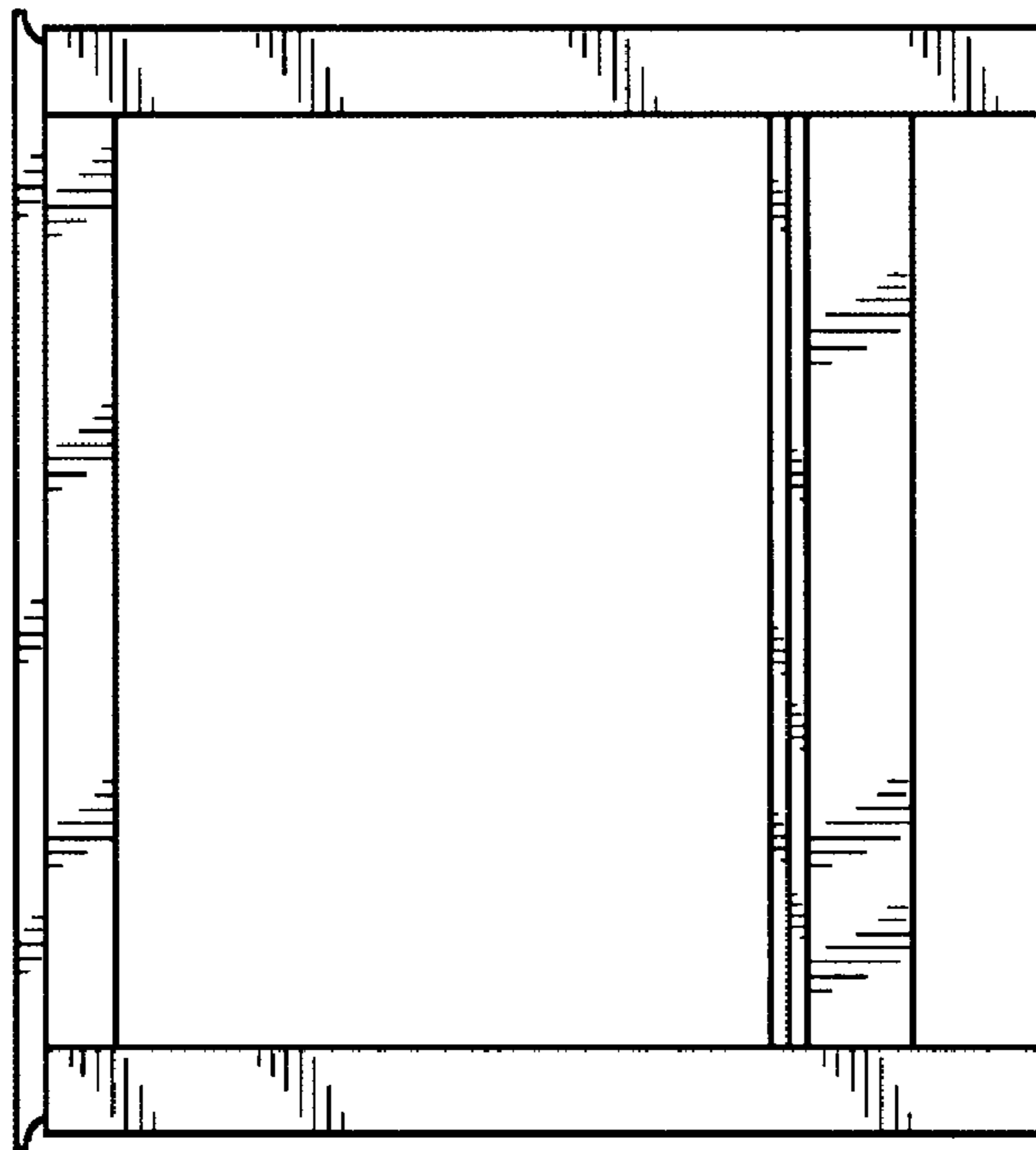

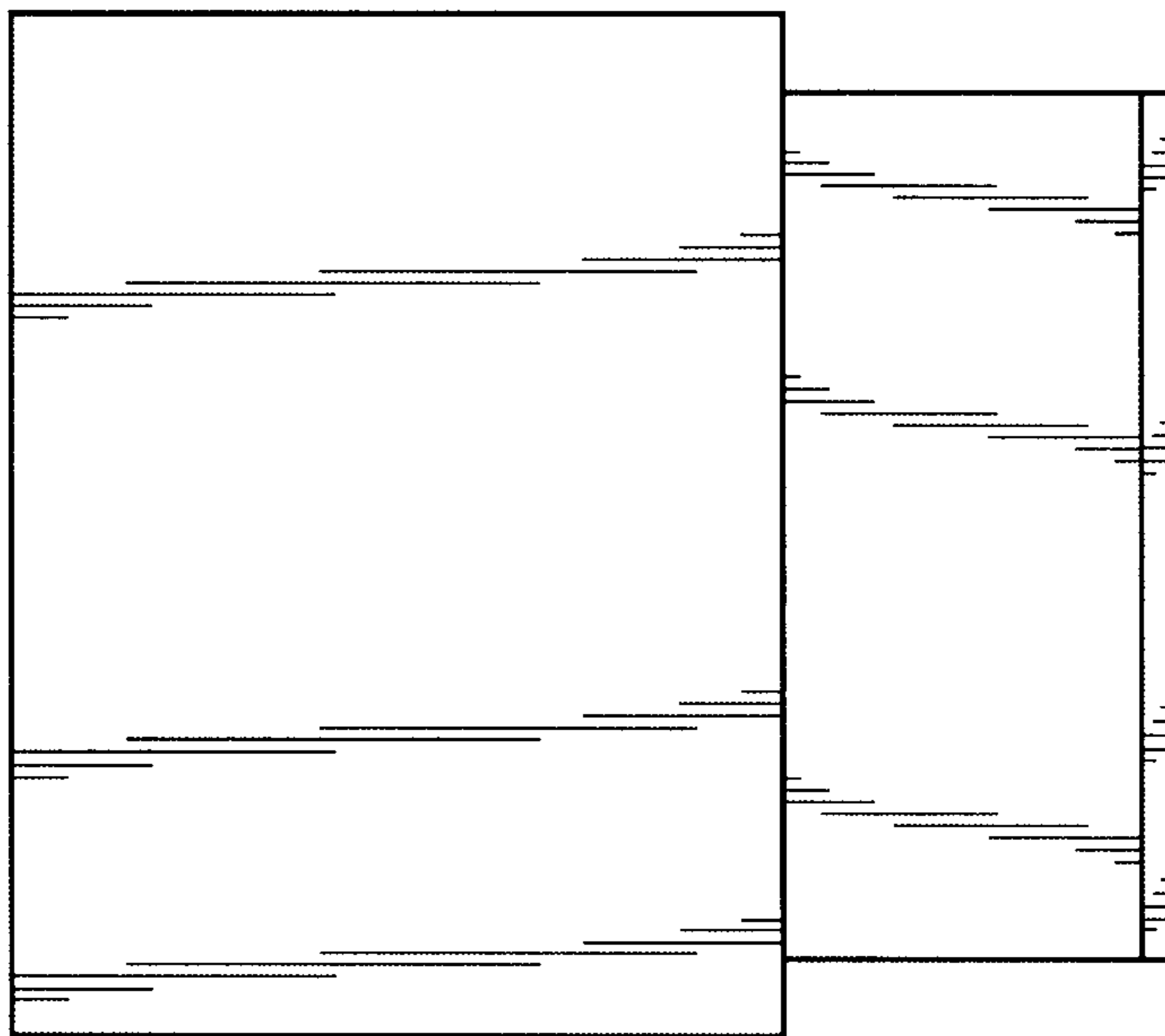

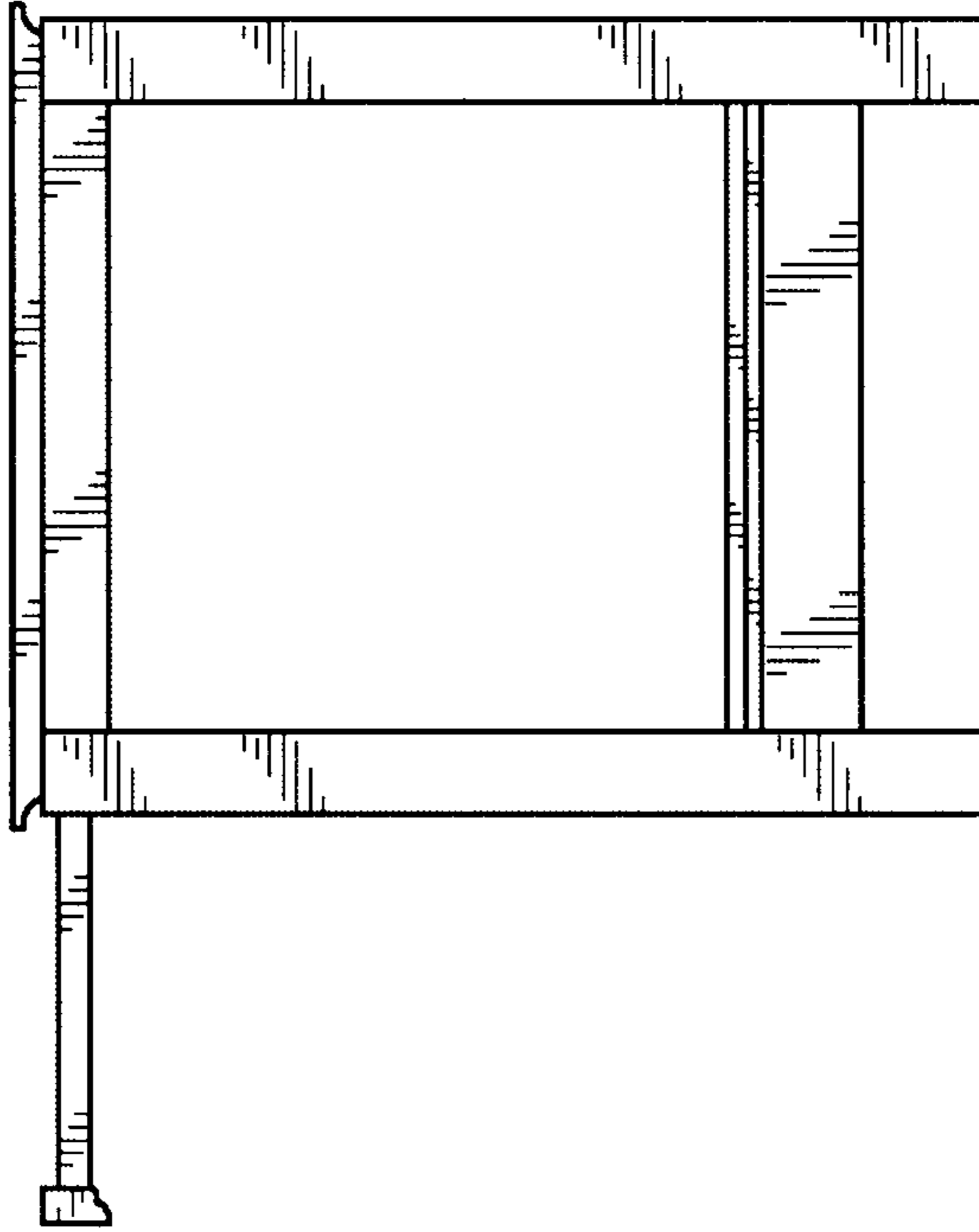
