(57) **CLAIM**

The ornamental design for a file cabinet, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a file cabinet embodying one aspect of our new design;

FIG. 2 is a front elevational view of the file cabinet of FIG. 1;

FIG. 3 is a left side profile view of the file cabinet of FIG. 1, it being understood that the right side profile view is a substantial mirror image;

FIG. 4 is a top plan view of the file cabinet of FIG. 1;

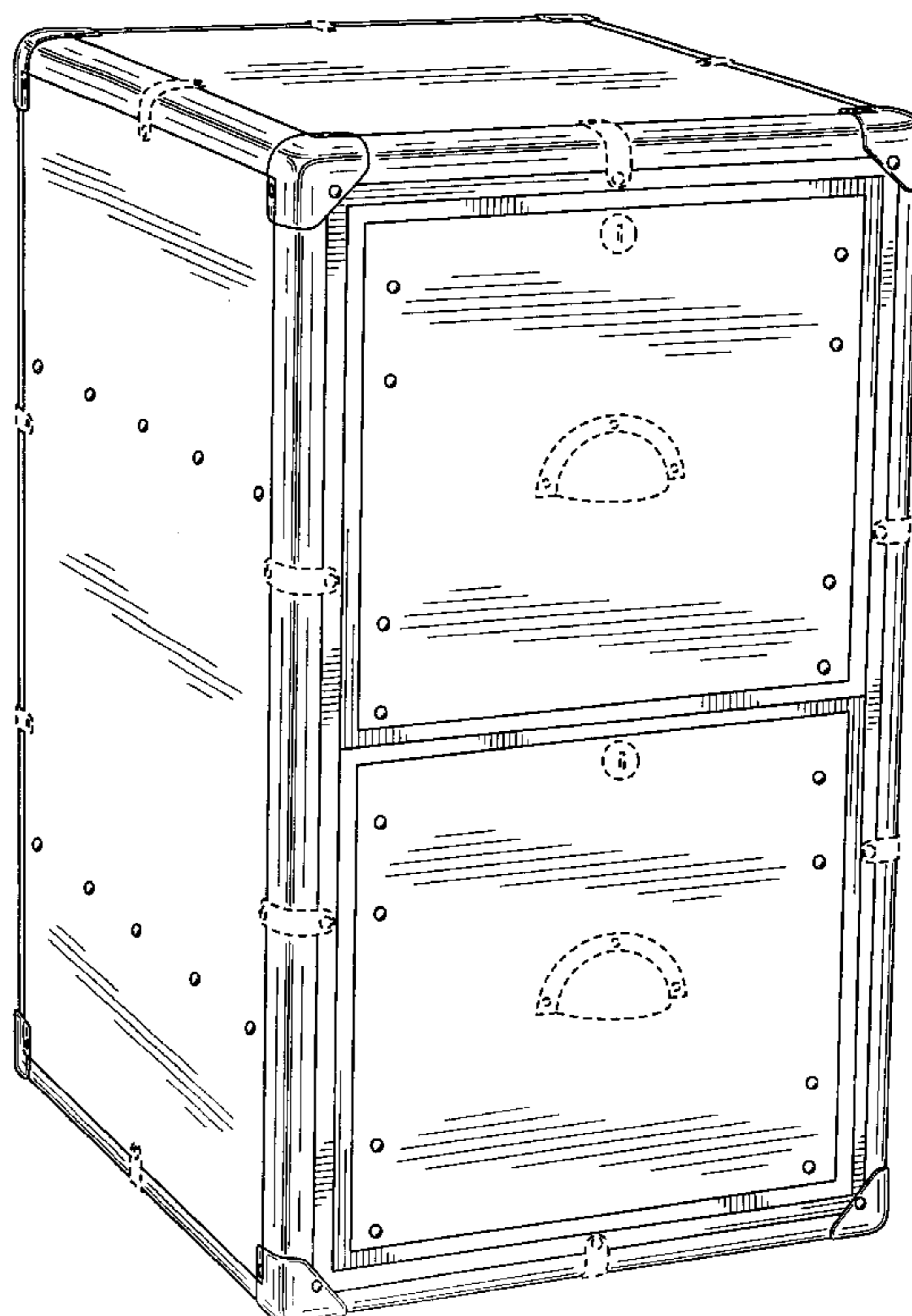
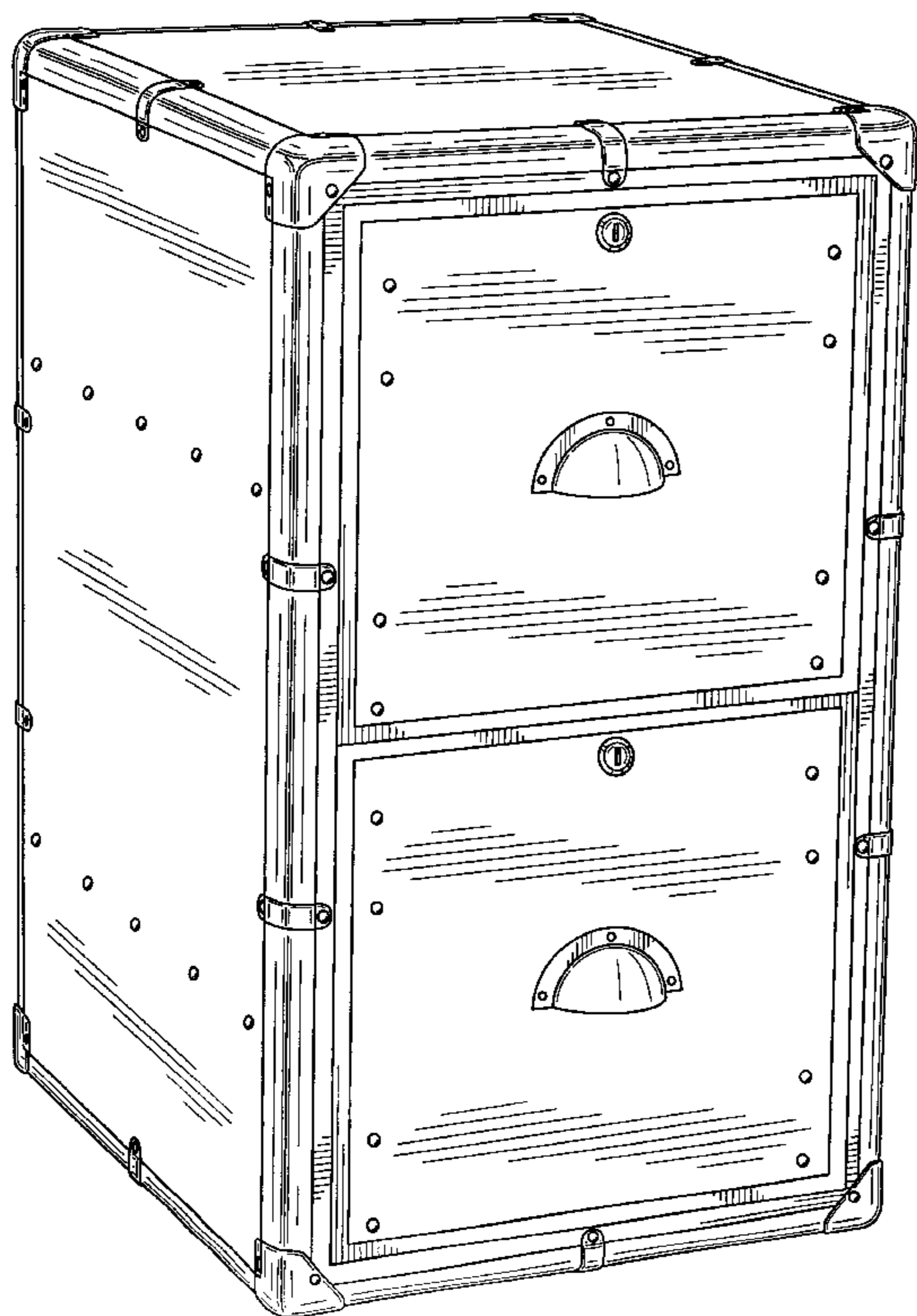
FIG. 5 is a perspective view of a file cabinet embodying another aspect of our new design, it being understood that the subject matter illustrated in dashed lines forms no part of the claimed subject matter;

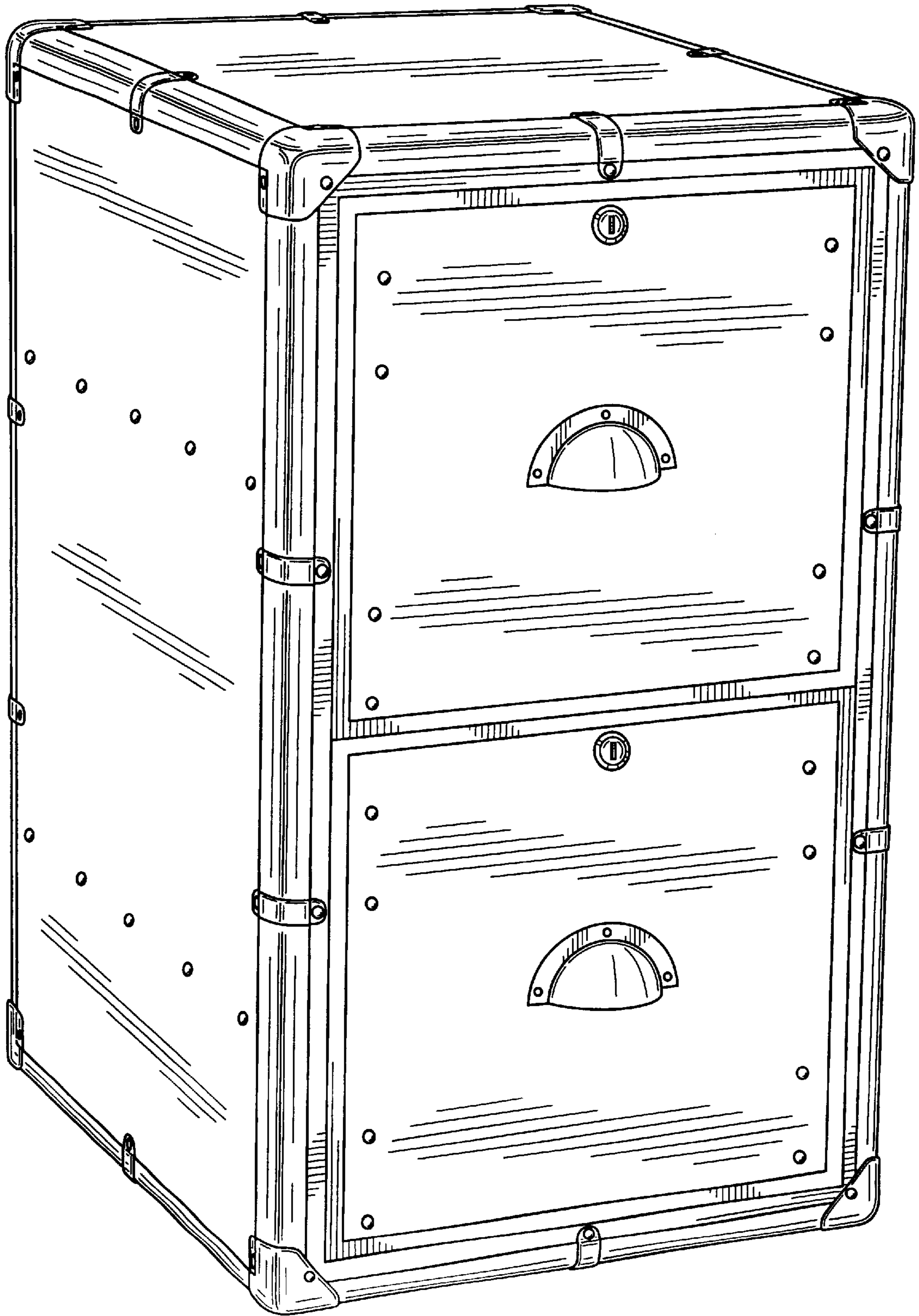

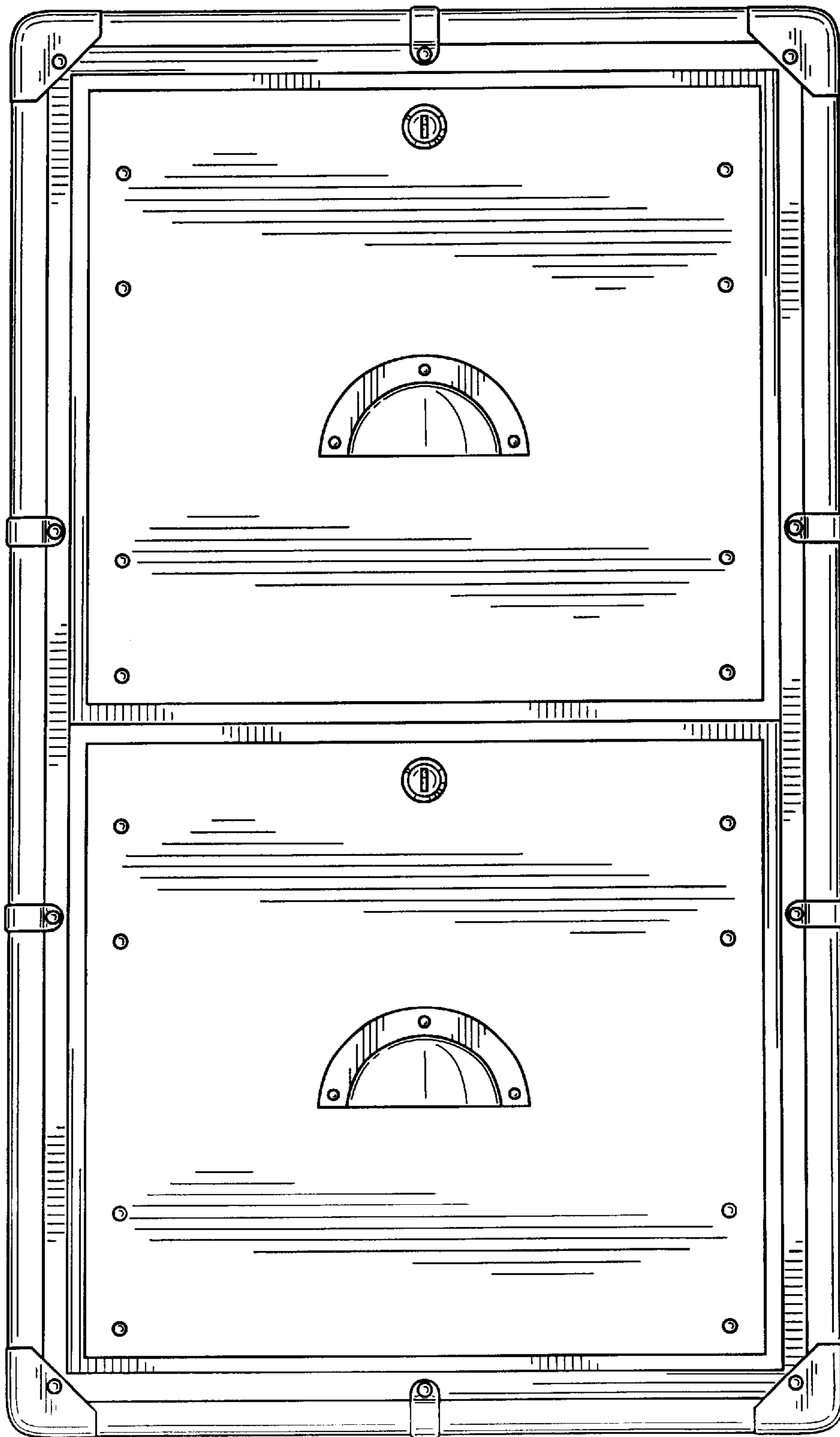

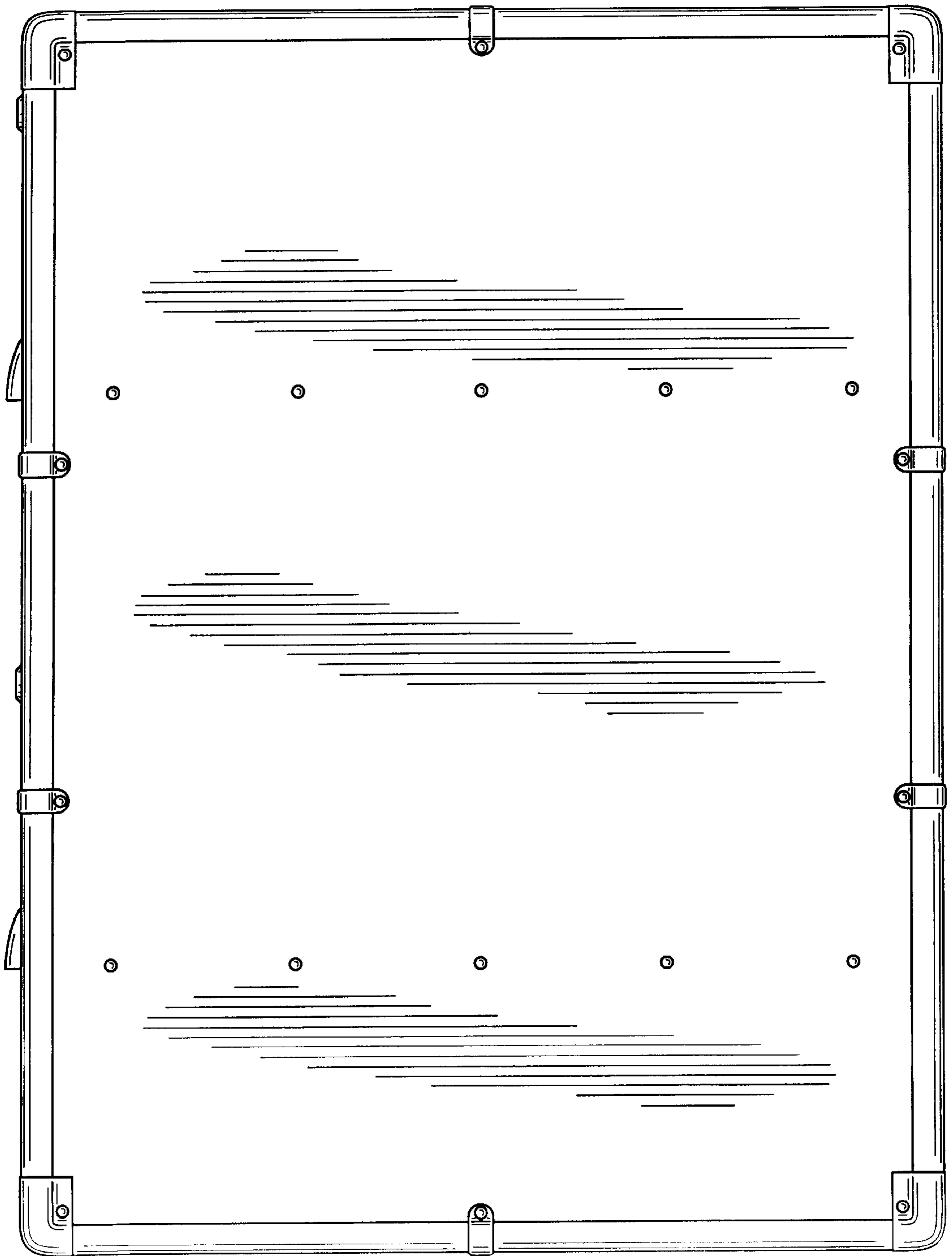

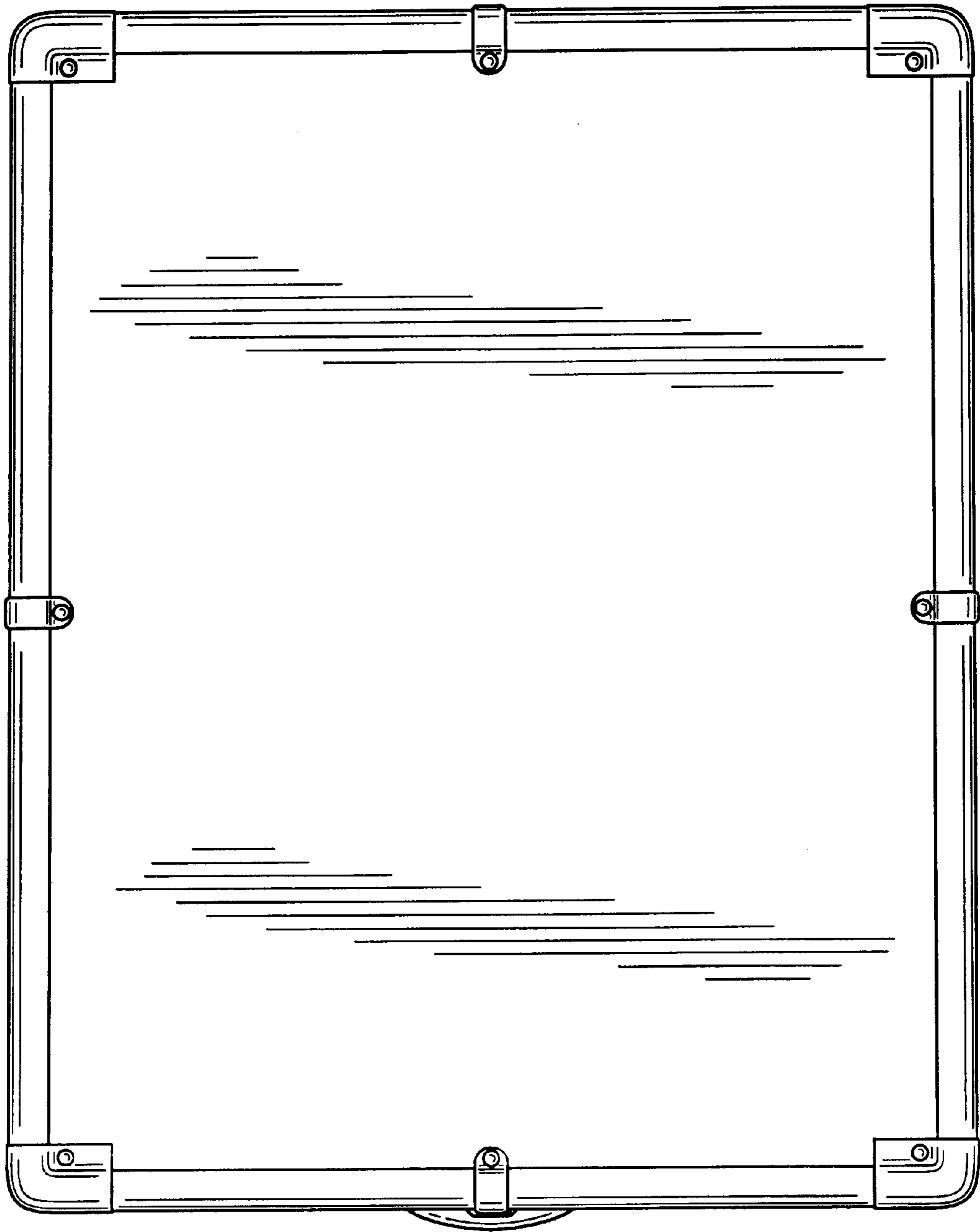

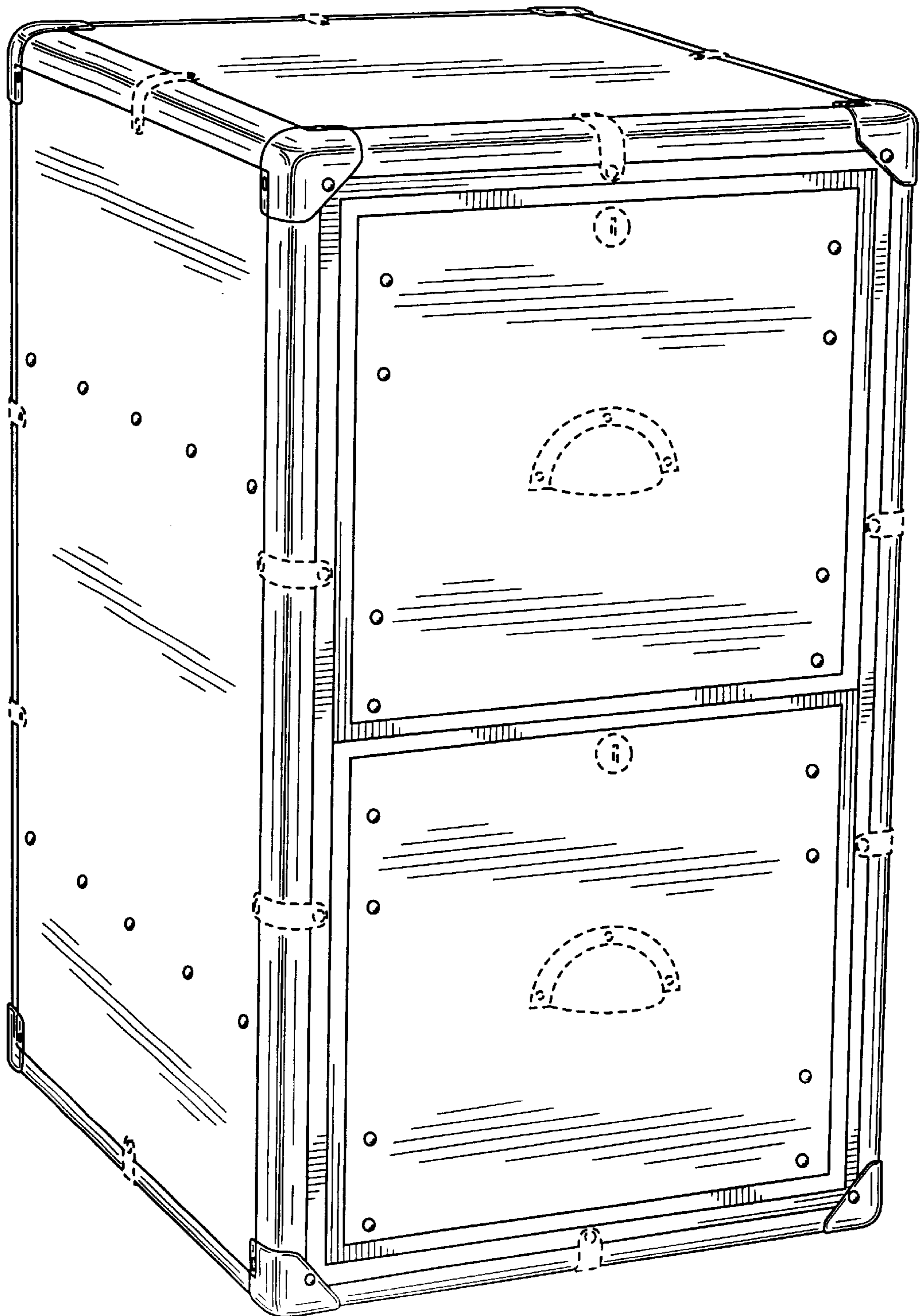

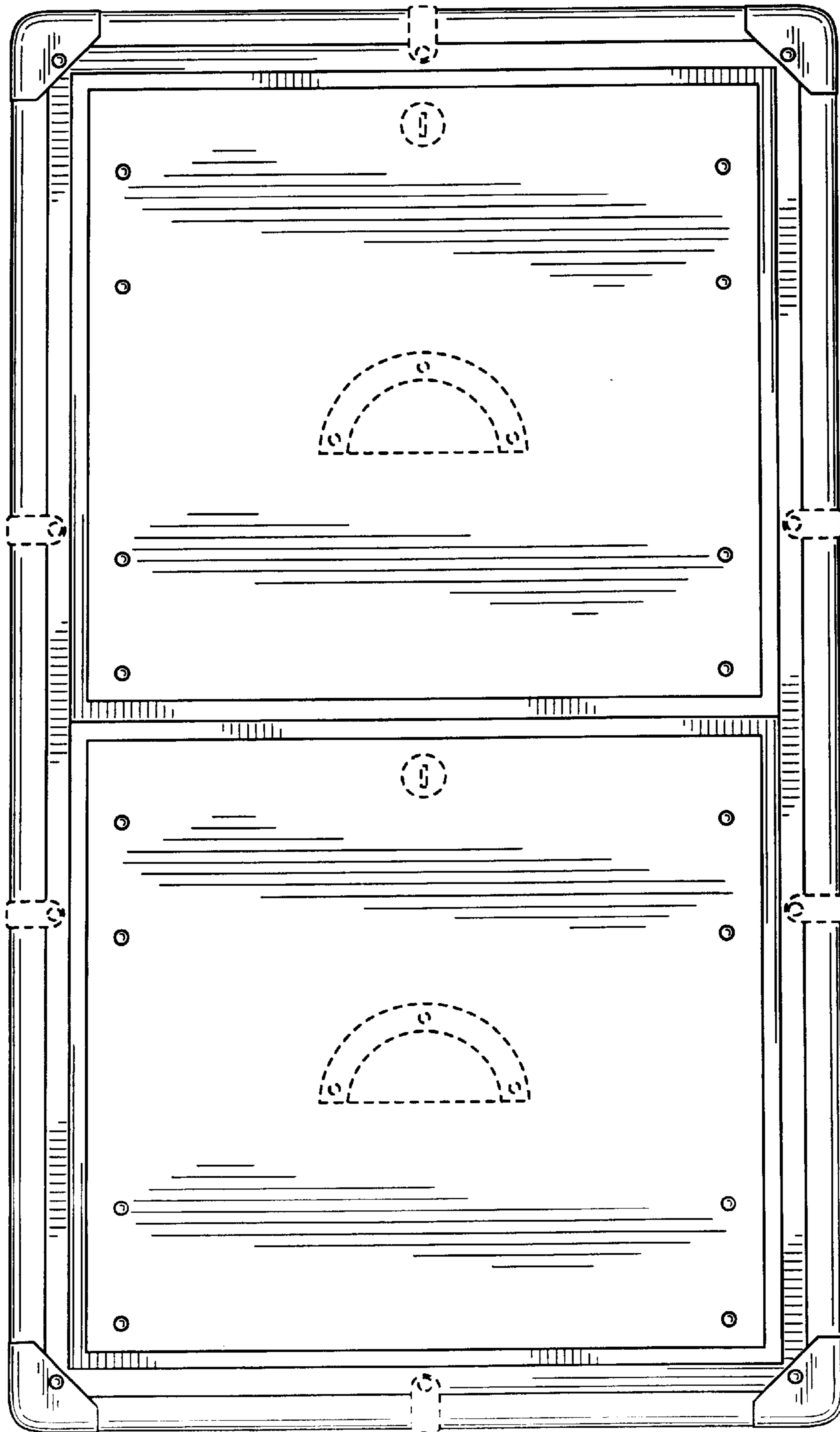

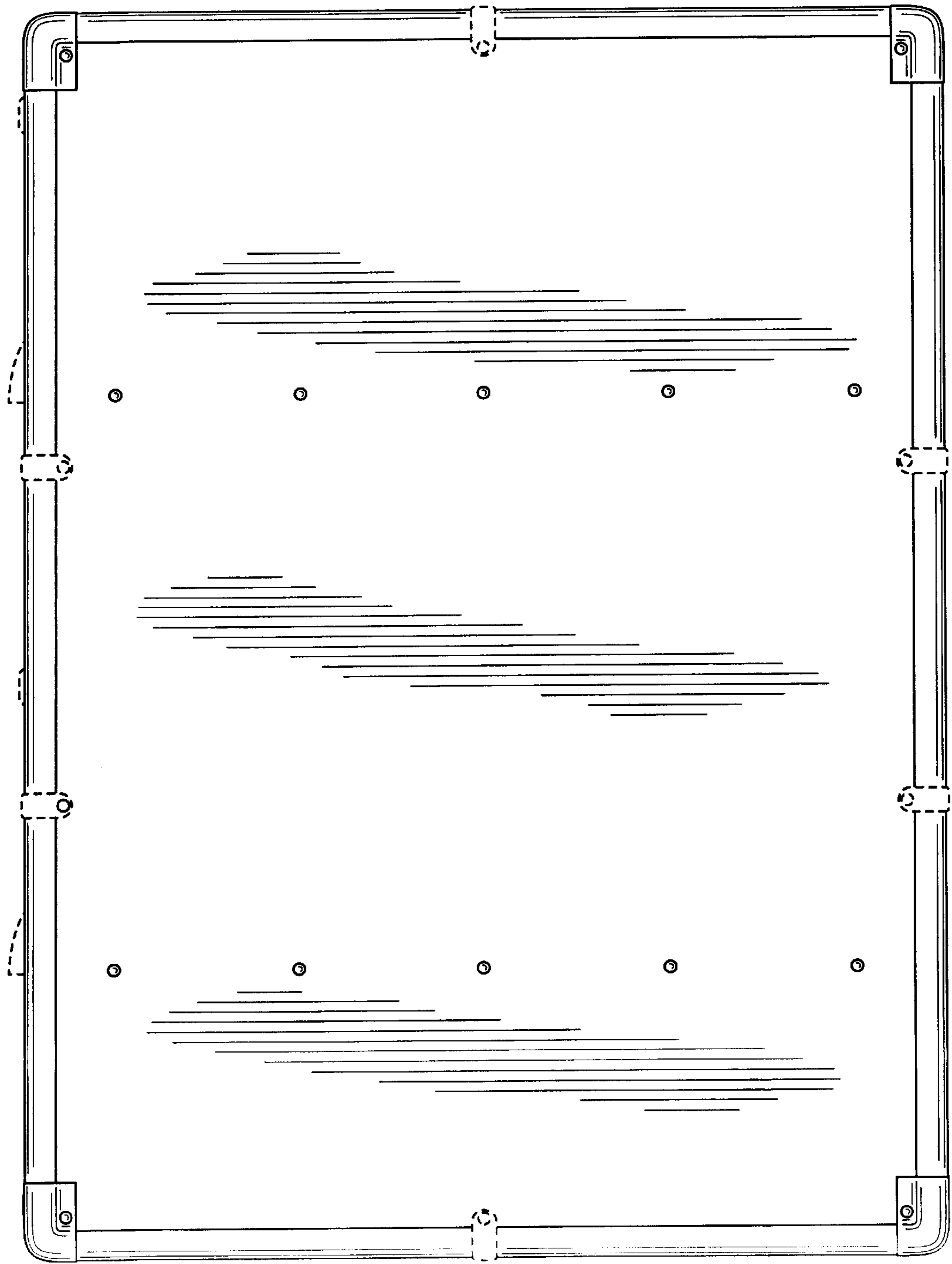

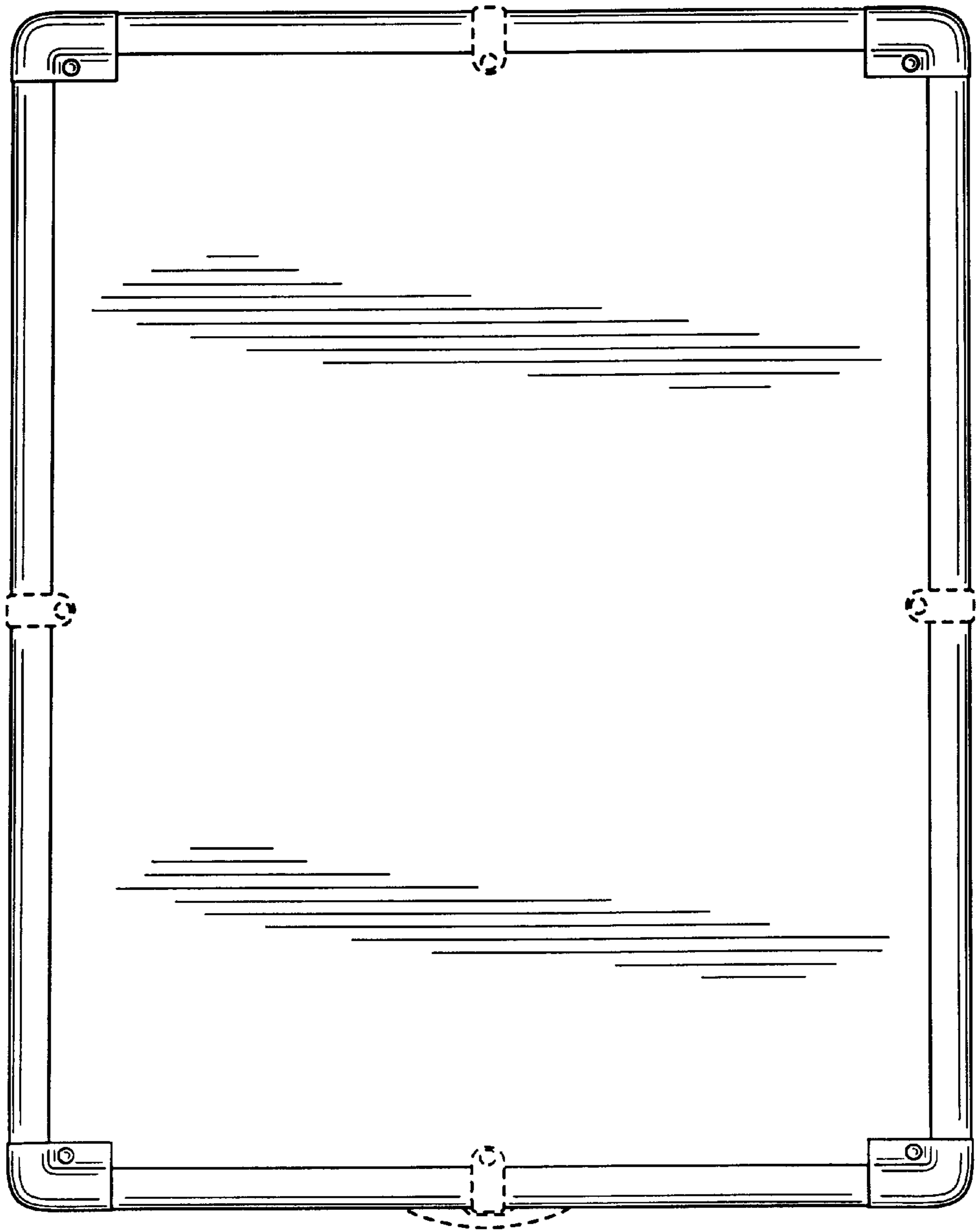
