(57) **CLAIM**

The ornamental design for a concrete table having a metal face, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing my new design of a concrete table having a metal face; FIG. 2 is a front elevational view thereof; FIG. 3 is a top elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a bottom elevational view thereof; and, FIG. 6 is a left side elevational view thereof which is the mirror image of the right side of the concrete table. The broken lines are for environmental purposes only and form no part of the claimed design.

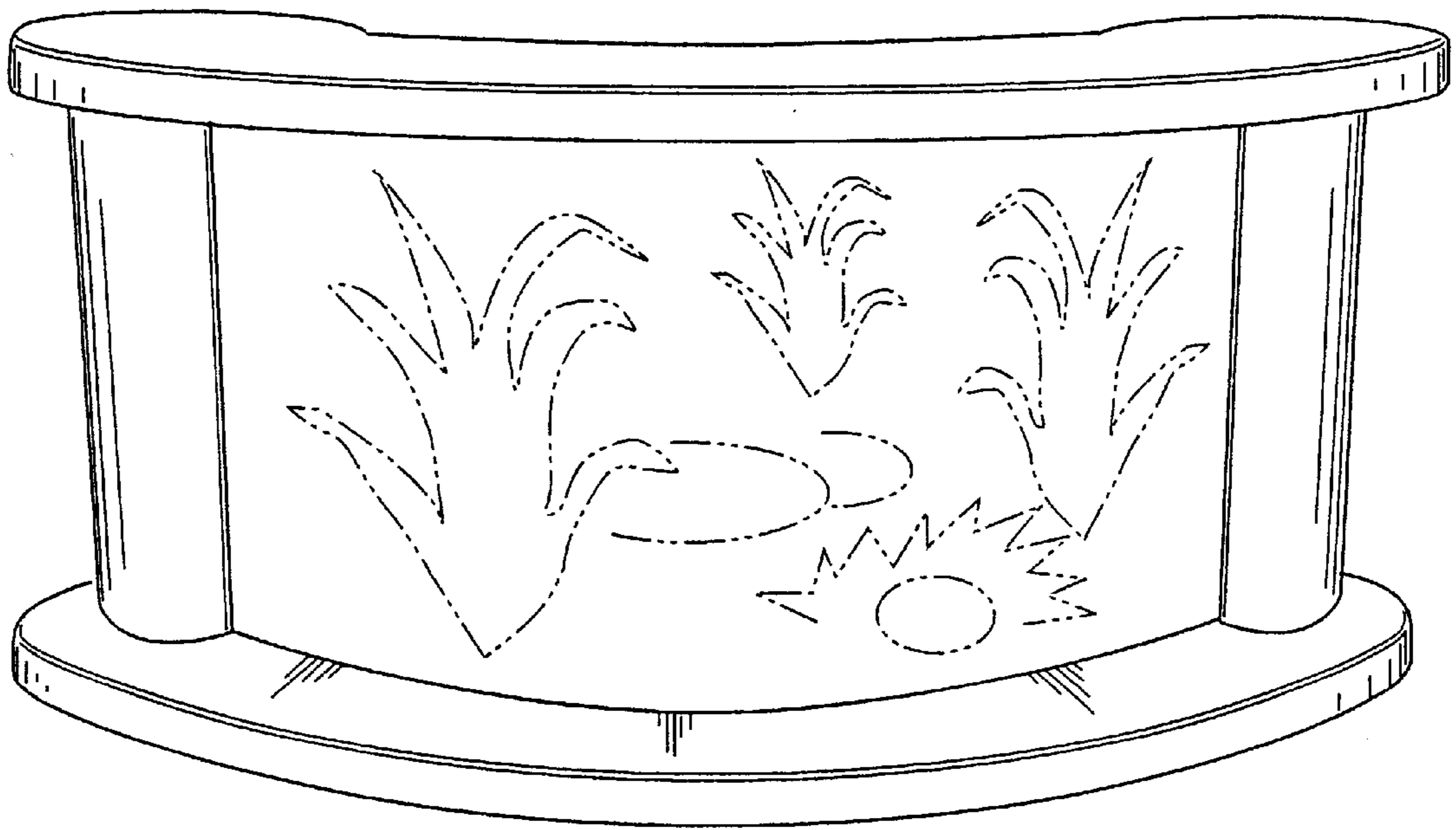
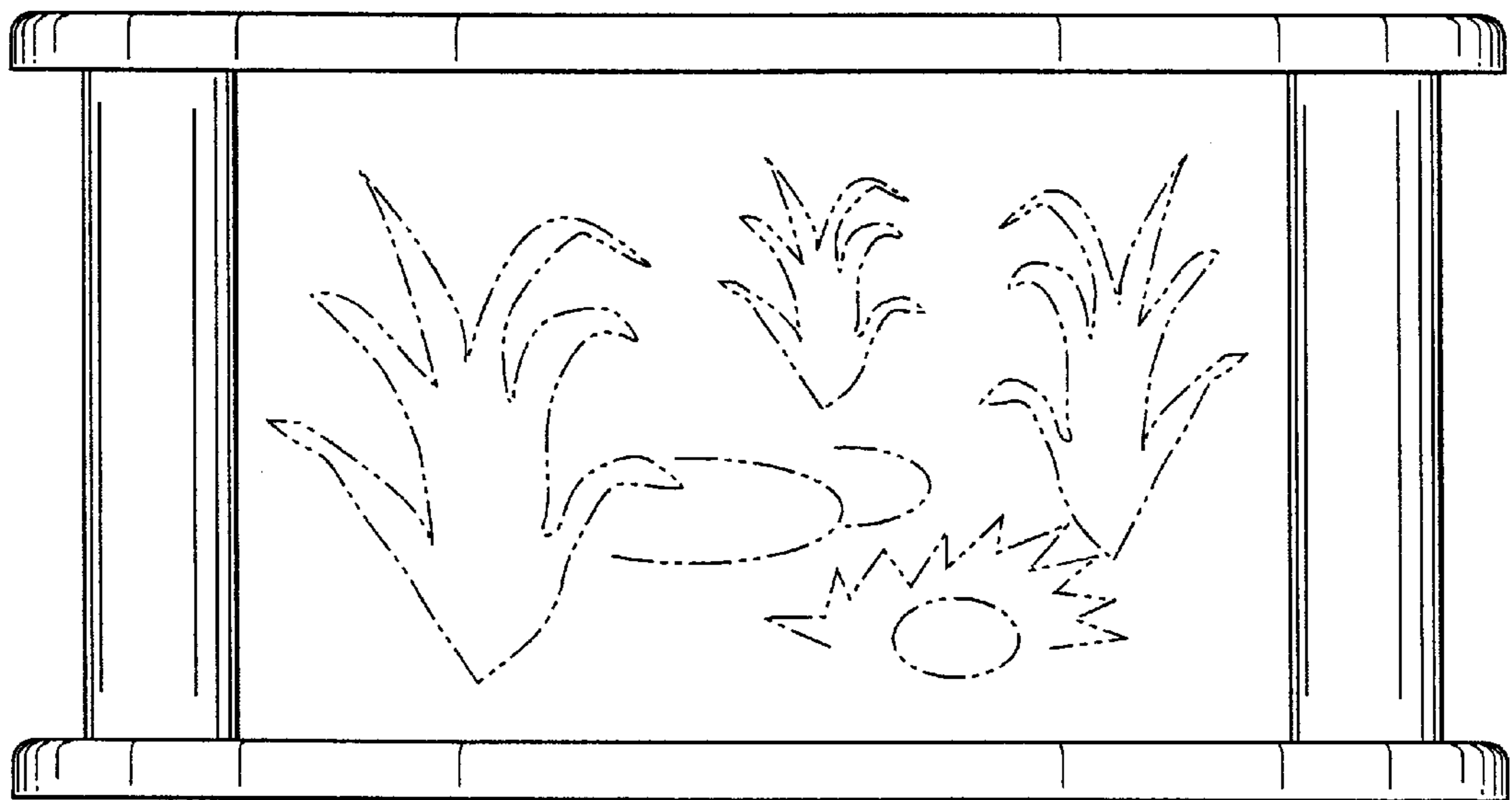

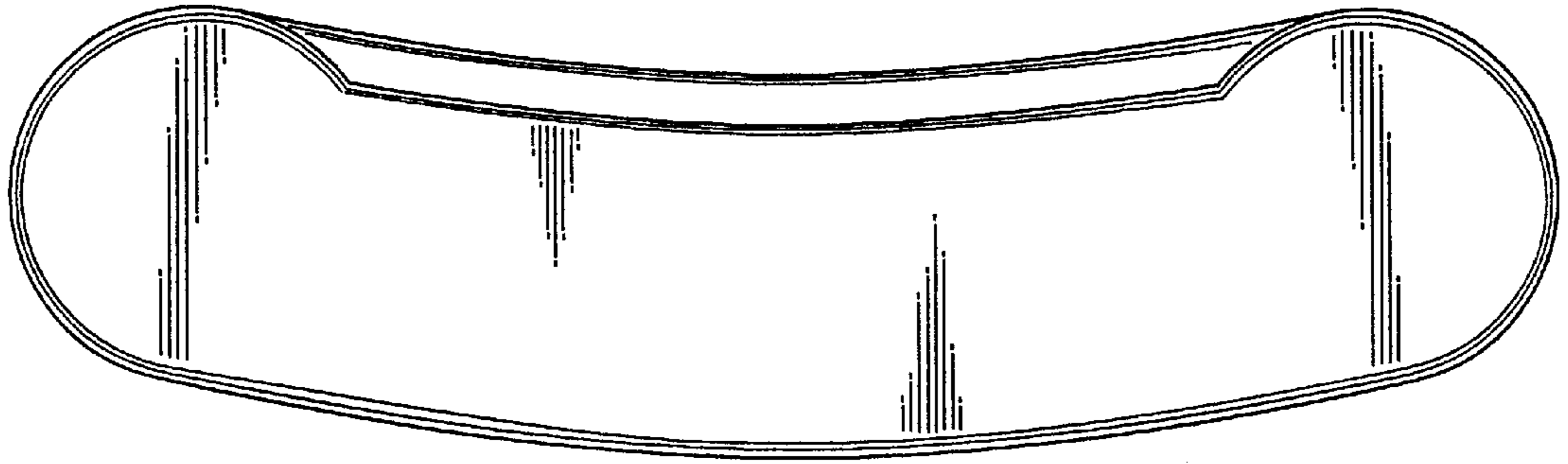
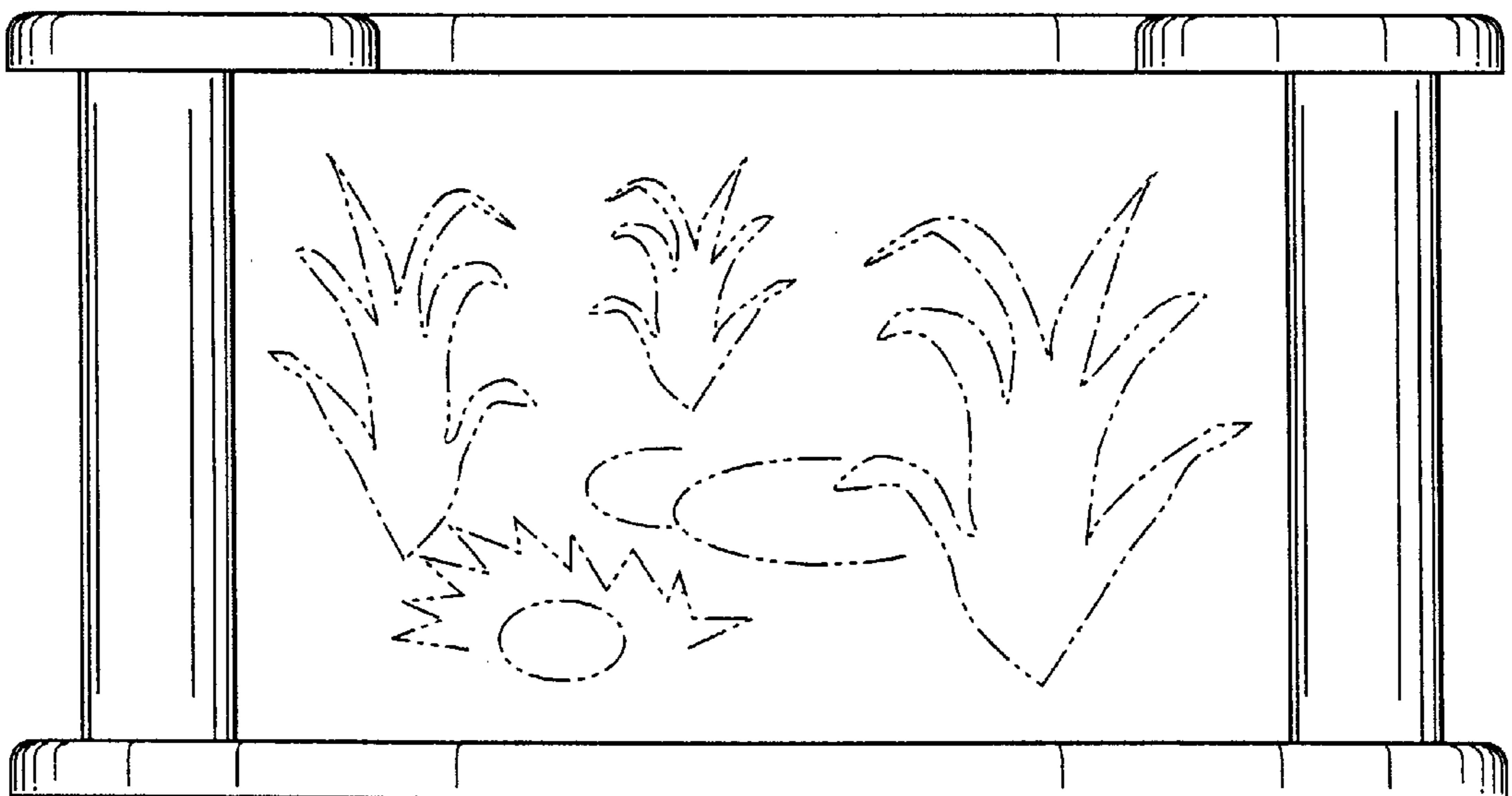

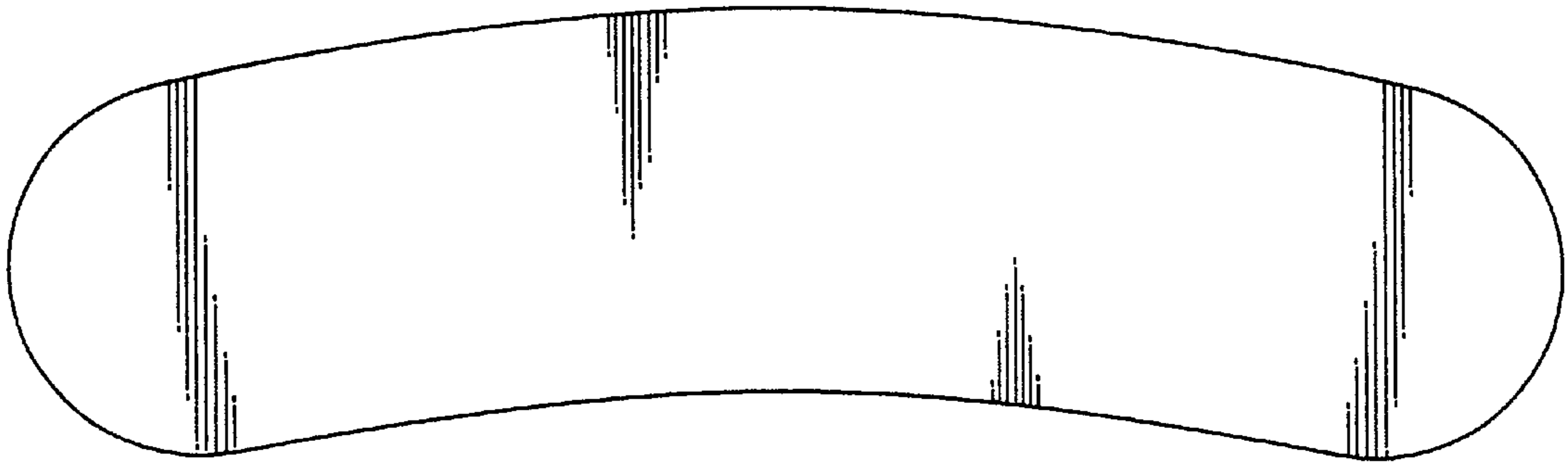
