FIG. 12 is a left side view thereof with the ring-shaped handle being fully extended.

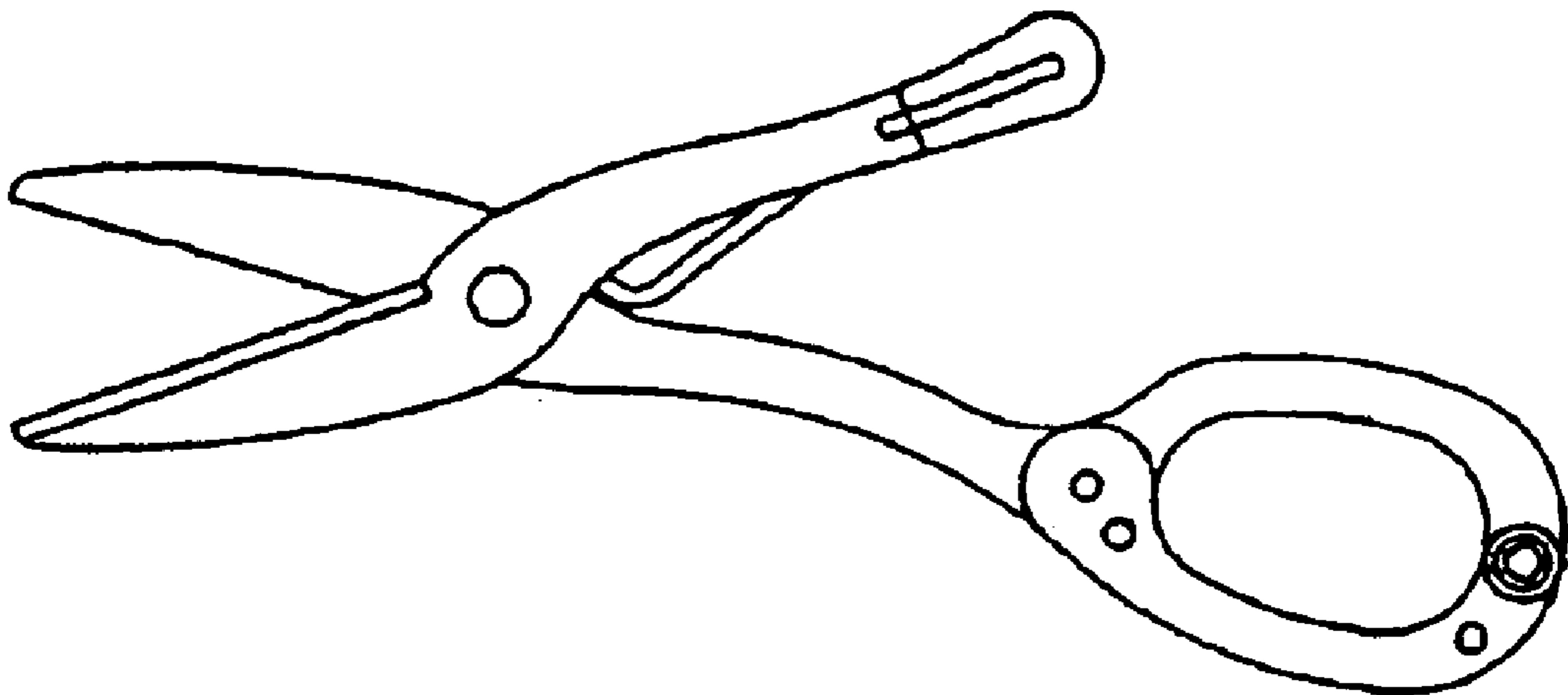

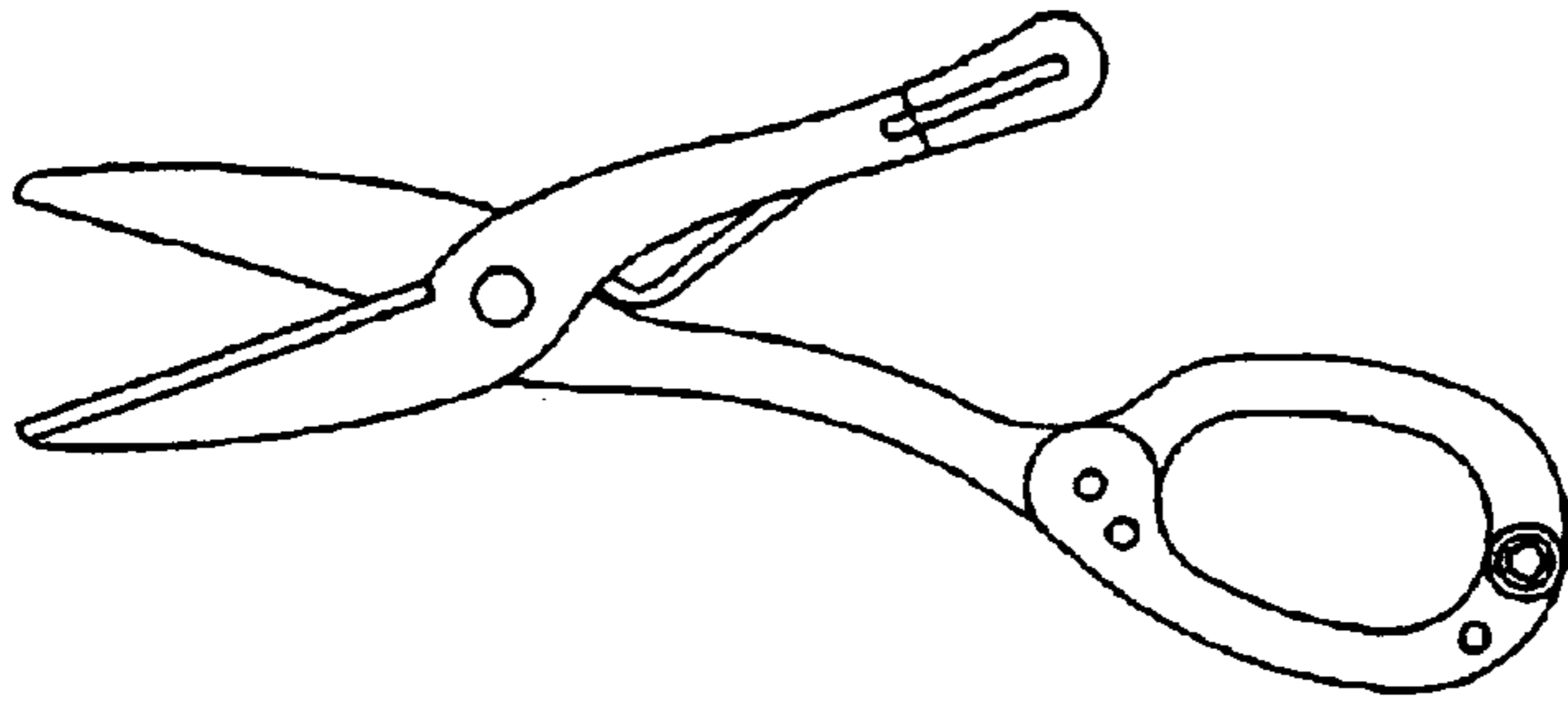

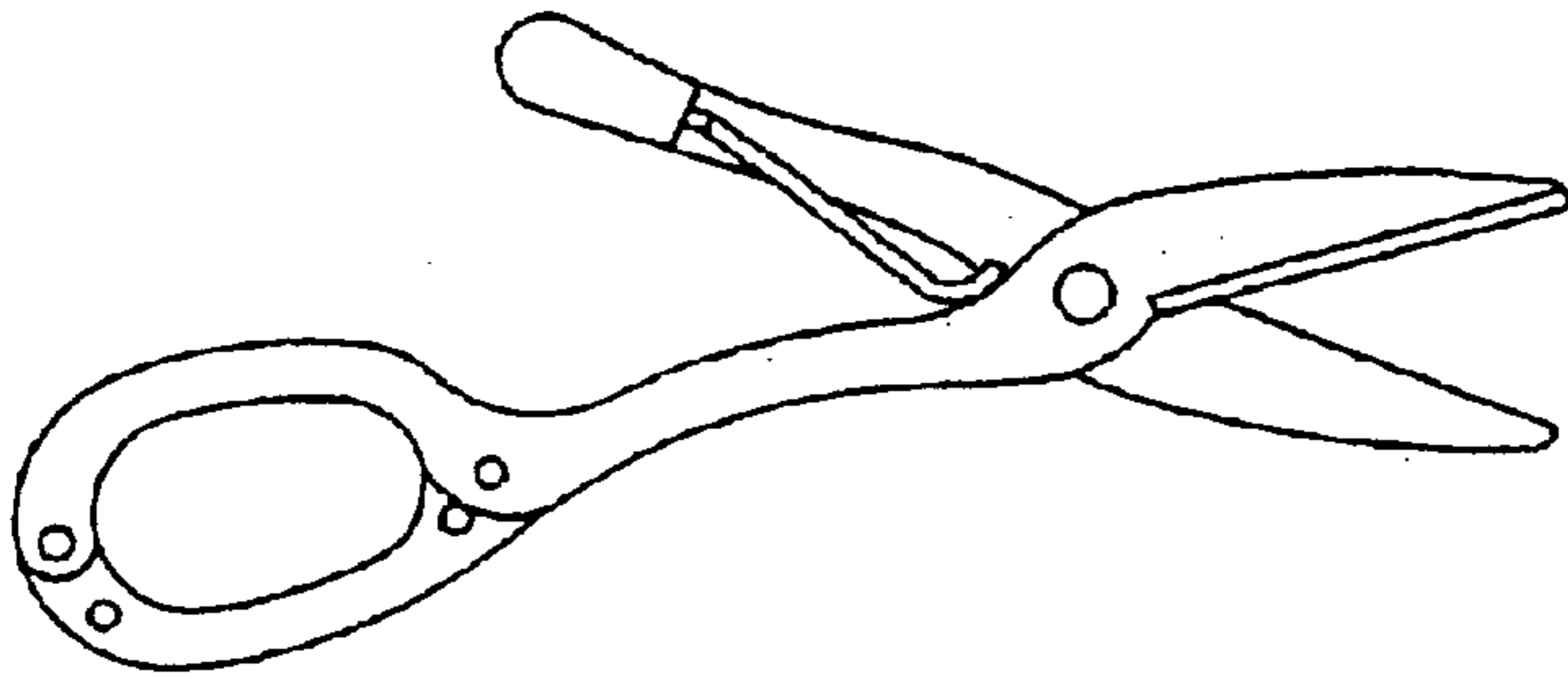

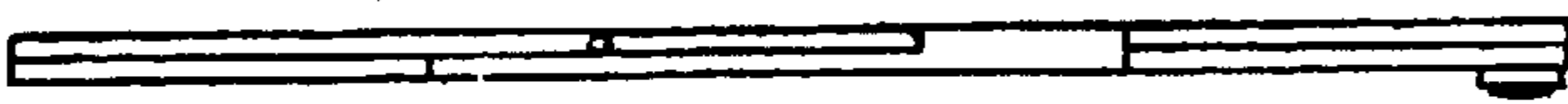

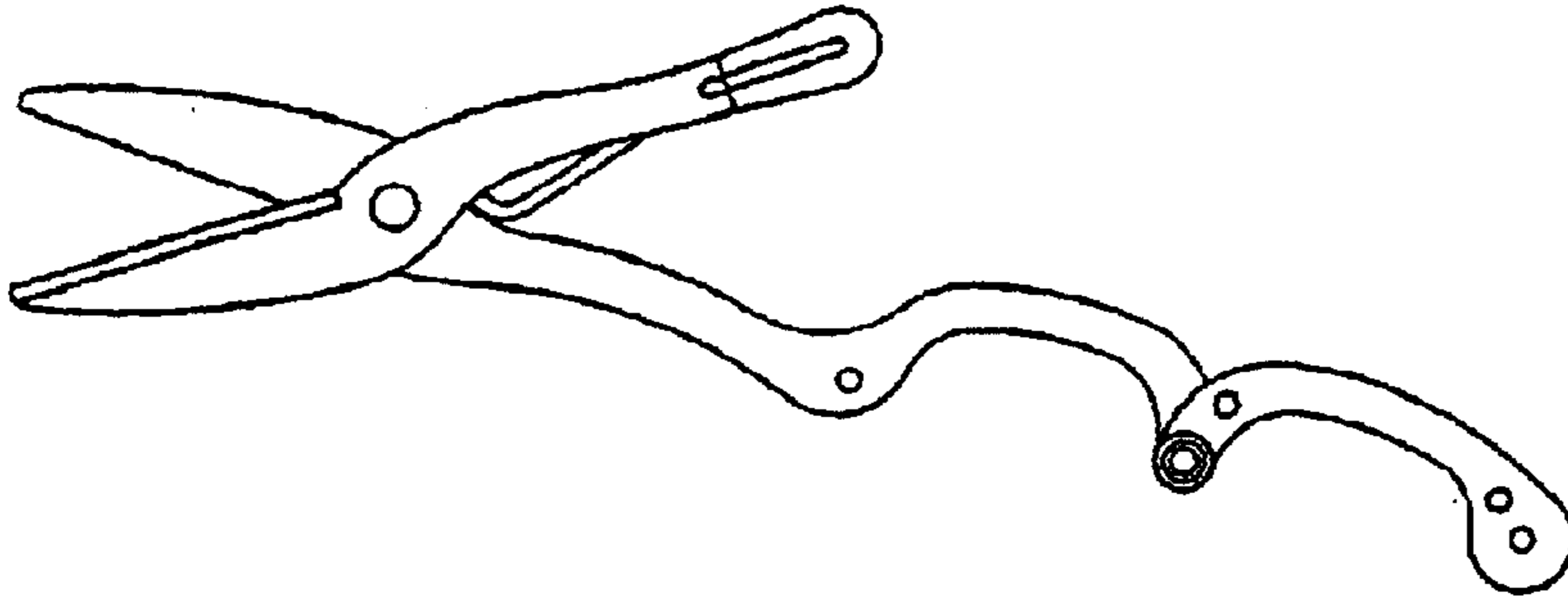

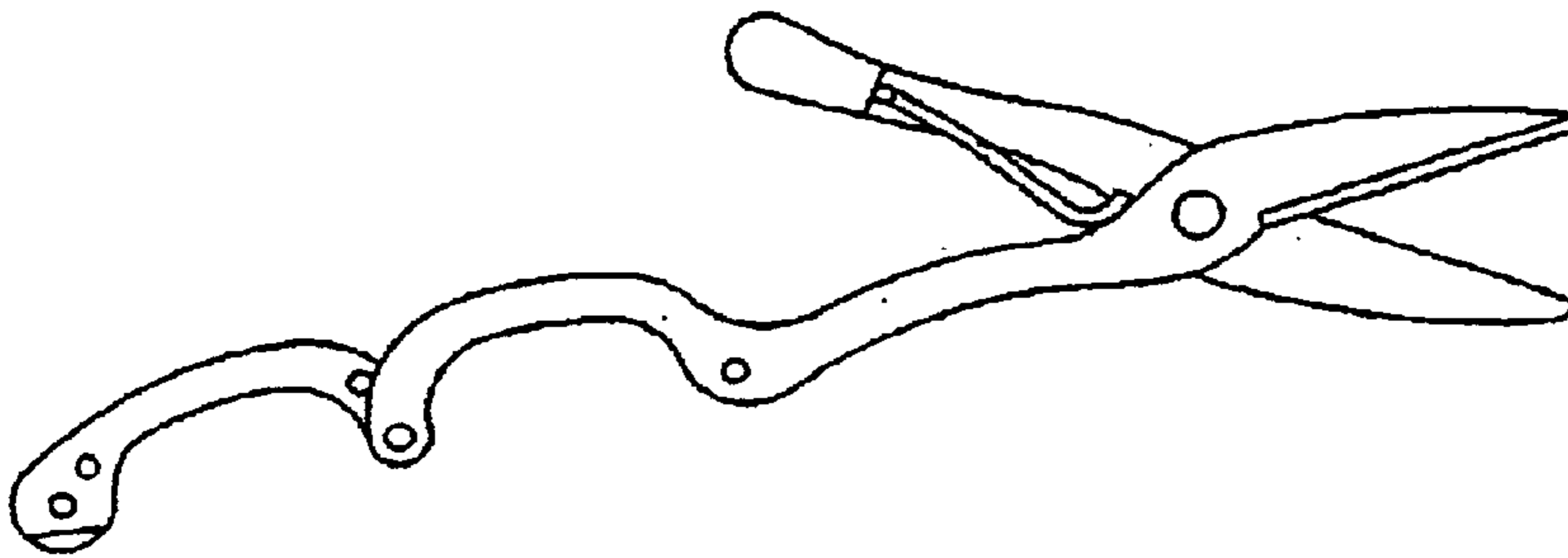

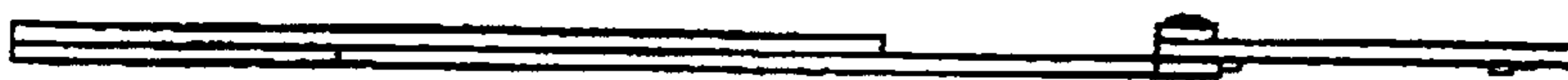
