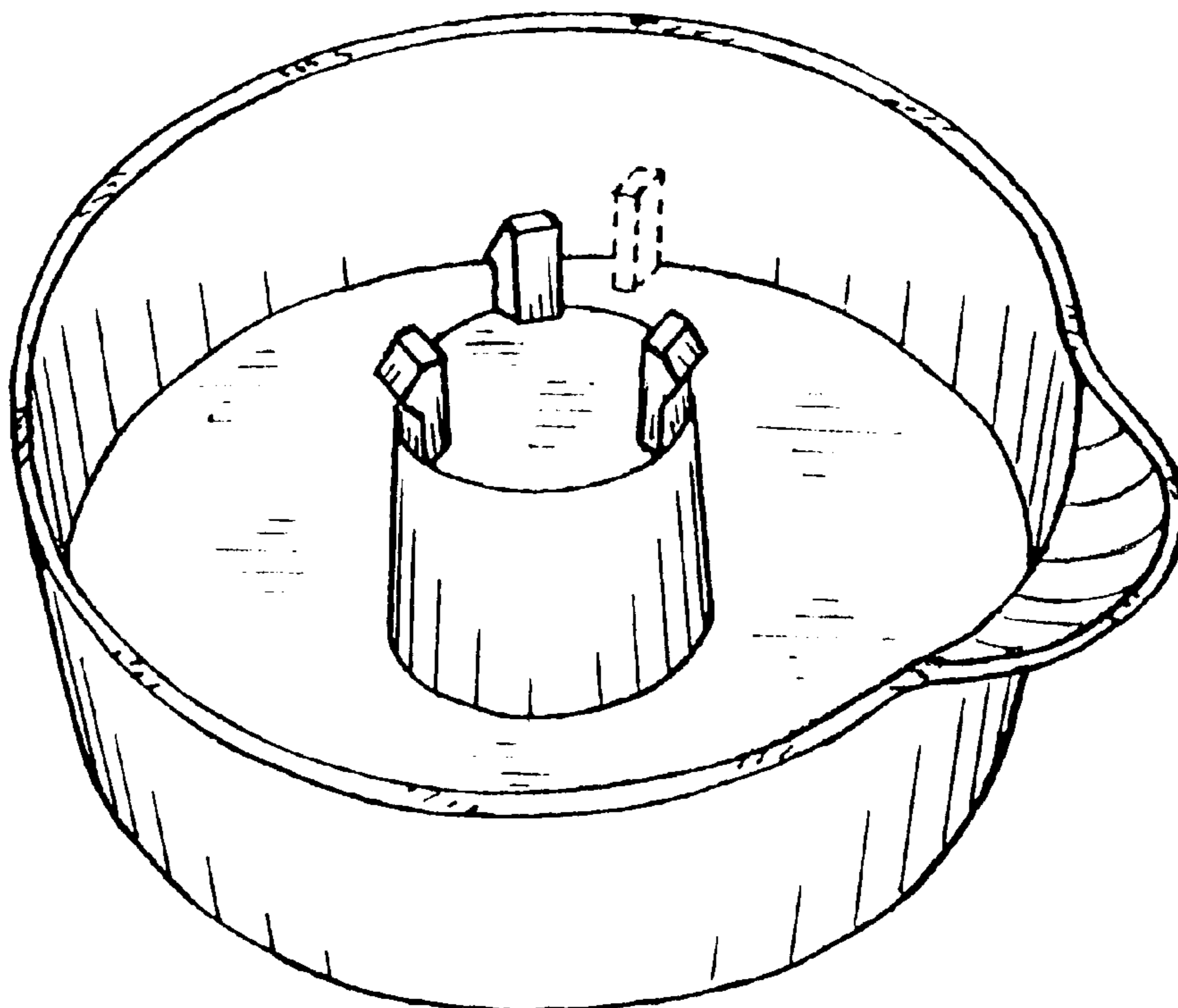

DESCRIPTION

FIG. 1 is a perspective view of a tray for hanging basket shown from the side and top for convenience of illustration; FIG. 2 is a left elevational view of FIG. 1; FIG. 3 is a top plan view of FIG. 1; FIG. 4 is a rear elevational view of FIG. 1; FIG. 5 is a bottom plan view of FIG. 1; FIG. 6 is a front elevational view of FIG. 1; FIG. 7 is a right elevational view of FIG. 1; and, FIG. 8 is a cross-sectional view taken along line 8—8 of FIG. 3.

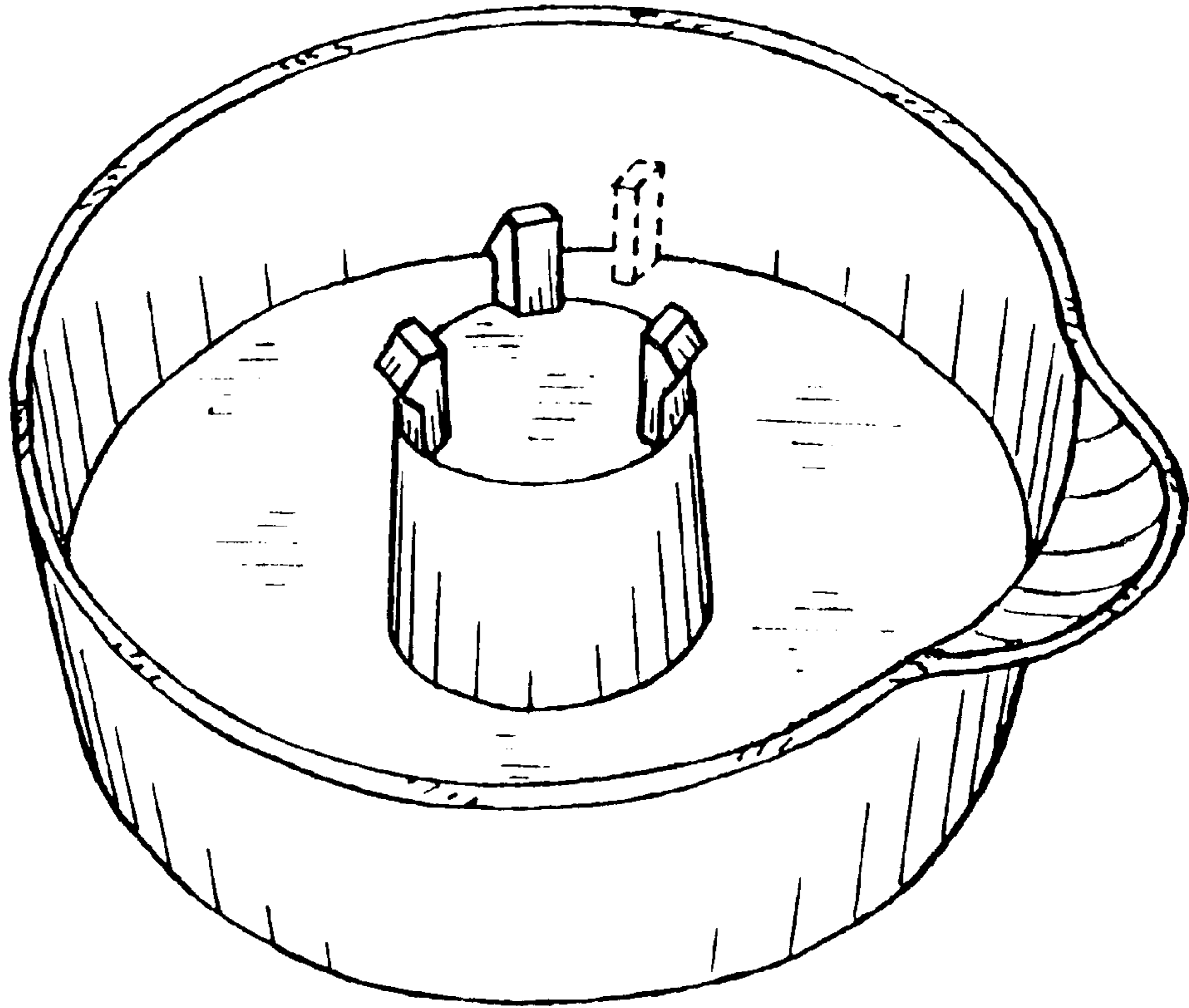

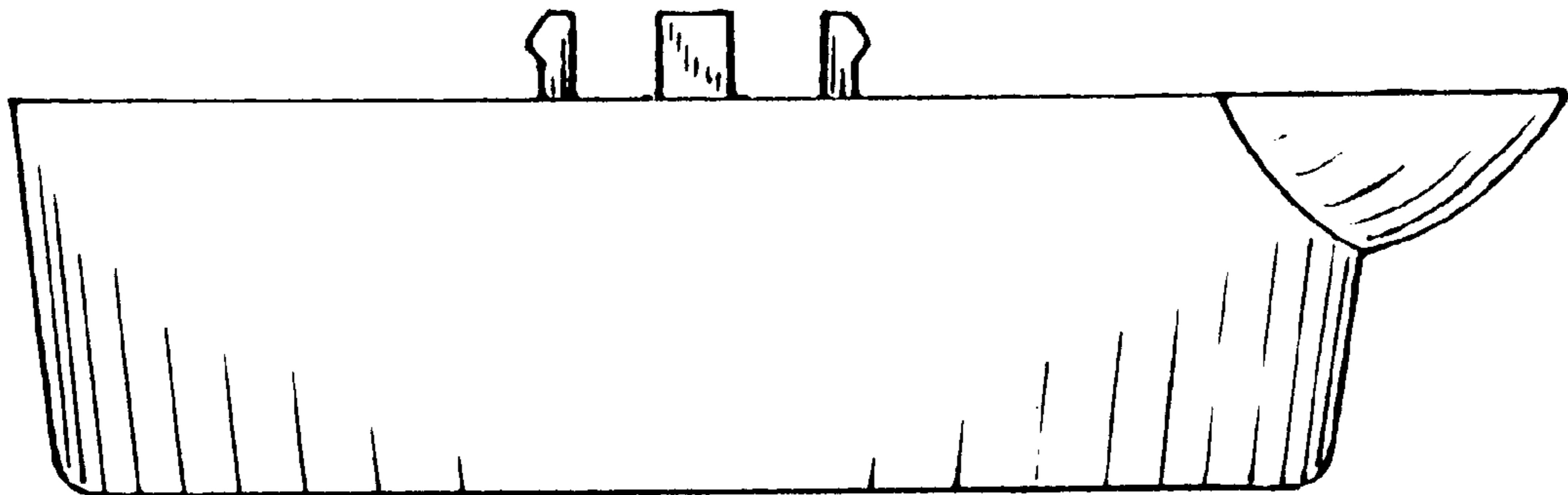

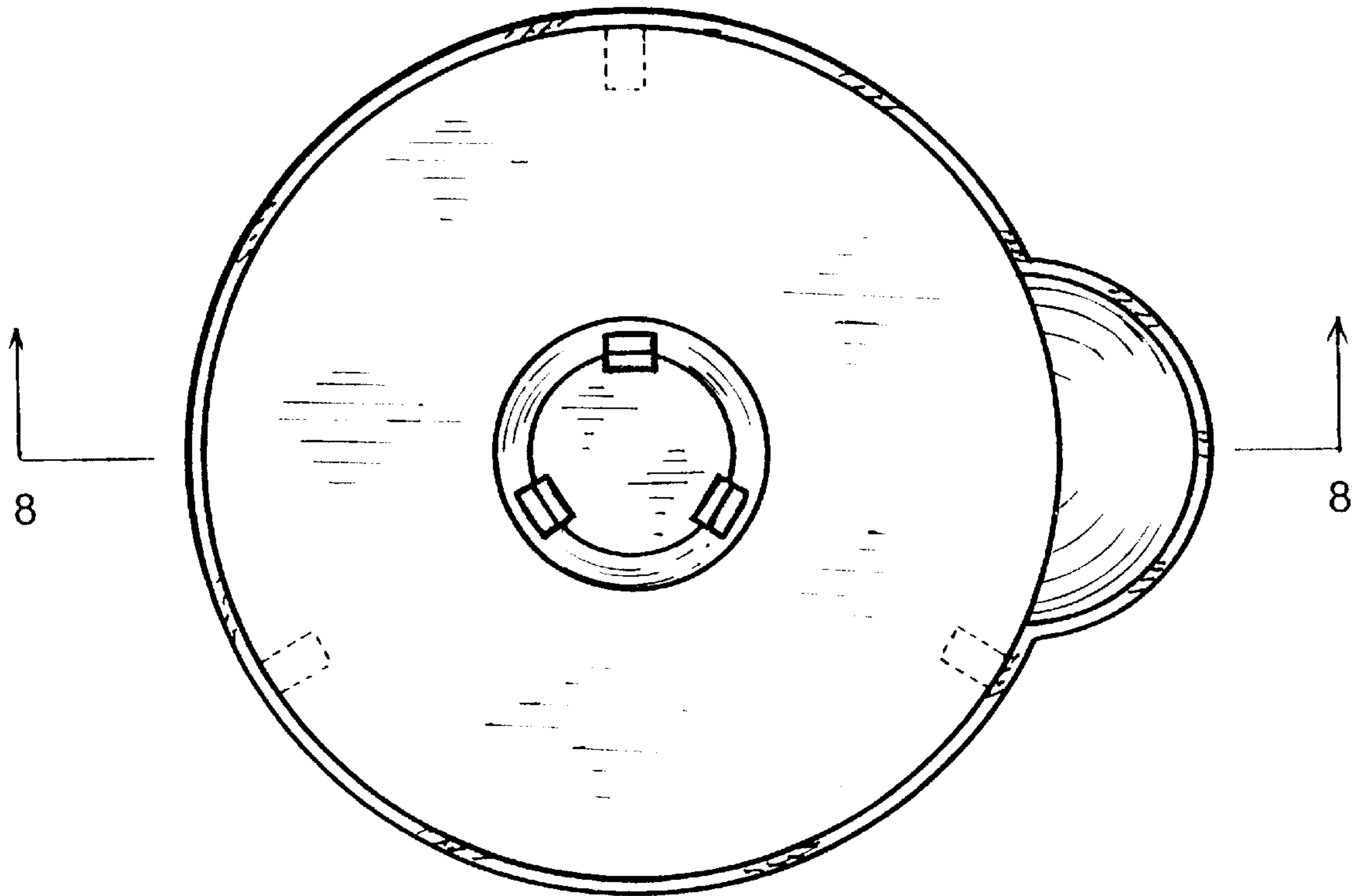

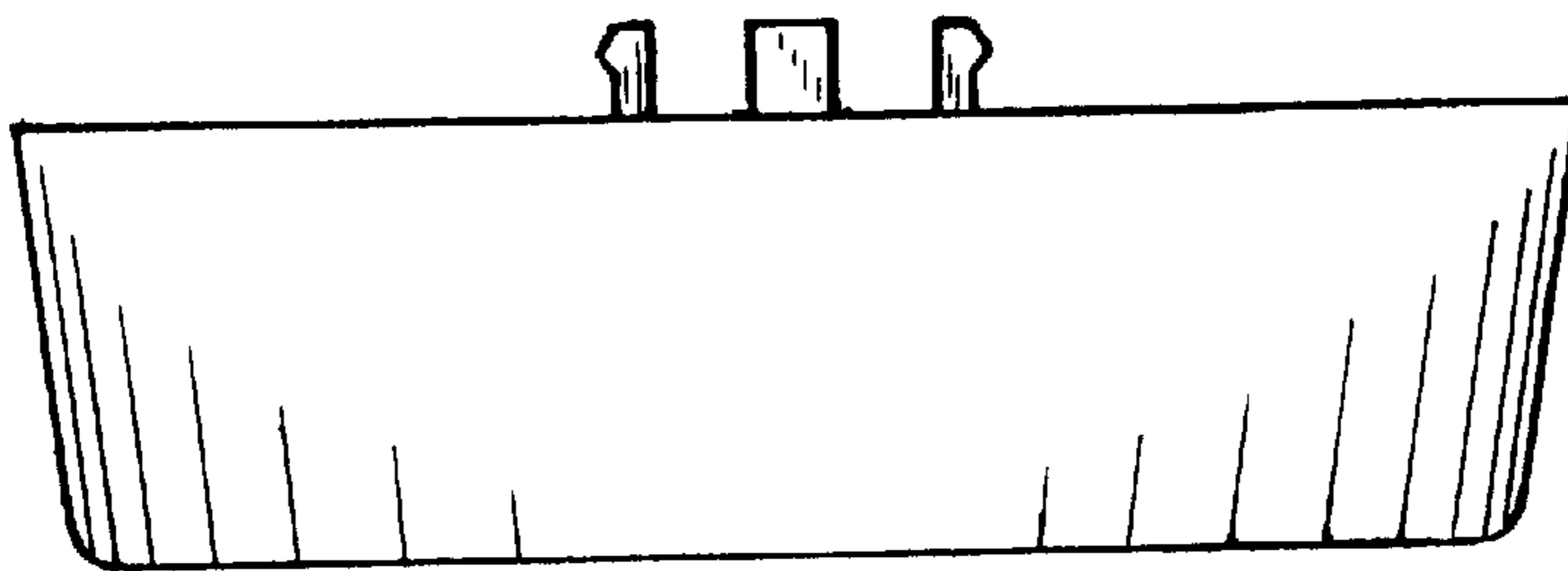

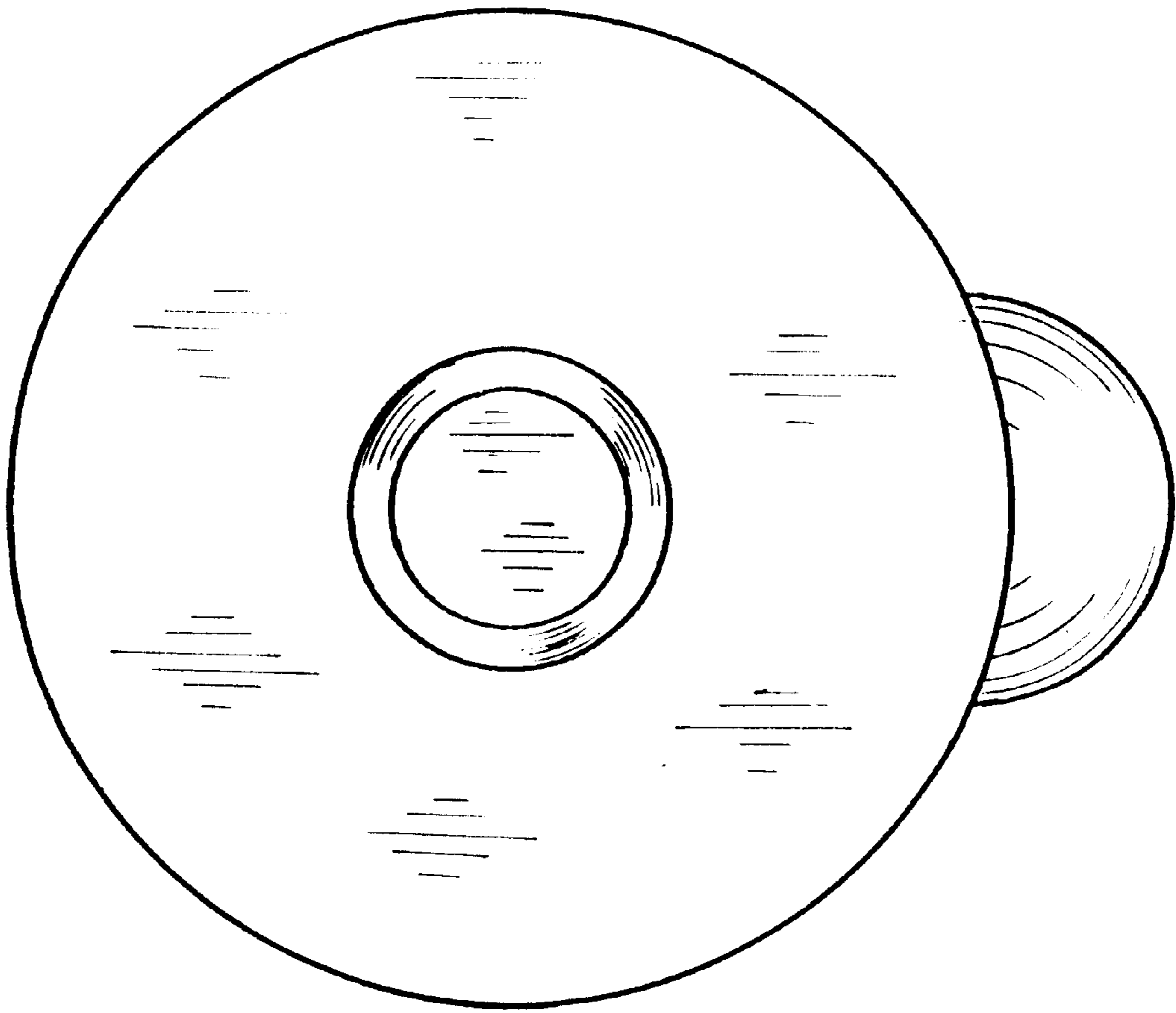

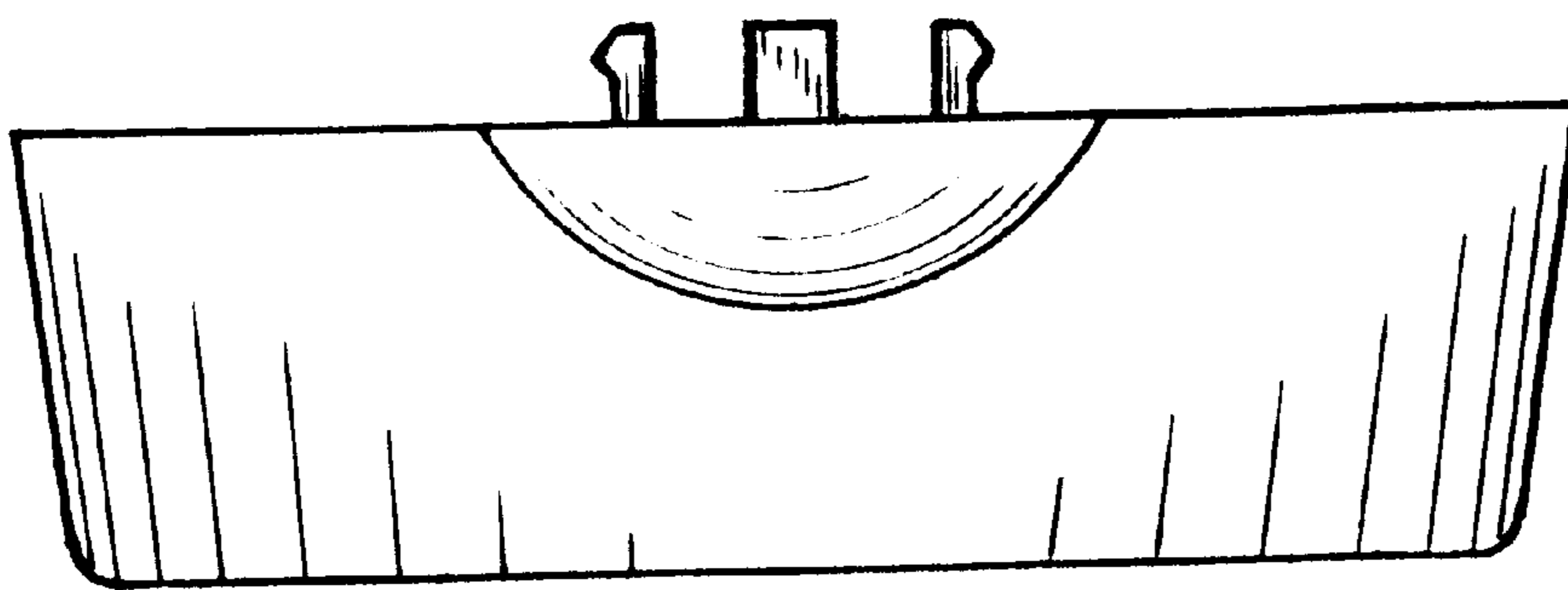

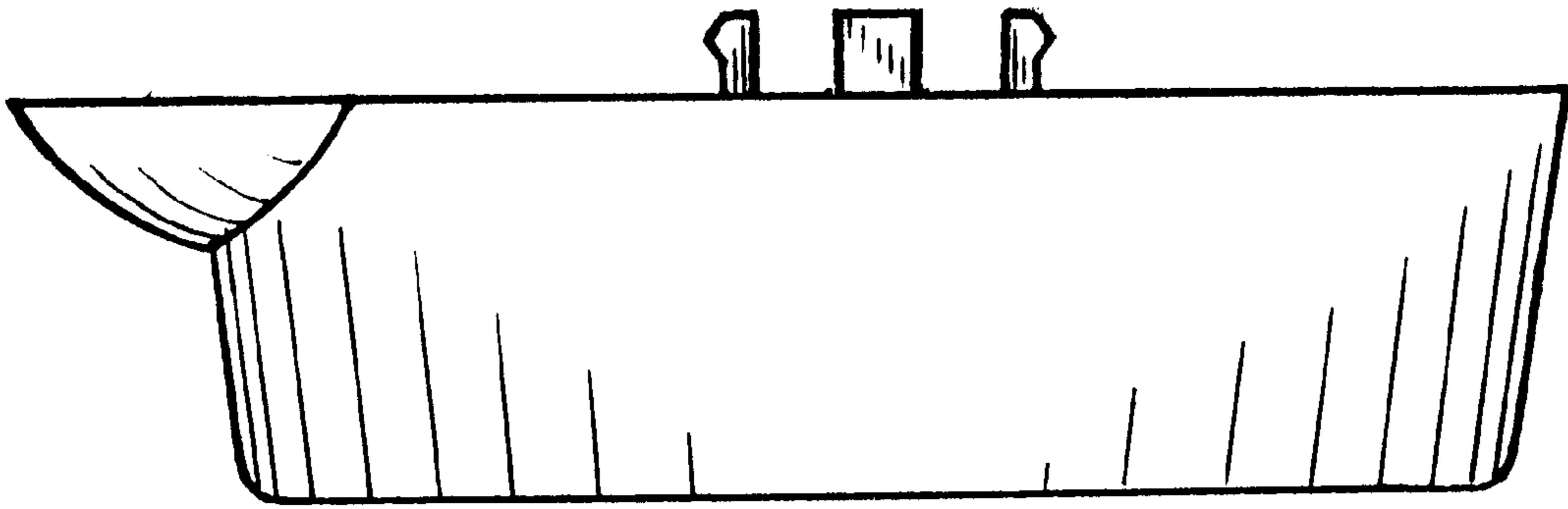

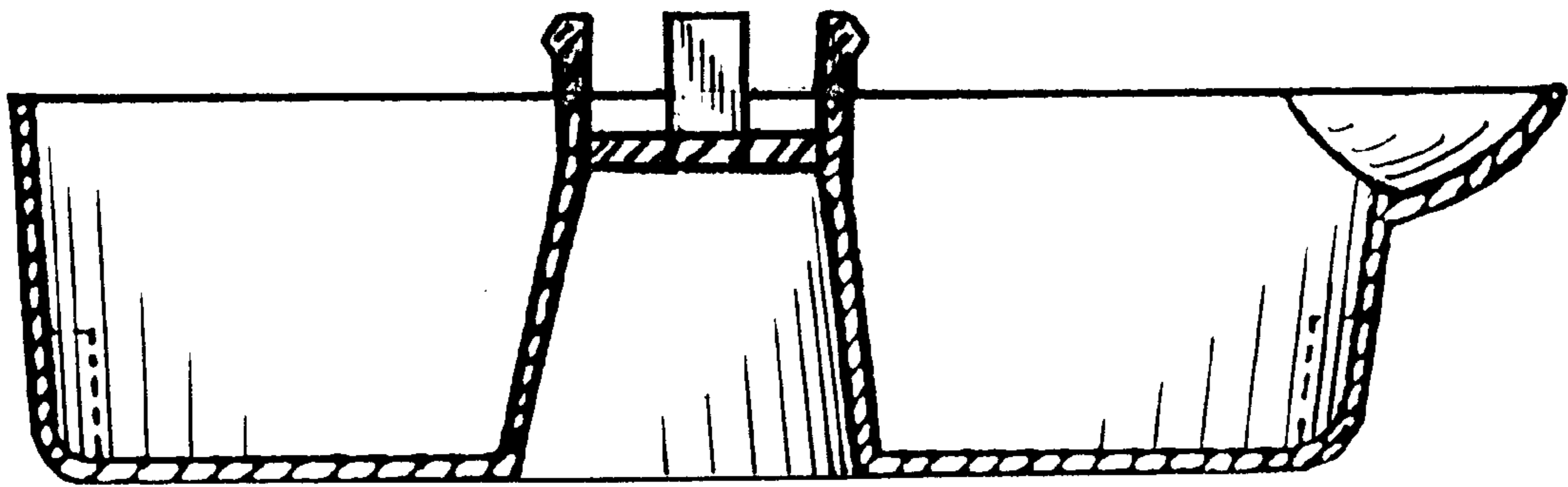
