DESCRIPTION

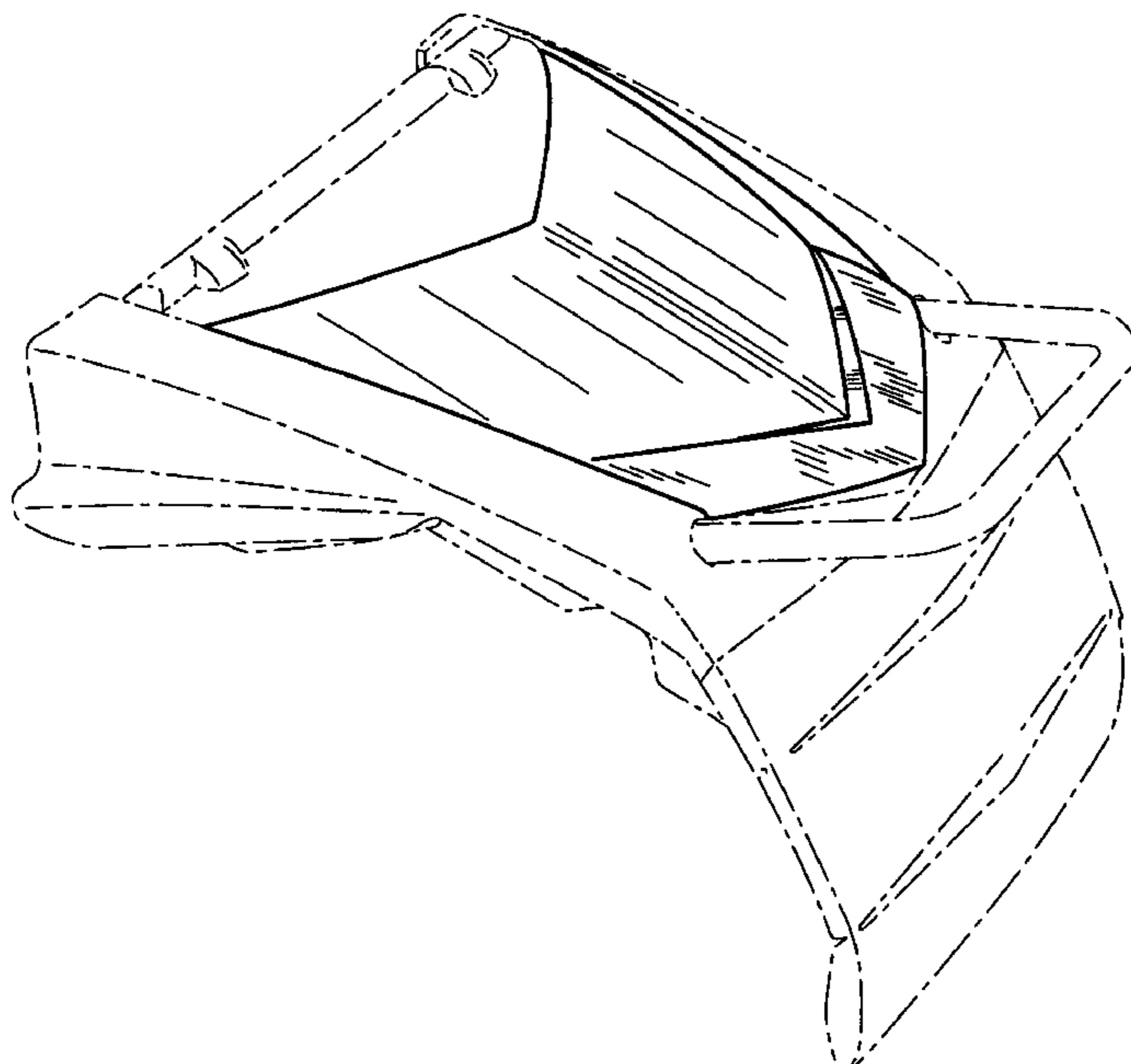
FIG. 1 is a perspective illustration, from the rear and left side, of a snow flap for a snowmobile according to our design;

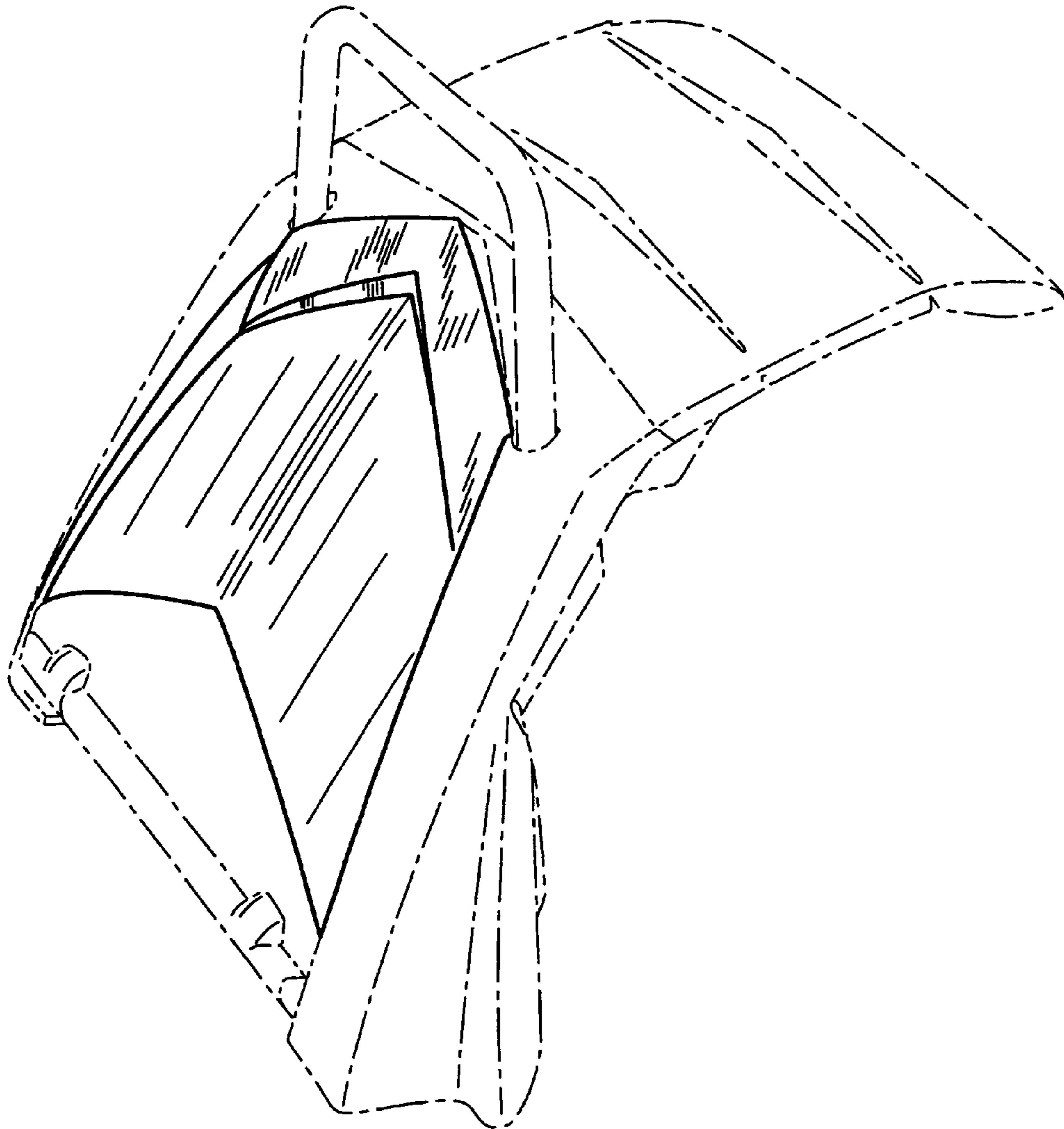

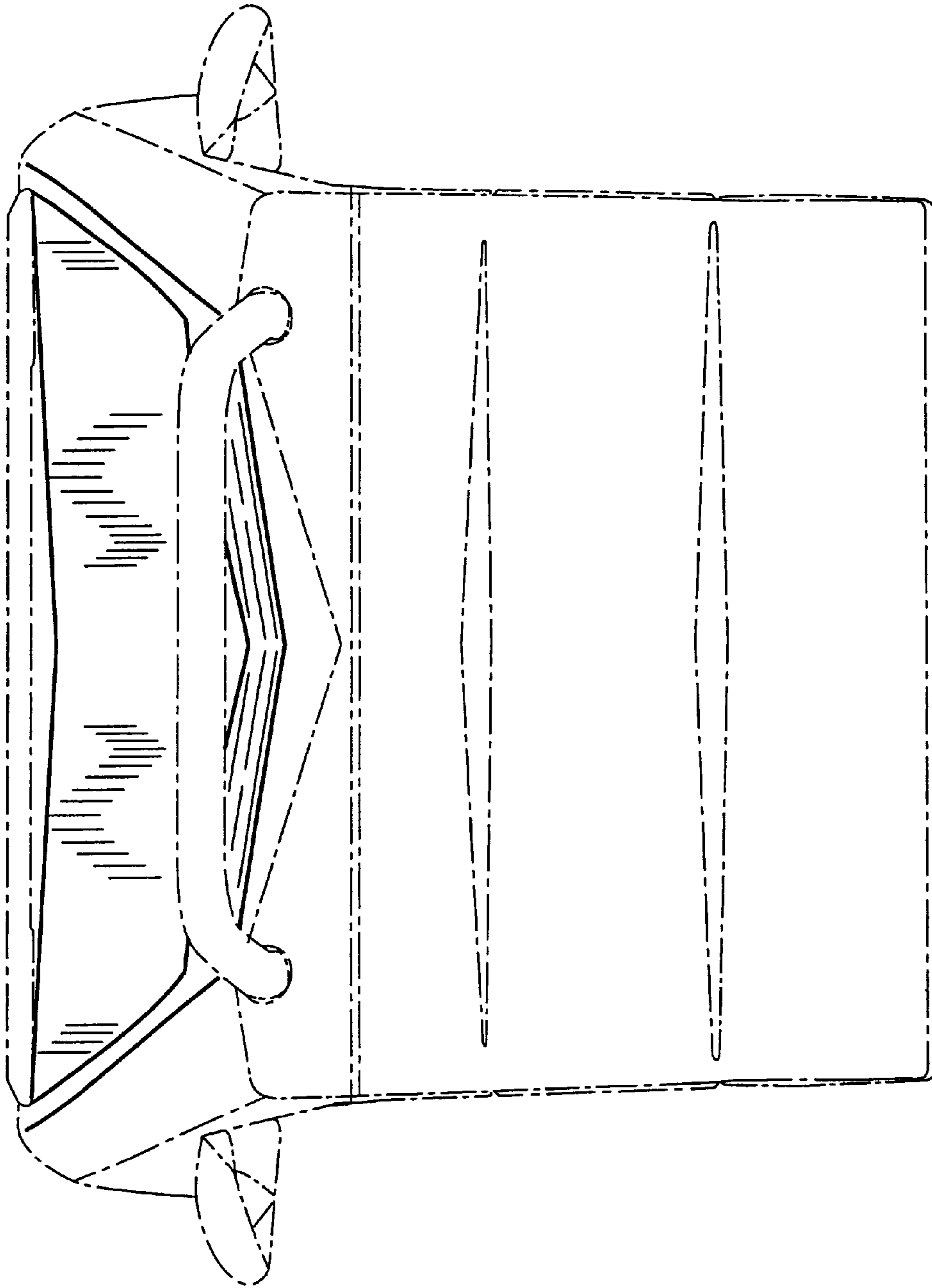

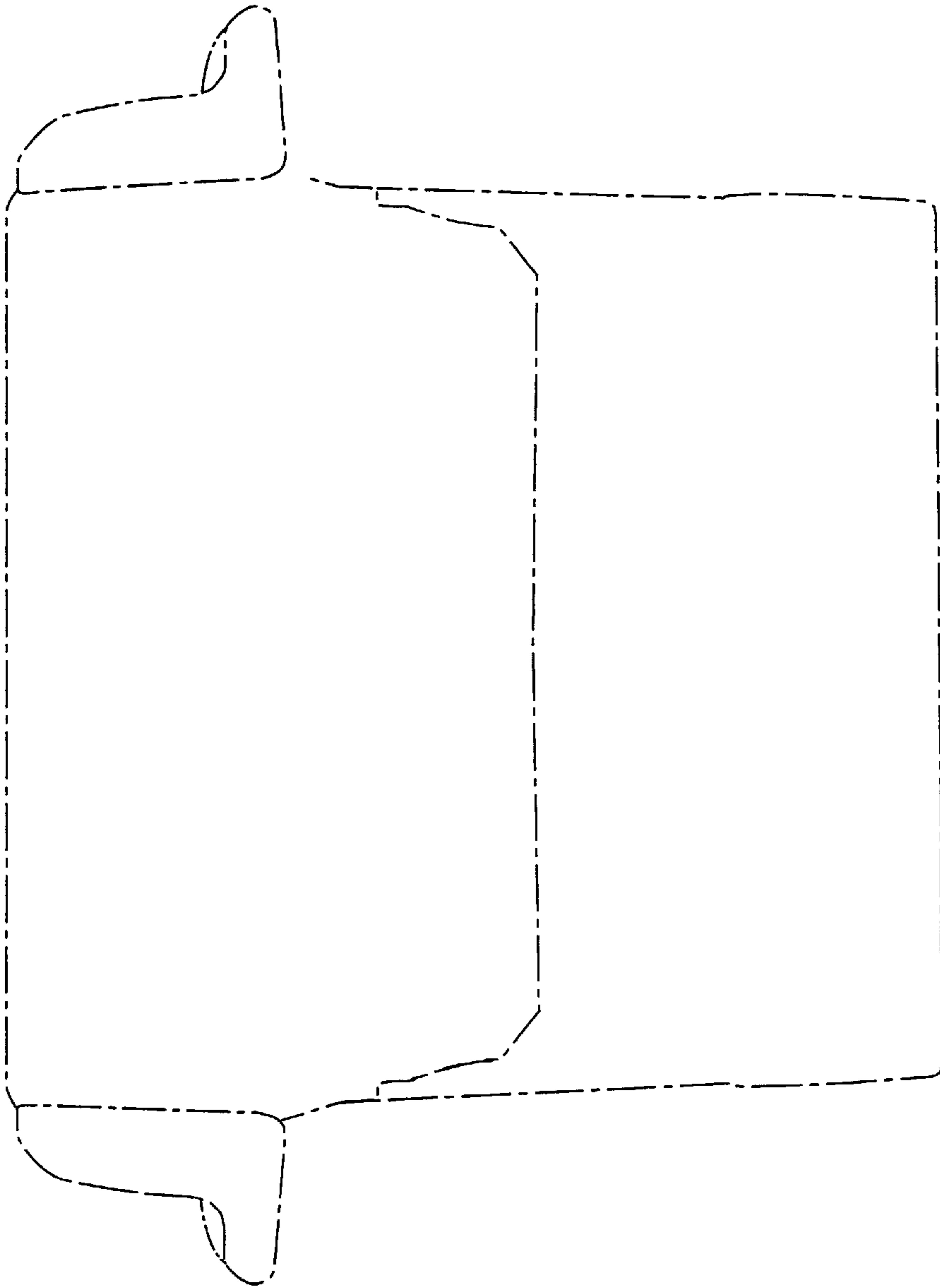

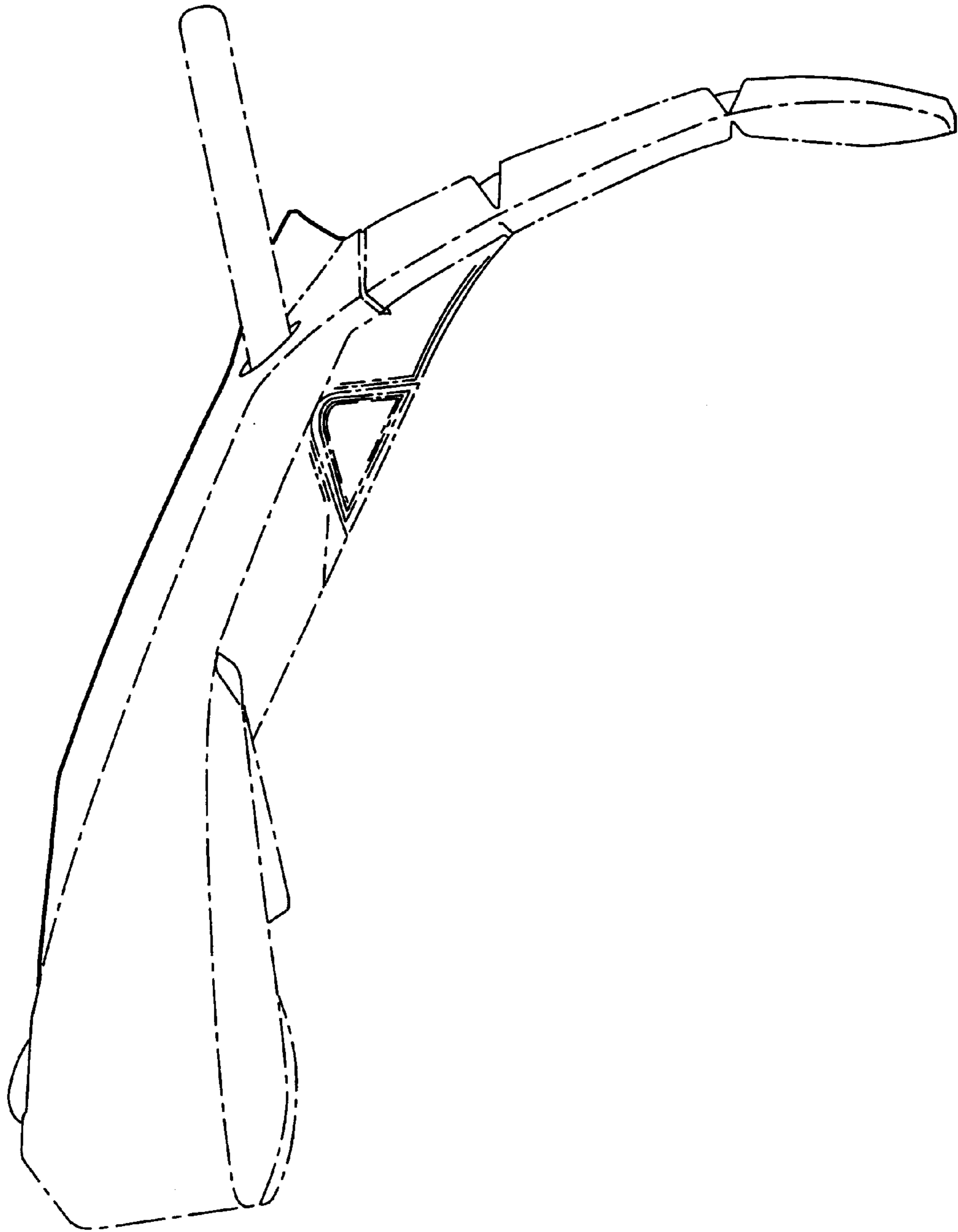

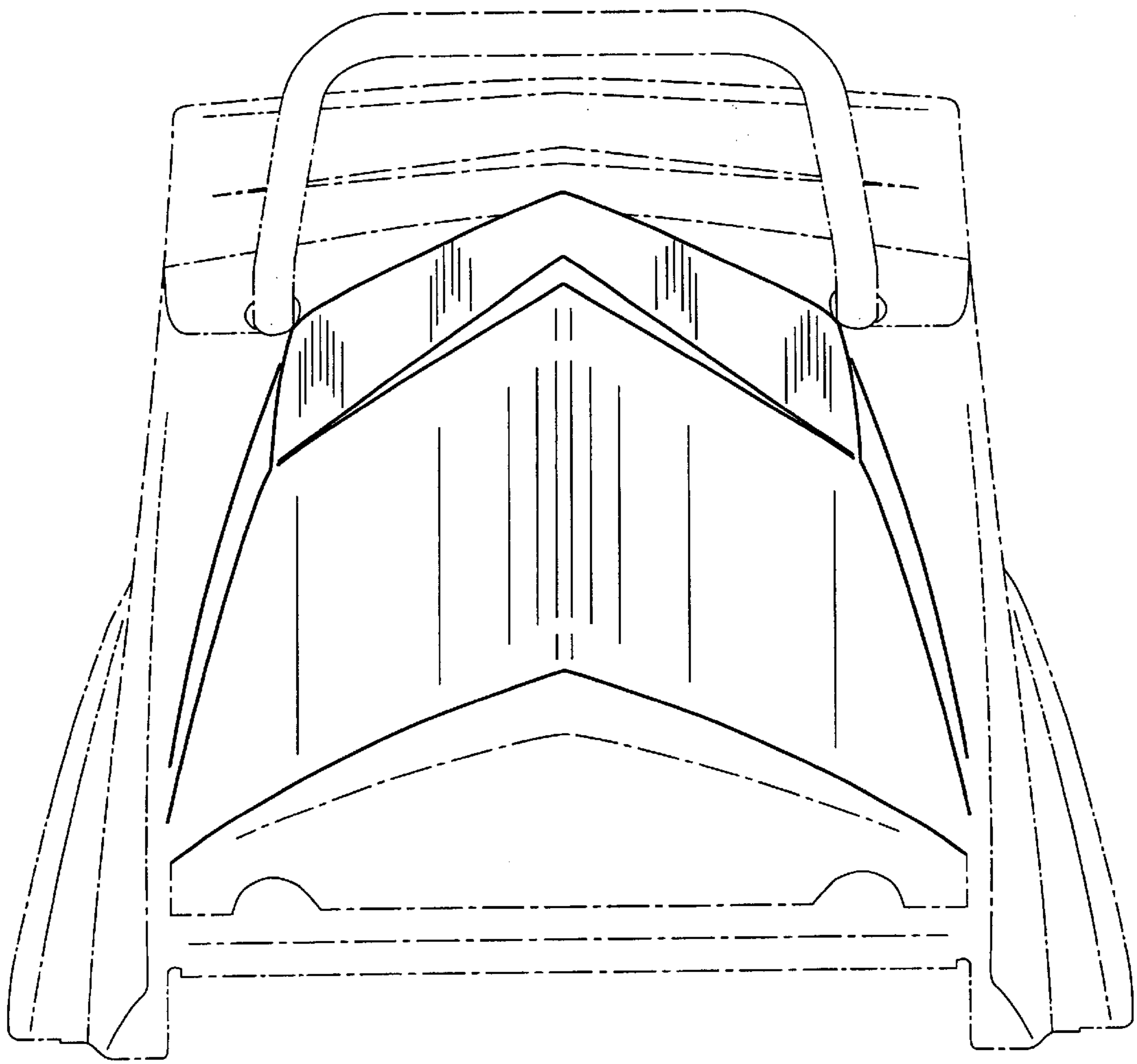

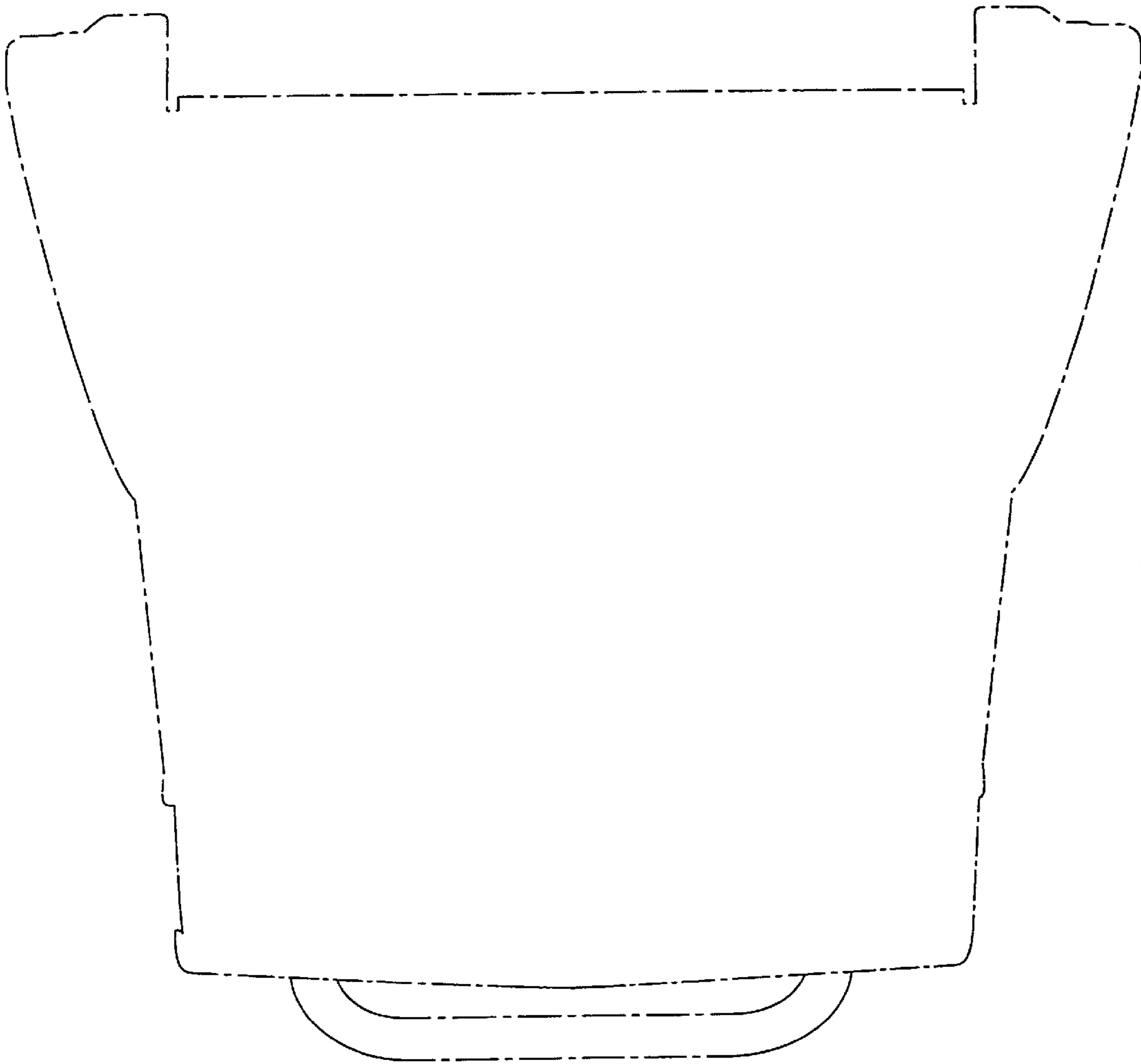
