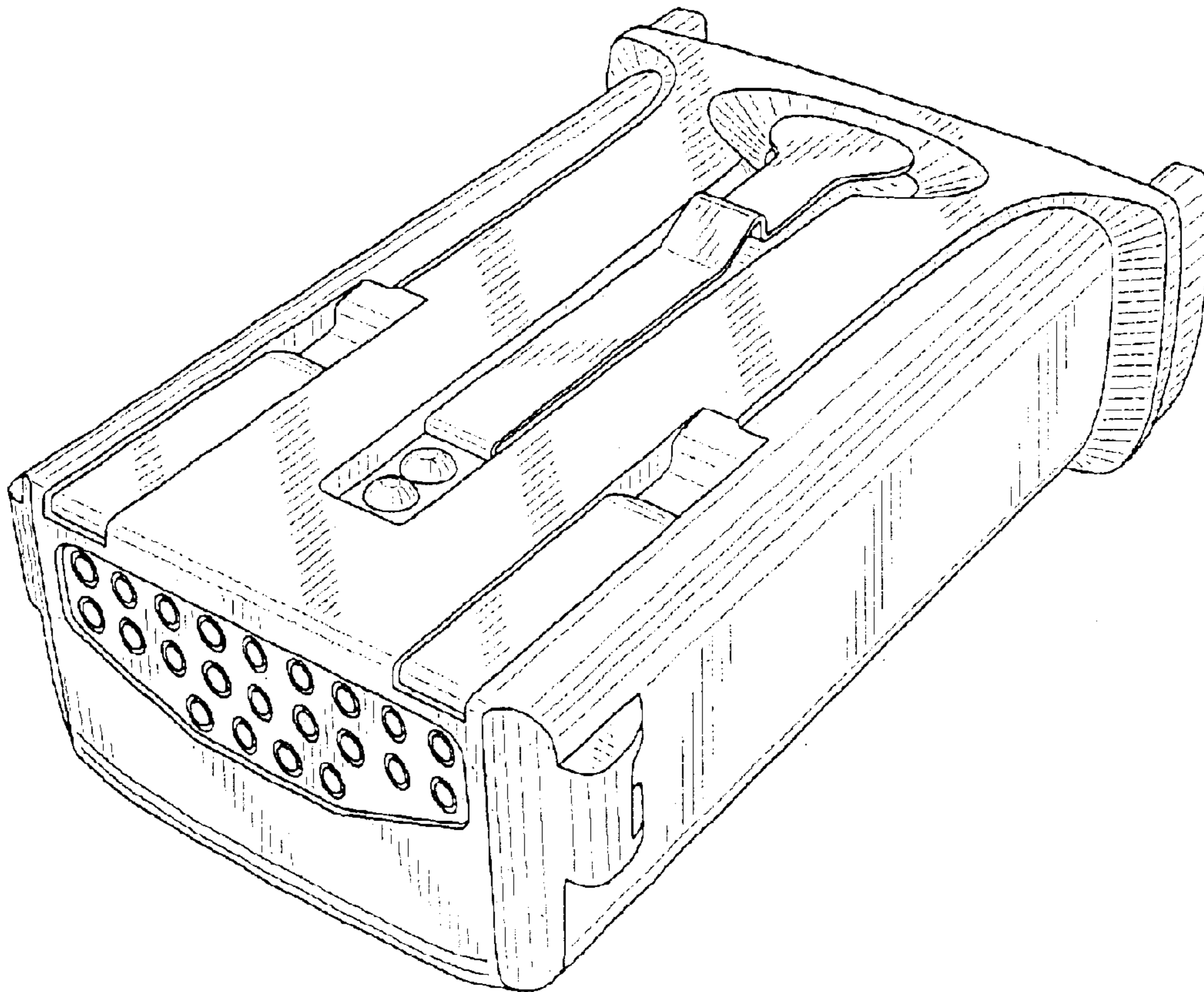
(57) **CLAIM**

DESCRIPTION

FIG. 1 is perspective view of the top, front, and right side of a battery showing my new design;

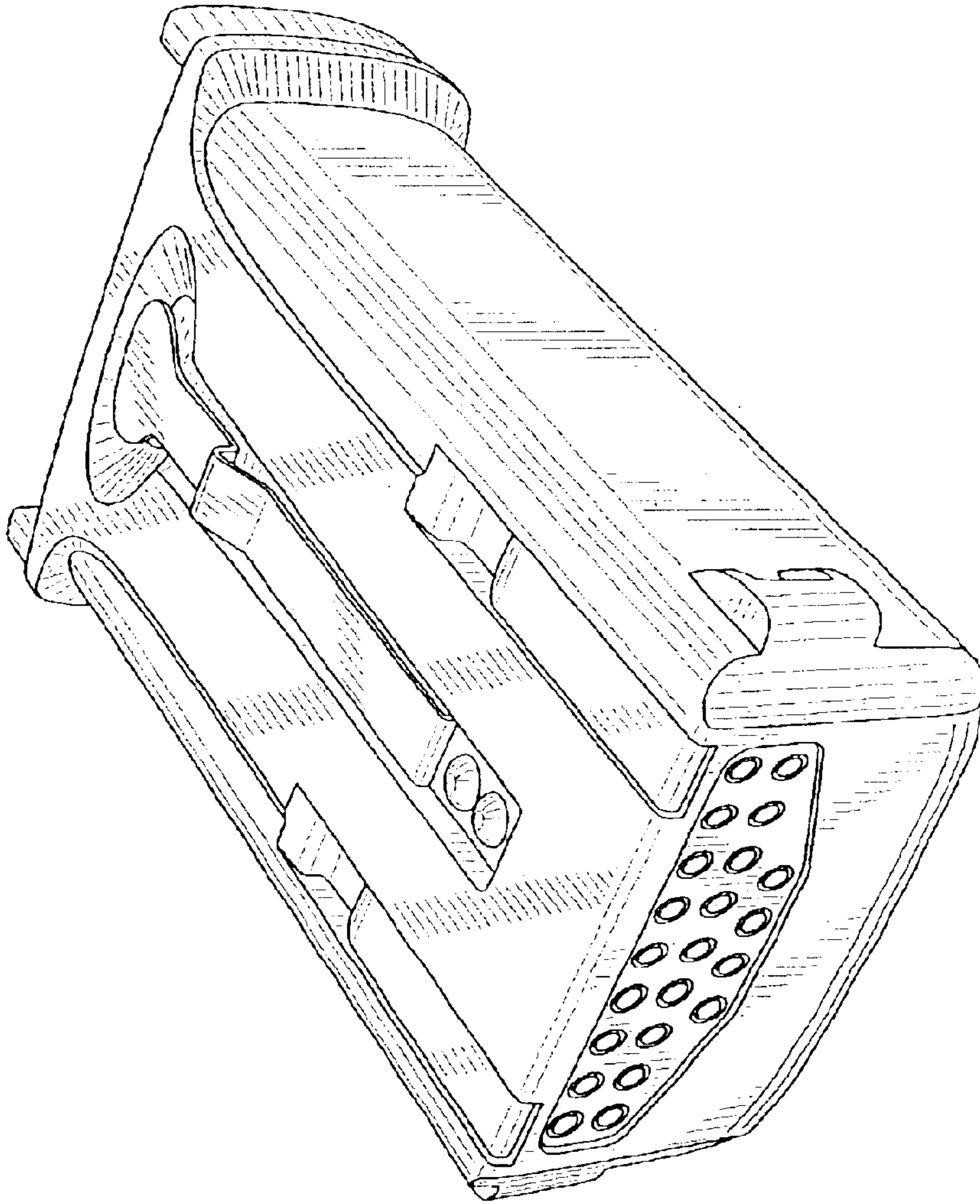

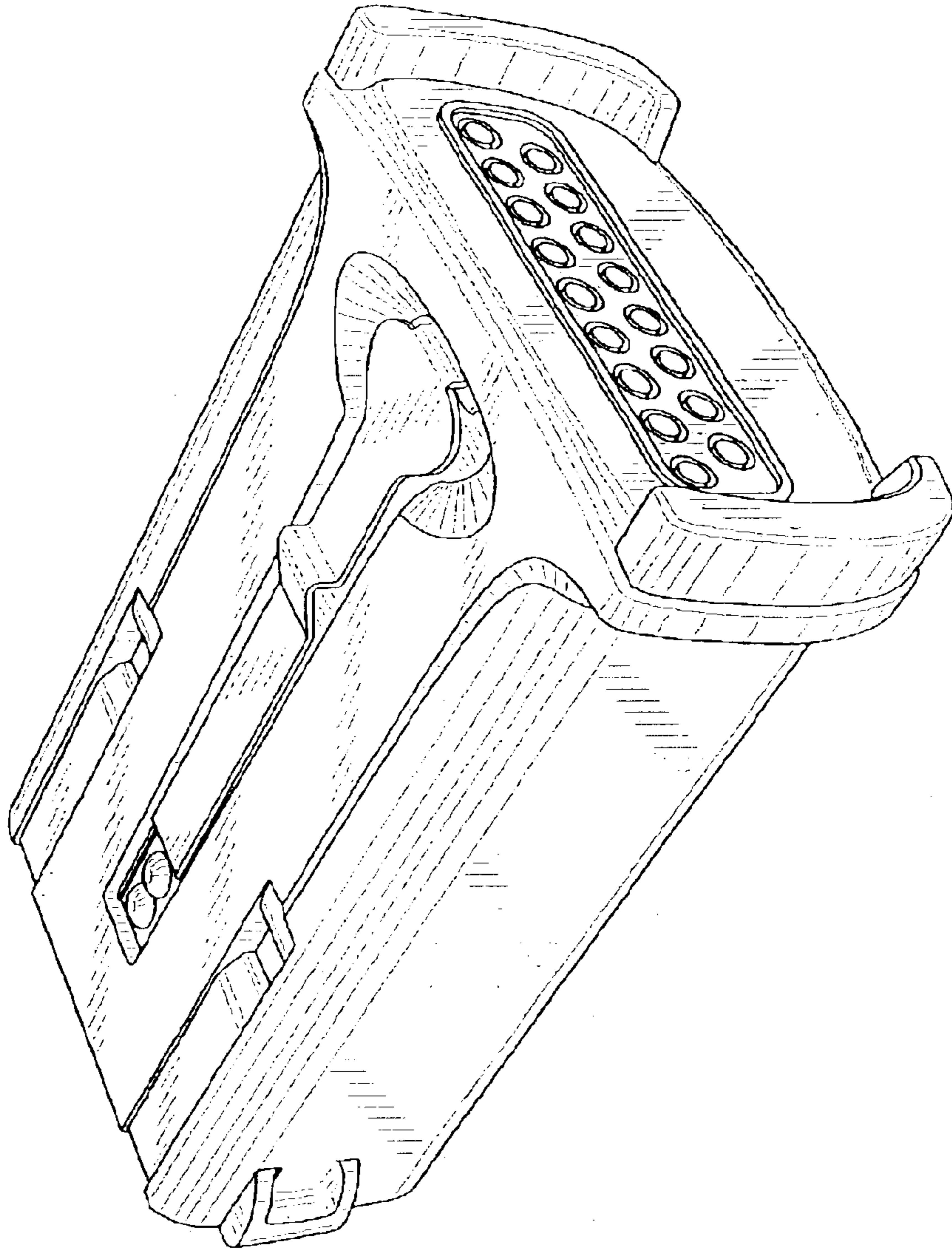

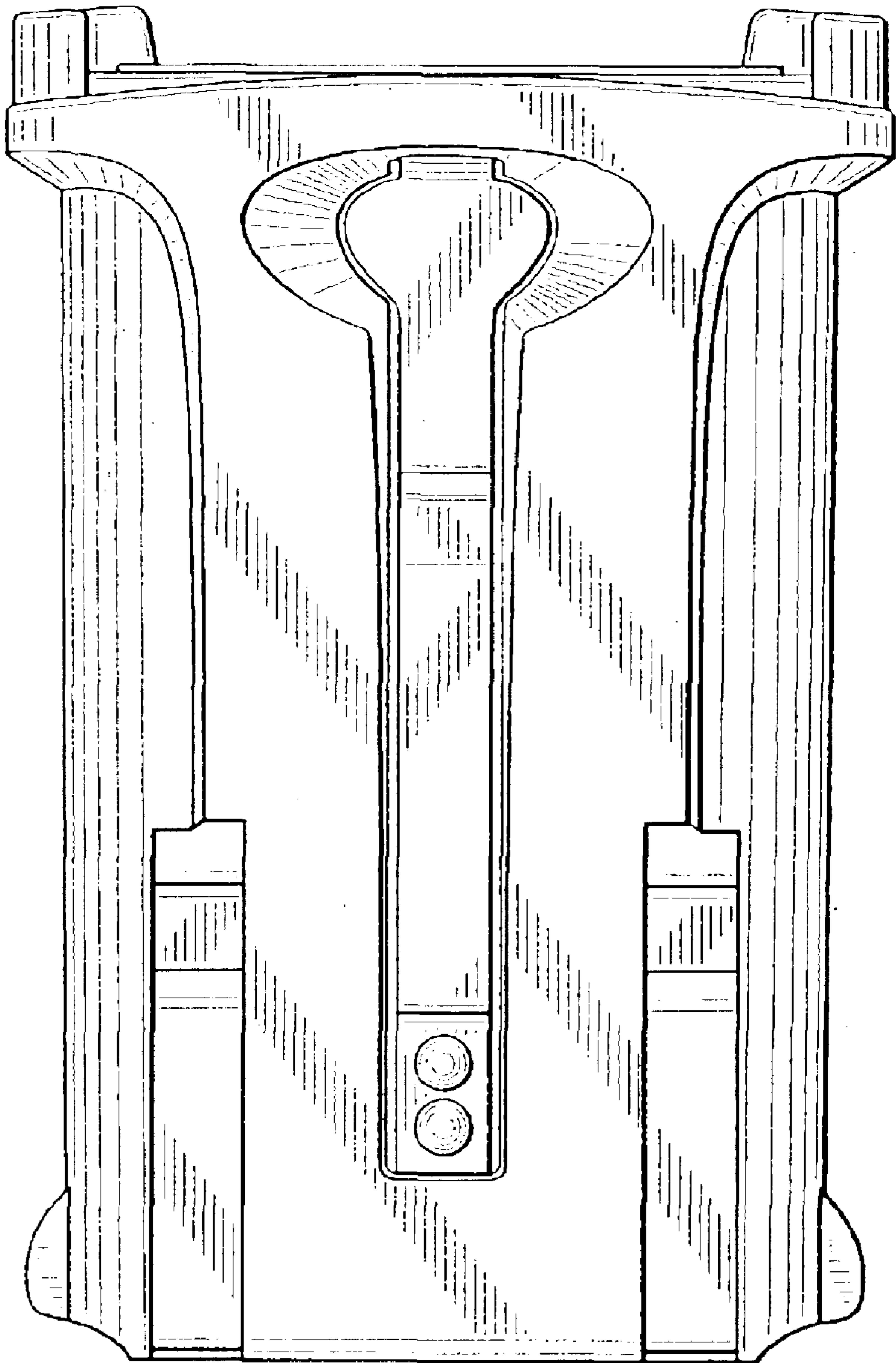

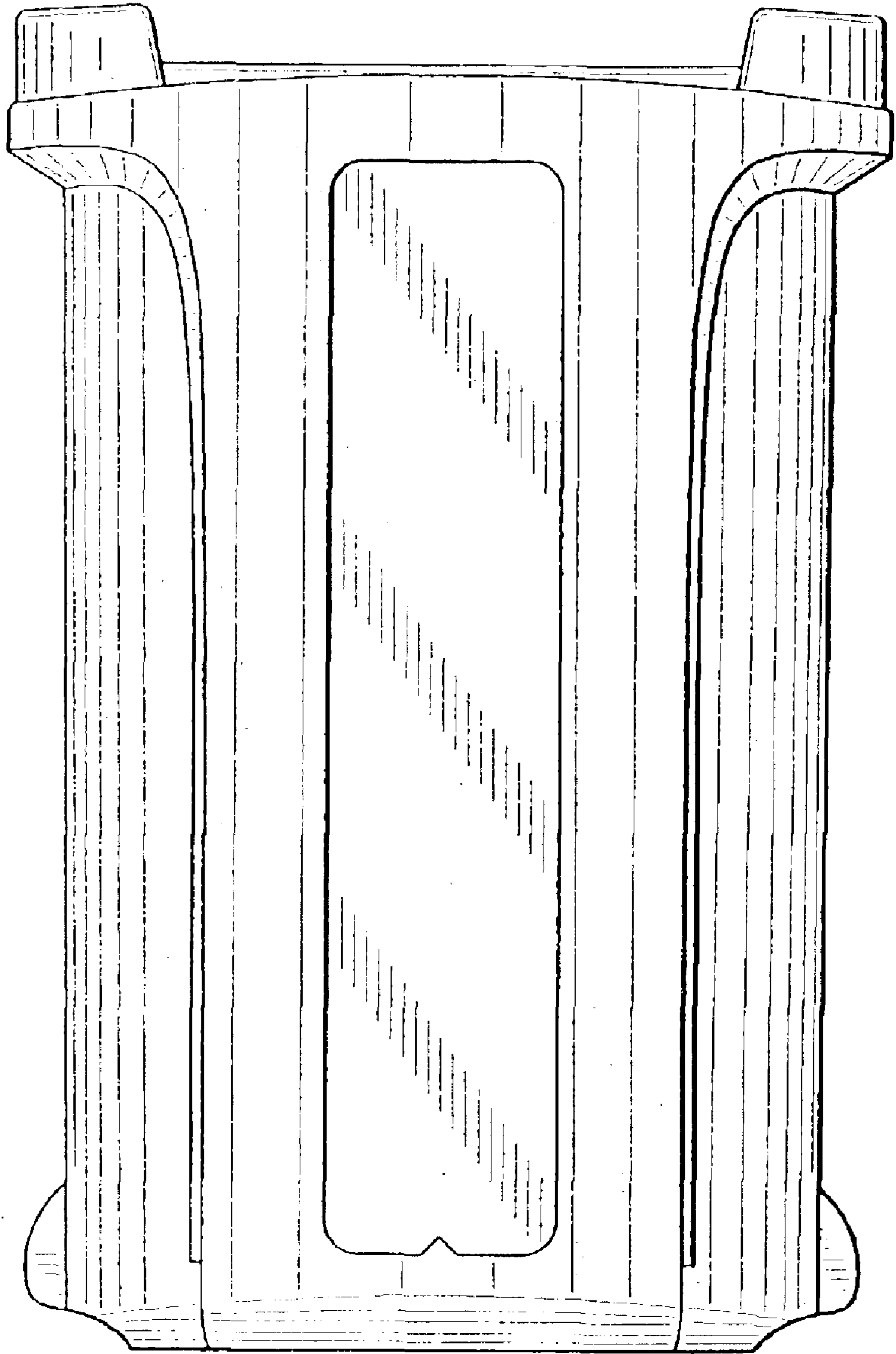

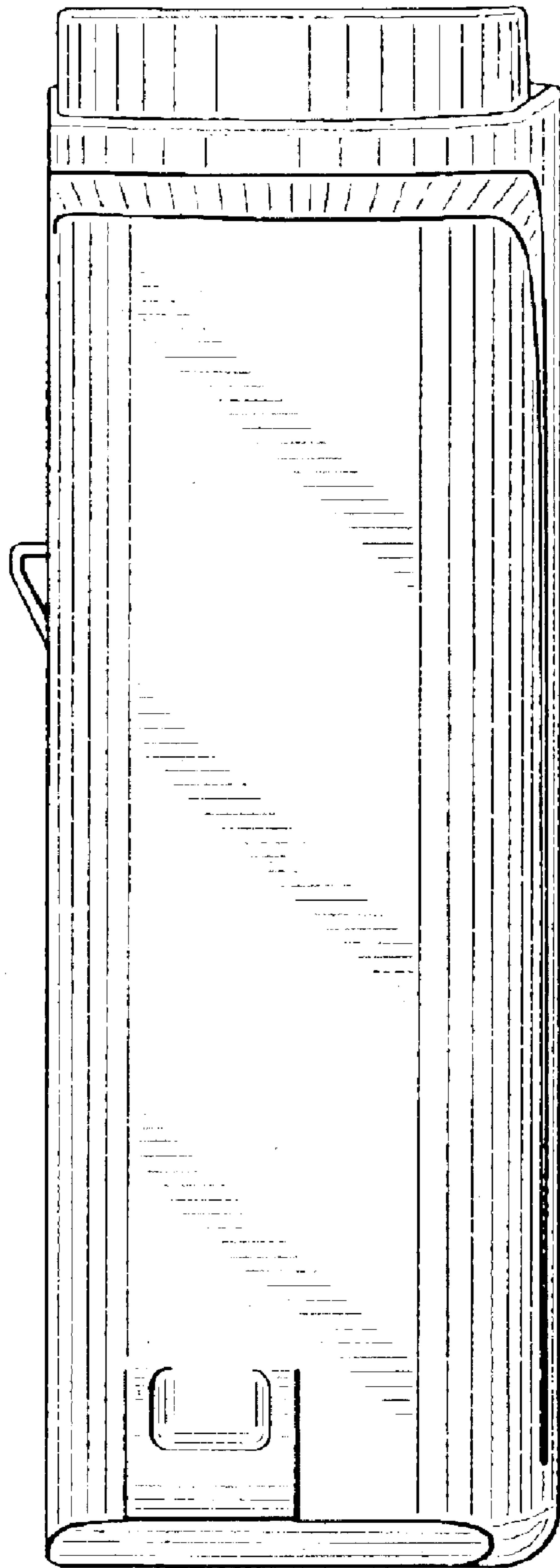

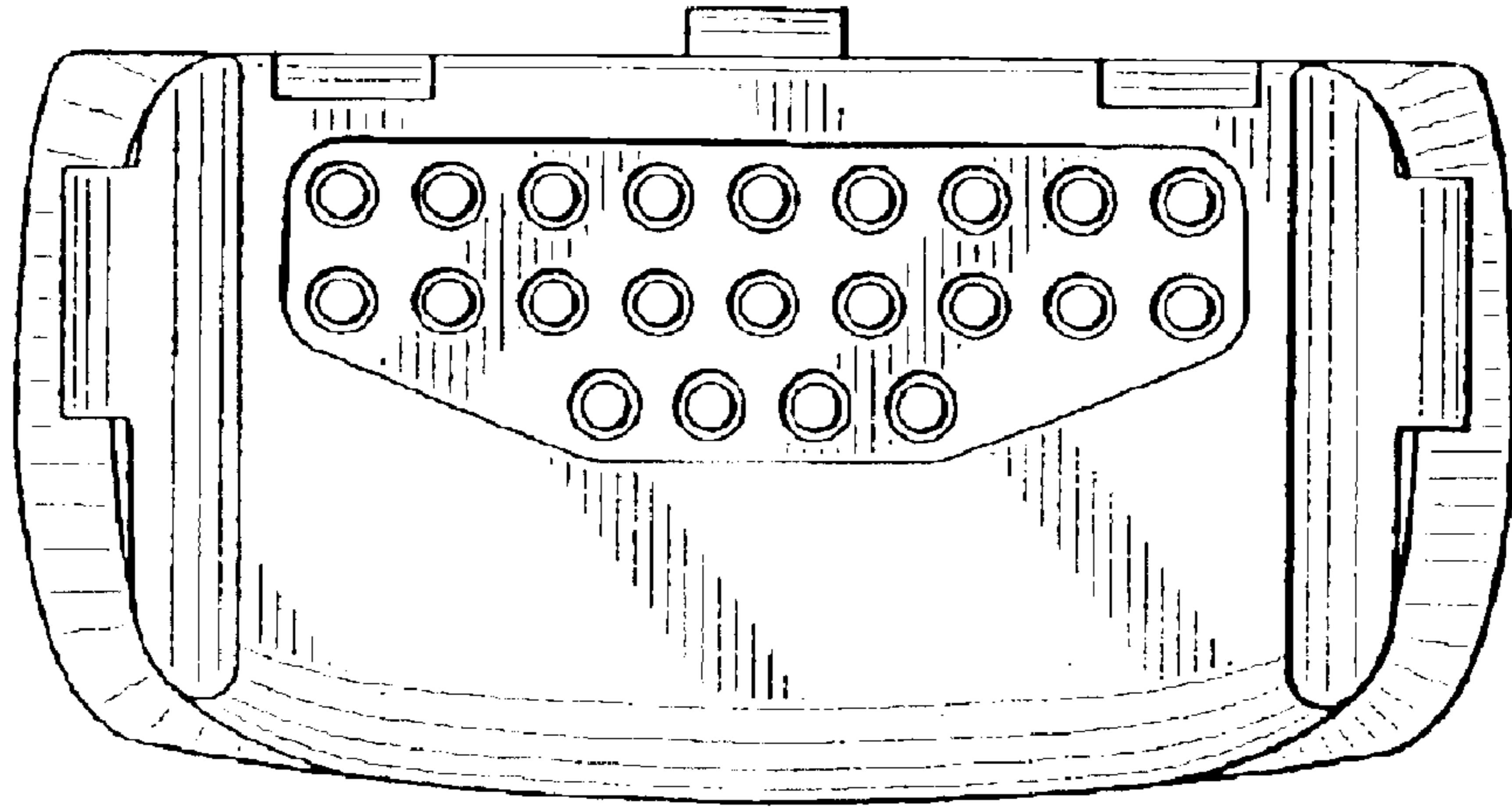

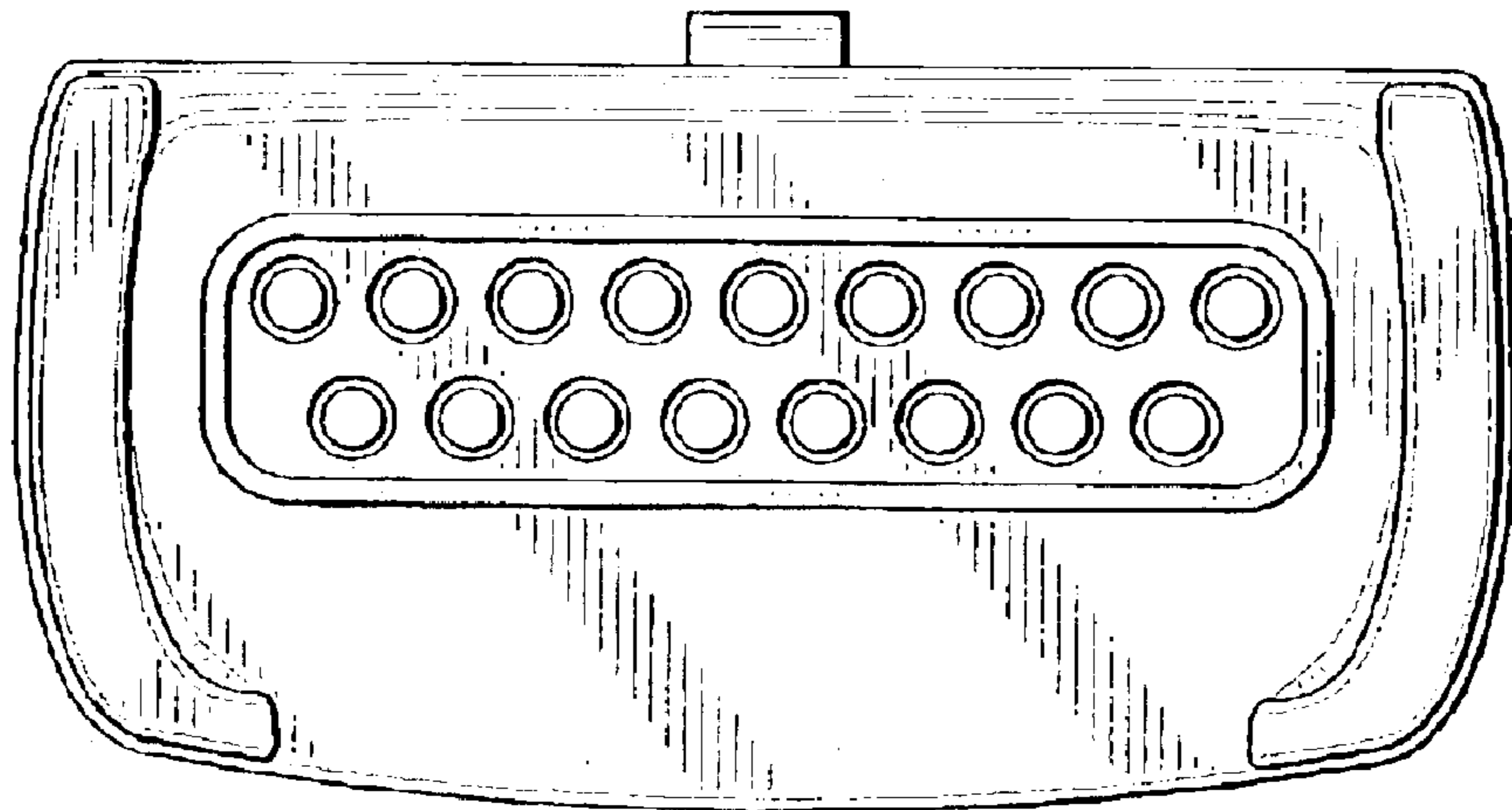
