DESCRIPTION

FIG. 1 is a front, perspective view of a cutting insert showing our new design;

FIG. 5 is a left side view of the cutting insert of FIG. 1;

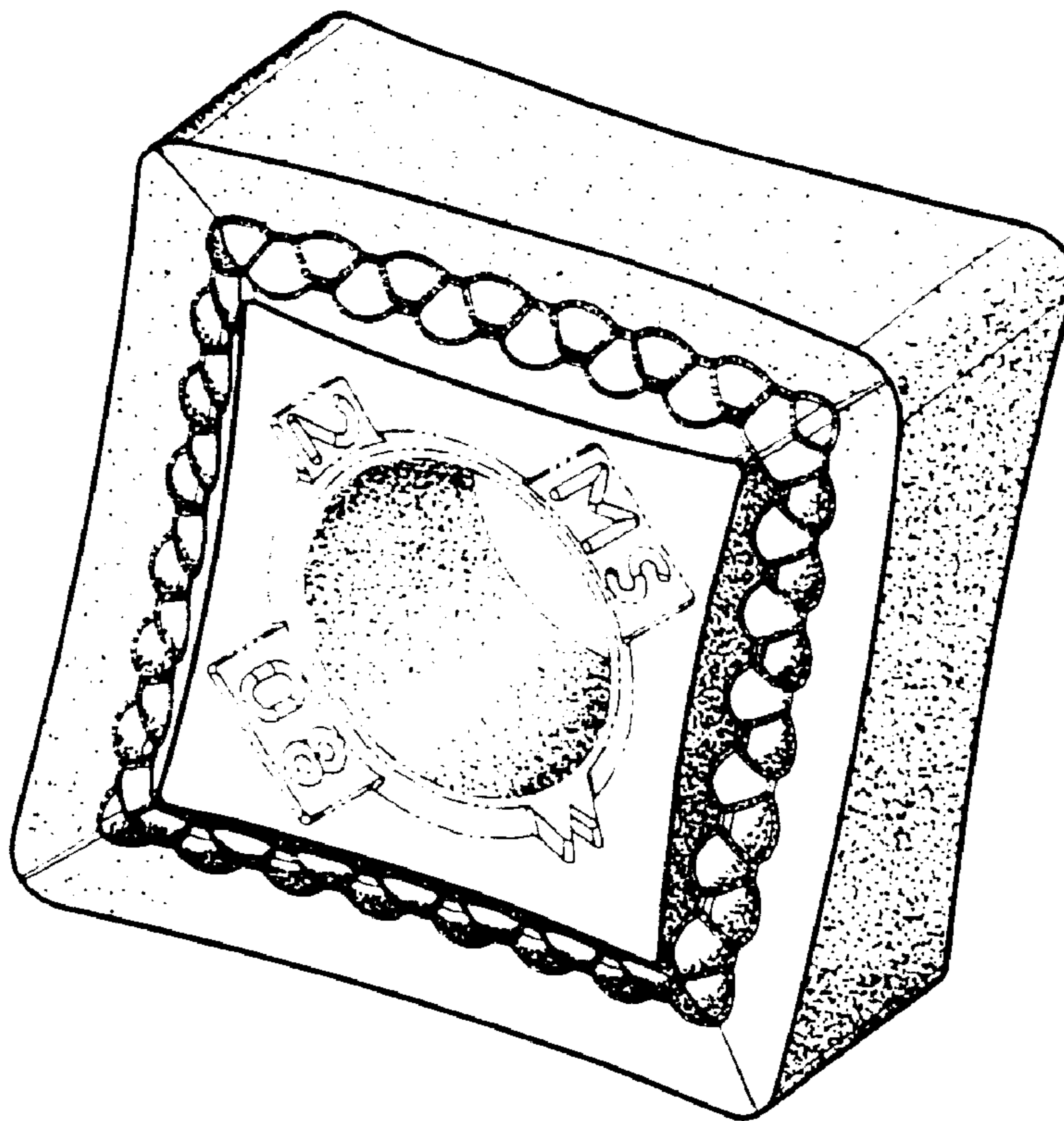
FIG. 6 is a right side view of the cutting insert of FIG. 1;

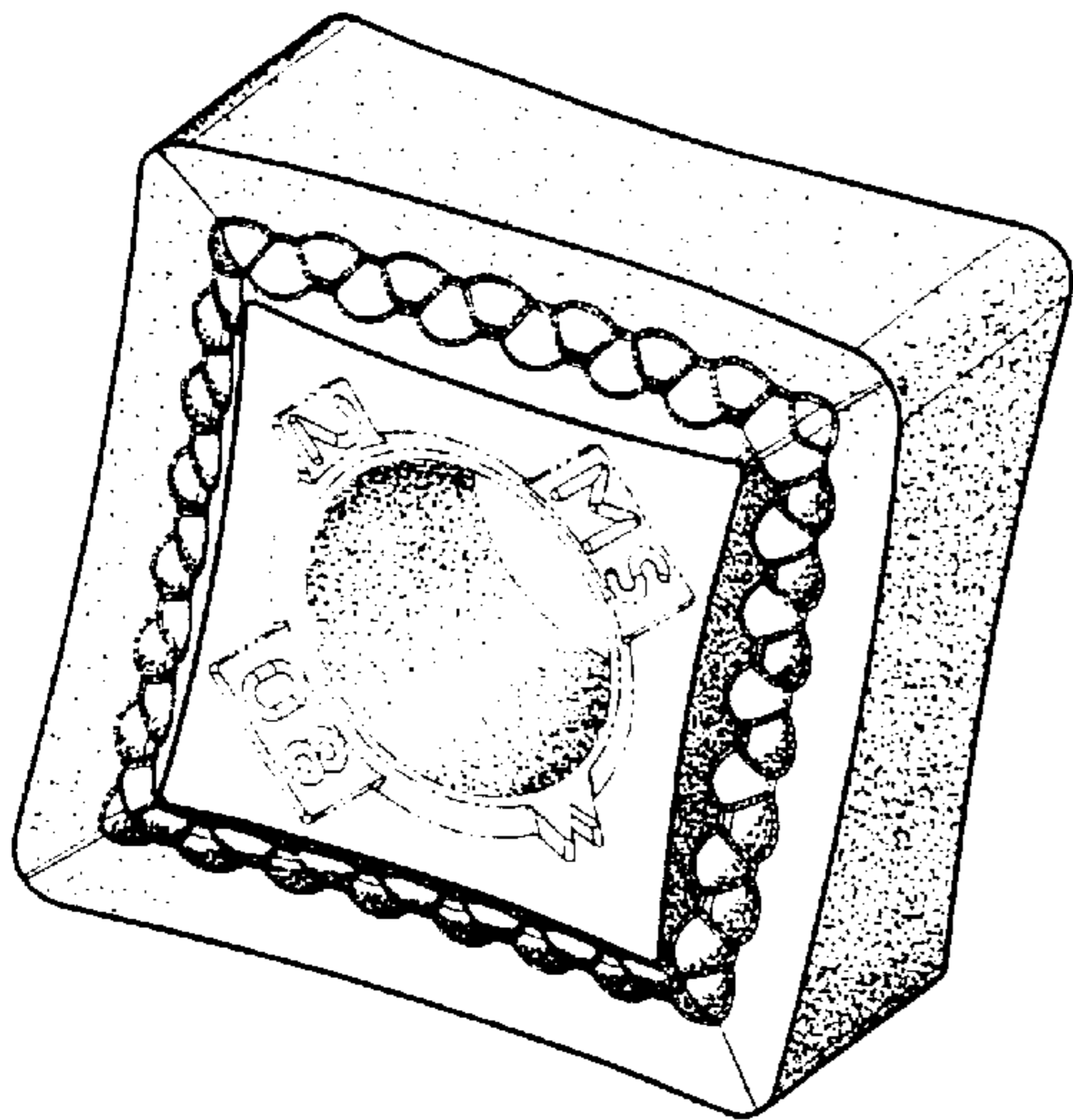

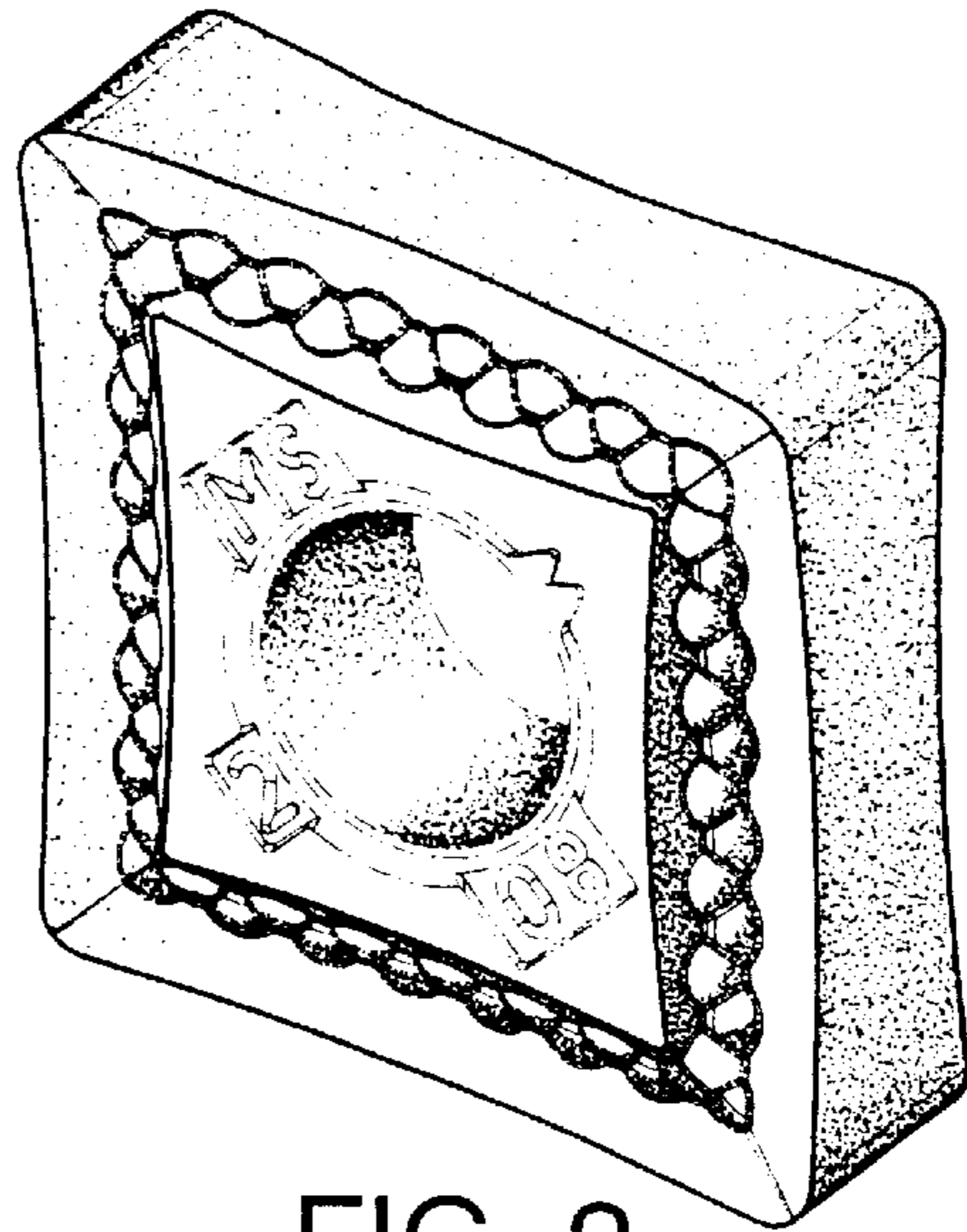

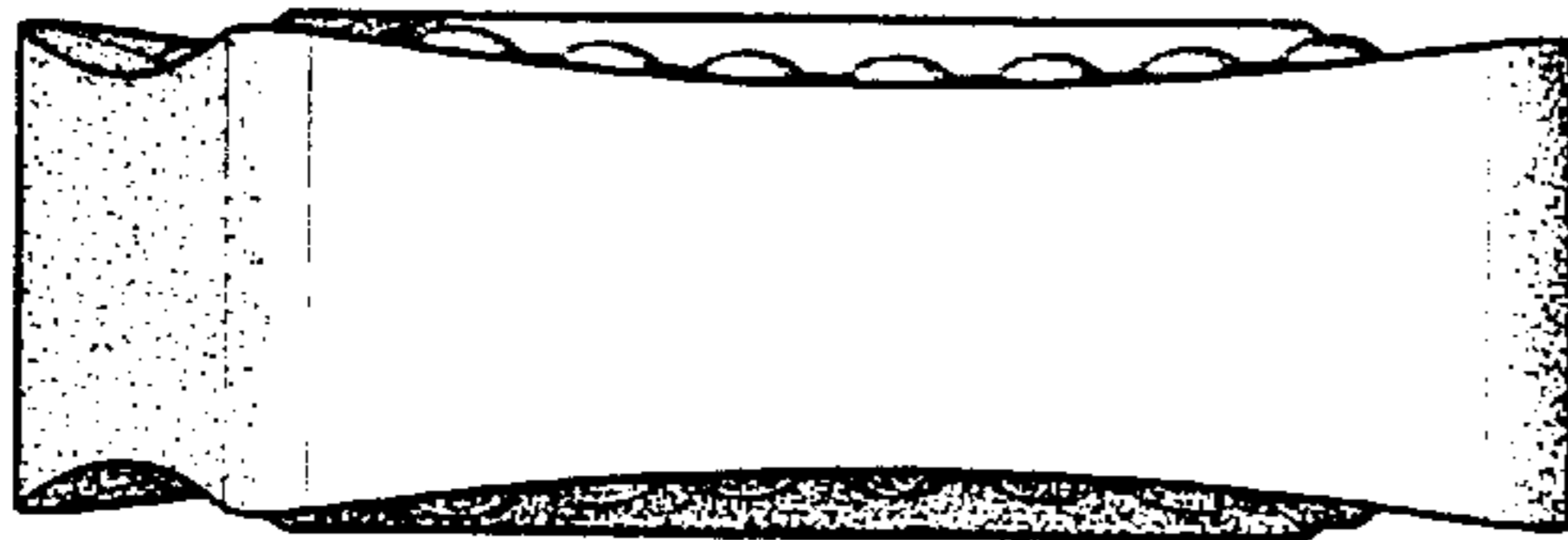

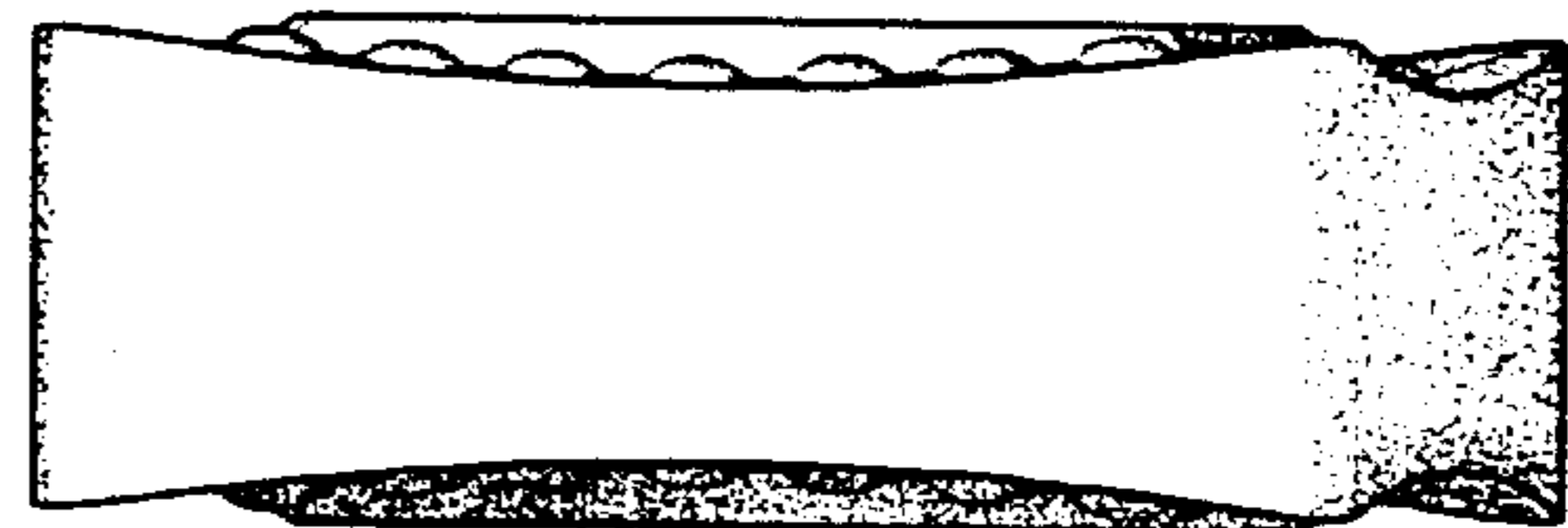

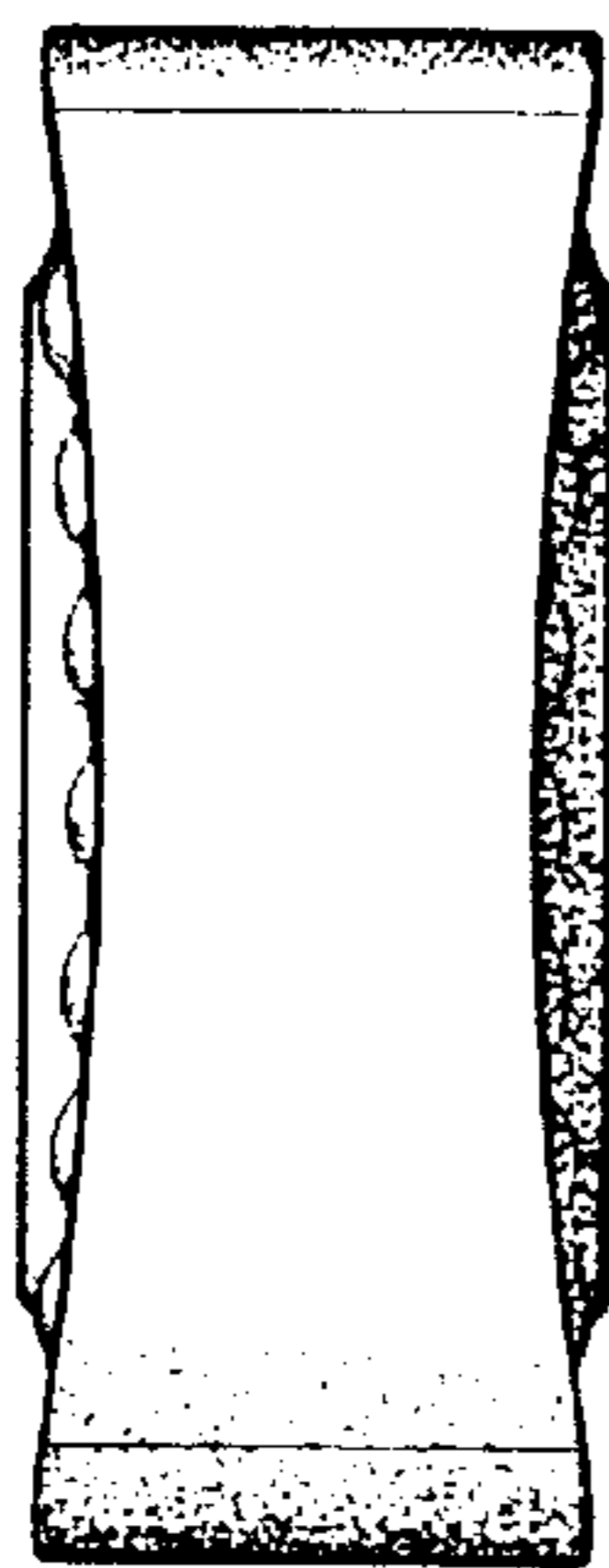

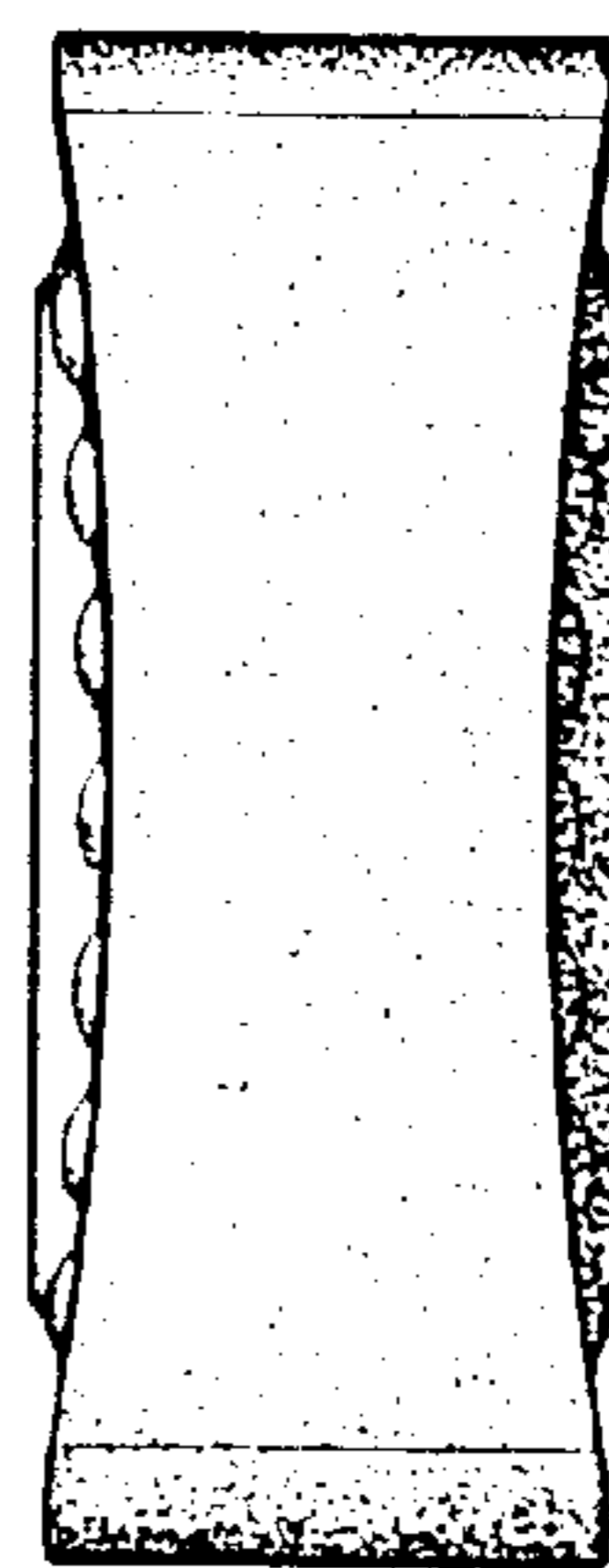

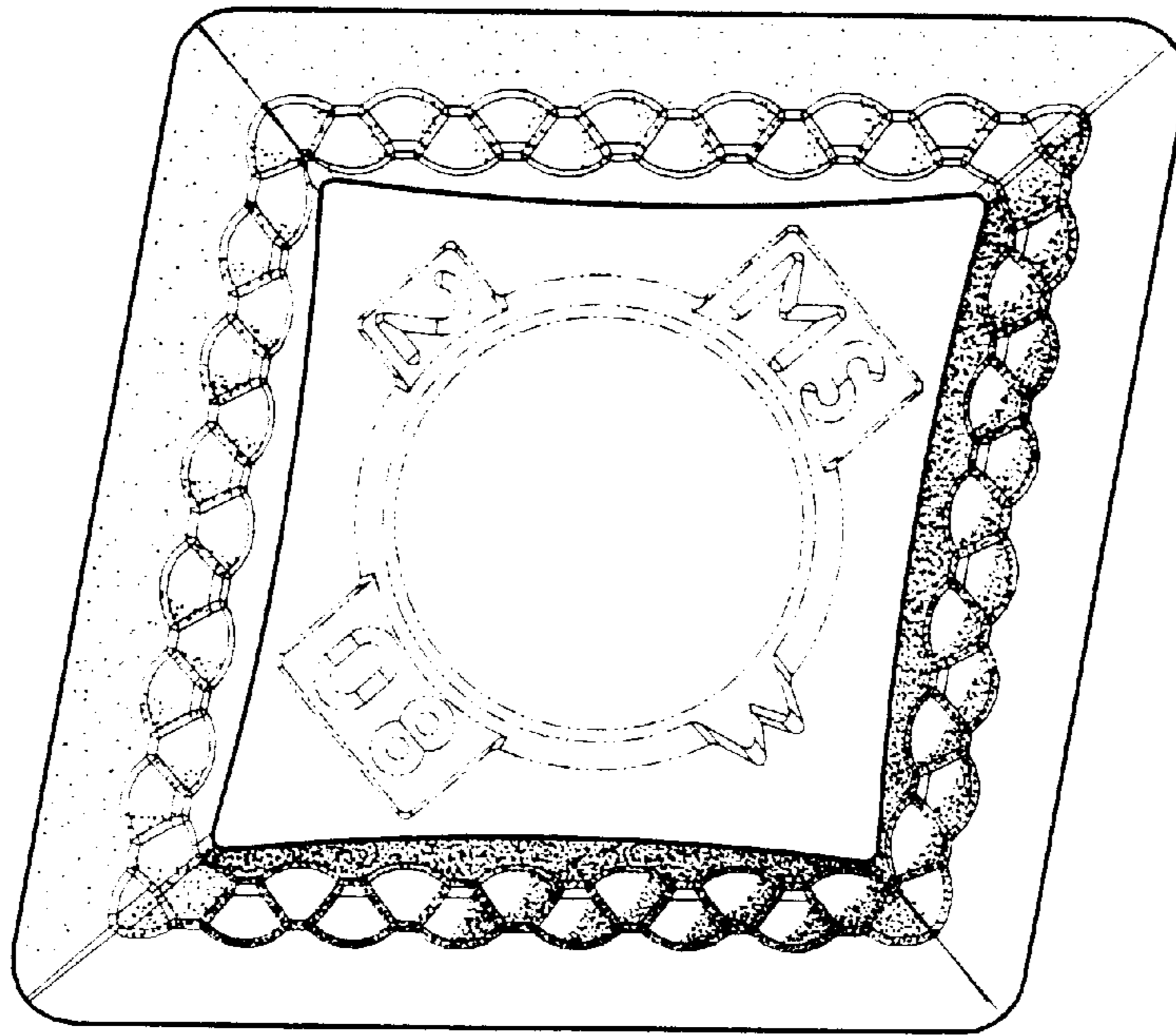

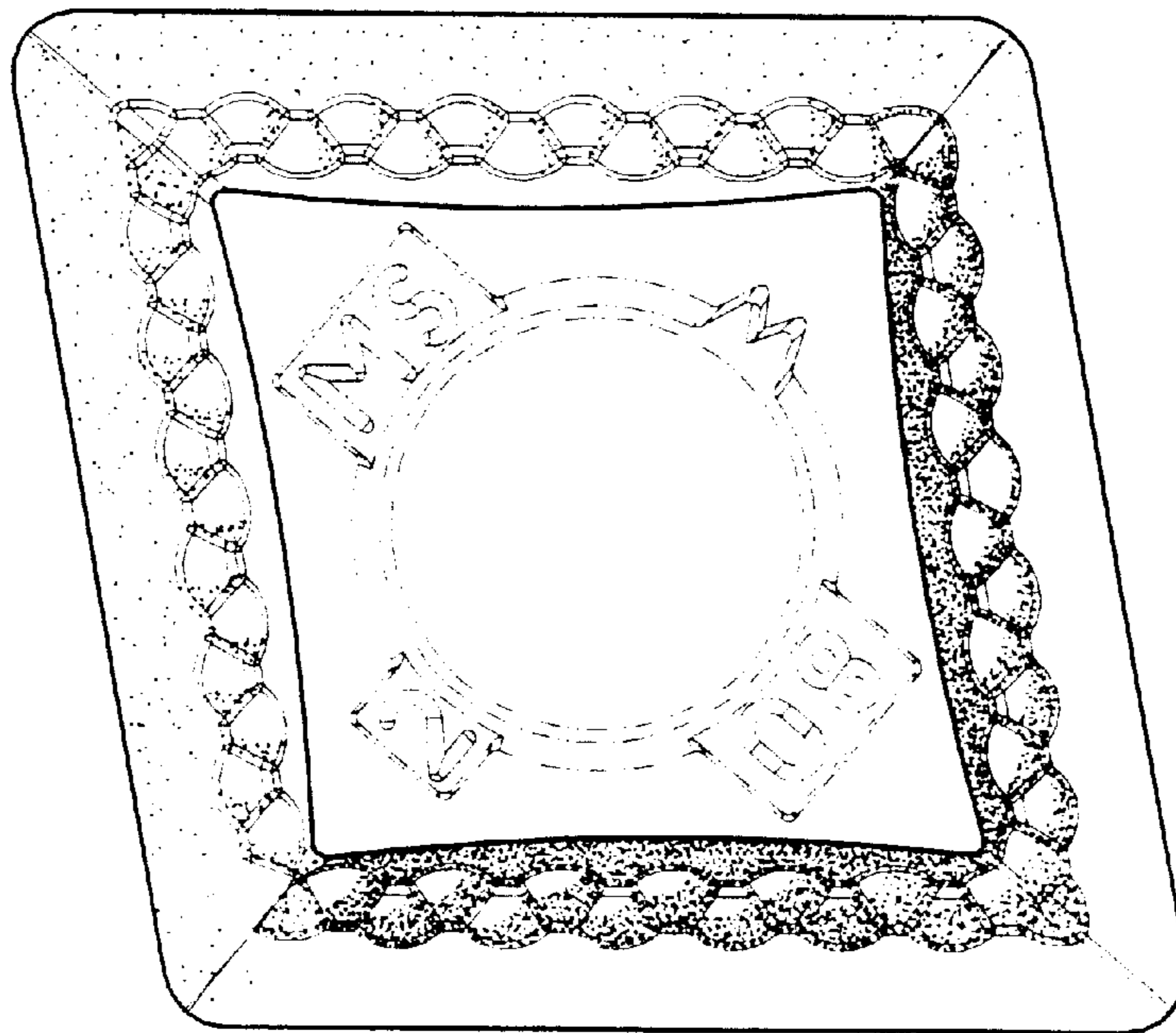
