FIG. 3 is a rear view thereof;

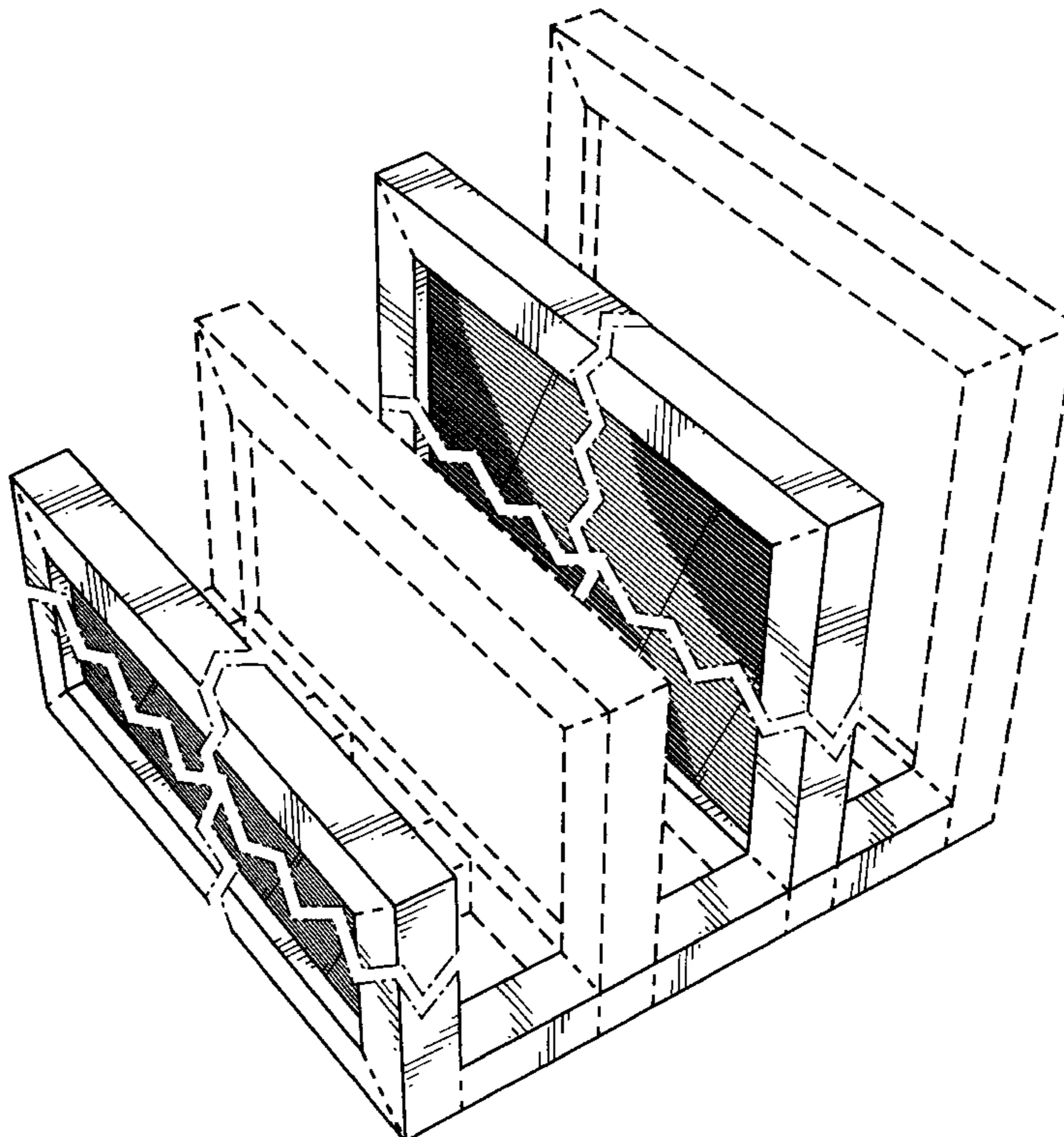
FIG. 4 is a right side, perspective view thereof, the left side, perspective view being a mirror image;

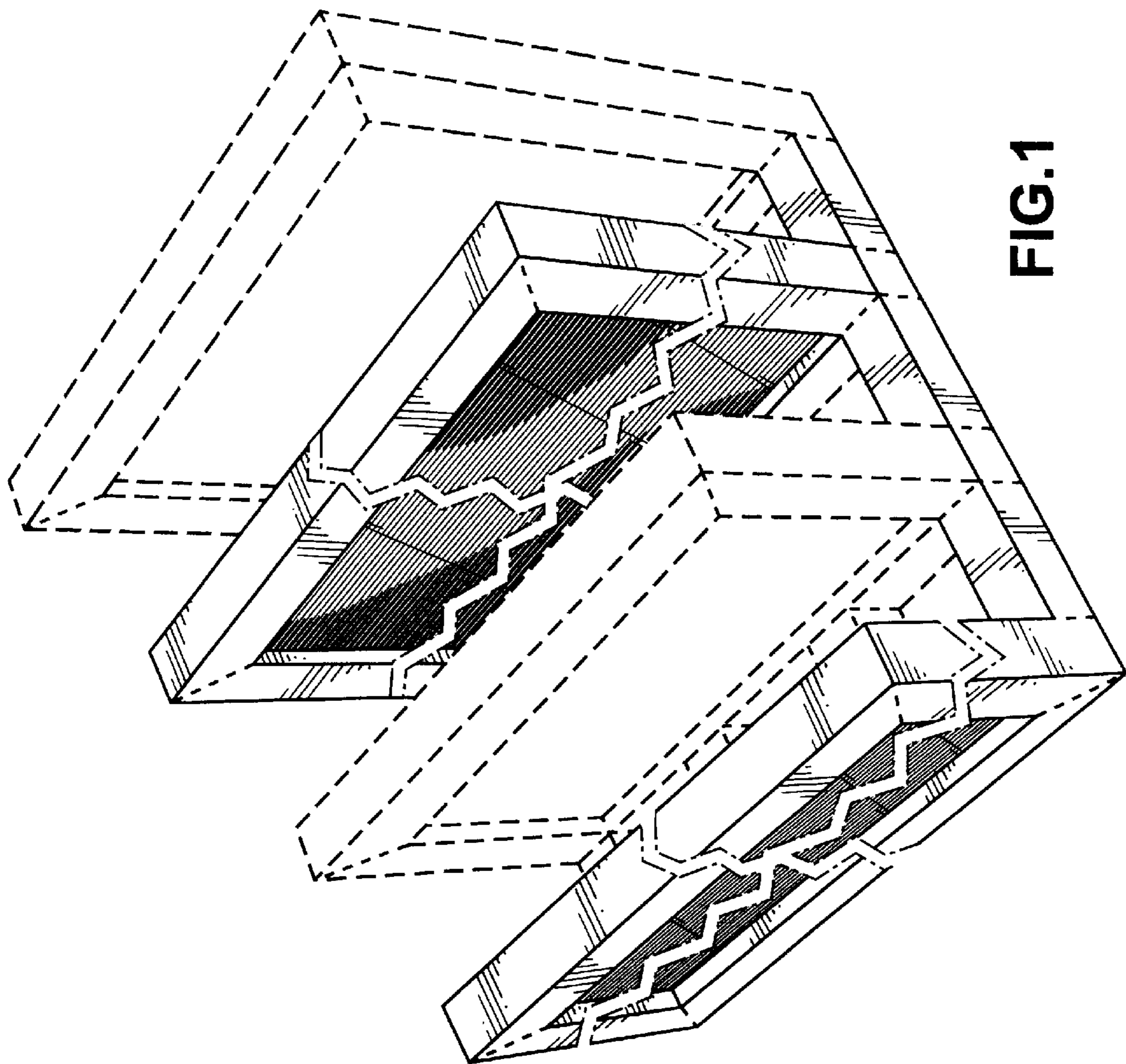

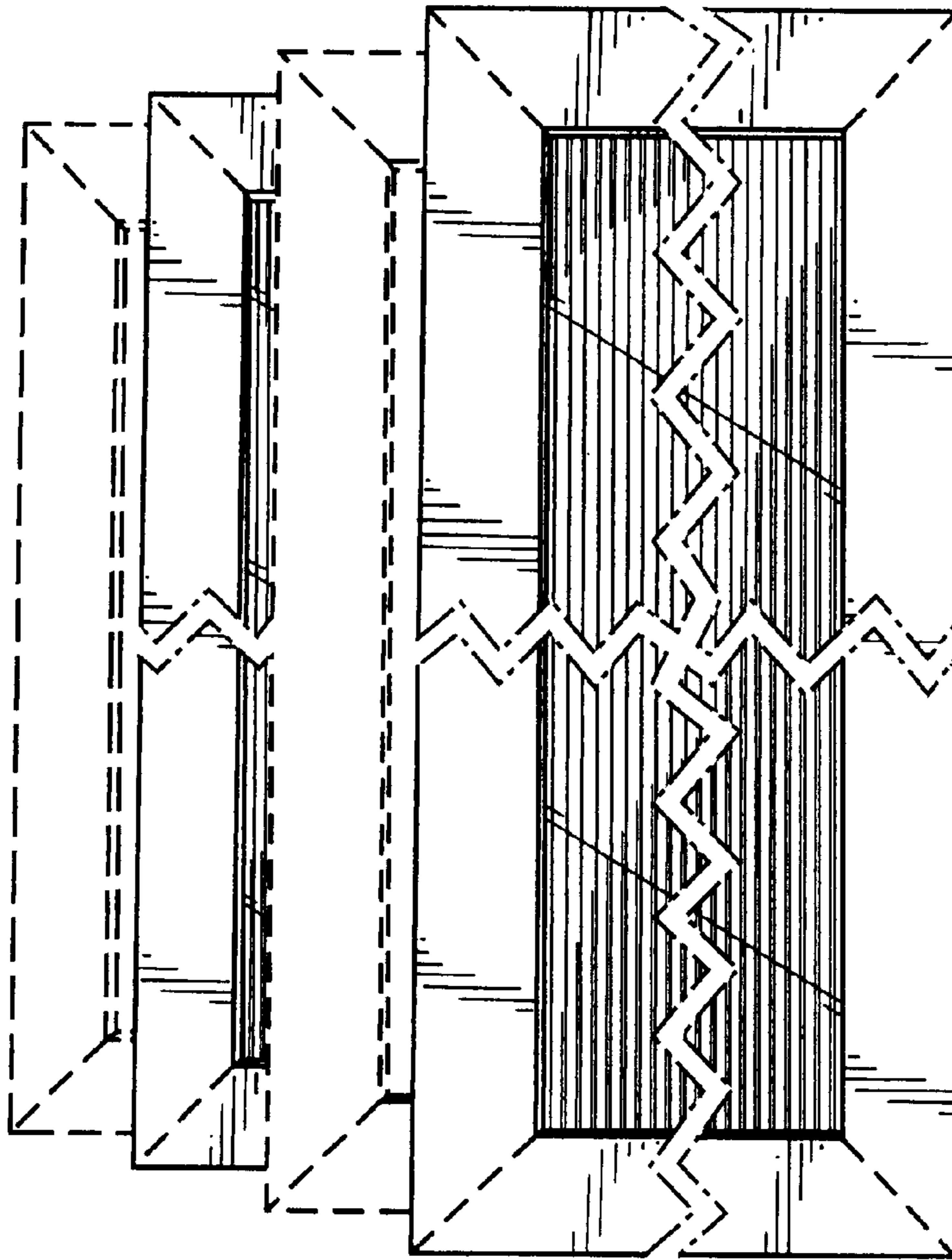

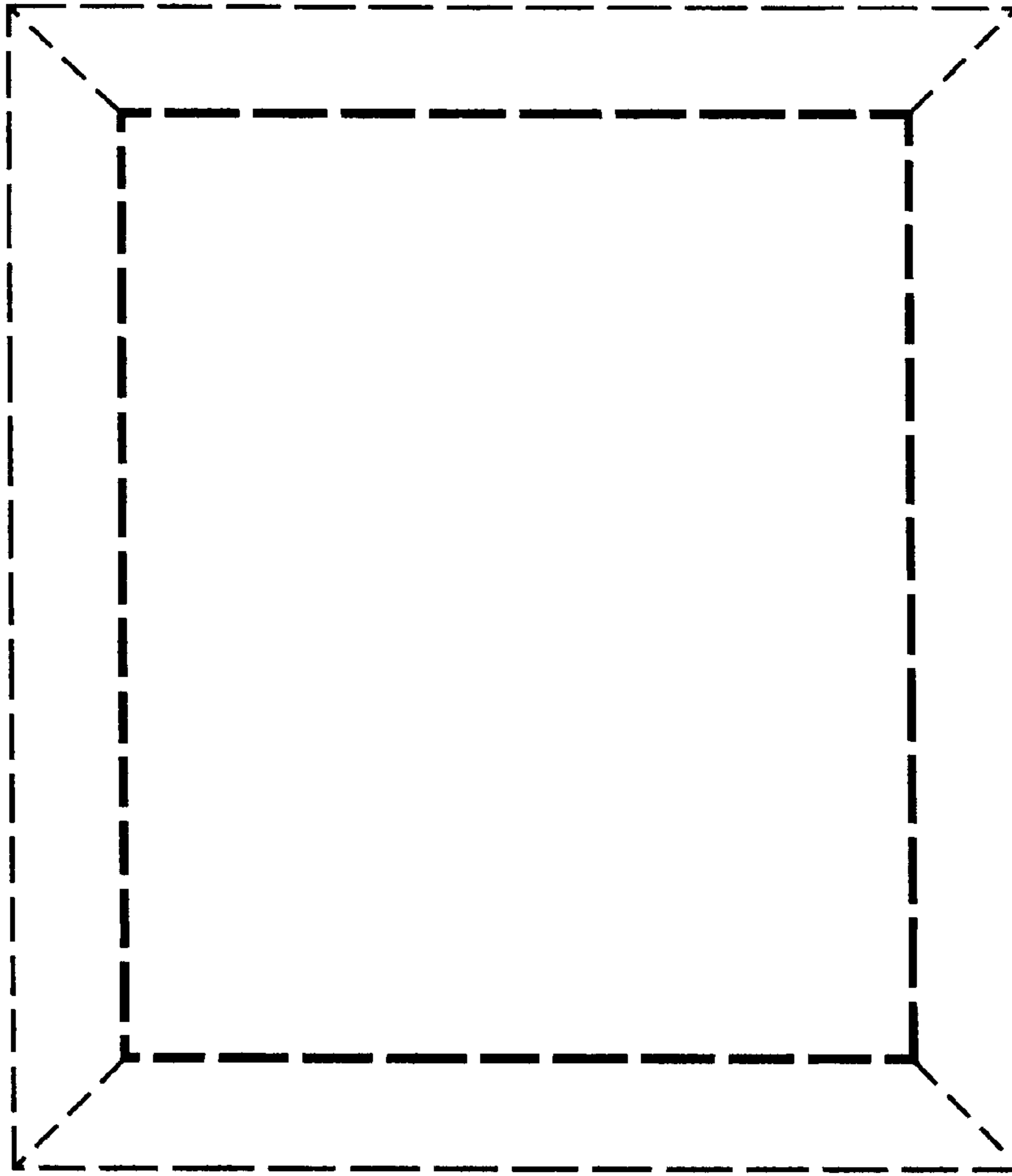

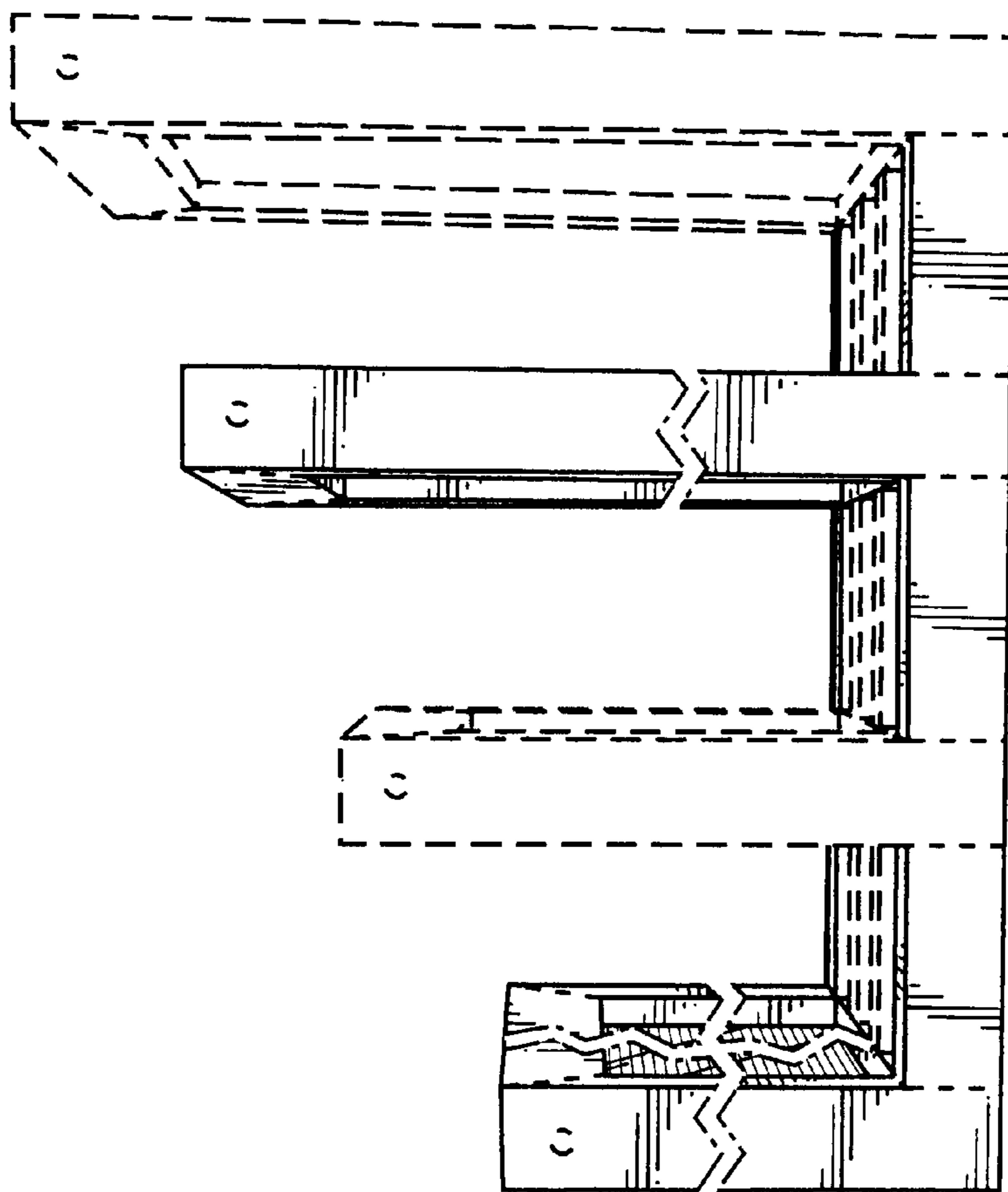

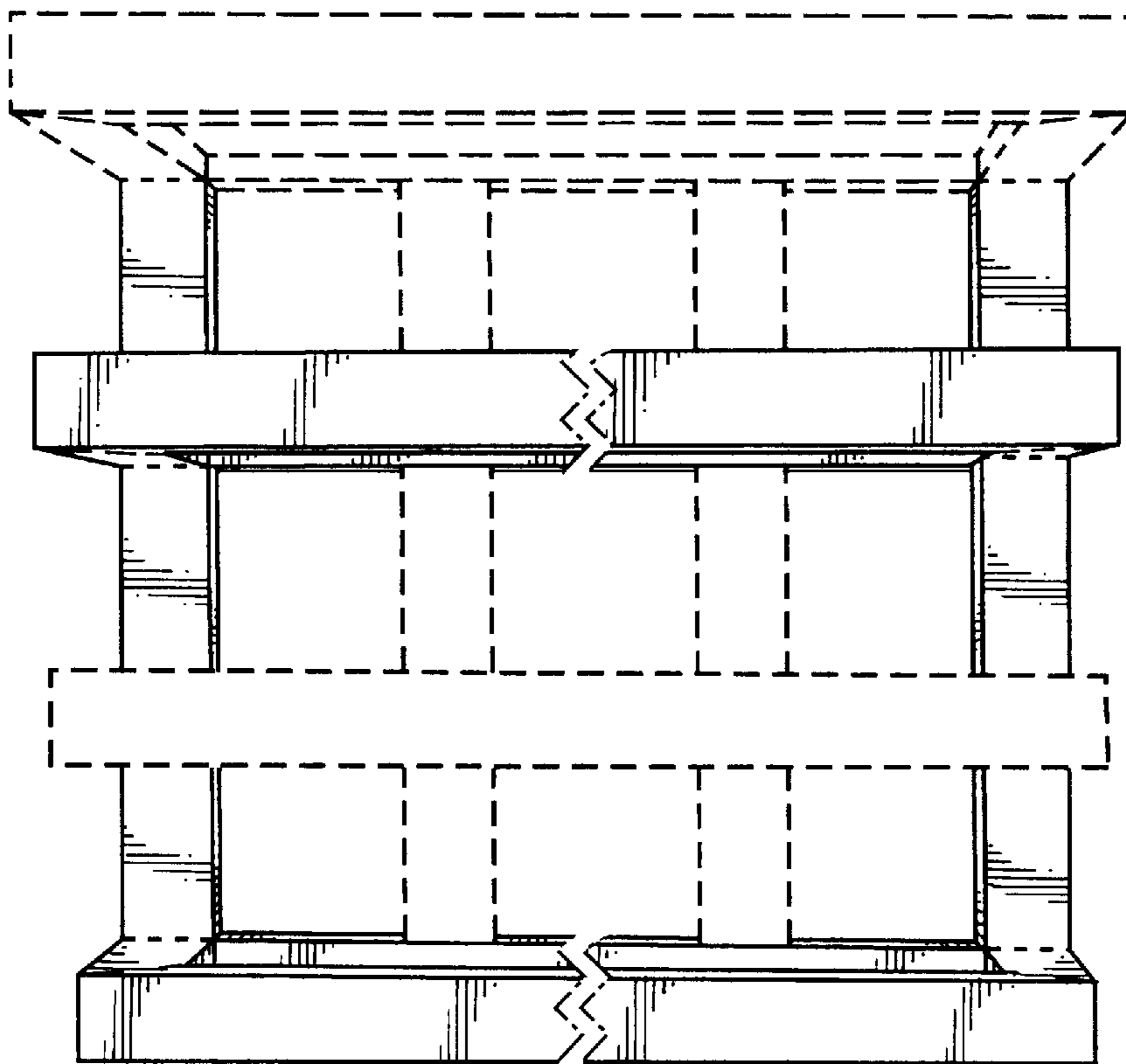

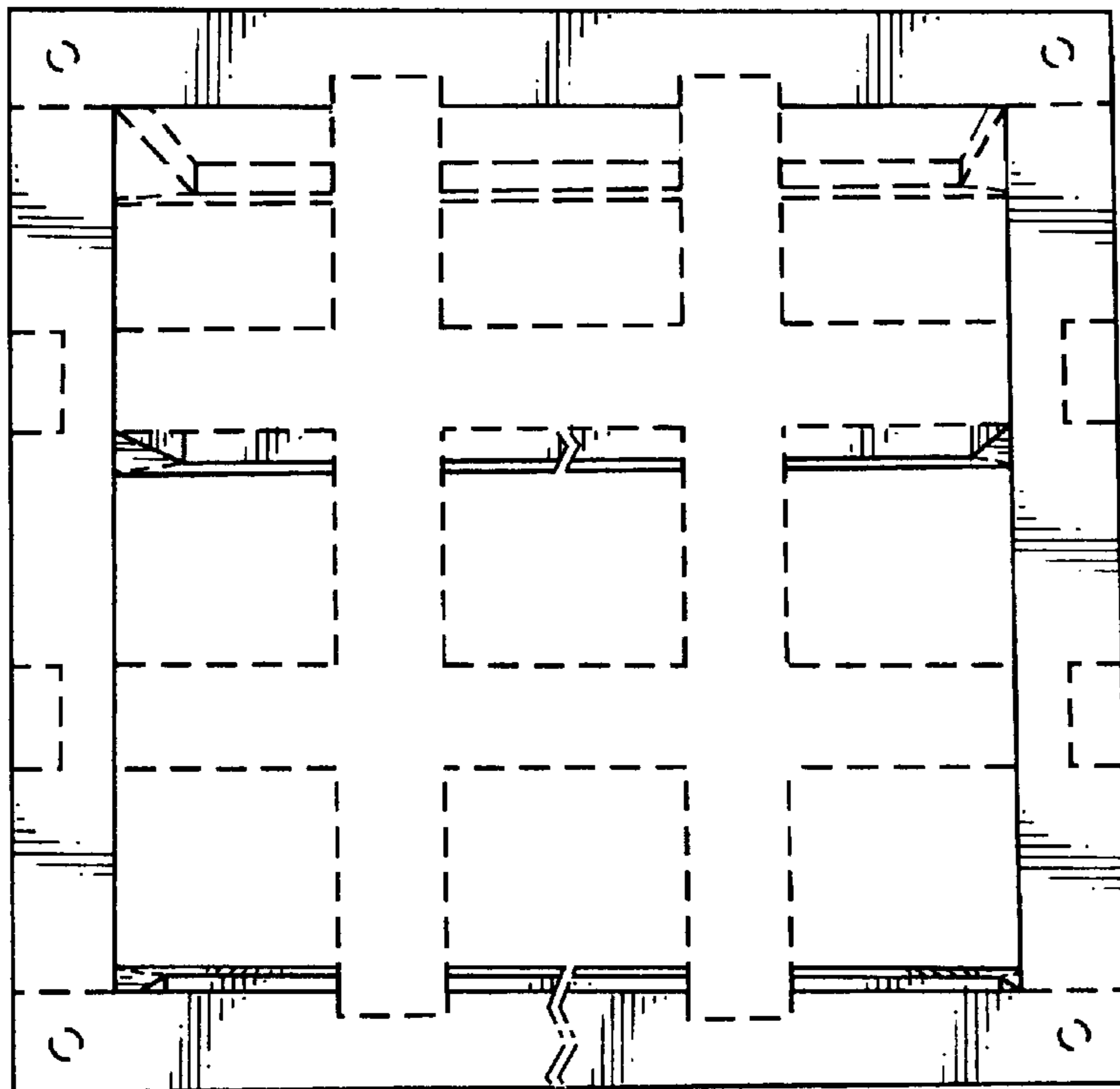
